AFP: Hapilon's topaide, Maute straggler killed

ZAMBOANGA CITY – Two suspected Maute gunmen were killed by government troops as the military continued clearing Marawi City of possible stragglers of the extremist group.

Col. Romeo Brawner, deputy commander of Joint Task Force Ranao, said troops caught up with the two terrorists in a firefight inside the main battle area late Wednesday.

Two soldiers were wounded during the encounter, Brawner said.

Brawner identified one of the slain gunmen as Abu Talja, said to be the right hand man of slain Abu Sayyaf leader Isnilon Hapilon.

They were trying to slip out of the tunnels to escape the area when troops chanced upon them, triggering the firefight, Brawner said.

He said the troops recovered the bodies of the two terrorists, which are now being processed by police forensic experts.

Brawner said the two stragglers appeared to be weak and malnourished, confirming the claim of captured Indonesian militant Muhammad Ilham Syahputra.

"The Indonesian said they are already weak for lack of Turn to Page 8 Arr

food so they forage during the night, hoping to get something to eat," Brawner said. Barangay watchmen arrested Syahputra while trying to escape last Wednesday

Syahputra said there are still 39 of them hiding in the labyrinth of tunnels dug by the Maute militants inside the main battle area.

"But it's possible there are still more than a dozen hiding inside," Brawner said.

Syahputra confessed he arrived in the Philippines last year to join the Maute group on the invitation of Hapilon.

Hapilon, who was named emir of the Islamic State (IS) in Southeast Asia, was killed last month along with fellow militant leader Omarkhayam Maute.

The Indonesian fighter, from Medan, said his group was involved in a 2016 suicide attack that killed eight people in the Indonesian capital Jakarta that was claimed by IS,

officials said.

Sources revealed the Indonesian militants went to Mindanao through General Santos City by boat.

Sources also identified two of Hapilon's other Indonesian companions as Savithri and Urdomo Hartono.

Syahputra, on the other hand, was immediately turned over to the police and flown to the Philippine National Police (PNP) headquarters in Camp Crame, Quezon City.

PNP deputy spokesperson Supt. Vemily Madrid said the Indonesian militant is now in the custody of the PNP-Criminal Investigation and Detection Group.

Syahputra would be facing charges of rebellion, illegal

possession of firearms and explosives and violation of International Humanitarian Law.

Authorities had seized from Syaputra a .45 caliber pistol, a hand grenade, one computer tablet, assorted ammunition, pieces of jewelry, P17,700 in cash and assorted foreign currency, along with the passport of one Khoirul Hidayat, also an Indonesiau.

On the other hand, officials are planning to award with special citations the village community watchmen who arrested Syahputra.

The village watchmen had alerted the military and police who took Syahputra into custody when they noticed he was not a resident of the city and could not speak basic Filipino.

Suspected Indon terrorist Charged with rebellion

A suspected Indonesian extremist affiliated with the Maute terrorist group has been formally charged with rebellion at the Quezon City Prosecutor's Office a day after he was caught fleeing the wartorn Marawi City.

Two remnants of IS inspired Islamic State (IS) were killed. Two soldiers were wounded even as the war in Marawa is over

Muhammad Ilham Syahputra, 23, who is from North Sumatra, idadonesia, is being charged with rebellion, illegal possession of firearms and explosives, and byiolation of the International Humanitarian Law.

Department official, Quezon City
prosecutors have already submitted
the case against Syahputra for
resolution following an inquest
proceeding conducted by Deputy
City Prosecutor Alfredo Agcaoili
and Associate State Prosecutor
Redan Parrocha.

Lanao del Sur police said that in Syahputra was intercepted by civilians and militia under Marawi's Barangay Peacekeeping Action Peam (BPAT) on Wednesday morning (November 1) after he was spotted swimming on Lanao Lake near the battle zone.

Syahputra to police and military forces, who seized a .45 caliber pistol and bullets, improvised explosive device and some various foreign currencies from him.

Syahputra reportedly was not carrying any Indonesian passport.

The suspected terrorist is currently under the custody of the Philippine National Police (PNP) Criminal Investigation and Detection Group (CIDG).

According to police, Syahputra arrived in the Philippines in November last year after he was intrivited by Isnilon Hapilon, slain leader of Islamic State (IS) supporters in the country.

Hapilon, together with rebel leader Omar Maute, was shot dead by government forces last month during a firefight that led to the liberation of Marawi from the Maute terrorist group.

Upon questioning, the Indonesian admitted before police officials to being a member of the ISIS terror group who came to the Philippines and took part in various terror operations.

Syahputra reportedly said he was involved in a group who perpetrated an IS-inspired suicide attack in 2016 that killed 8 people in the Indonesian capital Jakarta.

"He said he was invited by Isnilon Hapilon to be part of the struggle here. He added that he was involved in the Piagapo encounter with our Armed Forces and said he has involvement in the Thamrin bombing in Indonesia," said Senior Superintendent John Guyguyon. Lanao del Sur provincial police director.

Syahputra revealed that there are at least 39 Maute stragglers still inside Marawi City, according to Guyguyon. He also told government troops the location of 20 of them in Marawi City.

However, Syhaputra said the Maute stragglers will not stage an attack, but they will retaliate if the government troops will enter their camp, according to Guyguyon.

The military is currently checking this claim out

Encounter in battlezone kills 2
Mante terrorists, wounds 2 soldiers

Barely a week after the

in Marawi City, an encounter erupted on Wednesday at the main battle area resulting in the killing of two remnants of the Islamic State-inspired Maute terrorist group and wounding of two soldiers.

The military reported that the clash happened at around 8:40 p.m. inside the main battle area between two terrorist-stragglers and Army forces patrolling in the place.

"Both stragglers were killed while two soldiers were wounded in action," said Col. Romeo Brawner, deputy commander of Joint Task Force Ranao.

Brawner identified one of the slain terrorists as Abu Talja, tagged as the right hand man of Isnilon Hapilon—the designated emir or leader of the Islamic State of Iraq and Syria (ISIS) in Southeast Asia who was killed during the final phase of the military assault last month.

"The cadavers of both terroriststragglers are now being processed by the SOCO (Scene of the Crime Operatives) of the PNP (Philippine National Police)." said Brawner.

Brawner stressed that the neutralization of the two terrorists further reduced the capability of the remaining terrorist-stragglers in Marawi.

"The deaths of these two significantly reduced the ability of the remaining members of the Maute-ISIS to cause further harm and derail the ongoing return of the IDPs to the controlled barangays in the city," said Brawner.

"Normalization and rehabilitation efforts in Marawi City continue despite the ongoing clearing operations in the main battle area," he added.

Defense Secretary Delfin Lorenzana officially declared the war in Marawi City as over on Oct. 23 -exactly five months after the siege started last May 23, terminating all combat operations.

Prior to this, President Duterte declared the liberation of Marawi City from the IS-inspired terrorists immediately after the killing of Hapilon and Omarkhayam Maute.

The military claimed to have killed 920 terrorists since the start of the Marawi City siege until the war was declared over.

On the other hand, 165 government troops were killed in action while more 1,000 were wounded. Forty-seven civilians also perished while more than 1,700 were safely rescued.

DøJ probe vs online inciter set

The Department of Justice (DoJ) will launch today its preliminary investigation into the criminal cases against the widow of a notorious terrorist leader for allegedly recruiting foreign fighters to join the IS linked Mante group.

Karen Aizha Hamidon, who was arrested by National Bureau of Investigation (NBI) counter terrorism agents last October 11, will face the panel of prosecutors during the hearing for 14 counts of rebellion and cybercrime charges.

Hamidon is the wife of Mohammad Jaafar Maguid alias "Abu Sharifa," the former leader of the Ansar Khalifa Philippines (AKP), the group responsible for the September 2016 Davao City night market bombing.

Hamidon's husband is also responsible for the failed attempt to bomb the United States Embassy in Manila last December 2016, according to Gierran. He was killed by police in January 2017 in Saranggani.

DoJ officials said that Hamidon is considered internationally notorious when she successfully recruited Indian nationals to come to the country and join radical Islamic extremist groups in Mindanao in the middle of 2016.

Justice Secretary Vitaliano Aguirre II said that Hamidon sent 296 messages to social media applications "Telegram" and "WhatsApp" which appear to promote terror and rebellion in Marawi.

According to DoJ, Hamidon posted the following messages calling on Muslims to establish a province under the terrorist group Islamic State of Iraq and Syria (ISIS) in the country:

"The soldiers of Taghut are desperate to defeat the Muhajireen of the Islamic State of Marawi City...but Wallahi they won't be successful. They won't be able to defeat the force of Dawlah because Allah (Azza wa Jaal is on their side)."

"That is why the Dawlah is once again inviting all our ikhwaanil Muslimeen in all parts of the Philippines and around the world to support our Muhajireen of East Asia. Let us go to Marawi, in Mindanao to join the war against the Conquerors of the soldiers of Tawagheet."

Hamidon is also an ex-wife of Singaporean national Muhammad Shamin Mohammed Sidek who was identified as having links to ISIS.

Moreover, NBI officials confirmed that Hamidon is also a known associate of Musa Cerantonio, an Australian Islamist preacher who has inspired numerous foreign fighters to join ISIS.

"Hamidon is also under investigation by other foreign intelligence agencies for her possible links to international terrorist financing and her spreading radical Islamic propaganda," NBI Director Dante Gierran earlier told reporters.

The DoJ is also considering the move to file rebellion charges against Hamidon, since her acts "clearly denote that she was in conspiracy with the rebels."

"Under the law, under the jurisprudence, even if there is no proof of actual conspiracy the acts of the parties you would deduce, deduct that there was the same design, the same purpose that would be proof of the agreement and so I believe she is part and parcel of this rebellion happening still in Marawi city," Justice Secretary Aguirre explained.

To get the rehabilitation of wartorn Marawi City rolling, President Duterte has named a retired military general to lead the rebuilding task force.

Based on Administrative Order

No. 9 released yesterday by Malacañang, Housing and Urban Development Coordinating Council (HUDCC) chairperson Eduardo del Rosario is now designated as chief of Task Force Bangon Marawi.

Del Rosario will be taking over the post once held by martial law administrator Defense Secretary Lorenzana

Lorenzana and Department of Public Works and Highways Secretary Mark Villar are now vice co-chairmen of the inter-agency task force.

"There is a need to re-organize Task Force Bangon Marawi in order to reflect the government's current priority to rebuild and develop the settlement areas affected by the armed conflict," the AO signed by the President stated.

Moreover, the AO created two sub-committees that will respectively supervise housing efforts and securing peace and order in the Islamic City.

The sub-committee on housing, led by the HUDCC, will be "primarily responsible for the immediate rehabilitation and construction of temporary or permanent shelters, and the restoration of water, electricity and other public utilities."

The sub-committee on security, peace and order, which will be chaired by both the Department of National Defense (DND) and the Department of the Interior and Local Government," shall take charge of the "restoration and maintenance of peace and order and the continuity of public serves in the city."

Meanwhile, Office of Civil Defense (OCD) Assistant Secretary Kristoffer James Purisima said the government has already started the return of 6,463 internally displaced persons (IDPs) to nine barangays in Marawi.

"For the remaining barangays in the main battle area, we are awaiting for the conclusion of the clearing operations to be determined by the AFP," Purisima noted.

He announced that the initial P5-billion budget allotted by the government would be used for the city's early recovery. Of this amount, an estimated P3.4 billion will be tapped to provide health and social services to IDPs.

Purisima also confirmed that the government has received foreign donations from the governments of Canada, China, Germany, Korea, India, Thailand, and Singapore.

Additionally, financial assistance was provided by the Assan Coordinating Center for Humanitarian Assistance on Disaster Management (AHA Center) and the US Agency for International Development (USAID), also for the early recovery phase.

International organizations likewise pledged assistance of the country, including the agent and of Australia and Japanian asian Development Bank (ADI) the European Union (EU) the World Bank, and the United National Development Program (UNIP).

Arrested Indonesian Maute militant faces rebellion raps

Security officies sale the some

wo Maute stragglers, one of them reportedly the trusted lieutenant of Abu Sayyaf leader Isnilon Hapilon, were killed

Wednesday night by Army troops nine days after the government declared an end in the fighting in Marawi City.

Abu Talja was killed with another straggler following a clash that erupted at around 9 p.m. Wednesday inside the main battle area in Marawi.

"Both stragglers died while two soldiers were wounded in action," the source said Their bodies were immediately turned over to the Philippine National Police for processing before

their burial based on Islam rites.

Hapilon, the designated emir of the Southeast Asia caliphate being established by the ISIS (Islamic State of Iraq and Syria), was earlier killed along with one of the Maute leaders.

Security officials said the arrest of an Indonesian fighter and the death of two more local Maute gunmen significantly reduced the fighting capability of the remaining gunmen who attacked Marawi City.

Muhammad Ilham Syahputra, the Indonesian fighter, was arrested at around 7 a.m. Wednesday

during clearing operations in Barangay LuksaDatu in Marawi City, said Senior Supt John Guyguyon, director of the Lanao del Sur Provincial Police Office.

Thursday afternoon. Syahputra was subjected to inquest proceedings before the Quezon City Prosecutor's Office, the Department of Justice (DOJ) said.

The Indonesian was presented before Deputy City Prosecutor Alfredo Agcaoili and Assistant State Prosecutor Rodan Parrocha.

The criminal complaints filed by the Criminal Investigation and Detection Group (CIDG) against Syahputra were deemed submitted for resolution during the inquest proceedings.

Supt. Vemily Madrid, deputy spokesperson of the Philippine National Police (PNP), said complaints for rebellion and violation of the Comprehensive Firearms and Ammunition Regulatory Act (Republic Act 10591), Explosive Act (9516), and International Humanitarian Law (RA 9581) were filed against the 22-year-old Indonesian in connection with the Mrawi siege

Madrid said the suspected Indonesian terrorist arrived at Camp Crame Wednesday evening.

"He is undergoing the routine police procedures for the arrested person," said Madrid.

Syahputra was spotted by Barangay Peacekeeping Action Team (BPAT) during the clearing operations

Seized from him were a colored pink tablet; 10 pieces of \$\mathbb{F}\$1,000 bills; 15 pieces of \$\mathbb{F}\$500 bills; two pieces \$\mathbb{F}\$100 bills; six pieces of 10 Qatari riyal bills; four pieces 100 UAE dirham bills; two pieces 10 Singapore dollar bills; five pieces of 5 Qatar riyal; eight pieces of 100 Saudi riyal bills; and five pieces 1 Qatari riyal

Also seized were seven pieces of gold bracelets, a fragmentation grenade, a .45 pistol, and magazines and a passport of possibly his Indonesian companion.

Guyguyon had earlier said Syahputra claimed to have killed his Indonesian companion in order to escape

Based on intelligence reports, Syahputra arrived in the country in 2016 upon the invitation of Hapilon.

TF BangonMarawi revamped

With the Marawi conflict over, President Duterte has implemented a revamp of Task Force BangonMarawi by formally designating Housing Urban and Development Coordinating Council (HUDDC) chair Eduardo del Rosario to lead the team.

In Administrative Order No 9 issued by the President, Del Rosario will take the place of Defense Secretary Delfin Lorenzana as chairman of the task force in charge of the rebuilding efforts of the war-ravaged area and nearby localities.

The President's latest order amend-

ed AO 3, signed last June, that created the Task Force Bangon Marawi, an inter-agency group assigned on the comprehensive and integrated rehabilitation program for Marawi City.

"On 17 October 2017, Marawi City has been effectively liberated from the control of ISIS-backed local terrorist groups, signaling the start of a full-blown reconstruction period," the order read. "There is a need to re-organize Task Force Bangon Marawi in order to reflect the government's current priority to rebuild and develop the settlement areas affected by the armed conflict," it added.

In AO 9, the President authorized the HUDCC chair will have "operational control and supervision" of the Task force and the "overall responsibility" to ensure rehabilitation program is accomplished.

Lorenzana, on the other hand, will also serve as co-vice chairperson, alongside Public Works Secretary Mark Villar

The same order has also designated the HUDCC to lead the sub-committee on housing "to be primarily responsible for the immediate rehabilitation and construction of temporary or permanent shelters, and the restoration of water, electricity, and other public utilities."

The DND will also co-head the subcommittee responsible for the restoration and maintenance of peace and order, the continuity of public services in the city (With reports from Jeffrey G. Damicog and Genalyn D. Kabiling)

Iroops Kill Hapilon's aide

Along with another Maute straggler

OVERNMENT soldiers killed the right-hand man of slain Abu Sayyaf leader Isnilon Hapilon and another Maute group straggler Wednesday night as clearing operations continued in Marawi City.

Col. Romeo Brawner Jr., wounded in the firefight in deputy commander of Joint Task Force Ranao, said the two stragglers were killed, while two soldiers were Hapilon's lieutenant.

Brawner identified one of the casualties as Abu Talja.

Brawner also said rehabilitation efforts continued in the war-torn city amid isolated firefights in the main battle area as clearing operations continued.

Philippine Drug Enforcement Agency regional director Gil Castro said the suspects—Faroon Lumatao and his brother Alhotaibby Lumatao-were protecting the El Patron Drug Group that operates in South Central Mindanao.

Police on Thursday filed rebellion and other criminal charges against an Indonesian suspected to be a member of the Maute terrorist group before the Quezon City Prosecutor's

Muhammao rinam Syahputra, 23, was arrested in Marawi City last Wednesday, and brought to the Prosecutor's Office for inquest proceedings.

The police charged Syahputra with rebellion under Republic Act 134, illegal explosives under Republic Act 10591 and Republic Act 9516, and crimes against humanity under Republic Act 9581.

Deputy City Prosecutor Alfredo Agcaoili and Assistant State Prosecutor Rodan Parrocha immediately submitted the complaint against Indonesian for resolution.

In its complaint, the Philippine National Police alleged that Syahputra was part of the Maute-ISIS

group that attacked Marawi in May and battled government troops for five months.

"Based on accounts of rescued hostages, the ISISist group was reinforced by foreign nationals such as Indonesians. Malaysian and some were even Arabs," the complaint said.

The police said Syairputra was arrested by civilians and militia uncer Marawi's Barangay Peacekeeping Action Team after he was spotted swimming on Lanao Lake near the baitle zone.

Seized from him were a .45 cal. pistol and bullets. fragmentation grenade and various foreign currencies worth about P17,000, an Indonesian passport and several fake IDs bearing the name Khoirul Hidayan.

Syahputra who spoke Tapossession of firearms and inspired Maute local terror galog fluently said he was an Islamic State member who came to the Philippines two years ago. He said their were R least 39 more Maute group stragglers in the main battle area in Maraw? City, but Brawner could Bu confirm the number.

2 more Maute stragglers killed

THE right-hand man of the late Abu Sayyaf Group leader Isnilon Hapilon and a member of the terrorist Maute group were killed Wednesday night in Marawi City, the military said yesterday.

Government forces were conducting clearing operations in the main battle area at around 8:40 p.m. when they chanced upon the two stragglers who traded shots with them, said Col. Romeo Brawner, deputy commander of Joint Task Force Ranao.

Brawner said one of them was Abu Talija, right-hand man of Hapilon who helped the Maute in attacking Marawi on May 23. The other slain terrorist, who looks Filipino, remained unidentified.

Hapilon was killed on October 16, together with Maute leader Omar Maute. Hapilon was supposed to have been anointed by the Islamic State as its leader for Southeast Asia. On October 23, Defense Secretary Delfin Lorenzana officially declared the war in Marawi City over.

Last Tuesday, a Maute straggler was killed after exchanging fire with soldiers in the main battle area as he was attempting to escape.

Brawner said the latest killing "significantly reduced the ability" of the stragglers to cause further harm and derail the return of the displaced residents.

The military said 920 terrorists have died in the Marawi battle which ended last week. On the other hand, 165 government troops were killed in action and some 1,000 were wounded. Forty-seven civilians also perished while more than 1,700 were safely rescued.

Earlier on Wednesday, government forces arrested in the main battle area an Indonesian suspected to be a terrorist who fought alongside the Maute. On Wednesday night, Ilham Syahputra was brought to Camp Crame in Quezon City and turned over to the PNP Criminal Investigation and Detection Group where he

underwent the normal booking process.

Among items recovered from him were cash, a grenade, a gun, and an Indonesian passport bearing the name Khoirul Hidayat.

Video footages showed Syahputra initially identified himself as a member of the military intelligence during questioning by authorities. He later admitted he was part of the Maute group which encountered government forces sometime April this year, said Brawner. Syahputra was charged yesterday by the PNP with rebellion and other criminal cases, before the justice department.

The Department of Justice will conduct today preliminary investigation on criminal charges filed against Karen Aizha Hamidon who was arrested on October 11 in Taguig City for allegedly recruiting, through social media, fighters for the Maute. Hamidon is charged with 14 counts of violation of Article 138 of the Revised Penal Code (rebellion or insurrection) and of Section 6 of the Cyber-

crime Prevention Act.

REORGANIZATION

President Duterte reorganized the Task Force Bangon Marawi as government starts rehabilitation and reconstruction of the city.

In Administrative Order No. 9 signed October 27, Duterte designated the head of the Housing and Urban Development Coordinating Council as task force chair (former defense secretary) and the secretaries of the defense and public works departments as co-vice chairmen.

The Task Force's sub-committee

on housing, formerly headed by the Office of the Cabinet Secretary, will now be headed by the HUDCC. The panel is primarily responsible for the rehabilitation and construction of temporary or permanent shelters, and the restoration of water, electricity, and other public utilities.

The sub-committee on security, peace, and order will now be co-headed by the defense and interior departments. It will still be responsible for the restoration and maintenance of peace and order, and the continuity of public services in Marawi City. — With Ashgel Hachero and Jocelyn Montenayor

TWO more members of the ISIS-inspired Maute Group were killed while two soldiers were wounded in another encounter in the main battle area of

Marawi City the other day.

Armed Forces of the Philippines (AFP) Western Mindanao Command (WMC) chief Lt. Gen. Carlito G. Galvez Jr., said one of the fatalities was identified as Abu Talja, said to be the right-hand man of Isnilon Hapilon, the designated emir and leader of the Abu Sayyaf Group. The wounded soldiers were taken to the hospital.

Reports said the encounter occurred at around 8.40 p.m. on All Saints' Day in Marawi City.

IBP seeks AFP support in Marawi probe

ARAWI CITY - In its impending conduct of investigation on issues and incidents surrounding the five-month strife in this city, the Integrated Bar of the Philippines (IBP)-Lanao del Sur chapter is appealing for public cooperation, notably from the Armed Forces of the Philippines (AFP) hierarchy and ground commanders, to ensure an accurate outcome.

Lawyer Aminoddin "Mino" Macalandap, IBP-Lanao del Sur chapter president, said their long-planned probe will take off soon as residents started returning to the warravaged city.

More than 2,000 displaced residents from nine barangays have returned last Sunday and received a warm welcome from city, provincial and regional officials who distributed and extended relief goods, financial, medical and psycho-social assistance.

Macalandap said he and other local IBP members have started interviewing some of the returning residents.

In a report posted online by the Bureau of Public Information (BPI) of the Autonomous Region in Muslim Mindanao, 63-year old evacuee Abpisa Barese, who fled her home with her husband and daughter on May 26, complained that their prospects for recovery would be gloomy because their residence in barangay Malutlut here has been ruined and looted

Many of close to 200,000 displaced residents here have expressed sentiments similar to Barese's.

Majority of them are pinning their hopes on the Duterte administration's commitment that the government's recobnstruction program will prioritize non-affluent evacuees

Macalandap echoed the local IBP chapter's commitment to provide free legal assistance to evacuees seeking justice in the destruction of their houses and looting of their belongings.

"But in the IBP investigation of alleged looting cases involving soldiers as suspects, we would need the cooperation of the military hierarchy," Macalandap said.

President Duterie has reorganized Task Force Bangon Marawi, shifting its focus from defending Marawi City to recovery, reconstruction and rehabilitation.

Under Administrative Order 9 he issued last Oct. 27, the chairman of the Housing and Urban Development Coordinating Council (HUDCC) will head the task force and would have operational control, supervision and overall responsibility to ensure that objectives are accomplished.

The secretary of the Department of National Defense, who previously served as task force chairman, together with the secretary of public works will serve as co-vice chairpersons.

The group's sub-committee on housing, which was formerly under the Office of the Cabinet Secretary, was also transferred to the HUDCC. This subgroup is "primarily responsible for the immediate rehabilitation and construction of temporary or permanent shelters, and the restoration of water, electricity and other public utilities."

Duterte also ordered the defense and interior secretaries to co-chair the subcommittee on security to restore and maintain peace and order and ensure the continuity of public services in the ruined city.

He declared Marawi, the country's prime Islamic city, as freed from the terrorist Maute and Abu Savvaí groups

last Oct. 17. The liberation came after terrorist leaders Omar Maute and Isnilon Hapilon were killed by soldiers.

More than 200,000 people have been displaced and at least 1,000 were killed after the terrorists seized Marawi on May 23. Of those killed, 165 were law enforcers.

Opon his arrival at the Davac-International Airport on Tuesday night from his official trip in Japan, Duterte said Detense Secretary Delfin Lorenzana should be the one to oversee all the reliabilitation efforts.


BACK HOME | 2nd Scout Ranger Battalion given Heroes Welcome
