

## 2 SSS officials accused of bribery

At least two of the four officials of the Social Security System (SSS) accused of "serious dishonesty and grave misconduct" allegedly received monthly bribes from stockbrokers they accredited in exchange for handling part of the pension fund's equity investments.

The latest accusation came from SSS Commissioner Jose Gabriel La Viña, who filed on Oct. 24 an administrative complaint against the four officials who manage the investments of the state-administered pension fund.

At a press briefing on Tuesday in Quezon City, La Viña said he was "investigating allegations of bribery involving at least two out of the four" officials.

He did not identify who among the four—executive vice president for investments Rizaldy Capulong, equities investment division chief Reginald Candelaria, equities product development head Ernesto Francisco Jr. and chief actuary George Ongkeko Jr.—had been

accepting bribes.

At least one stockbroker "may be paying cash bribes" to SSS officials employed in the agency's investments division, according to La Viña.

He said he informed the SSS president, Emmanuel Dooc, "as early as July" that there were reports of this nature that had reached him, but added that these had yet "to be verified."

"The amount reported is allegedly in the six-figure range paid on a monthly basis based on the volume of business given to the stockbroker," he said.


"We are still verifying the identity of the broker or brokers," said La Viña, chair of the investment oversight committee of the Social Security Commission.

Profiteering

La Viña has accused Capulong, Candelaria and Francisco of unduly profiting from their positions in the SSS by trading their personal stock market accounts with stockbrokers whom they themselves helped accredit as official brokers of the pension fund.

Ongkeko was accused of failing to keep complete records of the personal transactions of the investment officials.

La Viña said that except for

Ongkeko, all three officials named in his administrative complaint "play major roles in the accreditation of brokers and [in] allocating how much business to give to each of them."

P119B in equities

The SSS manages about P500 billion in assets, accumulated through monthly contributions of 35 million members in the private sector. Up to 30 percent of its reserve fund can be invested

in the equities market.

As of last March, equity investments of the SSS amounted to P118.7 billion.

La Viña, who ran a successful social media campaign for President Duterte during the 2016 elections, said he had heard of bribery claims even before he assumed his post as SSS commissioner in November last year.

"Then I received reports [on the issue], anonymous," he said, citing his 1.4 million

Facebook followers.

He declined to divulge more details but expressed willingness to provide more information about the bribery after next week's Association of Southeast Asian Nations summit in Manila.

#### Francisco's reply

Francisco's reply to the charges filed with the SSS board-a copy of which was provided to the Inquirer—said the charges against him were baseless.

He said he merely participated in the initial public offering of a stock that the pension fund was ineligible to buy.

The stock, Villar familyowned Golden Haven Memorial Park inc., debuted on the stock exchange last year, earning for Francisco a return of 85 percent totaling P180,000.

The SSS investment official argued that this investment did not deprive the fund of any returns because internal rulesagainst highly speculative investments prohibited the institution from buying the stock—a risk he was prepared to undertake with his own personal money.

La Viña expressed hope that the House of Representatives' probe led by Eastern Samar Rep. Ben Evardone, chair of commit-

tee on banks and financial intermediaries, "will help shed light on the matter."

"I welcome it with open arms," he said. "I will cooperate fully and turn over all docu: ments that will help his committee establish the truth."

La Viña also expressed openness to the lifestyle check sought by Bayan Muna Rep. Carlos Isagani Zarate on SSS of-

#### Tale of abuse

"This sordid affair is a tale of corruption and abuse, of rentseeking, of the rich and powerful conspiring with those in government to take advantage of those who need social justice and protection the most, the very people SSS is supposed to serve," La Viña said.

He said the "investigative and oversight powers of the House of Representatives will help us in our quest to tell the whole story."

La Viña's complaint has so far resulted in the resignation of Candelaria and Ongkeko, but the SSS board ordered the latter to stay on until the end of the year due to the sensitive nature of his job as the fund's chief actuary. -- WITH A REPORT FROM DAX-IMIL LUCAS INQ

DAVAO CITY - Days after describing a mega drug rehabilitation facility in Nueva Ecija as "impractical" and "a mistake," Dionisio Santiago is out as chairman of the Dangerous Drugs Board (DDB).

Santiago was reportedly instructed by Executive Secretary Salvador Medialdea to tender his resignation on orders of President Duterte.

The DDB chief submitted his irrevocable resignation barely four months after he was appointed to the post last

"I was told to tell you to go," Santiago quoted Medialdea as having told him over the telephone last Monday.

Santiago said he told Medialdea he respected the President's decision and understood the reason for it.

The ex-DDB chief, however, claimed that the President was given the wrong information about his statements on the rehabilitation center.

"I have served in the government for 40 years. This is not the way out that I expected," Santiago admitted.

He packed his personal

things and left his DDB office yesterday. Sources said Duterte was not pleased when Santiago said that the 10,000bed capacity drug rehabilitation center at Fort Magsaysay in Palayan City, Nueva Ecija was a mistake. In an interview with ANC last week, Santiago said that the construction of the facility was "impractical" and "a mistake."

"Ang problema, naging excited si President, pero 'yung ginasta dun puwedeng ginamit sa

mga community-based rehab 'yan na maliliit' (The problem is that the President got excited, but the money could have been spent to finance smaller, community-based rehabilitation programs), which can accommodate only between 150 to 200," Santiago said in the interview.

"Masyadong malaki 'yung 5,000: Saan ka kukuha niyan?

(Five thousand people is too many. Where will those individuals come from?)" he added.

The Nueva Eciija rehabilitation center was donated by a Chinese businessman and the President has repeatedly mentioned this in his speeches in the past months.

To give Santiago at least a "graceful exit," Medialdea was tasked to relay to him that the President wanted him to resign.

Medialdea then informed Santiago of the wishes of the President that he step down from office as soon as possible

Santiago, a retired general, is also a former Philippine Drug Enforcement Agency (PDEA) chief. He ran for sena-

tor under Duterte's slate in the May 2016 polls.

It was Santiago whom the President would always quote when he mentions the "four million drug addicts" in connection with the administration's war against illegal drugs.

Santiago was also a former Bureau of Corrections chief.

## One-rank promotion for Marawi cops, soldiers pushed

or showing a rare display of valor and love of country, all soldiers and policemen who laid their lives on the line in the Marawi gunbattles should be granted one-rank promotion, a senior administration lawmaker proposed on Tuesday.

In a press statement, Quezon City Rep. Winston Castelo urged the leadership of the Philippine National Police (PNP) and the Armed Forces of the Philippines (AFP) to consider his recommendation. He also recommended that posthumous promotions be granted those who were killed in action if such move is allowed under AFP and PNP regulations.

A posthumous promotion may entitle the beneficiaries of deceased soldiers and policemen additional pension and government financial assistance.

Castelo, chairman of the House Committee on Metro Manila Development, said those who were sent to rid Marawi City of Maute terrorists are considered heroes who deserve to be honored by the whole country.

"All officers and uniformed men and women who fought for our peace and security deserve automatic promotion to the next higher rank as a show of the nation's gratitude," said Castelo, chairman of the House Committee on Metro Manila Development.

The QC lawmaker vowed to strongly lobby for additional budget should the proposed promotions require it

He called on Armed Forces Chief of Staff Gen. Rey Leonardo Guerrero

and Philippine National Police chief Director General Ronald dela Rosa to immediately adopt the necessary measures and mechanisms to make the promotion effective as soon as possible.

"Our soldiers and policemen risked life and limb to make sure those terrorists who occupied Marawi and threatened our nation's peace and security would not succeed,"Castelo said, stressing that one way to reward them is by giving them automatic promotion.

Castelo said promotion among members of the armed forces and the police is not easily earned.

"Among them, there is no greater criterion for promotion than service to country in times of grave danger as those who served in Marawi showed," he pointed out.

### More Chinese island-building? Rody relies on 'good faith'

President Duterte is relying on China's "good faith" that it would not embark on new reclamation activities in the South China Sea and West Philippine Sea in the face of renewed concerns sparked by Beijing's launching of a large dredging vessel.

vessel, triggering speculations that it would be used to reclaim Panatag (Scarborough) Shoal.

The shoal is within the Philippines' 200-nautical-mile EEZ, but was declared a "common fishing ground" by an arbitral court based in The Hague. It is only 124 nautical miles off Zambales.

and veterans of the Marawi battle, Duterte said he hoped China could be trusted to keep its word that it would not build new islands in disputed waters or in areas within the Philippines' exclusive economic zone (EEZ)

China recently launched what it In remarks before military officials described as a "magic island-maker"

Duterte said Chinese President Xi Jinping himself had promised not to reclaim Pagasa "and the nearby islands that we have occupied already."

The same assurance, Duterte said, was given to Foreign Secretary Alan Peter Cayetano.

"He will not build something on the Scarborough Shoal," the President said, referring to Xi.

"I just hope that he would honor it because it will change the entire geography of the world. And war starts. I don't know what will be the next geographical division of Asia,"

he added.

While vowing to assert the country's rights over the West Philippine Sea, Duterte stressed it is not yet the time to do it.

The Chief Executive reiterated he would not go to war over the West Philippine Sea as it would result in a "massacre"

of Filipino troops.

"If I were to insist on our arbitral claim as demanded by some of the justices, I would run afoul with everything else because China is not the only power that is claiming a part of the (South) China Sea. Taiwan has a claim and it overlaps the northern part of the country, our economic zones. And Vietnam has another idea of what this is. And Malaysia. And they were starting really to pile up," the President said.

"Instead of just facing one, I'd be facing many. If there are concessions given or conceded, the other countries who are also claimants on the same area will start to assert. That's my problem. It's really the changing geopolitics," he

pointed out.

He also vowed to be "frank" in discussing the maritime row with China on the sidelines of the Asia-Pacific Economic Cooperation (APEC) meet in Vietnam.

Duterte will leave for Da Nang today for the summit, where he is expected to interact with fellow leaders includ-

ing Xi. There was no official announcement if Duterte and Xi would have a meeting in

Vietnam but the Philippine leader hinted that he might have a word with Chinese officials.

A China Daily report said dredging ship Tiankun is 140 meters long and can dredge as much as 6,000 cubic meters of sand or clay per hour from 35 meters below the water's surface. Similar ships were said to have been used to build artificial islands in the South China Sea.

Earlier yesterday at Malacañang, presidential spokesman Harry Roque said Duterte "recognizes the principle of good faith in international relations" when asked to comment on the launching of the dredging ship.

China has told the President, they do not intend to reclaim Scarborough and we leave it at that. We need to rely on good faith because otherwise there would be no predictability in international relations," Roque told a press

China occupied Panatag Shoal in 2012 after a standoff with Philippine Navy vessels, which had tried to arrest Chinese poachers. Chinese maritime surveillance ships harassed Philippine Navy

vessels, enabling the poachers to escape with their illegal harvest of giant clams, endangered corals and baby sharks.

The Panatag standoff prompted the Aquino administration to contest China's massive claim in the South China Sea before the Permanent Court of Arbitration, which eventually validated Manila's position. Beijing had vowed not to comply with the ruling.

Asked whether the President would question the launching of the vessel, Roque replied: "As I said, he has relied completely on the principle of good faith. Which is, in fact, a fundamental and cardinal principle of international law."

Roque noted that Duterte has opted to maintain very close and cordial relationship with China despite the dispute over some areas in the West Philippine Sea.

"I think we are seeing new heights in terms of Philippine-Chinese relations and it has resulted in very tangible results, particularly economic investments," he said.

China has undertaken massive reclamation activities in Kagitingan (Fier) Cross), Pan-

ganiban (Mischief), Zamora (Subi), Burgos (Gaven), Kennan (Hughes), Mabini (Johnson) and Calderon (Cuarteron) Reefs, areas located off the western province of Palawan.

Airstrips, radar systems and barracks were also seen on the reefs, reinforcing theories that China is shoring up its military might in the region.

China has denied militarizing the South China Sea and maintained that it is committed to maintaining peace and stability in the region.

Meanwhile, construction of a beaching ramp in Pagasa Island in the Kalayaan Island Group has started in preparation for more improvements of military and civilian structures in the island town, the Department of National Defense said.

Defense Secretary Delfin Lorenzana, through spokesman Arsenio Andolong, said the construction ramp is expected to be completed early next year, depending of weather conditions.

The defense official said a beaching ramp would allow large ships to dock and unload construction materials. -Alexis Romero, Jaime Laude

### DUTERTE TO HOLD CHINESE LEADER TO HIS WORD ON PANATAG SHOAL

President Duterte said yesterday that he was keeping faith in the word of honor of Chinese President Xi Jinping, who promised that China would not encroach into Philippine territory in Panatag (Scarborough) Shoal.

"I just hope that he would honorit because it will change the entire geography of the world," said Mr. Duterte at the sixth anniversary of the Philippine Marines.

He said "war starts" if there was any aggression in disputed territories in the South China Sea. "I don't know what would be the next geographical division of Asia," said Mr. Duterte.

He also recalled that he had told Xi that the Philippines would not give up its claim on Pag-asa Island and nearby islands which the Philippines occupies.

Mr. Duterte's spokesperson, Harry Roque, earlier said that the President trusted China and believed it would not create artificial islands in Philippine waters, especially with the use of its newest mammoth island maker, a ship that could dredge 6,000 cubic meters of sand per hour.

Dredging tests

Defense officials were trying to monitor the movement of the giant dredging ship, Tian Kun Hao, after Chinese media reported that it started tests in waters that China claimed to be part of its territory.

Defense Secretary Delfin Lorenzana said it would be a cause of concern if the ship was deployed to the West Philippine Sea.

Roque said Mr. Duterte was keeping faith in China, however.

"The President recognizes the principle of good faith in international relations," said Roque.

"China has told the President they don't intend to reclaim Scarborough. We leave it at that. We need to rely on good faith," he said.

"Otherwise, there will be no predictability in international relations," Roque said at a press briefing.

Asked if the President would discuss Philippine defense officials' concern about the ship with China, Roque reiterated that Mr. Duterte relied on the principle of good faith.

He also said the Philippines was not just trusting China, but also relying on the ruling of the Permanent Court of Arbitration, which remains unchanged. INQ

### Duterte relies on China's good faith in sea dispute

resident Duterte is relying on China's promise that it will not claim islands in the disputed portion of the South China Sea, Malacañang said Tuesday.

This was stressed in the wake of reports that China is now testing the Tian Kun Hao, its biggest islandmaking vessel.

According to Presidential spokesman Harry Roque, President Duterte has opted to maintain a good relationship with China and to rely on good

faith. "The President recognizes the principle of good faith in international relations," Roque said in a Palace press briefing Tuesday.

"We need to rely on good faith

because otherwise there would be no predictability in international relations," he added.

According to Roque, the Chinese government assured Duterte that there will be no reclamation activities in the disputed waters.

"As I said, he has relied completely on the principle of good faith. Which is, in fact, a fundamental and cardinal principle of international law," he added.

Roque also said that the International Tribunal Court's decision to grant the Philippines sovereignty over the disputed waters still stands, despite the President's decision to set it aside for a while.

"We have a decision, the last time I checked. And that decision remains unchanged. It has said that the artificial islands form part or are built in our EEZ

(exclusive economic zone)," he said.

"Meanwhile, the President has opted to maintain very close and cordial relationship with China. I think, we are seeing new heights in terms of Philippine-Chinese relations and it has resulted in very tangible results, particularly economic investments," he added.

The Department of National Defense (DND) said that it is now closely monitoring the Tian Kun Hao amid suspicions that China's biggest dredger will be deployed in either the South China Sea or the Pacific Ocean.

"We have reports that they launched their big dredger, but we don't know where it is going. We are constantly monitoring the movement of this ship," Defense Secretary DelfinLorenzana earlier said.

Xinhua, China's state-run news outlet, had earlier reported

that China will abide by the Code of Conduct in the South China Sea and "won't use the dredger to expand its artificial islands.

President Duterte, being chairman of this year's Association of Southeast Asian Nations (ASEAN) Summit, has been pushing for the peaceful resolution on the South China Sea.

A year ago, the Permanent Court of Arbitration in the Hague declared China's claims to the disputed South China Sea as invalid.

But Duterte opted to set aside the ruling for the time being and preferred to establish better ties with China first, promising to revisit and to talk about with China before his term ends.

### DANGEROUS DRUGS BOARD

The head of the country's narcotics control body has resigned after just five months in the job, the second successive official to vacate the post after making statements contradicting President Duterte.

Retired Gen. Dionisio Santiago, former chief of staff of the Armed Forces of the Philippines, told Radyo Inquirer 990AM on Tuesday that he quit as chair of the Dangerous Drugs Board (DDB) after receiving a call from Mr. Duterte's executive secretary, a few days after he publicly said the construction of a 10,000-bed drug rehabilitation center in Nueva Ecija province was a mistake.

Santiago said Executive Secretary Salvador Medialdea had called him to say Mr. Duterte interview on Oct. 31 that the wanted him to resign.

#### "The boss is always right"

"My rule is the boss is always right and if you think the

boss is not right, refer to rule No. 1," Santiago said, adding he sentence resignation letter.

Countering illegal drugs is Mr. Duterte's signature program and he has repeatedly threatened to kill dealers and users and said he was willing to be jailed for it.

Police have killed thousands of people in carrying out Mr. Duterte's war on drugs, but the administration insists it is committed to arresting dealers and rehabilitating users, citing the new rehabilitation center in Nueva Ecija and the voluntary surrender of 1.3 million addicts and pushers as a sign of its positive intent.

Santiago told a television government might have overestimated the effectiveness of the rehabilitation center and should have pursued a practical community-based rehabilitation program.

Fewer than 500 people have had already submitted a two-been admitted to the rehabilitation center in Fort Magsaysay, which was Nueva Ecija, launched last year amid great fanfare and was funded by a wealthy Chinese businessman.

Santiago was pushing for a strategy in the narcotics crackdown that would be aligned with the social reform program of Mr. Duterte and would work closely with the National Youth Commission.

#### Family support system

He said a community-based rehabilitation program for drug users would be more effective than the "mega drug rehab" center, pointing out that a family support system was vital to the recovery of drug users.

Santiago said the rehabilitation center in Nueva Ecija was "impractical."

### Military verifying if Malaysian terrorist still alive

ZAMBOANGA CITY - The Armed Forces' Western Mindanao Command (Westmincom) is verifying reports that Malaysian militant Amin Baco, who was reported killed in the final Sayyaf, had allegedly replaced the

stage of the Marawi operation, has taken over as emir of the Islamic State (IS) for Southeast Asia, an official said vesterday.

Baco, who had been hiding for a long time with members of the Abu group's leader and IS chief Isnilon Hapilon, who was killed by troops in Marawi City last month, according to the Philippine National Police (PNP).

But Lt. Gen. Carlito Galvez Jr., Westmincom chief whose units neutralized the IS leadership including Hapilon and the Maute brothers, said

Baco was among the foreign militants killed in the main battle area in Marawi.

Baco was reportedly killed along with Malaysian university lecturer and IS recruiter Mahmud Ahmad during the final stage of the military of-

"We are still validating the report on Amin Baco since we have reports that he might be included in the recently killed stragglers," Galvez said, referring to remnants of the militants hiding to escape the government troops' clearing operation.

Galvez said the remnants of the IS have been on the run and could not regroup to select a new leader.

PNP chief Director General Ronald dela Rosa disclosed that Baco took over as IS head after the death of Hapilon.

Dela Rosa said Indonesian terrorist Muhammad Ilham Syahputra, who was

captured in Marawi last week, claimed that Baco had replaced Hapilon.

Baco, based on the intelligence reports, had been in hiding in Mindanao with the Abu Sayyaf and previously worked with another Malaysian bomb maker, Zulkifli bin Hir, alias Marwan, who was killed in 2015, during a police operation in Mamasapano, Maguindanao where 44 members of the police Special Action Force were killed in an encounter with Muslim rebels.

Baco managed to escape from Mamasapano and later joined the Maute group.

he commanding general of the Philippine Air Force (PAF) said that the service command spent some ₱1.44 billion in the war in Marawi City.

In a speech he delivered during the Heroes Welcome Ceremony hosted by the PAF to its personnel held at Villamor Air Base, Pasay City on Monday, Lt. Gen. Galileo Gerard Kintanar Jr., said at least 1,007 airmen involved in the offensive to defeat Daesh-inspired Maute terrorists were pilots, forward air controllers, and support personnel accomplished 1,358 sorties and flown a total of 4,950 hours.

Kintanar also said that a total of 6,716 soldiers and policemen were transported while hundreds of wounded were extricated and evacuated out of harms way, during the five-month war.

"Today, we give them honor, we pay them tribute, and as a fulfilled Air Force, we bask in their hardearned contribution to victory," Kintanar said.

Kintanar said that if he was to make a good accounting of the Air Force assets used, a fair representation of the majority can be found right inside Villamor Air Base.

### NEDA: Marawi rehab planning in full swing

The assessment of the rehabilitation needs in Marawi is in full swing as the military clears more areas, the National Economic and Development Authority (NEDA) said yesterday.

Task Force Bangon Marawi is preparing a Comprehensive Rehabilitation and Recovery Plan for the city and surrounding areas, Adoracion Navarro, NEDA undersecretary for regional development, told a press briefing.

Navarro said NEDA completed the assessment of 49 of the 96 affected barangays.

At least 77,170 families or 353,921 individuals affected by the fighting between government troops and Maute militants are staying in 69 evacuation centers in Lanao del Norte and Lanao del Sur.

Navarro said evacuees are continuously being provided relief assistance, including health services. She said those who opted to return to Marawi after the city was declared liberated from terror-

ists are also being provided with recovery assistance, such as transitional housing and cash for work.

Navarro said several development partners, such as multilateral development banks, have offered assistance, but have yet to make formal commitments. The World Bank and Asian Development Bank are among those that offered loans and technical assistance.

The government is initially allocating P5 billion for the early recovery phase, the bulk of which will be spent for health and social services.

### P4B spent to defeat Maute in Marawi

THE Armed Forces spent nearly P4 billion in the five-month operation to rid Marawi City of the terrorist Maute Group, according to Defense Secretary Delfin Lorenzana.

The military terminated the operations on October 23. Clearing operations have resulted in the killing of 15 Maute stragglers and the arrest an Indonesian terrorist.

During the celebration of the DND's 78th foundation anniversary on Monday, Lorenzana said the "liberation of Marawi from the hands of terrorists" is the DND's "most significant accomplishment" since the last DND anniversary.

Lorenzana last month said government has allotted P5 billion this year for the rehabilitation of the city, particularly for supporting evacuees, reconstruction of infrastructure, and repair of bridges.

For next year, government is eyeing a budget of P10 billion for

rehabilitation efforts.

Sen. Gregorio Honasan estimated the cost of rehabilitation at P50 billion over a period of three years. Honasan is chairman of the Senate special committee on Marawi, which is tasked to assess and examine matters relating to the rebuilding of Marawi City.

Lt. Gen. Galileo Gerald Kintai.ar, Air Force chief, said his command spent P1.4 billion in the Maravi conflict which saw the deployment of a number of and AW-109 multi-purpose attack helicopters.

"The statistics and numbers of our air campaign in Marawi are many: At least 1,007 airmen involved composed of pilots, forward air controllers, and support personnel; 1,358 sorties accomplished; 4,950 hours flown; 6,716 soldiers and police transported; hundreds of wounded extricated and evacuated out of harms way; and an operational cost of P1.448 billion," said Kintanat.

### PH Navy to take part in exercises in Thailand

THE Philippine Navy is sending two of its ships and about 600 personnel to Thailand to take part in the first ever Asean Multilateral Naval Exercise (AMNEX) that will be held from November 13 to 22.

The two ships - the strategic sealift vessel BRP Tarlac and the frigate BRP Gregorio del Pilar - and personnel will be sent off today by senior Navy officials from the South Harbor in Manila.

"AMNEX 2017 is the first ever maritime security collaboration of navies in the Southeast Asia region hosted by the Royal Thai Navy," said Navy spokesman Lued Lincuna

The exercise will be held off Sattahip Naval Base in the northern part of Gulf of Thailand.

Lincuna said AMNEX is being conducted in conjunction

with the commemoration of the 50th founding anniversary of ASEAN, along with the International Fleet Review on November 19 and the 11th ASEAN Navy Chiefs' Meeting from November 18 to 19.

The BRP Tarlac was among the Navy ships sent to support military operations against the Maute Group that attacked Marawi City on May 23.

The combat operations against the terrorist group were terminated on October 23 although clearing operations against Maute stragglers are ongoing.

The Marawi conflict resulted in the death of at least 900 terrorists, including senior Abu Sayyaf leader Isnilon Hapilon, said to be the leader of the Islamic State for Southeast Asia, and Maute leaders Omar Maute and Abdullah Maute. – Victor Reyes

### Doc says IS hacked his accoun

A Filipino doctor accused of dic surgeon, appeared on the first day of the hearing in Manila to extradite him to the United States. In a written deposition, Salic said IS and its sympathizers gained control of his online accounts after he "condemned" the group in 2015.

"This group was able to 'hack' my FB (Facebook) account and my e-mail address account," he said in the signed statement his lawyer submitted to the court last month and obtained by Agence France-Presse (AFP) on Tuesday.

US authorities and the

Philippine military have accused Salic of posting pro-IS content online and sending money to other countries in support of the jihadists.

Salic is accused of transferring \$423 in May 2016 to the other suspects as part of the thwarted operation, which was planned through internet messaging, according to the US justice department.

The bombing plot was monitored by an undercover Federal Bureau of Investigation agent posing as a fellow jihadist, US authorities said.—AFP




