HE Armed Forces of the Philippines (AFP) on Saturday threw its support behind localized peace talks with communist rebels after President Rodrigo Duterte's decision to cancel negotiations with the National Democratic Front (NDF).

AFP Chief of Staff General Rey Leonardo Guerrero issued a statement a day after the military's declaration of all-out offensives against the New Peoples' Army (NPA), the armed wing of the Communist Party of the Philippines (CPP), through "focused operations."

"The AFP supports the decision of the President to cancel talks with the CPP NPA and NDE, and to go 'all out' against

the NPA terrorists," Guerrero said in a statement on Saturday.

"The AFP also supports peace initiatives by our local elected officials including programs that seek to integrate NPAs back to mainstream society," Guerrero said.

Guerrero defended Duterte after CPP founder Jose Maria Sison's statement

that the President deliberately sabotaged the peace talks.

Guerrero was quick to point out that the military still supported the peace initiatives at the local government level, led by local executives.

On Friday, AFP spokesman Maj. Gen. Restituto Padilla Jr. said peace talks led by local government units (LGUs) could be the "bright spot" in the peace process.

"We will continue to campaign, together with the LGUs, to pursue peace talks because even though the formal talks at the national level have ended, our local [government units] and our forces will be joining forces to give chance to those on the mountains to go back to their normal lives," Padilla added.

'Sison entitled to his opinion'

Malacañang shrugged off the accusation by Sison that his former student, President Duterte, is the "No. 1 terrorist in the Philippines."

"Everyone is entitled to his or her own opinion," Palace spokesman Harry Roque said in a statement.

"The President, we have to underscore, terminated the peace talks after their members had failed to show their sincerity and commitment in pursuing genuine and meaningful peaceful negotiations with their continuous acts of violence and atrocities," he added.

Sison accused Duterte of being a terrorist after he ended the peace talks with the National Democratic Front.

"He is culpable for the abduction, torture, and mass murder of an increasing large number of poor people suspected as drug users and pushers, peasants and indigenous people in suspected guernilla fronts and Moro people suspected of aid-

ing the Dawlah Islamiyah from the time of the indiscriminate bombing of Marawi City to the present in several Bangsamoro areas," Sison said in a statement.

The President on Thursday signed Proclamation 360 terminating the peace talks with the rebels, represented by the NDF. Duterte slammed the NPA for attacking government troops and civilians, and extorting money from them to fund their activities.

Roque said the President "walked the extra mile for peace as he has always wanted to leave a legacy of peace under his administration."

But Sison, the NDF's chief consultant in the peace talks, refuted Roque's statement and said Duterte "maliciously sabotaged" the peace process, which was being brokered by Norway.

"In the course of his rants, Duterte unwittingly exposed his scarce, shallow and defective knowledge of the peace process," Sison said.

"Among [Duterte's] lucid statements ... are those pertaining to his voluntary admission as a fascist in the service of the [United States], his overwhelming desire for killing and war, and his advice to the [NDF] to negotiate with his successor in due time," he added.

In formally declaring the government's withdrawal from the peace talks, the President also bared plans to declare the NPA a terrorist group and to crack down on its "legal fronts."

On Friday, Duterte said he decided to cut talks with the communist rebels as the group sounded like they wanted a "coalition government" with his administration.

"As it was shaping up during our talks, I already noticed the trend of the thoughts of the other side

and when I summed it all, reading from all previous working papers, it would sound like a coalition government," Duterte said in a speech in Bulacan: "That is why I said in the previous days, I cannot give you what I don't own and certainly a coalition with the Republic of the Philippines is pure nonsense."

The President halted talks with the rebels in July following a series of attacks by the NPA, against government forces. He said he would not resume the talks unless the rebels stopped their extortion activities.

The fifth round of talks brokered by Norway was suspended on May 27 after the government panel withdrew from the negotiating table in response to the communist group's order to guerrillas to intensify attacks against security forces amid martial law in Mindanao.

resident Duterte said Communist Party of the Philippines (CPP) founder Jose Ma. "Joma" Sison should forget about returning to his motherland if he

does not want to land behind bars.

"If Joma Sison comes here, I will arrest him, Or if I were him, 'wag na siyang bumalik dito (I will not return anymore)." Duterte said in his speech during the San Beda Law Alumni Homecoming in Makati City late 11

Friday evening.

His statement comes after he signed Proclamation No. 360, officially terminating the peace talks between the government and the CPP-New People's Army-National Democratic Front (CPP-NPA-NDF).

At the same time, Duterte ordered the military to rearrest the CPP-NPA-NDF leaders; and that includes Sison and those he ordered to be temporarily released from detention so they could participate in the formal peace negotiations in Norway.

"I released about 32 of them, political leaders, ideological leaders, to show good faith and the confidence-building period which is really very necessary in talking to them and to the enemies of the state," said Duterte.

But his tone has changed with Sison, saying he will not allow the leader of the CPP, whom he earlier labeled as "dying," to return to the Philippines.

"I will not allow him to enter his native land and that is a very painful experience, especially if you're dying and you think na ((ihat) you should be buried in your own OFF cemetery, in your own town," he said Meanwhile, Duterte shrugged off Sisson's recent tirades, accusing him of sabota ging the peace talks and calling him the Nio. 1 terrorist in the Philippines.

He said Sison is entitled to his own opinion despite their irreconcilable values.

"You are entitled to your own opinion but the fact is we cannot ever agree on the so many things that you demand of me," Duterte said.

Sison, in a statement, said Duterte.

"unwittingly exposed his scarce, shallow and defective knowledge of the peace process." He added that Duterte is the country's top terrorist.

"Duterte is the No. 1 terrorist in the Philippines He is culpable for the abduction, torture, and mass murder of an increasingly large number of poor people (who are) suspected drug users and pushers, peasants and indigenous people in suspected guerrilla fronts and Moro people suspected of aiding the Dawlah Islamiyah from the time of the indiscriminate bombing of Marawi City to the present in several Bangsamoro areas," Sison said.

Before this, Sison called Duterte the "No. 1 drug addict" who should be the target of the police.

"Duterte is the number one drug addict in the Philippines and is the most fitting target of the police units that he has turned into death squads and corrupted with money and promotions." Sison, Duterte's former college professor, said last July.

Duterte's relationship with the Left started to turn sour after the rebels launched a series of ambuscades in Bukidnon which left three soldiers dead last February.

But Duterte seemed to have had enough when news broke out of the encounter between the NPA and members of the Presidential Security Group (PSG), leaving six members of the PSG wounded, last July.

Duterte, since then, expressed his unwillingness to continue with the peace negotiations, saying Sison is acoward for leaving his men in the coun-

try to fight his war for him.

Bridging the gap

Individual members of the 24-man Senate may act as a bridge between the Philippine government and the leftist organizations for peace initiatives to move forward after Duterte stalled it when he closed the doors to negotiations.

Senate President Aquilino Pimentel III, a political ally of the President, said all doors to negotiations should not be closed as the Upper Chamber is opening unofficial channels to be used by any of the two negotiating panels.

Pimentel anchored his position on the Senate's acting as "listening or relay post" because it considers all parties to the negotiations as part of its constituency and that "we are in one country."

"We are politicians. There should be openness," he said, but in the same breath, refused to consider the Senate as a "backdoor channel."

But while the Upper Chamber has yet to establish the "bridge" between the government and the Left, Pimentel said his office is already open to talking with groups

"Isa lang naman yung bansa natin, ang nag-aaway Filipino sa Filipino din Eh constituents din naman naming lahat yan eh (We have only one country After all, they are also our constituents)," he noted

The Senate chief, however, said the CPP-NPA-NDFP should be committed in settling issues with the government in order to regain the President's trust. "Kası kahit naman bukas yung pintuan for official peace talks, may attacks pa din. Dun nagagalit ang ating pangulo (Here's what – even if the doors for official peace talks are open, their attacks

continue. That's what fires up the President)," he said.

"So something must change," he emphasized

Pimentel said he understands the President in terminating the peace talks because the NPA has, like in previous administrations, been sabotaging it by staging ambuscades and killings with policemen and soldiers accounting for the majority of casualties, setting on fire equipment of mining companies, and collecting "revolutionary" taxes.

He brushed off claims of leftist organizations that the President is a "dictator" and that he is abusing his powers.

Pimentel maintained that Duterte considers that his decisions, under his jurisdictions. "He is just exercising his powers (President)," said Pimentel. (With reports from Mario B. Casayuran and Vanne Elaine P Terrazola)

here will be more blood. President Duterte, already being criticized for the bloodshed that marred his war on drugs, told soldiers to prepare for heightened violence following his decision to scuttle peace talks with communist rebels.

The rebels, Mr. Duterte told members of the First Scout Ranger Regiment, "will strike again."

"There will be virulent confrontations," he said a day after signing Proclamation No. 360 terminating peace talks with communist rebels.

"Be prepared for that," said the President, who wore a Ranger uniform in a gesture that appeared to deliver the message that he was ready for a full-scale war with communist rebels.

CPP warning

The President issued the warning shortly after Jose Maria Sison, founder of the Communist Party of the Philippines (CPP), declared there would be more rebel attacks as a result of Mr. Duterte's decision to end the talks.

Mr. Duterte told Rangers he would not allow the Armed Forces to be at a disadvantage in the war on the New People's Army (NPA), the armed wing of GPP which has been waging a Maoist revolution for nearly 50 years.

"I will not allow a weak military or police," he said at his speech at the Ranger camp in San Miguel, Bulacan.

"I intend to build a strong Armed Forces and police," he said. "If I don't they will just push us around," Mr. Duterte said. He said he was willing to spend more on weapons and war materiel for the military but that these should be brand new. "No more hand-medowns," the President said.

Open unofficial doors

War with the rebels was also the theme of Mr. Duterte's speech to alumni of his alma mater, San Beda College.

"You can somewhat expect a more violent activity of all sorts," he said.

A key ally of Mr. Duterte, however, said the government should not close all the doors to peace.

III, a top official of Partido Demokratiko Pilipino-Lakas ng Bayaban party which carried Mr. Duterte in the 2016 presidential election, said if official channels for talks with rebels had been closed there should be an effort to open unofficial ones.

"If the official door to peace talks is closed, we have to open unofficial doors," said Pimentel in a radio interview on Friday.

He said the Senate or senators could serve as a bridge for peace.

"That openness must be there but I'm not saving that we've already established a connection," Pimentel said.

He said he understood Mr. Duterte's

anger over soldiers and policemen getting killed outside of combat.

Feeling betraved

In his speeches on Friday, the President tried to explain his decision to end the talks.

"Even if we talk for a thousand years, we can never reconcile our values," said Mr. Duterte, who gained national prominence as mayor of Davao City for receiving captives freed by communist rebels operating in Davao.

He said he could not agree to coalition government with the rebels. But Sison, self-exiled founder of CPP, said Mr. Duterte was lying

about the coalition government.

Sison said talk about a coalition government came from Mr. Duterte, not the rebels. But Mr. Duterte said he studied the papers being discussed in the negotiations and felt that they all led to a coalition government.

The President said he was left with "no choice" but end the talks when rebels persisted in attacking government fargets, collecting revolutionary taxes and attacking companies that refused to come across.

Inner conflict

Sison, however, said Mr. Duterte was suffering from a conflict between what he says and what he does.

"He vowed to wage war on drugs but the problem has become far worse because his own family was involved,' Army Core Sison said.

Mr. Duterte, added Sison, vowed to wipe out corruption "but he got himself elected to the presidency by allying himself with extremely corrupt families."

The President said he decided to end the talks because he cannot give "a portion of sovereignty which nobody can own except the Filipino people."

Mr. Duterte did not elaborate on what he meant by sovereignty, but part of the agenda in negotiations between government and rebel representatives were proposed agreements on social and economic reforms, including a more thoroughgoing land reform program.

Part of what drove him to end the talks, Mr. Duterte said, were continuing attacks by NPA even on policemen and soldiers just "going home to their families."

He said he was also angered by the continued collection of taxes by rebels even when "we were talking already."

"Let's just shoot each other." Mr. Duterte said. -with a REPORT FROM CARMELA REYES ESTROPE

FSRR Commander Brigadier General Rene Glen Paje and his men met the President when get off from the presidential chopper donning Scout Ranger uniform.

Duterte made it to the event despite the bad weather and received the Honorary Scout Ranger Badge presented by Paje in recognition of his "invaluable support" to the Philippine Army's special operations command unit.

Rody to give Ecija drug rehab center to soldiers

DAVAO CITY – President Duterte said he is giving the 10,000-bedroom mega drug treatment and rehabilitation center at Fort Magsaysay, Nueva Ecija to the Armed Forces of the Philippines.

"I gave it to the soldiers. There are no takers," the President said in Filipino during the

centers closer to the communities of drug offenders would have been better.

But Duterte pointed out that making it hard for families to visit their loved ones under rehabilitation is exactly the point.

"That is precisely the reason, alienating them in the meantime from all things," the President said, noting that rehabilitation involves isolating a patient from his or her family for a certain period of time.

He lamented that although

the Nueva Ecija facility is a very good area for rehabilitation, there were no takers as families of drug addicts apparently opted for community-based rehab.

But health undersecretary Roger Tong-an said 60 drug dependents who underwent treatment at the mega center are set to graduate on Nov 29, just in time for the facility's first founding anniversary next week.

The former drug addicts comprise the third batch of

San Beda Law Alumni Homecoming the other night.

Chinese philanthropist Huang Rulun built the facility to help in Duterte's anti-drug efforts.

He earlier fired former Dangerous Drugs Board chair Dionisio Santiago after the latter called the building of the facility a mistake and that smaller

drug surrenderees liberated from their drug addiction, he added.

"They stayed there from four to six months to undergo rehabilitation," Tong-an said.

rehabilitation," Tong-an said. He said 102 surrenderees have already graduated from the program and endorsed to the Department of Social Welfare and Development and local government units (LGU) for "reintegration" in the community. A system is also in place to monitor those who have been discharged to ensure they would not go through a "relapse."

The graduates have also

been provided with livelihood training to help them get back on their feet after their release.

Tong-an said that, based on the assessment of health personnel in the community, only one percent of surrenderees have "severe" addiction requiring confinement at the center. The rest can just go through community-based treatment and rehabilitation under LGU supervision.

Data from the Department of Health showed that only 663 drug dependents have so far been admitted at the center, amajority of whom came from

the National Capital Region, Region 3 and Region 4-B.

Most of them were unemployed while others were tricycle drivers and construction workers. At least one was identified as a barangay captain.

"A rehabilitation center plays a vital role in our war against illegal drugs. Mere counseling does not work for many drug dependents so it is important for them to be kept."

"We monitored their-recruitment during the first quarter of the year It is still ongoing," said Encinas.

Duterte aching to become dictator, says Joma

President Duterte is aching to be a fascist dictator like the late strongman Ferdinand Marcos as proven by his decision to cancel the peace talks with the communist rebels, Communist Party of the Philippines founder Jose Maria Sison said yesterday.

"As a President in a rush to become a tascist dictator, he expects to have limitless opportunities for bureaucratic corruption like his idol Marcos, especially in overprice infrastructure projects, government purchases and cheap sale of raw materials," Sison said in statement released by the National Democratic Front (NDF).

Duterte on friday ordered the cancellation of the talks after rebel negotiators reportedly insisted on forming a coalition government. The President said the proposal was "pure nonesense."

"Duterte does mind being proven a big liar on the question of coalition government. He thinks that he can move on from success to success at political swindling. Now, he is being carried away by his obsession to establish a fascist dictatorship through charter change under the pretext of adopting a pseudo-federal system under his over centralized despotism and terrorism," Sison said.

He said Duterte reneged on his campaign promise of forming a coalition government with the left and the Moro Islamic Liberation Front.

"To prove that Duterte is a big liar on the question of coalition government, I call the attention of the Filipino people to the following news links," Sison said citing several news reports.

Sison added Duterte failed on his promise to rid the country of illegal drugs saying the drug problem is still around after almost two years and has even gone worse.

"This is because his family is involved in large-scale drug smuggling and his regime protects the biggest drug lords and protectors at the level of governments and generals, while engaging in the mass murder of more than 14,000 poor suspected drug users and pushers," he said.

Sison also criticized Duterte for his failure to addressing corruption in the government. He also accused the President of amassing great amount of undeclared wealth by collecting huge campaign funds from 2014 to 2016.

Marawi bishop backs martial law extension

MARAWI Bishop Edwin de la Peña is in favor of another extension of martial law, but only in specific areas and not in the entire Mindanao.

"Not for whole of Mindanao, but perhaps we can understand if it is extended in specific areas," de la Peña said over Church-run Radyo Veritas.

"For me it is unwise to put the whole of Mindanao in Martial law but specifically in areas that are in tension," he said.

The prelate said martial law in some places in Mindanao could help Marawi's rehabilitation.

"The clearing process is going to take a long time, and so we do not look forward to the start of reconstruction of Marawi church, it may take a long time before we can do that. We are more focused on locating our Christian population because it's very important that you establish, you build up the community before building the structures." he added.

Martial law was declared in Mindanao on May 23, when fighting in Marawi, the country's Islamic capital, broke out.

Under the 1987 Constitution, the declaration was limited to 60

days On the request of President Rodrigo Duterte, Congress extended martial law until December 31.

A day after the deaths of Isnilon Hapilon and Omar Maute in October. Duterte declared Marawi liberated from the influence of terrorists, allowing the government to shift its focus to rehabilitating the city.

Some sectors have asked Duterte to lift martial law now that security forces have eliminated the terrorist leaders.

But the military said martial law was still needed to curb terrorist networks in other parts of Mindanao like Basilan and Sulu. On November 18, Malacañang said it accepted the recommendation of the military on the possible extension of martial law in Mindanao. President Rodrigo Duterte however has yet to decide on the matter.

"You know, the declaration of martial law is always dependent on what the Armed Forces and the police recommends. They are the two entities that would be relied upon heavily by a president or head of states when we entertain something like extreme measures, martial law, state of emergency," Duterte said.

NPA INFLICTS P2-B LOSSES ON E. MINDANAO, SAYS AFP

NEW People's Army's atrocities have the rate of destruction from the 2016 caused damage to property and equipment worth P2.17 billion in Eastern Mindanao in 2017, a scourge tantamount to "economic sabotage," the Armed Forces of the Philippines said Saturday.

AFP spokesperson Maj. Gen. Restituto Padilla Jr. in an interview on Super Radyo dzBB said the over P2-billion figure represented an accumulated damage from NPA attacks in "more than 50" incidents of burning and destroying business implements from January to November 2017.

"This was based on field reports submitted and duly validated" on the ground," Padilla said in a message to GMA News Online:

In the radio interview, he also said there was a 2,000-percent increase in

accumulated figure estimated at "more than P100 million" in 36 hostile incidents.

And this is on top of the AFP's "modest estimate" of P2.2 billion in "extorted money" from mining companies among other businesses that the rebel group has collected in the Mindanao area, he pointed out.

He told GMA News Online the estimate was based on a study by the Eastern Mindanao Command.

Meanwhile, a policeman was killed and 10 others wounded when they were ambushed by communist rebels in the town of Maasin, Iloilo on Friday evening.

Maasin is the same town where, in June, New People's Army guerrillas took control of the municipal police station

without firing a shot and carted off several weapons and other equipment.

The Friday ambush took place a day after President Rodrigo Duterte signed Proclamation No. 360 formally terminating peace negotiations with the National Democratic Front, and two days after three policemen were wounded in a rebel ambush in Sibalom, Antique.

News reports said the police personnel, belonging to the 6th Regional Public Safety Battalion, were on a patrol vehicle and a private car when they were attacked early Friday evening. The lone fatality was identified as Police Officer 1 Jofer Odon.

Most of the wounded policemen were taken to Iloilo City.

On Saturday, the Coronacion "Waling-Waling"Chiva Command of the NPA on Panay acknowledged the attack, which it said was carried out in Barangay Bolo by a unit of the Jose Percival Estocada Jr. Command in Central Panay, although it claimed 12 policemen were wounded.

It also called the Sibalom incident an ambush pulled off by the Napoleon Tumagtang Command of Southern Panay.

On the same day as the Maasin ambush, Concha Araneta, spokesperson of the NDFP on Panay, issued a statement belittling Duterte's branding them "terrorist," saying this was no different from what past presidents since the late President Ferdinand Marcos had done.

President Duterte on Thursday signed a proclamation declaring the end of peace negotiations with the Communist Party of the Philippines-NPA-National Democratic Front of the Philippines

The reason, the presidential spokesperson said, was the "engage[ment] of the NDFP-CPP-NPA in acts of violence and hostilities."

SWS: 77% of Filipinos support Marawi rehab

EIGHT out of 10 Filipinos are satisfied with the government's efforts to rebuild Marawi City, according to the latest Social Weather Stations (SWS) survey.

The poll, conducted from September 23 to 27, found that 77 percent of Filipino adults were satisfied with the steps taken by the Duterte administration in restoring the country's Islamic capital.

Only 8 percent of the respondents said they were dissatisfied with the government's work in rebuilding the besieged city, while 15 percent were undecided.

This yielded a net satisfaction rating of +70, which the pollster classified as "excellent."

SWS said satisfaction with undertak-

ings to reconstruct Marawi was highest in Mindanao at an excellent +77, followed by Metro Manila at an excellent +75, Balance Luzon at a very good +66, and the Visayas at a very good +65.

By education, satisfaction was an excellent +76 among college graduates, and an excellent +74 among high school graduates. It was a very good

+67 among elementary school graduates and a very good +54 among nonelementary school graduates

By religion, satisfaction was within the excellent net satisfaction rangeamong Iglesia ni Cristo members (+75) and religions other than INC, Islam, and Roman Catholicism (+72). It was

within the very good net satisfaction range among Roman Catholics (+69) and Muslims (+65).

The same survey also found that 53 percent of Filipinos said it would take five years or more before the areas damaged by the Marawi City crisis could fully recover.

Forty-six percent said bringing back normalcy to Marawi could take one to four years while the remaining one percent were undecided.

"It hardly varied across locale, educational level, and religion," SWS said.

The survey was done using faceto-face interviews of 1,500 adults nationwide — 600 in balance Luzon, and 300 each in Metro Manila, the Visayas, and Mindanao It had a sampling error margin of ±3 percent for national percentages, ±4 percent for Balance Luzon, and ±6 percent each for Metro Manila, the Visayas, and Mindanao.

To recall, President Rodrigo Duterte declared Marawi City free from the Maute group on October 17, 2017, following 21 weeks of fighting between government troops and terrorist forces.

Repair of Marawi schools starts

LANAO DEL SUR – Classes in more schools in Marawi are expected to resume as the repair and rehabilitation of school buildings damaged in the fighting between Maute militants and government troops has started.

The Department of Education in the Autonomous Region in Muslim Mindanao will prioritize the repair of seven schools near the main battle area, John Magno, DepEd-ARMM director, said yesterday.

At least P34 million was initially allocated for the repair of the said schools.

Classes in more than a dozen schools in Marawi resumed last month shortly after President Duterte declared the city liberated from terrorists.

Magno said security forces also approved the resumption of classes at the Matampay, Tampilong, Datu Saber, Basak, Amai Pakpak and Pandi Elementary Schools.

Zenaida Unte, DepEd-ARMM assistant schools superintendent, said classes at a national high school also resumed recently.

Police and military personnel are securing the reopened schools.

Alfhadar Pajiji, DepEd-

ARMM deputy director, visited Marawi on Wednesday to inspect campuses cleared of booby traps planted by the terrorists.

The fighting in Marawi displaced around 60,000 elementary and high school students. At least 22 schools in the main battle area were destroyed.

Many of those displaced are attending remedial classes at temporary learning centers outside Marawi. The DepEd-ARMM, Gawad Kalinga and

World Food Program of the United Nations have been providing free meals to the students.

"The executive department of ARMM is doing its best to address the problem. The main office of DepEd is also extending its support," Magno said.

ARMM Gov. Mujiv Hataman announced last Monday that the regional government would allocate P930 million for rehabilitation projects in

Marawi.

Marawi Mayor Majul Gandamra, who is also chairman of the Marawi peace and order council, said many evacuees returned to the barangays that were declared safe and cleared of debris.

Marawi will be able to recover in at least 5 years

Majority of Filipinos believe that Marawi City will be able fully recover from the devastation of the five-month siege in the city within the next five years.

The nationwide Social Weather Stations (SWS) survey conducted last Sept. 23-27 with 1,500 respondents found that 53 percent of Filipinos think it will take at least five years for Marawi City to fully recover from war damages.

Meanwhile, 46 percent said it will take Marawi City one to four years to fully recover.

The respondents were particularly asked, "in your opinion, how long will it take before the areas damaged by the Marawi City crisis can fully recover?"

Thirty-two percent answered seven years or more after the crisis, 21 percent answered five to six years after the crisis, 30 percent answered three to four years after the crisis, and 16 percent answered one to two years after the crisis.

The remaining one percent did not give an answer.

Sixty percent of Filipinos in Mindanao and Visayas believe that it will take Marawi City five years or more to fully recover from the devastation.

The proportion of those saying it will take five years or more for Marawi City to fully recover was 60 percent (21 percent saying five to six years, 38 percent saying seven years or more) in Mindanao, 60 percent (25 percent saying five to six years, 35 percent saying years or more) in the Visayas, 50 percent (19 percent saying five to six years, 31 percent saying seven years or more) in rest of Luzon, and 44 percent (22 percent saying five to six years, 22 percent saying seven years or more) in Metro Manila.

Gov't forces on alert against NPA attacks after botched peace talks

The military has alerted all its forces in eastern Mindanao in anticipation of the escalation of attacks by Communist rebels after President Rodrigo Roa Duterte formally cancelled the peace talks with the Left.

Lt Gen Benjamin Madrigal, commander of the Eastern Mindanao Command (EastMinCon), said they are anticipating that the New People's Army (NPA) will reciprocate Duterte's Proclamation 360 with violent attacks.

"We have to be vigilant, intensify our monitoring and be pro-active in order to prevent them from terrorizing communities," said Madrigal.

Proclamation 360 officially teminates the peace negotiations with the Communist Party of the Philippines (CPP), National Democratic Front of the Philippines (NDFP) and NPA.

In his order, Madrigal said all commanders should raise their security posture and prevent the NPA from conducting atrocities against communities, economic establishments, military posts and personnel

In Butuan City, field commanders of the military and Philippine National Police (PNP) are now awaiting formal orders on when how to deal with consultants of at least 40 NDFP consultants were granted temporary liberty so that they could participate in the talks

In a separate interviews by The Manila Bulletin on Saturday, top northeastern and northern Mindanao military commanders of the AFP and PNP said they still cannot arrest the NDF consultants "without proper directive and guidance from their respective higher officials from the central command"

"We did not even receive yet the formal proclamation that the CPP-NPA-NDF is a terrorist organization, even though that we already called them communist terrorists, based on their extortion and burning of equipment activities," a field unit Army commander said, who requested anonymity as he is not authorized to issue any statement to media.

NPA asks for SOMO to facilitate release of abducted cops in Surigao

PLACER, Surigao del Nerte— New People's Army (NPA) rebels who have abducted two policemen in flus province have asked government for a suspension of military and police operations (SOMO) in at least six townsto (actiliate the safe release of their so-called "prisoners of war."

The custodial force of the NPA's Guerrilla Front Committee 16,

through its spokesman "Ka Oto," said on Friday that it had no more reason to detain Police Officers 2 John Doverte and Alfredo Degamon.

"We received the result and found out that the two had no direct involvement in the crimes like extrajudicial killing, drug trafficking and ex' rtion activities raised against Placer police and we see no reason to keep them as prisoners of war," Ka Oto said in the vernacular in an interview with a local radio station.

What the NPA wants now is a 10-day SOMO so they can work on the safe release of the two members of the Placer Municipal Police Station.

The call for a SOMO was already conveyed to military field commanders last Thursday by the third-party facilitator/negotiator who had started negotiations with the NPA for the release of PO2 Doverte and PO2 Degamon.

"This will also endanger the abducted policemen if they (military, police) continue their operations," Bishop Maximo Rhee Timbang of the third party facilitator said.

Aside from the appeal of the negotiators assigned by the crisis management committees (CMC) of Surigao del Norte and Placer, led by Governor Sol F. Matugas and Mayor Michael Jose Patiño, parents of the two police officers requested government security forces to halt their offensives to allow the release of the hostages.

The relatives and friends of the two abducted policemen also requested the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP) commanders to pull-out their troops in said areas to avert any untoward incident between the negotiators and all parties concerned.

Since the two were abducted from the police box stationed on the national highway in Barangay Bad-as, Placer town, Surigao del Norte, last November 13, they have been treated well by the NPA, Ka Oto assured.

"We assured the parents and their relatives that they are both safe and in good health," he said.

Ka Oto said they would release the two abducted policemen on condition that the army and police would order their forces to stand down in some villages in the towns of Alegria, Tubod, Placer, Bacuag, Gigaquit and Claver, all in Surigao del Norte.

However, the military and police commanders in northeastern Mindanao maintained yesterday that their operations against the NPA – declared recently by President Duterte as terrorists – "will continue without let up."

"Our operations against the communist terrorists is ongoing without let up, even before the abduction of these two policemen and we cannot stop our operations unless ordered us by our higher authorities," said Brig. Gen. Franco Nemesio M. Gacal, commanding general of the Army's 402nd Infantry "Stingers" Bridge (402nd IB) who has jurisdiction over areas of Surigao del Norte, Agusan del Norte and Dinagat Islands provinces.

DND, East Ave. Med ink drug-test deal

MANILA — The Department of National Defense (DND) and the East Avenue Medical Center (EAMC) have signed a memorandum of agreement (MOA) on drug tests for defense and military employees.

DND public affairs chief Arsenio Andolong, in a statement Friday, said the MOA was signed by Undersecretary for Policy Ricardo David Jr., who chairs the department's Drug-Free Workplace Assessment Committee, and EAMC head Dr. Emmanuel Bueno, on behalf of the hospital's National Reference Laboratory (NRL), at Camp Aguinaldo, Quezon City on November 23.

"Today, we officially seal the covenant between the DND and the EAMC-NRL on the engagement of quality drug testing for DND employees and of course, AFP personnel," David said. "This is a milestone for the department in the pursuit of a drug-free environment in compliance with Republic Act 9165, also known as the Comprehensive Dangerous Drugs Act of 2002... and the pursuit of a drug-free workplace as approved by the Secretary of National Defense on July-17, 2017."

The MOA aims to further strengthen the DND's anti-illegal drug efforts through the conduct of the annual mandatory and random drug tests of civilian and uniformed personnel, regardless of status or position.

The agreement would also serve as the reference point for the engagement of drug testing services of the EAMC-NRL, and ensure that the DND would be able to tap into qualified, competent, and sufficient number of personnel who will conduct the drug tests. (PNA)


Padilla said the AFP will certainly respond should the NPAs decide to attack and harass communities in the countryside.
