

Int'l groups press probe of drug kills

An international human rights group and a mission of international parliamentarians and civil society leaders have warned that the Philippines faces sanctions from the United Nations and European Union (EU) if the government fails to stop the killing of suspects and allow an independent investigation of President Duterte's fierce war on drugs.

If the Duterte administration continues to refuse to allow an independent investigation, the Philippines could lose its membership in the UN Human Rights Council (UNHRC) and jeopardize its relations with the council's members, according to Human Rights Watch (HRW).

"Many of those states have bilateral relations with the Philippines and the government is jeopardizing its good relations with governments around the world," Joseph Fisher, Geneva director of HRW, said in an exclusive interview with Inquirer. er.net on Friday.

"It's jeopardizing its bilateral relations. It's jeopardizing its continued membership in the UN Human Rights Council if it fails to heed those calls and to [attend to] the warning signals," Fisher said.

No risks seen

Malacañang, however, sees no risks to the Philippines' position in the UNHRC or its relations with other countries.

Presidential spokesperson Ernesto Abella said on Monday that other nations continued to support the Philippine government's efforts in "dealing with domestic challenges" without interfering in the country's international affairs.

"These countries continue to treat us with mutual respect and [they're] cognizant of our sovereignty," Abella told reporters.

"They continue to have relationships with us and we're on solid ground, solid economic ground. There's no need to fear about any changes in relationships," he said.

But parliamentarians belonging to the Progressive Alliance and the Party of European Socialists warned on Monday that the Philippines risked losing a preferential trade deal that allows 6,200 of its products to enter the European Union duty-free if it failed to immediately stop the killings and political persecution of critics.

The General System of Preference (GSP+) deal is under review and an EU report is expected in January.

Consequences

"If the human rights standards are not upheld, then there may be consequences in the Philippines' inclusion in the special trading instrument of the EU," said German parliamentarian Arne Lietz.

Lietz called for an immediate stop to the killings, the release of detained government critics—a reference to Sen. Leila de Lima—and an independent investigation into the thousands of police killings in the crackdown on illegal drugs.

The seven-member EU mission visited depressed communities in Metropolitan Manila most affected by the killings and met with lawmakers and human rights advocates during

a two-day visit that began on Sunday.

"The killings of persons accused, without evidence or trial, of involvement in the drug trade continue unabated even in recent days," said a statement issued by the mission members from Europe, the United States and Australia.

Equal alarm

In a press briefing at the Senate on Monday, the mission expressed equal alarm at the Duterte administration's alleged aggressive efforts to silence dissent, deploring "trumped-up charges" against De Lima and threats against Sen. Risa Hontiveros, Chief Justice Maria Lourdes Sereno, Ombudsman Conchita Carpio Morales and the Catholic Church.

"It's oppression of the opposition, especially the female ones," said Swedish parliamentarian Emilia Töyrä.

Töyrä said the gross human rights violations appeared to be encouraged by Mr. Duterte himself in his public speeches.

Malacañang had no immediate comment on the EU mission's statements. —with a report from AP INQ

How the Maute brothers embraced radicalism

Second part

SEN. Juan Miguel Zubiri, who hails from Bukidnon in Maguindanao, said it was easy for the Maute brothers to recruit members because of the high incidence of poverty.

"You have to remember, Lanao del Sur is No. 2 in terms of poverty incidence in the country. Close **SPECIALREPORT** to 70 percent of its population live below the poverty line. Marami pong 'no read no write' dun. Maraming illiterate sa probinsya na ito (There are

many 'no read no write' there. There are many illiterate people

in this province)," Zubiri said. Poverty led to the rise of the Maute extremist movement in

Lanao del Sur, he said. "Dahil s'vempre kung gutom ka medyo hindi mo nararamdaman ang tulong ng gobyerno napakadali sumama sa isang grupo na nangangako sa iyo na `pag sumama ka you will be in paradise. Makakatulong sila sa inyo (Of course, if you're hungry and you do not feel the help of the government it is easy to join this group which can promise you paradise. They promised help)."

The senator noted that the Maute group had been involved in terrorist activities, such as extortion, drug trafficking and kidnapping for ransom.

"May pera sila. So, binibigyan nila ng allowance itong mga tao na wala pong natatanggap o nararamdaman galing sa national government. So, 'yan po sa tingin ko ang No.1 reason na maraming gustong sumama sa kanila (They have money. They give monetary allowance to these people who receive nothing from the national government. That, I believe is the No. 1 reason why there are a lot of people who want to join them)," he said.

"And maybe the second reason is because ISIS now is being romanticized all over the world. If you watch television, you will see that they are called ISIS freedom fighters in Syria, in Iraq fighting infidels, so to speak, or their religious enemy," Zubiri said, referring to the Islamic State.

"And it's fueling the fire all over the world na parang 'Uy, ipaglaban natin ang kanilang mga adhikain at adbokasiva' (like, 'Hev, let's fight for their goal and advocacy) which is religious extremism," he said.

Injustice

Habib Macaayong, president of the Mindanao State University, believes that the primary reason for the rise of extremism in Mindanao is injustice.

"The Muslims have been clamoring for fair policies from the government. But they observed that there have been no fair policies in the government. It was very difficult for the Muslims to apply for a job, to participate in programs," he said.

"They have difficulty in owning

the land. Up to now many landowners in Marawi City have no land titles. So they want justice and the government failed to give them justice. So some of these people went abroad and they happened to be associated with these terrorists." he said.

"Number 2 is poverty. The founders of Maute, we heard, they are motivating the youth, to join them because they will be given salary. Maybe they joined [the group] to do terrorism but only to receive money," he said.

When asked how much salary, was offered to recruits, Macaavong said, "According to them P36,000 per month. [That's] big."

The Maute reportedly was able to convince their members that they will get regular salaries. "We heard Ithe money will come from abroad. But we don't know what country [was] offering the money to them."

Military spokesman Maj. Gen. Restituto Padilla Jr. said: "We have to understand the origins of Maute. The Maute group was first influenced by the JI (Jemaah Islamiyah). They joined the JI in 2012 because of a religious leader by the name of Sanjusi. But this Sanjusi, an Indonesian cleric, had already been neutralized."

"Si Sanjusi ang siyang nagtanim ng hindi magagandang idea sa utak ng mga Maute. By and large 'yung JI tame na tame pa 'yan compared to Daesh (Sanjusi was the one who implanted bad ideas in the minds of the Maute brothers. The JI is tamer compared with the Daesh)," Padilla said.

"Daesh" is an acronym for the Arabic phrase al-Dawla al-Islamiya al-Iraq al-Sham (Islamic State of Iraq and the Levant) and is another name for ISIS. But ISIS militants do not want to use Daesh as their identity as it has a pejorative meaning.

He said the Maute brothers come from a wealthy family. "Mayayaman ito e. Nagsimula sila sa pagiging bandido. Nangingikil, nanggugulo, naging aktibo sa mga banditry activities. Tapos, napasukan nga nitong si Sanjusi. Naimpluwensihan sila (They are rich. They started as a bandit group. They extort, harass, became active in banditry. Then, Sanjusi infiltrated their group. They were influenced)."

Padilla was referring to Ustadz Sanusi who reportedly became a mentor to the Maute brothers, but was killed in a police operation in 2012. Omarkhayam and Abdullah studied in Egypt and Jordan respectively.

"Tapos, ipinadala sa Middle East 'yung dalawa para mag-aral bilang Islamic scholars. Iyung isa (Omarkhayam) napunta sa Egypt. Nadikit siya ngayon du'n sa mga extremists at violent minds na nandu'n nu'ng (lumaganap ang) Arab Spring (Then two of them were sent to the Middle East to study and become Islamic scholars. One of them went to Egypt. He was able to mingle with extremists and violent minds when Arah Spring spread)," he said.

The "Arab Spring" refers to the revolutionary wave of violent and non-violent demonstrations in North Africa and the Middle East that began in December 2010 in Tunisia. The effect of the Tunisian Revolt spread to five other countries: Libya, Egypt, Yemen, Syria, and Bahrain which led to either change of regime or major uprisings.

"Iyung isa (Abdullah) nag-aral sa Jordan. Ganu'n din siguro 'yung mga naging barkada niya. Du'n siya pumasok sa linkages ng mga radical-extremists (The other one studied in Jordan. He must have gained the same kind of buddies. He became linked to radical extremists)," Padilla said.

He said the emergence of "Arab Spring" in the Middle East somehow influenced the Maute brothers to embrace radicalism. "That's the beginning."

"So meron na silang mga idea tungkol sa JI dahil nga dito kay alias Sanusi. Tapos nu'ng napunta pa sila ng Middle East lalo pang na fuel itong na mga ganong mga klaseng kaisipan. Lalo silang naging suicidal. Nakikita nila doon 'yung mga extremists, radicals (So, they were able to get some ideas about JI because of Sanusi. Their travel to the Middle East further fueled this kind of thinking. They became more suicidal. They saw extremists, radicals there)," he said.

"Actually, they started out with petty crimes until Sanusi's death. Iyung JI naluma na. So, sino bang pinakasikat noon after ng JI? Sino bang lumabas na tanyag na teroristang grupo? (JI lost its popularity. Who became popular after JI? Who came out to be the famous terrorist group)?" Padilla asked.

"Daesh and ISIS. Kaya du'n sila sumasama dahil 'yu'n ang sikat e. Tapos nabalitaan na maraming resources. Siguro, iniisip nila baka matulungan din sila (They joined it because it was popular that time. Then they learned that it had many resources. They probably thought it would be able to help them financially)," he said.

Santos is new 7th ID chief

MAJ. Gen. Filemon Santos, AFP deputy chief of staff for intelligence, has been designated by President Duterte as the new commander of the Army's 7th Infantry Division based in Fort Magsaysay in Nueva Ecija.

Santos assumed his new post last Saturday. He replaced Maj. Gen. Angelito de Leon who has reached the mandatory retirement age of 56.

Santos, a member of the PMA class of 1986, assumed his post as AFP deputy chief of staff

for intelligence in November last year. Before that, he was the deputy commander of the Army's 6th Infantry Division based in Maguindanao.

A Scout Ranger, a field artillery officer and an intelligence officer, Santos has a master's degree in management.

AFP public affairs chief Col. Edgard Arevalo said the successor of Santos as AFP deputy chief of staff for intelligence will be Brig. Gen. Fernando Trinidad (of PMA class 1987), the outgoing assistant AFP deputy chief of staff for civil military operations.

Arevalo (of PMA class 1990) said he will succeed Trinidad as the assistant AFP deputy chief of staff for civil military operations.

Arevalo's full-time position is deputy commander of the AFP Civil Relations Service and acting as the military's public affairs chief in concurrent capacity. His replacement at the CRS has yet to be announced.

Sayyaf leader slain in Tawi-Tawi

ZAMBOANGA CITY

– A sub-leader of the Abu
Sayyaf was killed in TawiTawi on Sunday.

Guro Idzri, alias Idris, shot it out with police operatives and Marines serving a warrant of arrest at his hideout in Sitio Suwang Kagang, Barangay Pasiagan, Bongao town, Brig. Gen. Custodio Parcon Jr., Joint Task Force Tawi-Tawi commander, said.

Idzri was pronounced dead on arrival at the Datu Halun Sakilan Memorial Hospital.

Parcon said Idzri was formerly with the group of Muamar Askali, alias Abu Rami, who was involved in the kidnapping and beheading of Jurgen Kantner, a German, last February.

Askali was killed in a military operation in Bohol in April after his group attempted to plan kidnappings in the area.

Meanwhile, government troops clashed with Abu Sayyaf bandits under Radullan Sahiron and Almuder Yadah in Patikul, Sulu also on Sunday, leaving an undetermined number of casualties from the militant group.

Brig. Gen. Cirilito Sobejana, Joint Task Force Sulu commander, said personnel of the 501st Brigade clashed with the bandits in Sitio Kanbadal, Barangay Pula Pansul before 8 a.m.

In Sulu, Abu Sayyaf member Jul Asbi Misuari, alias Imbuh, surrendered on Saturday night.

Misuari, a follower of slain leader Alhabsy Misaya, also turned over his machine gun.

At least 24 Abu Sayyaf bandits have surrendered in Sulu since January.

Court affirms corruption raps in AFP P5.1M procurement deal

THE Sandiganbayan has affirmed the validity of graft and falsification charges against former officers of the Philippine Army over irregularities in the procurement of P5.103 million worth of equipment and supplies in 2003.

In a 27-page resolution dated September 22, 2017 penned by Associate Justice Sarah Jane T. Fernandez, the Third Division denied for lack of merit the separate motions filed by Army Col. (discharged) Jessie Mario B. Dosado, Col. Barmel Zumel, Capt. George P. Cabreros, Col. Cesar G. Santos, and Accounting Unit head Editha B. Santos seeking dismissal of the cases for lack of probable cause and inordinate delay.

Presiding Justice Amparo M. Cabotaje-Tang and Associate Justice Bernelito R. Fernandez concurred.

The cases stemmed from audit findings that a purchase by the Philippine Army of combat clothing and individual equipment (CCIE) in 2003 amounting to P5,103,000 did not undergo the required public bidding.

Other defendants named were Lt. Gen. Gre-

gorio M. Camiling, Brig. Gen. Severino P. Estrella, Col. Cyrano A. Austria, and chief accountant Rolando F. Minel.

The anti-graft court said the full 13 years from the referral of the complaint on October 3, 2003 up to the filing of criminal charges before the Sandiganbayan on October 28, 2016 cannot be counted against the Office of the Ombudsman, contrary to the assertion of the defendants.

It said the prosecution adequately explained that the allegations of procurement anomalies had to be forwarded to the Commission of Audit for fraud audit investigation. The COA submitted its findings in September 2010.

Based on this, the Ombudsman-Military and Other Law Enforcement Offices (MOLEO) conducted a fact-finding investigation and endorsed the complaint for preliminary investigation on October 19, 2011.

The appeals were denied in a resolution issued August 15, 2016 and the cases were filed with the court two months later. – Peter J. G. Tabingo

NPAs 'silence' farmer tagged as 'intel agent'

KIDAPAWAN, CITY - Gunmen who identified themselves as members of the New People's Army (NPA) killed a farmer whom they tagged as an intelligence agent of the Philippine Army's 39th Infantry Battalion. Reports from Magpet PNP said that Bebs Nero Quino, 32, was inside a cockpit in Barangay Balite when three unidentified persons approached him brought him to an area just a few meters away from the cockpit. Minutes later, residents heard shots and saw the lifeless body of Quino covered with blood, reports -added. A witness told police that after ensuring that their target was already dead, the NPA rebels took the victim's motorcycle and later brought it to his house at Barangay Kamada. The rebels, the witness added, told Quino's wife what they did to her husband. Last October 3, NPA rebels shot dead Kagawad Valeriano Birondo of Barangay Mahongkog, also in Magnet. Birondo was on his way to his farm when he was waylaid by believed to be NPA guerillas. He was shot twice on his head and chest. He died on the spot. (Malu Cadelina Manar)

Ex-Army man, son held for drugs

Six drug suspects, including a former Army soldier and his son, were arrested in separate police operations in Quezon City over the weekend.

Retired Army sergeant Damaso Calayan, 57, and his son Julius, 33, were apprehended during a sting near their house along Road 1, JP Rizal Extension in Barangay Bagong Silangan at around 5:30 p.m. on Sunday.

Members of the Batasan police allegedly managed to buy P500 worth of shabu from the Calayans.

The father and son allegedly yielded six sachets of shabu, a .38-caliber

revolver and ammunition.

Mary Jane Fernandez, 47, and Darwin Mesa were collared in another drug bust along Alley 29 in Barangay Escopa.

Police said they allegedly recovered five packs of shabu and P100 in marked money from the

suspects.

In Barangay Tatalon, two more drug suspects, Rowena Dollente, 39, and Ronie Bactong, 43, were nabbed for alleged shabu possession.

The suspects are being held by police on drug charges.

SEARCH FOR MARAWI CIVILIANS

REQUESTS FOR DNA MATCH REVEAL 61 STILL MISSING

MARAWI CITY—Up to 61 persons were still missing here as government forces continued operations to rescue civilians still trapped in the fighting between soldiers and homegrown Islamic State (IS) followers trying to set up an IS province in this predominantly Muslim city.

Zia Alonto Adiong, spokesperson of the Lanao del Sur Crisis Management Committee (CMC), said authorities based their estimate on the number of missing persons on reports given by the police's Scene of the Crime Operation (Soco) personnel.

Adiong said residents searching for relatives had been going to the CMC and given DNA samples (hair, tissue, saliva, etc) hoping to locate their loved ones. These DNA samples were being matched with those of bodies recovered in the battle zone or rescued hostages.

Based on the number of requests for DNA matching, the number of still missing persons had reached 61, Adiong said.

Military estimate

The number matches the military's own estimate that between 40-60 hostages are still in the battle zone.

Col. Romeo Brawner Jr., deputy commander of the Joint Task Force Ranao, said the latest estimate on the number of hostages was drawn from information provided by those who had been rescued—including 17 hostages who managed to es-

cape and were intercepted by soldiers on Wednesday last week.

He said since the fighting had started, the total number of rescued civilians had already reached 1,750.

Fatima Lumabao, an evacuee, said she was hoping that her four missing children—Norhuda, 21; Rasida, 20; Parhana, 12 and Mohammad, 10—were among the civilians still being held captive by the terrorists.

Lumabao's four children disappeared amid the chaos that followed the rampage in Marawi City by Maute and Abu Sayyaf terrorists on May 23. Her search continued to be unfruitful for nearly five months now.

"I have asked everyone. I have inquired from the military each time news of hostages escaping reached me, but no positive development," she told the Inquirer.

Decent burial

But she admitted that sometimes she could not avoid thinking her children had been killed in the fighting.

"Even if the thought is depressing, I have to accept it. If they had died, I want their bodies found so I can give them a decent burial," Lumabao added.

Most of the recovered remains—including those that have been buried at the Maqbarah cemetery here—had not been identified but authorities believed they belonged to slain terrorists.

Since the start of the fighting, 117 remains had already been recovered and DNA samples had been collected from them before they were buried.

Lumabao's DNA samples did not match any of those from recovered bodies which gives her hope. "But where are my children?" she said. —ALLAN NAWAL INO

Doc treated Is fighters—Army

A Fifipmo doctor wanted for a forted jihadi plot targeting New York's subway and Times Square previously treated Islanic State (IS) followers in the mountains in Mindanao, the military said on Monday.

Russell Salic. 37, has links with the Maute group, which since May had been occupying parts of the predominantly Muslim city of Marawi in a bid to establish an IS province in Southeast Asia, authorities said.

"He was among those who were treating wounded members of the Maute group," military spokesper on Coi. Edgard Arevalo told Agence Prance-Presse (AFP).

Another military spote sperson, waj Gen. Kestitino Padula, told reporters sala had performed these tasks in visits to Maure training camps before the Marawi attack.

"That's why his nom de guerre or nickname, based on our information, was 'Doc' or 'Doctor,'" Padilla added.

Ramadan plot

Salic, who has been in government custody since April, is wanted by US prosecutors after he and two others were indicted over a plan to conduct hombings, and shootings in Times Square, New York's subway system and concert venues in the name of 1S.

The attacks were planned for the Mushin holy month of Ramadah in 2010, US prosecutors said when they amounced the charges on Friday.

Pinoy in NY terror plot served as Maute doctor

Rusell Langi Salic, the Filiino doctor allegedly involved in plotting terror attacks in the United States, had allegedly provided funds to the Maute group and treated wounded militants in Butig, Lanao del Norte in 2016, the military disclosed yesterday.

Armed Forces of the Philippines (AFP) spokesman Maj. Gen. Restituto Padilla said the 37-year-old physician, accused of sending money to help fund planned attacks in the US, also helped fund terrorist activities in Lanao del Norte.

"We have learned that he had connections with the Maute group when we had clashes in Butig," Padilla told radio station dzMM yesterday.

One alleged plotter is already in US custody while the second is in Pakistani custody.

Salic is accused of wiring \$423 to the US to help fund the plot, the American justice department said.

He and the suspect in Pakistan now face legal proceedings seeking their extradition to the United States.

Padilla said that prior to the release of US intelligence information on Salic's involvement in terrorist activities, the AFP already had initial information on the matter because the military has been working with allied intelligence agencies.

Authorities earlier confirmed that Salic was arrested last April in the Philippines OFFICE O for his alleged involvement in

He said Salic supposedly provided funds and material support for the group before the terrorists eventually started the Marawi siege last May 23.

Padilla said Salic surrendered to clear his name of the allegations.

He said there was information that Salic frequented the Butig mountains and allegedly had contact with and provided assistance to the Maute group.

Salic is wanted by US prosecutors after he and two others were indicted over a plan to conduct bombings and shootings in Times Square, New York's subway system and concert venues in the name of IS.

No deadline had been set to end the military operations in Marawi, an official clarified yesterday.

Padilla said they want to pull out the troops at the soonest possible time, but admitted that the presence of civilian hostages remains a challenge. Over 20 civilian hostages have yet to be rescued.

"We're just being careful about this. We really want to end this conflict as soon as possible...No definite timeline yet, except that we're really aiming to do it hopefully this month, he said.

A total of 774 militants, 158 soldiers and policemen as well as 47 civilians have been killed since the crisis started on May 23.

Around 60 terrorists remain holed up in Marawi, military officials said.

Amid reports that the crisis will soon be over, Edu Gariguez of the National Secretariat for Social Action of the Catholic Bishops Conference of the Philippines called on the faithful to help in the repair of churches damaged in the fighting.

"It is important that we restore the churches. I hope we will continue to extend assistance to those affected by the war and help them regain their normal lives," Gariguez said. - With Evelyn Macairan



'Counterterror measures facing uphill battle'

Counterterror measures such as the national ID system and registration of phone SIM cards are still facing an uphill battle, Philippine National Police (PNP) chief Director General Ronald dela Rosa said vesterday.

Dela Rosa was reacting to a statement by surgeon Russel Salic of Cagayan de Oro City, who has been charged by the US government for allegedly financing a plot of the Islamic State to bomb New York City's Times Square and subway system.

"You are asking about a comparison between our country and other countries. The terrorists choose to operate here because they know they can move easily around here. For one, the national ID system, which is deemed to be an important anti-terrorism measure, can hardly pass through legislation.

We have been clamoring for that, but it's a very uphill battle," Dela Rosa said.

He said the second possible measure to curb terrorism is the registration of prepaid SIM cards.

"Other countries do not have a prepaid system. They're all postpaid that's why all cellphone owners are identified. I don't know if we are the ones regulating the telcos or it's the other way around," Dela Rosa said.

The US justice department said Salic had told those involved in the foiled bomb plot that terror laws in the Philippines are "not strict" compared to Australia and the United Kingdom.

Dela Rosa and Armed Forces of the Philippines chief Gen. Eduardo Año yesterday signed the 2017 AFP-PNP Joint Peace Security Coordination Council agreement, aimed to strengthen their coordination in addressing terrorism and other crimes.

"It is true because you know the country enjoys so much democratic space that is being exploited by terror and also criminal groups. Unlike in other countries like Singapore, the US, Malaysia and Australia, they have a very strict internal security act," Dela Rosa said, referring to the lax terrorism law in the Philippines.

Año said the inter-agency committee on legal offensive showed the country has a lot of threat groups starting with the Abu Sayyaf, Maute group, Ansar al Khalifa, Bangsamoro Islamic Freedom Fighters and the New People's Army.

"The link of these groups to international terrorists organizations is a serious threat to our national security. This inter-agency committee on legal offensive will be in charge of intelligence gathering and cooperation, investigation, prosecution and monitoring cases against leaders of these groups," Año said.

The AFP said other countries allow authorities to detain an individual on mere suspicion of being involved in terrorism.

There is also a special court that hears the case and charges do not have to be filed immediately.

"Up to three years, they can detain an individual until they are able to determine that the person is really part of a terror group. Here, we have the human security act, but we want to have it amended and the provisions expanded because we believe it's not enough to address the threats brought by terrorism," Año said.

Countries like the Philippines, Malaysia and Indonesia with Muslim populations use linkages and blood relations to have easy access and support apparatus.

Año said Salic is part of a logistics support network of international terrorist groups. "Salic sends money to suspected terrorists in the Middle East, Malaysia and the US, and he has been under the radar since 2014."

With the help of other foreign intelligence agencies and the Interpol, there have been information-sharing that led to the neutralization.

Salic actually surrendered to the National Bureau of Investigation in April after learning that a warrant has been issued for his arrest," he said.

In China, Dela Rosa said terrorists could not find a way to attack, noting the Chinese people have no access to popular social media like Facebook.

"Cyberspace is regulated by the Chinese government, making it hard for the terrorists to operate. We've been asked to make recommendations and these have been hanging for a long time," Dela Rosa said.

NPAs attack plantation in Bukidnon

Reds hit military training of Lumads

DAVAO CITY – The New People's Army (NPA) decried the action of the Armed Forces of the Philippines (AFP)'s 10th Infantry Division to bring in Lumad fighters after the army announced earlier this month it would be training indigenous peoples into its army.

In a statement, Rigoberto Sanchez, NPA spokesperson for the regional operations command of the Southern Mindanao Region, called the move "highly despicable" and demanded that the military back off from recruiting the Lumads.

Sanchez said that recruiting Lumads into counter-insurgency will exploit the Lumad youth.

The AFP had announced it would be arming and training 300 Lumad youths from Davao, Cotabato, and Socskargen regions.

"The move is a desperate attempt of the AFP to score military points in the battlefield where its troops are required to have mastery of terrain, high tolerance for sacrifice and to exhibit innate courage – attributes that they sorely lack and want to exploit from the Lumad youth," Sanchez said.

The rebel group said it was tasteless of the national government to recruit members of indigenous groups who were allegedly abused by the military.

Marawi siege death toll nears 1;000 as clearing ops continue

S the government remains unsure when the conflict in Marawi City, Lanao del Sur, will end, the death toll in ground zero continues to rise and is nearing 1,000, according to the military.

In a news briefing on Monday, Armed Forces Spokesman Restituto F. Padilla Jr. said the number of lives lost in Marawi City is a fingertip close to 1,000 after more than four months of fighting. According to the military's recent count, the conflict has claimed a total of 982 lives-777 were terrorists, 158 were government troops, and 47 were civilians.

Padilla said government troops were able to clear 69 buildings over the weekend. However, he added there are still 200 buildings in about 5 to 7 hectares that are up for clearing by the military.

"Our troops are concentrating in this area and where those more or less 200 facilities remain, which includes one

mosque, which we believe is likewise being used as a safe haven and as a storage area for arms, food and whatever cache they have," he said.

As the death toll continues to rise, the military remains unsure when the conflict will end and has opted not to set a deadline, following numerous failures to meet previous target dates.

"I was just asking our troops on the ground if any categorical statement was made regarding the deadline, [and] I was informed there was none. We're really aiming to have this concluded at the soonest possible time," Padilla said.

"So as the case is, even the chief of staff does not want to put pressure on the troops because we know that any kind of pressure might lead to action that may lead to more casualties on our part. So we're just being very careful about this," the military's spokesman added.

Aside from clearing buildings, Padilla said government troops are taking extra caution in conducting offensives against the Islamist extremists, in light of reports that there remains about 40 hostages held by the enemy.

AFP and PNP strengthen ties in face of threat groups

HE police and the military agreed on Monday to further strengthen their collaborative efforts in the investigation and prosecution of leaders of threat groups, as the country grapples with the problem of terrorism.

Philippine National Police (PNP) chief Director General Ronald M. dela Rosa and Armed Forces Chief of Staff Gen. Eduardo M. Año signed the resolution creating the Inter-Agency Committee on Legal Action (Iacla) during the 20th Armed Forces of the Philippines (AFP)-PNP National Joint Peace and Security Council (JPSC) Meeting at Camp Crame.

The Iacla adds up to the number of agreements on coordination and collaboration between the police and military in the areas of peace and security, including the JPSCC.

"As shown, the country is beset with a lot of threat groups, starting with the Abu Sayyaf Group, Maute Group, Ansar al Khalifa Philippines, BIFF [Bangsamoro Islamic Freedom Fighters], including the (NPA [New Peoples' Army], and now the establishment of a [base] in the Philippines and the linkages of these groups to international terrorists. So this poses seriously to national security," Año said during a news briefing.

"That's why this interagency committee on legal offensive will be in charge in intelligence gathering and cooperation, investigation, prosecution and monitoring cases against leaders against personalities of these terrorist groups," he added.

Año cited the case of Dr. Russel Salic, the alleged doctor of the Maute

Group and who allegedly helped financed a thwarted plan by the Islamic State to bomb selected targets in the United States, taking advantage of lax Philippine laws.

"You know, the country enjoys so much democratic space that is being exploited by terror groups and also criminal groups. Unlike in other countries like Singapore, US, Malaysia, Australia, they have a very strict internal security act," Año said.

He added these countries have special provisions wherein they could arrest and detain a person up to three years "by mere suspicion based on information" until it is determined that the person is a member or part of a terrorist group.

Año said while the country has the Human Security Act, they have been asking that it be amended because they believed that "it's not enough to address the threats against terrorism".

According to the chief of staff, Salic, who is under the custody of the National Bureau of Investigation where he surrendered, is a part of the logistics-support network of the international terrorist group.

Salic's debriefing and investigation is continuing, although Año said he had disclosed information, it would be premature to disclose any details yet to the public.

On the other hand, dela Rosa said terrorist groups have chosen to operate in the country because of its "more relaxed laws", noting that even the "mere national ID system" is having a hard time getting the nod of legislators.

"We have been clamoring for that, but it's a very uphill battle," he added.

MILF delisted from UN list as using, recruiting children

THE removal of the Moro Islamic Liberation Front (MILF) from a UN list of armed groups recruiting and using children marks a stride and a victory toward realizing children's rights in the Philippines.

The UN Secretary-General's report on children and armed conflict is presented annually to the UN Security Council and contains information on the six grave violations against children and on the situation of children affected by armed conflict during the previous year. The report highlights trends and patterns of grave violations, progress made to protect children and further recommendations. The recently released 2016 report revealed that UN engagement has led to the delisting of two parties in the Democratic Republic of the Congo and in the Philippines.

UN children's agency UNICEF, which facilitated the work with the UN-MILF Action Plan to end recruitment and use of children, congratulates the MILF and highlights the work that still needs to be done to ensure that children affected by armed conflict enjoy

their full rights.

The UN-MILF Action Plan was completed at the beginning of 2017 upon the fulfilment of a six point roadmap, resulting in the disengagement 1,869 children from the ranks of the MILF. The disengagement of children will facilitate their access to appropriate support and services from government and development partners to enjoy all their rights to health, education and protection.

"The MILF's commitment to protect and promote the rights of children in their communities continues today, even as they are delisted from the UN report. Fostering lasting peace for children involves continued vigilance by all concerned, including the government, civil society, elders, parents and children themselves to ensure they are not involved in or used in armed conflict," UNICEF Philippines Representative Lotta Sylwander says.

The programme of support to disengaged/at-risk children and their families through UNICEF is being supported by the governments of Japan and Canada, among others. The MILF instituted safeguards through its command structure to regularly monitor and screen troops to prevent children from associating or re-associating. The United Nations will continue the monitoring of grave violations against children committed by all parties to conflict.

In the Philippines, children continue to be direct victims of grave violations in the context of the armed conflict, affecting their rights to life, survival, development, protection and education, among others.

Most common grave violations are recruitment and use of children, occupation of and attacks on schools, killing and maiming and detention for alleged association with armed groups. Thousands of children and families have been displaced in recent years by armed conflict, mainly in Mindanao. In 2017, the Marawi crisis displaced approximatively 359,000 individuals, 205,000 of them being children.

UNICEF engages with government and parties to conflicts to prevent grave violations and guarantee adequate response to victims. UNICEF works with the Office of the Presidential Adviser on the Peace Process, a key partner in peacebuilding. Military chief wants stricter anti-terror law

ARMED Forces chief Gen. Eduardo Año yesterday said the military is pushing for amendments to the Human Security Act to give it more teeth in the fight against terrorism.

He made the statement after Russel Salic, a Filipino the US wants extradited, was reported as saying the Philippines is a "breeding ground for terrorists."

Salic has been under the custody of the NBI since April when he surrendered. Last Friday in New York, US prosecutors said Salic and two others have been arrested since May last year on charges of plotting attacks in the city for the Islamic State.

Año said he wants an internal security act that is patterned after those of Singapore, the United States, Malaysia, and Australia, where authorities can arrest a person on mere suspicion he is a terrorist, based on available intelligence information.

"Here we have the Human Security Act but we are requesting our lawmakers to make amends or add some provisions because we believe it's not enough to address the threats against terrorism," Año said.

"The country enjoys so much democratic space that is being exploited by terror groups and also criminal groups unlike in other countries," he also said in a press conference in Camp Crame in Quezon City.

Año was in the PNP's headquarters for the signing of a joint resolution of the Armed Forces and the PNP creating an "inter-agency committee on legal action" which he said will be in charge in intelligence gathering and cooperation, investigation, prosecution, and monitoring of cases against leaders or members of terrorist groups.

He said under the internal security act of other countries, there are "special provisions" that allow the arrest of person "on mere suspicion based on information and there is a special court that will hear the case."

"And they do not even have to file charges immediately. Up to three years, they can actually detain a person until they determine that that person is really part of a terror group," he added.

PNP chief Ronald dela Rosa said stricter laws against—terrorism may not be passed because Filipinos are known to shoot down proposals which may not work in their favor.

Dela Rosa cited the proposed national ID system which he said "is a very crucial mission to address terrorism," and a proposal to do away with prepaid SIM cards and use of postpaid lines to identify all cellphone owners.

The House last month approved on final reading a bill seeking to install a national ID system.

achieve that not later than October 15," Galvez said.

ANOTHER MOSQUE RECOVERED

Galvez also reported that troops on Sunday recovered another mosque from the Maute, bringing to only one the number of mosques under Maute control.

"However, in the course of the effort, three soldiers died, bringing to 158 the total of soldiers and policemen killed in action (since May 23)," said Galvez.

The conflict has also resulted in the death of 774 Maute men and 47 civilians.

Galvez said the fighting in Marawi remained intense yesterday. He said he received information that some soldiers were wounded in yesterday's fighting but did not give figures.

Galvez said the military received information that Omar Maute was wounded during the assault of the Bato Mosque which was recovered from Maute control in the latter part of September.

Galvez said 12 children and 16 women are still being held by the Maute Group inside the main battle area.

Galvez said the number is on top of around 31 to 33 dependents of Maute and Abu Sayvaf members who were brought inside the battle

the conflict area has been further

reduced to about four to five hect-

ares from around 10 hectares some

three weeks ago.

"We have the remaining sector of TG (Task Group) Musang. It will be cleared not later than (October) 15 which is our deadline. But we are confident we will be able to clear the remaining area in the next few days," he said.

Galvez said the Wesmincom has informed AFP chief Gen. Eduardo Año of the October 15 target. Año is due to reach the mandatory retirement age of 56 on October 26, and he has said the conflict that started on May 23, when the Maute Group attacked the city, would be over before he bows out of service.

"Two of the three sectors have been already cleared. We are clearing just one... The timeline that we gave to the chief of staff is October 15 but I believe we can

area. He said military is treating the dependents as "non-combatants."

"For as long as they do not get firearms, we will treat them as non-military objectives. As much as possible, we want to isolate them so they won't be collaterals. That's part of our rules of engagement," he said.

FOREIGN TERRORISTS DEAD

Galvez also reported that three foreign terrorists died in recent air strikes, bringing the number of foreign fighters in the area down to six to nine.

"There were initially 12 (foreign terrorists) we monitored and we reduced it to nine. But there were three foreign terrorists who were hit in our air strikes. We're looking at the possibility that they're down to six to nine," said Galvez. - With Jocelyn Montemayor

Sorry for wrong logo, Lorenzana tells China

DEFENSE Secretary Delfin Lorenzana yesterday apologized to China for his department's "grievous but purely unintentional" error in putting the logo of the Taiwanese defense ministry in the banner displayed during the turnover of weapons donated by the Chinese government on Thursday last week.

DND public affairs chief Arsenio Andolong said Lorenzana sent the signed letter of apology yesterday to the Chinese government, through Chinese ambassador Zhao Jinhua.

"It (letter) was between the SND (Secretary of

National Defense) and the ambassador, apologizing for the error. We acknowledge it (error) but it was purely unintentional," Andolong said in a phone interview.

"He (Lorenzana) personally wrote the letter,"added Andolong

He said the department is not releasing a copy of the letter to the public because it was a "personal communication" between Lorenzana and Zhao.

Andolong said the Chinese embassy "politely" called the attention of the DND about the error isst Saturday, or two days after the turnover of the weapons, when they noticed the logo from pictures.

The banner showed the logo of the DND and that of the Taiwanese defense ministry, instead of the Chinese defense ministry. The banner had the markings: "Handover Ceremony, Military Assistance Gratis from the Ministry of National Defense of the People's Republic of China."

The banner was displayed at the AFP canopy in Camp Agunaldo where Zhao turned over to Lorenzana and APP chief Gen. Eduardo Año 3,000 M4 rifles, three million ammunition and 90 scopes for sniper rifles.

The Chinese government turned over the same number and type of firearms and six million ammunition to the DND and AFP last June. A third batch of Chinese weapons is due to be transferred to the Philippines early next year.

"(T)he Department of National Defense committed a grievous but purely unintentional mistake of using a different logo on a banner to represent the Ministry of Defense of the People's Republic of China," said Andolong.

Andolong said the department is "fully cognizant and grateful" of the assistance of China even as he assured that the DND and the AFP are strictly adhering to the "One China Policy" of the Philippine government.

"It is our sincere hope that this very unfortunate incident will not affect the cooperative and friendly relations between our two countries which has grown warmer over the past year," said Andolong.
