Palace: No expulsion of EU envoys

here are no plans to expel amassadors from European Union EU) members, according to residential spokesperson Eresto Abella, clarifying that Predent Duterte's tirades against the European Union this week were meant for a foreign delegation that included several European parliamentarians who had appressed concerns about hunan rights violations in the hilippines' war on drugs.

"There is no directive to do hat," Abella told reporters on riday, adding that Mr. Duterte's tatements were "being clarified irectly to persons concerned."

The President on Thursday lasted the European Union for upposedly calling for the hilippines' ouster from the Inited Nations and told it not to nterfere in the country's donestic affairs.

The President also said he ould cut diplomatic ties with U members and their ambasadors would have to leave the ountry in 24 hours.

"You think we are a bunch of norons here? You are the one. Iow the ambassadors of those ountries listening now, tell me, recause we can have the diplomatic channel cut tomorrow. You leave my country in 24 hours, all, all of you," Duterte said in his speech at the relaunching of the Malacañang press briefing room.

An international human rights group and a mission of international parliamentarians and civil society leaders on Monday warned that the Philippines faced UN and EU sanctions if the government failed to stop the killing of drug suspects and allow an independent investigation of the war on drugs.


The delegation included seven members of the Progressive Alliance and the Party of European Socialists.

'Gross misrepresentation'

On Wednesday, the Inquirer published a statement by former Senate President Edgardo Angara, the President's special envoy to the European Union, disputing the statement of the delegation as a "gross misrepresentation," adding they do not represent the governing majority in the EU Parliament.

The next day the Inquirer also quoted the European Union saying the delegation's statements "were made solely on behalf of the Progressive Alliance and do not reflect the position of the European Union."

The EU statement further said: "The European Union had no involvement whatsoever in

the visit of the seven-member delegation of the International Delegates of the Progressive Alliance which took place on Oct. 8 to 9 in Manila."

In explaining the President's statements, Abella said Mr. Duterte just reacted to what he had read.

"So, the President reacted as any leader would when national sovereignty is violated. So, we call upon also for the media to heed his request, too, for correct reportage," he said.

The seven-member mission, however, did not call for the expulsion of the Philippines from the United Nations. What the delegation members said was the Philippines could lose a trade deal that allowed its products duty-free access to the European Union if it failed to stop the killings and the "political persecution" of the President's critics.

It was the New York-based Human Rights Watch that had warned of the Philippines' possible loss of membership, not in the United Nations but in its rights body, if the government continued to refuse to allow an independent investigation of killings in the country.

Senate President Aquilino "Koko" Pimentel III said Mr. Duterte's rant was just "an outburst" that should be taken "in context."

The Department of Foreign Affairs (DFA) kept mum on a possible diplomatic flap with the European Union and its member-states as a result of the President's outburst.

Refer to Abella's statements

"Kindly refer to Abella's statements on the issue," DFA spokesperson Robespierre Bolivar said in a brief reply to an Inquirer query on the matter.

Trade and Industry Secretary Ramon Lopez said the European Union actually wanted to help the Philippines fight drugs and was collaborative instead of critical toward the country.

"They were not the lecturing type," Lopez told reporters.
"Their approach is, 'How can we help?' not, 'Why are you doing this?""

"They were actually saying, 'Tell us how we can help.' That was what they were saying as we were describing the anti-illegal drug campaign, for example, and all these issues," he said. "After we've explained, given them the correct set of numbers, they're telling us, 'How can we help?'"

He said he and Angara had told the EU officials that they appreciated the offer.

The Progressive Alliance that sent a delegation to Manila early this week is an international network of about 130 social democratic and socialist parties and groups, including trade unions and youth organizations, that promote justice, freedom and solidarity around the world.

According to its website, the Party of European Socialists includes socialist, social democratic, labor and democratic parties from the European Union and Norway that fight for a "better and more progressive Europe." It has 33 full members, 13 associate and 12 observer parties.

80% approval for Roa

Pulse: Still 'big majority' ratings despite slight dip

Despite the controversies hounding his administration, particularly on his brutal war on drugs, President Duterte enjoys the trust and approval of eight out of 10 Filipinos, according to the latest Pulse Asia survey.

Eighty percent of Filipinos expressed approval and trust in Duterte based on the Pulse Asia September 2017 Ulat ng Bayan national survey, fielded from Sept. 24 to 30.

Only seven percent of 1,200 adult respondents expressed disapproval with the President, while six percent said they have "small or no trust" in him.

Compared to his ratings in June, Duterte's approval and trust ratings fell only by two points and one point, respectively.

In the Pulse Asia survey, Duterte obtained majority nomic classes (72 percent to

92 percent and 75 percent to 55 percent respectively) and trust (72 percent to 93 percent and 74 percent to 85 percent, respectively).

But his scores in the new Pulse Asia poll contrasted with that of Social Weather Stations released last Oct. 8, where the President suffered 18-point and 15-point drops in his satisfaction and trust ratings, respectively.

Pulse As a president Ronald Holmes said differences of results among survey outfits were not uncommon.

"We have seen difference in survey results among survey organizations before. There are various possible reasons, from differences in questions, sampling method, period when survey was conducted, etc.," Hoimes told The STAR.

Palace welcomes results

Malacañang welcomed the results of the latest Pulse Asia

survey.

"Despite the multifaceted political noise, President Duterte is still the most approved and most trusted government official in the Philippines today with an 80 percent approval rating and 80 percent trust rating. Take note," presidential spokesman Ernesto Abella said.

"We hope these survey results inspire us in the government that despite the odds and challenges, we continue to provide a comfortable life for all Filipinos in an environment free from illegal drugs and criminality.

"This is the way we return the overwhelming confidence and trust bestowed by our people on the President," he added.

For Sen. Sonny Angara, the result of a survey is a "snapshot of public sentiment at a given time that really changes from time to time, just like those of the previous presidents."

Sen. Sherwin Gatchalian said Filipinos obviously continue to trust the President and they approve of his work and his advocacies.

"However, all studies should be analyzed carefully. It should be used to attune the policies and programs to the needs of our people. The basic problems such as poverty and impunity still persist in our society," he said.

Differte's allies, on the other hand, welcomed the survey tosult.

Senate President Aquilino Finientel III said he was not surprised by the results of the pol!

"I can also feel the support for the President spontaneously from the people I meet," Finentel said Senate Majority Leader Vicente Sotto III said the results of the poll were the "same feedback I'm getting on the ground - that eight out or to Filipinos approve or him and trust him."

For Davão City Rep. Karlo Nograles, the survey is proof that filipinos "love" the President.

He added that such ratings "will keep the political stability that we enjoy and lead us to greater heights as a nation."

Nograles expressed hope that the survey results "will discourage destabilizers from pursuing attempts to discredit the administration."

But the opposition said that it is Duterte who is destabilizing himself.

Gov't orderls' ratings movea

Meanwhile, other top national government officials experienced marked movements in their own ratings both at the national level and across geographic areas and socio-economic classes.

Senate President Pimentel

experienced a seven-percentage point decline in his approval score and a six-point drop in his trust rating in the third quarier.

Pimentel obtained an approval rating of 55 percent, while his trust rating was at 52 percent in September.

Speaker Paritaleon Alvarez and Chief justice Ma. Lourdes Sereno also suffered two-digit drops in their approval and trust ratings.

Alvarez's approval and trust ratings both tell by 10 points to 33 percent and 31 percent respectively.

Satisfaction with the work of the Chief Justice tell by 13 points to 35 percent, while trust in 161 dropped 12 points to 31 percent.

Approval for the work done by Sereno plunged in the rest of Luzon (-16 points); and in Mindar ac (-18 points) and among Class D (-14 points).

The survey has sampling error margin of plus or minus three percentage points at the 95 percent confidence level.

Lumads welcome to ioin AFP

AMP BANCASI, Butuan City—Indigenous peoples (IPs) from the different tribes in northeastern and northern Mindanao are welcome to join the ranks of the Armed Forces of the Philippines (AFP), the military's top official in the region said Friday.

"Having them join the Armed Forces is also giving them chance to serve their people, their fellow lumads while helping their community protect their ancestral domain, instead of being exploited by the New People's Army (NPA), armed wing of the Communist Party of the Philippines (CPP)," said Northeastern and Northern Mindanao Fourth Infantry (Di-

amond) Division (4th ID) Commander Maj. Gen. Ronald C. Villanueva the 4th ID chief said.

Villanueva issued the invitation as 15 IPs, or lumads, from different tribal communities in Caragao and northern Mindanao were welcomed to the fold of the military Wednesday afternoon as among the 115 Army candidates who will undergo six months military training at the 4th ID Training School in Malaybalay, Bukidnon and the Sixth Infantry Division (6th ID) Training School in Carmen, North Gotabato.

The six-month training will teach the candidate soldiers combat fighting, lifesaving imperatives, disaster response operation, peacekeeping initiatives, human rights, rule of law and rules of engagement.

According to Villanueva, the new breed of so-called peace advocates will fill up the needed number of personnel due to attrition such as optional and compulsory retirement, among others.

During the oath taking ceremony on Wednesday afternoon, the 4th ID chief advised the future Army soldiers to always follow commands and be "perfect."

There are currently some lumads in the ranks of the 4th ID who are already assisting highland communities in Caraga region, it was learned.

Meanwhile, leaders of the Higaonon, Manobo and Mamanwa tribes and officials of the Indigenous People's Mandatory Representative (IPMR) in Caraga

region unanimously expressed gratitude for the concern of the AFP in securing their respective highland communities from lawless elements by enlisting some of their qualified tribal members into the armed forces.

In a press forum at the sideline of the 20th Anniversary Celebration of the Indigenous Peoples Rights Act (IPRA) law at one of the city's hotel and convention center here on Thursday, the tribal leaders acknowledged the concern of the AFP for the security of their respective highland communities while also expressed gratitude to the office of the National Commission on Indigenous Peoples (NCIP) for continuously recognizing the concern of the lumads, especially the rights of indigenous cultural communities.

NPA owns up to banana firm attack

T'BOLI, South Cotabato - The New People's Army (NPA) has taken responsibility for a recent attack on a banana export firm here, saying that it was a punitive action for the company's unjust labor practices, and land grabbing activities and environmental destruction in the area.

In a statement to the media, Ka Dencio Madrigal, spokesperson of the NPA-Far South Mindanao Region, accused the Japanese-owned Sumifru Phils. Corp. of giving low compensation to banana plantation workers and non-payment of rental to landowners who leased out their lands for the firm's banana plantation.

Some 30 heavily-armed NPA guerillas swooped down on the company's packing plant in Barangay Laconon last October 2, and burned down its building and two water tankers.

The NPA rebels also disarmed the company's security guards of their firearms, including two .9mm pistols, and 12 gauge shotguns, and two handheld radio.

"The NPA-FSMR took a punitive action against the multinational agri-corporation for its persistent land grabbing activities, environmental destructions and unjust labor policies," Madrigal said.

Authorities placed the damage at P6 million.

The company's employees labor union confirmed the firm's alleged unfair labor practices, such as underpayment of salaries, unjust salary deductions and union busting.

Dodong Flores, Vice-President of the Sumifro Phils. Inc. Employees Union alleged that company officials connived with the Department of Labor and Employment (DOLE) for suspending the conduct of a certification election for employees union after OFFICE OF THE ARMY CHIEF PUBLIC AFFAIF a collective bargaining agreement (CBA) between the incumbent ALU-TUCP employees union and Sumifro management terminated last June.


NPA medic captured

Three Sayyaf fighters surrender

The military announced the surrender of three Abu Sayyaf terrorists with high-powered firearms in Sulu on Friday

Brig. Gen. Cirilito Sobejana, the commander of the Armed Forces of the Philippines (AFP) Joint Task Force (JTF) Sulu, identified the ASG members who surrendered as Ajimad Musnali, Nanah Amdad Tunggal, and Hasiri Sabirin. They shall undergo custodial debriefing at Camp Kuta Heneral Teodolfo Bautista Busbus, Jolo, Sulu.

Sobejana said the three surrendered to the JTF Sulu at vicinity of Barangay Bulibangao, Tongkil, Sulu, at 8:30 a.m. Friday

The ASG members also turned over to government high-powered firearms consisting of three Caliber.30 M1 Springfield rifles

Sobejana said the surrender was facilitated by the combined elements of 545 Engineering Construction Battalion (ECB) and Philippine Coast Guard Western Mindanao District.

Sobejana, in his report, cited a number of reasons the three surrendered,

Aside from these, they also cited lost of community support and that the beheading of their kidnap victims is un-Islamic.

Lorenzana: Mautes welcome to surrender

ZAMBOANGA CITY — Defense Secretary Delfin Lorenzana has brushed aside insinuations that Maute group members, who will surrender to the government, will still be killed by government forces.

Lorenzana issued the statement yesterday to counter the propaganda of the Maute group warning their remaining members fighting in Marawi City tat they will be killed by the government once they surrender.

"No, if you will surrender, you will not be killed," Lorenzana assured, citing they will be

afforded fair trial and the opportunity to be rehabilitated back to the society.

So far, Lorenzana said that three members of the Islamic State for Iraq and Syria (ISIS)inspired Maute group surrendered two weeks ago.

He said troops are moving around daily with public address system giving instructions on what to do by the Maute group members who wish to surrender.

He said it is useless for the remaining members of the Maute group to continue on fighting.

"If they keep on fighting, then

we will finish them," he emphasized.

He disclosed that the terrorist group leaders namely, Abdullah and Omar Maute, as well as Abu Sayyaf Group (ASG) leader Isnilon Hapilon are still inside the main battle area of Marawi City.

But Lorenzana this time begged off to give specific date as to when would the fighting ends in the besieged city of Marawi.

"The crisis will end soon," Lorenzana assured.

The defense chief arrived here yesterday for the opening of the two-day (not one-day as earlier

reported) Regional Ulama Solidarity Summit for Peace and Security.

The objectives of the solidarity summit are to bring together the *ulama* (religious professionals) in the Zamboanga-Basilan-Sulu and Tawi-Tawi (ZamBaSulTa) areas to mutually consult and discuss on the pressing issue of violent extremism and terrorism (VET); and, to reach consensus on how to protect the Muslim community in general and determine the *ulama* role in countering and preventing VET in the locality.

'Talks with Reds still alive despite President's tirades'

PEACE negotiations with the National Democratic Front still remain "alive" despite President Rodrigo Duterte's own pronouncements abandoning a possible revival of talks within his term, a senior Cabinet official said.

In a Palace news briefing, Labor Secretary Silvestre "Bebot" Bello III, who also sits as the chief government panel negotiator in the peace talks with the communist rebels, admitted they are not sending any formal notice to terminate the peace talks yet.

Bello stressed that Duterte will not "abandon" his pledge to the Filipino people to bring "lasting peace for our country" in coming up with a successful deal with the communists.

"When the President came in as our president, he made a very clear statement that his legacy to our country and our countrymen is a lasting peace for our country. So I don't think that the President has abandoned that legacy," the Labor chief added.

Despite Duterte's tirades virtually placing the final nail in the coffin for the possible resumption of the peace talks, Bello insisted these did not mean "that the talks were

canceled or terminated."

"The talks are alive and we are just waiting for the President to give us the instruction to go back to the peace table," Bello stressed.

Duterte earlier said he no longer wanted to talk peace with the Communist Party of the Philippines-New People's Army-NDFP group, saying their demands are "not really possible"

"We are fighting the NPA. At this stage, I am not ready to talk to them because it is not good for the country," Duterte said.

"Eh kung para lang sa bayan, okay 'yan. But the way that it is now, ayaw ko [If only it's for the good of the country, it's okay, but the way it is now, I don't want it.] And maybe it would take some time to... maybe another President to do it," he added.

The government was slated to resume the fifth round of talks with the communists last May, but suspended the negotiations following the "serious challenges" both parties were facing.

The round of talks slated last August was likewise cancelled, amid the "lack of enabling environment" to proceed with the talks, the government peace panel said.

RESIDENT Rodrigo Duterte on Friday warned he would declare a revolutionary government and arrest all political dissidents, including the communists and opposition "yellow" forces should they continue with their efforts to destabilize his administration.

"If they try to destabilize and the situation becomes too violent, I will not hesitate to declare a revolutionary government until the end of my term. I will arrest all of you and we can go to a full-scale war against the Reds," Duterte told his critics

"If they try to destabilize and the in a television interview aired over trustion becomes too violent, I will state-run PTV4.

"If I think you're about to take over the nation, and you have destabilized government like a new one would replace the current administration I am on guard," he added.

In a related development, Senate President Aquilino Pimentel III said he had instructed the Senate's IT Department to find out what security measures could be adopted to thwart a recurrence of the spread of fake e-mails sent from the hacked e-mail accounts of the Senate's minority staff.

He also ordered the department to determine if such hacking could be stopped.

"Although I also haven't seen any complaint from Senator Paolo Benigno Aquino about this, we already acted on it, having read it in the news," Pimentel said.

Aquino, in a press conference on

Thursday, revealed fake e-mails he said were attempting to connect the minority senators to destabilization plots.

"Fake news has escalated to fake e-mails and digitally planted evidence," Aquino said.

Duterte is confident the military will stick with him amid destabilization efforts by the Reds and the Yellows.

Duterte said the military was aware the Communist Party was active in the destabilization scheme, adding "Do you think the armed forces and police will sympathize with you after you've cheapened the lives of security forces with the [extrajudicial killings]?"

Duterte said his move to declare a revolutionary government was the same as what then President Corazon Aquino, whom he tagged as the "heroine of the yellows" did, soon after the Marcos regime.

Unlike Marcos, Dutete sees a revolutionary government as a more practical step since this eliminates the need for the President to report to Congress.

When then resident Marcos declared martial law in 1972, he did by virtue of his powers as commander-in-chief of the armed forces vested in him by the 1935 Constitution, after he called on the troops to quell a rebellion and suspended the privilege of the writ of habeas corpus—all steps given the

incumbent chief oif state by the Charter.

Marcos lifted the emergency in January 1981, three months before the presidential elections where he trounced former Defense Secretary Alejo Santos.

Aquino said the fake emails were found in the draft and spam folders of employees in an attempt by hackers to connect the opposition to the destabilization plots against the government.

"We decided to share this with the public because a lot of pro-administration personalities and online supporters alike are spreading take news of a destabilization plot by the Liberal Party," Aquino said.

"We have no destabiliza-

tion plot. Those behind the hacking and fake e-mails are the true destabilizers. They want chaos in the Philippines."

Aquino said the accounts of some staff members had been used to send dubious e-mails containing controversial subject lines like "Leaked Media Plan to Destroy PRRD" and "The Investigation on DDS," together with an attached file.

"It is also possible that these files, which prompt an error when opened, are being used to gain control of the device or fish for information." Aguino said.

The minority senators have reported the issue to the National Bureau of Investigation, Department of Information and Communications Technology and the Armed Forces of the Philippines to determine the people behind the hacking and the spread of destabilization rumors.

A total of five e-mail accounts have been hacked: two from the office of Aquino and three from the office of Senator Francis Pangilinan.

"We should know who are behind this and hold them liable. These people should go to jail because what they did was a crime," Pangilinan said.

The Liberal Party senators have criticized the administration for continually insisting that the party had a plan to destabilize the government.

Liberal Party president

Pangilinan stressed that airing criticisms and their sentiments were the foundations of democracy and should not be considered destabilization—against—the government.

Aquino said top government officials should stop floating news about destabilization as the Armed Force of the Philippines had declared it had monitored no moves to oust Duterte.

Senator Franklin Drilon said the administration should be open to criticisms and use these to improve governance and not consider them as destabilization moves.

"The administration needs to learn to take criticisms as these can also help improve ways of running the country," Drilon said.

Rody threatens to declare

revolutionary gov't if...

If the government will be in peril due to the efforts of the Left and his critics, President Duterte would not hesitate to declare a revolutionary government to quell destabilization moves against his administration.

He added that he would use the revolutionary powers to

avert the country from falling into chaos as he accused the Communist Party of the Philippines of playing a key role in the destabilization efforts.

"Pag ang (if the) destablization ninyo patagilid na at medyo magulo na (would be shaky and more trouble). I will not hesitate to declare a revolutionary government until the end of my term," he said yesterday over state-run People's Television Network

He will do this only when the destabilizers are on the brink of taking over government:

Once the military government is restored, Duterte said he would order the security forces to arrest all destabilizers and go on a full-scale war against the communist rebels.

"I will arrest all of you and

we can go to a full-scale war against the Reds," Duterte said.

A lawyer, Duterte noted that his hands would not be tied in case he declares a revolutionary government – unlike when he imposes martial law, which mandates the reporting to Congress within 60 days upon declaration.

With the military and the police on his side, he doubted

whether any effort to take over the government would be successful.

"Do you think the Armed Forces of the Philippines and (Philippine National) Police would sympathize with you after you have cheapened the lives of those who were killed in EIKs?" the Chief Executive said.

At the same time, Duterte also accused certain media

outlets critical of his administration as having received funds from abroad to destroy his administration.

"They are there to destroy me," he said, agreeing with the opinion of columnist Rigoberto Tiglao, who warned that certain media critics are receiving funding from a firm backed by the US Central Intelligence Agency.

Left warns of Du30 crackdown

Members of the left-wing Makabayan party-list bloc have warned of a looming crackdown on dissenters following the Duterte administration's creation of an Interagency Committee on Legal Action (Iacla).

The congressmen found the Iacla, created in an Oct. 9 resolution by Philippine National Police Director General Ronald dela Rosa and Armed Forces of the Philippines Chief of Staff Eduardo Año, to be a revival of the Arroyo administration's Interagency Legal Action Group (Jalag).

Bayan Muna Rep. Carlos Isagani Zarate said "there was a spike in trumped up charges

against the opposition" during the heyday of former President and now Pampanga 2nd Dist. Rep. Gloria Macapagal-Arroyo's Ialag.

Anakpawis Rep. Ariel Casilao noted the experience of the Makabayan bloc's precursor, the "Batasan Six," who were detained on rebellion charges when Arroyo placed the country under a state of national emergency in 2006.

Trumped up charges

He also cited the cases of activists, dubbed the "Southern Tagalog 72" and the "Tagaytay 5," as well as more political leaders in Cebu and Davao.

"If Iacla pushes through, the possibility of us in the Makabayan bloc being accused of trumped up charges will not be remote, as it has precedent, hence, it is just to call for the immediate abolition of this authoritarian measure," Casilao said.

"It is a shame that even this antihuman rights body under former President Macapagal-Arroyo was plagiarized by President Duterte, this was a major player in abuses against the people, particularly activists demanding then her resignation," he added.

Muzzle dissent

Gabriela Rep. Emmi de Jesus said the Duterte regime had set into motion the government's legal mill to target critics with fabricated charges, intensified vilification and extrajudicial killings of activists.

"In the face of mounting

criticisms and declining ratings, Duterte is resorting to the revival of Ialag in a desperate attempt to muzzle dissent, in line with the counterinsurgency plan 'Oplan Kapayapaan' and the US counterinsurgency manual. A desperate regime clings to heightened oppression," De Jesus said.

Tool of repression

Meanwhile, the National Union of People's Lawyers (NUPL) echoed the sentiment and said the Iacla would "institutionalize cover-up, mechanically pass off blame and brazenly harass or intimidate so-called 'enemies of the State' by enemies of the people."

"It was a legal tool of repression and a legal mantle of impunity then, it will be an illegal

tool of repression and an illegal mantle of impunity now. Enough already of these silly dangerous gimmicks," NUPL said in a statement.

Stronger coordination

PNP said in a statement on Tuesday that the Iacla was meant to "strengthen the intelligence gathering and cooperation, investigation, prosecution and monitoring of cases against threat groups ... by establishing stronger coordination of ongoing and future efforts of the government in addressing these cases."

Año reportedly said on Monday that the country has "so much democratic space that is being exploited by terror groups and also criminal groups." INQ

Scammers using Marawi crisis warned anew

The Department of the Interior and Local Government (DILG) has vowed to expose scammers soliciting money for Marawi evacuees.

DILG officer-in-charge Catalino Cuy said they continue to receive reports of phone calls and text messages from individuals who pose as DILG chief or members of his staff asking for cash donations for displaced Marawi residents.

"It's only a matter of time for you to be exposed. Our police information technology experts are now working, even as I speak," Cuy said in a statement.

"The hands of the law will reach fraudsters who are shamelessly using the name of poor Marawi evacuees to get money from unsuspecting victims," he said.

Cuy took exception to unscrupulous individuals who ask for donations to be sent through a remittance center or deposited in a bank account.

He called on local chief executives to help in the investigation.

"Help yourself from being a victim of extortionists and be part of the solution," Cuy said

No more deadline

Meanwhile, Defense Secretary Delfin Lorenzana is no longer setting a deadline to end military operations in Marawi.

"I have been burned many times, perhaps five times. At the end of the day, it is up to the ground commander," Lorenzana told reporters during a visit to Zamboanga City for a summit with Muslim scholars yesterday.

However, Lorenzana said Western Mindanao Command chief Lt. Gen. Carlito Galvez gave assurance that the operation would end

"He told me just awhile ago that the days are numbered, but he also did not give a date," Lorenzana said.

"Let's just wait. One of these days you will be surprised – the President will emerge from the battleground to declare that the war is over," he said.

Government forces have been fighting Maute militants who occupied parts of Marawi since May 23.

MALAYSIA, INDONESIA, PH TO CONDUCT AIR PATROLS

KUALA LUMPUR—Malaysia, Indonesia and the Philippines will begin coordinated air patrols off the strife-torn southern Philippines next month to combat the growing threat posed by Islamist militants, an official said on Friday.

The neighbors already launched joint sea patrols four months ago in the same area, the Sulu Sea.

Fears have been growing that the Islamic State (IS) group is trying to establish a Southeast Asian outpost in Mindanao after gunmen waving the jihadists' black flag occupied the Muslim city of Marawi in May.

They have fought off a US-backed military assault for almost five months and the conflict has left hundreds dead.

There has also been a spate of kidnappings in the Sulu Sea by the bandit group Abu Sayyaf.

A ceremony to announce the patrols was held on Thursday at Subang air force base outside Kuala Lumpur and was attended by defense ministers from the three countries. Piracy

A Malaysian defense ministry spokesperson said the patrols were aimed at combating the threat from "Daesh (IS), piracy and sea robberies."

The three countries will take turns to lead the patrols, with Malaysia starting in November, followed by the Philippines in December and Indonesia in January.

In a speech at the ceremony, Malaysian Defense Minister Hishammuddin Hussein said that some \$40 billion in trade passed through the Sulu Sea every year and no single country could police the waters alone. —AFP

Astute one step back on anti-drug campaign



in his satisfaction and trust ratings, as shown by the latest Social Weather Stations survey, President Duterte has taken a one-step backward in his widely criticized and condemned bloody anti-illegal drug campaign, led by the Philippine National Police. He had earlier expressed his concern about preserving his credibility to enable him to continue leading the nation.

In an October 10 memorandum, he has designated the Philippine Drug Enforcement Agency (PDEA) as "sole agency" to conduct all campaigns and operations against all those involved in illegal drugs. The move, the memo says, is aimed at bringing "order to the operation/campaign against illegal drugs, thus pinpoint-

ing precise accountability.

All information / data received by the NBI, PNP, AFP, Bureau of Customs, Philippine Postal Office and all other agencies or any and all ad hoc anti-drug task forces shall forthwith be relayed, delivered or brought to the attention of the PDEA for appropriate action," the memo states.

Cryptically, however, Duterte said: "The PNP shall, at all times, maintain police visibility, as a deterrent to illegal drug activities... Strict compliance is hereby

enjoined."

Moreover, questions may be raised as to whether the PDEA - with only 1,038 agents in its roster (as compared with the PNP's 175,000 manpower complement) - can more responsively and more effectively undertake the task: Duterte himself has acknowledged that the drug problem may remain for the rest of his term.

What the move shows is Duterte's political astuteness beneath his often disconcerting volatility and rashness in speaking and acting on key aspects of his administration's governance and policies. These include, for instance, the peace negotiations with the Left revolutionary forces and his avowed "independent foreign policy."

Having said that, one may as well watch for the President's next move vis-àvis the GRP-NDFP peace talks, which he

pparently stung by the steep drops has "cancelled" since his second state-ofthe-nation address last July

Think about this: Although he has kept on saying he no longer wanted to talk peace with the Left, he has refrained from sending a tormal notice to the NDFP leadership terminating the talks. In fact, he has allowed - or directed -- his chief peace negotiator, Labor Secretary Silvestre Bello III, to say at a recent Malacanang briefing that the peace talks can still continue, since Duterte has only cancelled but not abandoned the negotiations.

Back to the drug issue - over which Duterte is most touchy, bilious and truculent, as his recent tirades and cursing at the European Union has proven - what does the removal of the PNP from its lead role

in the campaign aim to achieve?

The instant effect of Duterte's memo is that the PNP has stopped the implementation of its two principal anti-drug campaigns: "Oplan Tokhang" and "Project Double Barrel. Oplan Tokhang entailed a police door-to-door campaign ostensi-

bly to convince drug users to surrender for rehabilitation. Under Project Double Barrel, the police conducted sweeping drives in slum areas where they admitted killing more than 3,800 suspected drug pushers/users, who allegedly resisted arrest and fought back. Thousands of other killings have been attributed to so-called vigilantes.

By ceasing the two police campaigns, Duterte may have taken the wind out of two "stop-the-killings" initiatives.

One was the filing last Wednesday before the Supreme Court, by the Free Legal Assistance Group (FLAG), of a petition asking the tribunal to stop the implementation of Oplan Double Barrel. The petition says the Oplan "violates the right to life, to due process of law, to be presumed innocent and to a fair trial by expressly authorizing the summary Lallling of suspected drug offenders in the guise of 'neutralizing' or 'negating' them." - It also claims Oplan Tokhang is unconsti-

tunonal pecause the house visits "are not limited to drug suspects and based on furtive fingers of unknown informants."

However, the SC can still entertain the petition with regard to its plea for the issuance of a writ of amparo and temporary protection order prohibiting the police from getting near the residences or work places of the petitioners: the families of two victims of extrajudicial killings (Ryan Dave Almora and Rex Aparri) and a survivor (Jefferson Soriano) in a police anti-narcotics operation. Also, the petition asks for an impartial investigation of the two incidents, and for the court to set oral arguments on the cases.

The other initiative which may be adversely affected by Duterte's memo is the open invitation by the Catholic Bishops Conserence of the Philippines (CBCP) to the general public to join an activity at the People Power Monument on Edsa on Nov. 5, a Sunday. Its aim: to start a 33-day "healing period" after the Catholic Church's 40day "Stop the Killings" campaign that began on Sept. 23 with the ringing of church bells, praying of the rosary, and candle lighting at

all churches nationwide.

The activity starts with a mass at the Edsa Shrine, followed by a candlelight procession to and massing-up around the monument. The image of Our Lady of Fatima, revered by Catholics (and which, during the peaceful popular uprising in 1986, was brought by devotees to Edsa in an effort to quell troops loyal to Marcos), will be carried during the candlelight proession, according to Archbishop Socrates Villegas, CBCP president.

Will the drug-related killings be reduced consequent to the scrapping of the Oplans and the lead role of the PNP? Perhaps, yes. But even if that happens, the publicly demanded impartial investigation of the previous killings, which largely victimized the poor, must be unrelentingly pursued and completed by prosecuting and penalizing those who are accountable.

The choice is for or against our country

first learned about the danger of narcopolitics in a conversation with Retired Brig Gen. Victor Corpus, former chief of the Intelligence Service of the Armed Forces of the Philippines (ISAFP) some years ago. He was then already warning all and sundry that its



dangers were growing rapidly unless it was tackled

seriously using the powers of the state.

Corpus knows what he speaks of because he used to be on top of the drugs issue as chief of the ISAFP. At the time when I met him, the war on drugs was not a central issue in our politics. We knew it in bits and pieces and there was no leader who would drag it out in the open as a platform of government. He watched how it grew and should now feel vindicated for his warnings.

He has recently come forward to say that he fully supports President Rodrigo Duterte's campaign

against illegal drugs.

"Nung nasa ISAFP ako, inumpisahan namin yung war on drugs. We campaigned against narco-politics," Corpus told reporters in a weekly Kapihan.

He said "We were not able to do what the Duterte administration has accomplished so far in its campaign."

"Hindi namin nagawa yung ginagawa ngayon ng presidente. Look what happened, lalong lumaganap ang problema," Corpus said.

He said he supports the government's anti-illegal drugs campaign "100 percent."

"Kung hindi natin gagawin ito, we will end up worse than Colombia," he added.

Corpus used the illegal drug trade in Colombia which reached its peak between 1993 and 1999 when it was the world's largest producer of cocaine and one of the

major exporters of heroin at that time.

To date, it has been a fight for numbers. Those who wish Duterte to succeed like Corpus et al use figures of what this government has done. It is Army Vision Ess succeeding because it has dragged the problem to the center of Duterte's government agenda. More and more Filipinos have become aware of the drug problem. The 1.9555 2003 5285 5295 figures from this side are 1,377 drug suspects and 22,503 arrested in 23,549 police operations. The figures come from the Philippine National Police (PNP)

There is another side to Duterte's war on drugs and that is how it is being used to put down his government by the discredited Liberal Party who did nothing about the problem and yet now wants to return to power.

They are aided by international groups mostly from the US and other Western countries who are against Duterte for a different reason. They don't like his separation from the US and the West. He said it bluntly without any pretension for niceties. I saw and heard him say it in China when he declared Philippines' separation from US domination. That is using "language as a source of power, and perhaps especially so within the sphere of politics." The team up of international NGOs and Liberals who want to return to power can be a formidable opponent. It has an infrastructure and money to use against Duterte's government. As already written about by other opinion makers it has become a political tool. Aquino and Drilon may have support from international NGOs but Duterte and his government has an unbeatable advantage despite what SWS survey says - he has the support of the Filipino people.

It has become a commonplace strategy to appeal to human rights in order to make a case for political change. This strategy is also what is behind powerful countries interference in the domestic affairs of other countries.

Filipinos must choose whether to be on the side of their government or foreign interference.
