<u>Ombudsman fires</u> Mabilog over wealth

By JENNIFER RENDON

ILOILO CITY - On leave and said to be out of the country after being linked to drugs by President Duterte, Mayor Jed Patrick Mabilog has been ordered dismissed by the Office of the Ombudsman for "serious dishonesty" in connection with his "unlawful acquisition of wealth."

Mabilog filed a leave of Piad said the mayor "has

30 purportedly for nearth reasons. He later filed for a 30-day extension of his "sick leave."

On Wednesday, Duterte concluded his remarks about the killing of alleged narco-politicians as well as Mabilog's own drug links with the words, "You're next." The President did not say what he meant exactly.

In a 13-page decision, the ombudsman also ordered the cancellation of Mabilog's civil service eligibility, forfeiture of retirement benefits and perpetual disqualification from public office.

His spokesman Mark

puusman s order as iviabilog has not yet received a copy of the document signed by ombudsman prosecution officer Rachel Cariaga-Favila on Aug. 29 and approved by overall Deputy Ombudsman Melchor Arthur Carandang on Oct. 6.

"We didn't expect that the ombudsman would not appreciate the evidences we presented," Piad said.

It was former Iloilo provincial administrator Manuel Mejorada who filed the charges against Mabilog.

Mabilog of hiding the true sources of his income, in violation of the law on the filing of statement of assets, liabilities and net worth (SALN).

The former provincial ad-

ministrator based his complaint against Mabilog on the latter's SALN.

The complainant alleged that the almost P9-million increase in the respondent's

net worth was "manifestly disproportionate" to his income as a public official and constitutes unexplained wealth.

In his 2013 SALN, Mabilog reported the purchase of a residential lot for P6 million, unspecified investments of P2.6 million and ownership of cash and cash equivalents amounting to over P6 million Mabilog's 2013 SALN showed a net worth of over P68 million.

In his 2012 SALN, he reported a net worth of P59.3 million. This means that within a year, Mabilog's net worth increased by P8.9 million, Mejorada added.

Even with his businesses and investments, Mabilog could not have raised enough cash to purchase 664 square meters residential property and acquire new investments, Mejorada said.

Mejorada also noted that Mabilog did not state in his SALN his wife's work as a comptroller in Canada. The mayor's wife, Mejorada claimed, could not have amassed such huge amount of money from her job in Canada where taxes are

high, "unless respondent can present proof that his wife's income is sufficient to accumulate wealth."

In his 2012 SALN, Mejorada noted that Mabilog reported a bank loan in Canada for P21,587,615, listed as P21,183,600 in his 2013 SALN.

The decrease, the complainant noted, "defies financial logic," especially since

- would allow them to live a comfortable and even opulent life, the mayor said.

Mabilog said his and his wife's property holdings and investments were all properly enumerated in his SALN. He stressed an increase in net worth does not necessarily mean an increase in income.

Mejorada believed that the loan was meant to make it appear respondent's net worth was smaller than it really was

He also noted that Mabilog has financial interests in Mega Pacific Food Services Inc., One Esplanade Realty, Iloilo Happy Haus Donuts and Globe Jami Motors Corp.

Based on Securities and Exchange Commission (SEC) records, Mabilog owns 30 percent share in the capital stock of Iloilo One Esplanade.

The ombudsman dismissed for lack of sufficient evidence the charge of grave misconduct against Mabilog in connection with his appointment of business partner Patrick Allan Sy as his "executive assistant for dengue concerns" as well as his alleged use of his position to secure favors for Iloilo One Esplanade.

Counter-affidavit

In a counter-affidavit, Mabilog dismissed the charges as malicious and conjectural with no solid basis.

He explained his family was already considered well off prior to his joining public office.

Mabilog insisted it was his business acumen that helped him spearhead the development of Iloilo City into a bustling center.

His wife's salary alone - at Cad\$200,000

Mabilog failed to rebut the assertions of unlawful wealth, the ombudsman added.

The ombudsman noted that Mabilog justified the increase in his net worth by citing his several businesses as well as his wife's huge income as a comptroller in Canada. Mabilog also failed to present proof of income from the business interests disclosed in his SALNs.

Mabilog hit the headlines in September after Duterte tagged him in public as a drug protector, with links to slain suspected drug lord Melvin Odicta Sr.

An assassin killed Odicta and his wife at Caticlan port in August last year.

On Wednesday before a gathering of Southeast Asian lawyers and diplomats, Duterte again accused Mabilog of involvement in the drug trade, even telling the mayor, "you're next."

It was apparently an ominous reminder to Mabilog of the fate that befell Odicta and mayor Rolando Espinosa Sr. of Albuera, Leyte.

Mabilog's spokesman Piad said Duterte's continued threats were aggravating the mayor's health condition. But he admitted Mabilog's extension of his leave was now more of a security precaution than a medical initiative.

Piad said they would exhaust all legal remedies to counter the dismissal order.

"Considering the gravity of the offense allegedly committed, there is a strong possibility that the following individuals may attemp to place themselves beyond the reach of the legal processes by leaving the country." Aguirre said.

In a statement, Divina lamented his inclusion in the ILBO as "an unfortunate but not entirely unexpected development," insisting that he has no liability over the hazing case as he has "no prior actual knowledge" of the incident.

"Nevertheless, I will comply with whatever order the DoJ may issue. In fact, I just came from two overseas business trips. In both cases, I had to cut short my trip and adjust my schedule to be able to attend to Schate committee and DoJ hearings." Divina said.

Divina said he remains committed to cooperating with authorities in the ongoing investigations into the hazing incident, expressing confidence that his name will eventually be cleared from the allegations of cover-up.

Meanwhile, the DoJ also included a dead person, former Mulaya newspaper reporter and Cavite provincial prosecutor Emmanuel Velasco, who passed away in 2013.

Sought for comment, DoJ spokesman Erickson Balmes said: "We don't know if he's dead already. Better safe than escape."

The order was issued in light of the testimony of former Aegis Juris officer Marc Anthony Ventura who appeared to have turned his back on his fracernity brothers after coming forward as state witness in the alleged fatal hazing of Horacio.

Ventura broke the fraternity's omerta when he restified against his fraternity brothers before the DoJ and National Bureau of Investigation (NBI) officials, detailing how Horacio was physically abused during four anne of harring

at the DoJ Main Building on Tuesday as his fraternity brothers who were tagged as suspects were filing their respective counter affidavits during a preliminary imestigation at the DoJ Forum huilding.

According to Aguirre, Ventura, Aegis Juris' former secretary, is willing to face resignation or expulsion from the fraternity for his actions.

The criminal complaints filed against Aegis Juris fraternity members tagged in the initiation rites believed to have led to Horacio's death are pending a preliminary investigation at the DoJ.

Case to speed up with Ventura as state witness

The decision of one of the suspects in the hazing death of Castillo, Ventura, to turn into a state witness is seen to expedite the resolution of the case.

Even the probe in the Senate on the case is seen to be expedited with this latest

development.

Sen. Panfilo Lacson, chair of the committee on public order and lead in the Senate probe on the Castillo case, said they have already scheduled the third public hearing on Monday, Nov. 6 to possibly wrap up the inquiry and introduce the pertinent legislation that will provide needed teeth to RA 8049 or the Anti-Hazing Law.

It is their hope that amendments to the law will avoid future deaths of physical harm on young people like Castillo, he said.

As to Ventura turning into a state witness, Senators Juan Miguel "Migz" Zubiri and Joel Villanueva, said it's a welcome development to the case and brings justice for Castille one step closer.

Lacson said it's still a long way to go before justice is finally served to Castillo.

"In any criminal investigation and trial, the details of the truth always add up to the credibility of a testimony. Ventura's narration of events that led to Atio's hazing to death has provided exactly that.

"Sadly, I can only imagine the

mived feelings of relief and agon through right now how they hate to hear what they have wanted to

know," he said. "Having said that, the manner by which the initiation rites were conducted, both preliminary and final could shock even those who have experienced the same ordeal when they joined their own fraternities," Lacson added.

Ventura had voluntarily submitted himself to the Department of Justice accompanied by his mother and lawyer.

He submitted a statement that narrated events and specific acts about more members and nonmembers of Aegis Juris fraternity who played their roles in the September 17 incident that resulted in the killing of Alic Castillo.

"The narration rendered by Ventura showed the frat bruds were relentless in inflicting pain and injury. What they did were not symbolic acts of initiation into brotherhood or tests of character.

Each paddle whack each punch and each candle wax drip had built into deathly blows from which no one could have emerged a whole person physically emotionally and mentally. Atio (Castillo) was a whole man before he underwent hazing, and came out of it a broken mass in pain," said Zubiri.

"The pang of conscience is the thin line that separates men from beasts. Young Marc (Ventura) gives me hope because his young conscience made him tell the truth and free himself from the sinister code of silence to cover up the crime within the walls of the Aegis Jyris der. called the Library," he

Ventura is the second Aegis Jyris member who spoke on the killing of Castillo, after John Paul Solano, a medical technologist not currently enrolled at the University of Santo Tomas.

"It must have been a battle that Marc (Ventura) fought in his mind and heart through all these days while the Senate investigated, his frat brods lied and lawyers conjured smokescreens to save their skins. I note with high regard that Mare won the fight from being s coward to one who fearlessly

to be part of the light instead of the dark lies," Zubiri said.

Villanueva said he expects Ventura's camp to submit his and other affidavits, which were submitted to the Dog to be furnished to the Seaste committee on public order and dangerous drugs which is investigating the death of Castillo.



Suspected NPA rebels torch truck carrying 1,462 boxes of bananas

BUTUAN CITY - Some 15 fully armed men believed to be members of New People's Army (NPA), armed wing of the Communist Party of the Philippines (CPP) torched a truck fully loaded with 1,462 boxes of bananas last Wednesday in Barangay Banahao, Lianga, Surigao del Sur, a flash report reaching the police regional headquarters on Thursday said.

The driver and helper of the truck -- not harmed during the incident,

police station.

The Bureau of Fire Protection (BFP) in Lianga contained the blaze after an hour at around 1:38 p.m.

Initial investigation conducted by the Lianga police showed that the truck of DOLE- Philippines was travelling from Tago town, Surigao del Sur to Panabo Čity, Davao del Norte prior to the incident.

"Upon reaching the aforementioned place, said van was flagged down by more or less 15 fully armed men believed to be a member of Sentro de Grabedad (SDG) platoon under certain a.k.a. 'Dindo' and Tulong Wagdos, a.k.a. "Tuloy', fired and burned the container van using their long firearms several times," the Lianga police report stated.

After the incident, the perpetrators immediately withdrew towards northwest direction in Sitio Huwangan, Barangay San Isidro.

Responding Lianga police personnel recovered from the crime scene several fired cartridge cases of M16 Armalite rifle, M14 rifle and AK47 rifle.

As of press time, elements of the Philippine Army's 75th Infantry Battalion and Lianga police are still in pursuit of the perpetrators.



Año retires, to head DILG after one year

The military chief credited for liberating Marawi from the clutches of Maute terrorists has been named head of the department that has jurisdiction over the police.

Gen. Eduardo Âño received his new appointment as secretary of the

Department of the Interior and Local Government (DILG) upon his retirement vesterday as chief of the Armed Forces of the Philippines (AFP)

President Duterte announced his

appointment of Año to the DILG at the turnover ceremonies for new AFP chief Lt. Gen. Leonardo Guerrero at Camp Aguinaldo.

But Año's actual assump-

Carrorny mappen aries a year from the date of his retirement in accordance with law, Duterte said.

Duterte's marching orders to the new AFP chief is to destroy all weapons left in the battle zones of Marawi.

The Chief Executive lauded Año for his achievements in his more than three-decade stint in the military.

"He would head the Department of the Interior and Local Government. But while he is prohibited from assuming the task for one year and that is the law, from the military service to the civilian sector, you have to wait for one year," Duterte said.

"Either he takes the title of Special Assistant to the President or undersecretary, whichever is tenable legally. And he will now supervise the Philippine National Police, together with (DILG officer-in-charge) general (Catalino) Cuy," he added.

The DILG has direct supervision over the Philippine National Police. (PNP), which was recently pulled out of the war on illegal drugs following reports of gross abuses that included the execution of teenagers.

Año will also have jurisdiction over the Bureau of Jail Management and Penology, which runs city and town jails that are currently crowded with suspects detained in the war on

Duterte said the liberation of Marawi was the "crowning jewel" of Año's career.

"As General Año leaves behind this legacy and marches towards his final review of our troops, I am confident that the AFP will sustain its gains because of the organizational

and capability upgrades initiated during his tenure," the President stressed.



New AFP chief turns sights on Reds, terrorists

WITH the defeat of the terrorist Maute Group, new AFP chief Lt. Gen. Rey Leonardo Guerrero yesterday vowed to end the remaining terrorist groups and neutralize communist rebels.

In his assumption speech in Camp Aguinaldo in Quezon City, Guerrero said he is going to use the entire military to achieve the objective during his incumbency as AFP chief, which is until December 17 or less than two months, unless extended by President Duterte.

"The priorities in the area of peace and security are clear—finish the remaining terrorist groups, neutralize the communist threat, and support law enforcement agencies By terrorist groups, Guerrero was referring to the Abu Savyaf and the Bangsamoro Islamic Liberation Front. Like the Maute Group, the two groups have pledged allegiance to the Islamic State.

Defense and military officials earlier this week declared that the Maute Group has been defeated with the end of the Marawi conflict after five months of fighting which left about 960 Maute members dead.

The New People's Army is the only communist threat. President Duterte terminated peace talks with the National Democratic Front of the Philippines-Communist Party of the Philippines-NPA in July as the NPA continued its attacks on government forces even while the formal peace negotiations were ongoing. The CPP even

troops after Duterte placed Mindanao under martial law in May because of the Maute attack on Marawi City.

President Duterte has said he no longer wanted to talk with the communist group. Last month, however, he told the NDFP-CPP-NPA to declare a ceasefire if they want the peace talks to resume.



The terrorists have time and again been offered to save themselves by surrendering. I do not say there were no mistakes, I say that in general it was how it should have been under the circumstances.

As a citizen seeing the above from a distance, I see an educated, modern, well-trained army. It seems we have come to a new day where troops are expert, disciplined and approachable, displaying remarkable courage and patriotism and regard for their fellow citizens as they lay their lives on the line to save the republic.





Año's appointment was announced as he retired yesterday from the Armed Forces of the Dhilinnings hut it takes offect

was given the challenging task of retaking Marawi from Islamic State-inspired gunmen who used civilians as shields and holed out in mosques as they engaged government forces. The urban warfare took five months, but the AFP, assisted by the PNP's elite Special Action Force, managed to neutralize the top terrorist commanders together with over a thousand militants and liberate the city.

With that victory, much is expected of Año when he takes charge of the department that supervises the PNP. Unlike the AFP, the PNP has seen its public image deteriorate amid gross abuses in waging the war on illegal drugs. Año will face the chal-

lenging task of restoring public trust in the PNP, especially if it rejoins the anti-drug campaign. Can Año liberate the PNP?

The DILG chief also has supervision over local governments, including barangay units. President Duterte has said thousands of barangay captains and personnel have been linked to the illegal drug trade. A number of baran-

city and provincial governments, are also notorious for red tape, graft and inefficiency. Many have yet to comply with the President's order to keep the waiting time for public documents and other government services to no more than three days.

Año will also have supervision over the Bureau of Jail Management and Penology, whose facilities are overwhelmed by inmates apprehended in the campaign against drugs and criminality. With full support from the President, the new DILG chief should be able to make a dent in these problems.

State-inspired terrorists.

President Duterte has made his point: he doesn't like open criticism and being told what to do by foreigners. It looks like foreign capitals got the message iquickly and have been channeling their concerns through diplomatic or official channels rather than in public. By now they must be aware that the worst scenario is when criticism is vented through mass media, which seems to trigger a Pavlovian reaction from Duterte: he's certain to throw a fit, not just once but at almost every public engagement.

However, there are ways of telling critics to shove it without jeopardizing long-standing bilateral ties. Duterte's aides can do the nation a favor by advising him about the advantages of circumspection when it

comes to international relations.

He's taking criticism of his policies as a personal affront, but the damage from his rants and actions can adversely affect the nation long after he's out of power.

ECC releases P2.3-M aid for wounded, slain troops in Marawi

MANILA -- The Employees Compensation Commission (ECC) has released more than PHP2 million worth of financial assistance for soldiers and policemen who were either wounded or killed in action during the Marawi siege.

ECC executive director Stella Zipagan-Banawis said Thursday that a total of PHP2.392.479.62 in benefits would be provided to the members of the Armed Forces of the Philippines (AFP) and Philippine National Police (PNP).

"The releases only represent the assistance provided to the uniformed personnel from January to September 2017." the ECC official said in a statement.

She noted that PHP1,752,479.62 was allotted for EC disability benefits, and PHP640,000 for EC death benefits.

The releases were made through the Government Service Insurance System (GSIS).

benefits for members of the AFP and the PNP who were wounded or killed in action in the war in Marawi.

"Similarly, ECC Board Resolution No. 17-96-23 was issued to provide, not only for the speedy facilitation of EC benefits of the members of the AFP and PNP who were wounded or killed in military and police operation, but also for their immediate enrollment under the ECC's Katulong at Gabay ng Manggagawang May Kapansanan (KaGabay Program)." Banawis said.

The program provides special assistance to persons with work-related disabilities (PWRD) in the form of either skills or entrepreneurial training and the provision of rehabilitation services and appliances.

Likewise, it primarily aims to facilitate their reintegration into the mainstream of the society.

Meanwhile, she reported that the Quick Response Program, another program of the ECC, has served 192 uniformed personnel. This is composed of 170 from the AFP, 20 from the PNP, and two from the Bureau of Fire Protection.

"The benefits also form part of the benefits granted to AFP and PNP battle and duty casualties, under the Comprehensive Social Benefits Program." Banawis said.

She added that the ECC continuously assists workers with benefits and services in the event of work-related sickness, injury, or death, and further emphasized the importance of keeping workplaces safe and healthy. (PNA)
