# Entire Caloocar City police force sacked

# Only new chief, deputy retained

Last month at the Police Service anniversary, the Caloocan Police received an award as the Best City Police Station.

Yesterday, the entire city police force was sacked, with only the newly installed chief and his deputy spared, following the killings of teenagers and a break-in and robbery by city policemen.

National Capital Region Police Office (NCRPO) chief Director Oscar Albayalde ordered the relief and retraining of the sacked police personnel.

The order came a day after members of the Caloocan Police Community Precinct 4 raided an elderly woman's home and reportedly stole money and other valuables in an incident captured on closed circuit television camera.

Albayalde said some 1,200 personnel of the Caloocan Police would undergo retraining and reorientation for 45 days before being reassigned to Turn to Page 10

other police units, not necessarily back to Caloocan City.

Only Caloocan City Police chief Senior Supt. Jemar Modequillo and his deputy for administration, Chief Insp. Ilustre Mendoza, were retained.

Modequillo replaced Senior Supt. Chito Bersaluna on Sept. 5, following widespread outrage over the killing of 17-year-old Kian Loyd delos Santos on Aug 16.

Mendoza, on the other hand, had a good track record as police administrator and chief of the investigation unit.

"We will start with the city's police precincts 2 and 7," Albavalde said.

The NCRPO's regional public safety battalion, a combattrained unit, would temporarily replace all personnel in Caloocan's headquarters and seven precincts.

There are about 3,500 policemen in the entire Caloocan Police force. "This (reshuffle) will be done in batches," Albayalde said.

It is the first time an entire city police unit has been relieved of its duties since President Duterte unleashed his bloody crackdown against illegal drugs 15 months ago, a campaign that has killed thousands of Filipinos.

The move comes amid intense scrutiny of police activities in Caloocan City in the wake of the killing of Delos Santos in what police said was an anti-drugs operation.

His lawyers and family said he was murdered in cold blood. The three policemen involved in the killing claimed Delos Santos fired at them and they acted in self-defense.

The Department of Justice has started an investigation based on the murder and torture complaint filed against the Caloocan policemen allegedly linked to the killing of Delos Santos.

The Internal Affairs Service (IAS) of the Philippine National Police (PNP) has set the hearing

on summary dismissal proceedings against the policemen.

Another teenager, Carl Angelo Arnaiz, suffered a similar fate. The 19-year-old was accused of trying to rob a taxi driver and shooting at police who tried to arrest him. The taxi driver said on Sunday that he saw him alive in the custody of the Caloocan police.

#### Cops, robbers

Some 13 policemen, some civilian clothen were seen in security video of a robbery the was uploaded on social med and went viral.

Albayalde ordered the rel of the entire personnel of t Caloocan Police commun precinct 4 after a woman co plained that 13 policemen a two police assets barged ir her house and ransacked belongings last Thursday.

CCTV footage purported showed the policemen robbithe house during an alleg drug raid.

This angered the PNP lea ership, according to Albayala who immediately issued to orders to relieve the Calooc precincts.

"From what we have se this has been done or w continue to be done by othe so it is best to implement the preemptive measure to ave similar incidents," Albayal told reporters.

IAS Inspector General A fegar Triambulo said the were violations committ by the Caloocan policemer including use of a minor catured on the house's surve lance camera stealing wriwatches and a cellphone.

A man with a physical d ability said to be a police; set was also with the grou armed with a firearm and cl in a police vest.

"That is a big violation police operational proc dures;" Triambulo said.

Triambulo said the policemen could also be held fi

ther liable if it is proven they entered the house without a search warrant.

The 13 policemen were identified as Police Officers 1 Ariel Furlo, Marvin Poblete, Sherwin Rivera, Jay Gabatu, Sahabane Sampurna, Rene Llanto, Louie Serrano, Jaypee Talay, Ronelio Julaton, Jay-R Sabangan, Jaime Natividad, Joey Learan and a certain PO1 Miguel.

They were charged with robbery and trespassing, Mod-

equillo said.

Modequillo said they have identified the boy and the police asset who accompanied the police in the raid but withheld their names. He did not say if they would also be charged.

Mendoza said precinct commander Chief Insp. Timothy Aniway would be facing administrative charges for command responsibility over his men. Team leader Senior Insp. Warren Peralta was included in the criminal charges, he said.

#### **Drastic measure**

Albayalde justified the reshuffle of the Caloocan Police.

"The reshuffle is a drastic measure but we have to do this to keep them away from their sphere of influence and prevent them from involvement in criminal activities in the future," Albayalde said.

"It is not farfetched that they would follow the bad example of those involved in the killings and other illegal activities," he added.

Albayalde gave assurance the functions of the Caloocan police would not be affected by the reshuffle.

"The delivery of public service would not be affected due to the reshuffle because the police officers relieved would be replaced by responsible policemen to oversee the peace and order in the city," he said.

However, some Caloocan policemen expressed dismay over Albayalde's order to relieve the entire city police force:

"We are saddened by this development. It's like punishing the whole police force for the wrongs committed by a few scalawags. But we will abide by the wisdom of the NCRPO chief, " one of the policemen said

A police official said the PNP leadership is asking for too much from them.

"If everyone else is relieved that would grossly affect the whole organization because those who will come in don't have any idea how things are done here," he said.

Another police official complained it would be inconvenient for him to travel outside Metro Manila if ever he would be reassigned elsewhere.

Some residents joined militant groups in holding a protest rally in front of the Caloocan Police headquarters.

Another group, holding placards saying "Stop the Killings," also held a rally at the Caloocan police precinct in Tala district.

#### Welcome move

Lawmakers, on the other hand, hailed the reshuffle of the Caloocan Police as a timely move to address concerns of abuses of the police.

Sen. Panfilo Lacson said the spate of killings involving the Caloocan City policemen appear to be due to the "false bayan said Albayalde should perception" of some police officers that they are immune from criminal prosecution.

He said the incident, as well as the killing of Delos Santos and Arnaiz, should prompt President Duterte to temper his language on assuring police officers of being pardoned if they are convicted of doing their jobs.

Lacson said Duterte should rethink the entire anti-illegal drugs strategy of the adminis-

He said the administration must make immediate "major adjustments" without sacrificing the overall objective of stamping out drugs and criminality.

"For one, there might be ingrained in the attitude of police officers the wrong perception

that they are immune from criminal complaints, or a false hope of automatic pardon from their commander-in-chief," Lacson said.

For his part, Caloocan City Rep. Edgar Erice said police abuses would continue to be committed not only in his city but throughout the country as well if President Duterte insists on his bloody anti-drug war.

"Practically, the government has given the police the right to kill, the right to plant evidence, the right to ignore terms of engagement and the rule of law," he said.

Erice said it's now the "rule of the gun" that prevails.

"God bless us all," he added. Magdalo Rep. Gary Alejano said the relief of the entire Caloocan City police force was a "welcome move" on the part of Albayalde.

"It goes to show that our PNP is sensitive enough in addressing the wrongdoings of its members. But such action will have no significant impact without reviewing its rules of engagement and policies in carrying out the war on drugs and without denouncing extrajudicial killings and committing to run after vigilantes who kill without letup," he said.

Rep. Tom Villarin of Akbe commended.

"His superior, (Director) General Roland dela Rosa, should learn a lesson or two from him. Accountability demands action and not melodramatics," he said.

For his part, Ifugao Rep. Teodoro Baguilat Jr. said Albayalde sacked Caloocan policemen a month after awarding them as Metro Manila's "best and finest."

Baguilat described Albayalde's order of relief as "ironic iustice."

On the other hand, Senate President Pro Tempore Ralph Recto said he believes Duterte did not order the killing of minors but it is such an alarming situation that he must quickly put a stop to it.

"It cannot be denied that

there are too many killings including children. I believe the President when he says he has not ordered it. But it is highly possible that there are rogue policemen abusing their authority," Recto said.

Sen. Sherwin Gatchaliar said in the absence of an official report from an investigation, it is very difficult to speculate if there is systematic killing of minors.

He suggested the PNP leadership immediately convene the péace and order council of Caloocan City to get the local government unit and community involved in addressing the issue.

Caloocan Bishop Pablo Virgilio David lauded the order for relief of the Caloocan police force.

"Praise the Lord!" David remarked after learning of the relief order.

David said he is hoping that even if these policemen have been relieved, appropriate criminal charges would still be filed against those responsible for these deaths.

"This is the only way the PNP can protect the integrity of the whole police institution: by disciplining their own ranks and following only just and lawful orders from their superiors," he added...

Albayalde said the relief of the entire Caloocan City police force should serve as a warning to other police stations to "toe the line.

"We would not condone any wrongdoing by our men. We would not hesitate to institute pre-emptive measures like this reshuffle should they continue engaging in killings and other illegal activities, Albayalde said.

Anger and protests have focused on the killing of Delos Santos and Arnaiz, prompting President Duterte, known for his frequent speeches that call for drug dealers to be killed, to order a thorough investigation. into the killings and warned police he would not tolerate abuses. - With Paolo Romero, Jess Diaz, Emmanuel Tupas, Evelyn Macairan, AP, Reuters

### Palace: Congress may restore CHR budget

It's early days yet.

Amid the furor over the P1,000 budget granted by the House of Representatives to the Commission on Human Rights, Malacañang said yesterday the CHR might still get Congress approval for a funding allocation of over P600 million for next year.

"Just to put things in perspective, the reduction is only at the earlier stages of our budget process," Communications Assistant Secretary Kris

Ablan said.

He emphasized that the Office of the President and the Department of Budget and Management have proposed a CHR budget of more than P600

million to Congress.

President Duterte and his allies have been assailing the CHR for criticizing the administration's vicious war on drugs. They insisted the CHR – chaired by Chito Gascon – has not been doing its job, as its investigations don't cover

common crimes or those committed by terror groups.

Under the Constitution, CHR's mandate only covers abuses by state forces

against ordinary citizens.

Ablan also assuaged concerns over CHR's getting only P1,000 budget, saying the House's decision was just "an exercise of the check and balance power" of the

legislative branch.

Explaining the budget process, Ablan said a budget program originates from the House of Representatives and is deliberated at the Senate before a final version is consolidated during a bicameral conference.

"So we still have a long way to go. In fact, since the version of the Senate and the House may not always be the same, there will still be bicameral conference

committee," he said.

"And the reduction of the budget of the CHR to P1,000 – we don't speak for Congress but as a lawyer and a student of public policy – as I mentioned earlier, is an exercise of the legislative branch of its checks and balances," Ablan said.

He also chided the "uninformed," reminding them there are only few times that the legislative can actually check on other branches, specifically the executive – and one such occasion is during inves-

tigations in aid of legislation.

"That's how they can pursue their check and balance power The other is to actually review the budget. The House of Representatives has the power of the purse. It originates from them and the PCOO, actually like any other government agency, has to appear before congressmen," he said.

PCOO stands for Presidential Communications Operations Office, where Ablan

is an assistant secretary.

"And this is the only opportunity for Congress really to hold us accountable, you know they asked us, 'What did you do for the past year? This is what happened'," he said.

"It will still go to the Senate and you've already heard comments from our senators that they will restore the budget of the CHR. It's a totally legislative matter that the Palace will respect. As far as we know, we submitted a budget for CHR," he added.

At the House, Speaker Pantaleon Alvarez said yesterday senators "are dreaming" if they think they can fully restore CHR's budget.

He stressed he is open to giving the agency a funding bigger than the P1,000 "but we will discuss how much we can

give them based on their programs, but they are not doing their job."

#### Restored

As senators have promised, the chamber's sub-committees have restored the budgets of the CHR, the Energy Regulatory Commission (ERC) and the National Commission on Indigenous Peoples (NCIP).

Senate Minority Leader Franklin Drilon had warned that reducing the budgets of the three agencies would be tantamount to abolishing them as they could not func-

tion with only P1,000.

Sen. Panfilo Lacson said he expects the issue to come to a head at the bicameral conference committee deliberations to resolve the disagreeing provisions of the proposed P3.7-trillion national budget for 2018.

He stressed senators are not "imposing on our House counterparts" but would "listen to their arguments for slashing the budgets of the three agencies, with the CHR being the most contentious."

"We expect that our contingent will also be listened to in the most civil and rational manner and act like statesmen in

this regard," Lacson said.

The bicameral conference committee, sometimes dubbed as the "third chamber of Congress," is the body composed of representatives from the Senate and the House formed whenever the two chambers need to reconcile conflicting provisions they have respectively passed.

Senators explained the proposed national budget is approved as a whole or Congress cannot pass it with some provisions left hanging. So if both chambers would not be able to resolve the deadlock before the end of year, the government would be operating on a so-called "reenacted budget."

Sen. Sherwin Gatchalian said both chambers should strive to break the looming impasse "by understanding the rationale" as to why the appropriations were originally proposed for the CHR, ERC and NCIP.

"I'm sure there is light at the end of the tunnel and both Houses will come up with a compromise at the bicam level," Sen.

Sonny Angara said.

Sen. Paolo Benigno Aquino IV, however, said before his colleagues worry about the possible deadlock, those supporting the restoration of the budgets should make sure they would be supported in the Senate plenary.

Aquino apparently suspects that some senators are in favor of the House move allocating P1,000 budgets to the CHR, ERC and NCIP. — With Jess Diaz

### 'Martial law on Sept. 21 a remote possibility'

President Duterte can use the vast powers of his office to quell lawlessness and anarchy in case mass protests on the 45th anniversary of the imposition of martial law by dictator Ferdinand Marcos get out of hand.

martial law, but Defense Secretary Delfin Lorenzana said yesterday that this possibility is "remote."

He said he did not believe protesters have the capability to mount the type of mass actions that would warrant the dec-The powers include the declaration of laration of martial law on Sept. 21.

Instead, Duterte might declare a holiday in government offices and schools in case mass protests become too disruptive, Lorenzana said.

Duterte had earlier said he might declare martial law to quell lawlessness in

case anarchy reigns during the martial law anniversary

Duterte said that he saw no problem if the people wanted to express grievances against his administration, or even resort to burning his effigy, as long as the protests remain peaceful.

Presidential spokesman Ernesto Abella clarified that Lorenzana did not say that Duterte would be expanding martial law to Metro Manila.

"It is clear from the press briefing that as per Defense Secretary Lorenzana, PRRD (Duterte) would declare martial law if and when protest action leads to anarchy and disrupts the civilian government," Abella said in a statement.

Lorenzana said the commander-in-chief can call out the Armed Forces to ensure peace and order in the metropolis.

The normal thing that we can do under an emergency is we can put up checkpoints, we can establish curfews. Just like martial law. Martial law is more severe, but almost the same," he said...

"We can... arrest people and hold them for 36 hours. Yun kasing martial law, 72 hours eh. So 36 hours. And then we have to let them go if we cannot find any culpable violation of law and we cannot charge them with any cases, we can let them go," Lorenzana said.

Left-leaning organizations plan to stage massive protest rallies against the administration on Sept. 21, which marks Marcos' declaration of martial law in 1972.

Duterte had warned protesters not to resort to violence, such as burning of property, during their planned protests.

"The President said, 'if the Left will try to have a massive protest, they will start burning (things) on the streets, they will disrupt the country, then I might'," said Lorenzana, quoting Duterte's statement last weekend in Cagayan de Oro.

"In our view, in my estimate, that is very remote to happen right now," said the defense chief, who is the implementer of martial law in-Mindanao.

He added that Duterte "is very concerned" that the massive protests "might get out of hand."

# MARTIAL LAW: AN OPTION BUT PROSPECT IS 'REMOTE

President Duterte said protest rallies planned for the 45th anniversary of the declaration of martial law by the late dictator. Ferdinand Marcos next week would not be disturbed by government forces but warned organizers he would send soldiers and police to quell any violence.

Defense Secretary Delfin Lorenzana told reporters in Malacañang that the President had considered the possibility of placing the entire country under martial law over fears that the protests might get out of control, but the prospect of such a declaration was "very remore."

National Security Adviser Hermogenes Esperon Ir. said martial law was "always an option" for the President and Mr. Duterte would "take the initiative to address" any violence.

#### 'Do not destroy, burn'

In an interview late on Thursday on state-run television PTV 4. Mr. Duterte did not say whether he would take extreme measures such as expanding the coverage of martial law that had been imposed in Mindanao if the Sept. 2: rally

furned violent.

Addressing organizers of next Thursday's rally, the President said in the TV interview: "This is the only thing I ask of you: Do not destroy, vandalize, burn things down."

"Do not make the mistake of destroying things because if you do that, the next thing you would face would be the military and the police." he said.

But he added in jest that protesters "can set fire to my effigy."

He also warned protesters not to allow members of the "red army"—the New People's Army—to join their ranks.


#### Sept. 21 rally

The Movement Against Tyranny is planning a big rally at Rizal Park on Thursday with the theme: "Stop the killings! Never again to tyranny and dictatorship!"

Organizers said they would protest the President's war on drugs and Mr. Duterte's alleged strongman tendencies. Thousands have died in police antidrug operations and attacks by unknown assailants.

The rally is being organized by a coalition that includes leftwing groups and opposition personalities, many of whom had fought the Marcos dictatorship.

# Duterte may declare martial law

Defense chief:
President expresses
concern massive
protests next week
may turn violent

resident Duterte may declare nationwide martial law if threatened massive protests by communists and other leftists against his rule turn violent or disrupt the country, his defense chief said Friday.

"He said, if the Left will try to have a massive protest, start fires on the streets, they will disrupt the country, then I might (declare martial law)," Defense Secretary Delfin Lorenzana told reporters, recounting a conversation with Duterte this week.

Lorenzana emphasized he thought the chances of Duterte declaring martial law were remote because he doubted the scheduled protests on September 21, the 45-year anniversary of the imposition of martial law by former President Ferdinand Marcos, would be as big as the organizers said theywere

planning.

"But the President is indeed very concerned because it might get out of hand. So he said I might declare martial law."

Lorenzana said Duterte is keen on declaring a holiday when massive protests are held by various leftist groups but did not specify the date.

"During my interaction with him early this week, sinabi niya na pagka magkaroon ng massive rallies sa Metro Manila and it might inconvenience the public, para hindi ma-inconvenience, sinabi niya, 'di ko na lang sila papasukin (he said that in order to not inconvenience the people in case of massive rallies in Metro Manila, he will just suspend classes and government work)," Lorenzana said.

"[He] will declare na wala nang papasok sa mga opisina (that there will be no government offices that day) so they will have a free hand kung anong gagawin nila sa mga demonstration nila (on what they want to do during their demonstration). That's what he said," he added.

"Hindi naman niya sinabi kung anong araw (He did not specify the date) but since the left is threatening to have this massive demonstration on the 21st, siguro (maybe) it will be on the 21st. Pakikiramdaman naman daw niya (But he will wait and see)," he continued.

Malacañang is also yet to confirm if Duterte will declare a holiday on the 21st or if the President is referring to the said date during his earlier speeches.

But in an interview over state-run PTV-4 Thursday night, Duterte said that he is "ordering a holiday" at this early

"Huwag kayong magkamali na magsira diyan, sira dito (Do not commit the mistake of destroying properties there) because if you do it, the next thing, ang kaharap ninyo (you would see) would be the military and the police," he added.

#### 'Movement Against Tyranny'

A coalition of groups naming themselves the "Movement Against Tyranny" had announced it was planning protests on September 21.

It said the protests, to be held at the Rizal Park in Manila, would voice opposition against Duterte's war on drugs that has claimed thousands of lives, as well as the president's attacks on democratic institutions.

The coalition also voiced outrage at Duterte's public support for Marcos, who was overthrown in the "People Power" revolution in 1986 and died in US exile three years later.

The announcement for the protest said its theme was: "Stop the Killings! Never Again to Tyranny and Dictatorship!"

Duterte won last year's presidential elections on a brutal law-and-order platform in which he promised an unprecedented campaign to eradicate illegal drugs in society by killing up to 100,000 traffickers and addicts.

Police have reported killing more than 3.800 people in anti-drug operations since he took office 15 months ago, while thousands of others have been murdered in unexplained circumstances.

Duterte has repeatedly threatened to impose martial law across the country, but neither he nor his aides have previously given a specific timeframe or event that would trigger it.

He imposed martial law across the southern third of the Philippines in May after Islamic State group supporters occupied a major Islamic city there, leading to a conflict that has claimed more than 800 lives.

### Defense chief: Nationwide martial law 'very remote'

DEFENSE Secretary Delfin Lorenzana on Friday played down President Rodrigo Duterte's threats of declaring martial law nationwide, saying this was a "very remote" possibility, given the

weakened state of militant groups.

## Gov't takes new tack in Marawi, urges Maute terrorists to surrender

MARAWI CITY—Surrendering gunmen will not be shot but will be treated humanely if they free their hostages.

The military on Friday made this guarantee as it intensified its campaign to convince the remaining members of the Islamic State-inspired Maute fighters and their allies to surrender.

"They have to free their hostages If they will surrender, we will not shoot them. That's our arrangement," Col. Romeo Brawner, Joint Task Force Marawi deputy commander, told the Inquirer.

Between 40 and 70 gunmen remain in a section of Marawi, trying to fight off advancing troops whose campaign to retake this capital city of Lanao del Sur is approaching its fourth month, according to government reports.

Brawner said the military had turned to text messaging, public address system and social media to reach out to the gunmen and convince them to lay down their weapons and free their hostages.

He said gunmen who wanted to surrender could call the hotline number being circulated in the city or send text messages.

A few weeks back, Omar Maute, one of the top terrorist leaders here, reportedly asked the military to provide him and his allies free passes in exchange for the freedom of the hostages, including Catholic priest Fr. Teresito Suganob.

Defense Secretary Delfin Lorenzana earlier said the offer, relayed by former Marawi mayor Omar Solitario, was the sec-

ond from the Maute group.

But President Duterte flatly rejected the proposal during his visit to Cagayan de Oro City on Sept. 10.

"No way. No way," the President said, adding that the only way Maute gunmen could get out of the conflict zone alive was to surrender.

"This has to end. This cannot go on. If they surrender, we will ... give them due process; provide them with a lawyer," he said.

"There will be no oppression or harassment or anything. No violence will be inflicted upon them if they surrender. That I could guarantee you," Mr. Duterte added.

Brawner reiterated the President's position but said the air strikes and ground assaults on the remaining gunmen would be without letup.

"We are very careful not to

hit any of the civilian hostages,' he said.

Brawner said 148 soldiers and policemen, some 660 militants and 45 civilians had died in the fighting that started or May 23, when Maute and Abu Sayyaf gunmen and their allies took over sections of Marawi.

He said government forces had pushed Maute fighters ou of many areas inside the mair battle zone in the city, with the fighting now closer to Lake Lanao.

Brig. Gen. Rolando Bautista commander of the Joint Tasl Force Marawi, said the militar was making its "final push" to completely retake the city.

"We have reduced their maneuver space. This is our finational push. We have to concentrate whatever personnel, whateve capability we have here, Bautista said. INQ

# Troops advance into ISISheld areas in Marawi City

fighting local Islamic State (IS) militants in war-ravaged Marawi City continue to advance to the main battle area and troops go on house-to-house searches scouring for booby traps and improvised explosives that have already killed scores of soldiers.

Security officials said militants have planted explosives in houses and buildings and structures they occupied making it extremely difficult for troops to accomplish their mission – to kill the enemy, rescue civilian hostages and liberate Marawi, the capital of Lanao del Sur.

Troops have occupied dozens of buildings and mosques previously

under the control of IS fighters who dug up tunnels and rat holes that served as their escape routes and protection from military air strikes.

The military claimed it has killed at least 650 bandits since May, but it did not give evidence to back up its claims, except the figures were all based on raw intelligence reports and unnamed

civilians and other sources. But the fighting had so far killed over a hundred soldiers and left more than or nearly 2,000 troops wounded.

President Rodrigo Duterte has been frequently visiting troops on the front line and inspected mosques damaged or destroyed by the fighting, pinned medals to wounded soldiers and visited the funeral of fallen soldiers.

Australia, worried over the fighting in Marawi, has pledged to send soldiers to help train local forces battling militants and this is on top of spy planes it deployed in the troubled region. Japan also sent food aid to war refugees.

The United States also deployed the Gray Eagle Unmanned Aircraft Systems (UAS) to Mindanao for additional surveillance in support of the Armed Forces of the Philippines (AFP) counter terrorism efforts. Compared to current surveillance platforms used in the region, the Gray Eagle has a longer flight duration which allows it to cover a larger area of reconnaissance and surveillance.

Over the past three years, the US has provided the Philippines with assistance valued at over P15-billion, to establish better command, control, communications, computers, intelligence, surveillance, and reconnaissance capabilities for the AFP. Recent deliveries include a Raven tactical UAS and two Cessna-208B surveillance aircraft as well as various munitions and weapons to support urgent defense and counter-terrorism needs.

# Aussies lead Marawi donors

OREIGN donations for the rehabilitation and repair of the besieged city of Marawi continue to outpour with Australia as the biggest source of foreign aid, Defense Secretary Delfin Lorenzana said Friday.

In a Palace news briefing, Lorenzana said more than P2.1 billion had been pledged by foreign governments for the wartorn city, while more than P50 billion would be needed for the city's complete rehabilitation.

In a related development, the governments of the Philippines and the United States will embark on a bilateral, interagency counterterrorism drill, Tempest-Wind, in mid-September intended to test and improve the ability of both nations to rapidly plan, coordinate, and conduct counterterrorism operations.

The whole-of-government drill will be augmented by additional military assessments, national level engagement, and subject matter expert exchanges, Philippine official sources said.

These events will take place in the Philippines and Hawaii and are designed to create a realistic environment to exercise counterterrorism strategy, including senior decision-making and tactical responses, while deepening the bilateral partnership.

In addition to important information exchanges, Tempest Wind is recognized as a way to test force readiness and exercise interoperability.

These assessments will help to focus future bilateral training efforts to enhance the crisis response capabilities of both nations, the sources said.

The Mutual Defense Board and Security Engagement Board approved Tempest Wind in November 2016, highlighting the enduring commitment of both countries to the US-Philippine alliance

The United States is a proud ally of the Philippines and will continue to provide support and assistance to Philippine, counterterrorism efforts and work jointly to address shared threats to the peace and security of both countries, the sources said.

Australia is already contributing two Orion spy planes for intelligence gathering.

In his recent visit to the country, Australian Defense Minister Marise Payne committed to sending small contingents of Australian soldiers to train Philippine troops.

Data from the Foreign Affairs Department stressed that education, health and peacebuilding programs in Mindanao accounted for more than a third of Australian aid to the Philippines.

Coming next is the United States, which also announced a P730-million humanitarian assistance.

Washington, which is also helping troops in form of "technical assistance," had earlier donated 1,040 rocket motors and 992 rockets to the Philippine Air Force, while 1,000 grenade launchers and 250 rocket-propelled grenade launchers were given to the Philippine Army.

The country's closest neighbors in the region, Japan and Thailand, have both donated P100 million.

The President's new found friend, China comes off at fifth with P85 million in assistance, which consists of P70 million for wounded soldiers and P15 million for the rehabilitation.

Lorenzana, however, did not include in the list China's donation of P370 million worth of rifles and ammunition—although intended for use in Marawi, all the firearms were given to the Philippine National Police instead.

"It was the decision of the President because he knows the police lack long firearms. And another thing is, we have sufficient firearms in the Armed

Forces," said Lorenzana.

Some of the Chinese-made rifles may have been used in Marawi by "two companies or a battalion" of the police's Special Action Force deployed to the besieged city, he added.

The 28-member European Union, meanwhile, has pledged P49 million for Marawi efforts, Lorenzana added.

With the depleted funds of the military because of the Marawi crisis, Lorenzana said they had already requested a supplemental budget of P2.5 billion before the Budget Department

Congress also has pledged to allocate additional funds if needed, Lorenzana added

On the 116th day of the ongoing rebellion in Marawi City, Lorenzana expressed confidence the war was nearing its end, with only less than two barangays left with Maute terrorists still there.

He said the military had not set a deadline but assured that government troops were "doing their best." With Sara Susanne Fabunan and Rio Araja

Lorenzana said when he was still in the military, erring soldiers who sold firearms to enemies were subjected to court martial proceedings. "We have identified them and we punished them. We punished those, we discharged them, we court-

martialed them," he said.

He said the same penalty applies for soldiers who could not adequately explain the loss of their firearms.

A military official earlier revealed that many of the firearms recovered from the areas occupied by Maute group were government-issued weapons. Capt. Jo-ann Petinglay, spokesman of the Task Force Marawi, reportedly said somebody from the government must have sold the weapons to the enemies.

As of September 14, the government has recovered 692 firearms from the terror groups in Marawi City

Lorenzana agreed that the Maute rebels could have obtained government weapons through acquisition, theft, and even smuggling.

"(There are) many ways that the Mautes acquired these firearms from the government," he said.

"They procure from unscrupu-

Lorenzana said the Maute rebels have also stolen government firearms and even combat during their clashes with soldiers.

"And also, they have been smuggling in from the outside through the southern backdoor, 'yung mga galing diyan sa labas na firearms supported by the foreign terrorist groups," he said.

He said during the Marcos regime, the government also provided many weapons to some groups to help in its security operations.

# ip50 Bnotenough for Marawi rehab

#### By CHRISTINA MENDEZ

More than P50 billion is needed to rehabilitate Marawi, Defense Secretary and Task Force Bangon Marawi chairman Delfin Lorenzana said yesterday.

Citing his visit to the city with President Duterte last week, Lorenzana said his initial estimate of P50 billion to cover the repair and construction of government and private infrastructure would not suffice.

"I think P50 billion is not enough. Talagang grabe 'yung destruction. When the fighting

stops...I will bring you there. You will see how damaged the area is," he told a press briefing at Malacañang.

Lorenzana said foreign governments have so far pledged around P2 billion. He said Australia pledged P1 billion; China, P85 million; the European Union, P49 million; Japan and Thailand, P100 million of water supply in the transi-

each and the United States, P730 million.

As of Sept. 12, Lorenzana said the defense department also received P13.3 million for soldiers wounded in action. He said P992,840 of the amount was donated to internally displaced persons.

Lorenzana said construction of transitory shelters for evacuees has started.

"The subcommittee on housing convened last Sept. 13 to discuss the provision

tional shelter sites," he said.

#### Supplemental budget

Lorenzana said the defense department requested a supplemental budget of P1.9 billion to replenish the supplies, including ammunition, of soldiers in Marawi.

He said post-conflict assessment groups are inspecting the cleared areas to determine the budget needed for rehabilita-

The Department of Public

Works and Highways and Army engineers are also helping in the planning for Marawi's roadmap for rehabilitation.

#### Ratholes

Meanwhile, the military adjusted its strategy to flush out remaining Maute militants holed out in Marawi.

Col. Romeo Brawner, Joint Task Force Marawi deputy commander, said the discovery of running trenches and ratholes, which connect to several structures including

mosques, changed the tempo of their operations in defeating the terrorists...

Brawner said air strikes would remain their primary option.

The fighting in Marawi, which entered its 116th day yesterday, has left 671 militants dead. The military also recovered 672 firearms from the terrorists.

At least 149 soldiers have been killed and 1,530 others wounded in the encounters.

# P50B NOT ENOUGH FOR MARAWI REHAB, SAYS LORENZANA

A war chest of P50 billion may not be enough to rehabilitate Marawi City given the extensive damage it has suffered from the battle between government forces and Islamic State-inspired extremists, Defense Secretary Delfin Lorenzana said yesterday.

Lorenzana said the amount was his initial estimate when asked during a recent Senate hearing how much would be needed for Marawi's reconstruction.

"But when we went there last week with the President ... I think P50 billion is not enough.

The destruction is really massive," Lorenzana said in a press briefing in Malacañang.

A postconflict assessment group that includes members of the Philippine Army and the Department of Public Works and Highways has begun inspecting the cleared areas of the city to check on the conditions there, he said.

#### P20 billion

President Duterte earlier pledged P20 billion for the Marawi rehabilitation efforts, promising to restore the city to its former glory.

Lorenzana said the government would use the funds donated by other countries for Marawi's reconstruction, except those from China, which specified that its grant would go to the wounded soldiers.

Australia has pledged P1 billion, while the United States said it would give P730 million. Japan and Thailand have pledged P100 million each. The European Union has also pledged P49 million.

Of China's P85-million donation, P70 million would be for the wounded soldiers, and P15 million for their rehabilitation.

Meanwhile, Lorenzana also said the Department of National Defense would be seeking an additional budget of P2.5 billion this year to replenish funds depleted by its operations in Marawi.

Most of the funds had been used for ammunition, fuel, medicines and incidental expenses, such as evacuation. The request for more funds was already forwarded to the Department of Budget and Management, he said.

Congress had also promised to pass a supplemental budget, he said.

Lorenzana said the conflict in Marawi was winding down based on the assessment of ground commanders. The fighting has displaced about 200,000 residents and destroyed roads, homes and other buildings. INQ

# Military to build permanent structures at PH Rise in 2 yrs

THE Navy will build permanent structures in Benham Rise in the next two years to establish its naval presence in the northeastern underwater territory also called the Philippine Rise, Defense Secretary Delfin Lorenzana said on Friday.

Three months ago, divers from the Philippine Navy planted the country's flag in the underwater plateau seven meters below the water surface, off the coasts that stretch from Cagayan to Bicol. The area was declared by the United Nations in 2012 as part of the Philippine continental shelf.

"My estimate is that...if we have the fund and we get the correct technology, maybe in two years' time we'll be able to start [building] permanent structures. We want to have a platform where helicopters could land and we want a place for our ships to go near there and dock, on top of deploying marine biologists and other scientists," Lorenzana told reporters in a news conference at the presidential palace.

Lorenzana, however, clarified that the establishment of a naval presence in nearby areas will take precedence over the permanent structures that have yet to be allocated any funds.

"Our plan [for] now is to establish a naval presence in Casiguran, considering that there is an airport there that is seldom used. The other one is in Polilio, which has been used by the Americans as an airstrip during World War 2. There's another one at the tip of Cagayan. So, we'll have three jump off points for our patrols," Lorenzana told reporters.

The defense chief stressed that the imperative for the Philippine military is to protect Benham Rise around its whole stretch of 13 million hectares, as huge as Luzon, and is home to the blue fin tuna, the most expensive tuna in the world.

"Fishermen from other countries have been poaching there for a long time....from Taiwan, South Korea, China. Even Japan comes to Benham Rise. And we would like to protect what belongs to us. That's our plan," Lorenzana said.

"We have to protect our resources," Lorenzana added.

The Benham Rise was designated as a "protected food supply exclusive zone" by the Philippine government in May 2017. The government banned mining and oil exploration in the plateau as a protected area. In the same month, President Rodrigo Duterte signed Executive Order No. 25 renaming the region to Philippine Rise.

# Palace hits spin on Lorenzana quip

The Palace again lambasted the foreign and so-called yellow media for spinning stories to reflect views against President Duterte in a report that quickly spread among international wire services about what was claimed as a plan to impose martial law as a result of left-wing protests.

Philippine Daily Inquirer (PDI) which was the subject of the statement of Presidential spokesman Ernesto Abella quickly revised the story it posted, changing its head to "Lorenzana on nationwide declaration of martial law: Remote possibility."

The story came with an editor's note: "We are reposting this story to clarify and update the story by AFP (Agence France Presse) we published earlier."

It was accompanied with a video of the Lorenzana media briefing.

Abella said the earlier misleading header on "martial law" by AFP, "which was irresponsibly repeated by the Philippine Daily Inquirer was a tacky trick to attract readers' attention."

"It is clear from the press briefing that as per Department of National. Defense (DND) Secretary Delfin Lorenzana, PRRD (President Rodrigo Roa Duterte) would declare martial law if and when

protest actions led to anarchy and disrupt the civilian government," he added.

The AFP story was titled "Duterte may declare martial law: defense chief."

It claimed that Mr. Duterte may declare nationwide martial law if threatened protests by communists and other leftists against his rule turn violent or disrupt the country, quoting Lorenzana.

Lorenzana during the briefing, however, emphasized it was very unlikely martial law would be declared, but said the president was worried about threatened "massive" protests by the left

"He said, if the left will try to have a massive protest, start fires on the streets, they will disrupt the country, then I might (declare martial law)," Lorenzana told reporters, recounting a conversation with Duterte this

"In my opinion, in my estimate the possibility of this happening is very remote. But the president is indeed very concerned because it might get out of hand. So he said: I might declare martial law."

AFP then inserted a view that "the comments fueled concerns by critics that Duterte is dragging the Philippines back into authoritarian rule while waging a deadly war on drugs, three decades after a famous 'People Power' revolution overthrew dictator Ferdinand Marcos."

\*\*C A coalition of groups naming themselves the "Movement Against Tyranny" had announced it is planning protests on September 21, the 45-year anniversary of Marcos imposing his military rule.

It said the protests, to be held at a park in the capital of Manila, would voice opposition against Outerte's war on drugs that has claimed thousands of lives, as well as the president's attacks on democratic institutions.

The coalition also voiced outrage at Duterte's public support for Marcos, who died in US exile in 1989.

The announcement for the protest said its theme was: "Stop the Killings! Never Again to Tyranny and Dictatorship!"

The Movement Against Tyranny includes communists, leftist activists, Catholic bishops and rights groups.

Lorenzana said Duterte told him a public holiday may need to be declared to ensure the public was not caught up in potential trouble arising from protests from the left.

He said Duterte did not specify which day the holiday would have to be declared, but then referenced next Thursday's protest.

"Since the left is threatening to have this massive demonstration on the 21st," he said.

It was unclear how big next week's rally would be.

Lorenzana added the military and local governments nationwide have not monitored any planned massive protests by antigovernment groups. "We do not have those indications in our reports," Lorenzana said.

Mr Duterte declared martial law in Mindanao last May in the aftermath of a siege on Marawi City from Islamic State (IS) allies.

A final military assault, backed by airstrikes, was underway to eliminate the remaining few dozen gunmen still fighting from houses and small buildings near Lake Lanao, according to the military.

Rody's high popularity

Despite vocal opposition from critics, Duterte remains an extremely popular leader, polis show.

Previous protests against his drug war have rarely gathered more than a few hundred people.

Duterte won last year's presidential elections on a law-and-order platform.

Police have reported killing more than 3.800 people in anti-drug operations since he took office 15 months ago, while thousands of others have been murdered in unexplained circumstances.

Many Filipinos back the drug war, seeing it as a quick solution to widespread crime, according to a series of polls over the past year.

Duterte has repeatedly said he would to impose martial law across the country, but neither he nor his aides have given a specific timeframe and event that would trigger it.

He imposed martial law across the southern third of the Philippines in May after Islamic State group (IS) supporters occupied a major Muslim city there, leading to a conflict that has claimed more than 800 lives.

Duterte said in May that he may expand military rule across the entire country if he believed IS had taken a foothold outside of the southern region of Mindanao.

It was one of many comments since becoming president in which Duterte had warned that martial law may be necessary to solve many of the nation's problems, including his drug war.

"If I declare martial law, I will finish all the problems, not just drugs," Duterte said in March.

#### Esperon confirms Rody statement

Should armed elements cause chaos during the anniversary of the imposition of martial rule on September 21, the implementation of Martial Law is "within range of probable actions", said National Security Adviser and Director General Hermogenes Esperon.

The official said during a meeting, Mr. Duterte, who reacted in a "level-headed" manner, asked him of possible actions he would take should protests on September

21 escalate.

"Such talks needed study. So he asked if the situation becomes criticial and the streets become chaotic, what should you do? So it is in the range of probable actions or response, isn't it?" he told reporters at the sidelines of the National Security Council (NSC) and National Intelligence Coordinating Agency (NICA) budget deliberation.

"It's not as if you make an action, or think of possible solutions if the problem is already there."

Asked who he was pertaining to, Esperon said "whoever".

"If that's the political opposition, whether it be the left or the terrorists, we will assess all threats and come up with courses of action that we may adapt in case those things arise," he said.

Esperon for his part corrected reports that the president is ready to declare a nationwide Martial Law-if-massive protests lead to public disturbances, stressing such proclamation still entails conditions.

"If the situation turns untenable and there is anarchy, what can you do? You could at least declare state of lawlessnes or lawless violence," he said.

But on one hand, he admitted that Martial Law declaration is "always an option".

He, however, clarified that Mr. Duterte has not made verbal such a possibility. "He earlier said demonstrators can hold rallies but don't take the law into your own hands." Esperon added.

Esperon said there's an intelligence report from their ranks confirming such threats.

Meanwhile, he refused to identify which groups the possibility of unrest may come, or which political factions they belong to.

"Let's not impute politics here. I mean, who are the armed grous? NPA (New People's Army), or the terrorists like IS (Islamic State) so we are looking into all of these things," he said.

From his end, the official reiterated that from good to werst case scenarios, they are ready for anything.

#### Marawi crisis nears end

Lorenzana added the ongoing rebellion in Marawi City is nearing its end, with only less than two barangays left with the presence of Maute terrorists.

"This is just one and a half barangay-wide. The area is just one and a half barangays. That's why I've been told by our ground commanders that it's nearly over," Lorenzana said during the Mindanao Hour press briefing in Malacañan.

He said the military has not set a deadline but assured that government troops are "doing their best."

"So a lttle more patience. Anyway, our troops are doing their best," he said.

The Cabinet official also announced that transitional shelter areas are already being built, noting that flooring for the transitional shelters have started last September 8.

He added that Task Force Bangon Marawi Subcommittee on Housing met on September 13 to discuss the provision of water supply in the transitional shelter site in Marawi City.

Lorenzana said Filinvest, that has expressed its willingness to assist the Task Force in the provision of water supply, will meet with Local Water Utilities Administration (LWUA) to work on a plan to provide the service.

He added the Office of Civil Defense's Quick Response Fund may be utilized to support such projects, such as water system, to address the immediate needs of internally displaced persons in Marawi.

In terms of psychological interventions, Lorenzana said the Task Force Bangon Marawi, in partnership with Mindanao State University, Marawi Sultanate League, and the Philippine Army has conducted a moral recovery and psychological program on September 13 in Iligan City.

Meanwhile, the Defense Chief said more than P50 billion would be needed for the rehabilitation of the war-torn Islamic City.

He said foreign assistance continues to pour in, including P1 billion from Australia; P730 million from United States: P100 million from Japan; P100 million from Thailand; P35 million from China, wherein P70 million will be allocated for the wounded while the remaining P15 million will be for rehabilitation; and P49 million from European Union.

Yesterday, Sen. Loren Legarda, chairman of the Senate Committee on Finance also approved the proposed 2018 budget of National Security Council (NSC) amounting to P186.3 million and National Intelligence Coordinating Agency's (NICA) proposed budget of P788.4 million.

Of NSC's 2018 budget, P79.9 million will be allocated for personnel services (PS), P70.7 million for maintenance and other operating expenses (MOOE) and P35.6 million for capital outlay (CO).

Most of its MOOE are focused on West Philippine Sea, the implementation of National Security Policy 2017-2022, and enhancement of the National Security Information System.

Meanwhile, NICA, the lead intelligence collector of the national government, 2018 budget breaks to P573.9 million for PS, P31.5 million for CO and P182.9 million for MOOE.

# Joma tags P1k outlay as 'killing budget'

COMMUNIST Party of the Philippines founder Jose Maria Sison denounced President Rodrigo Duterte Friday as the "worst kind of president" after authorizing a budget of only PL000 for the Commission on Human Pights and billions of pesos for lay enforcement.

"I think I have a lot of conteisms to make of previous presidents, but this is the worst kind of president.—Sison—said in an ANC television interview.

"I would say that Duterte is very well on the way to proclaiming a fascist dictacitation rick preparing for martial law and to impose a fascist dictaiorship in the Philippines." he added.

Sison siammed Congress' move to allocate only P1,000 to the CHR, which supports his statement that Duterie is heading towards dicatorship. Next page

"The way the budget is made, it's a killing budget, a budget for killing people, and a budget for expressing contempt for human rights."

"Reducing budget of the CHR to just Pl.000 and then giving tokhang' this scheme of mass murder, P900 million plus other funds of the Armed Forces of the Philippines and a huge intelligence fund of Duterte—this is a budget for fascist dictatorship and for killing more people." he said.

He added that Duterte is preparing for massacres in the Philippines.

"We are looking forward to despotic regime of widespread death and destruction. That is already well demonstrated in the destruction of Marawi, he added.

The Palace on Friday said that they are still hopeful that the P3.35-trillion budget submitted before Congress would be approved in whole, after the House of Representatives slashed the budget of at least three agencies to P1.000.

Communications Assistant Secretary Michael Kristian Ablan said the decision of the House to give the CHR only PL000 was simply part of the checks and balances in government.

"That's now... our checks and balances works under the Constitution. Until that is changed, we have to respect it," he added.

On Tuesday, 119 lawmakers voted to slash the 2018 budget of the CHR to only P1,000, while only 32 voted against the proposal.

Senators said they are hopeful they can find a middle ground to resolve their conflict with the House over the CHR budget.

Senator Panfilo Lacson, vice chairman of the Senate finance committee, has vowed to call for the restoration of the CHR budget, but said the Senate is not imposing its will on the House.

"Hopefully we can find some middle ground to resolve the disagreeing provisions of the 2018 budget bill," he said.

He added that the senators would listen to the House members' arguments during the bicameral conference committee meetings.

Senate Minority Leader Franklin Drilon said the Senate will stand firm on its decision to restore the CHR budget.

"Yes. Majority of the senators will stand by Senate's decision to maintain the CHR budget." said Drilon, who warned that a deadlock would result in a reenacted budget.

Senator Risa Hontiveres, meanwhile, Jammed the Du-

terre administration for cutting the CHR budget down to PL000. while allocating PL35 billion for the Presidential Communication Operations Office.

"There's money for fake news but not for human rights." Hontiveros said. "It seems that this government is willing to use taxpayer's money to reward lies and incompetence rather than allow a constitutionally-created body to fulfill its mandate to protect the human rights of Filipinos."

The PCOO, and the Philippine News Agency under its management, have made several embarrassing mistakes and factual ertors in the last-few months.

In May of this year, the PNA ran a story saying that 95 countries were convinced that there were no extrajudicial killings if the country. The claim was immediately contradicted by the United Nations Periodic Review.

In the same month, a photo depicting Vietnamese soldier was used to show Philippine soldiers fighting in Marawi. It wa later revealed that the same photo was sourced from Wikimedi commons.

Last August, the government's news agency posted a article calling the historic rulin won by the Philippines again: China an "ill-founded award."

# PH to build permanent structures on Benham Rise

The permanent structures that the Philippines wants to put up on Benham Rise to assert its ownership over the area may rise in two years, according to Defense Secretary Delfin Lorenzana.

Lorenzana said plans were being drawn up to put up a platform on Benham Rise, which has since been renamed the Philippine Rise, which could be used as a landing pad or a place for marine biologists who want to study the area. No funds have been allocated for this yet.

The Philippine flag has already been planted in the area, an undersea landmass in the Pacific Ocean potentially rich in mineral and natural gas deposits.

"By my estimate, if we have the funds and we get the correct technology, maybe in two years' time [we can put up

the structure]. In two years' time, we'll be able to start and maybe another one year to establish it there," Lorenzana told a press briefing in Malacañang.

He said the plan was to put up the structure on the shallowest part of Benham Rise.

But the harsh weather conditions in the area as well as the waves that could rise as high as 10 meters make this difficult.

"Anyway, we will ask the

experts on these kinds of things to advise us," he said.

In the meantime that there is no permanent structure there, he said the Philippines would establish its naval presence in nearby areas, such as Casiguran, Polilio Island and Cagayan.

"So we'll have three jumpoff points for our patrols in Benham Rise," he said.

The goal, he said, is to "protect what belongs to us." INQ

### Militant group says 4 slain NPAs were civilians, belies clash

SAN NICOLAS, Pangasinan

A militant group condemned
yesterday the killing of four civilians earlier reported by the Pangasinan Police Provincial Office
(PPO) as casualties of an encounter between its combatants
and New People's Army (NPA)
rebels in Barangay Malico, this
town last August 25.

Eco Dangla, spokesman of Bagong Alyansang Makabayan (BAYAN)-Pangasinan, referred to the incident as a "massacre" and not an encounter, and identified the fatalities as alleged "treasure hunters" and "senior citizens," not NPA guerrillas.

"Treasure hunters and senior citizens were the victims of PNP's (Philippine National Police's) Fascist Counterinsurgency Offensive in San Nicolas," Dangla said of the incident that happened in the same area where a policeman was killed in an earlier NPA offensive on July 28.

He said the PPO had allegedly made up the story of an encounter and that the bodies of the supposed slain NPA rebels Marcelo Perico, alias "Mar," 46, of Cauayan City, Isabela; Ar-

thuro Galvez, past 60 years old, of Ilagan, Isabelal; and Crisologo Alambra, alias "Celso," 60, of Lupao, Nueva Ecija, bore signs of torture.

BAYAN-Pangasinan said its fact-finding mission discovered that Perico and Galvez were treasure hunters and that Alambra was their cook and not rebels as claimed by the Pangasinan PPO and its Provincial Public Safety Company (PPSC)

It also alleged that Thelma Albano, 67, Galvez's common-law-wife, was killed but her death was only confirmed on September 3, because her body which was discovered on August 30 also in this town was declared by the PNP pathologist as that of a teenage girl.

For its part, the Pangasinan PPO maintained there was an encounter that happened last August 25 that resulted in the deaths of Perico, Galvez, and Alambra.

Chief Inspector Norman Florentino, PPO spokesman, said that the PPSC's operation was legal and that any group disputing the report should bring its complaint before the proper forum, not social media or the press.

### Comelec: Gun ban starts Sept. 23

Starting Sept. 23, the carrying of firearms and other deadly weapons is prohibited nationwide, unless the barangay and Sangguniang Kabataan (SK) elections are postponed.

In a resolution, the Commission on Elections (Comelec) ordered the ban in line with the village and youth polls on Oct. 23.

"No person shall bear, carry or transport firearms or deadly weapons outside his residence or place of business and in all public places, including any building, street, park and in private vehicles or public conveyances, even if he is licensed or authorized to possess or carry the same, unless authorized by the Commission," the resolution read.

Having bodyguards or availing oneself of the services of security personnel is also prohibited unless authorized by the commission, Comelec said.

"Whether or not such security personnel or bodyguards are regular members or officers of the Philippine National Police (PNP), Armed Forces of the Philippines (AFP), other law enforcement agency of the government or from a private security service provider is prohibited," the poll body

Also considered prohibited are the transport and delivery of firearms, ammunition and explosives, including their parts or components.

Comelec spokesman James Jimenez said the committee on the ban on firearms and security personnel would start to accept applications for the issuance of authority to bear, carry or transport firearms or deadly weapons on Sept. 21.

And just to be fair to everyone, President Duterte and Vice President Leni Robredo are not automatically exempted from the ban.

"This is basically to align them with the formality of the process, so that everyone is treated fairly. It's no longer a question of (whether) they should be given an exemption... it is self evident... but again we are asking them to comply with the rules as a matter of fair treatment to everyone," Jimenez said during a press conference.

Comelec Resolution 10197, promulgated on Thursday, authorized Duterte and Robredo to "bear, carry or transport firearms... during the election period or from Sept. 23 to Oct. 30" but they need to apply for exemption if they travel with more than two bodyguards.

Also exempted from the ban, provided they apply for exemption, are senators, congressmen, Cabinet secretaries, the Chief Justice and justices of the Supreme Court, justices of the Court of Appeals, Sandiganbayan and the Court of Tax Appeals, judges of the regional trial courts and municipal trial courts, ombudsman and deputy ombudsmen, chairmen and commissioners of the Civil Service Commission, Commission on Audit and Commission on Human Rights, among others.

Violations of the new order are considered election offenses and would bear a penalty of one to six years imprisonment, removal of right to vote and disqualification to hold public office.

Jimenez added that while there is a possibility that the upcoming polls will be postponed to next year, the ban would still be imposed pending a formal announcement of postponement.

# Lorenzana on nationwide declaration of martial law: 'Remote possibility'

The declaration of a nationwide martial law next week is a "remote possibility," Defense Secretary Delfin Lorenzana said Friday.

Wire service Agence France-Presse, which earlier came out with a report titled "Philippines' Duterte may declare martial law next week: Defense chief," has updated its story to remove its reference to the possibility of a declaration of martial law next week.

Duterte had earlier said he would be forced to declare a nationwide martial law if the communist rebels bring their armed struggle to the streets.

"Sinabi na rin ni Presidente 'yan eh. Sabi niya, kung the... mga... 'yung left, sabi niya, 'Kung left will try to have a massive protest, magsunog sila sa kalsada, they will disrupt the country, then I might."

(The President has said it. If the left will try to have a massive protest, burn roads, they will disrupt the country, then I might.)

Sinabi na rin niya ang rason eh. But I don't think — sa aking pananaw naman, estimate ko — very remote naman mangyari (But I don't think-in my opinion, my estimate-there is remote possibility)," Lorenzana said in a Palace briefing.

The defense chief said the President was only "concerned that it (rebellion) might get out of hand."

"So sabi niya, 'I might declare martial law.' But I don't think the possibility that the left will be able to conduct a massive ano, massive demonstration across the country, disrupting the civil government or the lives of the people, eh hindi naman siguro mangyayari 'yun (i don't think that will happen)," he said.

Various groups have announced to staged mass protests on September 21 to condemned the brutal war on drugs, alleged police abuses and human rights violations, and the President's plan to declare a nationwide martial law.


"Tempest Wind" is a whole-of-government activity that will include government agencies involved in crisis management, counter-terrorism, and security operations from both countries.

#### Tempest Wind: PH, US to hold joint counter-terror drills

MANILA—The Philippines and the United States will hold a joint counter-terrorism drill this month to test the ability of both governments to conduct anti-terrorism operations.

The Tempest Wind drill, which will take place in the Philippines and Hawaii, will include planning on counter-terrorism strategy, including senior decision-making and tactical responses.

Tempest Wind was approved late last year by the Mutual Defense Board and Security Engagement Board to test force readiness and exercise interoperability. Earlier this month, US Ambassador Sung Kim assured the Philippines of Washington's commitment in fighting terrorism.

"Counter-terrorism is a shared priority for both of our countries, and [is] important for regional stability," Kim said.

A long-time ally of the Philippines, the US has provided technical assistance to Philippine troops still battling Islamic State-inspired extremists in Marawi City.

Washington also <u>donated</u> P730 million (\$15 million) in humanitarian aid for relief and rehabilitation efforts in the besieged city.

Of this amount, P153 million will be used to deliver basic relief supplies such as drinking water, hygiene kits, and shelter materials for evacuees. The remaining P577 million will be used to help fund rehabilitation efforts in the conflict-stricken city.
