

to fear; says Office of the Ombudsman

The Office of the Ombudsman remains unfazed by President Duterte's threat to create a commission that would probe supposed corruption in the antigraft agency and insisted it would continue its own investigation of the President and his family.

"Sorry, Mr. President, but this office shall not be intimidated," the agency said in a statement on Friday, adding it would pursue its probe of the supposed ill-gotten wealth of Mr. Duterte and his family.

"The President's announcement that he intends to create a commission to investigate the **Qmbudsman** appears to have to do with this office's ongoing investigation into the issues that involve him," the agency said

"This office, nonetnesess, shall proceed with the probe, as mandated by the Constitution," the statement added.

### Sauce for the goose

After the Ombudsman issued the statement, Mr. Duterte appeared on government television and called on aggrieved government officials to testify about their experience with Qmbudsman lawyers.

"Now is the time for you to seek revenge, and I will pin them down," the President

urged government officials who supposedly paid Ombudsman officials to dismiss the cases against them

Mr. Duterte said he would seek the arrest of Ombudsman officials who would refuse to show up in investigations to be conducted by his proposed commission.

"That's the only way. That's not being a dictator. Justice for one, justice for all. Sauce for the gander, sauce for the goose," he added.

### Quiet probe

The probe is led by Overall Deputy Ombudsman Melchor Arthur Carandang, whom Ombudsman Conchita Carpio Morales authorized after she inhibited herself from handling the case.

Morales inhibited herself because her nephew, lawyer Manases Carpio, is married to the President's daughter and Davao City Mayor Sara Duterte-Carpio.

Carandang earlier told the Inquirer that the agency had quietly investigating Duterte and his family after receiving information from Sen. Antonio Trillanes IV.

Trillanes claimed the President amassed over a billion pesos worth of unexplained wealth.

### Bank records

Carandang said the probe was based on bank transaction records of Duterte family members purportedly from the Anti-Money Laundering Coun-

cil (AMLC).

But the AMLC said it had not "provided the Office of the Ombudsman with any report as a consequence of any investigation of subject accounts for any purpose."

The council confirmed it received a request from Carandang on Sept. 6 to investigate the finances of Mr. Duterte, but the AMLC had not taken action on the request.

"We have yet to evaluate the request, and the initiation of an investigation, as well as the release of any report on the subject will depend on such evaluation," the AMLC said.

#### Not the source

"We have categorically stated before that the AMLC is not the source of the documents and information attached by Sen. Antonio F. Trillanes IV in his complaint," the council said.

"We cannot make further comments considering the confidential nature of the matter," the AMLC said.

Instead, the council cast doubt on the document attached to Carandang's letter, saying "the alleged debits and credits representing outflows and inflows of funds were added together, thus, the resulting total amounts are wrong and misleading."

But the Ombudsman maintained, in its statement, that it stood by the documents it had in its possession.

### Nothing to fear

"As to the documents in its possession, the Office stands by its word," it said. "If the President has nothing to hide, he has nothing to fear."

In an interview on Tuesday, Carandang declined to show any document he had in his possession.

But when shown the transaction records Trillanes distributed to media, Carandang said "more or less, it has the same details"

However, Carandang also earlier said that he approved the request of the Deputy Ombudsman for Mindanao to obtain an AMLC final report on the Duterte family's bank transaction records.

#### Final report

He said his office had the bank transaction records but not AMLC's final investigation report.

Carandang's admission that he did not have a final investigation report spurred Trillanes to criticize the AMLC for making unnecessary statements instead of completing its report.

"As to the content, the supposed AMLC statement is improper. In its necessity for release and in its tenor, which sounded like the AMLC was defending and absolving Duterte," Trillanes said.

Instead of issuing unnecessary statements, the council should just expedite its final report on Mr. Duterre's bank transactions as requested by the Office of the Ombudsman, he said.

"The results of this investigation could now be reported out and be used for a basis of an impeachment complaint," Trillanes told Agence France-Presse (AFP)

But in an interview aired

over government-run PTV 4 on Friday night, Mr. Duterte lashedback at Trillanes and said the senator only wanted to "destabilize the government."

Mr. Duterte said Trillanes had amassed funds to support such a plot in offshore accounts, including one in DBS of Singapore.

After Trillanes went to Singapore to disprove the existence of a bank account under his name, Mr. Duterte claimed Trillanes closed the account days before the senator went to Singapore to show that the account was nonexistent.

"He terminated it online on Sept. 8, 2017 past 10 p.m., then left for Singapore after that to show his waiver to the bank teller" he said.

Trillanes flew to Singapore on Sept. 19 to disprove Mr. Duterte's allegation that he had an account at a DBS branch there.

"Based on analysis, the funds being laundered by Trillanes and his group may not be for their personal use," Mr. Duterte read from a report that was described as an "intelligence report."

Instead, the funds were "being used for their cause and possibly to destabilize government by paying for witnesses and funding destabilization operations," the President said.

Mr. Duterte said the funds came from many parties and "clients," including large corporations that Trillanes was dunning for funds. —WITH A REPORT FROM AFP INQ

# ug war alarms 9 countries in UN

Thirty-nine countries, including the United States, have expressed alarm over what they described as a rising "climate of impunity" in the Philippines as drug-related killings continue to increase.

In a joint statement delivered by Iceland through representative Högni Kristjánsson on Thursday, the countries noted that the human rights situation in the Philippines continues to be of serious concern, particularly in the light of killings associated with the Duterte administration's war on drugs.

The states called on the Philippines "to cooperate with the international community to pursue appropriate investigations into these incidents, in keeping with the universal principles of democratic accountability and the rule of

They also expressed concern over threats against human rights defenders and urged the government to ensure they are accorded full protection.

They also called for a safe environment for journalists and indigenous communities.

The joint statement came as the Universal Periodic Review (UPR) of the Philippines was adopted at the 36th session of the United Nations Human Rights Council (UNHRC) last week.

Thousands of drug-related killings have been recorded by non-government organizations

Iy accept more than half of the recommendations it received during the 36th session of its UPR at the UNHRC.

R. Iniyan Ilango of the Asian Forum for Human Rights and Development (FORUM-ASIA) said the Philippine government's failure to fully accept and implement nearly 60 percent of the recommendations in received during it. LIPP is "deeply concerning," especially given that these include most of the recommendations by over 40 states on its so-called "war on drugs."

"A growing chorus of

voices is speaking out at the United Nations' top human rights body to condemn the thousands of killings in the Philippines perpetrated in the name of President Duterte's so-called war on drugs," John Fisher, Geneva director of Human Rights Watch, said.

"The Philippines has so far shown itself unwilling to heed the calls to end this murderous campaign and hoto those responsible to account. The Human Rights Council should step in and do all that it can to end the violence, support an international investigation

into-the deaths and demand accountability for all unlawful killings," he added.

More than 3,800 Filipinos have been killed by police in anti-drug operations since President Duterte came to office 15 months ago and launched what he promised would be a brutal and bloody crackdown on drugs and crime.

Human rights groups say the figure is significantly higher and accuse police of carrying out executions disguised as sting operations, and of colluding with hit men to assassinate drug users.

Opinion polls show Filipinos are largely supportive of the war on drugs as an antidote to crime the government says is fueled by narcotics.

The latest survey by Socia Weather Stations, however suggests that Filipinos are no convinced of the validity o official police accounts of the killings, with about half o 1,200 people polled doubting that victims were involved in drugs, or had violently resist ed arrest as police maintair — With Rhodina Villanueva Reuters

# Bicolairport site attacked

### NPA guerrillas demanding revolutionary tax set fire to heavy equipment

LEGAZPI CITY—Armed men believed to be communist guerrillas attacked the site of an airport under construction in a town in Albay province, setting fire to heavy equipment and drawing condemnation from military and civilian officials.

At least 30 suspected members of the New People's Army (NPA), the armed component of the Communist Party of the Philippines, raided the construction site in Daraga town, in an attack that some of the guerrillas were heard as saying was punishment for the project contractor's refusal to pay revolutionary taxes.

Driver Ronaldo Austria, a witness to the attack, said he was parking his truck when the guerrillas approached him and ordered him out of his vehicle.

"They told us to lie facedown and leave crawling," Austria said. "After several minutes, I smelled gas." He said he then saw heavy equipment being used for the airport project burning.

A list of the burned equipment prepared by the town's Bureau of Fire Protection office said that among those set on fire were dump trucks, a mixer, a grader, a mini-dump truck, a service vehicle and a crane owned by E.M. Cuerpo Inc.

A jeep owned by Sunwest Construction and Development Corp. was also burned.


### Project delay

Joe Naz, E.M. Cuerpo liaison officer, said at least P40 million in equipment and vehicles were destroyed.

E.M. Cuerpo was one of the project's contractors

Naz said the attack set back the timetable for the completion of the project:

Chief Insp. Arthur Gomez, information officer of the Al-

bay police, said another group of guerrillas fired at police in the village of Bascaran in Daraga around 8 p.m.

It was a diversionary tactic, according to Gomez.

Gomez said that while police were in the gunfight in Bascaran, which lasted for up to 30 minutes, a loud explosion ripped through the airport project site, which was some 3 to 4 kilometers away.

Ernesto Responde, E.M. Cuerpo foreman, said workers heard gunshots in an Army encampment and ran for cover

Workers asleep in some of the trucks were ordered out by the guerrillas, he said.

Supt. El Cid Roldan, chief of the Daraga police, said at least three groups of guerrillas took part in the simultaneous attacks on the Army position, police in Bascaran and the airport project site.

### Too steep a price

Capt. Jomar Clavel, operations officer of the Army's 901st Brigade, said the guerrillas held workers briefly at gunpoint as they set fire on the construction equipment.

Some of the workers quoted guerrillas as shouting: "This is your company's fault because

they do not pay us! Kill them!"

Clavel said a house owned by Saldy Morta near the construction site was shot by the guerrillas with a grenade launcher, causing trauma to the family and neighbors.

Gomez quoted the project contractors as saying they could not afford the amount being demanded by the guerrillas.

Albay Rep. Joey Salceda, also a proponent of the Bicol International Airport (BIA) project, said the attack would further delay the project.

"So sad. Another big setback after 12 years of effort. But we

are not giving up," Salceda said.

"This flagship project is a pillar of our development aspirations since tourism is our biggest potential," he added.

Salceda asked the military and police to tighten security in the construction site.

BIA's passenger terminal building was in its final stage of construction.

The attack was the guerrillas' second on the airport prolect site

# TROOPS OVERRUN CAMP OF BIFF

COTABATO CITY—A combined force of government troops and Moro Islamic Liberation Front (MILF) fighters have captured a camp of the Bangsamoro Islamic Freedom Fighters (BIFF) after fierce fighting in Datu Salibo, Maguindanao province, the military said on Friday.

# APAlaunches simultaneous attacksin Albax

Suspected New People's Army (NPA) guerrillas harassed military and police outposts and torched several equipment used in the construction of an airport in Daraga, Albay on Thursday night.

The Southern Luzon Command (Solcom) said an undetermined number of guerrillas first attacked an Army patrol base in Barangay Alobo at around 7:30 p.m.

Thirty minutes later, the group split and attacked the 2nd Maneuver Platoon of the Albay Provincial Police in Barangay Bascaran

At the same time, another group of guerrillas barged into a construction site and burned equipment owned by EM Cuerpo Builders Inc., contractor of the airport in Daraga.

The rebels reportedly fired their guns as they torched six dump trucks, a pickup, a grader, a mixer, a crane and an owner-type jeep, according to Superintendent Arthur Gomez, spokesman for the Albay police.

The NPA was reportedly demanding money, which the construction company could not afford to pay.

There were no immediate reports of casualties or injuries from both sides, the military said.

Albay Rep. Joey Salceda asked the police and military to intensify security and prevent another attack on the construction site.

The attacks occurred as Solcom troopers were pursuing insurgents who launched attacks in Batangas on Sunday

# NPA rebels stage attacks in 2 barangays in Bicol

DARAGA, Albay – Two groups of suspected New People's Army (NPA) rebels on Thursday night carried out separate attacks against a police detachment in Barangay Bascaran and minutes later set fire on the heavy equipment at the construction site at the Bicol International Airport (BIA) in Barangay Alobo in this town.

Reports reaching the Philippine National Police (PNP) in Albay said yesterday that a 30-minute firefight ensued between policemen and an undetermined number of suspected rebels.

Chief Insp. Arthur Gomez, PNP Albay spokesman, said the gunfight at the PNP Public Safety Command detachment lasted for 30 minutes but no casualty was reported on both sides.

He added it appeared that the attack at the Bascaran police detachment is a diversionary tactic for the NPA guerillas to torch 11 construction machineries such at BIA. The attackers burned five heavy equipment trucks, mini dump truck, a cement mixer, crane among others, owned by the EM Cuerpo

Builders.

He said it was the second attack staged by the rebels at the BIA. The first was in 2005 when a group of NPA men barged in at the construction site and torched several equipment of the Sun West Construction after the firm denied the extortion demands from the rebels.

Barangays Bascaran and Alobo in Daraga town are 20 kilometers away from Legazpi City.

Albay 2nd District Rep. Joey Salceda yesterday expressed dismay over the reported attack at BIA.

"So sad. Another big setback after 12 years of effort. But we are not giving up," he said.

The Albay solon has asked the Armed Forces of the Philippines and the PNP to fully secure the ongoing construction work of the BIA passenger terminal building which is currently in its final stage.

"We remain hopeful and the entire government is resolute that the President's commitment of completion in three years will still be met by early 2020," Salceda said.

## BIFF executes 4 members for disloyalty

CAMP SIONGCO, Maguindanao — Four members of an ISIS-inspired terrorist group in Maguindanao were executed by its commanders after they were found conniving with the rival Moro armed group and the military, the Army here said yesterday.

Lt. Col. Gerry Besana, chief of the Army's 6th Infantry Division Civil Military Operations (CMO) Battalion, said the four Bangsamoro Islamic Freedom Fighters (BIFF) members were followers of Ustadz Esmael Abdulmalik whose group pledged allegiance to the ISIS.

The execution, according to Besana, came after joint Army and Moro Islamic Liberation Front (MILF) recovered the BIFF stronghold in Barangay Tee, Datu Salibo, Maguindanao following several days of artillery and air strikes from the Philippine military.

Major Gen. Arnel dela Vega, commander of the 6th Infantry Division and Joint Task Force Central, said the BIFF camp, where the Esmael Abdulmalik faction has been hiding since last month, was captured Wednesday afternoon. It was located iat sitio Dagaring, Barangay Tee, Datu Salibo, Maguindanao.

At the camp, dela Vega said in statement that elements of the 57th Infantry, Battalion recovered the body of a slain BIFF fighter, four improvised explosive devices, two M-14 rifles, an M-16 Armalite rifle and ISIS flags when troops set in at past 5 p.m. Wednesday.

The slain BIFF member was later identified by villagers as Ansari Alimama, a Maranao from Butig town in Lanao del Sur and believed to be allied with the Maute terrorist group, according to Senior Supt. Agustin Tello, Maguindanao police director.

Barangay Tee had been the object of occasional air strikes when the MILF provided the information to the Army about the BIFF Abdulmalik faction's location.

Lt. Col. Gerry Besana, spokesperson for Task Force Central, said the Army is verifying reports from the locals that four BIFF members were executed by Abdulmalik on suspicion that they were providing the Army and the MILF their location through text messages.

"The barangay and local leaders have been providing us information about it and we are validating it." Besana said.

He could not say where the cadaver of four slain BIFF members now, but their mobile phones can no longer be reached, according to information provided by the MILE.

ZAMBOANGA CITY: The Philippine Army has urged communist insurgents to peacefully surrender and take advantage of the government's amnesty offer and livelihood package for them to start a new life with their family.

President Rodrigo Duterte, in his recent public speeches, even offered New People's Army (NPA) rebels their own houses and join the military as soldiers should they lay down their weapons and surrender to the government.

On Wednesday, seven rebels surrendered to the Philippine Army in the town of Ipil in Zamboanga Sibugay province, according to Major General Rolando Joselito Bautista, 1st Infantry Division and Joint Task Force ZamPeLan (Zamboanga Peninsula at Lanao) commander

He identified those who yielded as Henry Bawan Becsala, Benbin Gumandag Mandaw, Mario Oksik Maghanaoy, Lauravel Obaran Niadas, Villa Neadas, Marcelino Gumangay Lavares and Joseph Gumangay Lavarez. They also

handed over two AK-47 assault rifles and a 45-caliber pistol to the 102nd Brigade which facilitated the surrender

"This recent surrender is a result of the combined intelligence and combat operations being launched by our troops on the ground to employ more pressure and compel the communist terrorists to lay down their arms. There is an ongoing facilitation on the resolution of two surrendered NPA members, and the CLIP benefits will be done after this will be resolved." Bautista said, referring to the government's Comprehensive Local Integration Program

The NPA, armed wing of the Communist Party of the Philippines and the National Democratic Front, has been fighting for many decades now in an effort to overthrow the democratic government and install a Maoist state in the country.

# AFP scores big against NPAs

People's Army (NPA) when government troops seized a major rebel camp
in Compostela Valley (ComVal), and

According to Second Lt. Honeylee Joy S. Maunahan, acting Civil Military Operation (CMO) officer of the Army's 66th Infantry Battallion (66th IB) here, soldiers were able to over-run a one-hectare NPA camp in Sitio Side 4, Barangay Mangayon in ComVal, following a fierce encounter with about 50 rebels Thursday.

In Zamboanga City, Joint Task Force ZamPeLan Commander Maj Gen Rolando Joselito Bautista reported that seven NPAs surrendered in Zamboanga Sibugay, while three others gave up their arms in Zamboanga del Sur

The NPAs surrendered to the government last Thursday and Friday, according to Bautista.

Those who surrendered in Zamboanga Sibugay were Henry Bawan Becsala, alias Natoy, Benbin Gumandag Mandaw, alias Lito; Mario Oksik Maghanaoy, alias Rex; Laurayel Obaran Niadas, alias Maribel, Villa Neadas, alias Sandra, Marcelino Gumangay Layares, alias Ruben; and Joseph Gumangay Layarez, alias Michael.

Those who surrendered in Zamboanga del Sur were Roselyn Terez and Dolly Terez of Dinas town Paulino Laurete, Jr., of San Miguel town

Maunahan said a team from the 66th IB was dispatched to the area of Dash 7 in Sitio Side 4 to confirm reports about the presence of a large number of rebels from the guerilla-Front Committees 20 and 25, and Pulang Bagani Company (PBC) 8 of the CPP-NPA

Southern Mindanao Regional Committee.

A firefight erupted at around 10 a.m. when the soldiers chanced upon three rebels planting landmines along a road in the area.

"The team was able to hold and sustain the hour-long firefight where they served as forward observer for the artillery fires towards the enemy location," she said.

The 66th CMO Officer also said the delivery of accurate artillery fires and the bravery of the team members despite being outnumbered forced the rebels to withdraw and abandon their camp.

Recovered in the encounter site

were one M16A1 rifle, two Improvised Explosive Devices (IEDs), assorted enemy personal belongings, food stuff and other war materials, she said.

There was no casualty on the government side while the communist rebels were believed to have incurred casualties as per reports received by the unit from the civilians, she added



ARAGA, Albay About 30 armed New People's Army (NPA) guerrillas swooped down on the construction site of the Bicol International Airport in Barangay Alobo, this town, last Thursday night and torched at least 11 dump trucks and heavy equipment.

Chief Inspector Arthur Gomez, chief of the Police Provincial Office's (PPO's) Investigation Division, said five dump trucks, a minidump truck, a double cab, a grader, a cement mixer, and a telescopic crane burned to a total wreck.

All the construction equipment are owned by Manila-based contractor, E.M. Cuerpo, Inc. while a jeep that was also burned was owned by Sunwest Construction

E.M. Cuerpo foreman Ernesto Responde Jr. said the armed men swooped down on the construction site at 8:20 p.m. while firing shots in the direction of the Philippine Army Patrol Base around two kilometers away

Farther from the construction site – three kilometers away in Barangay Bascaran – were elements of the 2nd Maneuver Platoon of the Albay PPO's Pro vincial Public Safety Company (PPSC) who were also harassec by the rebels, said Gomez.

Albay 2nd District Represen tative Joey Salceda bewailed the incident as "another big setbacl after 12 years of effort" to keep the peace in the province.

"So sad, so bad," Salceda sai of the incident, "We ask the AFI (Armed Forces of the Philippines and PNP (Philippine National Pc lice) to fully secure the ongoin construction of Bicol Interna tional Airport in Daraga now o its final stage - the passenger te minal building," he added.





# 'Fighting in Marawi not yet over'

### By JAIME LAUDE

Intense fighting erupted in Marawi City between government troops and the Islamic State-inspired Maute terror group as officials expressed hope that the conflict that started last May 23 would end yesterday as earlier projected.

On Wednesday, Defense Secretary Delfin Lorenzana told reporters at the House of Representatives that reports he received from the ground indicated that the fighting could end on Sept. 30. Last Thursday, President Duterte said he was hoping the conflict would finally be over by "the end of the month"

Aside from the continuing ground fighting at the main battle area in the city, the military launched an air strike Thursday and yesterday on Balt Island in Lake Lanao against heavily armed men who have reportedly landed on board four boats.

"As we are getting closer and closer, we are encountering heavy resistance," one of the military commanders said yesterday.

He said that he could definitely say that the conflict will be over today as all efforts are now being directed at the group of Basilan-based Abu Sayyaf commander Isnilon Hapilon who has joined forces with the Maute

Military forces have pushed the terrorists into a small area near the shorelines of Lake Lanao, where escape is almost impossible.

"Once we get him (Hapilon) it's game over," the official said

The Armed Forces of the

Philippines (AFP) also reported yesterday to have killed 736 terrorists and recovered 789 firearms, 82 of which were recovered in last Thursday's fighting

The more than four months of clashes that have reduced portions of Marawi City to rubble had also resulted in the deaths of 153 soldiers and 47 civilians.

Col. Edgard Arevalo, AFP Public Affairs Office chief, said that in the fighting Thursday soldiers were also able to clear 36 additional buildings previously used as sniper and machine gun nests by the militants.

The Joint Task Force Marawi, on the other hand, presented to the media undated aerial footage and photos taken by military drones, showing how the terrorists looted banks, key financial institutions and pillaged residential houses of cash and jewelry.

The Task Force also presented half a sack of coins that the troops recovered from the terrorists' position in the main battle area following intense fighting.

These coins, in various denominations, were being used as shrapnel by the terrorists in their manufactured IEDs (improvised explosive device).

"They (terrorists) collect all sorts of metals from nails, bolts and coins to be used as an IED component," said Lt. Col. Emmanuel Garcia, Civil Relations Service chief of the Western Mindanao Command (Westmincom).

Government security forces have also turned over yesterday to Land Bank of the Philippines (LBP) officials four bank vaults recovered in the Marawi battleground

# Creation of defense university pushed

N official of the National Defense College of the Philippines (NDCP) is pushing for the creation of a National Defense University (NDU), which is envisioned to produce a greater number of Filipinos with defense and security backgrounds and elevate the subject of security to a national level.

The establishment of an NDU could not be more timely and appropriate, as the country is facing both internal and territorial threats, with the domestic challenge coming from a three-pronged threat, including terrorism.

NDCP Executive Vice President, retired Major Gen. Rolando Jungco, said a draft on the creation of the proposed NDU has already been submitted to Defense Secretary Delfin Lorenzana for review prior to congressional submission.

This early, the proposal already earned the support of several legislators, including Sen. Loren Legarda and Rep. Rozzano Rufino "Ruffy" Biazon of Muntinlupa.

Legarda, like a few number of lawmakers, is a graduate of the NDCP and is a reserve officer of the Philippine Air Force Biazon, on the other hand, is a former Customs commissioner under the Aquino administration and son of retired Armed Forces Chief of Staff Rodolfo

Biazon, also a former senator.

The proposed NDU, if approved by Congress, shall offer baccalaureate and postgraduate degrees in defense and security courses. It is eyed to initially rise at the compound of the NDCP inside Camp Aguinaldo in Quezon City.

'Unique'

IN pushing for the creation of an NDU, Jungco noted that the Philippines is the only country in the region without such a school, which is an irony, as the country counts the most number of security challenges among the states in Southeast Asia.

Jungco said that in Indonesia and Thailand, you cannot be a lawmaker unless you have gone through their defense universities.

China, on the other hand, has two defense schools—one for defense and another for science and technology.

The Thai and Indonesian examples are what Jungco and the other proponents of the NDU want the Philippines to emulate.

Jungco said the NDU should have as students members of Congress, noting that some lawmakers do not have a full grasp of, or could not fully understand, national security and its surrounding issues.

He said its intention is to develop, harness and encourage the lawmakers to think strategically for defense and security.

### Defense Act revision

WHILE there may have been support for the creation of an NDU from members of Congress, it may take time, however, before it could be set up, as the proposal has to be incorporated into an updated National Defense Act of 1935.

Jungco said the law only talks about the military. The Department of National Defense (DND) along with its other attached agencies are not even mentioned in the law.

The military, or the Armed Forces of the Philippines, falls under the DND.

In revisiting the Defense Act through the creation of the NDU, Jungco said they also proposed the inclusion of the DND and its agencies, including the Philippine Veterans Affairs Office, the NDCP, Office of Civil Defense and the Government Arsenal, in the law.

The National Defense Act of 1935 is the only defense law in the country.

If the creation of the NDU materializes, it will have a mixture of civilian and military students.

Jungco said the students of the university should include lawmakers, all generals of the AFP with no exemption, and others in the civilian sector, including businessmen.

"Ideally, it would be under the Commission on Higher Education, but focusing more on defense and resource management," Jungco said.

# More Maute fighters neutralized — AFP

Twenty-one more Islamic Stateinspired terrorists were killed on Thursday while two more government troops were added to the military casualties as the Marawi City siege dragged on its 130th day yesterday.

Col. Edgard Arevalo, Public Affairs Office chief of the Armed Forces of the Philippines (AFP), said a total of 736 terrorists had been killed since the Marawi City siege erupted last May 23.

"Twenty-one (terrorists) were either neutralized or remains

recovered in yesterday's (Thursday) tally of the ongoing offensives," he added.

The military said it was checking if Omar Maute — one of the key leaders behind the attack on Marawi was among those killed.

A total of 789 firearms had been recovered from the battle area -82 of which were seized during Thursday's operation that led government troops retaking the White Mosque.

Two more government troops, however, were added to the list of

Defense Secretary Delfin Lorenzana said White Mosque was taken over by government forces after heavy resistance from the terrorists since Wednesday.

Arevalo said a total of 36 buildings in the battlefield where cleared on Thursday.

Last week, the military said Isnilon Hapilon, the designated emir or leader of the Islamic State of Iraq and Syria (ISIS) in Southeast Asia, and Omar Maute were still leading to main terrorist groups in the main battle area in Marawi City.

Several hostages are still being held by the terrorists.

Relatedly, Western Mindanao Command (Westmincom) chief Lt. Gen. Carlito Galvez said three Maute fighters surrendered in Marawi as troops continue to advance and gain ground in the battle area in Marawi City.

"I believe they can't anymore stand the intense fighting," he told a press briefing.

According to the military official, they are "regular fighters" or the recruits of the Maute Group.

Galvez, however, refused to give more details, citing operational security.

"We are still withholding the information because of some critical matters. We still have a lot of operations ongoing," he stressed.

Lorenzana has earlier said the lives of surrendering Maute Group terrorists will be spared provided they surrender peacefully.

He made this statement after Lanao del Sur Rep. Mauyag Papandayan told him that some of the surviving terrorists have expressed willingness to surrender.

Duterte reiterated that there was no need for celebration. "And my orders to the military is that kung manalo man tayo (if we win), we do not celebrate any victory in Mindanao, simply because we are waging a war actually against out own people and it would not look good, especially people who have adopted other religions," he said.

Duterte then assured the Maranao people of Marawi and the Lanao provinces that he would rebuild the city.

Fighting in Marawi City started on May 23 when military and police personnel tried to arrest Abu Sayyaf subleader Isnilon Hapilon, who was supposedly named "emir" of the Islamic State in Southeast Asia.

Government troops encountered stiff resistance from Islamist terrorists belonging to the Maute and Abu Sayyaf groups. This led Duterte to declare martial law in Mindanao.

The military has already missed three deadlines to retake the wartorn city.

Security officials originally aimed to finish their operations in Marawi City by June 2. However, this was not met as government troops continued to experience heavy resistance from Maute rebels entrenched in the city.

Duterte then said on June 4 that the Marawi siege would end in "about three days."

After this, the military said it would seek to liberate the town on June 12, the 119th anniversary

### Coins and IEDs

On Friday, the military said the Maute terrorists placed coins inside improvised explosive devices, with currency looted from wartorn Marawi. This explains why coins were found in the wounds of some soldiers.

Citing aerial footage, Col Romeo Brawner, Task Group Ranao deputy commander, said Maute members were "pillaging" and "looting" structures inside the main battle area.

"We can see items/boxes/sacks being taken from a seemingly residential building. This reinforced the revelations of rescued former hostages that the terrorists were looting important materials inside the MBA (main battle area)," Brawner said in a statement. On Thursday, military troops recovered four ATM money vaults from a Land Bank of the Philippines building, Brawner said. These were turned over to the security manager of the state-owned bank

"The money vaults were not opened. Some were obviously burned but were intact," he said.

The military also said former Maute hostage Lordvin Acopio, who was rescued alongside Fr. Teresito Soganub on September 16, had disclosed that some terrorists hid inside vaults while the Air Force conducted air strikes.

### Death toll

More than 900 persons have already been killed in the Marawi battle, the Armed Forces of the Philippines said on Friday.

At least 736 Maute members have been killed in clearing operations conducted by state forces, and 789 firearms were seized.

Fighting has also claimed the lives of 153 uniformed men and 47 civilians.

A total of 1,733 civilians have Arm been rescued, the military said.

# Sayyaf ties with drug 'gangsters' bared

CHINESE gangsters are to blame for the proliferation of illegal drugs in the Philippines, and they have even licensed the terrorist Abu Sayyaf to manufacture and distribute the drugs here, President Rodrigo Duterte claimed Thursday.

"They cook the substance inside a ship and then they just throw it to the sea," Duterte said in his speech during his visit to Balangiga town in Eastern Samar.

"They are able to manufacture and distribute because they are armed. They

are intentionally doing that,"

Duterte made his statement even as Aaron Aquino, director general of the Philippine Drug Enforcement Agency, said three drug syndicates were behind the proliferation of drugs in the Philippines.

He said the syndicates were from Taiwan, mainland China and Hong Kong, and that they could ship three tons of shabu to the Philippines.

Aquino said the open sea was the drop-off point for the illegal drugs, and that divers retrieve them and transport them from smaller boats.

Detailing the operations of two international drug syndicates who had turned the Philippines into their "client state," Duterte said the members of these drug groups would put the drugs in tin cans and then throw them into the sea. The cans would have Chinese markings and a global positioning system to locate them

While Duterte absolved China of being the new source of illegal drugs in the Philippines, he said there were also Filipino members of the drug triad. Next page

"China's government has nothing to do with it. The Chinese people has nothing to do with it. It's the gangsters of the Philippines and China," Duterte said.

"It's the gangsters of the Philippines and China combined. They combined to make the life of the Filipinos miserable," he added.

In his speech on Tuesday, Duterte said two international drug syndicates were engaged in large-scale drug trafficking activities in Southeast Asia and the Americas: The Hong Kong-based 14K and the Taiwan-based United Bamboo Gang, also known as UBG

He said the Philippines was being used as a transshipment point of these groups. He said he had sought help from the United States to help control drug smuggling.

Chinese ambassador to the Philippines Zhao Jianhua earlier denied that he was aware of a Chinese Bamboo Triad, a drug ring operating in the Philippines, and assured local officials that China will not protect criminals.

Taiwan has also denied the President's claims that it is a source of the drugs in the Philippines, with its representative in Manila, Gary Song-Huann Lin, saying he would like to get information on the President's allegations. John Paolo Bencito and Rio N. Araja

Government troops have been trying to flush out the Maute rebels from Marawi for the past four months but the enemies have kept a strong resistance. The military earlier claimed that the rebels have been using hostages as human shields and mosques as staging points for attacks.

#### **Humane treatment**

Meanwhile, Lorenzana assured that the Daesh-inspired Maute terrorists who wish to surrender or turn themselves in will not be hurt or killed but will be treated properly.

Lorenzana made the remark after re-

ceiving reports that some of the members of the Maute who occupied Marawi City since May 23, 2017 have signified their interest to turn themselves in to government forces operating in the area.

"Kahapon (yesterday), during the Marawi briefing by the Muslim Affairs Committee, ang sabi nila gusto nilang sumurender. Sabi ko walang problema (they said they want to surrender, I told there's no problem)," Lorenzana said

"In fact, the AFP Western Mindanao Command, our troops in Marawi... everyday they use a bullhorn asking them (the remaining members of the Maute) if they want to surrender. "Of course, we will not kill people who are surrendering. Our soldiers are not murderers. We will take them in and it's up to the courts to decide on the cases we will file against them. But they will not be killed if they surrender," Lorenzana assured

Meanwhile, Col. Romeo Brawner, deputy commander of the Joint Task Force Marawi, said some Maute fighters are already sending surrender feelers.

Brawner did not give a specific number, but disclosed that Galvez is estimating that the crisis will be over in "10 to 15 days."

"We are dependent on the statement of General Galvez. But on the ground, the police and the military, we are all doing our best," he said.

Brawner said the surrender feelers were sent continuously although he did not divulge how frequent.

"We still have some surrender feelers, we're receiving surrender feelers continuously But so far wala pang bagong surrenderees," Brawner said (With a report from Zea C. Capistrano)



#### Duterte gov't adopts US 'war on terror' plan



First, – after so much presidential anti-US blustering and threat to cut off relations and chart an "independent foreign policy" – it has brought the Duterte government complicitly in closer security/defense alliance with American imperialism under a warmongering Trump administration;

Second, it has tied down the Philippines to the latter's costly (in trillion US dollars and thousands of lives lost) global "war on terror" – as when, in late 2001, the Bush administration similarly tied down the Arroyo regime. Since then, that has enabled, by virtue of the Visiting Forces Agreement, about 600 US Special Forces troops (on three-month rotations) to stay in the country as advisers and trainers of AFP troops in the antiterror campaign against the Abu Sayyaf group; and

Third, it has reincluded the Philippines as a front of such war – this time against the Islamic State, or IS/ISIS – featuring intensively devastating aerial attacks, with less American troops on the ground. (The almost daily aerial bombings in Marawi, under US drone guidance, which have flattened a large party of the city, are just a small sampling of this mode of warfare.)

And now President Duterte, obsessed with pursuing till the end of his term a bloody war against illegal drugs to fulfill his electoral campaign promise, has found a convenient rationale for embracing the US global war on terror, he conflates his antidrug campaign with the antiterror war.



He has claimed that the Maute group, which along with Isnilon Hapilon's Abu Sayyaf group has engaged AFP troop's in fierce combat in Marawi for over four months now, is being financed by drug lords. His latest narrative was that the Marawi conflict had been triggered by an attempt by state security forces to arrest a "drug suspect" whom he didn't identify However, the broadly publicized story was that the arrest aftempt was directed at Hapilon, for whose "neutralization" as a "high-value terrorist" target the US government has offered a \$5-million bounty (similar to that for "Marwan" in the botched Mamasapano secret PNP operation).

Duterte has also claimed that the Philippines is being used as a transshipment point for shabu (crystal methamphetamine) bound for the US market – following up with the not-so-subtle suggestion that therefore America should "work closely" with his administration "on this serious matter."

Back to the Tempest Wind joint military drill, what did it entail?

In an unusual scenario, up to 1,200 American and Philippine troops were mobilized in a first-of-its-kind drill wherein a Hawaii-bound plane from Sydney, Australia was supposedly hijacked by an Islamic State cell and forced to land at Clark Air Base in Pampanga. More than 400 troops, airport police and hostage negotiators, and unspecified

civilian agencies from both governments were put to work.

No details were provided as to how the mock hijacking problem was resolved. But worth noting is that, as the report said, both the US and Philippine governments stressed that they knew of no such actual plot by the IS or its supporters.

Let's look at the rationalizations, reported in media after the closing ceremonies, of the key officials involved in

the exercise.

Defense Secretary Delfin Lorenzana said Tempest Wind is in line with President Duterte's wish to refocus the 1951 US-RP Mutual Defense Treaty toward counterterrorism and disaster relief. The MDT pertains to mutual defense against external attacks or invasions. Can either party refocus it just like that? Lorenzana was quoted as saying.

"(It) served as a perfect opportunity to assess the needs of the new security environment in the Pacific region, especially now that terrorism has become evident in our current security landscape. The drill was designed to provide realistic scenarios (on) terrorism that demand both high-level engagement from these countries on a tactical level."

How does Lorenzana's statement fit with the two governments' acknowledgment that there's no known plane

hijacking plot by the IS?

Provoking more questions was what the US ambassador to the Philippines, Sung Kim, reportedly said at the closing ceremonies: "(Tempest Wind) presented an unprecedented opportunity for comprehensive training for both senior leaders and action officers."

However, Jarrod Gillam, of the US State Department Counterterrorism Bureau, provided a definite reference point: Tempest Wind was a venue for the "whole-of-government approach to crisis resolution." "Whole-of-government approach" is an aspect of the 2009 US Counterinsurgency Guide that the AFP has adopted in its Oplan Bayanihan under the P-Noy (Aquino) government, carried over to the Duterte regime's Oplan Kapayapaan.

The concept, culled largely from US military experiences in their interventionist wars in Afghanistan and Iraq, requires all departments and agencies of government to be involved in the counterinsurgency, or antiterrorism, programs. That this idea hasn't worked is starkly shown by the fact that after 17 years the US war in Afghanistan continues — with President Trump now planning to send more American ground troops there.

Oplan Bayanihan also failed to achieve its goal: to "render irrelevant" the New People's Army. Yet Duterte's defense secretary and AFP generals, who he has acknowledged to be "all pro-US," have mindlessly incorporated those US-designed concepts ir its own counterinsurgency Oplan Kapayapaan. Come to think of it, the name ought to be Oplan Todo Gera, not Kapayapaan, given that it is being relentlessly pursued under the rubric of "total war" declared last February and endorsed by Duterte.

## Can a cyber attack justify a military response?

A S guaranteed by the UN Charter, a state always has the natural right to defend itself in case of an armed attack. Meaning, if the scale and consequences of the use of force against a state reaches the level of an armed attack, then the victim state may use force to defend itself.

Cyber operations are now a key element of modern warfare and an increasing focus of militaries around the world. The question is: when is a cyber attack an act of warfare? A cyber law pioneer on the subject is Tallin Manual 2.0, a product of NATOs Cooperative Cyber Defense Centre of Excellence (CCDCOF) in Tallin, Estonia, which analyzes how international law as it currently stands applies to cyber operations. According to the manual, for a cyber attack to reach the level of an armed attack, the consequences of the attack need to be comparable to those of a kinetic attack. Thus, if a cyber operation seriously injures or kills a number of people or causes significant damage to or destruction of property, it would, under international law, be considered an armed attack. It does not matter whether it is directed against military or civilian personnel or against public or private properties.

A classic theoretical example is when cyber weapons as tools



or viruses are used and accidentally cuts power to a hospital or medical center endangering civilian lives. Another example is a cyberattack on a country's banking system. If the attack resulted in grave physical damage, then such is an armed attack although, at the moment, consequence as mentioned remains unreported.

The reality of a cyber attack could, perhaps, be illustrated by the reported incident in Iran where a bug wreaked havoc on Iranian uranium centrifuge operations which became widely known because the bug proliferated broadly beyond the Iranian system but did not have an impact on systems outside the country's nuclear program due to the fact that the effects were specifically targeted. This example demonstrates that cyber weapons are still incredibly new compared to the more conventional warmaking counterparts.

The Tallin Manual 2.0 mentions that cyber operations have become part of modern warfare and are therefore governed by the law of armed conflict. In connection therewith, what comes to mind

are the principles of necessity and proportionality in the law of war which asks whether the amount of force required to repel the armed attack outweighs the anticipated collateral damage to civilian objects and non-combatants. Maarja Nagel of NATOs law branch of its CCDCOF believes a cyber attack could be met by 'countermeasures,' a form of selfhelp in international law, allowing a state to respond by taking actions that would, under normal circumstances be contrary to international law. "There are, however, strict limitations placed on countermeasures and they must be aimed at inducing the other state to resume lawful behavior, rather than as a punishment or revenge. They must also be proportionate " Economic sanctions or expulsion of the responsible state's diplomats are examples. So, too, is suspension of exchange of information or cooperation between national computer emergency response teams.

There are experts from the military, however, who consider cyberspace as the "fifth domain" of warfare after land, sea, air and space. But others are of the view that the latter are "inherently geographical" while the cyber domain is not. Cyber operations could be used to conduct large-scale espionage or subversion

which are hardly new elements in the world of defense. "Weapons systems, decision-making systems are increasingly cyber- and artificial intelligence-enabled and cannot be considered as a fifth domain somehow distinct from others because that is not really how it works." In other words, the digital frontline is not (yet) a warfare domain.

Besides, there are indeed areas of ambiguity in international law that need clarity in order to do legal adjustments. Cyber operations vis-à-vis the law of armed conflict is one of them. Much depend on practice or the process through which international law is interpreted and further developed via actual behavior of states.

As cyber warfare matures and types of attacks evolve and become a threat with increasingly local ramifications, the often quoted Martens Clause in international la—which provides that where the law of war does not address a particular case, reference should be to the "rule of the principles of the law of nations, as they result from usages established among civilized people from the laws of humanity and the dictates of public conscience"—still expects equal application among states in the 21st century.

#### Army, SAF engage in encounter with rebels

THE 62nd Infantry Battalion (IB) of the Philippine Army and Philippine National Police -Special Action Force (PNP-SAF) engaged in a firefight with suspected members of New People's Army (NPA) in Barangay San Isidro, Toboso, Negros Occidental early Thursday morning.

<u>Lieutenant Colonel Darrell Bañez, commander of 62nd IB, said yesterday the troops and police were conducting community security patrol in the area when they encountered about 10 armed men around 5 a.m.</u>

"The firefight lasted for about two minutes," Bañez said. No casualties were reported.

Additional troops were sent to the area to track down the armed men.

The joint combat operation of 62nd IB and PNP-SAF is in response to the reports they received from residents about the presence of armed men in the village.

Bañez expressed his gratitude to the community for their full cooperation that helped the government troops ensure peace and order in the province.

Colonel Eliezer Losañes, commander of 303rd Infantry Brigade, said hot pursuit operation is ongoing.

#### New People's Army admits killing of RPA-ABB leader

THE Armando Sumayang Command South West Negros Guerilla Front of New People's Army (NPA) owned up the killing of a commander of Revolutionary Proletarian Army-Alex Boncayao Brigade (RPA-ABB) in Kabankalan City, Negros Occidental three weeks ago.

In a press statement dated September 27, Andrea Guerrero, spokesperson of the rebel group, said Jovanie Banista, 50, a sixth district commander of RPA-ABB based in Barangay Locotan, Kabankalan City, had engaged in illegal gambling and illegal drugs as protector, particularly in areas of Bantayan, Magballo and Manduaw in Kabankalan City.

Guerrero added that Banista was also involved in corruption and illegal logging.

She said that Banista was hired as a personal bodyguard and hitman of politicians in southern Negros especially during the elections last year.

The rebel group also alleged that Banista was an instrument of the Armed Forces of the Philippines and Philippine National Police in counter-insurgency operations against the revolutionary movement.

They added that he was also involved in human rights violation against civilians, and in hold-up incidents victimizing businessmen.


On September 9, Banista was gunned down by about 12 armed men on his way home from Barangay Bantayan.

In August 2014, he was seriously wounded when he was also ambushed by the same assailants at Purok Cubay in the same village.

#### AFP troops seize large NPA camp

Camp Bancasi. Butuan City – Combat maneuvering troops of the Armed Forces of the Philippines (AFP) recently seized a large New People's Army (NPA) camp in Sitio Side 4. Barangay Mangayon, Compostela town, Compostela Valley (ComVal) province, said 2nd Lt. Honeylee Joy S. Maunahan, acting Civil Military Operation (CMO) officer of the Army's 66th Infantry Battalion (66th IB) on Friday.

She said an estimated one-hectare NPA camp was seized by the operating troops of the 66th IB following an armed encounter against some 50 heavily armed NPA rebels Thursday morning.

A small unit team was sent for an operation in the area of Dash 7 at Sitio Side 4, Barangay Mangayon, Compostela town, to confirm the report regarding the presence of a large number of communist rebels composed of guerilla-Front Committee 25 and guerilla-Front Committee 20 and Pulang Bagani Company (PBC) 8 of the CPP-NPA Southern Mindanao Regional Committee, the 66th IB CMO officer said, in a statement sent to The Manila Bulletin on Friday.

## The firefight started at around 10 a.m. when the three NPA terrorists who were laying landmines along a road fired upon the troops, she said.

"The team was able to hold and sustain the hour-long firefight where they served as forward observer for the artillery fires toward the enemy location," she said.

The 66th CMO officer also said the delivery of accurate artillery fires and the bravery of the team members despite being outnumbered forced the rebels to withdraw and abandon their camp.

The reinforcing 1st Platoon Bravo Company, 66IB, and the small unit who was earlier engaged, conducted the assault which resulted in the seizure of the NPA camp, she said.

Recovered in the encounter site were one M16A1 rifle, two improvised explosive devices (IEDs), assorted enemy personal belongings, food stuff and other war materials, she said.

There was no casualty on the government side while the communist rebels were believed to have incurred casualties as per reports received by the unit from the civilians, she added.

"This is a strong statement that 66 th IB will not allow incursion of peace spoilers and we have been continuously winning back the mass bases the NPA have gained during the ceasefire," also said 667th IB commander Lt. Col. Palmer Parungao, in the same statement.

The encounter is an evidence that many people now are against the communist wrongdoings and are willing to sacrifice for the protection of peace in this part of the region, Lt. Col. Parungao added.

# OFF LIMITS | Main Battle Area in Marawi restricted to civilians even if fighting ends

**CAMP GEN EMILIO AGUINALDO, Quezon City (DWDD)** – Civilians will not be immediately allowed inside the main battle area even if the fighting ends.

This was the statement made by National Defense Secretary Delfin Lorenzana who explained that they will not let civilians inside areas previously held by the Daeshinspired Maute terrorist group because the situation remains dangerous.

Buildings and other structures needs to searched and cleared by government forces from possible booby-traps or improvised explosive devices left by the terrorist and from unexploded ordnance.



Even if the shooting ends soon between government troops and the Maute terrorist, the area remains a large danger zone for innocent civilians. To begin with, Lorenzana added that it is a very large area to clear and safety is their main concern.

Aside from the danger, there are no more homes or structure to return to in the main battle area because it has been destroyed by the fighting.
