Gun ban in effect as election period starts

The election period for the May 14 Barangay and Sangguniang Kabataan Elections (BSKE) starts today and the Office of the Election Officer will start receiving certificates of candidacy

(COC) from 8 a.m. to 5 p.m. in the city or municipality where the candidate resides starting today until April 20.

Under the law, no person shall be eligible for any Barangay or SK position unless he or she files a sworn COC, the forms of which may

be obtained either at the local Offices of Election Officers (OEOs) or downloaded at the Commission of Elections (Comelec) website: www.comelec.gov. ph.

Voters aged 18 and above shall vote for one Barangay chairman, and seven Barangay Kagawads. Meanwhile, voters aged 15 to 30 shall vote for one Sanggunian Kabataan (SK) chairperson and seven SK members.

The Parish Pastoral Council for Responsible Voting (PPCRV) chairperson Rene Sarmiento reminded aspirants that running for public office is a serious business.

"Running for public office, presidency or Barangay/ SK (BSK) posts, is serious business, because it deals with people's lives, liberties and properties, and fortunes as well, and candidates should be God-fearing and people-serving," Sarmiento added.

Candidates for barangay chairman and kagawad should be a Filipino citizen, a registered voter in the Barangay where he intends to be elected, a resident therein for at least one year immediately preceding the day of the election, able to read and write Filipino or any other local language or dialect, and at least 18 years of age on election day.

SK candidates, on the other nand should be a Filipino citizens, a qualified voter of the Katipunan ng Kabataan (KK), resident of the Barangay for not less than a year immediately preceding the day of the elections, at least 18 years but not more than 24 years of age on the day of the elections, able to read and write Filipino, English or the local dialect, must not have been convicted by final judgment of any crime involving moral turpitude, must not be related within the second civil degree of consanguinity or affinity to any incumbent elected national official or to any incumbent elected regional, provincial, city, municipal, or barangay official, in the locality, where he or she seeks to be elected.

Gun ban

The Comelec said during the election period which will end on May 21, "no person shall bear, carry or transport firearms or other deadly weapons in public places, including any building, street, park, private vehicle or public conveyance, even if licensed to carry the same, unless authorized in writing by the Commission."

Only regular members of the Philippine National Police, the Armed Forces of the Philippines and other law enforcement agencies of the Government who are duly deputized in writing by the Commission for election duty may be authorized to carry and possess firearms during the election period.

However, the Comelec said, "when in the possession of firearms, the deputized law enforcement officer must be in full uniform showing clearly and legibly his name, rank and serial number, which shall remain visible at all times, and in the actual performance of his

election duty in the specific area designated by the Commission."

Gun ban exemptions may be issued to other qualified individuals, "who by nature of their official duties, profession, business or occupation, such as but not limited to cashiers, disbursing officers, persons who are under the Witness Protection Program, etc., are considered as high risk individuals."

All application/requirements for gun ban exemptions shall be filed with the Committee on the Ban on Firearms and Security Personnel (CBFSP) at the Comelec Main Office, 8th Floor, Palacio del Gobernador Building in Intramuros, Manila

To effectively implement the firearms ban during the election period, Comelec Checkpoints shall be established nationwide.

"There shall be at least one (1) ComelecCheckpoint in each city/municipality. However, additional checkpoints, including those coming from PNP/AFP commands outside the city/municipality, shall be established in coordination with the Election Officer (EO) having jurisdiction over the city/municipality," the Comelec said in Resolution No. 10198, promulgated September 14, 2017.

When the ban takes effect at 12:01 a.m. of April 14, 2018, the setting up of checkpoints will also commence, the Comelec said.

Third termers

Records of the Department of the Interior and Local Government (DILG) showed there are 8,927 third-termer incumbent punong barangays in the country and 51,273 third-termer sangguniang barangay members.

DILG officer-in-charge Eduardo M. Año said that under the Local Government Code, "no local elective official shall serve for more than three consecutive terms in the same position. Voluntary renunciation of the office for any length of time shall not be considered as an interruption in the continuity of service for the full term for which the elective official concerned was elected."

"The law is very clear regarding the prohibition of third termers to run for the same post. Do not file your candidacy if you will go beyond the third term, or consider running for another post. Betteryet, let the others have their chance to become barangay leaders," he added.

DILG Assistant Secretary and spokesperson Jonathan Malaya said the department has already submitted to Comelec the names of incumbent punong barangays and sangguniang barangay members serving their third consecutive terms in office in the same position.

"This initiative of the DILG to be on guard of third-termer barangay officials is in line with department's commitment of support to an honest and clean elections," said Malaya. (With reports from Martin A. Sadongdong and Chito Chavez)

Butuan City cops repulse NPA attackers after 20-minute gunfight

BUTUAN CITY — The Butuan City Police Station 5 (BCPO-S5) located in Barangay San Mateo, was reported attacked by about suspected fighters of the New People's Army (NPA) on Thursday, an assault that was repulsed by a crew of about 20 police officers after a 20-minute gunfight.

According to Chief Supt. Noli A. Romana, regional director of Northeastern Mindanao Police Regional Office 13 (PRO 13) the policemen of BCPO-S5 stood their ground until reinforcing troops arrived. The attack began at 9:36 a.m. Thursday.

"Rebels retreated neither getting any weapon and ammunition nor hurting any of our policemen on the ground," the region's police chief told The Manila Bulletin.

He added that the police force may have even inflicted casualties on the side of the marauding NPAs.

However, Romana admitted that the failed NPA attack may have created fear among residents living near BCPO-S5.

"We urge the people to help the Philippine National Police (PNP) and Armed Forces of the Philippines (AFP) in suppressing insurgency in the region by reporting the terrorists' presence and illegal activities to the nearest police/army unit," the region's top cop added.

The attackers were believed members of Guerilla Front Committee 4-A of the CPP-NPA Northeastern Mindanao regional Committee.

Troops from the 13th Regional Mobile Force Battalion and Butuan City Mobile Force Company reinforced the embattled elements of BCPO-S5, and conducted clearing operations.

Troops from the 402nd Infantry (Stingers) Brigade were also deployed to assist the police mobile forces in the wide pursuit operations against the retreating terrorists.

Meanwhile, security forces are also pursuing NPA fighters, who burned down Thursday a packing plant owned by a multi-national banana firm in Tupi, South Cotabato.

Sr. Supt. Nestor Salcedo, South Cotabato police Director, said six unidentified armed men, who introduced themselves as NPA members, barged into the compound of a banana packing plant owned by Dole-Stanfilco in Barangay Lunen Tupi, South Cotabato.

Police said the suspects, who were armed with rifles and handguns, confiscated the hand-held radio and cellphones of security guard Rio Alegria and other company employees before they set on fire the warehouse inside the compound.

Sulu health employee killed in ambush

ZAMBOANGA CITY: Unidentified assailants shot dead an employee of the Sulu Integrated Provincial Health Office in Jolo town at a time government leaders were working hard to promote peace and tourism in the Muslim province.

Edmiraldo Sollano, 38, was killed while driving home on a motorcycle in Barangay San Raymundo on Thursday. His assailants drove off with Sollano's motorcycle and disappeared in the dark.

No individual or group has claimed responsibility for the murder and police were investigating the attack. It was

unknown why the police and military failed to prevent the attack or strictly guard the capital town despite the extended imposition of martial law in the entire southern Philippines.

Abu Sayyaf bandits had previously attacked Jolo and kidnapped innocent civilians despite the presence of military and police camps in the town. Even the town's police headquarters are not safe anymore and also attacked in the past.

Police and military checkpoints and patrol were also limited in many towns and by nightfall there is hardly any soldiers and policemen guarding vital government installations in Jolo and nearby areas.

Gov. Toto Tan has repeatedly rallied the mayors in Sulu to work hard in protecting their communities and work harder to lure investors to put up business in Sulu, one of five provinces in the Autonomous Regions in Muslim Mindanao.

Just last week, Tan met with Army Colonel Santiago Enginco, commander of Metro Jolo Inter-Agency Task Group, and Doctor Farah Omar, of the Sulu Integrated Provincial Health Office, and discussed the security situation in Jolo town. He also

met separately with Army Major Aunor Balansi and Master Sergeant Anthony Abellera, of the 5th Scout Ranger Battalion.

Tan ordered authorities to impose a tighter security in the town and for the military to help police in maintaining peace and order in the province.

The Department of the Interior and Local Government has removed last year the supervision of the local executives over the police, which relied heavily on the support of local governments in their campaign against criminality.

Military seizes firearms from BIFF

CAMP SIONGCO, AWANG, Datu Odin Sinsuat, Maguindanao—In a press briefing, Maj. Gen. Arnel dela Vega, Commander of the 6th Infantry (KAMPILAN) Division, Lt. Col. Alvin Iyog, Commanding Officer of the 2nd Mechanized Battalion and Commanding Officer Lt. Col. Lauro Oliveros of 1st Mechanized Battalion presented to the media, 18 High Powered Firearms (HPFAs) and Low Powered Firearms (LPFAs) and the 5 BIFF terrorists who surrendered.

Along with the firearms are significant numbers of unassembled parts of weapons. There are 41 barrels, a number of stocks and an ample number of trigger mechanism that would double the number of seized firearms if assembled.

Military officials said the surrender of the firearms is a big loss in the part of Bangsamoro Islamic Freedom Fighters (BIFF)

Lt. Col. Iyog said, "This is the product of heavy bombardment made by the military troopers against the terrorist inspired BIFF led by Abu Nasriah and Commander Bungos. For the last two days, there were series of operations conducted by the military troopers in the area,"

As early as 6 a.m. of April 10, 2018, the combined efforts of one (1) Mechanized Infantry Company, Alpha Company of 57 Infantry Battalion and 61st Division Reconnaissance Company led by Lt. Col. lyog, conducted a clearing operation at Brgy, Pagatin, Shariff Saydona Mustafa, Maguindanao.

Subsequently, mortar section provided also mortar fire support while special army vehicle provided direct fire Philippine Air Force PAF also conducted close air support to the troops.

'THEY'RE TERRORISTS'

SARA ASKS DAD TO RECONSIDER REVIVAL OF PEACE TALKS WITH REDS

DAVAO CITY—Davao City Mayor Sara Duterte has appealed to her father, President Duterte, to reconsider his decision to revive the peace talks between the government and communist rebels, saying there are no indications that the communists are willing to negotiate for a peaceful resolution to the decades-old conflict.

In an emailed statement on Friday, Sara said that while she trusted "the wisdom of the President," she believed that pursuing peace with the insurgents "is counterproductive and plainly useless."

"Respectfully, I am asking President Rodrigo Duterte to, reconsider his decision to reopen the negotiations with the National Democratic Front of the Philippines (NDFP)," the mayor said.

No preconditions

Sarah made her appeal as Mr. Duterte on Friday denied that he had set preconditions for the resumption of the peace talks with the NDFP.

What he actually laid down were the aspects that could help get the talks back on track in two months' time, he said.

"It's not a condition, it's a timeline," the President said. "I will give my demands and they can also have theirs, and that is where we start negotiating."

But he said he wanted the insurgents to agree to a total ceasefire first. "There has to be a ceasefire. Not a single shot fired," he added.

Sara said the insurgency could only end if the NDFP, the Communist Party of the Philippines and its armed wing, New People's Army (NPA), would "reciprocate the gesture [to revive the talks] offered by the government."

The 49-year-old Maoist rebellion has claimed over 40,000 lives and stunted progress in the countryside.

'Peace not an option'

But Sara said there were no indications that the rebels were willing to talk peacefully.

"These are groups motivated by the desire to overthrow the government and rule the nation. For them, peace is not an option. And that's because they are terrorists," the mayor said.

The younger Duterte, an Army Reserve colonel, said there should be no negotiation with terrorists.

"Deal with them in the way we should—tough, strong, high-intensity and one that gathers all sectors to completely crush their influence in communities where they are present," Sara said.—FRINSTON LIMAND ALLAN NAWAL INQ

Mayor Sara says 'no' to resumption of peace talks

AVAO CITY — City Mayor Sara Duterte-Carpio urged her father President Rodrigo Roa Duterte to reconsider his decision to reopen stalled peace negotiations with the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF) because "there are no indications at all that they are willing to negotiate for a peaceful resolution of the conflict."

In a statement issued on Friday, Carpio said the insurgency problem in the country will end only if the Communists and their armed wing, New People's Army (NPA), show that they will be sincere, honest, and committed to reciprocate the gesture of peace and reconciliation offered by the government.

"Just like a battered lover, there is a time to finally say no to pain and suffering. No to peace talks," she said. Carpio maintained that the government should "be tough, strong, (and with) high intensity" in dealing with the Communists, while gathering all sectors to completely crush the insurgents' influence in communities where they are present.

Carpio added that the Communist movement could not be trusted "as they have consistently shown us their deep-seated proclivity to sow hate, violence and extremism, destruction, and senseless killings, (while being) motivated by the desire to rule the nation by overthrowing the government."

The presidential daughter, who was elected mayor for the second time in 2016 after serving as the city's local chief executive from 2010 until 2013 and vice mayor from 2007 to 2010, cited the recent atrocities committed by the NPA in the city and surrounding province.

She blamed the Communist guerrillas for the death of Larry Buenafe, a fish vendor who died due to the landmine plated and set off by NPA members when they burned the Lorenzo-owned box plant in Mandug on April 29, 2017.

"Let us not forget Larry's two very young children now growing without a father — and the many other prphaned children of other hapless, mostly poor civilians. Let us not forget the orphaned children of our brave soldiers and police officers killed by the NPAs in the name of a rusty ideology and deranged revolution," she said.

Carpio also cited infant Walysha Manchorao, who died in an NPA ambush on a police patrol car in Bukidnon in November 2017. Her death prompted the President to cancel the fifth round of talks on November 25 to 27, 2017 with the issuance of Proclamation 360.

The President subsequently issued Proclamation 374 designating the CPP and the NPA as terrorist organizations.

Sara Duterte rejec talks with Reds

AMBOANGA CITY: Davão City Mayor Sara Duterte appealed on Friday Ato his father, President Rodrigo Duterte, not to reopen stalled peace talks with communist insurgents responsible for many attacks in her hometown.

The President, who previously cancelled the peace talks with rebels following deadly attacks in the restive region, has revived negotiations in an effort to put an end to bloodshed to the world's

longest-running insurgency.

The New People's Army (NPA), armed wing of the Communist Party of the Philippines, has been waging decades of bloody separatist war. It demanded a coalition

government from Duterte, who flatly rejected the idea.

DND: No confirmation yet on signal jammers in WPS

The Department of National Defense (DND) is yet to confirm the reported installation of signal jammers by China on at least two of its occupied territories in the disputed West Philippine Sea as reported in the United States.

At the same time, Defense Secretary Delfin Lorenzana said that the DND has not received any formal report coming from the United States regarding the matter.

"None has been confirmed by us. All reports have been coming from the US and we have not received any formal communications to that effect," Lorenzana said.

Lorenzana said that on the part of the Armed Forces of the Philippines (AFP), it has not reported any jamming incident

during regular patrols in the West Philippine Sea.

"So far our regular patrols in the WPS have not reported any incidence of jamming. We will confirm using our resources if there really are jammers and if so what kind: to disrupt communications or disrupt weapons systems," Lorenzana said.

According to Lorenzana, signal jammers are very easy to install, depending on the purpose.

"There are small types for vehicles that can be used to jam communications. There are the sophisticated ones like for weapons systems which are bigger and installed on buildings and ships," Lorenzana said.

Lorenzana admitted that Philippine authorities could not do anything, if China indeed installed signal jammers.

"Can we stop China from installing jammers on its reclaimed islands? We did not even stop them when they started reclaiming," he said.

Earlier this week, the Wall Street Journal released a satellite photo showing suspected communications and radar jamming equipment on Mischief Reef, the largest of the seven areas occupied by China in the disputed West Philippine Sea.

The reef is located within the 200-nautical mile exclusive economic zone of the Philippines.

Wall Street Journal quoted US Department of Defense in reporting the jamming equipment were deployed in the past 90 days in Fiery Cross and Mischief Reefs.

The report stated that the move was seen to enforce China's claims and a step further in its militarization of the West Philippine Sea or South China Sea.


"I suspect that the US Navy ships discovered the jamming signals," Lorenzana said.

US warships, including aircraft carriers; are conducting routine patrols along international waters in the West Philippine Sea.

Akizuki-class destroyer on 3-day visit; Japan's 1st female commander in town

The Japanese Akizuki-class Destroyer arrived in Subic Bay yesterday for a three-day goodwill visit in the country with about 200 officers and crew, among them Japan's first-ever female commander of a warship squadron.

The Japan Maritime Self-Defense Force (JMSDF) vessel "JS Akizuki" (DD-115), a guided missile destroyer with one SH-60J helicopter, docked at the Alava Wharf – making it the second visit of a JMSDF ship in the country this year after "JS Amagiri" in Manila

last February.

Captain Lued L. Lincuna, Philippine Naval Public Affairs director, said the "BRP Emilio Jacinto" (PS-35) rendered customary meeting procedures in the vicinity of Morong, Bataan and escorted the vessels to its designated anchorage area.

Philippine Navy delegates headed by the representative of the Flag-Officer-in-Command, Captain Francis Alexandrer R. Jose, accorded the visiting navy a welcome ceremony upon arrival followed by a port briefing related to health and security aboard JS Akizuki.

Many eyes were on Captain Ryoko Azuma, commander of JMSDF's Escort Division One and the first female to command a warship squadron.

Azuma, along with Commander Kazunori Ishii, commanding officer of JS Akizuki, will call on the Commander of the Naval Education and Training Command (NETC), Rear Admiral Allan Ferdinand V. Cusi in San Antonio, Zambales.

Since her appointment Mar. 8, 2018, Azuma will command four ships and a combined crew of 1,000 which make up the First Escort Service in JMSDF, the naval branch of Japan's Self-Defense Forces (SDF).

Azuma said that Japanese Navy will engage in a series of confidence building activities with their Philippine Navy (PN) counterparts such as goodwill games followed by a boodle fight.

She said that the visit aims to strengthen the relationship between the two navies.

A 'dirty and brutal war'



nder martial law extended till the end of 2018 in the whole of Mindanao, the Duterte government has unleashed "a dirty and brutal war" against communities of farmers and indigenous peoples/national minorities aimed at "instilling fear and terror and silencing their long struggle for land,[human] rights, and justice.

The continuing extrajudicial killings (EJKs) have claimed the lives of more than a hundred farmers, many of whom are leaders or members of peasant organizations, "in active campaigns for their right to till, and against massive landgrabbing and exploitative ventures of foreign large-scale mining, plantation expansion, and energy extraction." The farmers' struggles go hand-in-hand with the national minorities' assertion off their right to self-determination, which have either been denied or undermined by a succession of administrations.

Besides EJKs, other human rights violations, including the filing of trumped-up criminal charges, faked or forced surrender, forced evacuation, and various form of threat, harassment and intimidation (denoted by human rights defenders as THI) have been also duly documented.

Commendably, the peasant and IP communities continue to confront the state's dirty and brutal war through their collective actions and organized

The above conditions sum up the findings of an International Fact-Finding and Solidarity Mission (to Defend Filipino Peasants' Land and Human Rights Against Militarism and Plunder in Mindanao), in which I was invited to participate on April 6-9. Three groups – each assigned to Caraga, Northern Mindanao, and Southern Mindanao regions - conducted on-site visits of communities, held focused went to Caraga.



In its draft overall report, the IFFSM cites these additional findings:

 The AFP and PNP use old and new tactics of sowing fear and dangling lucrative offers to discourage the farmers from asserting their rights.

"A dubious campaign of forced surrender of thousands of people, mostly poor communities of farmers," the report says, "deceives the general public into believing they are 'winning the war." But on the ground, it adds, "the reality paints a bleak picture of farmers who are not simply displaced from the land they till, but are also herded to be used and tagged as 'surrenderees,' put in detention, forced to report daily to military detachments; and live in constant fear and threats to their lives and security."

I intently listened to several testimonies among the 59 victims and their relatives who managed to meet with the IFFSM in Caraga, straining to understand their narratives (in Bisaya/Cebuano) aided by their body language. Later, aboard a van on their way home to Surigao, 15 of them were stopped at a checkpoint. Soldiers directed them to list down their names and addresses in a logbook, took a photo of each one, and seized the van driver's license before they were allowed to go.

 Observations on the EJKs: 1) Most of the victims were engaged in local peasant struggles, such as land cultivation, resisting landgrabbing, asserting the IP's right over ancestral lands and territories, and campaigns to improve their living conditions; 2) the victims were attacked in or near their homes and communities

and in the presence of family members and neighbors; 3) some were slain in their farms; 4) the killings were carried out by masked men in tandem, some of whom were identified as known "assets" of operating military units; and 5) the victims had been tagged or accused by AFP soldiers as members or supporters of the NPA.

The killing of 23-year-old farmer Aaron Notarte in Barangay Manat, Agusan del Sur, is notable for its brutality. Intercepting him enroute to his family's coffee farm, soldiers aimed their guns at him and ordered him to admit he was a NPA member. Failing to get an admission after their repeated demand, the soldiers pounded his back with their rifle butts, cut off two of his fingers, then ordered him to run and shot him dead. A few days later, the military reported that Notarte was among the NPA rebels killed in an armed encounter on Jan. 13, 2018.

 Military campaigns in the communities have become not only a deceptive maneuver but a money-making and extortion scheme. Also civilian agencies and local government units have been used as auxiliaries in combat operations and in the counterinsurgency drive called Community Operations for Peace and Development (COPD).

In Caraga, for instance, our group uncovered a modus operandi that has enabled inilitary officers or personnel to access and take the reward money offered by the government to alleged NPA surrenderees, or to extort money from farmers who had acceded or succumbed to military pressure to claim they were NPA fighters and "surrendered" - thus victimizing the farmers twice.

rights violations. I was with the group that Purpose: Serving the people. Securing the land.

In one province, where farmers accused of being rebels are assigned a PAO (Public Attorney's Office) lawyer, our group came across a case where the PAO lawyer allegedly demanded from the family of an arrested farmer a large sum of money to facilitate the dismissal of the trumpedup charge and the farmer's release. Two provincial prosecutors, whom our group's lawyer and his paralegal team had interviewed, revealed the questionable practices of a judge and certain prosecutors that violate due process. The judge routinely issued search warrants of doubtful basis and validity, while the prosecutors hurriedly filed trumped-up charges in court, simply because the respondents (who may not have received the court summons) failed to submit controverting evidence to the spurious charges.

The three-day fact-finding mission was too short as to enable me to pin down with certainty the deeper rationale for this dirty and brutal war against unarmed farmers and their resistant communities. However, I may come close to it with this concise

analysis and conclusion:

Woodenheadedly, the AFP is targeting, via Oplan Kapayapaan, to defeat the NPA in Mindanao by the end of 2018, despite Defense Secretary Delfin Lorenzana saying it's an unrealistic target. Now, previous AFP chiefs have assessed the failures of their previous counterinsurgency operational plans. They came to realize that the NPA has survived the intensive and extensive attacks because the revolutionary forces have built up stable areas of support among the farming communities, which are also among the wellsprings for the sustained recruitment of new NPA fighters. Thus the AFP, belatedly and wrongfully, tries to apply the principle: nip the enemy in the bud.

34 rebs surrender as Army pushes offensives in Cotabato

ARAKAN, NORTH COTABATO—Thirty-four communist rebels surrendered to the military this week, ahead of the expected resumption of peace talks between the government and the National Democratic Front of the Philippines.

Lt. Col. Ehrlich Noel Paraso, commander of the Army's 19th Infantry Battalion, said this was the biggest number of New People's Army (NPA) rebels to surrender in the town, although only two of them had turned over their firearms.

Lorenzana said jammers come in small and large sizes which could be used to jam communications, while the more sophisticated ones could be utilized to disrupt weapon systems.

Some jammers could also be fitted in buildings and ships, he added.

"It could be turned on or off depending on the mission. Even if you have a sensor you will not know if it's not turned on," he said in Filipino.

"I suspect the US Navy ships received the jamming signals. What's the purpose of China's jammers? Because they know US Navy ships are armed," he added. *(PNA)*

Alert status intensified after BIFF harassment in Maguindanao

SHARIFF AGUAK, Maguindanao - Soldiers and police in Maguindanao's second district were placed on heightened alert Thursday after members of the outlawed Bangsamoro Islamic Freedom Fighters (BIFF) harassed military detachments and set off a roadside bomb that injured a soldier.

Speaking for the military-led Task Force Central, Lt. Col. Gerry Besana, said the bomb went off in Barangay Poblacion Talayan at about 6:30 p.m. Wednesday as a convoy of M35 military trucks was passing by the area.

Pfc. Dennis de Jose of the Army's 6th Infantry Division (6ID) Signal Battalion was hurt in the bomb explosion.

Citing intelligence reports, Besana identified the suspects behind the bombing incident as followers of Abu Nasria, a BIFF sub-leader operating in the Talayan-Talitay area.

"It (bombing) was part of the BIFF's retaliatory attacks on government forces following the recent seizure of their high-powered guns and gun-making equipment," he said.

Major Gen. Arnel dela Vega, 6ID chief and Task Force Central commander, said the Army is expecting the Islamic State-linked BIFF to launch harassments and bombings "because we have disabled them" with the recovery of 18 high-powered guns following air and ground offensives on Wednesday.

Dela Vega also said that the BIFF factions of Kagui Karialan, Esmael Bongos and Abu Toraife have reunited and were holding a "kanduli" (thanksgiving) when the Army conducted an air and ground assault on their position.

At about 7:30 p.m. Wednesday, suspected BIFF fighters retaliated but failed to overrun the detachment of the Army's 57th Infantry Battalion (IB) in Barangay Pagatin, Shariff Saydona Mustapha, Maguindanao.

The Army reacted and a firefight ensued until the attackers, numbering about 15 heavily armed men, fled toward the marshland. No casualty was reported on both sides.

A day earlier, gunmen also harassed the 57th IB detachment in Barangay Labo-Labo, Datu Hofer, Maguindanao. (PNA)

ARSON INCIDENT | Communist Terrorist torched Banana Plantation in South Cotabato

TUPI, South Cotabato (DWDD) – Government troops are pursuing a band of some 20 armed men believed to be CPP-NPA terrorists (CNT) who partially burned a banana packing plant of Dole-Stanfilco at Barangay, Kalkam, Tupi, South Cotabato on April 12 I 2018.

The 27th Infantry "Action" Battalion under the 1002nd Infantry Brigade, 10th Infantry "Agila" Division based along the Gensan-Marbel Road in Brgy. Kablon, Tupi and the Tupi Municipal Police Station, PNP immediately responded to the arson attack together with the Tupi Municipal Fire Station of the Bureau of Fire Protection and the Tupi Rescue Team. The speedy response saved the production bodega from damage but not an estimated P500,000 worth of properties that were destroyed by the blaze.

Fortunately, however, no one was injured in the incident. While withdrawing about 9:45pm, the armed men, who are likely members of Platoon Roxas Range, Guerrilla Front 73, Far South Mindanao Operational Command, CPP-NPA, also disarmed a Barangay Tanod member of his service shotgun and handheld radio transceiver unit while rendering duty at the Barangay Tanod outpost in Sitio Sabuy, Barangay Lunen, some two kilometers from the beleguered packing plant.

According to witnesses, six of the armed men equipped with R4, Garand and M14 rifles, a shotgun and Caliber .45 pistols entered the packing plant about 7pm and introduced themselves as CPP-NPA members. The other armed men reportedly deployed themselves outside the compound. At gunpoint, the six armed men warned the guard-on-duty and six other workers present not to react against them as they only intend to burn the facility. Speaking in Hiligaynon (Ilonggo) dialect with heavy Blaan accent, the CNTs reportedly told them that they were imposing punitive action against Dole-Stanfilco due to its expansion activities that may drive them away and permanently displace. With three gallons of gasoline they brought with them, the CPP-NPA terrorists set on fire the packing plant and agribodega. The CNT band withdrew from the area around 7:40pm. The latest burning incident is believed to be the 80th arson attack nationwide, the 70th in Mindanao and the 64th in eastern Mindanao that were either claimed by or blamed against the NPA since President Duterte assumed office at noon on June 30, 2018. Similarly, it was presumed to be the 8th arson case nationwide this year that was attributed to the CNT. 27IB / MCAG

"The time was enough to continue some of the reforms when I took over and some of the initiatives I put in place, actually nandiyan nayan nakalatag na yan itutuloy na lang, we have the DSSP Kapayapaan and we all implement that, the term of CSAFP is not about the person, not about me, it's a team effort." Guerrero said

Meanwhile, Guerrero believes that professionalism is the AFP's key to attaining a very high public trust rating. The professionalism of our soldiers, the way the AFP handled the Marawi Crisis and the way we dealt with the problem of insurgency, especially with the CPP/NPA. Added to this was how the organization welcomed former rebels and making them feel that their Armed Forces always has an open-arm for those who wish to return to a peaceful life. This AFP showed its human side of the AFP, especially when they facilitated the meeting of almost 700 former rebels with the President Rodrigo Duterte.


When asked about his career after leaving the AFP and his possible new role as part of MARINA, Guerrero quipped that his leadership will still be the same although he will be implementing policy changes. He must also remember that he will soon be out of the AFP but he can use the experience in facing his new endeavor. But for now, Guerrero maintains that he is not yet thinking of his new pot in MARINA, since he is still the Chief of Staff of the AFP.

In regards his successor Lt Gen Carlito Galvez Jr., he believes in the capability of the gentleman, especially his leadership and being an effective peace negotiator.


