



ORDER ONUM CHALLENGES EXPULSION ORDER

The Bureau of Immigration (BI) has ordered an elderly Australian nun who has angered President Duterte to leave the country in 30 days.

In a one-page order issued on Monday, the BI revoked Sister Patricia Fox's missionary visa before it was to expire on Sept. 5. It also directed the deactivation of her alien certificate of registration.

"She was found to have engaged in activities that are not allowed under the terms and conditions of her visa," Immigration Commissioner Jaime Morente said on Wednesday.

Fox, a 71-year-old missionary belonging to the Our Lady of Sion congregation, was detained for a day last week after Mr. Duterte ordered her investigated for "disorderly conduct."

Mr. Duterte harshly criticized

the nun for having a "shameful mouth" and warned that he would not tolerate foreign visitors insulting the Philippines, which he said was a violation of the country's sovereignty.

"You come here and insult us, you trample with our sovereignty. That will never happen," he said. "I assure you, if you begin to malign, defame [the] government in any of those rallies there, I will order your arrest."

Fox's lawyer, Jobert Pahilga, said he would ask immigration authorities to reconsider their decision although it appeared to have been made upon the President's orders.

"The President has spoken. We take it as his marching order for the BI to deport Sister Pat," Pahilga said.

He said he had not expected the BI move, as Fox was given until May 4 to file a counteraffidavit answering complaints that she violated immigration rules.

Pahilga said BI documents supposedly showed Fox had openly and actively participated in activities such as rallies, press 'conferences and fact-finding missions, which are alleged violations of her missionary visa, making her an undesirable alien.

"The charge that Sister Pat is an undesirable alien has no basis in fact and in law," Pahilga said.

He said she was not en-

gaged in antigovernment activities and all her actions had been-"consistent with her missionary work of promoting peace, social justice and human rights."

Surprise

In a statement, Fox said she was surprised at the order to expel her.

"I am very sad that the decision at present is that I leave the Philippines," she said, "I may lose my right to be in the Philippines but I can never lose the learnings and heautiful memories."

She said she had worked in the Philippines since 1990 with poor farmers and tribal people in the rural areas, and with workers in urban centers where she had learned how they were impoverished.

As a Christian, she said, she had to get involved in projects to uplift their livelihood and also to push for their rights to land, peace, justice, security and human rights.

"It seems this is what has brought me into conflict with the Philippine government. I am still hoping for a chance to explain how I see my mission as a religious sister and maybe the decision can be reconsidered," she said. (See Fox's full statement on this page)

Opposition solons

Opposition lawmakers condemned the BI order:

"Harassing human rights advocates and faith-based organizations and individuals may succeed in the short run but it will eventually fail," Sen. Francis Pangilinan said in a state-

ment, adding that the Duterte administration was acting like Hitler's Gestapo

Tolerance lost ».

Sen. Bam Aquino said he would seek a Senate probe of the order, which he said was a clear harassment of people who fight abuses.

Bayan Muna Rep. Carlos Isagani Zarate said the BI action showed the Philippines "had lost the tolerance" for the missionary's exercise of her freedom.

"What was the government afraid of?" he asked.

Reacting to the BI decision, Senate Majority Leader Vicente Sotto III said, "Durg lex sed lex (the law may be harsh, but it is the law),"

"If that's the law, no one is above the law," Sotto said.

Equal protection clause

Sen. Francis Escudero called the BI order "unfortunate" but said the grant, denial or withdrawal of a visa was "discretionary on the part of any country,"

Sen. Panfilo Lacson said the equal protection clause in the

Constitution did not distinguish between foreigners and citizens of the Philippines.

Limitations

The executive branch, however, could impose limitations on certain activities of foreigners that are against the interest of the state "and that is what the government has applied in the case of Sister Patricia Fox," he said.

Lacson said Filipinos should back the BI move if allegations against Fox were proven true.

Manila Auxiliary Bishop

Broderick Pabillo said the expulsion order gave no consideration to the nun's nearly three decades of service to the Filipino people, especially the poor."

"This is very sad, All the good Sister Pat has done to help the underprivileged, which the government has not been able to serve, is glossed over and not even appreciated while the insecurity of the present government is given weight," Pabillo said.

Army to spend P215 M for combat equipment

The Philippine Army is spending P215.6 million to acquire new equipment for its soldiers and personnel, including 73,130 pairs of combat boots worth P115.5 million, an official said yesterday.

Maj. Gen. Joselito Reyes, who chairs the Army bids and awards committee, said they started the procurement process through an invitation to bid to prospective suppliers.

Included in the shopping list are 17,763 pairs of rubber shoes worth P35.5 million; 90,634 roundneck shirts amounting to P15.8 million; 17,706 Army uniforms for P9.7 million; 3,576 pieces of combat chest rig for P5.7 million, and 8,032 hydration packs for P12.8 million.

Reyes said the Army would also purchase 9,487 camouflage uniforms amounting to P11.3 million, 49,051 white socks for P4.4 million, and 25,632 belts worth P4.6 million.

Army spokesman Lt. Col. Louie Villanueva said the supplies are important in the performance of the soldiers' duties.

The Army, the biggest unit of the Armed Forces of the Philippines, has around 85,000 soldiers in various parts of the country.

Army purchasing P215M supplies

THE Philippine Army is acquiring P215.62 million worth of assorted supplies, including combat boots, for the use of its personnel, numbering around 80,000 men and women.

The procurement of the items is being done through public bidding, supervised by the office of the Army's Bids and Awards Committee.

The items being acquired include 73,706 pairs of combat boots worth P115.54 million; and 17,763 pairs of rubber shoes worth P35.52 million.

The other supplies are 17,706

athletic uniform (P9.73 million); 3,576 combat chest rig (P5.72 million); 8,032 hydration pack (P12.85 million); 9,487 jungle pack (P11.38 million); 49,051 athletic socks (P4.41 million); 25,632 tactical belts (P4.61 million), and 90,634 T-shirts (P15.86 million).


The Army regularly provides its personnel with such supplies, including the combat boots, which Army spokesman Col. Louie Villanueva said are crucial in the accomplishment of the Army's mission.

"Combat boots are very important to us because without them, our soldiers — esnecially our ground forces – cannot accomplish their mission. It's an essential clothing equipment of our soldiers," said Villanueva.

Villanueva said combat boots are usually worn out after six months to one year of use in the field, depending on the terrain where they are being used.

Army soldiers are in the forefront in the fight against various security threats, including the communist New People's Army; and the terrorist groups Abu Sayyaf, Maute Group and Bangsamoro Islamic Freedom Fighters. – Victor Reyes

800 loose guns recovered in Maguindanao

MAGUINDANAO —
More than 100 unlicensed firearms were recovered in Maguindanao on Tuesday.
Local officials in Datu Anggal Midtimbang, Talayan, Guindulungan, Datu Saudi and Pandag towns surrendered the guns to personnel of the 6th Infantry Division and Autonomous Region in Muslim Mindanao (ARMM) police.

At least 800 loose firearms


seized in this province were presented to President Duterte during his visit to Buluan yesterday.

Khadafeh Mangudadatu of the ARMM legislative assembly and his wife, Zihan, the mayor of Pandag town, were among those who surrendered their unlicensed guns. They turned over a 30-caliber machine gun and several rifles.

Maguindanao Gov. Esmael Mangudadatu and his brothers, Zajid and Freddie, congressman and mayor of Mangudadatu town, respectively, had earlier surrendered their loose firearms.

Mangudadatu said the mayors in the province were also set to meet with Duterte.

"I will report to President Duterte that we support the Balik-Baril program... The provincial peace and order council will implement it as a regular government program," Mangudadatu said.



Boy killed by soldiers no 'child soldier,' Reds claim

The Communist Party of the Philippines (CPP) has accused the military of killing a 15-year-old boy who, the insurgents claimed, was mistaken for a New People's Army (NPA) fighter. In a statement posted on its website on Wednesday, the CPP claimed that the boy, Rondi Ondo, was killed on April 21 in Barangay Astorga in Sta. Cruz, Dayao del Sur, while he was gathering coconuts in the company of his uncle and a cousin. It said that soldiers "fired upon them, mistaking them for NPA fighters." The insurgents took exception to a statement by Brig. Gen. Roberto Ancan, commander of the Army's 102nd Brigade, branding Ondo as a "child soldier" to "cover up their crime." But in a phone interview, Ancan claimed that Ondo was actually a resident of Sitio Tombo, Barangay Old Bulatukan, Makilala, North Cotabato. "Why was he there in the encounter site (Sta. Cruz)? How did he get to Sta. Cruz? That's the question," Ancan said. An M16 rifle was recovered next to the boy's body, he added. —JEANNETTE I. ANDRADE


Macdonald Domingo was pronounced dead on arrival in a hospital in this city where Pfc. Feliciano Tattao was also taken for treatment.

AFP vetting Negros barangay bets

BACOLOD CITY - Background checks on candidates for the barangay and Sangguniang Kabataan (SK) elections in Negros Occidental are being conducted amid reports that some of them have links with the New People's Army (NPA), a military official said yesterday.

Capt. Emil Charlie Jaudian, 303rd Infantry Brigade (IB) Civil Military Operations chief, said they expect to complete the profiling of candidates before the start of the campaign period on May 4.

A total of 23,548 persons filed their certificates of candi-

dacy for the barangay and SKelections in Negros Occidental.

The military said 93 of 662 barangays in the province are infiltrated by communist rebels. Sixty-two of these barangays are likely to be declared election hotspots.


Police said the three were riding a motorcycle when one of them fired shots in Barangay Sta. Cruz.

Security guard Henry Palafox, 46, who was wearing civilian clothes, was arrested for holding a shotgun in front of an automotive store in Barangay Centro East, Santiago, Isabela. He failed to show any document when accosted by Senior Superintendent Cornelio Comila of the regional civil security unit.

In Bulacan, Rodrigo Rodriguez, chairman of Barangay Mabalasbalas in San Rafael town, was gunned down by motorcycle-riding men while buying rice also on Tuesday.

DFA studying move on China monument

Malacañang has opted to say little for now about China's recent activities in the South China Sea, including its erection of a monument on Kagitingan Reef and landing military planes on another reef within the Philippines' territory in the strategic waterway.

Presidential spokesperson Harry Roque said in a television interview on Wednesday that the Department of Foreign Affairs was studying diplomatic actions it could take regarding China's construction of the monument and its landing of Xian Y-7 military transport planes on Panganiban Reef, which is located within the Philippines' 370-kilometer exclusive economic zone (EEZ) in the South China Seaknown as West Philippine Sea.

PH reef

Panganiban Reef is internationally known as Mischief Reef, which the UN-backed Permanent Court of Arbitration in The Hague ruled in July 2016 was within the Philippines' EEZ and part of the country's continental shelf.

Roque said not all of the government's actions on these matters could be made public.

"You know, in the field of diplomacy, not all actions can be announced. But I'd like to assure the public that the President is being apprised of the steps being taken by the Department of Foreign Affairs," Roque said.

Lawmakers and legal experts have been calling on the Duterte administration to protest China's landing of military transport planes on Panganiban Reef in January.

They say the landings were not just an affront to Philippine sovereignty but could be a precursor to the deployment of long-range bombers and fighter aircraft to the reefs in the Spratly archipelago that China has transformed into artificial islands.

China claims nearly all of the 3.5-million-square-kilometer South China Sea, but the arbitral court in The Hague, ruling in the challenge brought by the Philippines, declared Beijing's claim invalid and pronounced it in violation of Manila's sovereign right to fish and explore for resources in waters within its EEZ.

China, however, has ignored the ruling and proceeded to build artificial islands on reefs claimed by its rivals in the Spratly archipelago.

Message of determination

In a brief report on Monday, the People's Liberation Army Daily said China had unveiled a monument to mark its construction work on Kagitingan Reef.

The monument sends a message about China's determination to protect its territory and maritime rights in the South China Sea, the report said. —WITH A REPORT FROM REUTERS INQ

CPP: Slain boy not an NPA member

THE Communist Party of the Philippines yesterday said the 15-year-old boy slain by government troops in a firefight on Saturday in Sta. Cruz town in Davao del Sur was not a member of the New People's Army rebel, contrary to the military's pronouncement,

But Brig. Gen. Roberto Ancan, commander of the Army's 1002nd Brigade, maintained that the boy, Rondi Ondo, was an NPA rebel and was seen firing his weapon during the fire

fight with other insurgents.

In statement, the CPP said Ondo was collecting coconuts with his uncle and a cousin when soldiers opened fire at them after "mistaking them for NPA fighters."

The CPP said Rondi's mother, Marissa, also denied he was an NPA member.

"The AFP's fake news mill is daily churning out increasingly incredulous lies in the mass media to fool the people. This incident of child killing adds to the growing list of atrocities committed by the AFP against the peasant masses...," it added.

Ancan said the CPP's claim is "baseless" and said the NPA is "employing child warriors."

Ancan laughed at the CPP claim that the boy was collecting coconuts in Sta. Cruz town. He said the boy was a resident of Makilala town in North Cotabato.

"The question is why was he, a 15-year-old, in the area when he is from Makilala?" said Ancan. He said the boy was seen by the operating troops firing his weapon during the firefight.


"I think there is no need for

us to elaborate further. He was there in the encounter site. He is not from that place. What was he doing there? Why will he gather coconuts in (Sta. Cruz) when that's too far from Makilala?" Ancan added.

Ancan also said the military has information that the boy's father was also an NPA rebel. As to the boy's mother, the Army official said he is not certain if she is also affiliated with the communist movement.

Also killed in the encounter was Julito Pueblas, 62, head of the NPA's Guerilla Front 51.

Jalandoni, Ocampo expect agreements within 60 days The communist-led National Democratic Front of the Philippines (NDFP) has expressed hopes that peace talks with the government could resume within the 60-day window offered by President Duterte. In an interview during the "Pilgrims for Peace" forum on the University of the Philippines campus in Diliman, Quezon City, NDFP senior adviser Luis Jalandoni said the organization believed "agreements for peace negotiations" could be settled within two months. He cited a possible deal on the Comprehensive Agreement for Socio-Economic Reforms, which includes provisions on rural development and national industrialization. Satur Ocampo, NDFP consultant and cofounder, said he expected agreements on a ceasefire, amnesty for the NDFP peace panelists, and the Comprehensive Agreement on Respect for Human Rights and International Humanitarian Lawin 60 days Jalandoni however, said the talks should be held in "neutral formal yenue for ... the security of the participants." - JAYMEE T. Include cultural mapping in Marawi rehab—NCCA

AVAO CITY—The Mindan-ao State University (MSU) in Marawi City and the Autonomous Region in Muslim Mindanao (ARMM) have requested for a cultural mapping of this city by the scenic Lake Lanao, the identification of existing or damaged cultural sites of which may be incorporated in the rehabilitation of the city.

Augustinian priest Harold Ll. Rentoria, commissioner for cultural heritage of the National Commission for Culture and the Arts (NCCA). said the MSU main campus and the ARMM Bureau of Cultural Heritage recently approached him to conduct the cultural mapping of the city, saying that this may helped restore heritage sites that were destroyed during the May-October 2017 battle against Islamic State of Iraq and Syria-linked terrorists

Rentoria said the mapping would be conducted soon to catch up also with the drawing up of the comprehensive planto reconstruct and rebabilitate the city of 200,000 residents. Manyofthesepeoplearestillstaying in temporary shelters, evacuation centers and homes of relatives across Lanao del Surand surrounding citjes of Iligan and Cotabato.

The target of the mapping are heritage sites, commonly those structures not less than 50 years old, "which are either old houses and buildings, churches and mosques and other culturally shared structures."

"The heritage sites are either recognized and respected by the locales, or they were ignored or taken for granted by local residences," Rentoria said. The NCCA has done random mapping of places across the country and has known of the existences of centuries-old structures as also being noted by local governments in their notes of requests for mapping by the NCCA.

"There are also mosques and

churches in the Moro areas that needed mapping," Rentoria added. In the case of Marawi City, the cultural man would hope to catch up with the rehabilitation plan.

"But we would also like to know from the Task Force Bangon Marawi on which kind of rehabilitation works would be applied: Is it the entire city or the part of the city that was destroyed by the siege."


Rentoria said he would officially sit in the board of directors of the Task Force Bangon Marawi soon.

So far, he added, it would not be difficult to persuade rehabilitation bodies to include rehabilitation of heritage sites, saying that it was done in many previous reconstructions of places. The cultural mapping was earlier requested by the Marawi City government in 2016, and the NCCA met with them in 2017.

The same request was also sent by the governor of Maguindanao last year, but the siege in Marawi City has affected the security situation in the province also, which forced the mapping to be suspended, he said.

Now, the province would also like to proceed with the mapping. Manuel T. Cayon





Peace talks within 60 days?

N response to continuing calls for the revival of the peace talks with the Communist Party of the Philippines (CPP) and New People's Army (NPA), President Duterte last weekend called on CPP Founding Chairman Jose Ma. Sison to return home to the Philippines and resume the peace negotiations within 60 days,

The peace talks had begun right after the start of the President's administration in 2016, with talks in Oslo, Norway, and Rome, Italy, but they broke down last February over the NPA's call for the release of detained political prisoners, continued fighting on the ground despite the ongoing peace talks, and the absence of a bilateral ceasefire agreement.

Last Saturday, in response to an appeal made by some 60 lawmakers represented by the Makabayan bloc in the House of Representatives. President Duterte called on Sison, who lives in the Netherlands, to return home to the Philippines and resume the peace talks within 60 days. The talks should be held here, he stressed. "I will not go there. We're fighting for the Philippines, so you come here."

Despite our continuing hopes for a resumption of the talks and an ultimate peace agreement to end the 49-year-old rebellion, we have to admit that no talks are likely to be held under these conditions. Sison has lived in the Netherlands since 1986 – 32 years ago – and it is not likely that he feels any safer today than in all the previous years under previous administrations.


Earlier, during the talks in Europe, Sison had stressed that he cannot order the NPA around as its commanders can make decisions based on conditions on the ground. More recently, in his word war with President, Sison backed down from his boast that the NPA could kill one solckier a day. "I have always made it clear that I am not in any position to issue any kind of order to the Communist Party of the Philippines and the New People's Army," he said.

The NPA remains a nebulous enemy to the state, vague and indistinct in its organization and intentions. Sison, founding chairman of the CPP, could be of great help in any peace talks but the government may have to seek out the present party leadership and reach out to the ground commanders.

In his latest statement sent through his Facebook website last Monday, Sison declared he would return home "when a significant advance in the peace negotiations has been achieved within the framework of the Hague Joint Declaration and when my comrades and lawyers are satisfied with legal and security precautions."

He obviously has no intention of coming home to resume the peace negotiations. He will return only when "significant advance" has been achieved, while President Duterte wants him to come home to resume the talks. With such disparate statements, we cannot have much hope that the peace talks will be able to resume in 60 days.



NEW BATAAN, Compostela Valley Province (DWDD) – The 66th Infantry "Kabalikat" Battalion continues to press on its operations against the numerous Guerilla Front it has been confronting. Guerilla Front 25 (GF25) is now downgraded to just a Section Committee as majority of the fighters have surrendered to the Kabalikat Battalion. 23 members of GF25 are now under the care of the 66IB.

On April 15-2018, Sunday, the operating troops led by Captain Ricky Dioneda acted on the revelation of @Ganggang, a former political instructor of GF25, Sub-regional Committee 1, Southern Mindanao Regional Committee, about a cache of firearms and other war materiel in vicinity Kalaberahan, Sitio Puting Bato, Baranggay Ngan, Compostela Valley Province.

The operation resulted to the capture of the following: 1 Caliber 7.62 M14 rifle with 1 magazine full of ammunition, 1 Caliber 30 M1 Carbine with magazine loaded with 20 rounds ammunition, 1 magazine of M16 with 5.56 mm rounds, 4 cliploads ammunition of Garand rifle. As the situation progressed, on sameday at 5 in the afternoon, another cache was found. It was followed by the capture of 3 dual purpose improvised explosive devices measuring 26 cm in height, 71 cm in diameter and each weighing 15 kgs. They are antitank landmines.

On the following day, April 16, Lt Sonny Boy M Bueno acted on the revelation of Barangay Captain Henry Tabanao and conducted combat operations at vicinity purok Alimyon, Araibo, Pantukan town, CVP. The operation resulted to the capture of the following high powered firearms and other war materiel: 1 caliber 5.56 M4 carbine with a 20 capacity magazine full of ammunition and 1 caliber 7.62 M14 Rifle with 5 fullmagazines of ammunition.







On April 19, @ Cesar, Squad Leader of Abe Primera unit, GF2, SRC2, SMRC who surrendered last March 2018, revealed about a firearms and IED cache. Cpt Ricky Dioneda led the operating troops to Stockfile, Sitio Bantuayan, Bgy Camanlangan, New Bataan, Compostela Valley Province and captured the following items which were left by the GF2 members as they withdrew after the encounter last March 31 2018: 1 caliber 5.56 M16A1 rifle with two magazines full of ammunition, 4 dual purpose IEDs (1 weighing 25 kgs, 3 weighing 15 kgs each), 4 magazines of M14 rifle full of ammunition, 1 bandolier and 1 backpack containing personal belongings.

"As a result of the influx of surrenderors from almost all confronted guerilla fronts of the 66IB, the enemy's strength continue to fall down in terms of personnel and war materiel. Morale among its members is so low, the citizenry withdrawn their funds and materials support and distrust has grown enormously within the groups. Most of the Guerilla Fronts are nearing extinction" LTC Palmer M Parungao said.

Mgen Noel S Clement, Commander of the 10th Agila Division lauded the troopers of the 66th Kabalikat Battalion for their accomplishments which continue to mount. After dismantling Guerilla Front 27, Guerilla Front 25 is now downgraded into a section committee as majority of its fighters have surrendered to 66lB and the recent capture of these war materials added to its downfall. 10DPAO / MCAG


