SATUR'S GROUP FREED; GOVT DIRTY WORK H

DAVAO CITY-Two days after being arrested in far-flung Talaingod, Davao del Norte provactivists, now called the "Talaingod 18," were released on Saturday night as their supporters denounced security forces for the "dirty work" used against them.

Lawyer Joel Mahinay of the Union of Peoples' Lawvers in Mindanao said he posted a bail bond for his clients, including the former Bayan Muna representative, amounting to P1.44 million.

Mahinay said Executive Judge Arlene Palabrica of the Tagum Regional Trial Court had to order the police to present the group before her twice, but the police did not comply until late Saturday night.

The group, which also includes ACT Rep. France Castro, was charged with kidnapping and trafficking of children from a "lumad" or indigenous people's school that earlier complained of being harassed by security forces.

The group's lawyers said the 18 activists were part of a 75member "solidarity mission" that only wanted to bring food ince, Satur Ocampo and other and other supplies to a jumad school in Barangay Palma Gil in Talaingod.

Police, military harassment

Officials of the school, one of two operated by Salugpongan Ta' Tanu Igkanogon Community Learning Center Inc., complained that they had been harassed by the military since June.

Lolita Muya, the school president, said soldiers of the Army's 56th Infantry Battalion even set up camp near their other campus in June, a charge the military denied.

Muya said that on Oct. 25. soldiers and members of the Alamara militia gave them a week to leave the school in

On Nov. 1, four Alamara men returned and threatened to kill the teachers if they didn t leave the place, prompting the teachers to flee to the Salugpongan school in Sitio Dulyan, Muva said.

But on Wednesday, Alamara militiamen also padlocked the school at Sitio Dulyan, prompting the lumad teachers to flee with their students in tow and seek help from the solidarity

When the group received the teachers' distress call, they decided to go to the school in a convoy of five vehicles to rescue the teachers and students. They were arrested on their way out of Talaingod.

Philippine National Police chief Director General Oscar Albayalde on Saturday tried to justify the operation and

claimed that the Salugpongan teachers had been teaching 5 their students a "different curriculum."

Albayalde said in a radio interview that the Talaingod 18 were arrested at a checkpoint.

Different anthem

"When we spoke with the lumad, they said they were being taught a different national anthem. They forced 14 minors to that school where they teach something different." Albayalde said, reiterating the military's claim that the school had been shut down.

For Communist Party of the Philippines (CPP) founder Jose Maria Sison, the police used the legal process "to persecute people. Make false charges, detain the victims and make them crawl through the reactionary legal processes."

He accused the Duterte administration of copying the Arroyo administration's controversial "Bantay Laya" strategy, which has been linked to extrajudicial killings. "The same tactic of legal offensive used under 'Oplan Bantay Laya' of Arroyo is being used under 'Oplan Kapayapaan' of Duterte," Sison said in an online interview from Utrecht in the Netherlands

"They started some time ago. They are going to accelerate their dirty work," he added.

Oplan Bantay Laya was the counterinsurgency strategy that the military adopted against the CPP and the New People's Army during the Arroyo administration.



Palace to Satur: Stop using arrest for propaganda

Detained former lawmaker Satur Ocampo and his comrades should stop using their arrest as another tool for propaganda against the government and should, instead, follow the rule of law that allows them due process, presidential spokesman Salvador Panelo said yesterday.

Following the arrest of Ocampo and his supporters, Panelo noted that serious charges have been filed against them for violating Republic Act 10364 or the Expanded Anti-Trafficking of Persons Act of 2012.

"Mr. Ocampo, together with all the accused, have been given 10 days to file their respective counter affidavits to refute the allegations against them, hence due process is being accorded them," he said.

Panelo, who is also the chief presidential

legal adviser, urged Ocampo and his supporters "to hold their horses."

"Rashly jumping to conclusions and engaging in a propaganda war not only is unproductive but an attempt to resort to trial by publicity against the government by those identified with the left," he opined

He told Ocampo that the rule of law must always prevail in a democracy, explaining that "there is no room for short cuts that impair the legal processes. Let the constitutional processes proceed without fear nor favor."

Ocampo, ACTS party-list Rep. France Castro and 17 others, who include four UCCP pastors, lumad school teachers and a school administrator, were charged with kidnapping and human trafficking over the transport of minors in Davao del Norte. They were in five vans when the military stopped them at

a checkpoint.

Meanwhile, the Commission on Human Rights (CHR) has sent a response team to monitor their detention in Davao del Norte and to ensure that due process is respected and their rights guaranteed.

"We in CHR will work closely with human rights organizations and lawyers' groups in affirming all the rights that Ka Satur, Cong. France and everyone else that are being charged in this absurd scenario," said CHR chair Chito Gascon.

Gascon criticized Ocampo's arrest and detention, saying the charges of child abuse and trafficking "boggles the mind" as the group was undertaking a humanitarian solidarity mission.

Provincial prosecutor Norman Solis found probable cause to indict the suspects for violations of Article VI Section 10(a) for allegedly engaging in conditions prejudicial to the

children's development under RA 7610 or the Special Protection of Children Against Abuse, Exploitation and Discrimination Act.

Bail was set at P80,000 each but the suspects agreed to be held in police custody until preliminary investigation on the kidnapping charges filed against them have been resolved.

Police claimed they conducted the operation after receiving a complaint that minors, aged 14 to 17 and mostly students of the closed Salugpungan school, were taken without permission from their parents.

Interior Secretary Eduardo Año lauded law enforcement agencies "for coming to the rescue" of the minors and arresting the suspected perpetrators

In the face of President Duterte's wish to form a death squad to go after Sparrow units of communist rebels, the head of the Philippine National Police (PNP) said the infamous hit squad is "long gone."

PNP chief Director General Oscar Albayalde said they have not monitored incidents involving these sparrow units of the New People's Army (NPA) for the past three years. Albayalde said they have tallied 136 killings allegedly perpetrated

"We have monitored those incidents but the Sparrow units of the NPA are no longer existing." he said

PNP CHEF: NO MORE NPA-SPARU HIT SQUAD

PHILIPPINE National Police chief Dir. Gen. Oscar Albayalde on Saturday said the infamous hit squad of the New People's Army, the Special Partisan Unit (SPARU), no longer exists.

The alleged presence of SPARU assassins prompted President Rodrigo Duterte to declare that he will form a death squad to counter that of the communist rebels

"Right now, we have not monitored (any SPARU presence). There have been instances in the past years and killings recorded, about 136. But we have monitored those and indeed, the SPARU has long ceased to exist." Albayaide said in arvinterview with dzBB.

On Tuesday, Duterte said he wanted to form a "Duterte Death Squad to counter SPARU members.

"I will create my own SPARU-Duterte Death Squad against the SPARU.I will match their talent also for assassmating people. They will have firearms for sure. That's my plan," the President said.

"They will do nothing but look for idlers who are prospective New People's Army members and take them out," Duterte added.

Albayaide said the President may have his own sources as to the presence of the hit squad of

the communist rebels. And
The PNP chief, however, clarified that the Palace has yet to make an official order on the proposed formation of the Duterte Death Squad.

"We are talking with the Armed Forces of the Philippines in anticipation of the order. We need to discuss the composition of such a a group—whether it will be from the military or the PNP"Albayalde said.

Duterte's proposal was immediately shot down by his own political ally, Senator Aquilino Pimentel III, president of the President's ruling party, PDP-Laban.

Intel prompted DDS idea – Albayalde

Duterte has his own sources of information on the activities of the communist rebels

President Rodrigo Duterte must have gotten compelling information that prompted him to seek the creation of a special operations group to go against the communist hit squad "Sparrow Unit," Philippine National Police chief Director General Oscar Albayalde said on Saturday.

On Tuesday, Duterte said he wanted to form a "Duterte Death Squad" that "will match the talent" of the New People's Army (NPA) "Sparrow Units."

However, Albayalde said based on their own intelligence monitoring, the Sparrow Unit has long been disbanded.

"So far we have not monitored anything (on the activities of a communist hit squad). While there were incidents of killings (linked to the communists) reported in the past three years, or 136, all of these were monitored (by our intelligence agents). However, our information indicates that the "Sparrow Unit" is long gone," Albayalde said in a radio interview.

Asked what compelled the President to make such an announcement, Albayalde said Duterte has his own sources of information on the activities of the communist rebels.

He noted that recent series of encounters of military and police personnel with the NPA, such as the Sagay massacre, may have prompted Duterte to give the order.

"The ambush in Bicol against the troops of the Armed Forces of the Philippines, the incident in Samar where the police station (was overrun by communist rebels)—these developments probably served as the trigger that prompted the President to make such a decision.

Albayalde clarified that so far, they have not received

any official directive from Malacañang on the formation of a "Duferte Death Squad."

"We are already talking to the AFP to discuss what to do if the President pursues the idea. We have to discuss how to form such a group and if it would be composed exclusively of soldiers or of policemen," Albayalde said

Defense Secretary Delfin Lorenzana backed Duterte's plan.

However, Malacañang was quick to clarify on Friday that Duterte was just "bringing an idea" when he spoke about creating a "death squad" to hunt down the NPA insurgents, according to presidential spokesman Salvador Panelo

He said one of the ideas being floated

was to include NPA rebel surrenders in the "anti-Sparrow" teams as they could easily identify their

former comrades.

On Wednesday, Defense Secretary Delfin Lorenzana backed Duterte's plan to create a death squad unit but he said it should be composed of soldiers who must be properly trained and should not be allowed to fire at will.

Panelo said while Duterte was serious about the plan, details about its possible implementation would still have to be threshed out by the Department of National Defense.

NPA hit squad long gone, says Albayalde

Police intelligence units have not monitored the presence of the infamous hit squad of the New People's Army in any part of the country for several years, Director General Oscar Albayalde, chief of the Philippine National Police, said yesterday.

But Albayaide said President Duterte may have his own sources with regards to the continuous operations of the NPA Special Partisan Units, also known as "Sparrow Unit," especially in areas where the communist rebels usually operate.

What they know and were able to validate, according to Albayalde, were 136 deaths being attributed to the attacks of the communist rebels in some parts of the country in the past three years.

"We have not monitored the presence of the SPARU units for a long time although there were killings recorded in the past three years," said Albayaide in an interview over dzBB.

The SPARU gained notoriety in the 1980s for assassinations of soldiers, policernen, politicians, and businessmen whom the rebels accused of corruption and other wrongdoings. It was during the 1980s when the strength of the NPA peaked at more than 25,000.

But SPARUs began to fade away over the years as government forces have intensified its operations against the communist rebels. Based on the latest assessment, the strength of the NPA is estimated at more or less 4,000.

The discussion about SPARU was revived after Duterte threatened to create his own liquidation squad to match what he called SPARU unit operations.

While stating that the SPARU has long been gone, Albayalde said Duterte might have been angered by the

series of attacks of the communist rebels even in the middle of the peace negotiations. Those attacks prompted Duterte to cancel the peace talks.

The chief PNP mentioned the death of three policemen in an ambush in Camarines Sur in October, the attack on police station in Samar, and the death of nine farmers in Negros Occidental.

"This might have triggered the President to issue such statement," said Albayalde.

So far, Albayalde said they have not received any order from Malacanang about the formation of hit squads against the communist rebels in the police organization.

"We have not received any directive. We have been talking with the Armed Forces of the Philippines that if in case that pushes through, we need to discuss how it would be formed," said Albayalde.

Defense Secretary Delfin Lorenzana was quoted as saying that he in favor of the President's proposal provided that those who would compose the hit squads are soldiers in order to ensure accountability for any mistakes or abuses. (Aaron Recuenco)

CAMP SIONGCO, Maguindanao (PNA) — Six Communist rebels belonging to the Guerilla Front 73 of the New People's Army (NPA) surrendered in the Sultan Kudarai town of Senator Ninoy Aguino on Friday, Army officials said.

Lt Col Harold Cabunoc, command er of the 33rd Infantry Battalion, said the six NPA surrenderers included a rebel leader named Ka Loloy, 50, a resident of Esperanza, Sultan Kudarat.

Cabunoc said the latest batch of NPA surrenderers indicated that the military and the local government of Senator Ninoy Aquino town "are winning the hearts of Communist rebels."

He said the rebels yielded "because they want to live normal lives."

Chief Supt. Marcelo Morales, director of the Southern Mindanao regional police, said notess than the parents of the children and the tribal leaders in Davao del Norte had confirmed the alleged indoctrination of the Ocampogroup.

"There were reports that the children were taught with false ideals at school, far from the mandates of the Department of Education. Also allegedly, these group are using the children to be with them to rally against the government," said Morales.

The lumads have been at the center of the clash between the government and communist rebels in the eastern part of Mindanao. Both the government and the

NPA have been trading accusations over the death of tribal leaders and other tribal members over the years

Intelligence officials claim the lumad tribes in Davao and CARAGA regions have been the hotbed of rebel recruitment over the years-the reason why the NPA is strong in the eastern part of Mindanao

Different story

As an anti-insurgency strategy in the past, some lumads were allegedly formed into paramilitary groups to fight recruitment and spread of communist insurgency in their ancestral lands.

This allegedly resulted in the death of

lumad tribal leaders and some members over the years.

Ocampo, ACT partylist Rep France Castro and 16 others were charged in connection with the alleged abduction of lumad children on Thursday night in Dayao del Norte.

The group of Ocampo was apprehended by police and military forces in a checkpoint. With them were lumad children, reportedly students of Salugpungan School in Talaingod town.

Ocampo's group alleged that they saved the non-resident students of Salugpungan because they reportedly had nowhere to go after the school was ordered closed by the tribal leaders. Salugpungan school was ordered closed by the education department.

They were about to transfer the students to another location when they were intercepted

But tribal leaders and some residents have a different story. They said Ocampo's group took away the children without the consent of the parents.

Due process

Ocampo, Castro and 16 others are facing charges of child abuse, kidnapping and failure to return a minor. The Office the Provincial Prosecutor recommended an P80,000 ball for each of the 18 respondents.

Presidential spokesman Salvador Panelo assured that Ocampo and the other accused will be accorded their right to due process. "Mr Ocampo, together with all the accused, have been given 10 days to file their respective counter affidavits to refute the allegations against them. Hence, due process is being accorded them," he said.

"We advise Mr. Ocampo and his supporters to hold their horses. Rashly jumping into conclusions and engaging in propaganda war not only is unproductive but an attempt to resort to a trial by publicity against the government by those identified with the left." Panelo said.

Albayalde said soldiers from the Armed Forces of the Philippines were part of the security forces during the arrest but the arresting officers were from PNP.

"If there will be complaints from the parents of the minors, Deampo will have a major problem," Albayalde added.

The PNP chief welcomed the possible filing of counter charges by the camp of Ocampo and Castro against the PNP and AFP officers involved in their alleged harassment and detention.

"It's their right to file counter-charges according to law," Albayalde said.

Communists 'brainwashing' youth - DILG

INTERIOR Secretary Eduardo Año has denounced the Communist Party of the Philippines-New People's Army (CPP-NPA) for "brainwashing" young filipinos.

The statement came three days after former Bayan Muna congressman Satur Ocampo and Rep. Francisca Castio of Alliance of Concerned Teachers (ACT) party-list were arrested for alleged child trafficking in Dayao del Norse.

Año said in a statement the CPP NPA and their communist front organizations were brainwashing the Filipino youth to sympathize with them and light the government in guise of nationalism and humanitatian missions."

"We do not condone such reprehensible behavior against minors and condemn

the communists and their allies for their sins against the youth such as kidnapping, child trafficking and other illegal treatment of children," the chief of the Department of the Interior and Local Government (DILG) added

Ocampo, Castro and 72 others were arrested in Talaingod, Davao del Norte, on November 28 for allegedly kidnapping 14 minors whom police said were made to form part of a *solidarity mission convoy."

According to the police, they arrested Ocampo and the others after tribesmen in the convoy complained that the former lawmaker and his companions were taking away their children to bring them to a *lumad* (indigenous people) school without the parents' permission.

Another ACT congressman, Antonio Tinio, said the Ocampo group was attacked by members of the paramilitary group known as Alamara.

Instead of arresting the attackers, the police brought members of the group to the Talaingod Police Station where they were detained. Tinio said.

Año said they "strongly con-

demn all forms of child trafficking and exploitation in the country and will make certain that all those guilty [of] these abhorrent acts against the vulnerable and innocent will face the full judgment of the rule of law."

Ocampo and his group are facing charges of child abuse, exploitation and discrimination under Republic Act 7610.

Ocampo's wife, Carolina Malay, decried the arrest of her husband and members of his group.

"My husband was doing what he believes to be right, the way the Duterte administration is going about governing, it really shows people the severe limitations of the system, it's exposing the deep flaws in our governance, can we see due process there?" Malay told The Manila Times.

Commission on Human Rights Chairman Chite Gascon supported Malay

"We will coordinate with the lawyers, we call on the government to ensure that their rights as accused are being protected, and they are given the opportunity to present their case," Gascon said.

Palace: Duterte won't militarize peace panel

MALACANANG has allayed fears of the government's critics that President Rodrigo Duterte might soon militarize the office of his adviser on the peace process as a result of the resignation of Jesus Dureza.

He was chairman of the government's Committee on the Cessation of Hostilities before taking over as military chief.

"We surmise that Duterte would like the military, like the outgoing [Armed Forces] chief of staff Carlito Galvez, to take over OPAPP and militarize it." Sison said in an interview with ABS-CBN News Channel.

"The problem is when the military comes in, they impose conditions for the surrender of the New People's Army (NPA)." he added.
The NPA is the armed wing

of the Communist Party of the Philippines, which Sison founded

Ocampo, formerly an adviser to the communist rebels' negotiating panel, said replacing Dureza with a farmer military officer would be bad for possible resumption of peace talks.

Peace negotiations where the military will have the last say is not going to result in an acceptable agreement," he added.

They also surrendered their firearms including caliber .30 Springfield Rifle, caliber .45 M1911 pistol, and three caliber .38 revolvers.

Defense Undersecretary Reynalde Mapagu, head of the Task Force Balik Loob for his part, said the robels are realizing that the pledges of the President are real.

"I would like to call on the remaining communist rebels to rejoin the mainstream society," he said.

Clan war displaces hundreds in NoCot-Maguindanao border

IKIT, North Cotabato (PNA)

— Police said a farmer was killed while six others were injured in a series of clashes involving Moro families at the border of North Cotabato and Magundanao here on Thursday and Friday

The violence also sent hundreds of families fleeing to safety, according to Chief Insp. Theng Bacal, Pikit police chief.

Pikit Mayor Sumulong Sultan said the municipal disaster risk reduction and management council office quickly attended to the needs of the displaced families.

"The affected areas are Barangay Kabasalan in Pikit, North Cotabato and Barangay Darampua in Sultan sa Bar ongis, Maguindanao, where some 300 families evacuated to safer grounds due to the fighting." Sultan said.

The families locked in the conflict were from the Kusain-Saligan and the Hadji-Nasser Both have relatives who belong to the Moro Islamic Liberation Front (MILF) and the outlawed Bangsamoro Islamic Freedom Fighters, police said.

Both clans have for months been sporadically trading shots in Kabasalan, Pikit and Darampua, Sultan sa Barongis due to a land dispute

Tahira Kalantongan, Pikit's MDRRMC officer, said the MILF has already sent emissaries to the warring clans "for them to stop firing guns and allow civilians to return home."

Kalantongan said town officials were already facilitating the return of the dis-

placed families as of posting time

Family feud is one of the major concerns of the MILF that needs immediate attention once it assumes leadership of the expanded Bangsamoro political entity in Muslim Mindanao.

Through the Bangsamoro Organic Law, the MILF will soon take over the helm of the proposed Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) that will replace the current Autonomous Region in Muslim Mindanao (ARMM).

INDOMALPHI completes maritime exercise

Snips from the navies of the Philippines, Indonesia and Malaysia have completed the fourth day of their trilateral maritime exercise on Saturday.

The maritime patrol exercise is under the Trilateral Cooperative Arrangement signed in 2017 in response to a series of kidnappings of foreigners by the Abu Sayyaf Group and its affiliates.

The exercise was aimed at enhancing their respective security and defensive capabilities while preventing piracy and abductions in their common maritime borders.

In yesterday's trilateral security exercise, the three navies completed their combined maritime patrol and training activities

The participating vessels were KRI SURA 802 of Tentara Nasional Indonesia-Angkatan Laut (TNI-AL), KDI PARI 3510 of Royal Malaysian Navy (RMN) and BRP General Mariano Alvarez (PS38) of the Philippine Navy.

They conducted several naval ship executions such as officer on watch maneuver, flashing lights and communications interoperability exercises as they sailed from Zamboanga to Tawi Tawi.

The trilateral event includes demonstration, day tour and sports activities involving the three navies.

All the activities were held in the area of Western Mindanao Command Headquarters in Zambounga City.

The groups operate in waters along the common borders in the southern Philippines, a sea passage through which 16,000 international vessels and \$14 billion in goods pass annually.

Never should children be caught amid warring forces

IHE ARREST of former Bayan Muna party-list representative Satur Ocampo and ACT Teachers' party-list Rep. Francisca Castro comes as a shock to the public, despite the constant back and forth of accusations between the government and military on one hand, and the leftist or progressive movement on the other.

People were surprised at the nature of the charges leveled against Ocampo, Castro and their companions — human trafficking and kidnapping.

Ocampo, Castro and their party were apprehended at a checkpoint in Talaingod, Davao del Norte on Wednesday, allegedly with a group of 14 Lumad minors. The minors were supposedly students of the Salugpungan Learning Center, a Lumad school

The group was on a "solidarity mission" to check on the plight of Lumad children. According to the activists, the school was allegedly shut down by a paramilitary group on suspicion that communists were using it to brainwash the Lumad children into rebelling against the government.

We harbor no illusions that the leftists running the school are teaching a standard curriculum. We do not swallow hook, line and sinker the Left's line that there is no brainwashing happening in the school. But it is also hard to accept fully the military's statement that the progressives are carrying out massive abuse of the Lumad children.

"Ka Satur" Ocampo, 79, is a familiar figure — a politician, activist, journalist, writer, a former The Manila Times journalist. He co-founded the National Democratic Front of the Philippines with Jose Maria Sison. He also founded Bayan Muna and led it in three successful elections in 2001, 2004 and 2007. He continues to march on the streets as an activist despite his advanced age.

Castro is an advocate for teachers, with an electoral mandate to pursue legislation on their behalf. Neither of them is known as a child trafficker or kidnapper. They were only invited to join the solidarity mission, according to the organizers. Thus, they should not, at the very least, be held to account for the entire conduct of the activity.

Their arrest on the spot at the Talaingod checkpoint has raised public curiosity over the fact it was carried out without a warrant. What the police had were alleged complaints by parents and tribal leaders.

The government and military's issue is with how the Lumad schools are run. Philippine National Police spokesman Chief Supt. Benigno Durana Jr. claimed, as reported, that the Salugpungan learning school, which is not accredited by the Department of Education, only served as a recruitment center for the Communist Party of the Philippines and its armed wing, the New People's Army

Due process now requires Ocampo's group to be brought to public prosecutors and be allowed to freely refute the charges against them with the assistance of their counsels.

It is unfortunate that the Lumad people and their children are caught in a tug of war between the military and the Left. What seems to be forgotten here is the welfare, livelihood, health and education of the Lumad.

Both sides are to blame for making them pawns in a political struggle, rather than a people with self-determination and a free hand to chart their own destinies.



Lorenzana says they will create another military division to send to Sulu

Defense Secretary Delfin Lorenzana said that they will create another military division to send to Sulu to once and for all rid the province of the terrorist Abu Sayvaf Group (ASG).

In an interview, Lorenzana said they will recruit more people to fill up the division and fulfill the mission of eradicating Sulu of the terrorist group.

"We are going to create another division. We will have permanent presence in Sulu and eliminate once and for all the Abu Sayyat," Lorenzana said.

"We are going to recruit more people for that division," he added.

President Rodrigo Duterte announced on Tuesday the imminent troop movement after expressing dismay with the violent clash between government forces and the Abu Sayyaf bandits in Patikul, Sulu several days ago.

The encounter, which left five soldiers dead and several others wounded, was considered a "flashpoint" by the President.

"We visited a wake at Cauayan. I was with (Defense) Secretary (Delfin) Lorenzana and



(Interior and Local Government) Secretary (Eduardo) Año. I talked to them and complained about why so many of my soldiers in Jolo are dying," he said during a visit to a military camp in Bohol.

"By December 1, I told Secretary Lorenzana, 'I want one division there' so I will provide you with a Glock and three magazines," he told the government troops.

The planned troop movement to Sulu comes amid the President's decision to deploy more soldiers and cops to some parts of the country where incidents of lawless violence were reported.

Duterte earlier issued Memorandum Order No. 32 directing additional troops to the provinces of Samar, Negros Oriental, Negros Occidental, and the Bicol region to prevent the spread of violence.

The government forces have also been reminded to respect the constitutional rights of persons in performing their duty.

"No civil or political rights are suspended during the existence of a state of national emergency on account of lawless violence," the order read.

Lorenzana, in the same interview, said it's necessary to send additional forces in Samar, Negros Oriental, Negros Occidental and Bicol to prevent Communist New People's Army Terrorists (CNTs) from further committing terrorist attacks in those provinces.

He also admitted that the enemy still is a force to be reckoned with in those areas, thus the need for troop deployment.

Earlier, the Armed Forces of the Philippines (AFP) announced that two battalions of soldiers were already deployed to Samar to fulfill its mission of stopping the attacks by the CNTs.

"The NPA keeps doing things like burning, killing people so this is a preemptive thing para masugpo sila (to stop them. We can pursue our build, build, build program," Lorenzana said.

"Remember they burned the equipment of the contractors in the... so they are still there...And as per the information of the mayor of Legazpi there are still NPA collecting money, extorting money from businessmen," he added.

Lorenzana said the movement of troops will only be temporary to help troops on the ground.
