The presidential spokesperson says economic managers have their reasons in withdrawing their initial recommendation to suspend the fuel tax increase, which amounts to P2.24 a liter—P2 excise and 24 centavos value-added tax.

Malacanang is supporting the decision of government eco-

nomic managers to push sons in withdrawing their initial through with the second round of fuel tax increases next month.

Presidential spokesperson Salvador Panelo said the economic managers had their rearecommendation to suspend the fuel tax increase amid rising inflation.

"I'm sure they have basis to make that recommendation. They are competent and able to

explain themselves to the lawmakers," Panelo said at a press briefing on Monday.

Labor groups Maiacanang's backing of the economic managers' proposal to reimpose the second round

of the tax on fuel, saying it was proof of its "low regard" for the poor who are most affected by the administration's tax policies.

Last week, Pinance Secretary Carles Dominguez III, Budget Secretary Benjamin Diokno and Socioeconomic Panning Secretary Ernesto Pernia recommended the continuation of the next round of taxes.

They cited the recent decrease in crude prices as

the reason for withdrawing their previous recommendation to suspend the next round of fuel tax increase.

President Duterte said on Monday night that he would hold a Cabinet meeting on Tuesday to discuss the recommendation to push through with the next round of increase in fuel tax.

Mr. Duterte told reporters to just wait for the outcome of the meeting, which will arrive at a consensus on the matter.

Asked whether there would be a decision on Tuesday, the President said: "Not necessarily. But I hope we can resolve it in the Senate."

He underscored the need for his economic managers to speak about the impact of the fuel tax on government projects and "the lack or sufficiency of money in government to go on with the projects."

P2 excise, 24 cents VAT

The Tax Reform for Acceleration and Inclusion (TRAIN) Act imposes an additional tax of P2.24 a liter for diesel and gasoline, consisting of P2 excise and 24 centavos value-added tax (VAT), starting on Jan. 1.

An excise of P2.50 a liter was slapped on diesel and bunker fuel this year. This would go up to P4.50 in 2019 and P6 in 2020.

Excise on gasoline rose from P4.35 a liter to P7 in 2018, P9 in 2019 and P10 in 2020.

Dubai crude price

Under the TRAIN law, the imposition of fuel taxes can be suspended if prices of Dubai crude exceed \$80 a barrel for three consecutive months.

Dubai crude as of Nov. 29 trading was fetching \$65.59 a barrel, down 28 percent from

\$84.12 on Oct. 3.

On Sunday, Sen. Sherwin Gatchalian, chair of the Senate economic affairs committee, said the passage of the 2019 na-

tional budget might be delayed if the economic managers would proceed with the next tranche of fuel taxes.

Three other senators have

warned that raising fuel taxes in 2019 might result in a new wave of inflation.

Asked to comment. Panelo said Gatchalian was only one of the 24 senators in the upper chamber and that the "passage of the budget would again depend on the call of members of Congress."

"His opinion or observation may not be shared by the 23 others," he said.

Breathing space

The Nagkaisa labor coalition said suspending the second round of the fuel tax would have provided the poor breathing space after suffering from the high cost of basic commodities and services over the past few months.

"Pushing for its implementation depicts this government low regard for the welfare of the poor people affected by its tax policy that burdens them more," Nagkaisa spokesperson

Rene Magtubo said.

The group earlier blamed the high inflation rate, which reached a nine-year-high of 6.7 percent in September and October, to the fuel rax.

The Associated Labor Unions-Trade Union Congress of the Philippines (ALU-TUCP) said the government should not push through with the imposition of the additional tax as workers had yet to recover from the impact of this year's high inflation rate.

ALU-TUCP spokesperson Alan Tanjusay said a new round of fuel tax increases "will directly impact his (Mr. Duterte's) candidates in next year's midtern elections."

Sentro secretary general Josua Mata said he was not surprised by the economic managers' decision.

"Cloistered in their rich men's world, they no longer are capable of empathizing with the lot of the working people," Mata said. INQ

Sen. Leila de Lima described as "talse and illogical" the claim of Public Attorney's Office chief Persida Acosta that there are no state-sponsored killings following the conviction of the three policemen for the death of Delos Santos.

De Lima made the statement after Acosta said the verdict handed down by the court on the policemen proved that there are no extrajudicial killings in relation to the administration's war on drugs.

The senator said the conviction of the police officers "does not make the more than 23,000 summary executions committed by police and vigilante death squads any less statesanctioned killings."

AFP, PNP back another year of ML

To make a "significant dent on terrorism," the military will recommend to President Duterte another year-long extension of the implementation of martial law in Mindanao.

Gen Carlito Galvez Jr., Armed Forces of the Philippines (AFP) chief, said local government units, regional peace and order councils and other agencies, including the Commission on

Elections (Comelec), are supporting the move.

He added that there is actually a clamor for such extension for at least one more year considering the continuing threat "lurking"

in Mindanao.

"We have recommendations already. We will be recommending, so that we can substantially make a significant dent on terrorism," Galvez told reporters in an interview in Camp Aguinaldo yesterday morning.

To prove that there is still a threat of terrorism in the entire island, Galvez cited the bombing incidents in the provinces of Basilan and Maguindanao, and in Isulan town in Sultan Kudarat and General Santos City.

"So there is really a need to constrict and limit the maneuver space of the terrorists to the maximum. We have a very weak terrorism law. So with that, martial law is needed to completely defeat terrorism," Galvez said.

The AFF recommendation for another year of martial law in Mindanac, he added, would be submitted to Defense Secretary Delfin Lorenzana and the new AFF chief by Dec. 12—the day he retires from military service.

He stressed that the miltary's position would be to continue the implementation of martial law only in the Mindanao regions.

Philippine National Police (PNP) chief Director General Oscar Albayalde said the PNP is one with the AFP in seeking an extension, adding that this would greatly ensure peace and order in the coming plebiscite for the Bangsamoro Organic Law and the midterm elections in May next year.

Presidential spokesman Salvador Panelo said Duterte might be persuaded to seek another extension because of the support shown by various sectors, including the citizens of Mindanao, for the proposal

"The President will always evaluate whatever recommendations the AFP and the PNP will give him. But given the support of martial law in Mindanao, even by a Catholic bishop and the citizens there, the President may be per-

suaded to grant, to approve their recommendation. But of course, again, that is the prerogative of the President." Panelo said at yesterday's press briefing.

press briefing.

The 1987 Constitution permits the president to impose martial law for up to 60 days, which can be extended by Congress "if the invasion or rebellion shall persist and public safety requires it."

But for Anak Mindanao party-list Rep. Makmod Mending, the AFP should first organize a briefing for the Senate and the House of Representatives to apprise their members on the need to extend anew martial law in Mindanao.

Senate President Vicente Sotto III said senators would most likely seek a full security briefing to make an intelligent decision on the recommendation.

He added that he is open to calling for a special session to decide on the matter should Duterte request for one. An extension requires the approval of Congress in joint session.

Duterte first placed the entire Mindanao under martial law on May 23, 2017 after Islamic State-linked terrorists laid siege to Marawi City. Close to 1,000 terrorists and more than 160 soldiers died in that incident, the longest urban war in the country since World War II.

Congress has already extended the military rule in Mindanao twice. The first extension lasted until Dec. 31, 2017 while the second will lapse at the end of the year.

Some religious leaders, including Ozamiz Archbishop Martin Jumoad, are supportive of martial law extension, saying the military rule had reduced crime and enforced discipline among the people of Mindanao.

Activists and left-leaning groups do not share that assessment though, as they worry that an extension will lead to more human rights violations and abuses. — With Alexis Romero, Paolo Romero, Delon Porcalla, Edu Punay, Romina Cabrera

PALACE EVALUATING RECOMMENDATIONS

MILITARY, POLICE MAY PERSUADE PRESIDENT TO EXTEND MARTIAL LAW IN MINDANAO-PANELO

President Duterte may be swayed by the recommendation of the military and the police to extend the imposition of martial law in Mindanao beyond Dec. 31. Malacahang said on Monday

Presidential spokesperson Salvador Panelo said the President would "have to evaluate recommendations whatever were given by the Armed Forces of the Philippines and the

Philippine National Police.

"Given the support [for] martial law in Mindanao, even by a Catholic bishop and the citizens there, the President may be persuaded to go on to approve the recommendation," Panelo said.

President's prerogative

"But of course, again, that is the prerogative of the President" he added

The Palace official made the remarks after APP chief Gen Carlito Galvez Jr. said the military was pushing for the exten-

sion of martial law in Mindanao for at least another year.

PNP Director General Oscar Albayalde said the police was also recommending the extension of military rule in the South beyond Dec. 31.

On May 23, 2017, Mr. Duterte declared martial law in Mindanao following the attack by the Maute terrorist group on Marawi City that lasted for five

Later that year Gongress approved the one-year extension of martial law in the region. It will expire at the end of 2018.

Panelo said the President would always consider the "safety of the people there" in evaluating the recommendations of the AFP and the PNP.

Congress to decide

"If the threat remains and there is still an ongoing rebellion, then, constitutionally, the basis would be valid for the continuation of martial law," he said.

Malacañang, Panelo said, would leave to Congress whether to approve the extension of martial law in Mindanao should the President decide to

heed the recommendation of the military and police.

But opposition lawmakers in the House of Representatives on Monday lambasted Galvez for recommending the extension of martial law.

Bayan Muna Rep. Carlos Zarate said he was no longer surprised with Galves's decision as he knew that the miltary wanted martial law "ad infinitum."

"Truth to tell, this move to further extend martial rule can even be used to influence the elections in Mindanae and en

sure the victory of administration bets," he said.

Unconstitutional

Magdalo Rep. Gary Alejano warned that prolonging military rule was not only unconstitutional, but would also adversely affect the country's economy.

ACT Teachers Representatives Antonio Tinio and France Castro said extending martial law would only result in "more human rights violations and harassment by the military, paramilitary and the police." INQ M

AFP recommending one more year of military rule in Mindanao due to clamor of stakeholders

With the support from the military, police, and the residents of the region. Presidential spokesman Salvador Panelo said President Duterte might be "persuaded" to seek another extension of martial law in Mindanao.

Panelosaid the President's main consideration for any martial law declaration would always be the safety of the people.

"Of course the President will always evaluate whatever recommendations the AFP (Armed Forces of the Philippines) and PNP (Philippine National Police) will give him but given the support of martial law in Mindanao, you have a Catholic bishop and the citizens there, the President maybe persuaded to grant the recommendation." Panelo said during a news conference in the Palace.

Galvez said extending martial law in Mindanao for another year will be their final position as there is really a clamor for its extension.

"Yun ang magiging ano, position namin [That will be our position) because there is really a clamor for the extension (of martial law) considering that terrorism is still lurking in the area." Galvez said. The outgoing AFP Chief of Staff, who will retire from the military service at the age of 56 on December 12, 2018, cited the recent bombing in Basilan and encounters in Sulu as reasons for extending martial law.

"The Sulu problem still persists and also, we have also some bombings in Isulan and GenSan (General Santos) and also continuous bombing in Maguindanao. So there is really a need to constrict and limit the maneuver space of the terrorist to the maximum," Galvez said.

"We have a very weak terrorism law so with that, martial law is needed to completely defeat terrorism," he said

Gaivez said their recommendation to extend martial law in Mindanao will be submitted to the Secretary of National Defense (SND) Delfin Lorenzana

He assured that martial law will not be extended to other parts of the country.

"And then most probably this (command) conference, this coming December 12 with the new Chief of Staff, we will be presenting the recommendation." Galvez said.

The military chief had said terrorism was still a problem in the whole island despite the twice-extended martial law.

The recommendation will be presented by Galvez's successor during a command conference before Defense Secretary Delfin Lorenzana on December 12, or the day the military chief retires from service.

Philippine National Police chief Oscar Albayaide backed the military's move, saying martial rule would enable authorities to move against "lawless violence."

President Rodrigo Duterie declared martial law in Mindanao in May last year in response to the attacks made by the Islamic Stateinspired Maule group in Marawi City, which lasted for five months.

Duterie issued Proclamation 216 placing the entire Mindanao under military rule.

The declaration was good for only 60 days but was extended by Congress until the end of 2017. The legislative branch further extended it until the end of 2018.

The President "may be persuaded" to approve the recommendation of the military and police to extend martial law in Mindanao for at least one year. Malacanang said on Monday.

"IGliven the support of martial

law in Mindanao, even by a Carbolic bishop and the citizens there, the President may be persuaded to go on to approve the recommendation. But of course, again, that is the prerogative of the President, "Palace spokesman Salvador Panelo said.

meeting," the President said at the sidelines of the conferment of the Quezon Service Cross on the late Sen. Miriam Defensor Santiago.

"It will depend on the recommendation of the military and the police. They are the guys on the ground," Mr. Duterre said on the possibility of his seeking an extension.

Armed Forces of the Philippines (AFP) chief Gen. Carlito Galvez said the extension of martial rule for another year, the third time it will be stretched, is needed because of the "lurking" threat of terrorism.

He said the military's recommendation for a one-year extension would be forwarded anytime soon to Defense Secretary Delfin Lorenzana, who will then submit the proposal to Mr. Duterte.

Concurrence will be expedited if the military and the police will renew their commitment to respect the constitutional rights of every individual in the territory covered by the declaration.

"We have recommendation already... everybody — the local government units and even the Comelec (Commission on Elections) and other agencies are recommending for an extension of at least one year," said Galvez.

House Majority Floor Leader Rolando Andaya said the House will support an extended martial law as long as Mr. Duterte asks for it.

The lawmaker said that the inputs and views of the representatives of districts in Mindanao "will carry much weight during the deliberations."

The President may be persuaded to grant to approve the recommendation.

Philippine National Police (PNP) chief Dir. Gen. Oscar Albayalde said the PNP's position is consistent in that martial law in Mindanao is still needed.

Presidential spokesman Salvador Panelo said Mr. Duterte will "always evaluate whatever recommendations that the AFP and PNP will give him," but given the situation in the region and the views of the military and the police, "the President may be persuaded to grant to approve the recommendation."

Panelo said that the safety of the people in Mindanao will be Duterie's basis in making his decision.

Military rule in Mindanao expires at the end of the year. The region was placed under martial law in May 2017 after Islamic State (IS) inspired terrorists laid siege on Marawi City that lasted for five months.

It was extended by Congress on 28 July to 31 December 2017. A second extension, this time for a full year, was granted by both chambers on 13 December 2017.

Limiting terror space

"There is a need to constrict

and limit the maneuver space of the terrorists to the maximum. We have a very weak terrorism law, so with that martial law is needed to completely defeat the terrorism," Galvez said.

The AFP chief, however, stressed that the military's recommendation is limited to Mindanao only.

"It will not be expanded, it will only be in Mindanao." he said

Apart from the threat from terrorists, Galvez also cited the upcoming midtern elections in May 2019 as among the factors in the military recommendation.

Consultations set

Should Mr. Duterte accede to the security cluster's recommendations, he will once again course it through the House of Representatives and the Senate who. Panelo said, are the sole authorities to approve or turn down the proposed extension of military rule in Mindanao.

"Again, the Constitution grants them the authority to decide whether or not it will extend martial law. So, we'll leave it to them," the Palace official stated.

There is a need to constrict and limit the maneuver space of the terrorists to the maximum.

Senate President Vicente Sotto III have previously said Malacañang must be able to present strong, convincing arguments before the Upper and Lower Houses for lawmakers to yield to another request of extending martial law.

Galvez cited recent bombing attacks in Basilan, Isulan, Maguindanao and General Santos City and the encounter in Sulu as indications that the problem of terrorism still persists.

Military wants 1-year extension of martial law

THE military will recommend to President Duterte a one-year extension of martial-law-being implemented in Mindanao, Armed Forces chief Gen. Carlito Galvez Jr. said yesterday.

"We will be recommending (the oneyear extension) so that we can substantially make a dent on terrorism... That is our position because there is really a clamor for the extension considering that terrorism is lurking in the area," he said.

Galvez also noted that regional peace and order councils, local government units, the Commission on Elections, and other agencies which the military had consulted are also for the martial law extension.

The President, in a chance interview after an event in Malacañang, said he has yet to decide on the matter which he said will be discussed today during a Cabinet meeting in Malacañang.

Martial law is set to end on December 31.

Duterte declared martial law in Mindanao shortly after the Maute terror group occupied several barangays in Marawi City in May last year, leaving over a thousand terrorists and government troops dead.

The military rule has been twice extended by Congress, on the request of President, citing continuing threats from the terrorist groups. The last extension was in December last year.

House majority leader Rolando Andaya Jr. said the chamber will readily extend

martial law:

"If the President will ask for it, then chances are it shall be given," Andaya said.

Several senators have said another request for extension would be scrutinized.

PNP chief Albayalde last month said the PNP is for an extension of martial law. He said it is needed for the plebiscite for the Bangsamoro Organic Law plebiscite in Central Mindanao next month.

Galvez said there have been terror-

Duterte also mentioned "Quezon City," which may have referred to Quezon province which is also a known stronghold of the New People's Army, the armed wing of the Communist Party of the Philippines.

The President then joked he might have a clear decision after the "pot session" of the Cabinet.

Duterte, prior to the interview, said in a speech that he took marijuana to keep himself awake and active during hectic schedules for the Association of Southeast Asian Nation event last month. He later said it was a "joke" that only fools would believe to be true.

Justice Secretary Menardo Guevarra said any further extension of martial law "will depend on the continued existence of the factual basis for its proclamation, actual rebellion or invasion."

Guevarra also said his department has no role in the matter but it "may be called upon to help explain to Congress the legal and factual basis for any further extension."

Andaya said congressional concurrence "will be expedited if the military and the police will renew their commitment to respect the constitutional rights of every individual in the territory covered by the declaration."

"The inputs and views of the congressmen from Mindanao, who represent the people directly affected, will carry much weight during the deliberations," he said.

AFP Chief Carlito Galvez Jr. said the AFP and the PNP will recommend Rep. Mackmod Mending Jr. (PL, Anak Mindanao) said his vote on the possible extension will "depend on the threat assessment of Department of National Defense and AFP."

"Maybe it's time to call for a security briefing from them as well as an update on the implementation of the martial law," he said.

Rep. Robert Ace Barbers (NP, Surigao del Norte) said the government has to be able to justify the request "as a way of guaranteeing peace and security in the region.

Rep. Luis Raymond Villafuerte (NP, Camarines Sur), a vice chair of the committee on local government, said Congress should give more weight to the inputs of the people in Mindanao in considering a request for extension.

"Mindanaoans are the ones experiencing what it's like to live under martial law for a year-anda-half now, so they would have a better grasp of what is an acceptable option for them for continued peace and security," he said.

Left-leaning lawmakers fear an extension will only lead to more human rights violations and harassment by the military, paramilitary and the police.

Rep. Antonio Tiñio (PL, ACT) said martial law in Mindanao "has been used to terrorize and harass innocent civilians, human rights defenders, humanitarian workers, Lumad communities, environmental advocates and activists."

Rep. France Castro (PL, Act Teachers), said "the only terrorism still lurking in the area is state terrorism, brought by elements of the AFP, paramilitary forces and the PNP that drive Lumad children out of their schools, illegally detain people without warrants of arrest, charge them with trumped-up cases and tag them as terrorists."—With Wendell Vigilia and Ashzel Hachero

AFP backs ML extension; Duterte undecided

Balangiga bells in Manila next week

THREE bells taken by Americans soldiers from Balangiga town in Eastern Samar during the Philippine-American war in 1901 are set to arrive in Manila next week.

"Tentatively, the arrival of the bells is set on the 11th of December," said Arsenio Andolong, spokesman of the Department of National Defense.

He said the Balangiga bells will be transported by a US Air Force plane to Villamor Air Base in Pasay City where turnover ceremonies will be held.

Two of the bells will come from the Warren Air Force base in Wyoming where these were displayed as part of the US memorial to the 46 American soldiers killed by Filipinos in Balangiga town in 1901. The other was displayed at Camp Red Cloud, headquarters of the

US Army 9th Infantry Regiment, in South Korea.

Officials of the US Department of Defense and US Pacific Command will hand over the bells to Philippine defense officials during the handover ceremony, a source said.

The source said the bells will later be airlifted to Samar by a Philippine Air Force plane for their handover to Church officials in Balangiga town in Samar on December 15.

The source said President Duterte, who had strongly advocated for the return of the bells, may attend the ceremony in Balangiga. PL

Earlier yesterday, Defense Secretary Delfin Lorenzana told Samar residents the bells are "coming back home" on December 11 and will be brought to Balangiga in time for the start of the Misa de

Gallo on December 15.

CHR: Army execs liable for rights violation

Military officials say 2017 clash that killed 7 Cotabato tribe members 'legitimate'

LAKE SEBU SOUTH COTABATO—The Commission on Human Rights (CHR) has held two military commanders in Mindanao liable for rights abuses in connection with the killing of seven tribe members in a remote village here last year.

Erlan Deluvio, CHR regional director in Soccsksargen (South Cotabato, Cotabato, Sultan Kudarat, Sarangani and General Santos), said Lt Col. Harold Cabunoc, commander of the 33rd Infantry Battalion (IB) based in Sultan Kudarat, and Lt. Col. Benjamin Leander, former commander of the 27th IB based in South Cotabato, were cited for their roles in the Dec. 3, 2017 clash at Barangay Ned, where a rribal leader and six community members were killed.

"[They are] liable for human rights violations for their utter failure to exert earnest efforts in distinguishing combatants from noncombatants under the principles of distinction of International Humanitarian Law," Deluvio said in a resolution on Oct 5 that was obtained by the Inquirer only on Monday.

Reconsideration

Datu Victor Danyan Sr., chair of the T'boli Manobo S'daf Claimants Organization, a group based in Sitio Datal Bonlangon, and six community members were killed in what human rights and militant groups had described as a massacre.

and Cabunoc had filed a motion for reconsideration on the findings of the CHR regional office.

In their defense, they said a legitimate encounter between soldiers and the New People's Army (NPA) rebels broke out in the area, resulting in the death of the tribal chieftain and six others.

Two soldiers were also killed in the clash, they said.

Cabunoc said the court would eventually decide on the merits of the case.

"I will never falter in performing my constitutional mandate of protecting the people against armed aggression by the ... NPA and their auxiliary forces, like the group of [Danyan]," he told the Inquirer on Monday.

"If Datu Victor was fighting for his rights, I am also obliged to defend the ... workers of Dawang Coffee Plantation against the planned attack by NPA [rebels] who supported [Datu] Victor's armed followers in seizing lands from [plantation owners]," he added.

Plantation attack

In the CHR's nine-page resolution. Cabunoc and Leander claimed the military operation was triggered by intelligence reports that the NPA's "Platoon Arabo" and "Platoon My Phone" had merged at Sitio Datal Bonlangon allegedly to launch an attack against coffee producer Silvicultural Industries Inc.

Witnesses presented by the military claimed that Danyan and the rebels were allegedly hatching a plan to attack the plantation on Dec. 10 last year.

But Dehivio said a CHR investigation—showed—that Danyan's community was not a guerilla base. He said the supposed NPA camps identified by the military were detachments of government militiamen and company guards.

Don't take Du30 seriously on death squad

No one in government is authorized to kill-not even President Duterte, according to one of his top allies in the Senare.

Sen. Aquilino Pimentel III on Monday dismissed the President's widely criticized threat of forming the government's own death squad to hunt down communist rebels and their sympathizers, saying this was impossible under the law.

"Don't take that seriously. That cannot be done," said Pimentel, president of Mr. Duterte's ruling Partido Demokratiko Pilipino-Lakas ng Bayan.

"No one is authorized to kill. Even government is not authorized to kill." Pimental said at a press briefing in his Senate office.

'My own sparrow'

The former Senate President said the debate over the revival of the death penalty was proof that the government did not have the power under the country's judicial system to order anvone killed.

Last week, Mr. Duterte announced he would form "my own sparrow," referring to the special partisan unit of the New People's Army (NPA) that gained notoriety in the 1980s

for assassinating government targets in urban areas.

"They will do nothing but look for idlers who are prospective [NPA] members and take

them out." the President said of the government's death squad.

His instructions to what he called the "Duterce death squad," the President said, is

"get one or two" rebels.

The comment drew condemnation from critics, including the political opposition and human rights advocates.

Response to killings

Armed Forces of the Philippines chief Gen. Carlito Galvez. Jr. on Monday said the President's desire to create a death squad was in response to the killings of 136 policemen, soldiers, tribal leaders and government officials by the NPA's hit teams in the past three years.

"There is really a need to counter this [NPA unit]. And to counter this is to make our personnel vigilant, and we need to

counter this with the organization of a counter-sparrow force," Galvez said.

But the AFP chief would rather drop "death squad" in favor of a different name for the special government unit. He also stressed that the unit's task should be left to security forces and not involve civilians.

In an interview after Monday's flag-raising rites at Camp Aguinaldo, Galvez said the squad that would pursue the NPA's assassination unit would be called 'counter-sparrow force,"

The force, he said, would tocus primarily on intelligencebuilding and gathering to hunt down NPA rebels. INQ N

Communist death squads still active in some regions — AFP

Armed Forces of the Philippines chief Gen. Carlito Galvez Ir. expressed support yesterday for the creation of a unit that will counter the operations of the assassination squad of the Communist Party of the Philippines (CPP) and its armed wing, the New People's Army (NPA).

He told reporters yesterday that communist rebels now tagged by the government as terrorists definitely have assassination squads called "sparrow units" targeting military and police personnel

"What we see is that the assassination squads of the CPP-NPA are very active in Bicol, in the area of Eastern Mindanao, also in Western Mindanao and some areas in Samar and also in Negros," Galvez said.

However, he said the antisparrow unit that could be formed by the government to counter such assassination groups should be composed of police and military personnel

and not civilians.

"What the President is saying is that because there are more than 136 persons that have been killed and assassinated by the CPP-NPA terrorist group, there

is really a need to counter this," Galvez explained.

"And to counter this is to make our personnel vigilant and we need to counter this with the organization of counter sparrow force with the intelligence and our special units," he said.

On whether such unit should be called the Duterte Death Squad as mentioned by President Duterte, Galvez said the name should be more like a "counter sparrow unit" operating based on intelligence, training and "specialized to hunt these people "

«'I believe let's not involve

the civilians, it's more on the military and the police intelligence special units," he said.

Philippine National Police (PNP) chief Director General Oscar Albayalde has backtracked on his statement that NPA sparrow units have long ceased to exist, clarifying that the current leadership of the CPP still maintains hit squads.

Albayalde's statement comes as he said in a radio interview over the weekend that the NPA sparrow units have been phased out and that the last incident monitored was three years ago.

have recorded that CPP-NPA hit squads are responsible for 136 deaths in the past three years

Albayalde claimed that the CPP still has these sparrow units that undertake special operations such as "liquidation, murder or assassination as directed by the regional party committee" in rural areas

Albavalde said that the government should also set up a specialized unit as there is "strong possibility" that the communist hit squads would stage more assassinations of vulnerable targets.

"This specialized capabil-He clarified that authorities ity of the CPP-NPA should be addressed with an equally specialized countermeasure to reduce the potential for further acts on soft targets. There is also a likelihood that some misled guerrilla fronts and enterprising commanders may offer services for political assassination," he said.

Still. Albayalde said that they have not received any directive from Malacañang regarding the plan to establish the government's own death squad.

He said they still have to coordinate with the AFP on how to create and supervise this special unit.

Civilians not allowed in death squad - Galvez

ARMED Forces chief Carlito Galvez Jr. on Monday ruled out the inclusion of civilians in the formation of a death squad against the New People's Army's (NPA). "Sparrow" units.

"Let's not involve the civilians. It's more on the military and the police." Galvez told reporters in a chance interview after the flag-raising ceremony at Camp Aguinaldo, the military's headquarters in Quezon City.

However, Galvez suggested that the group be called "Counter-Sparrow Unit instead of "Duterte Death Squad"

The group, he said, would focus on intelligence operations to counter the Special Partisan Unit

(SPARU) of the NPA.

"This is a unit that will specialize to hunt these people," the military chief said.

Last week, President Rodrige Duterte eyed the formation of his own death squad that would 'match the talent' of the Sparrow units.

Galvez said the Sparrow units continue to carry out liquidation missions targeting government security forces.

"The assassination of these groups is still very active especially in Bicol, Eastern Mindanao and in Western Mindanao, and in some areas in Samar and also in Negros [Islands]," he said

PALACE SAYS LOCSIN OUTBURST OVER SATUR ARREST A PERSONAL SENTIMENT

Malacanang is unfazed by Foreign Secretary Teodoro Locsin Jr.'s outburst over the arrest and detention of his friend, former Bayan Muna Rep. Satur Ocampo, for alleged kidnapping and human trafficking.

"We view the comment of

Secretary Locsin as a personal sentiment given the fact that he and former Congressman Satur Ocampo are friends and were both together in [the House of Representatives]," presidential spokesperson Salvador Panelo told reporters on Monday.

"It's not reflective of the view of the administration," Panelo also said. Locsin tweeted last week his disgust of Ocampo's arrest, calling the charges "idiotic."

Humanitarian mission

Ocampo, ACT Teachers Rep. France Castro and 16 other left-leaning activists were arrested by the police on Wednesday in Talaingod town, Davao del Norte province, as they were rescuing

teachers and "lumad" schoolchildren from alleged harassment by a paramilitary force that shut down their community school.

Police filed kidnapping and human trafficking charges against them, but the provincial prosecutor's office rejected the kidnapping charge and released them on bail.

Panelo also issued a state-

ment saying Locsin's remarks were "personal sentiments supportive of a friend."

"Priendship, however, does not give birth to the conclusive conclusion that a person charged of a crime is innocent nor does a charge sheet automatically make such individual guilty thereof. That is precisely why the Constitution grants every critizen the

presumption of innocence and burdens the State to prove the guilt of the accused beyond reasonable doubt," he said.

Panelo noted that the prosecutor's office in Tagum City had granted the request of Ocampo's group to have a preliminary investigation and to proffer evidence and that they were released after posting bail. INQ

PNP to refile kidnap raps vs Satur et al.

The Philippine National Police will refile the kidnapping charge it had brought against ACT Teachers Rep. Prance Castro, former Bayan Muna Rep. Satur Ocampo and 16 other left-leaning activists but was rejected by the provincial prosecutor of Davao del Norte last week.

Castro, Ocampo and other activists were arrested by the military and the police in Talaingod town, Davao del Norte, on Wednesday night after they rescued teachers and schoolchildren from alleged harassment by a paramilitary force called Alamara.

The authorities detained the activists and filed kidnapping and human trafficking charges against them.

The provincial prosecutor in Tagum City rejected the kidnapping charge but found probable cause to prosecute them for child abuse.

Castro, Ocampo and the activists were released on bail of P80,000 each. They returned to Manila on Sunday.

Complaints from parents

The PNP said on Monday that the kidnapping charge would be refiled, following the filing of complaints by the parents of five of the schoolchildren.

PNP Director General Oscar

Albayalde said the prosecutor may have rejected the kidnapping charge because "the case might be weak."

But the prosecutor might accept a refiled case, as "there are already complaints from the parents," Albayalde said.

Gen. Carlito Galvez Jr., chief of staff of the Armed Forces of the Philippines, told reporters on Monday that the arrest of Castro and Ocampo for alleged child trafficking was proof that "they are active members" of the Communist Party of the Philippines (CPP) and its armed wing, the New People's Army (NPA).

"The last bastion of the CPP-NPA is the ['lumad'] because indigenous people are the most vulnerable sector that they can trick." Galvez said.

Ocampo on Monday denied that he was an active member of the CPP and that he was recruiting minors to fight for the NPA.

There was no immediate comment from Castro

"There is a rule in the CPP-NPA against recruitment of minors. So definitely that could not be a part of the program of the NPA," Ocampo said in a television interview.

Respect lawmakers

Speaker Gloria Macapagal-Arroyo on Monday said members of the House of Representatives should be accorded respect.

"The House is a body of

elected representatives of the people, and ... all its members, such as Rep. France Castro, are entitled to a certain level of dignified and respectful treatment in situations such as this," Arroyo said in a statement.

Arroyo, however, did not comment on the charges brought against Castro and the other activists.

Ocampo did not deny that the NPA was present in Davao del Norte and that there were indigenous people who had joined the insurgents.

"The communities of the



lumad are in the hinterlands so (these) become [battlegrounds]. It is not surprising that the NPA [organizes] the people in the struggle for their welfare." Ocampo said.

"So it doesn't deny that there are lumad who joined the NPA, but they are not minors," he added.

Independent now

Ocampo said he was no longer a member of the CPP-NPA and that he acted independently of the communist movement.

"it's a rule that after a long imprisonment or once a supposed leader of the CPP-NPA is arrested, he loses all the titles and the duties in the revolutionary movement," he said.

A Marxist, Ocampo was arrested and imprisoned during the martial law rule of the dicta-

tor Ferdinand Marcos.

He was ordered released in 1986 together with CPP founder Jose Maria Sison by then President Corazon Aquino, who was swept into power in the Edsa People Power Revolution that brought down Marcos.

Ocampo said he had the choice of rejoining the revolutionary movement, but opted to "stay aboveground and to join the open legal protest mass movement."

"All my activities are aboveground," he said.

Ocampo also denied Albayalde's claim that lumad schoolchildren in Davao del Norte were being taught by the rebels to sing a different national anthem.

"As far as 1 know, I don't know of an instance where a different version of the national anthem is taught in lumad schools," he said.

Produce evidence

Ocampo challenged Albayalde to produce evidence to prove his claim.

"I don't know [Director] General Albayalde's source. He has to produce evidence. That would be a ground," he said.

Alamara gunmen shut down the lumad school Salugpongan Ta'tanu Igkanogon Community Learning Center at Barangay Palma Gil on Wednesday.

Police said the Department of Education (DepEd) ordered the school closed because it was sus-

pected to be a front for the NPA.

The DepEd denied ordering the school closed.

"We [did] not issue a closure order. The Division of Davao del Norte has no authority to issue [closure orders]. If there is, the order should be issued by the DepEd central office in Manila," Josephine Fadul, the division superintendent, said in an interview on Sunday.

Fadul said the Salugpongan community schools were recognized by the DepEd and they had a regular curriculum.

Military harassment

Enrollment in these schools has been falling, however, because of the harassment of teachers and students by the military, she said, reporting a complaint from Meggie Nolasco, executive director of the Salugpongan community school.

Padul said she had written to the military for comment, but had yet to receive a reply.

On Monday, Davao del Norte Gov. Anthony del Rosario appealed to leftist groups to stop exploiting the lumad of Talaingod and work with the government instead.

Del Rosario said the arrest of Del Rosario said the arrest of Ocampo and his group had "exposed the wiles of the leftist organizations in using the [lumad] to push their agenda."—with reports from vince f. Nonato and Martsambalud INQ

Arrest of Satur, others proof they're NPA **AFP** chief

The arrest of former Bavan Muna party-list lawmaker Satur Ocampo and ACT Teacher's party-list Rep. France Castro in Talaingod, Davao del Norte last week was proof that they were active members of the New People's Army (NPA), Armed Forces of the Philippines (AFP) chief Gen Carlito Galvez Ir. said vesterday.

Ocampo and Castro, along with 16 other individuals caught transporting 14 minors aged 14 to 17 last week. Galvez said, were themselves carrying out the task of recruitment because they no longer have enough people on the ground

"We know they're active members of the NPA, that's why they were charged in Ormoc. Levte over Oplan Ahos," Galvez told reporters at Camp Aguinaldo, referring to the rebel purge in the 1980s.

President Duterte vesterday said law enforcers did the right thing in arresting Ocampo's group. His said children cannot be removed from their communities without consent of their parents.

"That is actually kidnapping. The victims are complaining. You heard they were lectured upon by the lamads. And it's like controlling the

lives of the natives. That's the problem with communists they use the *lumads,*" he said, vowing to protect police from counter-charges.

Galvez denied allegations Ocampo and the others were held on trumped-up charges.

"These are true, true reali-

ties," he said

Galvez added the people should know that lumad schools in Talaingod like the Salugpungan and Alcadev

are breeding grounds for NPA guerrillas

He said Ocampo and his militant supporters bring indigenous peoples (iPs) to Manila purportedly for exposure because the latter are the "most vulnerable sector *no knyo nilo*ng lokolun (that they can fool)."

AFP spokesman Brig. Gen. Edgard Arevalo earlier noted that the military has always believed in the rule of law and that it is now up to the courts

to look into the charges lodged against Ocampo and company.

He said the minors were taken without permission from their parents and "at the dead of the evening, in the dead of night."

Malacañang, meanwhile distanced itself from foreign affairs secretary Teodoro Locsin Jr.'s criticizing the filing of kidnapping charges against Ocampo and the others.

On Wednesday, joint forces from the Philippine Army and the Philippine National Police (PNP) аrrested Ocampo's group for allegedly transporting 14 students of a Lumad (natives) school during a "solidarity mission" in Talaingod, Davao del Norte. However, the former lawmaker and the others were released after posting bail.

"The people should know, that the "Salugpungan" and Alcadev (Lumad schools) are breeding grounds for NPA. What Satur did before is an exposure of this. There were those who surrendered from Alcadev and other areas of the Indigenous Peoples," Galvez told reporters in a chance interview with reporters after the flag-raising ceremony at Camp Aguinaldo, Quezon City.

"This proves that Castro and Satur Ocampo, they are active members of the CPP-NPA; we all know that that is why they have charges in...Leyte, he said.

CPP stands for Communist

Party of the Philippines.

The military chief also described Ocampo as a "propagandist" for the CPP-NPA, following his arrest in Talaingod, Davao del Norte for the alleged kidnapping of the students.

These are not trumped-up charges, these are true realities. We have to look for the truth, this is the truth," he added.

He also pointed to the previous arrests of National Democratic Front consultants Adelberto Silva and Vicente Ladlad.

"[The CPP-NPA] does not have anyone to use anymore, Satur Ocampo is now [being used] because they have no one already to command. And as far as we are concerned, the last bastion of the CPP-NPA are the indigenous peoples since they are the most vulnerable sector," Galvez also said.

Duterte backs arrests

President Rodrigo Duterte on Monday backed the move of police to arrest Ocampo and Castro for conducting a solidarity mission in

Davao del None, saving they did the right thing,"

He said that Ocampo and Castro should know that what they did during the solidarity mission was "kidnapping."

"You should be aware that you cannot move children from one community to another without the consent of the parents. That is actually kidnapping. The natives complained, you heard they were lectured upon by the Lumad, they are controlling their lives," Duterte said.

"I think the police did the right thing, respective of the intention You know, we might have been motivated by all the good intentions in the world but there is the intent which is criminal in bringing out the transferring children from one area to another, especially using them in the struggle. That is what the communists are doing. Why should we fool ourselves?" he added.

'Titles, duties lost'

Ocampo and Castro denied the charges.

"It's a rule that after a long imprisonment or once a supposed suspected leader of the CPP-NPA is arrested, he loses all the titles and the duties in the revolutionary movement," Ocampo said in a television interview.

"I am not a member of the CPP-NPA, Galvez. You are putting my life in danger. Whatever happens to me, Galvez, I will hold you accountable." Castro said

I advocate for the welfare of teachers That is what I am fighting for. We already know what happens to those who are being redtagged by the military. Whatever happens to me, it will surely be the AFP's fault," the lawmaker said.

On Saturday, Tagum City Executive Judge Ariene Palabrica issued a supplemental order to release Ocampo, Castro, and 16 others after they each posted P80,000 cash bond.

Other members of the "Talaingod 18" who were named in the order were Meggie Nolasco, Pastor Edgar Ugal, Rev. Ryan Magpayo, Pastor Eller Ordeza, Rev. Jurie laime, Jesus Modamo, Maryro Poquita, Maria Concecion Ibarra, Jenveive Paraba, Merhaya Talledo, Maricel Andagkit, Marcial Rendon, Ariel Ansan, Mariane Aga, Nerfa Awing, and Wingwing Daunsay,

"Section 17 (c) of the Criminal Procedure provides: Any person in custody who is not yet charged in Court may apply for bail with any Court in the province, city or municipality where he is held," the order read.

"As the above-named respondents are still presumed innocent and no Information have been filed against them, their supreme right to liberty must be upheld," it added.

Satur, solon tagged CPP-NPA members

ARMED Forces chief Gen. Carlito Galvez Jr. yesterday tagged former Bayan Muna party-list Rep. Satur Ocampo and Rep. France Castro of the party-list group ACT Teachers as active members of the Communist Party of the Philippines-New People's Army.

Castro accused Galvez putting her life in danger by tagging her and Ocampo as CPP-NPA members.

"I'm in danger. If anything bad happens to me, the AFP is behind

it. I'm not a member of the NPA, Galvez. I'm just making it clear to you," she said. "If anything happens to me, I will hold you accountable, General Galvez."

Speaker Gloria Arroyo took the cudgels for Castro, saying that like other House members, she should be "entitled to a certain level of dignified and respectful treatment in situations such as this, particularly since our judicial system is based upon the principle of presumption of innocence.

Arroyo also said she has known

Ocampo personally "and I pray that he, Rep. Castro, and their co-respondents are well and will continue to be so until this matter is resolved."

Ocampo was among the staunchest critics of Atroyo when she was president.

President Duterte said it is public knowledge that Bayan and Bayan Muna, along with other militant groups like the Kilusang Mayo Uno and Gabriela, are fronts for the Communist Party of the Philippines which he said is out to topple his government.

He said these militant groups often bring in young people to certain areas under the guise of

immersion programs.

"Bayan is a front of the Communist Party of the Philippines. You know there is war going on, kung magkaroon barilan diyan (if there is a shooting there) you put their lives in jeopardy," said Duterte who revived peace negotiations with the communists after he assumed the presidency in 2016 but cancelled the formal peace talks last year because of continued attacks by the NPA.

Duterte also said Ocampo's group violated laws, including transporting the minors without their parents' consent and placing the children in danger.

Ocampo and Castro were among 18 people arrested last week by the police and military for taking 18 students from the Salugpungan School, a special learning center put up by the Left in Talaingod town in Davao del Norte.

The 18 were charged with violation of Republic Act 7610 or the Special Protection of Children against Abuse, Exploitation and Discrimination Act after their arrest on Wednesday. Each posted an P80,000 bail and were released from detention last Saturday.

Prosecutors did not accept the PNP case of kidnapping against the group but PNP chief Oscar Albayalde said the kidnapping case will be re-filed, based on affidavits of some of the parents of the children.

Galvez said Ocampo and Castro are behind the establishment of the Salugpungan School, which is allegedly teaching communist ideals, and similar schools in areas of indigenous peoples, and turning their students into members of the NPA, the communist party's armed wing.

Galvez said five of the students from these communist schools who became NPA members surrendered to the Armed Forces in Northern Luzon this year.

"This really proves that Castro and Satur Ocampo are active members of the CPP-NPA. We all know that. And they have charges before in Leyte, in connection with Oplan Ahos," said Galvez.

Galvez was referring to the purging operation of the communist movement in Inopacan, Leyte in the 1908s. The remains of the victims — who are rebels and civilians suspected as military spies — were exhumed by the military in 2006.

Galvez said the latest case filed against Ocampo and Castro are not trumped-up charges, disputing Ocampo's allegations that he and his group were just rescuing the children from military harassment.

Galvez described Ocampo as a

"propagandist" of the CPP-NPA, which President Duterte classified as terrorist organizations last year. Peace talks between the communists and the government have been terminated by the President.

Chief Presidential Legal Counsel Salvador Panelo said criticisms made by Foreign Affairs Secretary Teodoro Locsin Jr. through social media against the arrest of Ocampo's group is the secretary's "personal position" and "does not reflect the official view of the administration on the issue."

"We therefore consider the remarks of Secretary Locsin as personal sentiments supportive of a friend, being former colleagues with Mr. Ocampo in Congress. Friendship, however, does not give birth to the conclusive conclusion that a person charged of a crime is innocent nor does a charge sheet automatically make such individual guilty thereof," Panelo said.

Locsin served as representative for the first district of Makati from 2001 to 2010 while Ocampo was the Bayan Muna representative during the same period — With

Castro, Ocampo deserve dignified treatment, Arroyo says

SPEAKER Gloria Macapagal Arroyo on Monday urged the authorities to treat ACT Teachers Party-list Rep. France Castro and former congressman Satur Ocampo with dignity and respect, after the two were arrested on Nov. 28 in Davao del Norte

"They entitled to a certain level of

dignified and respectful treatment in situations such as this, particularly since our judicial system is based upon the principle of presumption of innocence," Arroyo said in a statement. "This is my position regarding any member of the House, regardless of political or ideological alignment."

"At the same time the House will always uphold the law and its processes. I understand that they have been given 10 days to file their counter affidavits in order to refute the charges against them, and I would urge a speedy resolution of the matter within the framework of our judicial system," she said.

"I have long known former Rep. Satur Ocampo personally, and I pray that he, Rep. Castro and their co-respondents are well and will continue to be so until this matter is resolved."

Arroyo said she learned of their arrest through Gabriela Reps. Arlene Brosas and Emmi de Jesus, who called on her to look into their situation.

The leftist Makabayan bloc in the House said they would file charges against Armed Forces chief Gen Carlito Galvez Jr. for accusing Castro of being a member of the Communist Party of the Philippines and its armed wing, the New People's Army

"We will file a case sa Ombudsman against the military," Anakpawis Partylist Rep. Ariel Casilao, a member of the bloc, said at a news conference.

"This very dangerous and baseless statement," he added.

Casilao said Galvez was quoted as saying that Ocampo was as a "propagandist" of the CPP-NPA, and that the Salugpongan Tatanu Igkanugon Community Learning Center in Talaingod, Davao del Norte, and the Alternative Learning Center for Agriculture Livelihood Development are "breeding grounds" of the NPA

Castro denied she is an NPA member. Castro, Ocampo, and 16 others have been charged with kidnapping and human trafficking for allegedly taking custody of minors during their solidarity mission in Talamgod, Davao del Norte, on the evening of Nov. 28

All of them were released from detention on Saturday night after they each posted P80,000 bail for their charges.

Philippine National Police chief Oscar Albayalde rejected a challenge from a legislator that he visit the Lumad school that the military and police say is a communist breeding ground. "There's no need to visit them because when you get there, they'll be teaching something else," he said in Filipino. "That's not what our IPs (indigenous people) say We believe them. You could just imagine, they were exploited there and their minds were poisoned. Even their children."

Earlier, Castro dared Abayalde and the police to visit Lumad schools to check on their condition.

But Albayalde said he had no interest in visiting a Lumad school, where he said IP students were being brainwashed by the communists.

"What they are teaching is how to rally and other ways to help the [communist] movement," he added.

Albayalde rejected suggestions that Castro and Ocampo were arrested on

trumped-up charges.

"We cannot fabricate charges because that won't stand in court. We can never fabricate charges. If there is no complainant, there are no charges," he said, citing the complaint filed by parents and relatives of the children.

Castro said Albayalde's refusal to visit Lumad schools reflects his ignorance.

Ocampo, meanwhile, denied allegations that the communists were recruiting minors through the Lumad schools

In an interview with ANC Headstart, Ocampo said the communists had "a rule against recruiting minors."

"The NPA operates in the hinterlands. It so happens that most if not all of the communities of the Lumads are in the hinterlands, so they become battle-ground areas. It is not surprising that the NPA has its main objective of organizing the people in the struggle for their own welfare," he said.

NPA killed in Sarangani clash with military

ALABEL, Sarangani - A New People's Army (NPA) rebel was killed in a firefight with soldiers who were providing security to medical personnel dispatched to contain a measles outbreak in a mountain village in Malapatan town.

First Lt. Leah Canseran, civil military operations officer of 1002nd Infantry Brigade, said soldiers belonging to 73rd Infantry Battalion were escorting personnel from the Integrated Provincial Health Office to Barray Upper Suyan, Malapatan when they were waylaid by five suspected Communist rebels in hinterland village of Barangay Kihan, Malapatan over the weekend.

Canseran identified the slain NPA rebel as Sue Boding, an alleged member of NPA Guerilla Front 71 and a resident of Barangay Little Baguio, Malita, Davao Occidental

Troops recovered a .45 caliber pistol from the slain suspect.

Sarangani Governor Steve Solon had earlier sought the assistance of the military to serve as escort for the medical personnel he dispatched to contain an outbreak of measles in Barangay Upper Suyan which had killed at least 20 children and hospitalized 100 others.

National police chief Director General Oscar Albayalde clarified yesterday that the New People's Army (NPA) still maintains a group of hitmen

The hitmen according to Albayalde, are responsible for the death of 136 soldiers, policemen, local officials and even rebel returnees in the past three years.

"These hit squads are now popularly referred to as the Sparrows. But they are not based in urban areas like the former Sparrow Unit, but only gets out from the red area (normally rural area) to do special partisan operations like liquidation, murder or assassination, as directed by the Regional Party Committee," said Albayalde.

The latest assassinations carried out by the NPA hit squad, according to Albavalde, was the killing of two Army soldiers at the Las Navas public market in Northern Samar last Nov 27, the assassination of Philippine Navy Sr. Chief Petty Officer Jesus Zaavedra in Pio Duran. Albay and the botched assassination in Catbalogan City of ex-Mayor Aran Boller of Matuginao. Samar

Over the weekend. Albayalde had said that the Special Partisan Unit or SPARU of the NPA has long been gone. But Albayalde, in yesterday's press briefing, clarified that he was referring to the notorious hit squad, which is the defunct Alex Boncayao Brigade (ABB) of the Manila-Rizal Regional Party Committee of Filemon Lagman, belonging to the rejectionist wing of the CPP/NPA/NDF (Communist Party of the Philippines New People's Army National Democratic Front) led by Arturo Tabara and Romulo Kintanar.

He said that it was disbanded by the pre-Sison wing of the CPP/NPA/NDF in early 1990's during its second Rectification period.

"But since then, the pro-Sison reaffirmist wing also adopted its Sparrow-like operations against perceived enemies reportedly including the assassinations of Popoy Lagman, Arturo Tabara and Romulo Kintanar in early 2006," said Albavalde.

"There is strong possibility that it will stage more hits depending on how the communist movement would want to utilize the Special Partisan Unit/Special Operations Group specialized capability for small unit missions against vulnerable targets." he added.

The issue about the NPA squad was revived after President Duterte was quoted as saying that he wants to create a government version of hit squad targeting communist rebels.

Ata-Manobos want 'salugpungan' schools out

WITH their thirst for education. members of Ata-Manobo communities in Talaingod, Davao del Norte once welcomed schools known in their communities as "salugpungan," the local term for unity. But they soon found out that what they thought was a blessing. brought with it a curse.

In a protest action recently, they called for closure of the schools.

Datu Lumansad Sibogan, spokesman of the Talaingod Tribal Council of Elders, admitted he had a part in putting up the salugpungan schools some years back. He thought that having them especially in far-flung Sitio Nasilaban, Barangay Palma Gil, would be good for the young Ata Manobos who then had no schools

NPA-influenced

In two interviews with the Philippine Information Agency (PIA), Sibogan said he had faith in the salugpungan but this changed when he found out New People's Army (NPA) commanders were dropping by the

schools and the teachers were receiving them well. He said he knew them because he was once an NPA recruit himself.

Despite this, he noted that the students were learning but also worried about the mindset that such schools were developing among the young people, having once observed them being taught how to dismantle firearms during a night session.

"They're taught the right curriculum during the day but differently at night. Upon graduating, they'd have chaotic mindsets. he said in an interview before his group staged a protest action against the school.

Absence of tribal consent

His group is also protesting activities of nongovernment organizations (NGOs) that do not have tribal consent, citing the recent report on the alleged entry in Talaingod of NCO workers in eight vans with children onboard identified as

salugpugan school students.

Sibogan expressed concern over mothers looking for their children later found among those on board the vans held at a checkpoint by the Talaingod Municipal Police Station.

He cautioned the NGO personalities "not to come back otherwise something will happen to them."

Meanwhile, Abenad Bago, 20, who was at the protest rally said an NGO personality being held at Talaingod was among those running the salugpungan schools.

Abuses on young IPs

Bago was furious about how he and other young Ata-Manobos were sent to join protest rallies against the government, how they were made to believe in twisted education and in false information. He also confided that he was sexually abused by a gay salugoungan teacher.

"In our culture, we could execute him for having violated our human rights," he said referring

to the NGO personality and the gav teacher.

On the other hand, Manuel Salangani, 24, confessed to having the same experience as Bago and added that he was made to join protest rallies as a school requirement.

"We were taken wherever. What was supposed to be important was for us to still get grades for joining rallies," he told the PIA.

Later he found out that he had no grades, not even school records. He was not accepted in a public school for failure to present the necessary document required of transferees.

"That school [salugpungan] is not helping me," he said.

Sibogan, Bago and Salangani were among some 300 Ata Manobos who joined the November 30 activity that became a venue for expressing their disgust They called for self-governance and demanded that NGOs stay out of their place. They wanted their children to go through the generally accepted system of education. armed with the right knowledge, unarmed and not harmed A7

the consent of the parents," Mr. Dutorie said on the incident.

"That is actually kidnapping," he said in an interview after bestowing the Posthumous Quezon Service Award to the late Senator Miriam Defensor-Santiago

"That is the usual problem with communist rebels, they use the Lumads which is now the reason why many members of the tribe are dead," he said.

Retiring Armed Forces of the Philippines (AFP) Chief of Staff Gen. Carlito Galvez described the Salugpungan Community Learning Center and ALCADEV Lumad School where the tribal children were being taken as breeding grounds for New People's Army (NPA) rebels.

"What we saw in Talaingod (Davao del Norte) is how Salugpungan and ALCADEV are used as breeding grounds for the NPA. What they do is they bring the children here in Manila, which is an exposure. The five who surrendered in the north came from ALCADEV and from indigenous communities and this only proves that Ocampo and Castro are active members of the Communist Party of the Philippines (CPP)," Galvez explained.

He added his claim was already vouched for by Lumad leaders: "Now, we see that the last bastion of the CPP-NPA is the indigenous peoples (IP), because they are the most vulnerable sector whom they can deceive."

Ocampo's group was accused of violating Republic Act 10364 or The Expanded Anti-Trafficking in Persons Act of 2012 and Article 270 of the Revised Penal Code, which defines and provides penalty on the offense of kidnapping and failure to return a minor.

Ocampe and Castro claimed they were part of a humanitarian mission in Talaingod, Davao del Norte due to reports that students of these Lumad schools were fleeing the area following their closure.

Mind-conditioning sessions

The Department of the Interior and Local Government (DILG) also commended the Philippine National Police (PNP) and the local government unit of Talaingod for rescuing 14 minors and arresting the alleged perpetrators of kidnapping and child-trafficking led by Rep France Castro of ACT Party-list, Ocampo and other suspects in Davao dei Norte last week.

We laud our law enforcement agencies for their quick response to parental complaints of child disappearances and the immediate arrest of Castro, Ocampo, and company," Interior Secretary Eduardo Año said.

He explained that the DILG "will make certain that all those guilty for these abhorrent acts against the vulnerable and innocent will face the full effect of the rule of law."

The DILG chief also deplored the brainwashing of the youth by the CPP New People's Army (NPA)-National Democratic Front of the Philippines (NDFP) and their communist from organizations.

He said the mind-conditioning of these organizations were meant to instill hate toward their fellow Filipinos "under the guise of nationalism and humanitarian nussions."

"We do not condone such reprehensible behavior against minors and condemn the communist and their allies for their sins against the youth such as kidnapping, child trafficking and other illegal treatment of children," Año added.

Trust courts

Ocampo, his companions and their supporters will have to trust the legal process and not jump into premature judgment, Presidential spokesman Salvador Panelo added.

"That is what the rule of law is all about. The law hears before it convicts, and it hears before it acquits as well," Panelo stated.

He added the Palace did not have a hand in the arrest of the leftleaning group.

Ocampo along with ACT Toacher's party-list Rep. France Castro and 70 others were arrested last 29 November in Davao del Norte on allegations of human trafficking and lidnapping.

They have since been allowed to post ball for their temporary freedom and was granted their request to have a preliminary investigation to refute the accusations and present evidence to support their defense. The legal proceeding was proof that Malacañang is not meddling in the case and those accused 'are being accorded due process."

The last bastion of the CPP-NPA is the indigenous peoples because they are the most vulnerable sector whom they can deceive.

"We thus reiterate our advice to all parties to trust the process without hasty and prematurejudgments. Let the legal mechanism work as it should," he said.

Personal view

Panelo added Foreign Affairs Secretary Teodoro Locsin's remarks criticizing the arrest of Ocampo "does not reflect the official view of the administration."

The Foreign Affairs chief called accusations against Ocampo as "bullsh":

Locsin and Ocampo served in the House of Representatives at the same time, reason why the country's top diplomat said he "knows Ocampo" and added that the House "protected him against warrants."

Locain, a former media man, was Makati Ist District representative from 2001 to 2010, while Ocampo led the Bayan Muna Party-list group in three successful elections: 2001, 2004 and 2007. He also served as Deputy Minority Leader in the 14th Congress.

However, Malacañang views Locsin's defense of Ocampo as "personal sentiments supportive of a friend being former colleagues," according to Panelo.

Resolve case unickly

For her part,
Speaker Gloria
Macapagal-Arroyo
said the case filed
against Ocampo's group
should be resolved quickly

"I understand that they have been given 10 days to file their counter affidavits in order to refute the charges against them, and I would urge a speedy resolution of the matter within the framework of our judicial system," Arroyo said in a statement.

The former chief executive said that she was called on by Gabriela Party-list. Representatives Arlene Brosas and Emmi de Jesus to look into the situation of Castro, Ocampo and 17 others who were charged in Davao del Norte.

"My position regarding Rep. Castro is that the House is a body of elected representatives of the people and that all its members such as Rep. France Castro are entitled to a certain level of dignified and respectful treatment in situations such as this, particularly since our judicial system is based upon the principle of presumption of innocence, Arroyo explained.

She said that this is her position regarding all members of the Lower House regardless of their political or ideological alignment.

cadets dismissed

Philippine National Police (PNP) Director General Oscar Albayalde on Monday confirmed the dismissal of the three cadets who were tagged as principal accused in an oral sex scandal inside the police academy.

The order came less than a month after President Rodrigo Duterte expressed his disgust on the incident and ordered that the cadets be immediately kicked out from the PNP Academy.

Albayalde said the Philippine Public Safety College has recommended the dismissal of the three students from cadetship after forcing two underclassmen to perform oral sex on each other.

"The order for their dismissal is already for signature and it will be signed today," Albayalde said in a press briefing.

Sacred cows

The three dismissed PNPA cadets, however, can still appeal their case within 15 days, the PNP chief explained.

He also stressed that they will not have any sacred cows in their organization.

"We should really show no mercy on cadets doing this act, because it will become a precedent," said Albayalde.

One of the three cadets is said to be the son of a PNP general, who is reportedly assigned in Region 6. The father of one of the victims is an official of the Bureau of Jail Management and Penology.

The order for their dismissal is already for signature and it will be signed today.

The incident took place last 6 October at the barracks of the PNPA campus in Silang, Cavite.

The senior cadet allegedly ordered the plebes to perform oral sex on each other while the two other cadets watched.

Command responsibility

Then PNPA director Chief Superintendent Joseph Adnol was sacked for command responsibility

It was also during Adnol's watch when nine cadets were beaten up by six upperclassmen after their graduation rites in March

The cadets were found guilty of violating Rule 5 of PNPA cadet guide on sexual misconduct, undesirable traits and conduct unbecoming of an officer or acts immical or prejudicial to good order or discipline.

Death squad

Meanwhile, Albayalde backpedaled from his earlier declaration and insisted that the New People's Army (NPA) still has a special death squad unit.

Albayalde clarified that the NPA 'sparrow unit' that he was referring to that no longer exists was the notorious Alex Boncayao Brigade (ABB) led by Filemon Lagman, Arturo Tabara and Romulo Kintanar.

"It (ABB) was disbanded by the pro-Sison wing of the CPP/NPA/ NDF in early 1990's during its 2nd rectification period" he explained.

But since then, the pre-Sison wing also adopted its Sparrow-like operations against their perceived enemies." Albayalde continued.

"Over the past three years, there had been 136 hits on soldiers, policemen, rebel returnees, local officials and tribal leaders by attributed to its special partisan unit based in the "red areas."

LANAO LEADERS SUPPORT

MADALUM, LANAO DEL SUR -Traditional leaders from two Lanao provinces have pledged their full support for the implementation of the Bangsamaoro Organic Law (BOL) as those living within the Bangsamoro territorial jurisdiction were expected to vote for its ratification in a plebiscite on Jan. 21.

During their assembly at Barangay Poblacion here on Nov. 29, 500 leaders from Lanao del Sur and Lanao del Norte said they wanted to have the BOL ratified so the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) could be established

Support

The BARMM will replace the Autonomous Region in Muslim Mindanao

Sultan Usman Sarangani Sr., the Sultan of Uya-an and reigning paramount sultan of Mindanao, said the gathering was a venue for them "to amplify and ventilate salient provisions of the organic law to make them understand and appreciate it and encourage them to support the measure.

Among those who attended the assembly were leaders of the 15 royal houses and the 28 legislative councils, or the "mubabaya ko taritib" of the two Lanao provinces.

Sarangam said the assembly, with the theme "Unity, Solidarity and Teamwork," was the first of its kind in Lanao.

He said they hoped the BOL ratification and the establishment of the BARMM would lead to a "better and comfortable life for the Bangsamoro people."

Promoting peace

The BOL, he said, had recognized the importance of traditional leaders in Bangsamoro society, making it mandatory for them to play a pivotal role in promoting peace and order, preventing conflict, and in campaigning for the law's ratification.

"[We] will also work for the unification of the traditional leaders and encourage the search for solution to [their] differences," he said.

Adan Abdullah, who represented Ghadzali Jafaar, first vice chair of the Moro Islamic Liberation Front's (MILF) central committee and chair of the Bangsamoro Transition Commission (BTC), said he would convey to the MILF leadership what had been agreed upon by the traditional leaders, especially on their support for BOL ratification

He said the traditional leaders "have the responsibility to support governance," as he thanked the freedom fighters for "helping push the idea of self-governance and self-determination."

"No tribe of the Bangsamoro will be left behind," Abdullah added. 12

Army supports Duterte's plan to deploy more forces in BaSulTa

In a statement, Army spokesman Col. Louie Villanueva said they believed the plan of upgrading forces in those areas will hasten the neutralization of the Abu Sayyaf Group and other threat groups operating there.

He added that sending additional troops will also hasten delivery of essential basic services as part of its support plan in collaboration with other government agencies

"Currently we don't have a division in the BaSulTa area. What we have right now is Joint Task Force (JTF) Basilan and JTF Sulu," Villenueva said.

Villanueva said hundreds of troops were already deployed in the area in efforts of neutralizing the enemy

Meanwhile, Lt. Col. Gerry Besana, spokesman of the Armed Forces of the Philippines-Western Mindanao Command (AFP-WestMinCom), said there are still more than 300 remaining ASG terrorists in the BaSulTa areas based on the Joint AFP and Philippine National Police (PNP) Intelligence Coordinating Council.

He added that based on their latest count, the Abu Sayyaf was still holding six hostages – tour Filipinos, one Dutch and a Vietnamese national – all being held in Sulu.

Besana said troops were already scouring the area to rescue the remaining victims.

Defense Secretary Delfin Lorenzana earlier said they will create another military division to send to Sulu to once and for all rid the province of the ASG.

In an interview, Lorenzana said they will recruit more people to fill up the division and fulfill the mission of eradicating Sulu of the terrorist group.

"We are going to create another division. We will have permanent presence in Sulu and eliminate once and for all the Abu Sayyaf," Lorenzana said.

"We are going to recruit more people for that division," he added.

President Duterte announced last week the imminent troop movement after expressing dismay over a deadly clash between government forces and the Abu Sayyaf bandits in Patikul, Sulu more than a week ago. The encounter, which left five soldiers dead and several others wounded, was considered a "flashpoint" by the President.

"We visited a wake at Cauayan I was with (Defense) Secretary (Delfin) Lorenzana and (Interior and Local Government) Secretary (Eduardo) Año. I talked to them and complained about why so many of my soldiers in Jolo are dying," he said during a visit to a military camp in Bohol.

Quevedo calls for more

dialogues to promote lasting peace

COTABATO CITY - Retired Cardinal Orlando Quevedo on Sunday called for continuing dialogues to promote true understanding and lasting peace in the country, especially in Mindanao's troubled communities.

In a statement issued in time with the observance of Mindanao Peace Week, Quevedo urged the conduct of more dialogues that are "not merely intellectual discussion (but characterized by) all listening humbly and respectfully to the other"

"Dialogues should entail listening with one's ears, but most importantly listening with one's heart." said Quevedo, the country's eighth cardinal who retired on November 6, and was replaced by Jolo Bishop Angelito Lampon.

He cited as example the kind of dialogues that made peace possible between the forces of the government and Moro Islamic Liberation Front (MILF).

He said Mindanao was already on the "threshold of definitive peace," referring to the Bangsamoro Organic Law (BOL) that stemmed from two major peace accords forged by the government and the MILF in 2013 and 2014.

The BOL, officially known as R.A. 11054, seeks to create the Bangsamoro

Autonomous Region in Muslim Mindanao (BARMM) in lieu of the 29-year old Autonomous Region in Muslim Mindanao (ARMM).

It calls for the conduct of a plebiscite on Jan. 21, 2019 in ARMM and other areas proposed for inclusion in BARMM, namely the cities of Cotabato and Isabela, six towns in Lanao del Norte and 39 villages in six North Cotabato towns.

After his retirement, Quevedo had vowed to continue advocating peace dialogues relative to the BOL implementation stages

He had earlier told The Manila Bulletin he would rally actively for the inclusion of this city into the BARMM, unlike in 1989 and 2001 when church leaders played key roles in the residents' disapproval of inclusion in the Autonomous Region in Muslim Mindanao (ARMM).

Quevedo attended here on Sunday the launch of MILF Vice Chairman Mohager Iqbal's book entitled "Negotiating Peace: An Insider's Perspective to the Bangsamoros' Struggle for Self-Determination."

The book compiles Iqbal's chronologically-arranged speeches delivered from 2005 to 2016 as the MILF engaged in peace negotiation with the Philippine government.

16 suspects in slay of 3 farmers arrested

KIDAPAWAN CITY – Assisted by Muslim and Christian residents advocating peaceful coexistence, police operatives arrested 16 suspects in the killing of three Moro farmers in an ambush in Matalam, North Colabato over the weekend.

The 16 suspects were collared one after another in a police pursuit operation launched an hour after they allegedly waylaid a convoy of motorcycles bearing some ethnic Muslim farmers. Three of them died on the spot along Barangay Kibudoc in Matalam, a town adjacent here, on Saturday, the provincial police office here announced Sunday.

The three fatalities were identified as George Dilangalen, During Panga and Mohammad Angeles, who were said to be members of a Moro National Liberation Front (MNLF) faction led by the late Dima Ambil, a field leader of MNLF founding chairman Nur Misuari

Taher Guiambangan Solaiman, a North Cotabato-based official of the Mindanao Human Rights Action Center, called for a thorough probe of the ambush-slay, not only to give justice to the fatalities and their families, but also to prevent a repeat of bloody fighting between Moro natives and Christian settlers in the province in 1970s.

The arrested ambush suspects were led by Joel Bolante, 41, whose Ilongo family has been locked in a land dispute with relatives of the fatalities, Matalam police investors said.

Also detained at the town police station pending formal criminal charges were Romar Prado, 29, Redmar Samson, 32; Reynaldo Mosquera, 41; Efren Mosquera, 51; Warlito Mosquera, 37, Danilo Mercado, 25; Lando Helera, 43, Jonathan Viajante. 42; Alvin Villarin, 30; Dennis Olvido, 34; Johnny Patria, 27; and four minors, all Visayan residents of Matalam's Barangay Estado.

The three fatalities were traveling together aboard separate motorcycles on Saturday when their attackers emerged from the roadside, and peppered them with shots from mostly vintage rifles, which reportedly belonged to Visayan kin-members of the paramilitary Citizens Armed Forces Geographical Unit (Cafgu), initial investigations said.

16 SUSPECIS IN ambusins layof a famers nabled

KIDAPAWAN CITY — Sixteen suspects tagged in the ambush siay of three Moro farmers have been arrested in Matalam, North Cossbato.

Police nabbed 41-year-old Joel Bolante whose flongo family has been locked in a land dispute with relatives of the victims.

Also detained at the fown police station pending formal criminal charges were Romar Prado, 29; Recmar Samson, 32; Reynaldo Mosquera, 41; Efren Mosquera, 51; Warlito Mosquera, 37; Danilo Mercado, 25; Lando Helera, 43; Jonathan Viajante, 42; Alvin Villarin, 30; Dennis Olvido, 34; Johnny Patria, 27; and four minors.

all Visayan residents of Matalam's Barangay Estado.

The suspects were picked up one after the other, an hour after they allegedly waylaid a convoy of motorcycles carrying some ethnic Muslim farmers in Barangay Kiburlor.

The fatalities were identified as George Dilangalen, During Panga, and Mohammad Angeles, alleged to be members of a Moro National Liberation Front (MNLF) faction led by the late Dima Ambil, a field leader of MNLF founding chairman Nur Misuari.

Taher Golambangan Solaiman, a North Cotabato-based official of the Mindanao Human Rights Action Center, called for a thorough probe of the ambush-slay not only to give justice the fatalities and their families but also to prevent a repeat of bloody fighting between Moro natives and Christian settlers in the province in 1970s.

Police said the suspects were armed by vintage rifles, which reportedly belonged to Visayan kin-members of the paramilitary Citizens Armed Forces Geographical Unit.

ARMM officials optimistic of new law

COTARATO CITY: Officials of the Autonomous Region in Muslim Mindanao (ARMM) are optimistic that the incoming leaders of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) will bring out the best among students under their watch.

The BARMM will replace ARMM if the Bangsamoro Organic Law (BOL), the enabling measure for such a change, is ratified via a plebiscite on Jan. 21, 2019.

Rasol Mitmug ir., Department of Education (DepEd)-ARMM secretary, said the upcoming BARMM political entity would be proud of how students in the present autonomous region are at par with those in the Visayas, Luzon and in Metro Manila.

Mitmug said seven students from public schools recently brought honor to ARMM at competitions in Metro Manila and abroad.

Ricco Teraytay of the Camp Siongco National High School in Datu Odin Sinsuat, Maguindanao was a finalist in the 2018 World Taekwondo Poomsae Championship held from November 15 to 18 in Taipei, Taiwan with 59 countries participating.

Yahser Malang of ARMM's Regional Science High School, was one of two grand finalists in the Southeast Asia Video Festival held on November 24 in Manila.

"The DepEd-ARMM and our regional governor, Muliv Hataman, are glad of the honor they brought home, all seven of them," Mitmug said.

Aside from Teraytay and Malang, five more students of the Parang National High School in Parang, Maguindanao were champions in the Science Inventory Project contest held on November 16 in Olongapo City.

Meanwhile, Hataman said he was certain the Moro Islamic Liberation Front (MILF), which will lead the BARMM, would sustain the education programs of the present autonomous regional government.

The MILF will lead the transitory team that would oversee the transition from ARMM to BARMM pending the election of its pioneering set of regional officials

"We don't have an iota of doubt on the capability of the MiLF to pursue the education and extra-curricular advancement of ARMM's Muslim, Christian and lumad elementary, high school and college students. That's why we will vote in favor of the Bangsamoro Organic Law during the plebiscite next year," he said. 力JULMUNIR I. JANNARAL

Utterly unacceptable

umors that he ran a death squad to crack down on crime when he was mayor of Davao City has hounded President Duterte for years. His campaign threats to fatten the fish in Manila Bay with the corpses of drug users might have hinted at his atavistic instincts for solving social problems, but his allies and supporters have typically dismissed such talk as the usual braggadocio of a tough-talking politico.

Last week, Mr. Duterte once again seems to have confirmed killing as a preferred policy, when he announced that he was forming his own hit squads to deal with communist rebels or sympathizers. "I will create my own Sparrow," the President said, referring to the New People's Army's (NPA) unit that targeted police, military and government officials in urban areas during the 1980s.

"(The death squads) will do nothing but look for idlers who are prospective (NPA) members and take them out," the President said, adding that his instructions to the "Duterte Death Squad"—armed civilians not from the community to be posted in public places like transport terminals—would be "to get one or two" rebels.

Critics and horrified observers were quick to denounce Mr. Duterte's plan for a presidential team of assassins, calling it downright illegal. It is more than that. It is a reprehensible, utterly unacceptable idea, one that should never be legitimized in a society that calls itself, or aspires to be, democratic and governed by the rule of law.

Mr. Duterte's announcement came barely a week after he had issued Memorandum Order No. 32, which deployed additional police and military forces in Samar. Negros Island and the Bicol Region to deal with what Malacanang described as "lawless violence." The monumental irony in the President's death-squad proposition, however, is that it is the very definition of lawless violence—men empowered

to act above, or to arrogate unto themselves, the law,

How would these vigilantes go about their job targeting loiterers, "prospective" NPA recruits and just about anybody they suspect of being a communist sympathizer? Would psychic powers be a qualification to join such a force, for the killers to divine which Filipinos are wont to harbor sentiments and ideas deemed undesirable by this administration?

The appalling implications of the President's words were typically lost on presidential spokesperson Salvador Panelo, who said civilians should even be "relieved" that such a hit squad meant to defend soldiers and civilians from communist violence is being considered. Justice Secretary Menardo Guevarra, meanwhile, tried to explain them away as signature Duterte hyperbole. "We should always understand that kind of statement to mean. Use reasonable force to apprehend suspected assassins."

Like-minded people, however, unsurprisingly seemed to know exactly what the President meant. Former police chief and now senatorial aspirant Ronald "Bato" dela Rosa came out swinging for Mr. Duterte's proposal, on the grounds that "Yung mga NPA lang ba ang puwedeng sige, patay nang patay ng government troops? 'Di ba unfair 'yan? So ang gobyerno maghanap din ng paraan para makabawi din sa kanila 'di ba. Tagal na 'yung problema natin sa insurgency na 'yan dahil palaging nakatali 'yung kamay natin (Isn't it unfair that only the NPAs are allowed to kill government troops? The government must have a way to get back at them. We've had an insurgency problem for so long because our hands are tied)."

Alas, the only thing revealed by Dela Rosa's remarks, aside from his unqualified loyalty to his boss, is how, even after formal education and years of experience in the police force, he has apparently yet to grasp a fundamental principle: that the entire rubric of law and regulation and protocol that supposedly ties the hands of the police is what makes them officers of the law in the first place. Dela Rosa is not a cop because of his gun, but because of his badge—the symbol of the state authority that deputizes him as an enforcer of the law. Without the rule of law behind him to justify his use of a gun, he would be no different from a handit—or, for that matter, from the prospective gang of hitmen he's now championing unthinkingly.

How many more cops and men with guns may end up seduced by the siren call of impunity from on high? Caloocan City Judge Rodolfo Azucena Jr., who recently convicted three policemen for the murder of teenager Kian delos Santos, has a stark warning for the government and his fellow Filipinos in his decision: "A shoot first, think later attitude can never be countenanced in a civilized society."

The South starts to 'Sulong'

EW large property developments in the last two weeks in Northern and Southern Mindanao are a fresh batch of private sector investments that will dovetail with government infrastructure programs and create further opportunity in areas never thought possible.

Developers like Ayala Land and Cebu Landmasters Inc. (CLI) are betting big or Mindanao. Ayala's Habini Bay, a 526hectare master-planned estate located within the municipalities of Alubijid and Laguindingan, Misamis Orientai

Located near the midpoint of Cagayan de Oro and Iligan, bring a new wave of Investments to the Cagayan Iligan corridor, and pull up growth in the Lanae and Bukidnon provinces

Meanwhile, publicly listed CLI brings the 20-hectare Davao Global Township, a central business district that will bring in investors to build properties to spur further growth in the two southern Mindanao regions, as Socksargen and Davao, currently on the crest of 8 and 11% growth, respectively.

In the consolidated actionable recommendations of the recent "Sulong Pilpinas" multisectoral regional consultations in Clark, Davao Cebu, and La Union, agricultural productivity and raising farmers incomes through education and technologies emerged as No.1.

This is followed by the need to build more physical infrastructure such as seaports, airports, and mass-based transport systems; and simplifying requirements for loans with reasonable interest rates for SMEs and the rural sector.

Other recommendations in the top 10 include improving access to education; stricter profiling of the Pantawid Pamilyang Pilipino Program (4Ps) recipients, monitoring their expenses and providing them livelihood training; and speeding up the issuance by the Food and Drug Administration (FDA) licenses

Still, other proposals in the list are proper planning of infrastructure projects to reduce business disruptions, simplifying processes at the Bureau of Internal Revenue (BIR), and improving peace and order by ensuring police and military visibility in rural areas, intensively monitoring illegal trade activities in coastal areas, and continuing the implementation of martial law in Mindanao.

These recommendations build on the previous lists and gains of the last two "Sulongs."

Doubtless, some recommendations may raise the eyebrows of many of Manila's pundits, but these being results of consultations, and high growth numbers undeniable with the moves of investors to place their bets on the island shows a continuing growth that their eyebrows cannot deny.

They signal is the need to ensure deeper inclusivity of less capable sectors, particularly in the rural areas, to build on previous infrastructure gains by boosting food production and processing and training

The need for continuing Martial Law in Mindanao was not a surprising outcome, as high regional economic growth in several Mindanao regions are seen as a result of it.

Growth in the south is the key to unlocking the country's growth potentials. Inclusion of previously excluded sectors makes this possible. Without it, local businesses will not have the markets for their products. That said, the South has nowhere to go but up.

The real expectation for this season was but a semifinals slot – something they almost lost. Beating expectations and winning from below is the real story. Filipinos love the underdog and how they clash with the perceived powerful. How the once excluded can now eat at the leaders table is a scene many love to watch. The Maroons just showed how it can be done.

The road to autocracy

economic and political uncertainty
among investors and the ruling elite
of society.

To paraphrase Shakespeare's Hamlet, "Though this be madness, yet there is method in't," and thus we dare to ask what is PDU30 really up to in the emerging scheme of things?

Is democracy the best route to a strong republic and First World industrial economy, or will authoritarianism or autocracy do a better job?

With ambivalent masses fixated on poverty, a feeble opposition, an ineffectual Congress, and an increasing military capability and ubiquity, what does the future auger for the Philippines?

First, it is recalled that, for various reasons and political morass, the former economic "Poster Boy" of East Asia after World War II has since then been overtaken and eclipsed by Japan, South Korea, China, Taiwan, Singapore, Indonesia, Thailand, Hong Kong, Vietnam, and Brunel, and if the Philippines does not shape up, it might find itself lagging behind Myanmar, Laos, and Cambodia.

Though the observation is water under the bridge, so to speak, there are urgent challenges to be resolved such as Communist insurgency. Islamic terrorism, population growth, job generation, food security, SCS, and climate change pari-passu with the endless war against drugs, corruption, criminality, and other issues that call for extraordinary leadership, a different



political system, a transformed patriotic populace, and a strong disciplined Armed Forces.

Second, we find President Rodrigo Roa Duteric gingerly walking a tight rope between what he wants without too much fuss and legalese while adhering ostensibly to the rule of law, Congressional foot dragging, and social media.

In the process, in his effort to remain popular, Pres. Duterte resorts to legalistic shortcuts and autocratic behavior to get what he wants, and invariably achieves the desired results, to the consternation of civil society.

In conclusion, it is evident that to achieve rapid economic growth and bring the country to the next level of development, the country may to succumb to authoritarian rule and diminished liberties under President Rodrigo Roa Duterte or his successors.

There is always a price to pay.

Autocracy is not an ideal remedy
but it is a harsh alternative to a weak
republic.

China's nemesis stumped

IFTY years from now, people will not talk about new Chief Justice Lucas Bersamin or retired Teresita de Castro whom he replaced, but about Senior Associate. Justice Antonio Carpio, one of the best chief justices we never had.

After President Duterte said he appointed De Castro to restore seniority at the Supreme Court and would follow the tradition in selecting her replacement, Carpio no longer refused his automatic nomination.

But he was roundly rebuffed by Duterte's shameless double-talk by even carping that Carpio had previously rejected his nomination as chief justice.


portedly close to Xi due to deep family ties between the Chinese royal family and the Indonesian magnate.

Carpio will not let up on his devout vigilance against any constitutional infirmities in a major deal for the joint exploration of the West Philippine Sea, as well as in all the various business and government deals with Beijing. One of his shining moments once again proved he was a cut above the rest; when he refused the nomination to succeed ousted Chief Justice Lourdes Sereno, saying he did not want to benefit from the quo warranto petition against her which he opposed.

Teresita de Castro became the most likely successor to her boss whom she publicly vilified in leading the moves at the SC and before Congress for Sereno's humiliating removal. Unlike Carpio, she thought nothing of it and proudly basked in her appointment as

Carpio's personal and moral gratifications are not distinct from

each other and only come after the tests of his genuine character. And because his satisfaction rests on indisputably deep and upright moorings, it is not easily eroded by pride and personal ambition. In denying him the post of chief justice, Duterte has unwittingly made a profound choice to make Carpio's name more illustrious and coveted than his.

The Christmas season beckons with a spirit of pride and selfishness more than anything else. More and more people do not think of exempting themselves from the worsening traffic by acquiring new cars and SUVs. The latest LTFRB data says more than 240,000 vehicles are purchased each year with more than 30 percent of them in Metro Manila. Countless Filipinos just feel so entitled for new furniture, new wardrobes, new gadgets and tons

of food and drinks, as well as for travels abroad.

While Metro Manila may be abuzz with loud displays of the merriest time of the year, there are several places that are not, such as orphanages, prisons and hospitals. Inmares and patients receive only token donations from government officials and politicians who relish the days only because of the media and political mileage they bring. There are, of course, unquestionably committed and generous donors who do not mind parting with a hefty sum or substantial donations.

But, the calm is not inviting and almost palpable at hospitals where HIV/AIDS patients lie wasting away. San Lazaro's Pavilion Four has about 50 such patients, most of them had been abandoned by their families and friends. To them, Christmas does not decree a special moment for renewed compassion and fellowship. Only their "lovers" are found comforting them at their death beds.

This government has done little to prevent the rapid spread of HIV-AIDS. Some 1,200 new patients were found afflicted with HIV in Luzon during the first semester of the year. While relishing a nearly open lifestyle of sex with men, almost half of the current patients at San Lazaro did not feel any dread for the deadly disease. Some even thought it would be curable due to advanced medical technology. More than medication, they need the real spirit of Christmas that money cannot buy companionship, comfort and fervent prayers.

Bring back the ROTC

Critics of the ROTC-CMT program argue that... the entire program is a profitable enterprise for the ROTC-CMT officers who are alleged to receive a .commissionfrom the sale of military uniforms andsupplies.

It used to be called the Reserve Officers Training Corps or ROTO program from the Commonwealth era all the way to the proclamation of martial law in the Philippines in September 1972. Conceived as a training ground to prepare able young college men to defend the country in the event of a war, the ROTO program was in every university and college co-curricular list.

The program had two phases: the basic and the advance courses.

Every abie-bodied male college student in the Philippines was required to take the basic course, which consisted of four semesters of what was then called "military science and tactics." The students were required to wear a khaki or fatigue uniform, sport a prescribed haircut, observe strict rules of military discipline, march in cadence under the sun, read maps, carry a firearm or at least know how to handle one, and rough it up in the campus grassland or at a similar place elsewhere.

Graduates of the basic course are considered part of the reserve force of soldiers who may be called upon if war breaks out.

Those who choose to take the advance course continued with four more semesters of the same thing, or something more complicated than that

The students enrolled in the advance program become cadet officers tasked with handling the military training of their fellow students.

Upon completion of the advance phase, the student concerned becomes a reserve officer in the Armed Forces of the Philippines (AFP).

A commandant is in charge of the program. He is usually a sergeant or a probationary second lieutenant from the AFP.

Upon the proclamation of martial law in 1972, the ROTC nomenciature was renamed the Citizens Military Training (CMT) course. The new name was more descriptive of the program considering that not everyone who takes the course ends up as an officer in the reserve corps of the AFP. Besides, the program was all about training college students to be part of a citizen army.

Critics of the ROTC-CMT program argue that the military training is superficial because it is just about marching and parades, and that any training beyond that, like the use of firearms and map reading, is useless in a nuclear war. They also argue that the entire program is a profitable enterprise for the ROTC-CMT officers who are alleged to receive a commission from the sale of

military uniforms and supplies.

The ROTC-CMT program experienced a setback in 2001 when a scandal rocked the corps of cadets in the University of Santo Tomas in Manila. A cadet officer was found dead after he allegedly exposed corruption in the corps.

That incident prompted Congress to enact Republic Act 9163, which replaced the ROTC-CMT program with the National Service Training Program (NSTP). Under the NSTP law military training became optional for university and college students.

As many had predicted, enrollment in the ROTC-CMT program declined drastically. Nobody wanted to sport a military haircut on campus, march under the hot sun, and be shouted at by a foul-mouthed sergeant.

Many parents also saw the ROTC-CMT program as a useless expense and welcomed its abolition.

The NSTP program may have an ROTC option, but as long as it is an option, its consequence on the Filipino youth will not be felt.

Seventeen years since the abolition of the ROTC-CMT co-curricular requirement, many of today's young Filipinos do not know what to do in the event of a war hitting Philippine shores, much less discharge a firearm.

If they had at least taken the ROTC-CMT program, then they will know to what camp they are to report to, and they will at least know how to handle a firearm. More importantly, they will have the requisite nationalism, inculcated in them in the ROTC-CMT program, to resist enemy invasion without fear or favor.

The drills also taught each cadet the importance of command and more importantly, command responsibility. Each cadet had

to knew how to handle a real firearm, and got to fire one at the firing range at Fort Bonifacio. The discipline taught in the ROTC-CMT made better persons of every cadet. In retrospect, this writer is grateful for what he learned in the UP ROTC-CMT program.

Of course, the ROTC-CMT program is prone to corruption and abuse by acoundrels and scalawags. The solution is not to abolish the program, but to institute safeguards against

corruption and abuse. Seventeen years is too long a wait and an experiment on the NSTP. It's time to reinstate the ROTC-CMT program.

PRRD to study AFP, PNP's proposal to extend martial law

MANILA -- Malacañang on Monday said President Rodrigo Duterte will evaluate the recommendation of the Armed Forces of the Philippines (AFP) and Philippine National Police (PNP) to extend martial law in Mindanao for a year.

"Of course, the President will always evaluate whatever recommendation that the AFP and PNP will give him," Presidential Spokesperson Salvador Panelo said in a Palace media briefing.

Earlier, outgoing AFP chief-of-staff, Gen. Carlito Galvez Jr. said the AFP's decision was based on recommendations from Regional Peace and Order Councils, Commission on Elections, local government units and other agencies to extend martial law "at least one year" in Mindanao.

"Given the support of martial law in Mindanao even by the Catholic bishop and the citizens there, the President may be persuaded to grant, approve the recommendation," Panelo said.

"But of course, that's the prerogative of the President," he added

Panelo said the safety of the people in Mindanao is always the basis of any extension of martial

"If the threats remain and there is still an ongoing rebellion, then constitutionally, the basis would be valid for continuation of martial law," Panelo said.

Duterte placed Mindanao under martial law on May 23, 2017 following attacks launched by the terrorist Maute Group in Marawi City.

At the height of the six-month Marawi conflict in July last year, the House of Representatives granted Duterte's request for martial law extension until Dec. 31, 2017.

The House and the Senate granted anew the President's request for the extension of martial law and the suspension of the privilege of the writ of habeas corpus for a year, from Jan. 1 to Dec. 31, 2018.

Panelo said it would still be up to the two houses of Congress whether or not to extend martial law.

"Again, the Constitution grants them the authority to decide whether or not it will extend martial law. So, we leave it to them," Panelo said. *(PNA)*



Galvez wants 'almost 2-year term' for AFP chief

MANILA -- Outgoing Armed Forces of the Philippines (AFP) chief-of-staff Gen. Carlito Galvez, Jr. is hoping that the tenure for the military's highest position will be set for "almost two years" to ensure continuity in their programs and reforms.

"(We are hoping that) a tenure of almost two years for (AFP) chief-of-staff (will be set so that) magkaroon talagaing continuity, that is what we are asking. *Magkaroon sana ng ganoong* (That we have such) tenure (the AFP chief-of-staff), to (plan and see into fruition) the reforms that we can make for two years," Galvez said.

He also expressed confidence that the AFP can defeat all security threats within the term of President Rodrigo Duterte.

"I'm very, very confident that we can finish all the conflicts in two to three years' time, with the kind of President that we have, a very supportive President, we are very confident that we can finish all threats in his time," Galvez added.

The outgoing AFP chief is a member of Philippine Military Academy Class of 1985 and will step down on Dec. 12 upon reaching the mandatory retirement age of 56.

Galvez also said he is very fulfilled with his 30 years of military service, especially during his term as AFP chief.

"I'm very fulfilled *kasi yung lahat ng gusto kong mangyari sa* (everything that I wanted to happen for the) Armed Forces, with the help of our superiors, *yung mga* predecessors *ko* (my predecessors), we were able to instill discipline and *tinatawag nating* (what we call) institutional reforms. As of now, the Armed Forces have enjoyed good image wherein our legitimacy and our purpose of serving the people and the state has been recognized by the Filipino people," he said.

Galvez added he wants troops to remember him as the AFP chief who helped make the military's financial institution very strong and imbued an integrity program aside from helping weed out corruption in the institution. (PNA)

AFP to conduct more intel ops vs. NPA hit squads

MANILA -- The Armed Forces of the Philippines (AFP) will beef up intelligence operations to foil New People's Army (NPA) hit squads from attacking off-duty military personnel.

This was disclosed by AFP spokesperson, Brig. Gen. Edgard Arevalo in a message to reporters Monday.

"While it still remains an idea (to form a unit tasked to hunt or neutralize NPA hit squads) of the President as of this time, we will continue to step up our intelligence some more, continue to remind our troops to be extra vigilant during 'Liberty', Rest and Recreation', or otherwise non-combat activities to prevent them from falling prey to treacherous NPA attacks," Arevalo said.

Arevalo said the creation of the new unit highlights President Rodrigo Duterte's determination to stamp out the NPA liquidation squads.

The President earlier mulled the idea of creating the AFP's own liquidation squad to specifically go after NPA hit squads targeting security personnel.

"I do not want to second guess what's in the mind of the President by calling it Duterte Death Squad (DDS). But to us, it could've carried his name with it to show that he is personally resolved and determined to stamp out this terrorist NPA's liquidation squads," he added.

If the AFP is to be asked, Arevalo said the military can call it by another name like Team Counter-NPA Liquidation Squad and other similar names.

"We advocate a creation of teams comprised of elite soldiers to form that Team and we do not want its success to be referred to as the death squad of the President whose only intent as the Commander-in-Chief is to realize his care and compassion to the men and women of the AFP (and the welfare of their families) who may be victimized by the NPA," the AFP spokesperson said. AFP chief insists Lumad schools used as NPA breeding ground

MANILA -- Outgoing Armed Forces of the Philippines (AFP) chief-of-staff, Gen. Carlito Galvez said the Salugpungan Community Learning Center and ALCADEV Lumad School are being used as breeding grounds of the New People's Army (NPA).

This was emphasized by the military chief in an interview with reporters shortly after flagraising ceremony in Camp Aguinaldo, Quezon City Monday.

"Ang nakikita natin (sa) (What we see in) Talaingod (Davao del Norte), yung (the) Salugpungan, at saka (and) ALCADEV, ginagamit talaga yan (are being used). The people must know that the Salugpungan at saka yung (and the) ALCADEV is a breeding ground for NPA, yung ginagawa nila (former Bayan Muna Representative) Satur Ocampo na dinadala dito sa (What they do is that they bring them here in) Manila. This is an exposure. 'Yung lima na nag-surrender dito sa north na galing dun sa ALCADEV at saka galing din dun sa areas ng mga(The five who surrendered in the north who came from ALCADEV and those who came from the areas of the) IPs (Indigenous People). Ito yung talagang nagpapatunay na talagang itong si (This really proves that) (ACT-Teacher Partylist Representatives France) Castro at saka itong si (and) Satur Ocampo, they are active members of the (Communist Party of the Philippines) CPP-NPA," he added.

Galvez also said this claim is already attested by Lumad leaders.

"So ngayon, nakikita natin ang last bastion na lang ng CPP-NPA is yung IPs kasi yung mga Indigenous People ito na lang ang pinaka-vulnerable sector na kaya nilang lokohin (Now, we see that the last bastion of the CPP-NPA is the IPs because the Indigenous People are the most vulnerable sector whom they can deceive)," he added.

Ocampo, Castro and several others were accused of violating Republic Act 10364 or The Expanded Anti-Trafficking in Persons Act of 2012 and Article 270 of the Revised Penal Code which defines and provides penalty on the offense of kidnapping and failure to return a minor.

Ocampo and Castro claimed they are part of a humanitarian mission in Talaingod, Davao del Norte due to reports that students of these Lumad schools were fleeing the area following their closure. (PNA)

MANILA – Davao del Norte Governor Anthony del Rosario on Monday said leftist organizations use indigenous people (IPs) "to push their own agenda," and accused them of maneuvering the truth.

This, after former Bayan Muna party-list lawmaker Satur Ocampo and his companions were charged Friday with kidnapping and human trafficking over the transport of minors in Davao del Norte.

In a statement, del Rosario denied Ocampo's allegations that a paramilitary group forcibly closed the Salugpongan Ta'Tanulgkanogon Community Learning Center, Inc. (STTICLCI) in Dulyan, Palma Gil village, Talaingod, Davao del Norte.

"The so-called 'right defenders' exploited the issue to demonize the government and raise funds for their benefit," he said.

He said it was the local government unit and tribal leaders who pushed for the closure after seeing Salugpongan schools being used as platforms by leftist groups for anti-government propaganda and armed struggle.

"We cannot allow a few cunning individuals to mar our development momentum in the Lumad municipality," del Rosario said.

Del Rosario called on the leftist groups to stop exploiting the Lumads and start working closely with the government instead.

"The incident revealed how the age-old conflict between the government and those who seek to overthrow it took its toll on our innocent and disadvantaged IP brothers and sisters," he said.

"Time and again, we have proven that genuine pro-poor governance is the key to alleviating the lives of our Indigenous People," he added.

Ocampo and 17 others, tagged as 'Talaingod 18', were arrested last Wednesday evening for violating Republic Act No. 10364 or the Expanded Anti-Trafficking of Persons Act of 2012 after allegedly holding 14 minors without parental consent and permit from the LGU.

The leftist group, however, defended this move, saying it is part of a fact-finding mission on the Salugpongan schools' closure. (PNA)
