House responds

Compostela Valley Rep. Maria Carmen Zamora, chair of the House appropriations committee, denied that the House arbitrarily inserted P15 billion worth of road projects in the budget for Arroyo's district, saying it was the Department of Public Works and Highways (DPWH) that realigned the funds.

Responding to Larson's claims on Wednesday night, Zamora said none of the 292 members of the House received a huge increase in the allot

ments for their districts.

She reiterated that the funds were not pork.

Zamora, however, admitted that Arroyo's district got an additional allocation

Pressed about the actual amount, Zamora said it was around P500 million, not P15 billion as Lacson claimed.

Zamora said this brought to Pig billion the DPWH funds earmarked for the second district of Pampanga.

Pet projects

Pork barrel is a program that channels funds to congressional districts. It is used in the budget to give lawmakers lump-sum allocations to finance their projects after the appropriations law has been approved. It is a source of kick-backs

In the past, this was done through the Priority Development Assistance Fund or PDAF, which the Supreme Court struck down in a landmark 2013 rolling.

The Senate is working 12-hour days in the next two weeks to try to enact and ratify the spending bill before yearend to prevent a reenactment of the current national budget. But there may not be enough time, according to some senators.

Congress is supposed to have its last session day on Dec. 12, but it may extend the legislative calendar to accommodate the budget measure. INQ

House panel tackles scrapping offueltaxhike

Lawmakers yesterday began tackling measures scrapping taxes on oil products or at least suspending some of them, with opposition Rep. Edcel Lagman warning of street riots similar to those ignited in Paris by rising fuel taxes.

"We should not wait for a similar French experience. The French government was forced to suspend its fuel tax hikes because of violent riots. We should be able to avert that and Inclusion (TRAIN) law.

He said the House and the Senate should pass a joint resolution forgoing next year's increase in taxes on diesel, cooking gas, gasoline, kero-

For Sen. Risa Hontiveros. President Duterte's decision to proceed with the collection of the second round of excise lax on petroleum was "premature and impulsive."

Hontiveros said the decision has exposed the government's "wobbly policy" in dealing with the negative impact of unstable oil prices on consumers

"President Duterte claimed that we are powerless to respond to the impact of the rise of oil prices in the world market. He also said that we are at the mercy of the international oil market," she said. "Then why lift the suspension on the fuel excise tax collection, one of the few safety nets that protect the public from the volatility of the international oil market?" Hontiveros asked.

"If the government failed to foresee the depth and gravity of the impact of volatile international oil prices on our inflation rate, what makes it think that the overall economic environment is turning around for the better? Isn't it more prudent to continue to allow the safety nets, such as the suspension of the fuel excise tax, to take full effect to shelter the people in an uncertain economic climate?" Hontiveros said.

The senator said that there is solid basis to suspend the second round of excise tax on petroleum. She explained that value added tax (VAT) revenues from various petroleum products have risen and have exceeded projected revenues for 2018.

She also argued that despite the series of oil price rollbacks, the peso cost of petroleum products has been and remains quite high as a result of the depreciation of the peso and the still high international price of petroleum products.

"During the Oct. 24 hearing of the Senate committee on economic affairs, the Department of Finance (DOF) admitted that the excess in VAT revenues is indeed substantial. Why then collect more indirect tax revenues via the petroleum industry?"

For 2019, Hontiveros estimated that excess VAT collection would probably be around P10 billion given the lower expected oil prices.

She also said that the windfall revenue from the VAT on transactions related to high-priced petroleum was never contemplated when the TRAIN law was passed.

"What our economic managers should do is defer the second round of excise tax on petroleum. The deferment will be for as many months as necessary to return and neutralize the unintended 2018 and 2019 VAT collections on petroleum-related transactions," Hontiveros said.

Sen. Paolo Benigno Aquino IV said there is no basis for the government to take back its previous commitment to suspend the tax hike.

Aguino said the six percent inflation showed the country was still in the "middle of a crisis of high prices, so this decision to add to existing excise tax is wrong."

He said the government should have based the suspension of excise tax on fuel on the inflation rate and not on world crude prices.

Sen. Francis Escudero, for his part, filed a resolution formally asking Duterte to suspend the P2 per liter increase or at least consider its immediate suspension when inflation becomes uncontrollable again any time in 2019.

"It is best to suspend the implementation of the second tranche of tuel excise tax right

away or that the suspension be swift in 2019 so as to effectively address inflation, before it again directly affects the lives of every Filipino," Escudero said in Senate Resolution 964

Sen. Joseph Victor Ejercito told reporters "we're hoping for some sensitivity on the part of the economic manage ers, who should allow our countrymen to have some breathing space (from high prices).

"During the TRAIN debates, it's on record that we were not remiss in reminding them of the possible increase in oil prices," he said.

Senate President Pro Tempore Ralph Recto said that while inflation has gone down to six percent, "it's down to six percent, still high" and could inflict more hardship on consumers if taxes on petroleum are raised further.

"If the executive increases taxes on oil next year it clearly will increase prices and stoke inflation," he said.

Sen Sonny Angara said the government must fulfill its promise to implement safety nets for the poor to mitigate the effects of TRAIN.

The lawmaker was referring to the unconditional cash transfer and Pantawid Pasada programs, which were provided as "social welfare benefits" under the tax reform law.

'MOU on oil exploration with China constitutional'

There is no need for the Senate to review the agreement forged by the Duterte administration with China on oil and gas development in the West Philippine Sea, the Department of Justice (DOJ) said yesterday.

Justice Secretary Menardo Guevarra said the memorandum of understanding (MOU) signed during the recent state visit of Chinese President Xi Jinping does not require concurrence of Senate under the 1987 Constitution.

"It's not a treaty and therefore does not require any Senate concurrence or review," Guevarra said in an interview.

The DOJ chief made the statement after Senate President Pro Tempore Ralph Recto called for a legislative review of the MOU following concerns that it could compromise the country's sovereignty or lead to a debt trap.

Guevarra said he has examined the MOU and did not find any violation of the laws.

"There are no sovereignty issues whatsoever as the MOU merely expresses a mutual desire to agree on specific cooperation arrangements within 12 months," he stressed

Guevarra further explained that the agreement expressly stated that it "shall be without prejudice to the respective legal positions of the two governments and does not give rise to any rights or obligations under international or domestic law."

"It's just an MOU, it's non-committal, non-obligatory and non-binding from a legal standpoint. It's a mere expression of mutual desires," he pointed out

This is contrary to the opinion of former solicitor general and opposition senatorial candidate Florin Hilbay that the MOU may be unconstitutional.

Hilbay argued that the agreement is "incompatible with the full control and su-

pervision standard or clause."

"It is clear that we own the West Philippine Sea and it is against the Constitution if we allow China to jointly explore with us its natural resources like oil and gas jointly," he claimed.

Senior Associate Justice Antonio Carpio, a vocal advocate against China's claims in the West Philippine Sea, also said the MOU is "safe" as it included a service contract provision

"I don't have any objection with that kind of arrangement because if China comes in through our service contractors, those service contracts expressly recognize that the area falls within Philippine sovereignty or sovereign rights," he said.

Still, Carpio stressed that joint exploration and exploitation with China would violate the Constitution because the West Philippine Sea is part of the exclusive economic zone of the country.

Carpio stressed that "joint

exploration and exploitation" as defined in the law "will diminish our full control' and thus violate the Constitution."

Respect the people's opinion

A majority of Hong Kong nationals believe it is important for governments to follow the opinion of the people in settling the disputes in the South China Sea, a recent survey conducted by The University of Hong Kong (HKU) showed

The Survey on South China Sea Disputes showed 58 percent of respondents considered it important for a government to follow its people's opinion in settling these disputes

Almost half of them or 47 percent considered it important for a government to follow public opinion in the world in settling these disputes.

Half of the Hong Kong people (51 percent) were aware of the ruling of an international tribunal in 2016 regarding the South China Sea disputes

Those who said it is not important to heed people's opinion and public opinion in the world were registered at 18 percent and 30 percent, respectively.

The poll was conducted from Nov 1 to 6, using telephone interviews of 1,000 Hong Kong residents, 18 years old and above.

The survey also found 70 percent of respondents who were aware of the disputes, with 16 percent claiming to have extensive/adequate knowledge of the disputes.

The survey has sampling error margin of plus or minus 3.2 percentage points.

Results of the HKU poll were published on the website of the Social Weather Stations (SWS) yesterday

An SWS survey, taken from Sept. 15 to 23 tound 84 percent of Filipinos saying it is not right for the Duterte government to leave China alone with its infrastructure and military presence in the Philippine-claimed territories.

In 2016, the Permanent Court of Arbitration based in The Hague, Netherlands ruled in favor of the Philippines, invalidating China's "historical maritime rights" over contested areas in the West Philippine Sea.

President Duterte had ser aside the Philippines' victory in the arbitration case against China to improve ties between the two nations.

Meanwhile, presidential spokesman Salvador Panelo said yesterday there is no need to provoke Beijing by further by pushing the issue on weather stations put up by China in the South China Sea following Detense Secretary Delfin Lorenzana's statement that the military could not confirm such

"Well, because you need to go inside the territory that this particular country claims that it's theirs. So you may have some problems there, may even provoke something that we don't want," Panelo said. —With Helen Flores, Christina

Noneed for Senate review

of MOU between China, PH

HE Department of Justice on Wednesday said there is no need for the Senate to review the agreement entered between the Duterte administration and China on oil and gas development in the West Philippine Sea since it is not in the nature of a treaty.

Austice Secretary Michardo Chevarra said that the memorandum of agreement signed during the recent state tier of Chinese President XI Jiapping does not require concurrence of Senate under the 1987 Constitution.

According to Guevarra, he has examined the MOU and did not find any violation of the laws.

Zambo Sur town councilor slain in gun attack

ZAMBOANGA CITY – Unidentified motorcycleriding men gunned down a municipal councilor in Ramon Magsaysay, Zamboanga del Sur on Tuesday.

Romeo Mainar Sr., 54, a resident of Purok 3, Barangay Lantawan, Sominot, was driving his motorcycle on his way to Pagadian City when he was shot at around noon, according to Chief Superintendent Emmanuel Luis Licup, Zamboanga peninsula police director.

Licup said the incident occurred in Furok 4, Barangay

Bobongan.

Witnesses said the assailants alighted from their motorcycle and fired more shots when the victim fell from his motorbike.

The gunmen reportedly fled toward Molave town.

Residents rushed the victim to the Zamboanga del Sur Medical Center, where he was declared dead on arrival.

A manhunt for the assailants is ongoing.

'Deploy soldiers in La Union'

Meanwhile, the Commission on Elections (Comelec) has been asked to place La Union under military protection amid recent killings of politicians.

In a letter to Comelec Chairman Sheriff Abas on Nov. 20, La Union second district Rep. Sandar Eriguel said the military should intervene to ensure peace and order in the province, particularly in the towns of Agoo, Bauang, Caba and Tubao

"To wait for the start of the election period may be too late... The augmentation of... Army personnel... will provide a strong deterrent against evil forces roaming our... province. The presence of soldiers will also give confidence to our people to exercise their freedom of expression and right to suffrage without fear of threat and violence." Eriguel said.

She also asked the Comelec to provide security for her and her family members, saying they continue to receive death threats.

Eriguel's husband Eufranio, a former congressman, was gunned down while addressing barangay leaders in Capas, Agoo last May, two days before the barangay and Sangguniang Kabataan elections

Three other persons were killed and several others were injured in the gun attack

"At the time of my husband's murder, our... security details, including those of my daughter Agoo Mayor Stefanie Ann Eriguel, were pulled out which left us vulnerable to any attack." Eriguel said.

She also cited the killings of Sudipen Mayor Allan Buquing and Balaoan Vice Mayor Alfred Concepcion in recent ambushes

"Several local leaders were also gunned down in... Bauang and Tubao but these were not reported in the media," Eriguel said.

PAMPANGA IS BEST IN DISASTER RESPONSE

CITY OF SAN FERNANDO— Pampanga, one of three provinces that struggled to overcome the impact of Mt. Pinatubo's 1991 eruptions and lahar flows, was chosen as the country's best Provincial Disaster Risk Reduction and Management Council (PDRRMC).

Defense Secretary Delfin Lorenzana conferred the 20th Gawad Kalasag national award to Vice Gov. Dennis Pineda, vice chair of the Pampanga PDRRMC, at the Atmed Forces of the Philippines Amphitheater on Tuesday.

The Pampanga PDRRMC earned the national award after it won the regional Gawad Kalasag Hall of Fame for five consecutive years. In 2016, it was second in the 18th National Gawad Kalasag.

Breakthroughs

Cultivating the collaboration between government and the private sector has been one of the strengths of the Pampanga PDRRMC, its action officer, Angelina Blanco, said.

Among its breakthroughs are the construction of three permanent evacuation centers; the land banking of 67,7 hectares, which are intended for future relocation sites, and a house tag-

ging mechanism to prioritize the rescue of the elderly, persons with disabilities and children.

Pampanga reported organizing a wide network for information dissemination in disaster preparedness composed of 550 public school teachers and 9,760 community volunteers who assisted village leaders.

Humanitarian aid

It was certified to be wellequipped for rescue missions and medical emergencies, counting the five backhoes used to extract silt and deepen creeks and rivers year-round.

The council conducted humanitarian assistance for victims of Supertyphoon "Yolanda" (international name Haiyan) in November 2013, in Tacloban City and Samar province, Typhoon "Lando" (international name, Koppu) in Nueva Ecija province in October 2015, and flashfloods in Bataan province and Olongapo City in 2018.

Apart from holding training sessions and drills in evacuation management, it led the planting of mangroves and bamboo in coastal communities to create a natural shield against storm surges from Manila Bay. —TONETTE OREJAS

Duterte appoints Galvez as new OPAPP chief

President Duterte has named outgoing Armed Forces of the Philippines (AFP) chief Gen. Carlito Galvez Jr. as the next head of the Office of the Presidential Adviser on the Peace Process (OPAPP), Malacanang announced on Wednesday.

Galvez, a member of the Philippine Military Academy class of 1985, is scheduled to retire from the military service on December 12, 2018.

He will take over the post vacated by erstwhile OPAPP chief Sec. Jesus Dureza "The President announced his intention to appoint General Carlito Galvez, Jr to the Office of the Presidential Adviser on the Peace Process," Presidential Spokesman Salvador Panelo said in a statement.

The imminent appointment of Galvez was announced during a Cabinet meeting convened by the President in Malacanang last Tuesday.

Even prior to the resignation of Dureza, Galvez has reportedly offered his services to work at the OPAPP after his retirement

He has expressed support for the government's peace initiatives, including the efforts to end the conflict with the communist rebel group.

Dureza, a former classmate of Duterte, quit his post last week as part of command responsibility after his two subordinates were implicated in alleged corruption.

His possible appointment came less than two months before the January plebiscite for the Bangsamoro Organic Law, which grants wider self-rule to Muslim in Mindanao in southern Philippines

Galvez said he would urge the terrorist Bangsamoro Islamic Freedom Fighters to join the crucial Bangsamoro plebiscite

Galvez's appointment implies the "death of peace talks" between communist rebels and the government, the Makabayan bloc of lawmakers said on Wednesday.

"We are not surprised. The administration really shows that they do not value peace negotiations." ACT Teachers party-list Rep. Antonie Tinio and Rep. Francisca Castro said in a news briefing.

Anakpawis Rep. Ariel Casilan denounced the decision to appoint Galvez, describing him as spowder brained and trigger-happy.

'Hindi no nababagay sa posisyon ang isang heneral na utak pulbura at trigger-happy (A powder-brained and trigger-happy general does not suit such position)," he said.

The Makabayan lawmakers previously said they would file a case before the Ombudsman against Galvez for "recklessly" accusing Castro and former Bayan Muna Rep. Satur Ocampo as top communist rehels.

Castro said Galvez's pronouncement put her life in danger.

She and Ocampo were both part of the "Talaingod 18" who were released after posting bail for charges of kidnapping and human trafficking.

GMA guarantees House approval of ML extension

"If it comes to our chamber, I will recommend that we pass it," she told reporters in a chance interview, adding they are just awaiting the formal request from President Duterte on the matter.

For their part, Reps Robert Ace Barbers of Surigao del Norte, Michael Romero of IPacman party-list and LRay Villafuerte of Camarines Sur have also expressed their all-out support for another extension, insisting that peace and order is crucial in the conflict-ridden region.

"I will support the extension of martial law if only to maintain peace in the island." Barbers, chairman of the House committee on dangerous drugs, said. He clarified there is nothing wrong with it for as long as this can be justified under the circumstances.

Romero is concerned not just about the safety of Muslims and Christians alike but also about the local economy.

"Businesses should thrive. live under martial law for a Peace of mind is priceless. If vear-and-a-half now," he said.

Villafuerte, who sits as vice chairman of the House committee on national defense and security, underscored the need for the executive department to make a formal request to Congress – Senate and House of Representatives – for such an extension

PNP, AFP sign recommendation

As this developed, the Philippine National Police (PNP) and the AFP have signed a document recommending the extension of martial law in Mindanao for one more year, PNP chief Director General Oscar Albayalde said yesterday.

Albayalde said he had already put his signature on the document together with his counterpart in the military, AFP chief of staff Gen. Carlito Galvez Jr.

"We have just a signed a document together with the outgoing AFP chief of staff recommending the extension of martial law in Mindanao for another year," Albayalde said in a television interview over CNN Philippines.

He did not say, however, if they have submitted the document to Duterte.

"The recommendation of the AFP and the PNP is for the extension of martial law maybe for another year for Mindanao, no expansion, but of course, it will be up to the President," Interior Secretary Eduardo Año said in mixed Filipino and English in a chance interview at the awarding for child-friendly municipalities and cities yesterday.

"Once it is with the President, he may change it, add to (the provisions) or he may change them, or remove some." Año said.

Eriguel made the plea after several politicians were gunned down, including her husband former Rep. Eufranio Eriguel who was shot dead by still unidentified assailants on May 12, 2018 in Barangay Capas, Agoo. two days before the 2018 Barangay and Sangguniang Kabataan elections.

Prior to this, her husband survived a bombing attack on April 30, 2016 barely two weeks from the 2016 national and local elections.

The said bombing attack remains unresolved.

"The death of my husband was not the last of violent incidents that erupted in our province. The recent ambush on Sudipen Mayor Allan Buquing and Balaoan Vice Mayor AlFred Concepcion which resulted in their deaths as well as of their police security details, placed La Union again in the headline news," she pointed out.

"Apart from these, local leaders were also gunned down particularly in the towns of Bauang and Tubao but these were not reported in the national media," she said.

Eriguel said the prevalence of violence in La Union has not only caused fear among the people but also among politicians.

"Treceived information that I will be gunned down once I filed my certificate of candidacy, I did not take the information lightly, thus I instructed my chief of staff to the my COC with the provincial election supervisor of La Union as a precaution. To this date, I continue to

receive information of ongoing threats to me and my family as well as my allies in politics," she claimed.

'Place La Union under AFP care in 2019 polls'

GOO, La Union: La Union Rep. Sandra Eriguel (Second District) has recommended to the Commission on Elections (Comelec) to place La Union under military protection during the 2019 elections to prevent the spread of violence resulting from the deaths this year of several politicians in the province.

In a Nov. 20, 2018 letter sent to Comelec Chairman Sheriff Abbas, Eriguel asked the poll body to intervene during the mid-term elections next year to ensure there is peace and order in Ia Union particularly in the municipalities of Agoo, Bauang, Caba and Tubao in the Second District.

Enguel made the plea after the murders of several politicians including her husband, former Rep. Eufranio Eriguel, who was gunned down by unidentified assailants on May 12 while he was speaking in a meeting in Barangay Capas, Agoo. La Union, two days before the 2018 barangay (village) and Sanggumang Kabataan (Youth Council) elections

Her husband survived a bombing attack on April 30, 2016, or two weeks before the 2016 national and local elections.

The incident remains unsolved to this day.

"The death of my husband was not the last of the violent incidents that erupted in our province The recent ambush of Sudipen Mayor Allan Buquing and Balaoan Vice Mayor Alfred Concepcion, which resulted to their deaths, as well as that of their police security details, placed La Union again in the headline news," Eriguel said.

"Apart from these, local leaders in Bauang and Tubao were also killed, but these were not reported in the national media," she added.

Eriguel said the prevalence of violence in La Union has not only caused fear among the people but also among politicians, themselves.

"I received information that I would be gunned down once I file my certificate of candidacy (CoC). I did not take the information lightly so I instructed my chief of staff to file my CoC with the provincial election supervisor of La Union as a precaution. To this date. I continue to receive information about threats to me

and my family as well as my political allies," she added.

To put the situation under control, Eriguel also asked Comelec to call on the Philippine Army through the Department of National Defense to place La Union province, particularly the towns hit by political violence, under military protection.

She said government troops must also provide close security for those running in the mid-term elections as soon as possible.

Eriguel further asked Comelec to allow personnel from the Police Security and Protection Group and the Philippine Army to be detailed to her and her family during the election period

"I am willing to comply with any requirement which the Comelec would mandate. I am hopeful that peace would again reign over La Union and with the intervention of Comelec, peaceful and violence-free elections would still be attainable," she said.

3 soldiers wounded in Quezon encounter

Three soldiers were wounded after government troops overran a temporary encampment of the Communist New People's Army Terrorist Group (CNTG) following an operation in Quezon province on Tuesday, Dec. 4.

Lieutenant Colonel Jonathan S. Manio, the Commanding Officer of the Army's 1st Infantry Battalion, said troops were conducting Focus Military Operation (FMO) when they raided an enemy camp following an assault in the vicinity of Barangay San Bueno, Sampaloc, Quezon.

The operation, he said, was in response to intelligence report and tips from civilians about the NPA's presence and their ongoing extortion activities in the area

When the troops were near the enemy camp, a gun battle ensued against some 20 NPA rebels that lasted for almost 30 minutes.

Three soldiers suffered minor wounds and are in stable condition.

A report said much blood stains in the area occupied by the NPAs indicated casualties on the NPA side.

The NPAs brought their wounded comrades when they escaped the gun fight, according to the troops.

The soldiers recovered one loaded M16 rifle and other war materials

Manio said the rebels were believed to be members of the NPA Military Regional Guerrilla Unit (MRGU).

Brigadier General Arnulfo Marcelo B. Burgos Jr., commander of the 202nd Brigade which has operational jurisdiction over CALABARZON (Cavite, Laguna, Batangas, Rizal and Quezon), said the recent encounter in Quezon including last month's successive encounters in General Nakar came about following tips from concerned civilians.

"It clearly shows that the NPAs are indeed losing mass base support due to their extortion and terror acts towards the people," he said.

No holiday truce with NPA-Lorenzana

Defense Secretary Delfin Lorenzana on Wednesday rejected any suspension of military operations (Somo) against the Communist Party of the Philippines (CPP) and its military arm, the New People's Army (NPA), despite the insurgents' offer of a holiday ceasefire.

CPP founder Jose Maria Sison on Tuesday said the National Democratic Front of the Philippines (NDFP) negotiating panel had received an "advance notice from the CPP" saying it would order the NPA to observe a unilateral ceasefire.

Solidarity with Filipinos

The truce order is meant to manifest solidarity with the Filipino people's celebration of the Yuletide season and to celebrate the 50th anniversary of the CPP on Dec. 26, Sison said

In a statement issued from his base in Utrecht, the Netherlands. Sison said the insurgents' temporary unilateral ceasefire "demonstrates the high morale and self-confidence of the revolutionary forces and people in their all-round strength."

But in a message to reporters, Lorenzana said the military "objected to a Somo" and "shall not allow the CPP to use a Somo to celebrate (its) 50th anmiversary."

First time for AFP

This is the first time that the Armed Forces of the Philippines

is not even contemplating a cessation of hostilities with the CPP and NPA for the holidays.

"We see that in the past, (the CPP-NPA) has not been sincere with any suspension of military operations. They continue with their terroristic and criminal activities, extortion, (and) harassment. We do not want to give them the opportunity to gather and mass up to joyfully celebrate their 50th anniversary." AFP spokesperson Brig. Gen. Edgard Arevalo said at a press conference.

"Experience told us, experience showed us that (a Somo) is not worth it," he added.

But even as he offered a holiday truce, Sison warned that NPA rebels were ready to thwart possible attacks from its enemies during the projected truce.

NPA's surrender

Sison said President Duterte had made several unacceptable preconditions to continue peace negotiations, among them "the surrender of the NPA. the laying aside of the people's demand for social, economic and political reforms, and the self-destruction of the revolutionary movement."

Mr. Duterte terminated peace talks with the NDFP in November last year and shortly after, declared the CPP and NPA as terrorist organizations.

The NDFP is the umbrella group of all communist-led underground organizations that has been conducting on- and-off peace talks with the government since 1986. INQ. IN

He said they do not want the communist movement to use government's suspension of offensive military operations (SOMO) to celebrate the 50th anniversary of the Communist Party of the Philippines (CPP) on December 26.

The CPP and its armed wing, the New People's Army, traditionally mark their anniversary with attacks on military and civilian targets.

Government traditionally declares a SOMO during the Yuleride season. The communists traditionally reciprocate. After the truce period, the two sides exchange accusations of ceasefire violations.

"I have objected to a SOMO. We shall not allow the CPP to use a SOMO to celebrate their 50th anniversary," Lorenzana said.

On reports that the communists intend to declare a truce, Lorenzana said, "That's their call. We (defense department and Armed Forces) are not keen on a ceasefire."

AFP spokesman Brig. Gen. Edgard Arevalo said the military is not inclined to recommend the SOMO because the communists, particularly the NPA, have taken advantage of past ceasefires.

He said the NPA, in past ceasefires, continued with their "terrorist and criminal activities extortion, harassments etc.'

"We've seen their insincerity and their nonadherence (to ceasefire declarations). Experience told us, showed us, it's not worth it," he added.

Arevalo acknowledged that while the defense department and the military are not recommending a SOMO, President Duterte has the "last say" on the matter.

The President also consults other agencies, including the PNP and the interior department, before making a decision on a truce declaration.

Last year, the government and the communists declared a four-day truce for Christmas, from December 23 to 26, and another four days for New Year, from December 30 to Jan. 2.

The Duterte government also declared a SOMO in 2016.

No more peace talks Duterte

On Sunday, Sison said the communists were set to observe a holiday truce to allow guerillas and their families to "freely enjoy" the celebration of the 50th anniversary of the Communist Party of the Philippines (CPP) on December 26.

It has become a tradition for the military and communist guerillas to observe a truce during the holidays through separate ceasefire declarations.

But the Armed Forces of the Plater ares (AFP) said it was not inclined to recommend a truce.

Brig. Gen. Edgard Arevalo, AFP spokesman said, the military did not

want the rebels to use the holiday truce as an opportunity to celebrate their 50th anniversary

"We do not want to give them the opportunity to gather and mass up, to joyfully celebrate their 50th anniversary. "Arevalo said.

Defense Secretary Delfin Lorenzana also rejected the idea of the ceasefire, saving there was no need to declare a suspension of military operations (SOMO) in line with the Ci^{njo}s 50th anniversary.

"I have objected to a SOMO. We shall not allow the CPP to use a SOMO to celchrate their 50th anniversary," Lorenzana told reporters.

Dutente terminated peace talks between the government and the communist group in November last year amid the NPA's continued attacks on state troops.

Massacre survivor's charges unfounded — police chief

BACOLOD CITY: Charges filed against the father, the police chief and three members of the Sagay police are "unfounded and fabricated," a police official said.

Chief Insp. Robert Mansueto, Sagay police chief, described the criminal complaint filed by the mother of a 14-year-old boy who survived the Sagay massacre as "fabricated and designed to intimidate the police."

"There is no basis for it and the police has evidence to prove this," he said.

On Tuesday, the minor's mother filed criminal complaints with the Department of Justice (DoJ) against the boy's father, Mansueto and the three police officers.

Flor, the mother of "Lester," the

massacre survivor, alleged that the boy's father, identified only as "Vic," was inflicting psychological abuse on the child with his attempts to take custody of him and force him to testify in the investigation of the massacre, the mother's lawyer, Katherine Panguban, said.

Panguban added that Vic, who is not married to Flor, left Lester in his mother's custody 10 years ago but resurfaced after the Sagay massacre.

She said Vic is being used by the police and the military to force Lester to point to members of the communist New People's Army (NPA) as the culprits behind the massacre

Aside from Vic. Flor also filed

a child abuse complaint under Republic Act 7610 or the Anti-Child Abuse Law, against Mansueto and Senior Police Officer 1 Julie Ann Diaz and PO Christine Magpusaw.

Panguban said the police officers threatened mother and son and took Lester's testimony without the presence of a support person, in violation of the Supreme Court's rules on examination of a child witness.

Flor, in her complaint, also slammed the boy's father and the Sagay police for charging Panguban with kidnapping and serious illegal detention for allegedly taking custody of Lester without consent

Mansueto, however, said the

child was placed under the care of the city's Department of Social Service and Development, not with the police.

"When the child narrated, for an affidavit, before the prosecutor what he saw during the massacre, his father and a social worker were present and we have evidence to prove it," he added.

Mansueto said in Lester's affidavit, he did not specify the identities of the perpetrators, "Unless he sees them again."

Earlier, the Philippine National Police listed two recruiters of the National Federation of Sugar Workers as suspects and pinned the blame for the massacre on the NPA

Military forms strike force to stop NPA attacks

THE military will form a unit to counter New People's Army hit squads this month, made up mostly of intelligence officers from the Armed Forces of the Philippines and its different branches. Defense Secretary Delfin Lorenzana said Tuesday

"The core of this unit will be from the Intelligence Service of the AFP. The Army, Air Force, Navy and Marines have the core of this anti-SPARU unit," Lorenzana said, referring th the NPA Special Partisan Unit

He said he supports the formation of the special unit to protect military personnel from attack by NPA hit squads.

"I support the anti-SPARU unit that will protect our soldiers but I said let us be very careful in organizing these people. Some quarters are saying we'll get civilians to do it. I think no, this will be

their own intel unit, so they could form very difficult for civilians to do this [as] they might think they have blanket authority to just kill anybody they suspect of being NPA. I want soldiers to be our anti-SPARU unit members and this should be

supervised by officers," he added.

President Rodrigo Duterie proposed the creation of a "Duterte Death Squad" after reports said 136 people, most of them military, police and rebel returnees, were assassinated by the communist rebels in the last three years.

The Communist Party of the Philippines blamed the President for the repeated termination of peace talks.

CCP founding chairman Jose Ma. Sison said communist rebels have wanted to peacefully end the five-decade-old armed conflict with the government, but the Duterte administration has failed by setting up conditions and terminating the peace talks.

"Duterte and his armed minions have only themselves to blame for the repeated terminations of peace negotiations that Duterte declared and for making preconditions," said Sison from his base in Utrecht, The Netherlands on Wednes-

The top communist official said the government's conditions such as the surrender of the New People's Army, the laying aside of the people's demand for social, economic and political reforms, and the self-destruction of the revolutionary movement have blocked the path to peace and hindered the establishment of a just and lasting ceasefire between the government and communist rebels.

Sison said the National Democratic Front of the Philippines was expecting that the comprehensive agreements would have been made before the end of the year.

He said Duterte should have fulfilled his promise to [grant] amnesty and release all political prisoners.

"He would have gotten a ceasefire longer than the nearly six months from August 2016 to January 2017. And the peace negotiations would have advanced fast and smoothly," Sison said.

"But whenever the comprehensive agreement on social and economic reforms moved forward. Duterte always came up with a surprise declaration of termination."

Meanwhile, the AFP has formed a division-size group of infantry men to be deployed in the volatile province of Sulu to defeat the lingering security threat posed by various terrorist groups, particularly the Abu Sayyaf Group,

AFP spokesman Brig Gen. Edgard Arevalo said the division-sized unit will be permanently stationed in Sulu Archipelago to containe and decimate terrorists elements that continue to sow havor

"The Armed Forces of the Philippines, in support to national leadership, is determined to engage squarely and defeat decisively all threat to national security that are harboring in Sulu," Arevalo said.

The insertion of the 11th Infantry Division with a complement of about a thousand troops in Sulu came after President Duterte expressed concern that, despite the AFP garnering major victories in Sulu, security forces continue to incur casualties

Zambo City LGU opposes petitions for BARMM inclusion

ZAMBOANGA CITY -The city government here will oppose petitions filed by residents of at least five barangays to be included in the proposed Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

Mayor Maria Isabelle Climaco-Salazar said she would present the position of the city government to the city council for approval before filing it with the Commission on Elections (Comelec).

Some residents of Barangays Busay, Landang Gua, Tumalutab, Arena Blanco and Cawit filed petitions to allow them to participate in the plebiscite to ratify the Bangsamoro Organic Law. The local Comelec office

said only one percent of the residents of Barangays Arena Blanco and Cawit signed the petitions.

The plebiscite will be held on Jan. 21 next year in the ARMM as well as in Balo-i. Munai, Nunungan, Pantar, Tagoloan and Tangkal towns in Lanao del Norte and 39 barangays in Aleosan, Carmen, Kabacan, Midsayap, Picgawayan and Pikit in North Cotabato, which will comprise the proposed BARMM

Subject to the approval of the poll body, the plebiscite may also be held in contiguous local government units.

City legal officer Jesus Carbon also noted that Zamboanga City is not contiguous with the BARMM.

Muslim villages oppose Bangsamoro inclusion

ZAMBOANGA CITY: Almost all the predominantly Muslim barangay (villages) here have expressed opposition to their inclusion in the proposed Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), which replaces the Autonomous Region in Muslim Mindanao (ARRM) when the Bangsamoro Organic Law (BOL) is approved in a plebiscite. according to a lawmaker.

The two Houses of Congress passed the BOL which was later signed by President Rodrigo Duterte.

Rep. Celso Lobregat made the disclosure after he visited the villages of Landang Gua, Busay, Tictapul and Tumalutab for a dialogue with their leaders and inhabitants to find out their sentiments about their possible incorporation into the BARMM.

Present during the dialogue were former lawmaker Lilia Nuno. Councilor Melchor Sadain and village chiefs Abdurahman Nuno and Benjamin Adjulla together with their barangay councilmen

Lobregat later told media men in a news conference that all the leaders of the villages concerned unanimously passed resolutions, addressed to the City Commission on Elections, vehemently rejecting the incorporation of their villages into the proposed BARMM.

"We will openly disclose out negative reactions during the scheduled plebiscite," a Landang Gua councilor said.

Lobregat advised the leaders from the four island villages "to explain their side" to local Commission on Election (Comelec) officials during the verification of the petition they submitted objecting to their inclusion in the BARRIM.

Earlier, the officers of Barangay Cawit submitted to the Comelec their acceptance of their inclusion in the Bangsam-ANTONIO RIMANDO oro region

IS supporters shoot down 2 military drones

ZAMBOANGA CITY: Pro-Islamic State (IS) forces reportedly shot down a pair of military drones hovering near their encampment in Maguindanao where security forces were battling a huge group of the terrorist Bangsamoro Islamic Freedom Fighters (BIFF) early on Tuesday evening.

The military confirmed the report but did not elaborate on the extent of damage to the drones.

This happened close to the start of the campaign period, on Friday for the Bangsamoro plebiscite.

The report from Shariff Aguak, Maguindanao, said Maj. Gen. Cirilito Sobejana, commander of the 6th Infantry Division (6th ID) declared on Wednesday that the Armed Forces of the Philippines (AFP) is on top of the situation after the Tuesday night clashes between the BIFF and the Philippine Army in Sitio Narra, Barangay Salman, Ampatuan, Maguindanao.

Troops of 2nd Mechanized Battalion led by LL. Col. Alvin lyog were conducting the offensives when the drones were hit.

lyog admitted that the BIFF, which has snipers, had slowed down Army offensives.

"Our two birds eye drones were even hit," he said of the flying military equipment that managed to hover over enemy positions.

Soldiers fired 105 howitzers toward enemy positions even at night toward a suspected BIFF

encampment in Ampatuan town as troops advanced to capture the remote area in Salman village from the bandit group.

The group is blamed by authorities for terrorism and a spate of attacks on civilians and the military in Maguindanao and nearby provinces.

The scene of the firefight is around 600 meters uphill from the infamous massacre site in Ampatuan where the group of Abu Rusda and Diok, both subcommanders of Commander Karialan's BIFF faction, have been sighted.

Philippine Army intelligence information showed the rebel group had converged in the area and planned to launch attacks on military and police detachments in the municipalities of Shariff Aguak, Datu Hoffer and Ampatuan, so they can cross the national highway and proceed to the Liguasan marshland.

Senior Supt. Madzgani Mukaram, Maguindanao police director, said. "We have no report on the ground if there are casualties now, what we learned so far is that the enemies were already cornered that is why we secured the town centers and highways."

The sporadic fighting on Tuesday night continued on to the next day after troops were dispatched to the town where BIFF gunmen had converged.

A possible exit that government authorities are closely watching is the nearby town of Datu Abdullah Sangki, Maguindanao

There were no immediate reports of casualties from both sides, but raw military intelligence reports suggest that there had been a sizeable number of militants either killed or wounded in the battle.

Meanwhile. Commission on Elections officials and members of the Bangsamoro Transition Commission and Office of the Presidential Adviser on the Peace Process are set to arrive in Cotabato City to brief journalists on the plebiscite on Friday.

Cotabato City is more than an hour away from the site of the clash in Maguindanao.

The BIFF is a breakaway rebel group of the Moro Islamic Liberation Front (MILF) that forged an interim peace pact with the government in Manila in 2014.

It remains outlawed.

The Bangsamoro Autonomous Region in Muslim Mindanao, which will be created once the Bangsamoro Organic Law (BOL) is ratified in the plebiscite early next year, is set to replace the Autonomous Region in Muslim Mindanao.

The new political entity is a product of the peace process between the government and the MILF.

Campaign period for the plebiscite on the ratification of the BOL will start on Friday, December 7, and end on Feb. 5, 2019.

The MILF has not yet issued a statement on the clashes.

"We haven't heard any or a single case of human rights violation in Mindanao since the implementation of martial law," he said.

"There were allegations by the same sectors of society (critical of President Rodrigo Duterte) but no case was ever filed. These are all allegations and not even substantiated," he added.

On the contrary, the PNP noted a significant drop in the crime volume in Mindanao during the past year.

"Because of martial law, we have a drastic improvement on the peace and order situation in Mindanao where the crime volume dropped by 28,853 incidents or 32.8 percent." he said.

Index crime down

"We have recorded a drop of 44.2 percent on index crimes that include murder, physical injuries and homicide cases. So, these are all the good effects of martial law and also the recovery of almost 10,000 loose firearms in Mindanao," he added.

With the implementation of military rule, Albayaide said the PNP managed to deploy two battalions of its elite Special Action Force in areas in Mindanao, thus increasing police visibility.

He said even tourists have not stopped coming to Mindanao.

Another positive effect of martial law in Mindanao, he added, was the removal of the "control and supervision of local chief executives to the local police." Mr. Duterte declared martial law on 23 May 2017 after elements of the Islamic State (IS)-inspired Maute-Abu Sayyaf Group laid siege on Marawi City which ended on 23 October 2017 with the killing of more than 1,000 terrorists, government troops and civilians.

Most of Marawi City was left in ruins in its aftermath.

The initial six-month military rule was extended to one year by Congress that will expire on 31 December.

Albayalde said the PNP and AFP leaderships have already signed their recommendation to extend martial law in Mindanao for another year. They are expected to conduct next security briefings with lawmakers for their concurrence.

Not on agenda Presidential spokesman Salvador Panelo, meanwhile, said the extension of military rule in Mindanao was "not on the agenda" when President Rodrigo Duterte convened his Cabinet on Tuesday night.

Mr. Duterte is still carefully reviewing the recommendations made by the AFP and PNP of prolonging martial law down South but may announce his decision "today or tomorrow."

"He is still studying it. Wait for the announcement," Panelo replied via text message to Palace reporters when asked about the Chief Executive's take on the peace and order situation in Mindanao.

The Palace official previously said the "safety and security of the people in Mindanao" will be the President's main concern in deciding whether to ask Congress for another martial law extension

Going for 3

Both chambers of Congress have twice extended military rule in Mindanao as a result of the siege of Marawi City by IS-inspired terror groups last year.

On the contrary, the PNP noted a significant drop in the crime volume in Mindanao during the past year.

Viva voce

On Tuesday, the House approved Resolution 15 of both Houses which proposes the revision of the 1987 Constitution through voice voting a day after the period of debates was closed.

This came after Arroyo announced they will focus on the charter change this week with only three session days left before the Christmas break.

The President first declared martial rule on 23 May 2017 effective for 60 days after IS-inspired terrorists placed Marawi City under siege that resulted in a bloody battle with government forces that lasted for five months. It was extended by Congress on 28 July to 31 December 2017. A second extension, this time for a full year, was granted by both chambers on 13 December 2017. The declaration is set to expire on 31 December.

Earlier this week, Mr. Duterte had said the AFP's and PNP's recommendation "has not yet been submitted" to his office, but Justice Secretary Menardo Guevarra bared the issue has been "taken up privately elsewhere."

House to heed call

Speaker Gloria Macapagal Arroyo said the House of Representatives is bound to heed a call from Mr. Duterte for an extension.

"If it comes to our chamber, I will recommend to pass it," Arroyo said in an interview, referring to the possible extension of martial rule.

Despite only three session days before the proposed Federal charter has passed on second reading last Tuesday, the Speaker denied the House

During the period of amendments, the line of succession after the President during the transitory period was changed from Senate President to Vice President.

ACT Teachers Partylist Rep. Antonio Tinio also moved to insert the anti-dynasty provision in the House version. However, it was rejected through voice voting.

With Hananeel Bordey, Elmer N. Manuel of Representatives "railroaded" its passage.

"Well, it's part of the democratic process. There was a debate, it was voted on, we sent it to them," Arroyo, who also pushed for charter change during her administration, said.

The former President said they should take it up on third reading possibly on Monday.

Own interest

Minority Leader Quezon Rep. Danilo Suarez said the Senate is "not in the mood" for the proposed amendments to the 1987 Constitution as there were issues in the House version that night "threaten" the existence of the chamber.

He said it is "high time" to revisit the Constitution as the current charter was made out of "vengeance" and it instill that "anything that is Marcos is bad."

"The conditions 30 years ago no longer exist. It is time to revisit the Constitution. We must determine whether its provisions are sustainable and can stand firm, as our nation is continuously adapting to an evolving, connected world," Suarez said.

Moreover, BUHAY partylist Rep. Lito Atienza added it should be revised, but the House leadership should be "more democratic" and "lenient" to encourage more intelligent discussion and to prevent being a "stamp pad" Congress.

Military: No over-reaction to Abu Sayyaf threat

THE Armed Forces yesterday justified the creation of the 11th Infantry Division of the Army to hasten the defeat of the Abu Sayyaf terror group.

The 11th ID, which will be composed of around 4,500 soldiers, will be tasked to hunt down some 300 Abu Sayraf members operating in Sulu.

"It's not overreaction," said AFF spokesman Brig. Gen. Edgard Arevalo in a press briefing in Camp Aguinaldes

Arevalo said what will be created is merely the headquarters of the 11th ID, to be based in Sulu, and the personnel that will be useful it are the same forces that are already conducting operations in the area.

Defense Secretary Delfin Lorenzana said the division is due to be activated by President Duterte during a visit to Sulu on December 17. He said the division will have operational control over three brigades composed of around 4,500 men.

"What we're creating acroady is just the headquarters. The composition of that 11th Infantry Division remains to be the units, the personnel, and the equipment already in Sulu," said Arevalo.


Army spokesman Col. Louis Villanueva earlier said the Joint Task Force Sulu, which controls the three brigades in Sulu, will be dissolved to give way to the divi-sion. The task force is under Brig. Gen. Divino Rev Pabavo.

"We would like to have a unit that has a particular command and control of the units and personnel already there. We need it so we can enhance, be more effective and make the operations more efficiently," said Arevalo. 1)d

"For now, the focus will only be the province of Sulu," he added.

He could not immediately say who is going to be in command of the division but said the selection process is ongoing.

Arcvalo said the military has no specific timetable as to when to defeat the Abu Sayyaf, which is blamed for numerous atrocities, including bombings, kidnappings, and beheadings. The group is holding 10 foreign and Filipino kidnap vicums in Sulu.

China is the largest net importer of petroleum in the world. China wants the lion's share of the oil and gas in the South China Sea. The Chinese estimates that the South China Sea holds 130

billion barrels of oil, and if this is correct, the South China Sea has more oil than either Kuwait or the United Arab Emirates Areserve of 130 billion barrels of oil

can supply China's oil needs for 22 years. The South China Sea is also rich in methane hydrates – said to be one of the fuels of the future. China wants to secure all these methane hydrates, which can fuel China's economy for 130 years.

China also wants the South China Sea as a sanctuary for its nuclear-armed submarines - free from surveillance by US submarinehunting Poseidon aircraft or US nuclear powered attack submarines. China wants a second-strike nuclear capability, joining the ranks of the US and Russia. A secondstrike capability means a nuclear power, after its landbased nuclear weapons are obliterated in a pre-emptive first-strike by nuclear-armed enemy, it can still retaliate with its nuclear-armed ballistic missile submarines. This second-strike capability deters an enemy from making a pre-emptive first strike.

illegal reclamations and harvesting of endangered species

The coral reefs in the Spratlys serve as the breeding ground of fish in the South China Sea. It comprise 34 percent of the world's total coral reefs, despite the South China Sea occupying only 2.5 percent of world's total ocean and sea surface. Coral reefs are the single most valuable ecosystem – a hectare of reef can produce a potential value of approximately \$350,000

a vear.

Prom 2014 to 2016, China deployed dozens of dredgers in the Spratlys. The rotating cutters of these dredgers pulverized the coral reef and the hard sediment on the seabed. The pulverized materials are pushed by pressure through a floating pipe and deposited on the rim of the reef. This kills all the coral reefs in the atoll. Dr. McManus, a marine biologist who has studied the marine life in the Spratlys, made a survey in February 2016 said "China's reclamations are the most rapid permanent loss of coral reef in human history It's a terrible, terrible thing to do this. It was really a massive destruction."

The nine-dash line claim of China drilled Into the Chinese

In December 1947, the Kuomintang Government of China adopted the ninedash line claim, embodied in the Location Map of the South Sea Islands, released in China, February 1948, with 11 dashes forming a broken U-shaped line covering almost the entire South China Sea. The title of the map indicates China's claim of the islands enclosed by the eleven dashes, namely Pratas, Paracels, Macclesfield Bank, and Spratlys. China was silent on any claim to the surrounding waters. Scarborough Shoal is not mentioned in the map. Macclesfield Bank is not an island because it is fully submerged. In 1950, China under communist rule, announced the removal of two dashes in the Gulf of Tonkin. The line became known as the nine-dash line.

Once the Chinese people realize the falsity of the ninedash line, they themselves will be too ashamed to press the nine-dash line claim before the world. That will be the time when the Chinese government can comply with the ruling of the arbitral tri-

Squeezed and caught in the crossfire: The story of the Lumad

FERTILE land promising a Thounty of natural resources, from forests to minerals, that hapnens to be the home of indigenous peoples is certain to become a political flashpoint. We saw this in the hills plains and valleys of both Americas, in Asia and Africa. Evervwhere there are native peoples living in pristine environments blessed with natural wealth, we see outsiders coming in, laying claim to the land. Armed with superior force, these outsiders intrude into the natural and cultural habitats, effectively destroying the cultural ecologies that sustain the logic of the native peoples.

Externally, the colonization of native peoples became an



imperative for the expansion of empires seeking new territories. These territories are primarily seen for their natural resources and their strategic advantages. even as their inhabitants are always seen as either problems to be annihilated or human resources to be assimilated. Indigenous economic and political systems are displaced in favor of extractive and exploitative modes of production

tragic procession of monarchs and native chiefs dethroned. local resistance subjugated and killed, and native consciousness colonized and corrupted.

This is the story of the formation of the Philippines as an outcome of a painful process of colonization. And well and as if we did not experience the tragedy attending colonization and failed to learn lessons from it, we are also doing it to our native populations.

The Lumad of Mindanao, which is the collective name given to non-Muslim ladigenous peoples living there have suffered the curse of being the

offered outsiders the promise of unbridled wealth-making. Their forexis became beacons for logging companies to cut, and when these were gone, to convert to industrial forest plantations. Buried deep in their mountain ranges are mineral ores and gold which became irresistible magnets that attracted mining companies. The tragedy of the Lumad is that the logging and mining interests coincided with, and on many occasions, even carried the interests of the political and economic clites who were in control of the seats of power and influence in government. These interests are amply represented

in the Cabinet, in Congress and in various local executive and legislative positions. To these, the Lumad were no match.

The only option left available for the Lumad, as an alternative to capitulation whose consequence is loss of their land and their very being, was to fight. Faced with a government that could not represent their interests, the Lumad tribes fighting for their land rights were left with no choice but to join the only available option, which is that offered by the communist rebels.

It would have been easy for every Filipino who knows his or her history to understand the predicament of the Lumad. After all, our nation was born through the blood of our martyrs and heroes who fought the Spaniards and the Americans It would not have taken a lot of effort to express empathy towards the plight of a people who are just fighting for their land. It would not have been much of an exercise of solidarity with them for us to understand why the Lumad would join the rebel forces, and would find hope in the ideology that the CPP-NPA-NDF offered to them, simply because the government appeared to have abandoned them when it took the side of the capitalist landgrabbers.

Indeed, one could argue that the state attempted to take the developmentalist route to address the land rights issue of the Lumad. The Indigenous People's Rights Act (IPRA) was enacted through RA 8371 in 1997, and the National Commission for Indigenous Peoples (NCIP) was established as an outcome of the law. In theory, the Lumad would have been entitled to be awarded their Certificate of Ancestral Domain Titles (CADT).

But the influential elites, with knowledge of the legal

loopholes, and with influence to peddle, took advantage of the paternalistic and hierarchical cultures of the Lumad tribes, and were able to effectively coopt many datus to grant them free and prior informed consents (FPIC) for their continued exploitation of the Lumad lands despite these now being covered by CADTs. In fact, some powerful personalities were even able to exercise their influence and were able to install their own datus, thereby displacing the indigenous power structures in the tribal communities

This further fucled Lumad resistance against these external forces, and indirectly, against the state and the government.

Unfortunately, instead of understanding, what the state gave in return to the Lumad is the iron fist, lumping them with the communist rebels and declaring them

to be enemies of the state. Instead of a compassionate approach, what the state unleashed was further militarization. What is even more tragic is that the military appeared to have adopted a divide and conquer approach when it formed Lumad paramilitary militias to wage its low-intensity ground war against the CPP-NPA-NE)F, thereby effectively pitting Lumad against Lumad.


In the end, the Lumad is squeezed and caught in the cross-fire between the military and its Lumad paramilitary militias on one hand, and the CPP-NPA-NDF and its Lumad cadres on the other.

There are allegations that the CPP-NPA-NDF is using the Lumad schools to indoctrinate the Lumad youth in the communist idealogy. The existence of these schools is in fact a structural reaction to the relative neglect of the state of the educational needs of the Lumad, by failing to establish government schools in their areas. This led to Church-based organizations and progressive and leftist NGOs filling up the void by establishing alternative Lumad schools, Indeed, it is plausible that these schools can provide an avenue for breeding rebellious minds. As to whether they actually do so remains to be established by an objective fact-finding process, and not conducted by the military or by progressive forces allied with the Left. And the long-lasting solution is for the Department of Education to make its presence felt and supervise closely these Lumad schools, and provide them technical and financial support.

It is most unfortunate that the anti-insurgency campaign of the government remains fixated on a militaristic approach. In response to ambushes, assassinations and attacks by the rebels, the military and paramilitary militias respond with equal force by harassing the Lumad who are suspected of being members of the NPAs. Here the Lumad schools which are suspected of teaching Lumad children the communist ideology are the onesthat suffer as collaterals, with their students and teachers being caught in the middle of and held hostage by a tug-of-war between government and rebel forces.

It's about time the government re-examine its approach towards the lumad. The root of their discontent is their loss of security to their ancestral lands. The state has only to secure these, and endeavor to convert their areas into peace zones. This can be achieved by engaging the Lumad combatants from both sides in localized peace talks, with the military and the CPP-NPA-NDF being prohibited from entering the picture. Only then can a long-lasting peace be possibly attained.

Mutual benefit should guide PH-China ties



WE HAVE been fortunate to take a close look at China in two separate visits-in April 2017 and in June this year. In these two media visits—the first took us from Guangzhou to various cities in the southwest and ended up in Shanghai, the second from Beijing and on to Harbin city near the border with Russia-we marveled both at the scale and pace of economic progress the country has been making since the People's Republic of China was founded in 1949. To think that from the '50s to the '60s

and mid-'70s, China had witnessed both political upheavals and economic setbacks. It managed to surmount all this to emerge as the second-biggest economy in the world today after the United States.

That China is now an economic giant and at the same time a military power is a reality that we must learn to live with. That much is how longtime China

resident Jaime FlorCruz, a former CNN Beijing Bureau chief and now Peking University professor, views our current ties with our neighbor to the west.

Take the controversy over the issue of joint exploration and development of oil and gas resources in the West Philippine Sea. While there are those who say that we should not enter into such an arrangement as this would negate our legal victory in the Permanent Court of Arbitration in 2016. there's also the view, as articulated by FlorCruz, that the idea of joint exploration is "very complicated" as it involves legal, territorial and sovercignty issues

"We really need the oil and gas. Our oil and gas supply is fast depleted and

we need more. So for pragmatic reasons, we should be open to exploring the possibilities of doing it," he pointed out in a recent TV interview.

FlorCruz believes that while the Hague ruling represents a "good legal and moral victory" for the Philippines, we should "take that out of the front and center of our relationship with China. We do not concede that it's China's, we still insist on the territory that it's ours Meanwhile, let's explore the possibilities."

The pragmatic approach appears to be working, from all indications.

In his remarks at the reception to mark the 69th Founding Anniversary of the People's Republic of China, Chinese Ambassador Zhao Jianhua observed that 2018 witnessed the sustained growth in Philippines-China relations, with the leaders of the two countries already having met at least five times on bilateral and multilateral occasions. The state visit of Chinese President Xi Jinping in late November further strengthened bilateral ties, with no less than 29 agreements signed during the occasion.

Since the second half of 2016, the two countries have revived a series of dialogue and consultation mechanisms in such areas as foreign affairs, defense, energy, economy and trade, agriculture, fisheries, science and technology. There have been also increasing interactions and exchanges between local governments, media agencies, universities, think tanks and cultural institutions.

The Philippines and China have also maintained good economic ties. Last year, trade volume reached \$50 billion, which made China the Philippines' No. 1 trading partner and import origin, and the fourth largest export market. Also in 2017, additional investments from China reached \$53.84 million, representing a year-on-year increase of 67 percent. In the first five months of this year, China poured another investment of \$165

million into the country.

China is also assisting the administration's Build, Build, Build infrastructure program through outright grants, commercial loans and loans under official development assistance. So far, two bridges over Pasig River and the Chico River Pump Irrigation Project have already started. The two sides are pushing forward more big infrastructure projects, such as New Centennial Water Source-Kaliwa Dam, Subic-Clark Railway, Philippine National Railways South Long Haul and the Safe Philippines, with total volume surpassing US\$ 7 billion

The Philippines is also benefiting from increased tourist arrivals from China. In the first seven months in 2018, more than 760,000 Chinese tourists visited the country, representing a 40-percent year-on-year increase. More than 1.5-million Chinese tourists are expected to visit the Philippines this year, with the tourist influx expected to generate revenues of more than P32 billion.

Relations between the Philippines and China have deteriorated in recent years because of conflicting territorial claims in the South China Sea/West Philippine Sea. But the two countries agreed to initiate dialogue through the Bilateral Consultation Mechanism and Joint Coast Guard Committee, and explored practical cooperation in various areas, such as fisheries, maritime affairs, joint search and rescue, marine scientific research and environmental protection

What the two sides are doing at this point is to properly manage differences in views through diplomacy and dialogue and to focus on cooperation in various fields of endeavor.

With the Duterte administration choosing to emphasize common interests rather than differences, bilateral ties have markedly improved in the past two years. For as long as we deal with the Chinese government on the basis of mutual benefit and mutual advantage, we can expect better prospects for trade and investments and development cooperation in the years ahead.

And since the government has special relations with the US that extends to economic, political, cultural and military control, the balancing between global superpowers means developing better closer ties with China

> Indeed, President Duterte has surpassed all previous Presidents CROSSCURRENTS in terms of his closeness to Beijing Antonio Tujan and has a better record compared

to others, including Gloria Macapagal Arroyo in terms of creating goodwill and attracting Chinese capital. He has already made three official visits to China, bringing with him a large entourage of investment businessmen and government officials, making him the most frequent traveler to China among all Philippine Presidents.

Expectedly, our traditional politicians are true-blue and die-hard supporters of the US. Thus, they criticize Duterte for his overtures to China. But Duterte loves Trump and the US, too. He may deny it, but he would also qualify as a staunch supporter. But at least he is balancing the relations between two powers. And there is a lot of ground to cover.

Duterte's interest is not simply balancing



relations. The Philippine government seeks China's support for at least P788 billion worth of infrastructure projects accounting for almost half of the PL5 trillion flagship projects under the Duterte administration's "Build, Build, Build" program. To date, it has already identified P392 billion worth of projects for China's consideration.

China's portfolio in the Philippines includes: the PNR South Long Haul, Mindanao

Railway, Subic-Clark Railway, Chico River Pump Irrigation Project, New Centennial Water Source-Kaliwa Dam, Hocos Norte Irrigation, Pasig-Marikina River bridges, Davao Samal bridge, Davao River bridges, Davao City Expressway, Panay Guimaras Negros bridge Camarines Sur Expressway, Agus-Pulangui Hydroelectric Power and the Ambay-Simuai Rio Grande de Mindanao flood control project. It is also building the Philippine National Police. Bureau of Isil Management and Penology and Bureau of Fire Protection command centers in Metro Manila and Davao.

But there are many controversial issues that the government has to deal with properly. First of all, do these projects truly fulfill the needs of the

masses or are they made to sacrifice their lands to give right of way only to favor big business. Chinese and Filipino alike?

China official development assistance has become controversial Duterte with its high-profile cases that stipulate the collateralization of resources and state assets should a country default on its loan payments and actually enforces its claim. The Sri Lankan government, for instance, was forced to lease its strategic Hambantota Port for 99 vears to a Chinese company when it was unable to pay back its debt.

Such conditions are standard in the terms of reference in China loans and are included in the Chico River Pump Irrigation loan agreement. Additionally, these loans require that

disputes in the agreement, as well as the rights and obligations of both parties, be put beyond the scope of Philippine laws and transparency in the public domain. Such disputes are to be settled at the China International Economic and Trade Arbitration Commission (CIETAC) and the agreement "shall be governed by and construed in accordance with the laws of China."

There is a phenomenal increase in Chinese capital flowing into the Philippine economy.

China has recently overtaken the US in terms of foreign direct investment (FDI) inflows and

In the first semester of 2018, FDI from China amounted to \$175 million as compared with Japan's \$154 million and US's \$84 million. From January to September, Philippine exports to China (including Hong Kong) amounted to \$13. 9 billion compared to exports to the US worth \$7.8 billion. This is just another aspect of rebalancing economic relations between the two powers.

Behind the reciprocal visits of heads of state and officials to cement diplomatic and political-economic cooperation is the target to become part of China's Belt and Road Initiative which could otherwise bypass the Philippines. China already controls the disputed South China Sea/West Philippine Sea through the series of garrisons built on the islets and atolls to the actual loss of our claims.

In the end, it is important to remember that the US and Japan remain dominant in the Philippine economy. They hold the largest FDI stock in the country which is an important indicator of the extent to which foreign capital exploits Filipino labor, natural resources and markets and also points to how much of the country's economic surplus is repatriated abroad. 🛇



A dare

Rody's political foes should be challenged to live for a while in suspected Islamic State lairs in Mindanao to know the real situation close up.

President Rody Duterte provided resolute action in imposing martial law in Mindanao to smother the Islamic State (IS) incursion in May last year, a move that surprised even his yellow foes who accused him of setting the stage for a nationwide imposition.

The opposition's line remains the same after two extensions granted by Congress and a possible third until the end of next year which security officials have recommended.

Rody's proposal to Congress for a one-year extension of martial rule is a certainty after Defense Secretary Delfin Lorenzana, the recommending authority, said he would follow the views of the police and the military to extend martial law for another year.

The usual critics immediately recycled criticisms already discredited by recent assessments of a benign military rule that contributed to the economic transformation of most parts of Mindanao.

A left-wing partylist House member said extending martial law in Mindanao for the third time may embolden the AFP to expand its coverage to the whole country.

Lorenzana, however, said terrorist activity is again strong as terrorists from Malaysia, Indonesia and the Middle East who are experts in bomb-making have entered Mindanao.

The protests, however, are pointless and can be consigned to the political noises now in vogue as national elections are set next

the Supreme Court (SC) already ruled that martial law and the terms for its implementation are within Rody's powers.

Regarding petitions to invalidate Rody's Proclamation 216, the SC decision gave the President preeminence in using powers available to him during a crisis period.

In the majority decision penned by Associate Justice Mariano del Castillo, the SC said, "The Constitution grants him the prerogative whether to put the entire Philippines or any part thereof under martial law."



"There is no constitutional edict that martial law should be confined only in the particular place where the armed public uprising actually transpired," the SC ruling stated.

It likewise affirmed the role of the House in the discussions related to the basis for the martial rule edict which invalidated the chamber's minority views.

By issuing a resolution supporting it, the House of Representatives is declaring that it finds no reason to review the sufficiency of the factual basis of the martial iaw declaration which is in direct

contrast to the petition of Albay Rep. Edcel Lagman, the SC said.

The tribunal even said it merely took a liberal approach through "judicial self-restraint" to accept the petition for review.

The ruling stated the judicial power to review the sufficiency of factual basis of the declaration of martial law or to suspend the privilege of the writ of habeas corpus does not extend to the calibration of the President's decision on what powers he will avail of in a given situation.

The President as Commander in-Chief wields the extraordinary powers of calling out the armed forces, suspending the privilege of the writ of habeas corpus and declaring martial law, according

to the SC ruling.

The Supreme Court already ruled that martial law and the terms for its implementation are within Rody's powers. It was also the SC which debunked the allegations of dictatorial tendencies on Rody.

It said he exhausted all options available to him before declaring martial law.

The President decided to use his power to call out first. Unfortunately, the situation did not improve; on the contrary, it only worsened, according to the SC.

PNP, AFP recommend 1-year ML extension in Mindanao: Albayalde

MANILA -- Police and military officials have signed a document recommending to President Rodrigo Duterte a year-long extension of martial law in Mindanao, Philippine National Police (PNP) Chief, Director General Oscar Albayalde, confirmed.

"We have just signed a document together with the outgoing military chief of staff (Gen. Carlito Galvez) recommending the extension of martial law in Mindanao for another one year," Albayalde said in a TV interview on Wednesday.

Citing PNP data, he said crime volume in Mindanao dropped by 32.8 percent since January this year.

"Because of the martial law, we have a drastic improvement on the peace and order situation in Mindanao where the crime volume dropped by 28,853 or 32.8 percent — because of the implementation of martial law and because of the forces present there now conducting target hardening measures, military operations, police operations, checkpoint operations," he said.

Albayalde said most notable is the 44.2-percent decrease on index crimes, which include murder, physical injuries, and homicide cases.

The freedom to conduct operations and implementation of security measures under martial law has also resulted in the confiscation of some 10,000 loose guns in Mindanao, he added.

"So, these are all the good effects of martial law in Mindanao," Albayalde said, adding that it resulted in the people of Mindanao feeling safer now.

He said there has been no reported incident of human rights violation since the declaration of martial law in the island.

"That's one thing good. We haven't heard of any or a single case of human rights violation in Mindanao since the implementation of martial law. These are all allegations by the same sectors of society, but no case was ever filed. These are all allegations and not even substantiated," he noted.

Martial law in Mindanao was declared on May 23, 2017 following attacks launched by the Maute Group in Marawi City.

The House of Representatives, in a special joint session in July last year, granted the extension of martial law until Dec. 31, 2017 at the President's request.

The Senate and House of Representatives, convening in a joint session early December, granted the Chief Executive's request for the extension of martial law and the suspension of the privilege of the writ of habeas corpus for a period of one year from Jan. 1 to Dec. 31, 2018. (PNA)

New Sulu-bound infantry division activated this month

MANILA -- To fully neutralize Abu Sayyaf Group (ASG) terrorists in Sulu, the military will formally activate a new infantry division sometime this month.

"The unit shall be oriented, armed, and equipped to address the peculiarity of the enemy, weather, and terrain; as well as enemy techniques, tactics and procedure; and other variables that are unique to the island province of Sulu," Armed Forces of the Philippines (AFP) spokesperson, Brig. Gen. Edgard Arevalo said in a press briefing Wednesday.

Defense Secretary Delfin Lorenzana said the new unit will be activated on December 17.

With the activation of this unit, the AFP will now have 11 infantry divisions, one mechanized infantry division, one Army artillery regiment and various support and logistics units.

"The President expressed concern that, despite the AFP garnering major victories in Sulu, government security forces continue to incur casualties. The AFP leadership, and in response to the clamor from the local government executives, has recommended the activation of a division-sized unit that shall be permanently stationed in Sulu Archipelago," Arevalo added.

The AFP spokesperson said creating a new infantry division is a much better option that moving an existing unit from elsewhere in the country.

"Hence, the (proposed) activation of the 11th Infantry Division is envisioned to effectively and efficiently engage and decisively defeat the lingering security threat in Sulu in the soonest time possible. For the time being, the units already in the area: Two Infantry Brigades, Two Infantry Battalions; Two Special Forces Battalions, among other Navy-Marines units will initially man the Division," he added.

Other component units and capabilities to find, fix, shoot, move, and communicate to fully compliment the Division will be gradually filled up until 2022, Arevalo added. (PNA)

AFP chief stands pat on rebel tag on Ocampo, Castro

MANILA — Armed Forces of the Philippines (AFP) chief-of-staff, Gen. Carlito Galvez, Jr. stands firm on his statements that former Bayan Muna Rep. Satur Ocampo and ACT-Partylist Rep. France Castro are active members of the Communist Party of the Philippines-New People's Army (CPP-NPA).

"The AFP chief-of-staff stands pat by the statement he made the other day (Monday). He questions the motive of Mr. Satur Ocampo and ACT Partylist Rep. (France) Castro in going to Talaingod, Davao Del Norte at the dead of the night in spiriting away 14 minors from Salugpungan Learning Center to unknown destination without appropriate courtesies to local government executives, devoid of any parental authority or permission," military spokesperson Brig. Gen. Edgard Arevalo said in press briefing Wednesday.

He added the incident has all the indications of kidnapping.

"If there is anything, they must be afraid of, it is not their so-called 'red tagging' by the AFP. It is the cases legally and validly filed against them and the mounting evidence against their infamous version of 'rescue'," the AFP spokesperson said.

Arevalo added that the AFP chief cannot be cowed by reports that the party-list representatives are filing a case against him.

"He has been incarcerated in the past for fighting for what he believes in. All his prime spanning nearly four decades, he has been putting his life and limb and that of his men on the line in the name of protecting the people and securing the state. What else can be more patriotic than that as against enemies of peace and development?" the AFP spokesperson added.

Arevalo also said the AFP chief will not succumb to propaganda and lies of the enemies of the state who belong to front organizations of the CPP.

"He will not cower in fear for this terrorist organization that has exploited and killed Lumad tribesmen and their leaders and even fellow NPAs on mere suspicion of being government assets; NPA that murders their own people who plans to leave their inutile struggle and return to the folds of the law and their families," he said. Duterte eyes Galvez as next OPAPP head

Armed Forces of the Philippines (AFP) Chief of Staff Carlito Galvez Jr. as the next head of the Office of the Presidential Adviser on the Peace Process (OPAPP), Malacañang announced on Wednesday.

"The President announced his intention to appoint Carlito Galvez Jr. to the Office of the Presidential Adviser on the Peace Process" during Tuesday night's Cabinet meeting, Presidential Spokesperson Salvador Panelo said in a statement.

Galvez, a member of the Philippine Military Academy Class of 1985, will step down on Dec. 12 upon reaching the mandatory retirement age of 56

He had served the military for 30 years, including eight months as top official of the AFP.

Last week, Jesus Dureza resigned as Presidential Adviser on the Peace Process, taking full responsibility for the corruption allegations against two OPAPP officials – Undersecretary Ronald Flores and Assistant Secretary Yeshter Donn Baccay.

During the inauguration of the Bohol-Panglao International Airport, Duterte announced he regrets accepting the resignation of Dureza, a high school classmate at the Cor Jesu College in Digos City, Davao del Sur.

Duterte fired Flores and Baccay over allegations of corruption. Both were involved in the OPAPP support services and implementation of the PAMANA (Payapa at Masaganang Pamayanan) projects. (PNA)
