CESSPOOL TAGUPSETS BORACAY RESIDENTS

Townsfolk and entrepreneurs welcome the President's six-month deadline for fixing the sewage problem but are dismayed by his comparison of the tourist destination to a pit of fecal matter.

Residents and business operators on Boracay Island are unhappy with President Duterte likening the world-famous tourist destination to a pit of human waste.

But they welcome his directive to Environment Secretary Roy Cimatu to solve the sewage and garbage problem in Boracay in six months, or he would shut down the island resort.

"[C]alling the island a cesspool shows the President is probably misinformed of the nature and magnitude of the problems," said a resident business operator, who asked not to be named to avoid reprisal from the President or his supporters.

"Does he even think what will happen to the thousands of workers and their families who earn a living here if the island is closed down?" said the resident.

Another resident said the President's hardline stance could move other officials to take action. "Maybe the governor, congressman and local government units will wake up."

Unfinished drainage system

A business leader said Boracay's problems had worsened due to the inadequate support from the national government, citing the island's drainage system, which had yet to be completed more than 10 years after the project started.

"What we need is less reaction and condemnation and blame. We need actual ideas, solidly researched and organized plans, and leadership that will do the hard things to ensure Boracay can get through current difficulties," said another business leader.

In a speech during a business forum at the Marco Hotel in Davao City on Priday, the President said: "I will close Boracay, Boracay is a cesspool."

He said Boracay's sewage and garbage problem was destroying the island's ecosystem and posing a threat to the health of millions of visitors.

"There will be a time that no more foreigner will go there because ... when he goes back to the plane, he will be full of shit going back and forth to the restroom," he said

In illustrating how serious the problem was, the President said garbage was just 20 meters away from the beach.

"At a distance, you see white sand. But you go into the water, it's smelly. Smell of what? Shit because everything that goes out in Boracay ... it's destroying the environment or the Republic of the Philippines and creating a disaster," Mr. Duterte said.

Shame

Tourism officials affirmed the President's assessment.

'It's a shame that Boracay, which has repeatedly been recognized by prestigious travel magazines as the world's most beautiful island, may yet end up a paradise lost if water contami-

nation continues," Tourism Secretary Wanda Teo said in a statement

Ricky Alegre, the Department of Tourism spokesperson, said a number of establishments were draining their sewage directly into the sea.

Of the 150 business establishments recently inspected by
the government, only 25 were
connected to the sewage line,
he said.

Many establishments were also building too close to the beach and spilling over into the roads of the 1,000-hectare island, Alegre said.

That was why, Mr. Duterte said, Cimatu should solve the problem in six months. "I'll give you six months. Clean the (fucking) thing."

Task force

The President earlier approved the creation of a task force to deal with the problems

in Boracay

Cimatu himself had warned owners that their establishments on the island would be shut down if they were found releasing sewage into the sea.

He said a "a serious and honest-to-goodness crackdown" was needed to bring Boracay back to what it was—clean beach and unspoiled environment.

The Department of Environment and Natural Resources (DENR) earlier urged officials of Malay town, Panay province—to which Boracay belonged—to require establishments and residents to connect to the island's sewerage system to prevent untreated wastewater from flowing into the sea.

"It's not just establishments, but even the houses of local residents are not connected to the sewerage system," Jim Sampulna, director of the DENR in Western Visayas, previously said.

2M tourists

Sampulna said overpopulation was also a problem for the island-resort. Some 50,000, many of them workers, live in Boracay.

The island also hosts at least 2 million tourists yearly and brings in P56 billion in annual revenues, according to tourism department and industry sources.

As a result, the carrying capacity of the island has been exceeded since 2010, according to Sampulna. —with reports from Jaymee T. Gamil and AFP INQ

DoJ criminal raps vs Spanish Abu sympathizer out this week

The Department of Justice is set to come out this week with its resolution on the criminal complaint filed by the military against a Spanish "militant sympathizer" who was arrested in Basilan last month.

The investigating panel had already finished its preliminary investigation over the case last January 31.

"It might come out this week," said Senior Assistant State Prosecutor Peter Ong.

Abdelhakim Labidi Adib sought the dismissal of charges of illegal possession of explosives filed by the Army's 14th Special Forces Company against him.

Adib, 20, a Spanish citizen of Tunisian descent, was arrested last January 22 at a military checkpoint in Basilan.

Government troops claimed he was accompanied by an Abu Sayyaf Group member who was one of their argets.

His companion, however, manged a clude arrest.

Seized from Adib's possession were grenades and bomb-making equipment.

In his counter-affidavit, Adib efuted the allegations against him, laiming that the pieces of evidence resented were "planted by the greating officer."

"I vehemently deny and assert that don't own and I have nothing to do vith the alleged recovered evidence which are the hand grenade and the lleged improvised explosive device IED)," he stressed.

"I was illegally arrested by civilian ersons, I was just walking on the

It was planted by the arresting officer because I never have those items in my bag nor in my possession," part of Adib's 10-page counter-affidavit stated.

He said he arrived in Manila last Oct. 10, 2017, and went to Davao where he visited several attractions before proceeding to Cagayan de Oro, where he met a certain "Abuzaid" who claimed to be a member of the Yakan tribe.

He said Abuzaid offered to take him to his tribe and introduce him to its culture.

"I went here in the Philippines as a tourist. I have no intention whatever to aid anyone in any terrorist activity, especially in causing trouble to the

The suspected militant sympathizer had previously traveled to Morocco and Tunisia, citing information on his passport.

According to Adib, he chose the Philippines because he heard a lot of good reviews" about the country.

"I began thinking about going to the Philippines when I heard so many good reviews and feedback about the country that it is a touristic place with beautiful islands and scenery and above all, splendid people who are very accommodating and hospitable," he said.

He added it was not his intention to go to Basilan and that he went to the Philippines only for a vacation.

Adib said he stayed for two months in Cagayan de Oro.

'Not a happy experience'

From Cagayan de Oro, he said they proceeded to Zamboanga and eventually to Basilan, a known anglet of the Ab The Transport for-ransom group, to visit the Yakan tribe.

While in Basilan, he said the three weeks he spent with the tribe were "not a happy experience."

"There is no food, no shower, no electricity, no proper shelter and it was not a comfortable stay," he lamented, adding he was afraid, especially after the group showed him photos of dead people.

"I decided to go home. I really regret my decision in going to Basilan. Nobody explained to me that Basilan is a dangerous place," he said.

Before he was allowed to leave, he said the tribe members took his money, mobile phone and some of his personal belongings.

He said he was escorted to Isabela City, Basilan, on January 19 where he was arrested by armed men.

He also countered the military's claim, stressing he was nabbed on

BAGUIO CITY—Environment Secretary Roy Cimatu has ordered a nationwide crackdown on illegal mining operations, starting with pocket mines at the outskirts of the Philippine Military Academy (PMA) here.

'The campaign against illegal mining would be formally launched on Feb. 14 but it was piloted on Saturday at PMA's Fort Del Pilar by the National Task Force on Mining Challenge on Cimatu's instructions, said retired Maj. Gen. Mario Chan, chief executive assistant at the office of the environment secretary.

Chan supervised the closing of at least 15 tunnels around PMA and confiscated equipment and ore taken from these areas. He also deployed 200 men from the police, the military and the Department of Environment and Natural Resources (DENR) to five small-

scale mining areas in the village of Kias near PMA grounds.

NPA financing source?

Chan said the government considered illegal mining a "big problem" because of allegations some operations in the provinces had been used to finance the New People's Army (NPA).

But the Benguet Federation of Small Scale Miners Inc. (BF-SSMI) said that was not the case in the province where the first mines started.

None of the miners here have paid so-called "revolutionary taxes" to communist rebels, said BFSSMI president, Lomino Kaniteng.

He also said miners had applied for the establishment of a "Minahang Bayan" site but the government had not yet acted on it. Former Environment Secretary Gina Lopez had identified an open

pit mine in Itogon town as an appropriate site for Benguet's first Minahang Bayan.

The tunnels and mills inspected and deactivated by the DENR task force were located at the base of the mountain where tributaries of the Bued River flow.

Task force members seized mining tools, containers filled with cyanide, metal carts and small conveyor belts. They also took samples from leachate ponds and hauled out extracted mineral ore.

Security sentinel

Soldiers were sent to secure the mining tunnels and mills that were ordered closed by the government.

No miners were arrested during the operation. However, tension rose in one of the mining areas when residents from neighboring communities tried to discourage the task force from disrupting their livelihood

Kaniteng said closing pocket mines in Benguet would bring hardship to small-scale miners who rely on the industry to feed their families. "If we tell them to stop immediately, where will they get money to send their children to school and put food on the table?" he said.

BFSSMI has 23,000 members operating mine tunnels in seven towns with bigger concentrations in Itogon, Tuba and Mankayan which host large-scale mines.

During peak season, smallscale miners in Benguet produce an average of three tons of gold, Kaniteng said.

It was not clear, however, whether Cimatu's order would also lead to closure of mines in Mt. Diwalwal, where a gold rush has led to the rise of communities dependent on mining.

DUTERTE OFFERS 'LUMAD' 720,000 ROUNTY FOR EVERY REBEL KILLED

DAVAO CITY—President Duterte has offered the "lumad" (indigenous people) P20,000 for each New People's Army (NPA) guerrilla they kill, raising fears of an escalation of violence that has driven thousands of natives to flee their communities to avoid getting caught in the crossfire between government forces and communist insurgents.

Mr. Duterte announced the bounty he had offered to the umad during a talk with reborters here on Friday.

Hunt for lumad killers

The President said he also offered to train the indigenous people in fighting the NPA.

"Give me about three months, I will train them as Cafgu members," he said, referring to the militia group Citizen Armed Forces Geographical Unit

The President has repeatedly accused the Left of using the lumad to fight the government.

He said he would arm the indigenous people and deploy them to hunt down "those who killed their comrades."

Mr. Duterte was referring to the recent killing of a triballeader and his son, which the President blamed on the NPA. The insurgents have never denied nor owned up to the killings.

"You want money? For every NPA that you can kill, you lumad who would become Cafgu, I'll bay you," Mr. Duterte said.

Kerlan Fanagel, chair of the Pasaka Confederation, an umbrella organization of 39 lumad groups from an area that extends from the Caraga region to Central Mindanao, said Mindusterte's plan was alarming.

"He's now using the lumad

as bait," Fanagel said. "What kind of solution would it bring?"

Instead of ending the insurgency, he said, giving the lumad a prominent role in fighting the guerrillas would further divide the natives.

More killings

The bounty would lead to more killings of lumad, especially those tagged as communist insurgents or sympathizers of the communists, he said.

"It's not the responsibility of the lumad to run after insurgents," said Fanagel, who is a B'laan.

"The government should protect us from those causing us suffering, like large corporations," he said.

The solution to the communist insurgency, he added, is to deal with its roots, like poverty,

Mr. Duterte has not stopped ranting against the communist insurgents since he terminated peace talks with them late last year.

Rallving lumad

At a meeting with selected lumad groups earlier this month, Mr. Duterte tried to rally the natives against the NPA.

After the meeting, a lumad leader who supported the government, Datu Banadjao Mampaundag, and his son, Jhonard, were killed allegedly by NPA guerrillas in Talaingod, Davao del Norte.

On Wednesday, lumad leaders supporting the government's counterinsurgency campaign threatened to wage a tribal war to avenge the killing of Mampaundag and his son.

But that, too, would be dangerous, according to Fanagel, because it could lead to the targeting of lumad who had been tagged as communist insurgents. INQ

Duterte offers P20K bounty for head of every NPA rebel

DAVAO CITY — President Puterte offered a P20,000 bounty for the head of every member of the New People's Army (NPA) who continue to harass the indigenous Peoples (IPs).

This was the President's reply when asked about the killing and continued threats on IP leaders who do not support the cause of the communist groups.

Diterte bared at a press conference on Friday night at the Matina Enclaves in Davao City that he wants the IPs to be trained as Citizen Armed Force Geographical Unit (Cafgu) for them to be able to fight against the rebels.

"Go out and hunt those who killed your comrades," he said.

He said the IP would be trained for three months, after which they would be given firearms to use in fighting the rebels.

"I'll put a reward to those Lumads (IP) who will become Cafgu, one NPA you will kill I'll pay you. You want money, I give you money, I'll make P20,00 per head," he said.

Anyway, he said the government has money. However, in the meantime, the President advised the Lumads who are being harassed by the NPA to evacuate temporarily to areas near the military camps or other places.

The Eastern Mindanao Command has reported the death of Datu Banadjao Mampaundag and his son Jhonard inside their home in Sitio Igang, Barangay Palma Gil in the town of Talaingod, Davao del Norte on February 4.

The rebels allegedly strafed the house of Mampaundagusing a vehicle to appear they were soldiers.

Aside from killing the victims, the rebels also tried to ambush the responding ambulance to rescue them.

On February 9, the Indigenous Peoples Mandatory Representative (IPMR) of the Mamanwa Tribe in Alegria, Surigao del Norte identified as Dakula Guillermo Tiambon was shot dead in front of his family in their farm at Sitio Palo 10, Barangay Camp Edward, Alegria, Surigao del Norte on Friday afternoon.

According to the victim's daughter, her father received death threats from the NPA for being an active advocate of peace and development.

On February 8, Lumad leaders in Talaingod launched a protest seeking justice for the killing of the Mampaundags.

Last January 31 to February 1, Lumad leaders from four regionsin Mindanae convened in Davae City upon the initiative of the President to hear their concerns

The two pressing issues raised by the Lumads were on their security and lack of economic opportunities to uplift their lives.

BBL lasting solution vs terrorism — AFP exec

The passage of the Bangsamoro care Law (BBL) will significantly sen the threat of terrorism and tremism in Mindanao, a ranking litary official said.

According to Lt. Gen. Carlito dwez Jr., commander of the litary's Western Mindanae mmand (Wesmincom), since the Lis designed to address the rootcauses of the Mindanae conflict, it will dissuade people from joining extremists and the terrorists like the Abu Sayyaf group and the islamic State inspired Maute Group.

"The enactment of the BBL will significantly help in lowering the threat of extremism and terrorism, particularly the Abu Sayyat," Galvez said during a public hearing conducted by lawmakers in Basilan regarding BBL.

He stressed that with the passage of BBL, terror groups will now find it hard to recruit members and carry out attacks.

"Right now, the terror groups are trying to change the narrative of the conflict in Mindanao," he said, adding the extremists are taking advantage of the frustrations of the Bangsamoro people against the government.

Galvez said the military fully

supports the Duterie administration's peace agenda, particularly the implementation of the peace agreements the government has signed with the Moro Islamic Liberation From (MILF) and the Moro National Liberation Front (MNLF).

He cardier said the "outcome of the peace process has a direct correlation with our problem on terrorism." Turn to page 3

Senators led by Juan Migual Zubiri, who chairs the subcommittee on the BBL, went on Saturday to Basilan, Sulu and Tawi-Tawi and the city of Zamboanga for public consultations

During the public hearing in Basilan, Zubiri stressed the implementation of the BBL will help in the campaign against terrorism.

"They (security forces) are the ones who want peace more than all of us. It is them who also wish that the BBL be achieved," he said.

Basilan Gov, Hadjiman Hataman Saliman said there is a need to fully address violent extremism in his province.

"We have a problem on terrorism. We experienced terrorism since 1991. That's why while we are discussing the BBL, let's free Basilan and other areas in ARMM (Autonomous Region in Muslim Mindanao) from terrorism," he said.

The Senate and the House of Representatives are simultaneously conducting public hearings on the BBL.

Congress targets to pass the BBL by March.

HE Philippines can look for different country sources that can supply choppers similar to those from a anadian manufacturer whose P12-bilon contract with the Armed Forces of the Philippines (AFP) had been ordered rminated by President Rodrigo Duterte.

In a text message, Defense Secrey Delfin Lorenzana on Sunday Id Russia, China, South Korea, rkey and India can be the new urces for choppers with capalities similar to the Bell 412 EPI om Bell Helicopter.

On Friday night, Duterte ordered the AFP to scrap the multibillion deal with Bell Helicopter and Canadian Commercial Corp. (CCC).

His order stemmed from reports that the Canadian government had ordered a review of the helicopter contract after *Reuters* said the Bell choppers will be used in operations against the communist New People's Army.

"Are there other suppliers if the Canada deal will not push through? Yes, there are," Lorenzana said.

"They [Canada] can think of anything they want to. For me, I maintain that they should not meddle since we bought [the helicopters] from them, not asked for [them]. One more thing, these are not attack helicopters but medium-lift [helicopters]," he added.

Last week, Arsenio Andolong, spokesman for the Defense department, said Canada should reconsider its decision to review the contract, adding that human rights violations allegedly committed by the military should be verified first.

On December 29 last year, Lorenzana and representatives of Bell Helicopter and CCC signed the contract for the purchase of the helicopters that will be used by the Philippine Air Force for humanitarian assistance and disaster response (HADR) operations and for ferrying injured soldiers from the battlefield.

Delivery of the first batch of Bell helicopters had been expected by the first quarter of 2019.

Purchase of these helicopters is part of the AFP modernization program.

AFP-RSBS LEGAL CHIEF GETS 55 TO 98 YEARS IN JAIL

The Sandiganbayan has meted out prison terms of 55-to 98 years on the legal executives of the Armed Forces of the Philippines Retirement and Separation Benefit System (AFP-RSBS) for underdeclaring the value of the land purchased for the Presidio Royale project in Iloilo City by P46-35 million, cheating the government of capital gains taxes.

The court's Seventh Division found former legal department chief Meinrado Enrique Bello and documentation division head Manuel Satuito guilty of five counts of graft and six counts of falsification. They were also fined P30,000 and permanently banned from government employment.

Discrepancies

Also ordered jailed was Grand Manor Iloilo Realty Corp vice president Minviluz Camiña, who brokered the transactions

The case arose from the discrepancies in the registration of the deeds of sale for six parcels of land bought from November 1996 to fully 1997, defrauding the government of the corresponding capital gain's taxes:

Although the purchases were declared to have a total worth of P13.54 million, the prices actually amounted to P59.89 million.

At the same time, the court found the six landowners' signatures in the registered deeds of sale to have been "conspicuously" forged. At least two of the sellers have come forward to disown their signatures in the documents, "NO

DND: Navy's P18-B frigate deal still on

Navy frigate project still on despite HHI 'troubles'

The Philippine Navy's P18-billion Frigate Acquisition Project (FAP), which was awarded to South Korean shipbuilder Hyundai Heavy Industries (HHI), is "still proceeding on schedule."

This was the remark of Department of National Defense (DND) spokesman Arsenio Andolong when asked about the program's status after HHI was banned from participating in any South Korean tenders for two years after its top executive was found guilty of offering bribes in order to win the bid to supply parts for four nuclear reactors to be constructed at the United Arab Emirates.

The case stemmed in 2013 and in 2015, HHI was convicted and was penalized by a two-year ban.

It sought to have the ban

nullified in 2015 and the South Korean Supreme Court on Dec. 22, 2017 ruled with finality against the shipbuilder. "There's no official word from the Republic of Korea (including its Embassy in Manila) as of today, the project is continuing, we are still going for the milestones that are outline(d) and (in the) timeline, (the project is) just proceeding as planned," he added, when pressed on whether the South Korean government has advised the DND to terminate its contract with HHI.

The FAP is one of the key pieces of the Armed Forces of the Philippines' modernization program, as it seeks to provide the country with the capability to deal with air, surface and sub-surface threats.

It will be armed with a variety of missiles and guns capable of defeating such threats.

Magdalo partylist Rep. Gary Alejano earlier claimed that the frigate project is riddled with anomalies and that its design was altered from the original

This includes the alleged preference for the Hamwha combat management system, the lawmaker said

"There is a proper process prescribed!" R- 9184 (Government Procurement Reform Act) concerning the termination of a procurement project and there are specific conditions that must be present in order to invoke it, none of which are existing at the moment in this project," Andolong earlier said.

The DND spokesman also said the anomalies claimed by Alejano are "mere allegations and innuendos" which hardly constitute grounds for termination of the project.

Rebel killed in Abra clash

MANILA -- A New People's Army (NPA) rebel was killed in an encounter with government troops in Abra early Sunday.

In a statement, Lt. Col. Isagani G. Nato, Northern Luzon Command (Nolcom) public information officer, said the clash took place at Sitio Mabungtot, Ud-Udiao, Sal-Lapadan, Abra at around 7:30 a.m. Sunday.

The clash erupted between troops and around 10 NPA rebels while the former were conducting focused military operations (FMO) in the area.

The 28-minute fight resulted in the killing of one NPA brigand and the recovery of four highpowered firearms and equipment consisting of three M16 rifles, one carbine rifle and a twoway radio.

No loss or injury was incurred by the government forces.

Additional troops were already deployed to hunt down the NPA brigands. (PNA)
