

PALACE: NO STOPPING BARANGAY ELECTIONS

The barangay and Sangguniang Kabataan (SK) elections will be held as scheduled in May, Malacañang said on Monday, disputing Senate Minority Leader Franklin Drilon's warning that President Duterte's allies in the House of Representatives are plotting to postpone the two ballotings as a first step to extending their terms.

Drilon said in a radio interview on Sunday that the term extension would be accomplished by postponing the barangay and SK elections and holding them simultaneously with a plebiscite on a railroaded federal Constitution in October or November.

For the plot to succeed, Drilon said the Senate had to agree to the postponement, but there was no more time to pass a law that would authorize it because Congress was going on Lenten recess in two weeks' time.

'Strange, speculative'

Presidential spokesperson Harry Roque said in a press briefing on Monday that Drilon's comments on Sunday were

"strange" and "very speculative."

Roque said Senate President Aquilino Pimentel III himself said in an event on Friday that the Senate had no plans of postponing the barangay elections for a third time.

holding them simultaneously "While there is a pending with a plebiscite on a railroaded bill in the House filed by Confederal Constitution in October" gressman Johnny Pimentel (of

Surigao del Sur) to suspend anew the barangay elections, Senator Pimentel declared before the audience of 4,000 that there was no support in the Senate for another postponement of the barangay elections. That means, as far as Congress is concerned, barangay elections will push through," Roque said.

'No more time'

Following Drilon, Pimentel reiterated on Monday that there was no more time to pass a law that would allow the postponement of the village and youth elections, as there were only 12 days left before Congress went on recess.

Pimentel said there was no compelling reason to postpone the barangay and SK elections and that was why he did not file

a bill that would authorize the postponement.

"Everyone is prepared, the Commission on Elections is ready [for the elections] and so are the candidates and the voters," Pimentel told reporters.

The two elections have al-

ready been postponed twice, from May 2016 to October 2017, then to May this year.

Postponement bills filed

Davao City Rep. Karlo Alexei Nograles confirmed on Monday that two measures had been filed in the House for the postponement of the barangay and SK elections.

Nograles, chair of the House appropriations committee, said the measures were pending on the committee on suffrage.

He said one of the bills proposed to postpone the barangay elections to October, while the other would move the balloting to May next year.

"One of the reasons [for the postponement] is to hold it simultaneously with ... the ratification of a new Constitution," Nograles said.

He denied, however, that the postponement was aimed at canceling the midterm elections. next year.

Caloocan Rep. Edgar Erice, in a radio interview on Sunday, said the synchronization of the barangay and SK polls with a plebiscite



Aquilino Pimentel III tor a railroaded federal Constitution would allow the cancellation of the midterm elections.

Erice explained that the proposed new Constitution would have transitory provisions that would authorize the term extension of incumbent congressmen and local officials.

If the new Constitution is ratified in the plebiscite, no midterm elections will be held because the terms of congressmen and local officials will be extended until the election of new, federal officials.

Sought for comment on Mon-

day. Erice said he agreed with Roque that the proposal to postpone the barangay and SK elections wouldn't fly in the Senate.

"I agree with him. I think the effort is just in the House," Erice

Roque s'aid President Duterte did not want to rush the amendment of the 1987 Constitution.

He said Mr. Duterte wanted a thorough discussion on any proposal to amend the Constitution for a shift to federalism.

Consultative committee

The President has formed a consultative committee that will propose amendments to the Constitution, Roque said.

"That means the President would prefer that Congress await the outcome of the work product of the [consultative committee] before it is even

tackled in Congress," he said.

"It is not the President's pur-Army Vision: By 2028, a world-class Army the pose to railroad it knowing how important it is, revising no less than the fundamental law of the land, and the people will be given ample time and opportunity to debate and ponder ... the proposed revisions, whatever they may be," he added.

The consultative committee. headed by retired Chief Justice Reynato Puno and composed of other legal luminaries, has six months to complete its recommendations, which the President is expected to submit to Congress.

Congress may or may not follow the proposals.

Tighter timetable

Drilon said he remained convinced that the House wanted the barangay and SK elections held simultaneously with the plebiscite for a new Constitution, noting the filing of two bills for that purpose.

Rep. Johnny Pimentel's bill which was filed on Jan. 31 sought to synchronize the two elections with the plebiscite in October, Drilon said.

The bill filed by Oriental Mindoro Rep. Reynaldo Umali on Feb. 13 would have the two elections held simultaneously with the plebiscite in May 2019

A third bill, similar to that o Pimentel's, has been filed by ANAC-IP Rep. Jose Panganiban Jr

"So really there's a seriou effort to postpone the baranga elections and piggyback the constitutional amendments which will be railroaded in that kind of timetable," Drilon said.

The timetable has become even tighter, Drilon said, noting that under the 1987 Constitu tion, the plebiscite cannot be held earlier than 60 days or late than 90 days after the approva of the amendments.

"The only way to do it is to railroad it," he said. -- wITH REPORTS' FROM VINCE F. NONATO, ARMAND GALANG AND ANSELMO ROQUE INQ

Terror threat keeps soldiers on their toes

The Armed Forces of the Philippines (AFP) Monday said that it is continuously monitoring and verifying every information related to any alleged movements of terror groups following statements made by Australian authorities that terrorists are regrouping after the Marawi siege.

AFP spokesman and concurrent Civil Relations Service (CRS) chief Brig. Gen. Bievinido Datuin, made the remark during an interview.

"The main concern of the security sector is not only to address the armed component but the financial and logistics line of terrorist organizations," he added.

Datuin said there will always be a gap in the security measures being implemented by every nation in the world, big or small. He said the terrorists will always look into those gaps and take advantage of them.

"(With this in mind) we aim to strengthen our security measures with the help of our citizens in order to fill in those gaps," Datuin said.

"We call on our people to help in the effort against terrorism. The fight against terrorism is not the sole responsibility of the government or the security sector but of every citizen of the republic," he added.

Australian Ambassador to the

Philippines Amanda Gorely was quoted earlier in news reports that terrorists behind the five-month-long Marawi siege which ended in October 2017 are said to be regrouping and intend to strike again in another area.

Gorely said the evidence was based on intelligence information provided to the Philippine authorities.

Meantime three more Abu Sayyaf members on Monday surrendered to the marines of the Joint Task Force Sulu (JTF Sulu) in Jolo, Sulu.

Hajar Abbang, 38, a resident of Barangay Kan Bulak, Luuk, Sulu; Kirah Ainazri Jawad, 20; and Sani S Jawad, 18, both residents of Buanza, Indanan voluntarily surrendered to the Philippine Marine Ready Force 2 of the Joint Task Force Sulu at 9:45 a.m.

According to Abang, he was formerly a follower of the late Abu Sayyaf Group Subleader (ASGSL) Alhabsy Misaya while the other two are followers of the late ASG subleader Abraham Hamid.

"The trio also voluntarily turned over their firearms, an M16 rifle; an M79 rifle; and an M1 Garand rifle to our soldiers," said Brig. Gen. Cirilito Sobejana, commander of the Joint Task Force Sulu.

The three were brought to Kuta Heneral Teodulfo Bautista Station Hospital in Barangay Busbus, Jolo, Sulu for medical checkup and for custodial debriefing. Sobejana lauded the accomplishment of the marines and said, 'with the right combination of focused military operations that pressures the ASG and the nonviolent approach that we are introducing, it is expected that more ASG members will be neutralized which may lead to their eventual downfall.

"It is notable that since our proposal for the ASG surrenderer Comprehensive Reintegration Program, more ASG members now returns to the folds of the law with firearms. This is a welcome development for us since we want to end our campaign against the ASG peacefully. After all, they are just misguided individuals and also Filipinos whom we are bound to serve," he added.

"In this case, the initial ransom demand of the kidnappers was P7 million which was eventually reduced to P1.069 million through negotiation," pahayag ni Dela Rosa

Ex-soldier, NPA leader in kidnappings nabbed

The Philippine National Police yesterday announced the arrest of a dismissed Philippine Army soldier and a New People's Army leader for their alleged involvement in a series of kidnap-for-ransom incidents.

PNP chief Director General Ronald M. dela Rosa presented in Camp Crame in Quezon City the arrested suspects identified as Brandall Mark Cacatian, alias "Cat," a dismissed Army soldier who is No. 8 in the PNP's Anti-Kidnapping Group wanted list, and Donat Jacob, alias "Jonas and

Dondon Diego," the alleged leader of the NPA-Sandatahang Yunit Propaganda operating in Bulacan.

Dela Rosa said that Cacatian was apprehended last Feb. 21 on Levi Mariano St. in Barangay Ususan, Taguig City.

On the other hand, Jacob was arrested by the PNP-AKG, Intelligence Group, and the Malabon City police last Feb. 24 on F. Navarette-Panghulo Road in Obando, Bulacan. (Martin A. Sadongdong)

IS-influenced terrorists regrouping; PNP, AFP on alert status

Police and military establishments are now on their toes amid reports that Islamic State-inspired terrorists are currently regrouping after the failed Marawi City siege last year

Philippine National Police (PNP) chief Director General Ronald dela Rosa, however, maintained that it would be hard for the terrorists to launch attacks similar to the Marawi City siege that erupted from May to October last year.

"Our campaign against terrorism is very aggressive. We, the PNP, the A.FP

(Armed Forces of the Philippines) and all other intelligence agencies of the government are helping each other," said dela Rosa.

Dela Rosa said Director Camilo Pancratious Cascolan, head of the PNP Directorate for Operations, was in Davao City for a meeting on the defense and security of the home-city of President Duterte.

"It will be replicated in other key cities in Mindanao to ensure that there will be no repeat of the Marawi City siege in Mindanao," said dela Rosa, who admitted that other cities are candidates

to be next Marawi if their security operations are not intensified.

The chief PNP is not discounting the possibility that terrorists, who have slipped out of Marawi City, are now recruiting new members.

Dela Rosa said that authorities should be able to thwart the recruitment activities to ensure there will be no attacks.

"We should address to from the recruitment made, if they fail to recruit they will not have enough forces to use," said dela Rosa.

AFP spokesman Brig. Gen. Bienvenido Datuin said that the military is closely monitoring the movements of the terrorist groups.

"The AFP is continuously monitoring and verifying every information related to any alleged movements of terror groups. We are in constant coordination with our foreign and local counterparts to address the scourge of terrorism," said Daruin.

"The main concern of the security sector is not only to address the armed component but the financial and logistics line of terrorist organizations," he added.

Palace: Security forces able to deal with new threats

Malacañang on Monday assured that state security forces are "able and willing to deal" with new threats of any terrorist group, following warnings that jihadists loyal to the Islamic State (ISIS) could seize another area in the country.

Presidential Spokesman Harry Roque made this remark after Australian Ambassador to the Philippines Amanda Gorely was quoted saying that terrorists behind the Marawi siege are regrouping and are intending to strike again elsewhere.

"We are of course monitoring the situation. We are able and willing to deal with any new threats," Roque said in a Palace briefing.

Roque also pointed out that Gorely's statement merely verified what the Armed Forces of the Philippines (AFP) already knew, which also led to the decision to extend martial law in Mindanao until the end of 2018.

"I think that has been a shared view of our Armed Forces which prompted in fact the decision to extend martial law in Mindanao," Roque said.

"But I think this latest statement of Australian ambassador only verifies what we already know that they are regrouping and recruiting more people," he added.

Continued vigilance

AFP spokesman Brig. Gen. Bienvinido Datuin earlier said that the AFP remains vigilant on the movement of terrorist groups.

"The AFP is continuously monitoring and verifying every information related to any alleged movements of terror groups. We are in constant coordination with our foreign and local counterparts to address the scourge of terrorism," Datuin said.

Datuin, meanwhile, called on Filipinos to help in the fight against terrorism.

"We call on our people to help in the effort against terrorism. The fight against terrorism is not the sole responsibility of the government or the security sector but of every citizen of the Republic," Datuin added.

Top NPA propagandist, political officer nabbed

CAGAYAN DE ORO CITY: A high-ranking officer of the New People's Army (NPA) in Northeastern Mindanao was arrested in El Rio, Sibagat, Agusan del Sur by military and police personnel, a military report said on Monday.

Lt. Tere Ingente, Public Affairs Office chief of the Army's 4th Infantry Division, said arrested was Pablito Campos, alias "Batik" or "Ponsoy," the secretary and political officer of the NPA Guerilla Front 21A of the Northeastern Mindanao Regional Committee (NEMRC).

She said that Campos, a noted terrorist propaganda expert, was also the spokesman of NEMRC's regional committee of Westland.

Ingente said the operatives from the Army's 401rd Brigade in Agusan del Sur and the police also seized from Campos one M4 Rifle with a fully loaded magazine, three mobile phones, one backpack containing a hand grenade and personal belongings.

She added that the Regional Trial Court in Surigao del Sur and Bayugan City, Agusan del Sur, have issued eight warrants of arrest against Campos for crimes involving rebellion, frustrated murder, murder, multiple attempted murder, kidnapping and serious illegal detention.

Campos was allegedly responsible for the failed ambush of policemen on July 29, 2017 in Sibagat, Agusan del Sur which resulted in the death of one of the police officers.

Ingente said that as ranking NPA terrorist, Campos implements extortion activities against companies and decides on personalities who would be kidnapped.

"With the arrest of Campos, guerrilla front 21A would experience blind leadership that would lead to its eventual downfall," said Major Ronald Villanueva, commander of the Army's 41D.

Since January this year, the 401st Brigade in Agusan del Sur has captured four NPA terrorists and accepted the surrender of 57 NPAs and the recovered 26 high-powered firearms.

He also recognized his father who is one of the icons of the EDSA revolution because of the foundation of NAMFREL or the National Citizen's Movement for Free Elections.



4 dead as MILF clashes with MNLF in N. Cotabato

MATALAM, North Cotabato—Clashes erupted over the weekend between two Moro fronts in a remote village here, leaving four fighters dead, police yesterday said.

Chief Insp. Sunny Leoncito, Matalam police chief, said both the Moro Islamic Liberation Front (MILF) and Moro National Liberation Front (MNLF) have suffered two fatalities each in sporadic skirmishes in Barangay Marbel here.

"The fighting erupted Saturday night and continued until Sunday morning," he said, adding that the two-day fighting also sent several families fleeing now housed at the Barangay Marbel covered court.

He disclosed that the fighting was triggered by a "rido" (clan war) between MNLF Commander Datu Manial and MILF Commander Ustadz Manzur.

Accordingly, Manial's brother

was killed by followers of Commander Manzur, subsequently sparking hostilities in the area. On Saturday, armed followers of two Moro fronts figured in a running gunbattle when they met in adjacent barangay Kidama, also in Matalam.

On Sunday, both sides are still sporadically exchanging bullets. Leoncito said leaders of warring armed groups have been meeting to pacify the warring groups. **PMA**

MILF 'sees light at end of tunnel' in BBL deliberations

COTABATO CITY – The Moro Islamic Liberation Front (MILF) leadership said on Sunday it is seeing a "bright future" in the commitment of the Duterte government for the passage of the law that will create the Bangsamoro Autonomous Region, ending decades of armed struggle for self-determination in Mindanao.

"We see the light at the end of the tunnel finally," MILF First Vice Chairman Ghazali Jaafar told The Manila Bulletin.

Jaafar is chairman of the Bangsamoro Transition Commission (BTC) that crafted the draft Bangsamoro Basic Law (BBL) that is still pending deliberation in the 17 Congress.

The BBL draft version of the BTC defines Bangsamoro people as the Muslim, Christian and lumad residents in Mindanao coexisting for decades.

Jaafar was all praises that the Senate has "adopted the BTC version," while the House of Representatives is also heeding public clamor to do the same.

Leaders of both Congress chambers were reportedly contemplating to pass their versions for third and final reading next month.

So far, Jaafar said, the trend was heading towards such timeline, adding he had attended all Senate field hearings and has been attending all consultative meetings by the House working committees as BTC chairperson.

"I am thankful to the leaders of both the Senate and the House for giving me a role in their hearings," Jaafar said.

3 ASG fighters surrender to Marines in Sulu

ZAMBOANGA CITY – Three Abu Sayyaf Group (ASG) fighters surrendered to the Philippine Marines Ready Force 2 of the Joint Task Force Sulu (JTF-Sulu) Sunday.

JTF-Sulu Commander Brig Gen Brigadier General Cirilito Sobejana identified the surrenderers as Hajar Abbang, 38, of Barangay Kan Bulak, Luuk, Sulu; Kirah Ainazri Jawad, 20 and Sani S Jawad, 18, of Buanza, Indanan, Sulu.

The trio turned themselves in to the Philippine Marine Ready Force 2 of the Joint Task Force Sulu at 9:45a.m., Sunday.

Abang was a former follower of the late ASG Subleader (ASGSL) Alhabsy Misaya, while the other two are followers of the late ASGSL Abraham Hamid.

"The trio also voluntarily turnedover their firearms – an M16 rifle, an M79 rifle, and an M1 Garand rifle to our soldiers," Sobejana said.

The three ASG men were brought to Kuta Heneral Teodulfo Bautista Station Hospital in the village of Busbus in Jolo, Sulu for medical check-up and custodial debriefing.

Sobejana said that "with the right combination of focused military operations that pressures the ASG and the non-violent approach that the military is introducing, it is expected that more ASG members will be neutralized."

"It is notable that since our proposal for the ASG Surrenderor Comprehensive Reintegration Program, more ASG members now returns to the folds of the law with firearms," he added.

AFP wants public help in stepped-up fight vs terrorism

The Armed Forces of the Philippines (AFP) is hoping to intensify its security efforts against terrorism with the help of citizens in the wake of fresh reports that ISIS-inspired Maute terrorist group is reorganizing after the five-month battle in Marawi City last year.

"There will always be a gap in the security measures being implemented by every nation in the world, big or small. Terrorists will always look into those gaps and take advantage of them," AFP spokesperson Brig. Gen. Bievenido Datuin told reporters on Monday.

"We aim to strengthen our security measures with the help of our citizens in order to fill in those gaps," he also said.

Reports of Maute terrorists rebuilding its forces have been cited by the military after the five-month siege ended in October 2017.

The regrouping of the terrorists to launch another attack was also one of the reasons why the military asked for the extension of martial law in Mindanao until December 2018.

In a news report on Monday, Australia echoed such a possibility of Maute terrorists reorganizing.

Australian Ambassador to the Philippines Amanda Gorely was quoted as saying that they have received evidence of the regrouping based on the intelligence information shared by the Philippine government.

The military, for its part, continues to verify all the information they could get.

"The AFP is continuously monitoring and verifying every information related to any alleged movements of terror groups. We are in constant coordination with our foreign and local counterparts to address the scourge of terrorism," Datuin said.

He further said they are also concerned with the "financial and logistics line of terrorist organizations" apart from the armed component of terrorism.



The two-day fighting also sent several families fleeing to safer ground. They were now housed at the Barangay Marbel covered court, Leoncito said.

He identified the two warring Moro rebel leaders as Commander Manial of the MNLF and Commander Manzor of the MILF.

Manial's brother was allegedly recently killed by followers of Commander Manzur.

On Saturday, armed followers of the two Moro fronts figured in a running gunbattle when they met in Barangay Kidama. The clash continued in the adjacent village of Marbel by Sunday.

As of Sunday noon, both sides were still trading bullets, Leoncito said.

Leoncito said MNLF and MILF leaders have been meeting to pacify Commander Manial and Manzur. /atm
