

### Cha-cha h Shag; Sc ling needed

With the Senate and the House of Representatives not budging from their conflicting stands on how to vote in a constitutional assembly (Con-ass), Senate Minority Leader Franklin Drilon and Sen. Panfilo Lacson said on Thursday they believed the proposal to amend the 1987 Constitution for a shift to federalism was dead.

"Yes Cha-cha is dead," Drilon said in a text message, using the shorthand for "Charter change," which means amending the Constitution.

"Nothing will move forward," Lacson said, also by text, "Unless we all yield to the intent and spirit of the 1987 Constitution, Cha-cha will not happen."

But for Speaker Pantaleon Alvarez, all is not lost. He said the disagreement between the two chambers of Congress should be taken to the Supreme Court for resolution.

Lacson filed a resolution on Monday calling on the Senate to sit as a Con-ass and introduce amendments to the Constitution, with the proposed changes to be approved by threefourths vote of the chamber.

On Tuesday, the House adopted a resolution convening Congress into a Con-ass for tution, with all its members apSeparate voting

The Senate has always rejected joint voting, as the senators are outnumbered by the representatives.

On Wednesday, the senators decided to ignore the House Con-ass, with Lacson suggesting expulsion for those who would break ranks.

Amendment by separate Con-asses is an original proposal by Drilon based on the reading of the constitutional provision on amendment that Congress is a two-chamber body.

It works like ordinary legislation, with senators and representatives separately proposing amendments and separately voting to approve the proposed changes.

Conflicting amendments are to be reconciled in conference then submitted to the people for approval in a national plebiscite.

The 1987 Constitution does not expressly say whether the Senate and the House should vote jointly or separately in proposing amendments to the Charter.

arate voting, as Congress is a bicameral body.

"We will destroy institutional equality (of the Senate and the House) if we interpret Article 17 (of the 1987 Constitution) to mean that the Senate and the House shall vote together and not separately," Puno told the hearing.

#### House view

"That's their right, and that's their view," Alvarez said in a radio interview on Thursday, referring to the Senate's interpretation of the amendment provision.

"But we have a different view because the letter of our Constitution is clear. It is stated there that Congress by a vote of three-fourths of all its members may amend or revise the Constitution," Alvarez said.

"So for me, that provision is quite clear and there is no room for interpretation," he added.

Alvarez also suggested that the 292-member House could go it alone, if worse comes to worst. A three-fourths vote in the House, even without the senators, could still satisfy the threefourths vote of Congress, considering the disparity in numbers.

"Yes, at the end of it, that [House vote] will satisfy the requirement in the Constitution, which says three-fourths of all its members. Let us count all the members, get the threefourths, and vote . . . for us, the constitutional requirement is complied with," Alvarez said.

Told about Davide and Puno's statements to the Senate hearing on Wednesday, Alvarez said those were the two former Chief Justices' opinion.

"That's their opinion, but they are not the Supreme Court. Let us wait for what the Supreme Court will say on this :95 issue," Alvarez said.

Sen. Juan Miguel Zubiri called on the Senate and the House on Thursday to hold a legislative summit to talk things through and end the bickering, a proposal that Senate President Aquilino Pimentel III supported.

"Summit or talks, whatever you call it, we need to talk," Pimentel said in a text message.

#### Rendering Senate irrelevant

In his text message, Lacson said he heard what Alvarez had said in his interviews and that "it only confirms our suspicion that they interpret Article 17,

Section 1 (of the Constitution) to mean rendering the Senate vote irrelevant in a Con-ass contrary to the interpretation of all the senators as well as constitutional experts and legal luminaries, including our resource persons [in Wednesday's] committee hearing."

"It also justifies my suggestion to expel any member of the Senate who will go astray and betray the institution where he belongs," Lacson said.

Senate President Pro Tempore Ralph Recto frowned on the House bid to exercise the three-fourths vote on proposed amendments to the Constitution without the Senate.

"The three-fourths voting formula, to be exercised by one chamber alone, is the wrong calculus. The Constitution speaks of a bicameral legislature," Recto said in a statement on Thursday.

"[I]t takes two to Cha-cha. Going solo is shadow dancing," he said.

"If two bodies are needed to pass a bill changing the name of a barangay, then how can one House arrogate upon itself the far more important job of changing the basic law of the land?" he asked.

Sen. Francis Pangilinan, chair of the Senate committee on constitutional amendments and revision of codes and laws, said the House "should think twice about forcing the issue and proceeding with Cha-cha even without the concurrence of the Senate."

"I doubt if our people will simply stand and watch while the Constitution is being desecrated and torn to bits by selfserving politicians," Pangilinan said in a text message.

#### Hearings to proceed

Pangilinan said he would proceed with the committee hearings on proposals to amend the Constitution "so that these and other issues are ventilated and made known to the public in an open and transparent, participatory and deliberative process."

At a news forum in the Senate, Zubiri urged the House to "tone down the rhetoric," saying the representatives' talk of abolishing the Senate under a new form of government that would be created after the amendment of the Constitution would not help their cause for Charter revision. INQ

### Communist leaders hunted

ommunist Party of the Philippines (CPP) leaders Berito and Wilma Tiamzon are now the subject of a manhunt after

a Manila Regional Trial Court (RTC) ordered their re-arrest following the collapse of the peace talks.

los, Philippine National Police spokesman, said the PNP is ready to comply with the directive.

Manila Regional Trial Court (RTC) Branch 32 Judge Thelma Bunyi Medina issued the order after she granted the Department of Justice's motion for recommitment and cancellation of the \*100,000 bail of the Taimzon couple and their co-accused National Democratic Front (NDF) leader Adelberto Silva. The order, dated January 11, 2018, was released on Wednesday.

"Well, we follow the order of the court, we follow the order of the RTC in Manila for the re-arrest of the (Tiamzon) couple and whoever personalities are included (in the order)," Carlos said.

Earlier, Presidential spokesman Harry Roque said the PNP should hunt down the couple.

Carlos said it would be easy to locate the whereabouts of the Tiamzons and Silva since they have been monitored by the PNP-Intelligence Group (IG).

"Even if they were temporarily released for the purpose of the peace talks, they really have to answer for the violation of the law before the court kasi they were charged accordingly," Carlos said.

"Again babalik lang naman tayo doon sa... they should answer for the violation of the law before the court," he added.

The Tiamzons were arrested in Cebu in March, 2014 over murder charges.

Carlos said that the normal procedure include the giving of the copies of the warrants of arrest to the Criminal

Investigation and Detection Group (CIDG), which would then implement it with all other PNP units.

Tiamzons to appeal

Meanwhile, the camp of Tiamzons said they would appeal the court's rearrest order.

The Tiamzons were implicated in the murder of 15 persons believed to be tied to a purge among communist rebels in Leyte in 1980s and arrested in 2014.

In August, 2016, they were temporarily freed after they were allowed to post bail to serve as consultants for the peace negotiations between the government (GRP) and the CPP-NPA-NDF.

But the peace negotiation was terminated by President Duterte following an ambush in Bukidnon in November, 2017, resulting in the death of a policeman and a four-month-old baby.

### 5 NPAs killed, scores wounded in Agusan del Sur, Davao Oriental skirmishes

Butuan City — Five New People's Army (NPA) rebels were killed while an undetermined number of other rebels were reportedly wounded during a gun battle between government security forces and communist terrorists in the hinterland areas in Agusan del Sur and Davao Oriental provinces, military and police report said.

Combat maneuvering troops of the Army's 28th Infantry battalion seized from the four slain rebels four firearms, improvised explosive devices and other bomb-making materials on Tuesday in Sitio Palo Palo, Barangay Marayag, Lupon, Dayao Oriental, it said.

A separate military and police report received here said one NPA terrorist was

killed while an undetermined number of other rebels were believed wounded when a gun battle erupted between government troops and communist terrorists in the upper part of Quarry 69, Sitio Agpan, Barangay Imelda, Bunawan, Agusan del Sur.

A flash report received here also said the two platoons from the Army's 75th Infantry Battalion (75th IB) led by 2Lt. Begee de Jesus and 2Lt. John Arangoso were conducting Focused Military Operations (FMO) when they encountered a number of heavily armed NPA terrorists.

The communist terrorists in upper Quarry 69 were believed to be members of guerrilla-Front Committee 14 of the CPP-NPA Northeastern Mindanao Regional Committee (NEMRC).

The rebels, however, disengaged from the firefight after almost 15 minutes upon sensing that they were outnumbered, dragging along with them their wounded and leaving behind the killed comradein-arm.

Operating froops recovered from the encountersite one unit AK47/rifle, two pieces magazine loaded with live ammunitions, one piece back pack containing personal belongings and anti-government documents, military and police report said.

The identity of the slain rebel has not been revealed as of press time.

PRO 13 Regional Director Chief Supt. Noli A. Romana ordered the commander of the provincial mobile force safety battalion and Agusan del Sur PPO to assist the 75th IB by conducting blocking positions along the possible escape route of the withdrawing NPA terrorists, said PRO 13 spokesman Chief Inspector Renel E. Serrano

In a separate encounter, troops of the 28th IB also encountered an undetermined number of armed NPA terrorists at 1:25 p.m. on Tuesday at Sitio Palo Palo, Barangay Marayag, Lupon, Davao

#### Oriental.

Capt. Andrew M. Linao, spokesman of the 701st Infantry Brigade, said-patrolling troops of the 28th IB-were responding to a call from residents in Barangay-Marayag about the presence of the NPA terrorists in their village allegedly revolutionary taxes.

Meantime, Brig. Gen. Reuben S. Basiao, commanding general of the 701st Brigade lambasted the recruitment of minors and extortion activities of the NPAs.

#### Surrender

The military yesterday said that five members of the New People's Army (NPA) laid down their arms and surrendered to government troops in Ampatuan, Maguindanao on Tuesday.

The rebel returnees who belonged to the platoon Samsung and My Phone of Guerrilla Front (GF) 73 were identified as Dany L. Daligdig, 32; Emiliano M. Tarusan, 47; Mike T. Kadingilan, 21; Marcelo M. Dampo, 49 all from a Teduray community in Brgy. Pamantingan, and; Wen M. Bilagen, 31, from a Tboli tribe in Brgy. Salumping, all of Esperanza, Sultan Kudarat.

According to the military, the five turned themselves in to Lt. Col. Lauro G. Oliveros, Commanding Officer of the 1st Mechanized Infantry Battalion in Brgy. Kamasi, Ampatuan, Maguindanao. They also surrendered one homemade Springfield, one caliber 357, two homemade M79, and one Ingram. (With a report from Francis T. Wakefield)

### 4 NPA rebels killed in clash with soldiers

Four New People's Army (NPA) rebels were killed in an encounter with government troopers in Davao Oriental on Tuesday, the military reported yesterday.

There was no reported casualty on the government side.

Soldiers were verifying reports that NPA rebels were collecting so-called revolutionary taxes from residents of Barangay Marayag in Lupon town when the clash occurred, Capt. Andrew Linao 701st Infantry Brigade (IB) ternmander, said.

Lirao said an improvised explosive device and four guns were recovered from the fatalities.

Linao said pursuit operations for the rebels are ongoing.

#### 2 battalions to fight Reds in Negros

With the all-out offensive against the communists following the scrapping of peace talks, the military will deploy two more battalions in Negros island.

A battalion will be deployed this month and another next month, Brig. Gen. Dinoh Dolina, newly designated commander of the 3rd Infantry Division (ID), said during a courtesy call on Negros Occidental Gov, Alfredo Marañon on Tuesday.

The 3rd ID's three battalions were deployed in Marawi last year to fight Maute militants.

Dolina said the 3rd ID would also activate the 93rd IB to be deployed in Negros Occidental and Negros Oriental.

Two battalions are currently deployed on the island.

The military said it is eyeing the declaration of Negros, Iloilo and Capiz as insurgency-free by the end of the year. There are around 500 rebels operating in the areas.

In Northern Luzon, the newly appointed commander of the 5th ID, Brig. Gen. Perfecto Rimando Jr., said the campaign against the communists would be "bloody" if NPA rebels will not surrender.

"It is best for them to surrender...and help solve once and for all the problem of insurgency in the country," Rimando said. – Jaime Laude, Gilbert Bayoran, Victor Martin

### 5 Reds killed in clashes

BUTUAN CITY — Five New People's Army (NPA) rebeis were killed following separate skirmishes with government forces in Agusan dei Sur and Davao Oriental recently, a military and police report said,

One of the rebels fell in a gunbattle that occured 4 p.m. Sunday in Quarry 69, Sitio Agpan, Barangay Imelda, Bunawan, Agusan del Sur.

The report said two platoons from the Army's 75th Infantry Battalion (75th IB) led by 2Lt. Begee de Jesus and 2Lt. John Arangoso were conducting Focused Military Operations (FMO) in the area when they encountered the rebels.

The firefight lasted some 15 minutes before the rebels disengaged, leaving their dead comrade behind.

No one on the government side was hurt in the incident.

Meanwhile, four rebels fell in the gunbattle that occurred in Sitio Palo Palo, Barangay Marayag, Lupon, Davao Oriental around 1 p.m. on Tuesday.

Capt. Andrew M. Linao, spokesperson of 701st Infantry Brigade, said the encounter occurred after patrolling troops of the 28th IB, were alerted by residents of Barangay Marayag about rebels allegedly collecting revolutionary tax in the area.

. "Our operating troops simply responded to the call and engaged the rebels," Capt. Linao said.

Apart from the bodies of the four slain communist combatants, elements of the Army's 28th Infantry battalion collected a number of low and high powered firearms as with several improvised explosive devices that were left by the rebels in the area following the skirmish.

In a statement, Brig, Gen. Reuben-S. Basiao, commanding general of the 701st Brigade, lambasted the continued recruitment and extortion activities of the NPA.

"The NPA is desperate in implementing their recruitment efforts forcing the residents to attend their meetings and extorting the communities for their survival. However, the community is tired in believing their false promises realizing they will not benefit from the terrorists and would rather prefer to have the government on their side," he said,



## DUTERTE PICKS EMPEDRAD AS NAVY FLAG OFFICER IN COMMAND

President Duterte has designated Rear Adm. Robert Empedrad as head of the Philippine Navy.

The President's order, dated. Jan. 16 and addressed to Defense Secretary Delfin Lorenzana, was released by Malacañang on Thursday. It approved Empedrad's designation as Navy flag officer in command, effective Dec. 19, 2017.

"I wish to inform you that, per your letter-endorsement and in accordance with the recommendations of the chief of staff, Armed Forces of the Philippines and chairman, AFP Board of Generals ... the designation of (Empedrad) ... as commander, flag officer in command, Philippine Navy is hereby approved," the President said.

#### Weapons system

Empedrad replaced Vice Adm. Ronald Joseph Mercado as Navy chief because, according to Lorenzana, of Mercado's inordinate insistence on a particular weapons system for the country's first two missile frigates.

Lorenzana said he had lost "trust and confidence in [Mercado's] integrity and leadership" because of his threats to derail a weapons contract that was signed last year.

The contract was awarded to Hyundai Heavy Industries (HHI) in early 2016 during the Aquino administration. Empedrad had chaired the Navy's Frigate Project Management Team.

The controversy over the project erupted again this week after Special Assistant to the President Christopher "Bong" Go was accused of interfering in the project.

Go has denied the allegation and President Duterte has de-

fended his top aide.

On Wednesday, the Department of National Defense cleared Go of any wrongdoing and said he did not intervene in the project.

#### Paper trail

Based on what was claimed as a paper trail, Magdalo Rep. Gary Alejano said on Thursday the President should have ordered an investigation into Go's alleged interference in the frigate acquisition project (FAP) instead of "lawyering" for him.

In a statement, Alejano said Malacañang's denial of Go's involvement in the FAP was a "glaring contradiction to the documents."

The bone of contention lies with Go's alleged preference for HHI's choice, Hanwha's Naval Shield, for the warships' combat management system (CMS), overruling the Navy's own choice.

Alejano cited the following documents as evidence of Go's interference in the FAP, especially in the selection of the CMS:

• A Jan. 12, 2017, white paper with Defense Secretary

Lorenzana's marginal note saying the document came from Go.

• A Jan. 18, 2017, letter from Go's office directing newly appointed Navy chief Empedrad to report to Malacañang.

- The appearance of Empedrad and the whole Project Management Team (PMT), which he headed then, in a Jan. 20, 2017, meeting with former Undersecretary Lloyd Christopher Lao under Go's alleged instructions.
- Empedrad's Jan. 23, 2017, letter to Mr. Duterte, which made references to a letter by Go's office requesting the PMT to justify the CMS chosen by HHI.

Alejano claimed Go's actions were prompted by an alleged visit of an official of South Korean CMS provider Hanwha. The supposed meeting with Go "possibly" took place between Jan. 5 and 11, 2017.

## DUTERTE WARNS OF 'MANY MARAWIS' IF BANGSAMORO LAW IS NOT PASSED

President Duterte has warned of numerous wars similar to the five-month-long Marawi siege erupting all over Mindanao if Congress fails to pass the proposed Bangsamoro Basic Law (BBL), Sen. Juan Miguel Zubiri said on Thursday.

The passage of the draft BBL, which would establish a new autonomous Muslim region in Mindanao, was part of the 2014 peace accord between the government and the Moro Islamic Liberation Front (MILF).

"[The President said] if there is conflict [in Mindanao] and we

do not pass BBL and war ensues, you are looking at Marawi 10 times or 50 times over," said Zubiri, who heads a Senate subcommittee handling the proposed measure.

Zubiri told reporters at the Kapihan sa Senado that he spoke on the phone with the President on Monday.

#### Extremist groups

He said the President was concerned that extremist groups in Mindanao would take advantage of the absence of the BBL, which was a commitment by both the government and the MILF to end decades of armed secessionist struggle in favor of Moro autonomy.

He also said Presidential Peace Adviser Jesus Dureza had told him that extremist groups continued to recruit people in the Autonomous Region in Muslim Mindanao, which is comprised of five predominantly Muslim provinces.

Zubiri said he informed the President that he had withdrawn his original proposal that adopted the previous Senate measure and this week filed a bill that adopted the BBL version of the Bangsamoro. Transition Commission (BTC). He said the BTG version dropped many constitutionally questionable provisions.

The members of the BTC include representatives from the

government and the MILF.

"I would like to assure the public ... that we will give it utmost priority and my timeline is before March 22, our last day of session. We will try to pass the BBL in third and final reading," Zuhiri said.

Presidential spokesperson Harry Roque said the proposed BBL was "certified urgent" by the President last year.

Quoting House Muslim affairs committee chair Rep. Jun Papandayan, Roque said the bill was expected to be passed by March.

Dureza said Mr. Duterte met MILF chair Murad Ibrahim and other MILF leaders on Monday and assured them that the bill would be passed before any shift to a federal form of government.

#### **BTC** version

He welcomed Zubiri's decision to adopt the BTC's version as the working draft to be discussed in the planned Senate hearings.

"We call on Filipinos to all help and contribute to the realization of this long-awaited aspiration of the Bangsamoro," Dureza said.

Zubiri said he would hold public consultations on the draft BBL starting next week in Cotabato City and Marawi City.

He said he would try to have Congress pass the measure so that the plebiscite on the proposal could be held simultaneously with the barangay and Sangguniang Kabataan elections in May.

Hundreds of extremists and followers of the Islamic State (IS) group attacked Marawi in May last year, battling thousands of government troops for five months. The fighting left more than 1,600 people dead and reduced the city center to rubble.

The siege prompted the President to declare martial law and suspend the privilege of the writ of habeas corpus in Mindanao. The martial law period has been extended twice, the second lasting a year till December 2018.

Several petitions questioning the constitutionality of the latest extension have been filed in the Supreme Court INQ

### Military checking if top Malaysian terrorist survived

The Armed Forces of the Philippines is trying to validate intelligence information that a top Malaysian extremist survived the defeat of an Islamic State-linked siege on Marawi City and is helping restart efforts to establish an extremist alliance, a military official said.

The commander of Joint Task Force Sulu, Brig. Gen. Cirilito Sobejana, said troops were trying to validate reports that Amin Baco is wounded during the siege but managed to escape to Sulu, where he was hiding with Abu Sayyaf Group (ASG) terrorists.

Yusop Jikiri, central committee chair of the Moro National Liberation Front (MNLF). which has a peace treaty with the government, said that his group received information that Baco is being protected by Abu Sayyaf commander Hatib Sawadjaan, the Hajan Malaysian militant's Filipino father-in-law, in the mountains of Sulu's Patikul town.

Sawadjaan is a notorious kidnapper linked to several abductions of foreign tourists.

#### Validating information

"We also got that information and we're validating it," Sobejana said. "Our efforts against this group have been. relentless."

Abu Amri Taddik, chief of MNLF intelligence, said Baco was involved in renewed efforts to establish an IS-linked alliance of several groups including the ASG.

A senior military officer who spoke on condition of anonymity said the list of officers recommended for the top Navy chief and submitted to the office of President Duterte was "maneuvered."

The source said the Board of Generals initially recommended, through the DND, three officers for the post.— Empedrad and Rear Admirals Rommel Ong and Giovanni Carlo Bacordo, both of the PMA Class 1987.

The recommendation was revised, and contained the names of Empedrad and other members of PMA Class 1986 — Rear Admirals Gaudencio Collado, Danilo Rodellas, Rene Medina, and Allan Ferdinand Cusi.

"They (Bacordo and Ong) were not included. They were replaced with members of the (PMA) Class 86," the source said noting

Meanwhile, spokesman Arsenio Andolong said the Department of National Defense is not going to terminate the P18-billion frigate acquisition project which Magdalo party list Rep. Gary Alejano, a former Marines captain, earlier said was anomalous.

He said Alejano's "allegations" are not enough to cause the abro-

gation of the deal.

The P18-billion contract for the construction of the two frigates, including the weapons system and munition, was awarded by the defense department to Hyundai Heavy Industries of South Korea in October 2016.

Lorenzana has said it should be Hyundai that should decide on the type of combat management system that should be installed on the frigates. Hyundai is reportedly eyeing to install a cheaper and less capable CMS produced by Hanwha of South Kotea.

In a privilege speech on Tuesday, Alejano alleged that Mercado was relieved because he was blocking the "business interest" of Hyundai.

Alejano also alleged that Christopher "Bong" Go, special assistant to President Duterte, intervened in the project, in favor of Hanwha. Lorenzana and Mercado on Wednesday said Go did not intervene in the frigate acquisition program.

EAR Admiral Robert Empedrad, whose name was dragged into the controversial acquisition of a frigate, was appointed as the new flag officer in command of the Philippine Navy, Malacafiang announced Thursday.

The former Armed Forces of the Philippines deputy chief of staff for Retirees

and Reservists Affairs' appointment was released on Jan. 16 but was made public only on Jan. 18 and signed by President Rodrigo Duterte.

Meanwhile, Defense Secretary Delfin Lorenzana on Wednesday dismissed as proposition by a lawimaker to abrogate the consummated P18-billion contract to acquire a modern frigate for the Philippine Navy.

Lorenzana was reacting to Rep. Gary Alejano's suggestion that the frigate procurement project be terminated because it was allegedly anomalous.

He said the frigate project for the

Navy could not just be scrapped in the absence of questionable conditions in the transaction.

"There is a proper process prescribed in Republic Act 9184 and there are specific conditions that must be present in order to invoke it, none of which are existing at the moment," Lorenzana said.

Lorenzana endorsed Empedrad as Philippine Navy Chief effective Dec. 17, 2017.

Empedrad's appointment came amid a controversy involving the Philippine Navy's P15.7-billion Combat Management System procurement plan for its two missile frigates.

But Malacañang said Empedrad had nothing to do with the procurement that was made during the Aquino administration.

In December 2017, former Philippine Navy flag officer in command Vice Admiral Ronald Joseph Mercado was sacked because of "insubordination,"

Earlier, Lorenzana said Mercado was relieved from his post for "jeopardizing" the frigate acquisition project. Both Mercado and Empedrad worked with the technical working group handling the procurement deal since the Aquino administration.

# Duterte warns of war

### If BBL is not passed

BY CATHERINE VALENTE

RESIDENT Rodrigo Duterte warned that a war will erupt in Mindanao if Congress will fail to pass the Bangsamoro Basic Law (BBL).

In his speech during the launch of Overseas Filipino Bank in Manila on Thursday, Duterte said failure to address the concerns of Bangsamoros could lead to more clashes in the country.

"Because at this time, if nothing will happen to the BBL or we change the Constitution or do not change the Constitution at all, there will be war in Mindanao, I can assure you. mamili kayo (You choose). Hindi ko na ma-control iyan (I cannot control that)," Duterte said.

"And at this time, it could be a double whammy because my enemy would be their friends and what would that be? It's the ISIS," he added, using another name for Islamic State terrorists.

The BBL is the enabling measure of the peace compact signed by the Philippine government and the Moro Islamic Liberation Front (MILF) in 2014. It aims to create a Bangsamoro political entity with enhanced autonomy.

Duterte has banked on the bill's passage to heal the "historical

injustices" suffered by the Moros, who have waged a separatist rebellion since the late 1960s.

The measure failed to pass in the previous administration because of the bloody Mamasapano clash, where 44 elite cops were killed by several assailants, among them members of Morogroups. The bill also faced questions on its constitutionality. Duterte met with MILF leaders led by Ibrahim Murad on Monday in Davao City. He gave assurances that BBL would be enacted first before he will pursue proposals to shift to a federal form of government.

#### Test

Sen. Juan Miguel Zubiri on Thursday said the creation of a Bangsamoro Autónomous Region (BAR) through the Bangsamoro Basic Law (BBL) would be a "good test" to see if federalism will work on smaller scale.

Zubiri, chairman of the Senate subcommittee on BBL, is set to conduct next week a series of public hearings on the BBL that aims to abolish the Autonomous Region in Muslim Mindanao.

"I am willing to give it a chance especially now that extremism is going on again, recruitment is ongoing. I will focus on BBL first before Charter change. This is the long term solution that will provide long lasting peace in Mindanao," he said.

"This will dictate whether we will have peace in Mindanao. This is the remaining promise that government has to fulfill to be able to complete the 1972 Tripoliagreement."

Zubiri said the current BBL version of the Bangsamoro Transition Commission (BTC) no longer contain provisions that would violate the Constitution.

"Our version relied heavily on the past version. During our brief-

ing on December 20 (2017), I saw the BTC version. It's good. They took out several unconstitutional provisions, "he told reporters.

Only two provinces were added to the current BBL version — Cotabato and certain towns of Lanao del Norte. The earlier version included Palawan and Zamboanga City.

Palawan and Zamboanga City.

"They took out the provision that they will set up their own institutions such as their own Commission on Audit, Civil Service Commission and Bangsamoro police," Zubin said. "This is a nice step to get 100 percent support from fellow lawmakers."

The senator hopes to pass the BBL before Congress adjourns in March,

If the House of Representatives passes the same version, the two chambers will have a bicameral conference meeting to fine-tune the BBL so they can ratify it when Congress resumes session in May.

### DND hits Alejano for 'innuendos' on frigate deal

THE Department of National Defense (DND) on Thursday Hit back at Magdalo party-list Rep. Cary Alejano for alleging irregularities, on the purchase of Navy frigates, saying the lawmaker only had "in-

nuendos" and no proof:

there were no grounds to terminate the frigate acquisition project of the Philippine Navy.

"We must pidint out that the anomalies DND spokesman Arsenio Andolong said being cited by [Alejano] are mere allegations and innitiendes which are not legal grounds for permination of the [frigate]

project," Andolong said in a statement.

"There is a proper process prescribed in Republic Act No. 9184 (Government Procurement Reform Act) concerning the termination of a procurement project and there are specific conditions that must be present in order to invoke it, none of which are existing at the moment inthis project," he said.

 In a privilege speech earlier this week, Alejano called for the cancellation of the P18 billion frigate project, claiming the Korean contractor violated the contract, endangering the modernization program of the Armed Forces of the Philippines. Alejano claimed the government would not lose money because Hyundai Heavy Industries (HHI), contractor of the Navy's frigate deal, had paid 20 percent of the contract, which . Delfin Lorenzana, successor of Gazmin, could be confiscated.

The dispute centers on who should be the supplier of the weapons system - Dutch company Thales Tacticos or South Korean-based Naval Shield of Hanwha Thales.

Vice Admiral Ronald Joseph Mercado was sacked on December 18 as flag officer in command of the Navy, for allegedly sitting down on the frigate deal for four months.

He was replaced by Rear Admiral Robert Empedrad, former AFP deputy chief of staff for reservists and retiree affairs (J9).

#### Timeline .

Mercado was said to have favored Thales Tacticos and even met with former Navy chiefs to help his cause, which earned the ire of Defense Secretary Delfin Lorenzana.

Palace Communications Secretary Martin Andanar said the memorandum of the acquisition decision was released as early as 2015, during the time of Defense Secretary Voltaire Gazmin.

It was Gazmin who approved the final technical specifications for the frigate procurement. last January 2016.

At the time, Mercado was commander of the military's Western Command but was among members of the technical working group (TWG) of the Philippine Navy.

He was also part of the post-qualification team that declared HHI as the "qualified and capable" in delivering two frigates for the Navy's project worth P18 billion.

On August 18, 2016, Defense Secretary signed the frigate project's Notice of Award and consulted the TWG.

. A well-placed military source of The Manila Times said Lorenzana repeatedly asked the TWG, which included Mercado, if there were any questions or concerns regarding the frigate project before he signed the contract.

In October 2016, Lorenzana and the vice president of HHI signed the contract in accordance with the procurement process. Vice admiral Jesus Millan was the Navy chief.

But in January 2017, Mercado supposedly questioned the terms of the contract despite Lorenzana's earlier consultations with the Philippine Navy TWG.

The HHI contract also states that it is responsible for the delivery of the entire frigate including its components such as the combat management system (CMS).

In February last year, Mercado sacked Empedrad as chairman of the TWC for the frigate deal and designated Capt, Sean Villa.

The Times source said Mercado wrote to the Defense Acquisition Office (DAO) of the DND, saying that the Navy was not endorsing HHI as the CMS supplier, allegedly lobbying for Thales Tacticos to supply the weapons system.

Another source, however, said Mercado and Empedrad had a rift.

Among reasons why Empedrad and Mercado fought was because of the latter's favoring France for the CMS, after a trip to Europe.

This month, reports came out alleging that Special Assistant to the President (SAP) Christopher "Bong" Go intervened in the Navy frigate deal and supposedly lobbied for Hamwha Thales to supply the weapons system. Duterte and Lorenzana have denied Go's involvement in the frigate deal.

#### **Empedrad gets appointment**

Also on Thursday, the Palace said President Duterte had made permanent Empedrad's appointment as chief of the Philippine Navy.

In a letter dated January 16, Duterte informed Defense Secretary Delfin Lorenzana that Empedrad's appointment was approved effective December 19, 2017.

Empedrad, a member of the Philippine Military Academy Class of 1986, was a commander of the Navy's Offshore Combat Force and concurrent project manager of the frigate program.

ROM the original estimate of P7 trillion, the cost of taking over the military pension system by the Government Service Insurance System (GSIS) has gone up to as high as P9 trillion, according to latest numbers crunching by the Department of Budget and Management (DBM).

But as stratospheric as that number might be, neither the DBM nor the GSIS has the slightest idea for now on how to craft a military pension system that is self-sustaining and not taken out of the pockets of taxpayers.

Budget Secretary Benjamin E. Diokno on Thursday bared optimism that such a mechanism hopefully could be crafted by midyear, when government planners finally come up with a plan addressing the ballooning pension cost of military personnel.

"Maybe around midyear. But we still don't know the modality yet," Diokno told financial reporters at the sidelines of an infrastructure forum on Thursday.

The budget chief added that should the GSIS take on the challenge of managing the pension system of the Armed Forces, the government would have to infuse funds to the agency to make the deal more attractive.

"We are still studying several options but a combination, probably using GSIS as the base. But if we want to convince the GSIS to take on the challenge, we have to give something," he said.

Just last year budget officials and the Department of Finance (DOF) began addressing the necessity of a sustainable retirement system for mili-

tary personnel. One proposal was to incorporate such an entity with the GSIS and do away with subsidies from the government.

In February last year Diokno categorically said addressing the cost of military pension through the annual budget was not sustainable. He also said the Legislative-Executive Development Advisory Council last January agreed to a review of the pension system for military personnel and policemen.

To correct the deeply flawed pension system of military personnel, budget officials said a seed fund equivalent to P5.57 trillion is required. Without so-called indexation and active personnel contributions to the seed fund, the cost was lower at only P2.03 trillion, based on the latest actuarial study

conducted by the GSIS.

Without a self-sustaining military pension system, the cost of extending pension benefits to the uniformed services will have to be taken out of the annual budget of the military. Such a cost had been estimated at 50 percent to 60 percent of their annual budget.

Extending subsidy to the military is also very expensive for taxpayers, as the cost amounts to some P90 billion a year.

The GSIS has thus far refused to take on the challenge of providing pension benefits to those who bled for the country and have willingly put themselves in harm's way so that the rest of us can live in peace.

The GSIS has said it will help craft a pension system that is not funded by taxpayers' money. Rea Cu

A few days after demoting Mercado, President Duterte named Empedrad as acting chief of the Philippine Navy.

The CLIP beneficiaries were Marites Esteban Ilaguno, alias Ka Jenjen/Nimfa/John Well/Lea, political guide and regular member of Kilusang Larangang Guerilla (KLG) Sierra Madre (SM) of NPA; Joseph Ilaguno, alias Ka Erwin/Moymoy, squad leader Tersera KLG; Ardie Catipon, alias Soter, vice commanding officer of Larangang Guerilla sa Patag (LGP); Jose Gallegos, alias Ka Jeff of Sangay ng Partido sa Platun (SPP) Central Aurora; Edgar Baldonade, alias Ka Adim, vice commanding officer and Carl Rissa Baldonade, alias ka Kim, political guide SPP central Aurora.

Paredes said these former NPA rebels decided to go down and surrender because they wanted to live peacefully and to avail of the government's livelihood, peace and development program.

"The CLIP program started in 2011 benefitting former rebels on social welfare, livelihood, health which also aims to facilitate the mainstreaming of former NPA rebels as productive citizens in their communities," he said.

Based on joint circular issued by the DILG and Office of the Presidential Adviser on the Peace Process (OPAPP), qualified beneficiaries of CLIP are those regular members of NPA who surfaced 2011 onwards and have expressed the desire to abandon armed violence and become productive members of the society including their partners/spouses (whether legitimate or illegitimate), parents or siblings, if applicable.

Also qualified are those who did not receive full assistance under the Social Integration Program based on OPAPP's special list of former rebels that surfaced in 2007 to 2009.

Paredes also vowed to assist the former rebels to live normal lives.

Meanwhile, Governor Gerardo Noveras is very grateful that the rebels finally returned to the mainstream of the society and is hoping they will become productive partners of the government in establishing peace and order in the community.

#### Philippine military welcomes LGBT applicants

From Update Philippines (Jan 18): Philippine military welcomes LGBT applicants

In searching for 10,000 Filipinos who want to volunteer to become new soldiers, sailors, airmen, or marines, the Armed Forces of the Philippines (AFP) said they would not discriminate against members of the lesbian, gay, bisexual and transgender (LGBT) community who may want to apply.

But along with the open invitation came repeated reminders for the LGBT community to behave properly, if they so wish to join the Philippine military.

"We were being asked kung ang recruitment be namin will include members of the LGBT – the so-called LGBT community. Are we not going to discriminate against them? Ang sagot po namin, no. The AFP is not going to discriminate against them. Malaya po silang makapag-apply at pumasok sa Armed Forces." said Colonel Edgard Arevalo, AFP chief of public affairs.

"Subalit ang amin pong tagubilin ay iisa lamang. Sa sandaling sila po ay mag-apply at tanggapin na po sa Armed Forces of the Philippines, atin po silang pinapa-alahanan na kallangan po nilang mag-act at kumilos nang may dignidad at pag-lingat sa kanllang unipormang isusuot. Sapagkat an AFP is a uniformed service. It is a noble profession of arms," he added.

Arevalo said there are provisions in military law defining good conduct.

"Ang ating AFP has punitive laws. Lalong-lalo na ang nakalagay sa articles of war, na sinasabing nagpo-proscribe ng conduct prejudicial to good order and military discipline." he said.

He stressed that anyone who could fulfill the application requirements would be welcomed into the AFP, regardless of their gender.

"They are welcome. Pwede po silang mag-apply, Tatanggapin po natin sila sa AFP, but of course they have to pass all the examinations, all the tests," he said.

Arevalo expressed his belief that the LGBT community would be able to contribute greatly to the Armed Forces, but again ended with the warning that military discipline is required under the articles of war.

The public affairs chief however did not explain why he felt the need to issue such reminders in discussing the prospect of recruiting members of the LGBT community.
