

DOE acts to avert summer blackouts

Power plants allowed to sell capacity at WESM

o avert a possible power shortage during the summer months, the Department of Energy (DOE) has allowed power plants without certificates of compliance (COCs) to operate and self their capacity at the Wholesale Electricity Spot Market (WESM).

"The Department of Energy and the Wholesale Electricity Spot Market agreed to allow power generation companies with expired

COCs or with pending COC applications with the Energy Regulatory Commission (ERC) to operate and trade in the WESM," Energy Secretary Alfonso G. Cusi said.

The decision was anchored on Cusi's "assurance that he will not allow any disruption in the country's power supply as a result of the delay in the processing of applications before the ERC, including COC applications, due to the suspension of its four Commissioners."

Power plants, before getting into commercial operations, are required to be thoroughly assessed and validated on their technical compliance as well as on parameters of cost recovery, because that will set the required level of reliability for the country's power system.

In the ERC's process, technical validation being done at power plants alone up to the completion of documentary requirements and processes would take 2-3 months, hence, it portends a not-so-promising summer months for Filipino consumers when it comes to electricity supply.

Cusi said "the move aims to protect electricity consumers by preventing disruptions in WESM transactions while the ERC issue is being sorted out."

He added that the decision was arrived at in a Resolution that was cemented by the board of directors of the Philippine Electricity Market Corporation (PEMC), the operator of the electricity spot market.

"The paramount consideration is the overall protection of public interest and the security of the supply of power," Cusi said, adding that "this is needed for the Philippines to meet its economic targets,"

The energy chief stressed that "this should take precedence over administrative issuances especially when an administrative body is unable to aet."

Power plants with 2,977.89-megawatt capacity have to renew their permits to operate while those with 1,971.49MW capacity have pending COC applications with the ERC.

It has been prescribed under the Electric Power Industry Reform Act (EPIRA) and the corresponding rules of the restructured electricity sector that if power facilities with expired COCs will inject capacity into the grid so they can sell at the WESM, they are liable for penalties.

Energy Undersecretary Felix William Fuentebella argued that "old plants with expiring COCs are supposed to file for renewal six months prior to expiration," noting that with that as a process, these COCs could already be "deemed approved, so there are no penalties because these are deemed approved."

He cited ERC Resolution No. 16 series of 2014 as legal ground, which stipulates that "COC is deemed approved when ERC fails to act on the same."

He qualified though that these are still up for validation. "What I am driving at is: We will look into the details based on these rules and other options available under the law."

Fuentebella added the DOE "will have to fill the gap from now until the new Commissioners come in."

Under the DOE-PEMC resolution, it was specified that "power generation companies with expired COCs can continue trading upon proof of submission of their application for the renewal of their COC with the ERC."

Further, the department emphasized that "new plants will also be permitted to trade or submit offers to the WESM upon proof of completion of testing and commissioning and other requirements for the issuance of a COC."

Soldiers battle Maute remnants; 6 wounded

Government troops of the Joint Task Force "Ranao" encountered Maute-ISIS remnants and bombers in Lanao del Sur over the weekend, clashing for the first time since the government declared victory over the terrorist group in Marawi City last October.

Army spokesman Major Ronald Suscano said six soldiers sustained minor shrapnel wounds as a result of the encounter.

The clash erupted after gov-

ernment forces encountered about 10 members of the Maute Group in a district in Lanao del Sur, a stronghold of the rebel group, which has pledged allegiance to Islamic State, Suscano said in a statement.

Major General Roseller G. Murillo, the commander of the army's 1st Infantry Division, disclosed that the encounter took place early Saturday morning when government forces responded to a report from concerned residents about the presence of armed militants.

The exchange of fire lasted about 35 minutes until the militants fled, said Murillo.

He added that the terrorists attempted to escape via the lake but soldiers were able to sink their two boats. Operating troops collected one M-203 grenade launcher, two rocket-propelled grenades (RPGs), three anti-personnel 60 mm RPG ammo, one anti-tank RPG ammo, three 40mm ammo, a hand grenade, two RPG fuse, one binocular, one ISIS flag, and several drug paraphernalia.

Murillo said this is the first encounter since the liberation of Marawi City was declared on Oct. 23, 2017.

He commended the operating troops for the successful operation.

"We shall continue to totally eliminate the remaining Daesh-inspired groups in Lanao Provinces and to sustain our efforts to prevent them from establishing Wilayat and spreading Daesh ideology in our joint area of operation," Murillo said. (With a report from Reuters)

When the military truck reached the said area, the truck's brakes failed, causing the driver to lose control of the steering wheel


Investigators said the truck driver tried to avoid a vehicle ahead when it accidentally fell into a ravine down to the river bank.

Duterte welcomes 2 NPA surrenderees



AVAO CITY—President
Duterte last Saturday vowed an
inclusive government for all as
he welcomed two New People's Army
(NPA) rebel returnees.

During the presentation of the NPArebels at Matina Enclaves here, the Chief Executive pledged that NPA surrenderees would be welcomed and accepted.

Duterte expressed his gratitude to the two former rebels for deciding to surrender to government. At the same time, Duterte appealed to the former NPA members for their continued support to his administration.

The President assured the rebel returnees of government's protection and assistance as they begin to immerse in the civilian way of life. In previous statements, Duterte urged members of the NPA to surrender, vowing to provide them with houses and jobs.

Earlier, the President said it is his obligation to protect the rebels who will surrender to the government.

Each of the former rebels was given a transitory housing unit, cash and financial assistance, food packs and a smartphone.

Meanwhile, Duterte reiterated his desire for peace, noting that the war between the government and the communists has went on for an extended period of time.

According to the President, the economy in Mindanao, as well as in the whole country, would improve once peace is achieved.

He recalled that, in his years as the mayor of Davao City, his friendship with the communist rebels was forged by the shared experience of poverty.

The President referred to this as a common ground in understanding ideology and social issues.

Duterte, however, said that, as President, addressing the country's national security is his top priority and sought for the communists' understanding. PMA

Joma calls for mass protests vs Du30

LUCENA CITY—Communist Party of the Philippines (CPP) founder Jose Maria "Joma" Sison on Sunday urged the youth to emulate the riots of the "First Quarter Storm" (FQS) of 1970 against the Duterte administration.

But President Duterte reiterated in Davao City that the communist movement in the country had become irrelevant after meeting on Saturday with communist leaders who had recently surrendered.

"The student youth of today can and should launch huge mass marches and rallies in the National Capital Region and in the provinces, like during the First Quarter Storm (FQS) of 1970," Sison said in an online interview from his base in Utrecht, The Netherlands.

Sison was referring to the social turmoil in 1970 caused by riots and demonstrations from late January to March of that year that then President Ferdinand Marcos used as a pretext to declare martial law.

Sison cited recent controversial events, like the Tax Re-

form for Acceleration and Inclusion (TRAIN) law, moves to amend the Constitution and moves against press freedom, to incite the public against the government.

"With the signal act of the student youth, the rest of the people—workers, the peasants, women, youth of other sectors, cultural workers, professionals and religious—will participate in the mass-protest movement," Sison said.

Surveys not true

Sison disputed the recent results of surveys conducted by Social Weather Stations and Pulse Asia, whose questions and sampling methods he criticized as "not correct."

"It is not true that Duterte enjoys high trust rating and popularity," Sison said.

"We should not forget that Duterte was elected by a minority of the total electorate in 2016, only 39 percent, 25 [percent] of that in Mindanao and Cebuano part of Visayas and 14 [percent] from the bailiwicks of

Lost relevance

But Mr. Duterte reiterated that the communist movement had lost relevance because people are already questioning the sincerity of their cause.

Lt. Col. Benjamin Leander, the 27th Infantry Battalion commander, said Legazpi had voluntarily surrendered through the help of South Cotabato Gov. Daisy Avance-Fuentes.

"Governor Fuentes helped a lot in convincing Ka Efren to come down," Leander said, adding that Legazpi, 58, had

been NDF-FSMR spokesperson for 20 years, while Bendalian was the chief medic of the New People's Army's medical team.

The FSMR covered the provinces of Davao del Sur, South Cotabato, Sarangani and part of Sultan Kudarat and Davao del Sur.

Doing the right thing

One of the sources present at the President's meeting with the surrendered rebels said Mr. Duterte praised the couple for doing the right thing and called on others to follow suit.

Aside from meeting Legazpi, Mr. Duterte also attended the reunion of the Ateneo de Davao University High School Batch 1961, whose members—including Finance Secretary Carlos Dominguez—were his classmates.

2 INDONESIANS HELD BY ABU SAYYAF FREED

ZAMBOANGA CITY— Two Indonesians abducted near Taganak Island in Tawi-Tawi in November 2016 have been freed by their Abu Sayyaf captors in Sulu, the military said on Sunday.

A military report said Indonesians La Utu bin La Raali and La Hadi La Edi were handed over to former Sulu Gov. Abdusakur Tan on Friday.

Tan told the Inquirer in a text message that he did not know the circumstances surrounding their release since the Indonesians were only brought to him.

Rear Adm. Rene Medina, commander of the Naval Forces in Western Mindanao, said the two Indonesians who were both boat captains of fishing vessels, were kidnapped off Taganak Island on Nov. 5, 2016.

"We were informed that JTF (Joint Task Force) Sulu commander (Brig. Gen. Cirilito Sobejana) received a telephone call from former Gov. Sakur Tan Sr. indicating that two Indonesian kidnap victims were brought to his residence at Barangay Asturias, Jolo, Sulu, by a concerned citizen," Medina said.

Debriefing

He said the two freed kidnap victims were immediately fetched by operatives from the JTF Sulu for medical examination and debriefing.

The military had been trying to free the remaining kidnap victims in Sulu, according to Lt. Gen. Carlito Galvez Jr., commander of the Western Mindanao Command.

Based on the record of the military, nearly a dozen people—including foreigners—still remained in Abu Sayyaf captivity to date.

In September, two Indonesians kidnapped by the Abu Sayyaf on Nov. 19, 2016, walked free after a clash between the military and the bandits in Sulu.

Saparudin bin Koni, 43, a boat skipper, and his deputy, Sawal bin Maryam, 36, were on a public utility vehicle when spotted by soldiers at a checkpoint at Barangay Bunot in Indanan. Sulu

The Indonesian sailors were among foreigners snatched by the Abu Sayyaf from the waters bordering the Philippines, Indonesia and Malaysia. INQ

SENATE COMMITTEE TO PROBE NAVY'S P16-B WARSHIP PURCHASE DEAL

The Senate committee on national defense and security will open inquiry into the controversial purchase of two Navy frigates next month, Sen. Panfilo Lacson said on Sunday.

Opposition senators called for the inquiry after President Duterte's closest aide had been reported to have meddled in the P16-billion deal.

Lacson, vice chair of the committee, said he and committee chair Sen. Gregorio Honasan II had agreed to hold the inquiry in February upon the request of Sen. Antonio Trillanes IV.

Lacson said in a radio interview that Trillanes had to take a trip and would return in February, and that Honasan wanted to study the voluminous documents that had been sent to him.

Empedrad, Mercado

To be invited were new Navy chief Robert Empedrad and his predecessor, Ronald loseph Mercado. President Duterte's chief aide, Christopher "Bong" Go, would also be asked to appear because he was the "central figure" in the controversy, according to Lacson.

Go has been accused of taking special interest in the frigate acquisition project when he supposedly sent an unsigned letter to Defense Secretary Delfin Lorenzana overruling the Navy's choice of a combat management system (CMS) for the frigates.

Go allegedly pushed for a CMS offered by another company.

Go has denied the allegation and both Lorenzana and Mercado have said he never intervened in the Navy project.

Opposition Rep. Gary Alejano also blamed Go's supposed intervention for the relief of Mercado last month. Mr. Duterte has designated Empedrad as Mercado's replacement.

AFP modernization

Go has denied having intervened in the project. In a statement, he said he would cooperate in congressional hearings "and face the false and malicious accusations" against him.

The Senate minority filed Senate Resolution No. 584 last week directing the committee on national defense and security and the congressional oversight committee on the Armed Forces of the Philippines Modernization Act to conduct an inquiry into the status of the modernization program and the purchase of two frigates.

Opposition senators wanted the inquiry to establish whether there were violations of the government's procurement laws and if the President's aides intervened in what they said was the first military procurement of the Duterte administration.

The project was first initiated by the Aquino administration in October 2015 to beef up the

country's territorial defense and disaster response capabilities.

Mercado on Saturday said he was willing to appear at the Senate inquiry. He insisted that nobody from Malacañang intervened in the program.

In an interview with Presidential Communications Secretary Martin Andanar over Radyo ng Bayan, Mercado said he would take the hearing as a chance to present his side and that of the Navy's project management team.

He reiterated his earlier statement that Go did not meddled in the matter.

Lorenzana

The allegation of Palace interest in the project arose after Defense Secretary Lorenzana was given a document in Malacañang that favored a South Korean weapons systems supplier for the frigates.

The document assailed the Navy's preference for the Tacticos CMS made by Thales of the Netherlands but highlighted the advantages of the Naval Shield integrated CMS of South Korean Hanwha Systems.

Lorenzana gave the document to then Navy chief Mercado, telling him it came from Go and asking him to prepare a rebuttal.

Go's office also sent a letter to then Commodore Empedrad, who headed the frigate project's technical working group, to attend a meeting in Malacañang to discuss the selection of the CMS.

Lorenzana has since said he had wrongly assumed that the document had come from Go and that the latter had not intervened in the project.

In the radio interview on Saturday, Mercado said he had met Go several times, but the secretary had never asked him about or expressed any interest in any Navy project.

The President has never shown a similar interest in the project either, he added.

Mercado also said that whenever the Navy received communication from Malacañang, somebody from the Palace would call to follow it up. But there was no such call with regard to the document about the frigate that had been given to him. INQ

Abu henchman nabbed in Basilan

COTABATO CITY – Authorities yesterday arrested a senior henchman of Abu Sayyaf leader Furudji Indama in Maluso, Basilan.

Chief Supt. Graciano Mijares of the Regional Police Office-Autonomous Region in Muslim Mindanao said agents cornered Andaang Mataun San, 47, in the town proper of Maluso after a month-long surveillance.

In a report to Mijares, the Basilan provincial police said San turned himself in when he was shown an arrest warrant for murder issued by Judge Leojay Principe of the Regional Trial Court in Basilan.

The operation that resulted in the arrest of San was jointly carried out by combined personnel of the

Maluso municipal police, Basilan provincial police office, Military Intelligence Group 9 and the Intelligence Service of the Armed Forces of the Philippines.

Mijares thanked officials of Maluso for helping the police locate San, a resident of Barangay Upper Mahayahay.

San is one of the key henchmen of Indama, the leader of a big Abu Sayyaf group in Basilan.

Tausug and Yakan community elders confirmed that San started as a follower of an Abu Sayyaf sub-leader named Junaiver under Isnilon Hapilon, who was killed by pursuing soldiers in Marawi City in October last year.

San bolted Hapilon's group in 2015 and joined the Abu Sayyaf faction led by Indama.

Duterte to protect NPA surrenderees

PRESIDENT Rodrigo Duterte has vowed protection and assistance for New People's Army (NPA) rebels who will surrender to government authorities.

He made the assurance during the presentation of two former NPA rebels who surrendered over the weekend at the Matina Enclaves in Davao City.

"The Chief Executive pledged that NPA surrenderees would be welcomed and accepted; assured the rebel returnees of the government's protection and assistance as they begin to immerse in the civilian way of

life," the Palace said in a statement on Sunday.

The President also thanked the former rebels for laying down their arms and appealed for their support to the Duterte administration.

Each of the former rebels was given a transitory housing unit, cash and financial assistance, food packs and a smartphone.

The President first made the call to the NPA to lay down their arms in exchange for jobs back in November.

At that time, the President made the pitch in connection with the initiative of his daughter, Mayor Sara Duterte, to localize the peace talks with the National Democratic Front (NDF)—the umbrella group of all communist organizations in the country – in Davao City.

The mayor said in July 2017 that she had an obligation to pursue a just and lasting peace and that the localized peace process would be comprised of the City Social Services and Development Office from the city government and representatives from the private sector "capable of offering alternatives to the rebels," such as providing livelihood and employment.

The Duterte administration last year called off peace negotiations with the NDF because of the communists' supposed violation of a ceasefire agreement and attack on a presidential convoy.

Rody praises NDF couple surrenderers

PRESIDENT Rodrigo Duterte had his hands full on weekend even as he met with Noel Legazpi, spokesperson of National Democratic Front (NDF) in the Far South Mindanao Region (NDF-FSMR), and his wife, Wendy Bendalian, at the Matina Enclaves in Davao City.

The two rebel leaders both surrendered to the military in Koronadal City on Jan. 15.

Duterte praised the couple, stressing that continuing to fight the government would have been futile.

The President had been calling on communist rebels to surrender, saying they would get houses and jobs if they do instead of dying for a "lost cause."

In December, Duterte pledged to "protect" rebels who would yield.

Legazpi, also known as Ka Efren Aksasato, volun-

tarily surrendered with the help of South Cotabato officials, according to Lt. Col. Benjamin Leander, commander of the 27th Infantry Battalion.

He said 58-year-old Legazpi had served as NDF-FSMR spokesperson for the past 20 years while Bendalian was the chief medic of the medical team of the New People's Army.

Leander said the couple's surrender came about after months of negotiations with the help of South Cotabato Gov. Daisy Avance-Fuentes.

The FSMR covers the provinces of Davao del Sur, South Cotabato, Sarangani, and parts of Sultan Kudarat and Davao del Sur.

Aside from meeting Legazpi, Duterte was also scheduled to meet US-based gastroenterology specialist Dr. Pedro Dayrit, whom he had befriended years back. **Efren Montano**

6 wounded, as troops fight first clash with militants since Marawi battle

Government troops clashed briefly with pro-Islamic State militants in the volatile south on Saturday, the army said, in their first engagement since the government retook Marawi city in the country's biggest battle since World War Two.

Army spokesman Major Ronald Suscano said six soldiers were wounded in the encounter. The clash erupted after government forces encountered about 10 members of the Maute group in a district in Lanao del Sur, a stronghold of the rebel group, which has pledged allegiance to Islamic State, Suscano said in a statement.

The military in October declared victory over the Maute group, which seized control in the southern city of Marawi on May 23, after killing the remaining militants, including a few foreign fighters. More than 1,100 people, including 165 soldiers, died in the five-month conflict.


The siege of Marawi, the country's biggest security crisis in years, has stoked wider concerns that Islamic State loyalists have learned how to thrive in impoverished Muslim areas of the island of Mindanao and use its jungles and mountains as staging posts to launch attacks.

Philippine President Rodrigo Duterte has extended martial law for all of this year in Mindanao, an island he called a "flashpoint for trouble" and atrocities by Islamist and communist rebels. (Reporting by Karen Lema, Editing by William Maclean)

JCI treats Marawi soldiers to day of wellness
