



China deploys missiles on 3 PH-claimed reefs

The United States on Thursday reiterated the importance of keeping a presence in the region amid China's increasing militarization of the South China Sea, where Chinese forces recently installed antiship cruise missiles and surface-to-air missile systems (SAMS) on three Philippine-claimed reefs in the hotly contested waterway.

"We are concerned anytime a claimant, including China, takes an aggressive unilateral action toward militarization. It seems to suggest that they (China) are moving toward militarization," US Ambassador to the Philippines Sung Kim told reporters,

Kim spoke a day after the US network CNBC, citing sources with direct knowledge of US intelligence reports, said China had deployed antiship missiles and SAMS on Kagitingan, Zamora and Panganiban, three of seven Philippine-claimed reefs that China had seized and transformed into artificial islands.

The three reefs are internationally known as Piery Cross, Subi and Mischief reefs, respectively, and they are among the marine features in the Spratly archipelago that are disputed by China and the Philippines and three other Southeast Asian nations—Brunei, Malaysia and Vietnam.

Taiwan, like China, claims all of the Spratlys, an archipelago of about 100 islets, reefs and atolls in the middle of the South China Sea.

The installation of the missiles, if confirmed, would mark the first Chinese missile deployments in the Spratlys.

At a regular press briefing on Thursday, Chinese foreign ministry spokesperson Hua Chunying neither confirmed nor denied the deployment.

OFFIC tion in the Spratly archipelago, including the deployment of

necessary national defense facilities, is almed at protecting China's sovereignty and security," Hua said.

"Those who don't intend to violate [this sovereignty] have no reason to worry," she said,

Malacanang said it had no information about the missile deployment.

"Let me verify that," said presidential spokesperson Harry Roque.

Past 30 days

CNBC quoted unidentified sources as saying that according

to US intelligence assessments, the missiles were moved to Kagitingan; Zamora and Panganiban reefs within the past 30 days.

The US defense department, which opposes China's installation of military facilities on reefs in the South China Sea, declined comment.

Surveillance photographs published by the Inquirer on Feb. 5 showed that China had almost completed transforming seven Philippine-claimed reefs in the Spratlys into military outposts.

Quoting sources from the Pentagon, the Wall Street Journal reported last month that jamming equipment were deployed in the past 90 days on Kagitingan and Pangahiban, a move seen as enforcing China's claim to almost all of the South China Sea and a step further in its militarization of the region.

The Inquirer reported on April 18 that China landed two military transport planes on Panganiban in January.

US presence important

"Precisely because we are concerned [over some of] the developments [in the] South China Sea, it's very important for us to be present [there]," Kim said.

The United States, he said. continues to send its warships to the region "to display the nature of [its] relationship [with the Philippines] and [their] shared maritime concerns?

Kim cited the recent visits to the region of the US aircraft carriers Carl Vinson and Theodore Roosevelt and the assault ship Bonhomme Richard as part of the US way of reassuring its Southeast Asian allies:

He said the warships visits demonstrated the US commitment to its alliance with the Philippines and its other allies in the region to protect the freedoms of navigation, overflight. China to strike vessels within and commerce in the South China Sea.

"This is not only important for us but to everybody, So we will do whatever we can to protect these rights," Kim said.

"I saw the report and [Chi-sides in the territorial disputes in the South China Sea, but has expressed interest in the peaceful settlement of the rival claims.

> "We have consistently called on all claimants, including China, to refrain from unilateral aggressive actions that are inconsistent with the international law and norms; and we will continue to do so," Kim said.

Within missile range

Greg Poling, a South China Sea expert at the think tank Center for Strategic and International Studies in Washington, said deploying missiles on the Spratly reefs would be important.

He said such deployments were expected as China built missile shelters on the reefs last year and already deployed such missile systems on Vietnamclaimed Woody Island in the Paracel archipelago farther to the north.

Poling said the missile deployment would be a major step on China's road to dominating the South China Sea, a key global trade route.

Before this, if you were one of the other claimants . . . you knew that China was monitoring your every move. Now you will know that you're operating . inside Chinese missile range. That's a pretty strong, if implicit, threat," he said.

CNBC said the YJ-12B antiship cruise missiles would allow 550 kilometers.

It said the HQ-9B long-range SAM could target aircraft, drones and cruise missiles within 300 kilometers. —with RE-PORTS FROM JULIE M. AURELIO, REUTERS AND AFR INO





NPA hit man slain, 4 others are captured

A MEMBER of the New People's Army bit squad was killed while four others, including three amazons, were captured during a clash with government troops in Laguna Wednesday afternoon, police said Thursday,

C/Supt. Guillermo Eleazar, director of the Calabarzon police office, said the clash was between operatives of the Laguna Mobile Force Company and Regional Intelligence Unit and an NPA rebel band

on board a van. He identified the slain rebels as Ismael Criste, alias Ka Maeng, a member of the Rebolusyonaryong Buwis sa Kaaway na Uri of the NPA's Cesar Batrallo Command operating in Laguna province and nearby towns in Southern Tagalog.

The captured rebels were Luis Etolarde Alano, 44 of Tanauan, Batangas; Shirley de Guzman Martines, alias Shee, 47 of San Antonio, Quezon; Felicidad de Mesa Villegas, alias Ka Felly, 60 of Barangay Banilan, Pakil, Laguna; and Cristy Ramos Lacuarta alias Tintin of Dao Nasunugan, Capiz City,

Eleazar said the clash occurred at about 4:30 p.m. along a checkpoint setup by the troops in Barangay Dambo, Pangil town, only 12 days before the barangay and Sangguniang Kabataan elections.

Records showed that Alano and De Guzman were reportedly members of the Cesar Batrallo Command while De Mesa and Ramos belonged to the Special Partisan Unit of the NPA

The military's Southern Luzon Command based in Camp Nakar, Lucena City identified Cristy Ramos as the alleged leader of the NPA rebel band the military had encountered.

Military authorities said the rebel band was tasked to conduct atrocities against government troops in Sta. Cruz and Alaminos, both in Laguna.

Military appeals to family of kidnapped cops not to pay ransom

The commander of the Armed Forces of the Philippines Joint Task Force (AFP-JTF) Sulu on Thursday appealed to the families of the two female cops and their two male companions who were kidnapped in Sulu on Monday not to pay their captors any ransom.

In an interview, Brig. Gen. Cirilito Sobejaria said paying ransom to the kidnappers will only further entice them to conduct kidnappings as this will become a lucrative venture for them.

Sobejana said as far as the military is concerned, it will stick to the "No Ransom Policy" position.

"We are discouraging them and ask them to trust us in our effort to rescue their loved ones safely," Sobejana said.

"Kami naman manatili kami sa aming posisyon na no ransom policy kasi nga the more we give ransom the more na magkaroon ng kidnapping kasi nagiging lucratice venture ang kidnapping dito kung may magbabayad kaagad (On our part we will be sticking to the no ransom policy because the more we give ransom the more there will be kidnappings as this becomes a lucrative venture for them)," he added.

Sobejana earlier said that the four victims were abducted by armed men in Patikul, Sulu

on Sunday.

He identified the victims as Jakosalem Ahamad Blas of Brgy. Gandasuli, Patikull, Sulu; Faizal Ahidji and the two policewomen identified as PO2 Benierose Alvarez and PO1 Dinah Gumahad, both ssigned at the Police Regional Office-9 (PRO-9) (Zamboanga City) Crime Laboratory.

Sobejana said the abduction took place at the vicinity of Brgy Liang, Patikul, Sulu at about 12:40 p.m. Sunday.

It was learned that the victims were on board a red tricycle with body number 1899 and markings "Igasan Family" when they were flagged down by more or less 11 armed men led by one Mujir Yada.

Sobejana said the four were then forcibly taken towards the south direction.

Since the kidnapping took place, there were unverified reports circulating that the kidnappers were reportedly demanding P5 million for the release of the lady cops and P150, 000 each for the release of the two men.

Sobejana said although they do understand the families that they want their loved ones to return to them safely, the AFP is doing its best to safely rescue them.

"Just the other day there was an encounter, so we are doing our best (to rescue them) that's the assurance that I can give to them," Sobejana said.

Military nixes ransom payment

MILITARY authorities have urged the families of the four kidnap victims—two police woman and two civilians snatched by Abu Sayyaf-affiliated terrorist group—not to succumb to the ransom demand by the kidnappers.

"We are discouraging them [to pay], and to trust us in our efforts to rescue them [victims] safely," Brig Gen Cirilito Sobejana, commander of the military's Joint Task Force Sulu, currently pursuing the terrorist kidnappers, said Thursday.

He said paying the ransom demand would only encourage them to continue in their kidnapping activities.

The terrorist kidnap group had been reportedly asking P5 million and P300,000 for the release of the two policewoman and two of their companions, but PNP chief Oscar Albayalde refused to give in saying "that's a terror activity, so we do not give in to these kinds of demands to them we consider terrorist."

Police woman P02 Bennierose Alvarez and P01 Dinah Humahad, along with Jakosalem Ahamad Blas and Faizal Ahidji were on their way back to Jolo town after strolling on the Quezon beach when flagged down and forcibly taken by the ASG last week.

Sobejana, for his part, said they could not compel the families of the kidnap victims to pay ransom just to ensure the safety of their loved ones.

"Of course, we understand the sentiments of the families who want to make sure that their loved ones will go home safe and alive but on our part, we are doing our best," said Sobejana.

"We cannot compel them [victims' families] not to give in... but for us, we will stop ransom payment...we need to do all we can," he added.

Two days after the kidnapping incident, ground troops on a search and rescue mission encountered a terrorist group believed to have had a hand in the kidnapping.

As troops pursue the ASG bandits, a constant coordination with local officials and religious leaders in the area was progressing to convince the suspects to just free the victims.

Sobejana tagged the group of Mujir Rada as responsible for the kidnapping of the four victims. Francisco Tuyay

NPA rebel slain, 4 captured in Laguna encounter

Government troops clashed with members of the New People's Army (NPA) liquidation squad in Laguna on Wednesday afternoon = killing one rebel while four others were captured, police said yesterday.

Chief Supt. Guillermo Eleazar. director of Police Regional Office-4A (Calabarzon), said that the shootout happened between elements of the Laguna Mobile Force Company and Regional Intelligence Unit in Calabarzon and an NPA band aboard a van.

According to Eleazar, the firefight erupted at about 4:30 p.m. along a checkpoint established by the troops along Barangay Dambo. Pangil town in Laguna in connection to the upcoming barangay and Sangguniang Kabataan elections,

Eleazar identified the alleged slain rebel as Ismael Criste alias Ka Maeng, member of the Rebolusyonaryong Buwis sa Kaawayna Uri (RBKU) of the NPA's Cesar Batrallo Command that reportedly operates in Laguna and other parts of Southern Tagalog.

Captured were identified as Luis Etolarde Alano Jr., 44, resident of Tanauan, Batangas; Shirley de Guzman Martinez alias Shee, 47, resident of San Antonio, Quezon; Felicidad de Mesa Villegas alias Ka Fely, 60, of Barangay Banilan, Pakil, Laguna; and Cristy Ramos Lacuarta alias Tintin, resident of Dao Nasunugan, Capiz City.

Alano and de Guzman were reportedly members of the Cesar Batrallo Command while de Mesa and Ramos are members of the Special Partisan Unit of the NPA.

Recovered from the five rebels were four.45 caliber pistols; an Intra Tec .9mm sub machinegun; a Garand rifle; a .38 caliber revolver and two hand grenades.

The military's Southern Luzon Command tagged Criste as the leader of the encountered NPA band.

Solcom said that the NPA band was tasked to carry out atrocities against government troops in Sta. Cruz and Alaminos both in Laguna.

The government is maintaining a no-ransom policy after the Abu Sayyaf group (ASG) demanded a P5-million ransom for the release of four kidnap victims including two policewomen, a military official said.

Brig. Gen. Cirilito Sobejana,

commander of the military's Joint Task Force-Sulu, said that giving in to the ransom demand of the Abu Sayyaf will only embolden the terrorists to continue kidnapping.

Sebejana, however, admitted that authorities could not compel the families of PO2 Bennierose

Alvarez and PO1 Dinah Gumahad. Jacosalem Ahamad Blas and Faizal Ahidji from paying just to ensure the safe release of their loved ones.

"Our position is no ransom policy because the more we give ransom, the more that there will be kidnapping because it's

becoming a lucrative venture for them," said Sobejana.

Currently, 14 kidnap victims are still being held by the terrorist Abu Sayyaf group in Sulu.

The latest kidnapping happened despite claims by the military that

it is gaining ground in fighting the terrorists.

"We are discouraging them (to pay), and to trust us in our effort to rescue them (victims) safely," said Sobejana.

Apart from ongoing rescue operation being conducted by both the police and JTE Sulu, Sobejana said that they are also in constant coordination with local government officials and religious leaders in the area to convince the kidnap men to just free the victims.

"Of course, we understand the sentiments of the families who want to make sure that their loved ones will go home safe and alive but on our part, we are doing our best," said Sobejana.

"We cannot compel them (victims' families) not to give in...but for use, we will stop ransom payment...we need to do all we can," he added.

Last Wednesday, Philippine National Police (PNP) chief Director General Oscar Albayalde said that the kidnap men demanded P5 million for the release of the two policewomen.

Information also circulated in Sulu that P300,000 was being asked from the families of Blas and Ahidji.

the PNP will not negotiate with the terrorists.

Sobejana tagged the group of Mujir Rada as responsible to the kidnapping of the four victims, who just came from Quezon Beach in Patikul and were on their way back to Jolo when abducted.

Sobejana expressed fears that if ransom is paid, the ASG will only use it to buy firearms and continue with their illegal activities.

Negotiations ongoing

Earlier, Police Chief Supt. Billy Beltran, Police Regional Office-9 (PRO-9) director, said the ASG has demanded ransom payment in exchange for the release of the two policewomen and their two companions, adding that "negotiations" are ongoing.

Beltran said the case is now being handled by the Philippine National Police-Anti-Kidnapping Group, together with the victims' families.

Reports said that four were seized by ASG bandits led by Mujir Yada on Sunday, April 29, in Barangay Liang, Patikul.

Beltran said operations by the Joint Task Force Sulu to rescue the captives are also ongoing, and that the safety of hostages is of paramount concern.

Chief Insp. Helen Galvez, PRO-9 information officer, said in a statement the two policewomen were on vacation in Sulu.

She said they came from Quezon Beach, one of the famous picnic grounds in Sulu, when the ASG seized them.

Alvarez is assigned with the Albayalde, however, yowed that Engineer Service Division under the Regional Logistics Office of PRO-9. She is from Isabela City, Başilan.

Gumahad is undergoing a 45day Criminal Investigation Course at Regional Special Training Unit-9. She is assigned in the town of Midsalip, Zamboanga del Sur.

NPA now operates in Zambo provinces

NEW People's Army rebels have been seen in the Zamboanga provinces, prompting the military to form a battalion to address the apparent expansion of the area of operations of the communist rebels.

"We've been receiving reports of rebel activities (in the Zamboanga Peninsula). This could be part of their expansion efforts. That is one of the considerations (in the deployment)," said Maj. Ronald Suscano, spokesman of the Army's 1st Infantry Division based in Zamboanga del Sur.

Suscano said the military started receiving reports of NPA presence in the Zamboanga Peninsula in November or December last year.

The NPA operates mainly in the Davao and Caraga regions. The Davao region covers Compostela Valley, Davao del Norte, Davao del

Sur, Davao Occidental, and Davao Oriental. Caraga covers Agusan del Norte, Agusan del Sur, Dinagat Islands, Surigao del Norte, and Surigao del Sur.

Suscano said the newly-formed 97th Infantry Battalion, composed of 400 soldiers and headed by Lt. Col. Rufino de Leon, will be deployed to Zamboanga del Norte, Zamboanga del Sur, and Zambo

anga Sibugay after it completes a 45-day training which started yesterday.

Maj. Gen. Roseller Murillo, the 1st ID commander, said the training "is designed to enhance the competence and individual skills of every soldier and also develop their teamwork as a unit." It is also expected to boost the soldiers' confidence.

The NPA is the armed wing of the Communist Party of the Philippines. In November last year, President Duterte terminated peace negotiations with the CPP-NPA-National Democratic Front of the Philippines because of continued attacks by the NPA.

Last month, Duterte directed government negotiators to work for the resumption of the talks but military operations against the NPA continue.

In Laguna, meanwhile, a member of the NPA's hit squad, the Sparu, was killed by policemen in a shootout at a checkpoint in Barangay Dambo in Pangil town.

Four other Sparu members were arrested.

Chief Supt. Guillermo Eleazar, Southern Tagalog regional police chief, identified the slain rebel as Ismael Criste aka Maeng, who is also a member of the NPA's Rebolusyonaryong Buwis sa Kaaway na Uri (RBKU) under the Cesar Batrallo Command.

Police said the RBKU is the

NPA unit tasked to collect revolutionary taxes.

Eleazar said policemen placed Criste under surveillance after they received reports that a group of communist rebels were out to assassinate policemen from the towns of Sta. Cruz and Alaminos.

Eleazar ordered his men to intensify checkpoint operations.

Military to cops' kin: Don't pay ransom

A MILITARY commander yesterday appealed to the families of two policewomen and their two companions not to pay ransom to the Abu Sayyaf so as por to encourage other lawless groups to engage in kidnapping

Brig. Gen. Cirilito Sobejana, head of the military's Joint Task Force Sulu, made the appeal a <u>day</u> after PNP chief Oscar Albayalde said the kidnappers are demanding P5 million for the release of the two law enforcers.

"It (paying ransom) will allow them to continue with their operations because they can buy new weapons, they can buy supplies because currently, they are running short of logistics," he added.

The military has said the kidnappers are members of the Abu Sayyaf but Albayalde said PO2 Benierose Alvarez, PO1 Dinah Gumahad,

Jakosalem Ahamad Blas, and Faizal Ahidji were kidnapped in Patikul town by a group composed of relatives of slain Abu Sayvaf men.

Unconfirmed reports said the Abu Sayyaf is also asking P300,000 for the release of Blas, a tricycle

The policewomen are detailed with the crime laboratory of the Zamboanga Peninsula Regional Police Office in Zamboanga City. They came from a beach in Talipao town and were on the way to Jolo town when they were abducted. The military has said the kidnappers were led by Abu

Sayyaf leader Mujir Yada.

Sobejana said the military establishment will strictly observe the government's no-ransom policy. "We are going to prevent any ransom payment," he said.

Sobejana assured the families of the kidnap victims that the military establishment is exerting all efforts to rescue the four safely.

"In fact, the other day, we encountered (kidnappers). We are giving them our assurance that we are doing our best," Sobejana said.

Troops from the elite 5th Scout Ranger Battalion clashed with part of the kidnap group in Talipao town on Tuesday, killing one of the kidnappers.

Sobejana said the military is coordinating with local government officials and religious leaders in the province to negotiate and "to convince the abductors to release the victims."

US envoy cites importance of naval ship visits in SEA

United States (US) Ambassador to the Philippines Sing Kim on Thursday emphasized the importance of American ship visitations in the Southeast Asian (SEA) region, following concerns about continuous militarization in the South China Sea (West Philippine Sea).

"Not only does our presence. Visits of ships are really fantastic, ships (and) carri-

ers demonstrate our commitment to the US-Philippines alliance, the region, and also to do whatever we can to protect international flights, freedom of navigation and overflight," Kim said during the "Kapihan sa Embahada" at the US Embassy in Manila.

Kim was referring to the recent port visits of powerful US warship to the Philippines, namely aircraft carriers USS Carl Vinson and USS Theodore Roosevelt, and the USS amphibious assault ship Bonhomme Richard.

"(It's) very important for us to be present and the recent ship visits that I mentioned are directly relevant to the situation we have in the South China Sea... So we'll continue whatever we can to protect those rights," the US envoy said.

Political rhetoric

Kim also said it is more important to listen to what is happening on the policies and substance concerning the relationship between Manila and Washington, D.C. rather than the occasional political rhetoric from President Duterte.

Kim was reacting to questions about Duterte's most recent statement saying that some countries in the Association of Southeast Asian Nations (ASEAN) are complaining about the meddling of western countries in the internal affairs of regional neighbors like Indonesia, Cambodia, and Malaysia.

"We work together on so many fronts and making concrete progress in so many important areas, and I'm also quite optimistic what's happening right now. I think it's important to pay more attention to what's happening on the ground, what actions and policies and substance rather than occasional political rhetoric," he said.

US to donate addl P182m for Marawi victims

UNITED States Ambassador Sung Kim on Thursday announced the US would povide an additional P182-million assistance for the people displaced due to the Marawi City conflict in 2017.

This amount brings to nearly P1.4 billion the total contribution of US government, through US Agency for International Development, for the total recovery of the southern city.

"Together with our partners on the ground, we will build transitional shelters; repair water and sanitation facilities, provide social support, establish safe spaces to protect women and children from exploitation and violence, and, hopefully, in the process, also help jump-start the local economy," Kim told reporters at the US Embassy in Manila.

Last January, the embassy allocated an additional P330 million to support young women and men to enhance job skills and attain livelihoods.

The United States, through USAID, has been a key partner of the Philippine government in the recovery, stabilization, and rehabilitation of Marawi City and its surrounding areas.

USAID's early assistance involved restoring access to water and distributing desks for schools where displaced students are enrolled. It also provided health clinics in Marawi City and surrounding areas with supplies and services to combat tuberculosis and support maternal, newborn, and child health needs. PNA

This brings the total US contributions to the Marawi humanitarian response to nearly P1.4 billion or \$26.4 million, Kimitold reporters.



Ka Trese was immediately rushed by the troops to Bontoc General Hospital for treatment upon being seen exhausted and confused, and later collapsed. She later turned-over the subversive documents, cellular phones and ammunitions. Ka Trese also revealed that she was a red fighter of the New People's Army (NPA), but eventually opted to surrender after experiencing sexual and physical abuses from his comrades from the Leonardo Pacsi Command.

NOLCOM hardly condemns these unlawful and terroristic acts against humanity. These are manifestations of the terrorist group's disregard to people's right, as well as the exploitation and abuse of minors. Armed men torch payloader at Ecija flood-control site

BONGABON, NUEVA ECIJA – Three armed men, who identified themselves as communist rebels, set fire to a payloader that has been used for a flood-control project in Barangay (village) Labi here on Wednesday night (May 2).

Equipment operator Lorenzo Soria, 54, told the police that he was awakened by the men at 11:30 p.m. and was ordered to lie face down on the other side of the road by the suspects.

"Naamoy ko na lang na amoy gasoline at may mga putok ng baril (I started to smell gasoline then heard guns being fired)," said Soria, who works for the Cabanatuan City-based Front Nine Construction Company.

The armed men walked away after torching the heavy equipment, said Chief Insp. George Caluag, Jr.

The firm informed the police that it has been receiving demands from the New People's Army to pay a "progressive tax."

Authorities placed the damage at over P4 million.
