CHINA SHIPS, PLANES AT PH REEFS SINCE 2017

Two maritime security experts say Beijing's steady capability buildup in the Spratlys indicates development toward full operation of its military bases in the hotly contested region.

Chinese warships and aircraft have been frequenting Philippine territory in the Spratly archipelago since 2017, indicating a steady pace of development toward "operational status" of Beijing's military bases in the hotly contested South China Sea.

Missile-equipped vessels were seen last year near Philippine reefs in the Spratlys, which China had turned into artificial islands

Surveillance images obtained by Inquirer net showed a Luoyang Jiangwei II-class frigate (Hull No. 527) at Zamora Reef, known internationally as Subi Reef, last Nov 15. This vessel is said to be armed with shortrange surface-to-air missiles and antiship cruise missiles.

Last June 16, a Type 056 Jiangdao-class missile frigate, the Luzhou 592, was spotted at Panganiban (Mischief) Reef.


Last Jan. 14, a Jiangkai IIclass missile frigate and a Louyang III-class guided-missile destroyer were seen at Panganiban.

A Type o56 Jiangdao-class guided-missile corvette was spotted at Zamora on Jan 14 this year.

Chinese Coast Guard ships, amphibious and sea transport vessels had also been spotted by air patrols in the region.

Security patrol

"Some of the ships were probably meant to provide security to the continued development of the island and its facilities, to try to discourage any curious ships and aircraft from coming too close, and even prevent any unwanted visitors from landing on the artificial islands," said Jay Batongbacal, director of the

University of the Philippines Institute for Maritime Affairs and Law of the Sea.

"Other ships were probably using the artificial islands as resupply bases for long voyages and patrols;" Batongbacal said.

Last week, satellite images released by the Washington-based Asia Maritime Transparency Initiative (Amti) showed a Shaanxi Y-8 military transport aircraft on Zamora. The photos were taken on April 28.

Earlier in April, the Inquirer reported the presence of two Xian Y-7 aircraft on Panganiban, shown in surveillance image taken on Jan. 6.

A closeup examination of the image showed the insignia of the People's Liberation Army Air Force, confirming the aircraft were military planes.

Amti also published satellite photos of combat ships regularly patrolling the artificial islands, along with logistics vessels.

But what really worried Southeast Asian claimants to territory in the South China Sea were the April 9 report of The Wall Street Journal that China had installed military jamming equipment on Panganiban and Kagitingan (Piery Cross) reefs and CNBC's May 2 report that Beijing had deployed antiship cruise missiles and surface-to-air missile systems on Kagitingan, Zamora and Panganiban.

Full operation of bases

"All these are incremental steps toward full operational status of these military bases," Batongbacal said.

Most alarming was the deployment of Chinese high-tech weapons on Philippine territory, but Malacañang said last week that it was still trying to verify the report.

The Department of Foreign

Affairs said it was taking the report seriously, but the DFA had not stated what it intended to do.

Batongbacal described the Duterte administration's response as an "incredibly weak excuse" to justify its position of not protesting the developments "out of fear that it might elicit an adverse reaction from China."

President Duterte has put aside a 2016 ruling in favor of the Philippines of the Permanent Court of Arbitration in The Hague that invalidated China's claim to 90 percent of the South China Sea in exchange for aid, loans and investments from Beijing.

Insulting to military

"The [military] is not so lacking in competence that it cannot even analyze reconnaissance photographs from ship, [airplane] or satellite, nor is it without other resources of information from allies and friends . . It is actually insulting to think that the [military] cannot even verify such matters." Batongbacal said.

He said there was nothing more to verify after China had admitted the missile deployments.

"Its answers to two pointed questions separately made and recorded in separate [Chinese Ministry of Foreign Affairs] briefings do not deny them, and even refer to them as the relevant deployment," he added.

The Philippine military, however, said on Monday that it was still verifying the missile deployments.

"We are coordinating with our counterparts and we are still validating the issue," said Gen. Carlito Galvez, chief of staff of the Armed Forces of the Philippines.

Galvez gave assurance that the military was doing its best to protect Philippine territory but he would not give specifics.

The Senate opens an inquiry into the missile deployments when it resumes sessions on Tuesday.

Collin Koh, a research fellow at Rajaratnam School of International Studies' Maritime Security Program, told the Inquirer that the capability deployment pattern should have been long expected.

"This is a gradual, creeping addition of increasingly high-powered capabilities to those Chinese-occupied features. It'll appear that Beijing is ready to up the ante by beefing up its defenses [on] those artificial islands," Koh said.

Long-range weapons

"When Beiling built such high-value installations as enormous airstrips replete with shelters and possibly bunkers, as well as sizable ports with huge ship berthing

spaces, it's a matter of time it will beef up the preexisting short-range defenses such as close-in weapons systems with [long-range] ones," he said

Koh said the "defensive preparations" may be part of China's measures to assert sovereignty over the contested region, including sea patrols and aerial surveillance using fighter jets and bombers.

In time, China may use its capabilities for offensive operations, he said.

"These long-range systems would allow China to actively challenge foreign military activities within their engagement envelopes, deterring against any undesired moves by the latter," he added.

Koh viewed the Duterte administration's usual response as "a purposeful attempt to [play down] the issue" in order not to "rock the boat" with China.

Both Koh and Batongbacal criticized the Duterte administration's statement that it was "confident" that China's missiles were "not directed" toward the Philippines because of the improved relations between the two countries.

"Manila may say that when ties are rosy. But when ties turn sour, which can [happen] overnight without warning, those missiles would still remain there to threaten Philippine interests in the South China Sea," Koh said.

"Moreover, the missile deployments and the very characteristics of these systems pose a direct challenge [to] Manila's ability to resupply or reinforce [its] outposts in the Sprattys such as Thitu [Pag-asa] Island," he said. "Any plane [flying] out of Palawan [to] that very outpost can be easily interdicted by those Chinese missiles deployed [on] those artificial islands." —with a report from Jeannettel andrade inQ

Electioneering: 1,100 local execs,

reps tagged

Over 100 vote buying cases to be probed

Around 1,000 local executives and 100 members of the House of Representatives reportedly intervened in the barangay and Sangguniang Kabataan (SK) elections by trying to influence their constituents to vote for their bets, an official of the Department of the Interior and Local Government (DILG) said yesterday.

DILG Undersecretary Martin Diño said that about 1,000 elected barangay captains are facing suspension and disqualification from office for violating laws and Commission on Elections (Comelec) rules, including vote-buying.

Dino said they are also building cases against the 100 lawmakers, who he said made a mockery of the electoral process.

He said the 100 congressmen, who come from different districts nationwide, would be accorded due process

to get their side and discover the truth," he said in Filipino.

"We received reports that some of the congressmen gave money, while others invited candidates. One candidate had withdrawn, then he or she was convinced to run. These reports are coming from all over the country," Dino said.

The stories are being veri-

fied by the DILG.

"Let's admit it, these congressmen really supported candidates, but it shouldn't be obvious as the process is supposed to be apolitical," said Diño.

He pointed out that lawmakers, mayors and other politicians were overcager to provide support to barangay captains in their areas of jurisdiction to help their reelection bid next year.

This is in support of their reelection bid in 2019. They need the support of barangay captains for their re-election," he noted.

Dino said such practice should be stopped and that once information is verified and affidavits are sworn to, the DILG will closely coordinate with the Comelec for the perpetual disqualification from public office of these people.

He cited the first cases of Batangas Rep. Raneo Abu, who released letters instructing his constituents to vote for certain candidates or he would stop supporting their scholarship programs. He said the case against Abu has been filed.

"Two barangay chairmen have filed the complaint against him," Diño said.

Abu could not be reached for comment

At the same time, Diño said 1,000 elected barangay chairmen are facing suspension and disqualification from office for alleged violation of Comelec rules.

"If the 1,000 will win they will not be proclaimed as winners because of their violations and the complaint against them. We have their names, unless they can clear these and answer the accusation against them," he added.

In one case, Difice said an Australian ran in the barangay elections despite the law providing that only Filipino citizens can run for public office in the Philippines.

"Some are not Filipino citizens, while others had served three terms but insisted to runagain. They fooled the government and the Filipino people," he noted.

He vowed to work hard to put these people behind bars for violating the law, as he called on the public to submit to the DILG evidence against them.

As this developed, arrests have been made, following more than 100 reported cases of vote-buying.

Citizens' arrests was made on seven persons, who were allegedly buying votes in Lucena City on the eve of the elections.

Police found the suspects, who will be charged with illegal possession of unlawful election paraphernalia, in pos-

session of envelopes each with sample ballots and P200 cash.

The Southern Tagalog Police identified the suspects as Pepito Carbonel, Virginia Sta. Ana. Dory Repollo, Romeo Bersabe, Arsienio Lagrason Jr., Fernando Casino and Wilma Anthony.

In Calamba City, barangay health worker Corazon del Rosario was arrested when councilor Saturniño Lajara and electrician Loreto Gareza, sought the help of authorities, claiming that they saw Del Rosario giving money to Antonio Latumbo in Barangay Milagrosa last Sunday.

Barangay captain Christian Maraña, of Poblacion in Calauag, Quezon was accused by Franklin Maravilla and Franklin Pulgar, a candidate for barangay captain, of vote buying.

Police nabbed Toofilo Banares Jr for alleged votebuying on behalf of a candidate for barangay councilor in Taguig City yesterday.

A complainant had approached the police and claimed that Banares offered him P1.000.

Banares will be charged with violation of the Omnibus Election Code.

For their part, police are investigating an alleged vote-buying incident in Mandaluyong.

Senior Supt. Moises Villaceran, Mandaluyong City police chief, said they are gathering evidence to pin down the suspects behind the incident reported by Mharlee Mac Albaciente, a poll watcher.

According to Villaceran, Albaciente brought to his office Genesis Magsino and Herminia dela Cruz, who claimed



somebody paid them P100 and P300, respectively, to vote for the ticket of a candidate for barangay chairman.

Magsino and Dela Cruz brought with them the money but failed to present supporting documents like the sample ballots showing the candidates they are supposed to vote for

In Aklan, Comelec spokesman James Timenez said a suspected vote buyer was caught in the act of distributing envelopes containing cash and sample ballots on the eve of elections.

Jimenez added that the suspect faces an election offense, which is punishable with up to six years imprisonment, perpetual disqualification of the right to vote and to hold public office.

Philippine National Police (PNP) chief Director General Oscar Albayalde added that they are validating reports of vote buving.


Senior Supt. Rodolfo Castil, provincial police director of Negros Occidental, vesterday confirmed reports of vote buying in La Castellana. This is now being investigated by the Comelec.

P3,000 each for voters

Although there was no violence this time, alleged vote-buying was reported in some Abra towns ahead of yesterday's polls.

Voters in at least three towns were reportedly given P3,000 each to favor barangay and SK bets supported by political kingpins.

DILG officer-in-charge Eduardo Año said they have ordered several mayors to explain after they were reported to be involved

in the whittling down of barangay candidates to a single slate.

Earlier, Diño acknowledged that they were verifying reports of vote buying and harassment in Abra, San Rafael in Bulacan, Antipolo City and 17 cities in Metro Manila, including Quezon City and Marikina.

The DILG official also said they received video footage of some municipal mayors, congressmen and governors "harassing" those running against their candidates.

Diño vowed that once these complaints are verified, the DILG will file administrative charges against the officials, which could lead to their perpetual disqualification from holding public office.

For its part, when the Comelec received reports about missing precincts and missing names, these were immediately addressed with the help of its accredited citizen's arm, Parish Pastoral Council for Responsible Voting, Commissioner Al Parreño said.

For his part, Albayalde reported that a total of 1,100 policemen have replaced teachers as Board of Election Tellers (BETs) in Sulu, Basilan, Maguindanao, Lanao del Sur and Cotabato city.

Meanwhile, the Comelec barred more than 3,000 residents of Maguindanao province from voting yesterday for having multiple voters' registration.

China to deploy fighter iets to SCS — think tank

In a matter of time, China will deploy fighter jets to its artificial islands in the South China Sea, which is expected to significantly expand Beijing's capability to project power in its outposts, a private think tank has reported.

The Asia Maritime Transparency Initiative (AMTI) of the Washington-based Center for Strategic and International Studies (CSIS) recently said that developments at Kagitingan (Fiery Cross) Reef, Zamora (Subi) Reef and Panganiban (Mischief) Reef - known as the "Big Three" – followed similar military deployments in the

The think tank said China deployed J-10 and J-11 fighter jets to Woody Island. In October last year, the Chinese military released images and video of J-11Bs on Woody for

The report said that like on Woody Island, Chinese antiship cruise missiles, military transport aircraft, surfaceto-air missile systems and jamming equipment are on Kagitingan, Zamora and Panganiban Rects

"With similar platforms now seen on the Big Three, it is reasonable to look at other recent Woody Island deployments as signs of things to come at Fiery Cross, Mischief

"Considering that China has built identical hangars for combat aircraft on Woody and on each of the Big Three, it is likely that J-10s or J-11s will soon find their way south to the Spratly Islands," it said.

The current and expected deployments of air and missile platforms in the Paracels and Spratlys are steadily expanding Chinese power projection capabilities from its outposts," the report said.

The AMTI said the Big Three host both air and naval bases and support an evergrowing Feople's Liberation Army Navy (PLAN), Chinese Coast Guard (CCG) and fishing fleet presence across the southern portion of the West Philippine Sea.

Tracking surface ships in the

West Philippine Sea, the AMTI monitored around 15 Chinese warships and coast guard vessels of various types anchored on its man-made islands on the three reefs

The AMTI identified several PLAN and CCG vessels in the Spratlys, which include Type 053, Type 053H1, Type 053H1G and Type 053H3 frigates.

AFP doing its best

Meanwhile, Armed Forces chief Gen. Carlito Galvez yesterday assured Filipinos that the military is doing its best to secure and protect the country's maritime territory and territorial integrity

Galvez issued this statement in the wake of China's sustained militarization in the Kalayaan Group of Islands in the Spratlys.

islands and also in the westem portion, we are protecting seven islands along the Sulu and Celebes seas," Galvez said.

He was referring to the AFP's nine military outposts in the Kalayaan currently being guarded by the Marines

These military outposts include the islets Pag-asa, Likas, Parola, Lawak, Kota, Patagand Panatag as well as Ayungin Shoal and Rizal Reef.

Under direct threat from China's militarization in the Kalayaan Group of Islands are Pag-asa Island and Ayungin Shoal.

Kalayaan town on Pag-asa, a fifth class municipality of Palawan, is located just 12 nautical miles from China's man-made island on Zamora

Ayungin Shoal is 23 nauti-"We still maintain the nine cal miles from the Chinese

military base at Panganiban Reef, which is only 129 nautical miles from mainland Palawan.

As reported by the think tank, China has been assembling around 15 warships and coast guard vessels in the disputed region since last year.

"For now we are coordinating with our counterparts and we are still validating the report," Galvez said.

He declined to discuss the issue, saying any official statement on the West Philippine Sea is no longer within the domain of the military but of the Department of Foreign Affairs

On the northern frontier, Galvez said the AFP has deployed a battalion of Marines to help secure and protect the country's territory. ~

DUTERTE TO SEND OFF FILIPINO OF SCIENTISTS TO PHILIPPINE RISE

President Duterte is sending off an all-Filipino team of scientists to Philippine Rise on Tuesday to begin the country's first scientific research in the vast undersea plateau off Aurora province.

The send-off program commemorates the 2012 United Nations declaration that the submerged plateau, then known as Benham Rise, is part of the Philippines' exclusive economic

zone and extended continental shelf

Mr. Duterte's trip is also symbolic, as it falls on the eve of the first anniversary of his renaming the 13-million-hectare seamount Philippine Rise.

Accompanying the Presi-

dent in sending off the 50strong scientific team are Defense Secretary Delfin Lorenzana and some members of Congress, including Sen Win Gatchalian, National Security Adviser Hermogenes Esperon said on Monday.

Esperon said the government had stopped processing foreign applications for scientific research in Philippine Rise, and was encouraging Filipino scientists to carry out studies of the resource-rich seamount.

On June 12 last year, the mili-

tary's Northern Luzon Command planted a metallic Philippine flag on the seamount.

The command also placed a marker 21 meters below the surface to assert that the plateau is part of the Philippines' territory INQ 6

Rody leads rites renaming Benham as Philippine Rise

President Duterte will lead today the commemoration of the renaming of Benham Rise to Philippine Rise to emphasize the Philippines' sovereignty over the resource-rich underwater plateau

Activities commemorating the awarding of Benham Rise to the Philippines and its renaming to Philippine Rise will be held in Aurora province today until tomorrow, according to Malacañang and military officials.

These will include the send-

ing off of a team of about 50 Filipino scientists who will conduct research in Philippine Rise, casting of buoy made by the Bureau of Fisheries and Aquatic Resources as floating marker, laying of a marker at the shallowest point in Benham Plateau and fly-by of air assets

of different agencies conducting mantime air patrol in the area.

Li Col Isagani Nato, public information chief of the Armed Forces of the Philippines' Northern Luzon Command, said this week's commemoration is the second since the awarding of Philip-

pine Rise to the country.

The Philippines has sovereign rights over the undersea region, a 13-million-hectare submerged continental shelf off the province of Aurora. This means that the country has the exclusive right to explore and exploit the natural and nonliving resources found in it.

The United Nations declared the underwater plateau as part of the Philippines' continental shelf in 2012. Duterte renamed the undersea landmass from Benham Rise to Philippine Rise through Executive Order No. 25 issued in May last year. Q

The Philippine Rise is a natural submarine prolongation / undersea region of the Luzon Island located 135 miles from the coast of Aurora and 160 miles from the northern coastline of Dinapague, Isabela.

AFP - Northern Luzon Command Spokesman and Public Information Office chief Lt. Col. Isagani Nato said scheduled activities include the send-off of some 50 Filipino scientists who will conduct maritime / scientific research in the Philippine Rise, the casting of buoy made by the Bureau of Fisheries and Aquatic Resources (BFAR) as floating marker, laying of another marker at the shallowest point in the Benham plateau and fly-by of aircrafts of different agencies conducting maritime air patrol in the area.

Philippine territory

Last month, Duterte said he would visit Philippine Rise to make a bold statement that the Philippines "owns this place."

'I'm going to set sail to Benham Rise and I will make a statement there that nobody but nobody owns this place, including the continental shelf," Duterte said last month.

UNCLOS ruling and resources
Under the United Nations Conven-

tion on the Law of the Sea (UNCLOS), the Philippines has sole rights to explore and exploit the mineral resources in the Philippine Rise.

It is said that its seabed may also contain highly valuable minerals.

It is home to a rich marine biodiversity with reefscapes containing corals, algae, and halimeda, sustaining a variety of fish.

With its fishery resources, the region is crucial to fisherman from Quezon, Aurora, Catanduanes, and adjacent provinces.

It is said to have the highest catch rate of tuna species compared to other areas in the country.

Rody's warning

In March this year, President Duterte said he is ready to go to war against any country which will conduct research or experiments in the Philippine Rise without the government's permission.

"If any country would say that they want to try and experiment there (Pnippine Rise) without our permission, hindi talaga ako papayag (I will not

allow it) and it will mean war. Duterte said in a speech in Davao City two months ago.

"Nandoon na ang mga marines. Wag kayong matakot, kasama ako doon (The marines are already there, Do not be afraid, I will be there with you)," he added.

Duterte earlier said that he will not allow foreign researchers to explore the Philippine Rise without his permission and recommendation from the Armed Forces of the Philippines (AFP) following reports that the government admitted that Chinese survey ships have a record of illegal entry in the Philippine Rise.

"Sinabi ko talaga walang magexperiment na diyan hangga t wala sila permiso galing sa akin (I said that no one will be allowed to experiment there until I give my permission). But the armed forces will have to recommend it," Duterte said.

China

Duterie's pronouncement about the Philippine Rise stemmed from reports that China has given name to five of

the underwater features in the Philippine Rise.

However, the Philippine government said that it will proceed with giving them Filipino names.

Malacanang earlier expressed that there is no reason for the public to be alarmed by China's move since the Asian giant recognizes that it is the Philippines which has sovereign rights over the 13-million hectare underwater plateau. (with a report from Mar T Supnad) | 1

Duterte leads visit to Philippine Rise

PRESIDENT Duterte will lead the commemoration of the first year anoversary of the renaming of the intercontinental shelf that will be highlighted by a "solidarity visit" and send-off rites for an all-Fillipino scientific team-that would conduct maritime research in the area.

The commemoration will be held May 15 to 16.

The MSR is the first nationally-coordinated research to be conducted in the undersea region off the provinces of Isabela and Aurora since Duterte signed Executive Order 25 renaming Benham Rise to Philippine Rise on May 16, 2017.

It is part of the Coordinated National MSR Initiatives and Related Activities or CONMIRA that the national government agencies and research institutions are conducting in the Philippine waters from April to November this year.

CONMIRA comprises the Bureau of Food and Aquatic Resources, Marine and Geosciences Bureau and Biodiversity Management Bureau of the Department of Environment and Natural Resources, National Mapping and Resource and Information Authority, Philippine Navy and University of the Philippines-Marine Science Institute

Duterte had earlier ordered to stop all the marine explorations by foreign entities in Philippine Rise and to give priority to Filipino scientists.

Last week, Presidential Spokesman

Harry Roque announced that around 50 Filipino scientists will conduct the MSR.

In a March forum last year, Cesar Villanoy of the UP-MSI said there was a need for more scientific exploration to determine the economic potential of Philippine Rise.

Villanoy said the government should also develop a sustainable management framework for the development and protection of the area believed to be rich in marine resources, natural gas, oil and minerals.

He suggested a practical cooperation, possibly with other countries, for

technological capability since research expeditions in Philippine Rise require the use of modern equipment such as remotely-operated vehicles and Baited Remote Underwater Video Systems.

Villanoy said the MSR was a step towards creating a more comprehensive understanding of the area.

"This is just the beginning to know what is at the rise and understanding processes," Villanov said

Mario Aurelio, director of the UP National Institute of Geological Sciences, said the Filipinos had the expertise to conduct MSR in Philippine Rise. PNA

Phil Rise claim, 'perpetual legacy' for next generation — NAMRIA

"A perpetual legacy" bestowed by the present generation to all future Filipinos.

This was how the National Mapping and Resource Information Authority (NAMRIA) Deputy Administrator Efren Carandang described the successful validation of the country's claim to the Philippine Rise to the United Nations Commission on the Limits of the Continental Shelf (CLCS).

"(Philippine Rise recognition by the UN CLCS) will enrich the national patrimony, aside from demonstrating to the international community of nations the country's strong determination, capability and political will to assert its rights under international law," Carandang said.

The territory measures 13 million hectares.

He also called the validation of

the Philippine Rise claim as the country's first successful validation of a claim in accord with the 1982 Law of the Sea Convention (UNCLOS).

"It is a perpetual legacy that this generation has bestowed upon the future generations of Filipinos," the NAMRIA official added

The Philippine Rise, comprised of the 200-nautical-mile continental shelf from the baselines of Luzon, extends 118 nautical miles beyond the legal continental shelf limits.

Its main body is like a plateau with its broad crest and steep slopes toward the deep ocean floor of the West Philippine Basin.

Meanwhile, it is comprised of the NAMRIA-discovered Palanan Saddle and the Bicol Saddle.

It has also two prominent spurs: the Narra Spur in the northeast and the Molave Spur in the southeast.

On May 16, 2017, Duterte signed Executive Order 25 changing the name of the undersea feature to Philippine Rise.

"The Benham Rise Region is subject to sovereign rights and jurisdiction of the Philippines pursuant to relevant provisions of the 1987 Philippine Constitution, national legislation, and the UNCLOS and applicable international law," EO 25 stated.

In 2012, the United Nations, through recommendations of the CLCS, approved the Philippines' claim that the Philippine Rise is within the country's 200-nautical-mile exclusive economic zone.

The Philippines first sought recognition for its claims to the Philippine Rise on April 8, 2009.

Elections generally peaceful AFP, PNP

Except for seven confirmed violent incidents, the barangay and Sanggumang Kabataan (SK) elections across the country yesterday were generally peaceful, according to police and military officials.

Armed Forces of the Philtppines (AFP) chief Gen. Carilito Galvez Jr. said polling precincts from the farthest Turn to Page 12

villages, including those in Barangay Pag-asa on Kalayaan Island in the Spratlys, Turtle Island in the Sulu Sea and northern Batanes, simultaneously opened at 7:30 a.m. without any major incident.

"We have reports of 42 violent incidents but the Commission on Elections (Comelec) confirmed only seven. Of the seven cases, 13 were killed," Galvez said.

Philippine National Po-

lice (PNP) spokesman Chief Supt John Bulalacao said the National Election Monitoring Action Center (NEMAC) at Camp Crame in Quezon City received reports of isolated violent incidents before and during election day that left 35 persons dead and 27 hurt.

The PNP, however, recorded 47 violent cases and also validated seven, with 13 persons dead. Investigations were being

conducted on 40 cases, Bulalacao said "Intensified police operations through police response, check point, gun check and scrvice of search warrants, resulted in the arrest of 1,350 persons for various violations, including vote buying, liquor ban, illegal possession of firearms and explosives and bladed weapons," he said. Police also seized 1,157 firearms, 79 grenades, 350 explosives and 7,926 ammunition. Galvez said all of the 174,000 precurcts in the country opened for the first time between 7.30 a.m. and 11.30

a.m. with the help of Comelec, police and military officials.

About 30,000 soldiers and militiamen were deputized by the Comelec for election duty, especially in critical areas in the country, to support the PNP and ensure smooth and peaceful polls, he said.

Elections, however, were suspended in Marawi City while the opening of precincts in Lanao del Norte were delayed, he said.

Aside from the slaying of former representative Eufranio Eriguel and his two bodyguards in Agoo, La Union and the killing of four persons in Basilan two days before elections, political exercises were peaceful, he added.

33 killed

At least 33 people were killed in 42 incidents believed to have been triggered by intense political rivalry during the month-long election period for barangay and SK polls, the PNP said. Of the incidents, seven were validated

to be violent while 35 other cases were being investigated.

PNP chief Director General Oscar Albayalde is hoping that the number of violent incidents will no longer increase.

He directed all police units to beef up security in their respective localities. The PNP NEMAC reported that from April 14 to May 14, total dead comprised 18 elected government officials, four candidates three former officials, two supporters and six civilians.

35 KILLED, 27 WOUNDED IN 'PEACEFUL' ELECTIONS

Despite incidents of violence before and during the May 14 barangay and Sangguniang Kabataan elections, officials said voting was relatively peaceful.

As of Monday afternoon, the Philippine National Police had received reports of 47 violent incidents since the election period began on April 14. Thirty-five persons were killed and 27 wounded.

In Sultan Kudarat province, a reelectionist village chair in the coastal town of Palimbang was shot dead on Sunday.

Mustre Aguib, 51, of Barangay Mina, was driving his motorbike on his way home when gunmen flagged him down and shot him dead, according to Senior Insp. Carl Jayson Baynosa, police chief of Palimbang

In Opol town, Misamis Oriental province, the husband of a village chair candidate at Barangay Malanang was shot dead on Sunday night. Two suspects were arrested for the death of Eliezer Zafra, 41.

Dumagat candidate

In Donya Remedios Trinidad town, Bulacan province, a Dumagat woman, who was running for village councilor at Barangay Kabayunan, survived a gun attack

Emilità de la Merced, 45, was on a truck with 20 Dumagat people at about 10 p.m. on Sunday when two men on a motorcycle fired at her at Sitio Johnson.

On Monday, a businessman, whose son was a reelectionist barangay captain, was shot at Barangay Poblacion in Lapu-Lapu City, Gebu province, around 2:30 a.m. He was in critical condition.

SPO3 Candido Barinque identified the victim as Eduardo Godornez. He said Godornez was about to step out of his Toyora Fortuner when a gun-

man repeatedly fired shots at him, hitting him in the abdomen, shoulder and leg.

While residents cast their votes in Pio Duran town. Albay province, an alleged supporter of the opponent of the reelectionist barangay captain of Cuyaoyao was injured in a shooting incident.


Heated argument

While inside Cuyaoyao Elementary School, village chief Nilo Soria had a heated argument with his opponent, said Senior Insp. Darwin Sevilla, deputy chief of Pio Duran police.

Soria seized a handgun from his opponent's supporter Norly Madela, 53. He, then, used the gun to shoot Madela in the back when he noticed that the latter was about to get another firearm.

In Taguig City, voting at a polling place briefly stopped after a poll warcher was mauled allegedly by employees of the City Hall.

Voters and board of election inspectors ran out of Maharlika Elementary School on Mindanao Avenue at Barangay Ma-

harlika about 2:20 p.m., crying for help after a group of men started a fist fight at one of the precincts.

Minutes after police and military escorted out a man whose face was severely beaten up. Maharlika Village chair Baisittee Pangaudaman identified the victim as Ybrahim Ismael, one of his poll watchers.

Ismael's wife, Rajah Bai, was also hurt in the scuffle. Policemen later arrester four suspects.

Volunteers

In Isabela City Basilan province, Jograd Infanter and his daughter Roselle were manning a precinct as volunteers of the Parish Pastoral Council for Responsible Voting when supporters of a candidate slapped them.

The father and daughter

were accused of being biased for still unknown reasons.

At Barangay Campo Uno in Lamitan town, Basilan province, Raffy Ismael complained he was mauled by two men while he was queuing for his ballot.

Soldiers manning the precinct at Campo Uno had to fire warning shots as some voters and supporters started to become unruly.

At Barangay Lanote, also in Isabela City, supporters of some candidates were also involved in a melee.

In Jolo town, Sulu province, fist fights involving supporters of candidates took place in the Walled City and Chinese Pier, according to Brig. Gen. Cirilito Sobejana, the commander of the Joint Task Force Sulu.

Gun ban violation

In Sulop town, Davao dei Surprovince, police said they had arrested a man for violation of the gun ban on election day.

At Barangay Alegria in San Francisco town, Agusan del Sur province, a 33-year old man was also arrested for bringing a handgun.

Two explosions were heard

near Barangay Dungos in Tulunan town, North Cotabato province, on Monday.

"There was no reported casualty but the blasts caused panic among voters (in Dungos)," said Supt. Bernard Tayong.

Eight hours before balloting took place in Datu Unsay town, Maguindanao province, an explosion also took place outside its town hall.

Barangay, SK polls generally peaceful

Election victory won't spare candidates on drug watch list

he conduct of the 2018 Barangay and Sangguniang Kabataan (SK) Elections was generally peaceful based on the reports from the police and military a Palace official said Monday.

The military and police reports about this year's village and youth elections were sent to the Office of the President for regular updates, accord ing to Special Assistant to the President Christopher "Bong" Go.

"As of now namen mayroong mga illang insidente perogenerally peaceful naman po [As of now, there are a few incidents but the elections were generally peaceful)," he said in an interview with DZRH

He said the President had earlier directed the police and

military to "stay neutral" and keep peace and order during the Barangay and SK elections

Go, however, acknowledged that some cases of violence and allegations of vote-buying have marred the elections.

In Davao region, Go said the elections were also generally peaceful although there was a reported shooting of an incumbent chairman of Barangay Pangyan. Calinan. Davao City. He was referring to Antonio Guatno who was shot by authorities after allegedly resisting an implementation of a search warrant for illegal possession of firearms.

33 election period deaths

The Philippine National Police (PNP) said that at least 32 persons have been reported killed since the start of the election period last April 14 up to Monday's elections.

Citing data from the National Election Monitoring and Action Center (NEMAC), PNP chief Director General Oscar Albayalde said 18 of the victims were elected government officials, four were running candidates, three were former government officials, two were supporters, and six were civilians. The data were recorded from 6 a.m. of April 14 to May 14.

Albayalde noted that the 33 were victims of the 42 violent incidents recorded.

Aside from the 33 deaths, 26 persons were wounded while 24 others were left unharmed in the recorded violent incidents, he said. He, however, clarified, that the data were significantly lower compared to the 109 victims recorded in 57 violent incidents in the 2013 elections.

Vote-buying

Go said they also received reports of alleged vote-buying in some places.

He noted that vote-buying allegations hurled by rival political parties against each other cannot be avoided especially in bitterly contested polls. He, however, pointed out that poverty was not a valid reason for a person to sell his ballot during elections.

Go, who voted in his hometown. Instead encouraged the public to "go out and vote wisely," saying the future of their community is at stake. He said barangay leaders provide the frontline services to the constituents especially in times of disasters and other emergencies.

Suspected vote-buying in Calamba, Laguna, as well as in Lucens and Calauag. Quezon. There were also cases of arrest for illegal possession of unlawful election paraphernalia in Lucena.

Among the arrests for alleged vote-buying incidents include one Corazon Del Rosario, 63, a barangay health worker.

She was accosted by policemen after allegedly giving money to one Antonio Latumbo, a registered voter, in Barangay Milagrosa, Calamba, as reported by city Councilor Saturnino Lajara and electrician Loreto

Police said they found two P500 bills individually placed inside a small brown envelope. She will be charged with violation of Omnibus Election Code Section 261 (a) for vote-buying, police said.

The Commission on Elections (Comelec) admitted receiving many reports of alleged vote-buying but it only verified a few cases.

"As far as we are concerned, what we need are the verified reports, but as far as verified reports, dalawa or tatlo palang na lugar ang meron (only two to three reports were verified)," said Comelec spokesman James Jimenez.

No immunity for winners

As this developed, Albayaide likewise warned winners in Monday's electoral exercise who are on the government's drug watch list that their victory will not spare them from investigation and punishment should they be proven to be involved in illegal drugs or any unlawful activity.

"What we can do is to further validate the allegations against them and conduct a case build up if they are really in the [drugs watch list]." Albayalde said.

"If there is basis, then we can file a case or apply for a search warrant. It [winning from the elections] is not an excuse. Winning does not absolve them from their involvement in illegal drugs," he said.

Last month, PDEA released a "validated" drug watch list which includes the names of at least 216 village officials. The PDEA said the information was based on military and police intelligence information.

But Albayalde clarified that until the allegations are proven, the winning candidates on the drugs watch list will have to perform their duties as duly elected village officials.

"The [Commission on Election] will proclaim the winners. The PNP's part is for intelligence and case buildup only if they are really involved. Remember, these are mere allegations [being included in drugs watch list] and it is also not a reason for them to be deprived of exercising their powers once they get elected," he said.

Albayaide assured the winning officials on the drug watch list that they will be accorded due process while investigation is being conducted.

"It's a watch list, not a warrant of arrest," he said

The PNP had previously advised the public not to vote candidates whom they know are involved in illegal drugs.

"You know who they are because it is your barangay, so do not vote for them or else you will suffer the consequences," said then PNP chief. Director General Ronald dela Rosa

Intelligence monitoring

The PNP chief also warned that policemen who abandoned their duties or intervened in favor of relative-candidates will face sanc-

Albayalde vowed to run after policemen who either did not show up or abandoned polling precincts which they were

assigned.

"This is the reason why we created the Red Teams. They were instructed to account discreetly if the policemen assigned to man polling precincts were really there," said Albayalde.

The Red Teams, he said, were complemented with counter-intelligence operatives in the provinces and in the regions," he added.

Aside from the reports of the Red Teams, he said they are also monitoring if the 2,875 policemen whose relatives are running for any barangay posts have intervened.

Those policemen were reassigned to oth er places long before the barangay elections so as not to influence the barangay polis.

"We will investigate if any of them intervened but as of this time there is none," said Albavalde

"If we would find out that they intervened even if they were already reassigned, they will be charged accordingly," he added.

Police as BEIs

Meanwhile, Albayalde said there were areas particularly in Mindanao, where policemen acted as Board of Election Inspectors (BEIs) because the teachers who were supposed to be BEIs pulled out from the duty out of fear.

He said 872 cops deployed in Maguindanao, Sulu, Basilan and Lanao de! Sur have acted as BEIs, and more than 100 were on reserve status.

"Remember, before they were tasked to be BEIs the Comelec has given them a one-day seminar. Those men are territorial police, they were trained and they are prepared for that duty," he assured

But the Department of Education (DepEd) reported that the conduct of the 2018 Barangay and Sangguniang Kabataan Elections was "generally peaceful" as far as public school teachers who fulfilled their poll duties are concerneo.

In a press briefing at the Election Taskforce Operation (ETF) and Monitoring Center currently set up in the Bulwagan ng Karunungan of DepEd Central Office

in Pasig City, key officials said the opening of pollearlier was "generally peaceful" with "no reports o violence to schoolteachers who serve as volunteer: for the elections."

The military likewise reported that the conduc of elections in Northern Luzon was also generally

peaceful.

Northern Luzon Command spokesman and con current Public Information Office (PIO) chief Lt. Massive vote buying mar Monday polls

SHOOTING incident involving a barangay (village) chairman in Albay, massive vote buying and confusion in the voters' list were the most common complaints in various parts of the country even as the Commission on Elections (Comelec) declared the Barangay and Sangguniang Kabataan (SK) polls on Monday generally peaceful.

Maria Luisa Calubaquib, Philippine National Police (PNP)-Bicol spokesman, said re-electionist village chairman Nilo Soria, 55, of Barangay Cuyaoyao, Piodutan town is now in police custody after he shot Norly Madela during an altercation.

Early on Monday, Sona reportedly confronted a certain "Ambo" but Madela, 53, of Barangay Nablang Bulod in Pioduran intervened and punched him in the face. A commotion ensued and when Madela tried to pull out a firearm Sona quickly drew his gun and fired at him.

Although both were wounded, Soria and Madela were detained at Libon police station.

Meanwhile, Comeler-Bicol regional director Jean Valeza said vote buying was reported in the provinces of Albay and Catanduanes with voters being given from P300 to P500 each.

In Laguna, Cotazon del Rosario, 63, a village health officer was charged with violation of the Omnibus Election Code for alleged vote-buying in Purok 5, Barangay Milagrosa, Calamba City.

Chief Supt Guillermo Eleazar, PNP-Calabarzon chief, said Del Rosario was arrested after Calamba City Councilor Saturnino Lajara and Loreta Gareza reported they saw the suspect in the act of giving money to Antonio Latumbo.

Police recovered from Del Rosatio two small envelopes with P500 bills each.

Calabarzon is comprised of the provinces of Cavite, Laguna, Batangas, Rizal and Quezon. In Quezon province, Christian Maraña, chairman of Barangay Poblacion 2 in Calauag escaped before police could arrest him after complaints of vote-buying.

Witnesses Franklin Maravilla and Franklin Fulgar reported that Maraña went to their house and gave them two small envelopes containing P200 each with a sample ballot indicating Maraña's name and his seven councilmen

In Lucena City, police arrested Peptio Carbonnel in Purok IV, Dulong Buhangin, Barangay Dalahican, as well as his companions – Virginia Sta Ana. Dory Repollo, Romeo Bersabe, Arsenio Lagrason, Fernando Casiño and Wilma Anthony.

'Successful, peaceful'

The Comelec declared that the synchronized barangay and SK elections were successful and generally peaceful, with all precincts nationwide able to open for voting.

"Remember, the Comelec has trained 1,000 police officers per region as election officers as a contingency measure." Albayalde added.

The military spokesman, Arevalo, said 19,444 military personnel were deployed to secure the polls, or 15 percent of the total number of enlisted personnel, aside from reserve and auxiliary forces.

The Department of Education, for its part, said 87 percent of cash allowance cards were delivered to the teachers serving as members of barangay board of tellers

There were 78,004,600 registered voters, both for barangay and SK, in this year's elections. Of that number, 57,378,380 were registered for the barangay level, while 78,004,600 were registered for the SK level.

More than 36,000 classrooms or schools nationwide served as voting centers.

There were 336,328 contested positions in the barangay elections. Of that number, 12,041 were for barangay chairmen, while 294,287 were for barangay kagawad (village councilors).

The SK elections had the same number of contested posts.

Voters recite litany of problems; Comelec claims success

HIRTY-FIVE people have been killed and 27 others were wounded in 47 separate election-related incidents, police said Monday. In a press conference in Camp Crame as polis opened for the barangay and Sangguniang Kabataan elections, Philippine National Police chief Oscar Albayalde said since the start of the election period on April 14, 18 elected government officials, six civilians, four candidates, three former elected officials and two supponers of poll bets have been killed.

Albayalde said, however, that only 13 of these deaths have been validated so far as being election-related.

During the same period, police reported 47 suspected election-related incidents.

Of the 126 suspects in the incidents, 29 were

identified, 82 were unidentified, six were arrested and nine were released from detention.

Among the cases under investigation were the shootings involving Daanbantayan Mayor Viceme Loot in Cebu, who survived an ambush, and former La Union Rep. Eufranio Eriguel of La Union, who was killed.

Albayalde said that 181,212 personnel assumed election duty as the entire PNP went or nationwide full alert.

"As 36,781 polling centers across the country opened at 7 a.m. today, 73,562 PNP personnel manned their respective posts to provide

security to these voting centers," the PNP chief said.

He said on alert at the Police Regional Officers were 13,267 troops comprising the Reactionary Standby Support Force and 2,854 RSSF at the National Headquarters.

The 89,529 personnel comprising the Quick Reaction Teams were also placed on the highest alert condition and readiness to respond to any contingency, he noted.

Albayalde added that the deployment of PNP personnel was backed by troops from the Armed Forces of the Philippines

Commission on Elections acting chairman Al Parreño said the elections were successful, though marred by the usual problems of vote buying, threats, and missing poll precincts.

Parreño said that 177,574 clustered precincts or 100 percent were open Monday for voters to cast their votes.

"We are able to open all precincts, 100 percent All 177,574 precincts were able to successfully open and they were able to start their elections," said Parreño.

In a press conference, Parreño acknowledged that polling precincts in provinces such as Manalay, Mindoro, Tagoloan, Lanao del Norte, Turfie Island, Tawi-Tawi, Bacolod-Kalawi, Masiu, and Binidayan, Lanao del Sur were able to open a little later than 7 a.m.

Comelec spokesman James Jimenez said, however, that this was not considered a failure of election.

Comelec Commissioner Rowena Guanzon, meanwhile, urged members of the media to act as witnesses if they recorded any poll irregularities.

"Those reporting on such matters can even stand as witnesses... those who captured them on video," she said.

Albayalde said the PNP received fewer election-related violence reports than in the 2013 barangay elections.

In Lanao del Norte, Mayor Jabar Tago, his two brothers and five others were arrested Sunday for illegal possession of firearms, one day ahead of the elections.

Weapons seized included a sniper rifle, an AK-47, an M16 and a grenade launcher, Col. Robert Dauz, commander of the Army's 2nd Mechanized Brigade, said.

Also on Monday, the Comelec said qualified teachers who served during the polls would be able to get the 5-percent tax deducted from their honoraria and allowances.

Based on Comelec Resolution No. 10332, public school teachers will be able to process the refund of their taxes withheld as provided for by the Tax Reform for Acceleration and Inclusion (TRAIN) law.

"Those serving in the Electoral Boards, DESOs, and support staff, who are exempted from withholding tax on compensation, shall be able to execute the prescribed Sworn Declaration, and to submit the same to the Commission on Elections for the processing and refund of the tax previously withheld," the poll body said.

It noted that the refund was included in the provision of the TRAIN law, wherein those with an annual taxable income of P250,000 are exempted from income tax payment.

Covered by the provision are those serving in the elections, whose net taxable compensation for the year will not exceed P250,000, will now be deemed as "tax-exempt poll-workers."

"Only those persons, who rendered election services and submitted the required sworn declaration, are entitled to the tax refund under this resolution," the poll body said. With PNA



Church assails Chinese moves

The Church, meanwhile, again went overboard in a pastoral letter authored by Lingayen-Dagupan Archbishop Socrates Villegas which was read in Sunday masses as it slammed the expansion activities of China while berating "quietly tolerant" officials.

The Church enjoined voters to choose leaders that will "defend the Philippines' territorial sovereignty."

Villegas said China's expansionism is only a few miles away from Pangasinan and that the province is now getting Chinese radio programs.

"Our barangay leaders who are quietly tolerant are harming our nation," the pastoral letter read.

"The principle of solidarity also mandates us to demand from our government to preserve our territorial sovereignty," the Church said.

The letter also urged voters to choose village officials that will fight "crimes against the poor."

"We must fight the crimes against the poor like the killing of the poor in the name of the drug war and the unabated rise in basic food commodities," it added.

"When they offer you money, they are putting a price tag on you. Get mad!" the Church said.

The letter also appealed for elected officials to "respect the non-partisan nature of our barangays and to desist from using our barangay leaders as political wards."

RP position pathetic - Leila

Detained Sen. Leila de Lima, meanwhile, scoffed at the government's alleged inaction and indecisiveness on the issue of China's domination of the Spratlys which was further highlighted when Vietnam issued a strong statement against it

"In the face of Vietnam's impressive statement that the deployment of Chinese missiles is a direct threat to its national security and sovereignty, the Philippine position comes across as nothing short of a pathetic and shameful excuse for Malacañang's lack of response," she said.

It betrays, the senator said, the complete absence of a comprehensive foreign and defense policy vis-a-vis China, except one of simple mendicancy, appearement and collaboration.

"While the Philippines adopts the anemic position that it is still verifying the presence of Chinese missiles in the Spratly Islands, a fact that China has already admitted, Vietnam categorically demands China to withdraw its missiles from day one," she pointed out.

De Lima also added that no less than President Duterte himself even proclaimed that China is the protector of the Philippines.

"He added that the Philippines will stay 'neutral' in the regional power play between the US and China, forgetting that the Spratly Islands threatened by China are Philippine-occupied areas, not US territory," she said.

The senator also did not let come to pass the pronouncements made by Palace SpokesmanHarry Roque who even claimed that if ever there are Chinese missiles in the Spratlys, these are not directed at the Philippines "because China is already our friend."

"He, however, does not explain how China can be a friend while it installs missiles less than 300 kilometers from our shores," she further pointed out.

De Lima also compared Vietnam's response, which she claimed as impressive, as it asked China to withdraw its military equipment in the South China Sea saying that its deployment is a direct threat to its national security and sovereignty.

Compared to Vietnam's strong statement. De Lima said Malacañang's inaction and indecisiveness on the issue of China's domination of the Spratlys, also shows how far the government has regressed in the defense of the country's territorial claims.

"It reflects a broken down foreign and defense policy that amounts to nothing more than the present government's absolute and total abdication of its West Philippine Sea interests," she said.

Spike-ER MX to help secure PH territories

ONCE installed and fully operational, the Israeli-made Spike-ER surface-to surface missiles will be useful in protecting the country's vast maritime territories and scalanes of communications.

This was disclosed by Philippine Navy flag-officerin-command Vice Admiral Robert Empedrad in an interview Sunday

The weapons, are now undergoing integration on three of the Navy's multi-purpose attack craft, will greatly deter shipborne intruders trying to violate the country's waters.

"The [Spike-ER] missiles are very accurate and I'm sure [that once it is up and running] it can threaten intruders aside from securing the choke points [of our] sealanes of our maritime nation," Empediad added.

The Spike-ER missiles along with its launchers arrived on the third week of April.

It is the first missile system to be acquired by the PN

These missiles are capable of penetrating 1,000 mm (29 mches) of rolled homogeneous armor and has a range of eight kilometers.

As of this posting, the Navy has nine MPACs in inventory with another three units planned.

Three of the above-mentioned craft are now being fitted with the Spike-ER missiles and its launchers.

These naval craft were activated on May 22, 2017 and were manufactured by Subicbased Propmech Corp. for P270 million PNA

2 soldiers killed; gun ban violators nabbed

POLICE and military officials yesterday said the barangay and Sangguniang Kabataan elections were generally peaceful except for the arrest of scores of people for election-related offenses, including carrying of firearms and violation of the liquor ban.

Two soldiers on election duty, however, were killed in an ambush staged by New People's Army rebels in Camarines Sur, according

to AFP chief Gen. Carlito Galvez.

"We have an incident where our troops going to an election precinct to secure it were ambushed by the NPA. We have two dead," Galvez said.

Capt. Joash Pramis, spokesman of the Army's 9th Infantry Division, said the ambush occurred around 8:30 a.m. yesterday Barangay Salvacion in Ragay town. Pramis said one of the two slain soldiers held the rank of second lieutenant.

Southern Police District spokeswoman Supt. Jenny Tecson said 69 people were nabbed for carrying deadly weapons, 29 for carrying firearms, 28 for violating the liquor ban, three for carrying explosives, and two for carrying explosives.

A 62-year-old candidate for barangar councilor in Quiapo, Manila died of heart attack shortly before the elections. Hertaine Francisco, chairman of Barangay 390, said Peline Baligod Jr. died at around 6:22 a.m.

Manila Police District chief Joel Napoleon Coronel said Baligod was rushed to a nearby hospital but was declared dead on arrival.

There were several incidents of altercations between poll watchers and candidates but cops deployed in voting centers

Albavalde said the PNP fielded 181,212 police officers nationwide, with 73,562 manning 36,781 polling centers; 13,267 making up the Reactionary Standby Support Forces and 2,854 from the National Headquarters on standby. The PNP went on full alert status at 6 p.m. Sunday.

Albayalde also said a total of 2,875 police officers were temporarily reassigned outside of their mother units since they have relatives running for posts.

NORMAL, PEACEFUL

"Based on our assessment, it's very normal and peaceful," Galvez told a press briefing in

Camp Aguinaldo.

Galvez said more than 174,000 precincts nationwide opened and it's a very good report, encouraging report," crediting the feat to security measures adopted by the APP, PNP and the Commission on Elections.

Galvez said the military deployed 30,000 soldies and Cafgus throughout the country to help

Solon hopeful peace talks will lead to Caser signing

"The Comprehensive Agreement on Social and Economic Reforms [Caser] is a make or break stage of the negotiations as the issues being discussed like the prevalence of landlessness, the lack of national industrialization and extreme economic exploitation of majority of Filipinos are among the main reasons of the almost five-decade-old armed conflict," Bayan Muna Partylist Rep. Carlos Zarate said.

"Hopefully, it can be signed this year so that the panels can move on the remaining agenda of the talks," he added.

Zarate, chairman of the House committee on peace, unity and reconciliation, made the remarks after Labor Secretary Silvestre Bello III, who also serves as government peace panel chairman, said formal peace talks between the government and the communist National Democratic Front were expected to resume early next month following an interim peace agreement by both parties.

"More than the bilateral ceasefire, the signing of the CASER and its thorough implementation, which would pave the way for giving lands to landless peasants and industrialize our lagging nation, would be a safeguard against armed hostilities,"

Zarate said.

Zarate said it would be best, too, that the talks be conducted still in a neutral venue to ensure that no undue pressure or interference could be exerted on either party; and the negotiations could go as smoothly and unhampered as possible.

"We laud and thank the Royal Norwegian Government for the perseverance and the continuing facilitation of the negotiations," Zarate said.

Firefights erupt as gov't troops pursue bandits holding hostages; 20 others wounded

ZAMBOANGA CITY—At least 14, three of them soldiers, were killed when government security forces on a mission to rescue about a dozen people held by the Abu Sayyaf in Sulu province clashed with the bandit group on Sunday and Monday, a military commander said.


Brig. Gen. Cirilito Sobejana, commander of the Joint Task Force (JTF) Sulu, said to Abu Sayyaf bandits were killed while 15 others—12 soldiers and three bandits—were wounded in the clash that erupted at Barangay Tanum in Patikul town on Sunday.

He said soldiers were conducting an operation at Sitio Kan Alas when they clashed with the bandits at 6:15 a.m.

'Foreign-looking'

On Monday, a bandit was also killed during a clash at Sitio Bud Kaha in Barangay Maligay at noon.

But in a press briefing at Camp Aguinaldo, Armed Porces chief of staff, Gen. Carlito



Galvez, said three bandits, including a "foreign-looking" man, were killed in the encounter.

"Our troops were continuously doing security, search and rescue [to ensure the] freedom of the kidnap victims, resulting in an encounter with an undetermined number of Abu Sayyaf members," Sobejana said.

One soldier was killed while five more were wounded during Monday's clash, he added.

Among those being res-

cued were PO3 Bennie Rose Alvarez and PO1 Dinah Gumahad, who were assigned in the Western Mindanao police office here. They were being held since April 29.

Sobejana said Abu Sayyaf subleaders Hatib Hajan Sawad-jaan, Idang Susukan, Injam Yadah and Ben Tattoh were with the group that engaged the soldiers in the gunfight on Sunday that lasted for about an hour.

Four of the slain bandits

were identified as Amah Talah, Taha Sawadjaan (younger brother of Hatib Hajan Sawadjaan), Long Abraham and one known only as Red.

Sobejana said soldiers recovered a baby Armalite, buliets, bomb components, mobile phones and batteries from the clash site.

Shallow grave

Shortly before Monday's clash, soldiers pursuing the bandits discovered a shallow grave where three men, believed to be Abu Sayyaf members slain on Sunday, were buried.

"We will sustain our efforts until the last kidnap victim is rescued and the Abu is neutralized," Sobejana said.

On May 7, a clash also erupted in Patikul while soldiers were searching for the two police officers and other victims held by the Abu Sayyaf.

Seven soldiers were wounded while three bandits were killed in that clash. —with a report from teannette t. Andrade INQ

Sobejana identified the wounded ASG members as Ben Quirino, alias Ben Tattoo, and Adzren Sawadjaan

Other ASG leaders who were identified as present during the encounter were Jajan Sawadjaan, Idang Susukan and Injam Yadah.

Unfortunately, the fierce clash resulted in the death of two government soldiers while 12 troops were injured. Their names are still being withheld by the authorities.

Sobejana said the bodies were already transported to Zamboanga

through the Philippine Air Force (PAF) planes and helicopters while the wounded were brought to hospitals for treatment.

Sobejana said soldiers of the 5th Scout Ranger Battalion under Lieutenant Colonel Marlou Jomalesa were on rescue operations for kidnapfor-ransom victims of the ASG when they encountered the terrorist group believed to be under ASG sub-leaders Hajan Sawadjaan, Injam Yadah and Ben Quirino at Sitio Kan Alas. Brgy Tanum, Patikul, Sulu, at about 6:15 a.m.

Sobejana said soldiers are still pursuing the fleeing bandits believed to have with them an undetermined number of kidnap victims.

"We delivered artillery and mortar fire to pin-pointed enemy locations.

Our actions are, however, very limited and calculated since we do not want to harm the kidnap victims," he added

Sobejana said the bodies of the soldiers killed in action were brought to the headquarters of Joint Task Force Sulu and immediately airlifted to Zamboanga prior to sending them to their respective next-of-kin

"We are sad to report that two of our soldiers gave the ultimate sacrifice today in an attempt to rescue the remaining KVs," said Maj. Gen. Arnel Delavega, the General Officer in Charge of the AFP's Western Mindanao Command

"The Chief of Staff Armed Forces of the Philippines, General Carlito G Galvez, Jr. has already given instructions to extend all the necessary assistance to the family of our heroes, and to ensure that a heroes burial be accorded to them." he said.

2 soldiers, 10 Abu Sayyaf members killed in Sulu clash

WO soldiers and 10 members of the Abu Sayyaf Group (ASG) were killed while rescuing kidnap victims on Sunday in Patikul, Sulu, according to the military.

Brig Gen. Cirilito Sobejana, commander of Joint Task Force Sulu, said on Monday, the encounter between the Philippine Army's 5th Scout Ranger Battalion and the ASC members happened

at 6:15 a.m. on Sunday at Sitio (sub-village) Kan Alas, Barangay Tanum, Patikul

The Army troopers were on their way to rescue Police Officer (PO) 2 Benierose Alvarez and PO1 Dinah Gumahad who were abducted in April, along with civilians Faizal Ahidji and Jacosalem Bas Amahad.

Military forces rescued Amahad last week. Sobejana said the terrorists were under the supervision of Abu Sayyaf sub-leaders Hajan Sawadjaan, Idang Susukan, Injam Yadah and Ben Tattoh

The encounter lasted for about an hour, resulting in the deaths of 10 ASC members and the wounding of two others, according to Sobejana

Four of the 10 Abu Sayyaf fatalities were identified as Amah Talah; Taha Sawdjaan, younger brother of Hatib and second of command in the ASG leadership; a certain Red; and Long Abraham.

The two wounded terrorists were identified as Ben Quirino alias Ben Tattoo and Adzren Sawadjaan. 1,2

Sobejana said that the clashes also led to the killings of two soldiers and injuries to 12 troopers.

Foreigner, 2 ASG cadavers found

THE military recovered three cadavers from the Abu Sayyaf Group (ASG) before an encounter on Monday with the terrorists in Patikul, Sulu, according to Armed Forces chief Gen. Carlito Galvez Jr.

Galvez said in a media conference in Camp Aguinaldo, Quezon City that he was told by the Joint Task Force Sulu of the encounter in Patikul wherein they were able to recover the ASG cadavers, two of whom he identified.

One is believed to be the son of ASG sub-leader Hajan Sawadjaan and one a "foteign-looking" terrorist, Galvez said.

"The report [on their identities] is still in the process of validation," Galvheez added, citing the report sent by JTF Sulu chief Brig. Gen. Cirilito Sobejana.

Galvez said the encounter followed the clashes on Sunday morning, wherein two Scour Rangers and 10 Abu Sayyaf members were killed village of Tanum in Patikul

He explained that the clashes in the past two days were part of the military's efforts in rescuing the two policewomen abducted along with two civilians late last month.

They are Police Officer (PO) 2 Benierose Alvarez and PO1 Dinah Gumahad while the civilians are Faizal Ahidji and Jacosalem Bas Amahad.

Last week, authorities rescued Amahad after Ahudji was released by the bandits.

But Sobejana explained that the bodies of the three Abu Sayyaf men were retrieved before the encounter on Monday.

In a separate report, he confirmed that another clash happened at 11:45 a.m. in Barangay Maligay also in Patikul.

11 Sayyaf bandits, 3 soldiers killed in Sulu

ELEVEN Abu Sayyaf members and three government soldiers were killed and 17 other soldiers were wounded in clashes in Patikul town in Sulu on Sunday and Monday

Brig. Gen. Cirilito Sobejana, commander of the military's Joint Task Force Sulu, said the troops assaulted a lair of the Abu Sayyaf in Sitio Kan Alas in Barangay Tanum where the bandirs were said to be keeping several kidnap victims.

Sobejana said the kidnap victims kept in the lair included the two policewomen, PO2 Benicrose Alvarez and PO1 Dinah Gumahad, who were abducted by the group on April 29, along with two companions who are now free.

Sobejana said forces of the Army's 5th Scout Ranger Battalion attacked the ASG lair around 6.15. a.m., leading to a one-hour firefight with the bandies led by sub-leaders Hajan Sawadjaan, Idang Susukan, Injam Yadah and Ben Tattoh.

Sobejana said the fighting was so intense that he ordered support from 105 onn and 155 mm arallery assets and MG-520 attack

helicopters.

Sobejana said the lair used to be a camp for Marine soldiers but this was abandoned a few years ago "as part of our assessment because we believe we no longer need it." He said the bandits then occupied the camp.

"It (firefight) resulted to 10 ASG members killed but only four were positively identified," said Sobejana. He said reports about the death of the 10 Abu Sayyaf men were based on information provided by "reliable sources."

The Army general named

four of the 10 slain Abu Sayyaf members as Taha Sawadjaan, a brother of Abu Sayyaf's No. 2 man Hatib Sawadjaan; Amah Talah; one Long Abraham; and one alias Red.

Sobejana said they received reports that many other Abu Sayyaf men were wounded in the firefight, including Ben Quirino alias Ben Tattoo; and Adzren Sawadiaan.

Sobejana said two soldiers were injured in the clash and 12 others were wounded.

During pursuit operation yesterday, Sobejana said Scout Ranger soldiers clashed with the fleeing bandits in Barangay Maligay, also in Patikul town, at around 11:45 a.m. Sobejana said the clash was still ongoing as of 4:30 p.m. yesterday.

Sobejana said yesterday's fighting resulted in the death of one soldier and wounding of five others and recovery of two highpowered firearms and supplies. On the Aim Sayyaf side, he said one was confirmed killed.

Before the encounter, Sobejana said soldiers exhumed three bodies of Abu Sayyaf men about a kilorneter away from last Sunday's encounter site. He said they believe the three are part of those

killed in the Sunday clash.

"Prior to the encounter, the troops discovered three hastily-buried cadavers believed to be the ASG fatalities in Sunday's encounter. We are now in the process of checking the identity of those cadavers," said Sobejana.

"They look like foreigners. We are still establishing their identities...We want to make sure (if they are really foreigners)," said Sobejana.

The Abu Sayyaf has known links with foreign terrorists, including those from the Islamic State of Iraq and Syria.

Intense Sulu clash leaves 2 troops, 10 Abus dead

Two soldiers and 10 Abu Sayyaf terrorists were killed while 12 other government troops were wounded during an intense clash in the outskirts of Sulu province where the military is conducting rescue operation for the remaining hostages on Sunday.

Brig. Gen. Cirilito Sobejana, commander of Joint Task Force Sulu, yesterday said that the encountered Abu Sayyaf band was led by subleaders Hajan Sawadjaan, Injam Yadah and Ben Quirino, alias Ben Tattoh.

Sobejana said that elements of the 5th Scout Ranger Battalion, under Lt. Col. Marlou Jomalesa, were on search and rescue operations along Sitio Kan Alas, Barangay Tanum in Patikul town at around 6:15 a.m. when the clash erupted.

The firefight reportedly lasted for about an hour, resulting in two soldiers dead and an estimated 10 unidentified Abu Sayyaf members killed.

Out of the 10 slain terrorists, four were identified as Amah Talah, Taha Sawadjaan — younger brother of Hatib Sawadjaan who is now second in command of the ASG leadership; Long Abraham and a certain "Red."

Recovered from the scene were an M653 Baby Armalite rifle, several

rounds of ammunition, explosive components including canisters of ammonium nitrate, cellular phones, batteries and electronic mechanism.

Twelve soldiers were also wounded while undetermined number of terrorists were also believed to have been hurt:

The JTF-Sulu commander said that there were indicators that there were hostages with the encountered Abu Sayyaf band.

Sobejana said the artillery and close air support were provided to the Rangers.

"We delivered artiller," and mortar fires to pin-pointed enemy locations," said Sobejana.

"Our actions are however very limited and calculated since we do not want to harm the kidnap victims," he added.

As of press time yesterday, Sobejana said that government troops are still conducting clearing and pursuit operations against the fleeing terrorists.

"We will sustain our efforts until the last kidnap victim is rescued and the ASG is neutralized," vowed Sobejana

Currently, the Abu Sayyaf group is still holding 12 hostages, including PO3 Benierose Alvarez and PO1 Dinah Gumahad who were abducted last April 29, in Sulu.







DUTERTE VOWS ANEW TO RETIRE AFTER COUNTRY SHIFTS TO FEDERAL SYSTEM

President Duterte has declared again that he would step down once the country completes the shift to a federal system of government.

"I'm still good until 2022 But once there's already a federal setup I will step down I will give it to [you] Choose your leader, I'm ready to retire," he said.

Mr. Duterte made the remarks in a speech on Friday in Marawi City, where he accepted firearms surrendered by former members of the Maute terror group and distributed aid to them.

Millitary and local officials presented 27 Maute surrenderees to the President.

It was not the first time Mr. Duterte had offered to cut short his six-year term and give way to a new leader if a federal form of government was put in place before 2022.

Having been elected in May 2016, the President has a constitutional mandate to serve until June 2022.

Transitory position

In February, he renewed his offer to step down from office, saying he did not want to take on a transitory position.

On Friday, Mr. Duterte again said he would resign once his administration had completed the shift to a federal form of government, or if the proposed Bangsamoro Basic Law (BBL) pushed through

"If the BBL or federalism is

completed by 2022, if it's in place and requires new elections, I will step down." he said.

He would renew talks with Moro National Liberation Front founding chair Nur Misuari once the proposed BBL is passed, he said.

Misuari had voiced opposition to the BBL, saying it only served certain More groups

Congressional leaders had earlier promised the President during a meeting in Malacanang that they would pass the BBL by May 30.

"I want us to look for a formula. Let's talk about this. I'm just waiting for the BBL. And once it is passed. I will start talking with Misuari," Mr. Duterte said.—JULIEM. AURELIO INQ.

The Senate will also continue deliberations on the proposals for Cha-cha and federalism at the Senate Committee on Constitutional Amendments, Revision of Codes, and Laws

Incessant intrusions

Il this time, the two polar positions of war or appeasement have been the only options on the China-Spratlys question that the Duterte administration seems capable of processing and presenting to the Filipino people.

As late as March this year—in a speech where he tried to justify the idea of "joint exploration" and "co-ownership" with China of resources in

the West Philippine Sea, a plan that concerned observers have described as fundamentally unconstitutional—President Duterte reiterated his oft-repeated line that he would not send Filipino soldiers to confront Chinese intrusions in the area, to avoid the prospect of a "massacre." Chinese President Xi Jinping had supposedly warned him that "there would be trouble" if the Philippines began drilling for oil in the Spratly Islands.

Thus, in the face of one Chinese provocation after another, each more outrageous than the last. Malacanang's default response has been an anemic statement of concern designed more, it appears, to soothe Beijing than to level up with the public at home.

On news that China had violated its own promise to the international community not to militarize the area when it built hangars, control towers and a runway on Panganiban (Mischief) Reef, which is within the Philippines' exclusive economic zone, Mr. Düterte's spokesperson Harry Roque basically threw up his hands: "I think whether or not we like it, they intended to use them as military bases. So, what do you want us to say?" He would follow that up with an even more staggering statement: "There will come a time when China's might has ceased, when we will have to thank them for those islands."

Naturally emboldened, Beijing ramped up its takeover by next landing military planes on Panganiban Reef. Roque's response? "[The] secretary of foreign affairs has said that we are preparing and exploring the possibility of a diplomatic protest. We'll leave it at that." And apparently they did, because nothing more was heard of the planned diplomatic protest.

Less than a month later came the explosive CNBC report that China has installed antiship cruise missiles and surface-to-air missiles on Panganiban Reef, Kagitingan (Fiery Cross) Reef and Zamora (Subi) Reef. The report came with satellite images, and the Chinese Foreign Ministry subsequently confirmed the news by saying that "the relevant deployment targets no one." Foreign Secretary Alan Cayetano's response, however, was the height of nonchalance "We're verifying the information."

Vietnam, for one, was having none of that empty, noncommittal stance: It publicly reminded China to "show its responsibility in maintaining peace, stability in the East Sea," and asked that it withdraw its missiles. There was no mention or threat of war, but Vietnam's firm statement, while it may receive only a shring from Beijing, at the very least brings the issue to the consciousness of the international community. Vietnam's statement also puts China on notice that it cannot simply get away with its incessant muscle-flexing and double-talk.

Manila's dilly-dallying, meanwhile, could only make the likes of Sen. Panfilo Lacson apprehensive: "If up to now, the government still has not confirmed the presence of a foreign count 's missiles in one of our islands, we may have as I-ous national security problem," he said in a statement that called for a Senate investigation into the matter.

China is not letting up; it has reportedly landed a plane again in the area, this time on Zamora Reef. Zamora is a mere 12 nautical miles away from Pagasa Island, which is inhabited by a small Filipino community. It's the first confirmed landing of a Chinese military aircraft on the reef, according to the Asia Maritime Transparency Initiative of the think tank Genter for Strategic and International Studies in Washington.

It's time everyone took note that China's intrusions are getting deeper and deeper into Philippine territory. Why isn't Malacañang livid at this incessant provocation?

Jardeleza: 'Unpleasant history' immaterial to auo warranto case

Jardeleza, I.:

(Excerpts from opinion)

RESPONDENT Chief Justice Maria Lourdes P.A. Sereno (respondent) in her Ad Caurelam Respectful Motion/or Inhibition (Motion) seeks to prevent me from participating in this special civil action for quo warranto. She invokes the New Code of judicial Conduct, which entoins judges to disqualify themselves from participating in a matter in which it may appear, to a reasonable observer that they are unable to decide a matter impactially, and where the judge has actual bias or prejudice concerning a party. She further invokes the due process clause of the Constitution.

Determining whether a sitting justice of the Supreme Court should recuse in a case is an exercise fraught with constitutional difficulty. This is due in no small measure to the absence of a clear litmus test by which a just's partiality is measured. Walking the tightrope between a judge's duty

to decide and inhibition being a matter of conscience, the Court has . made largely ad-hoc decisions that turn on the factual subtleties of each case. This has prevented the development of a bright line rule on inhibition. In the Philippines, this tightrope walk between judicial accountability and judicial independence is made more problematic by the very paucity of formal mechanisms that institutionalize the reconciliation of these two concepts. This gap in the law is complicated by the history, practice and tradition of the Court respecting recusal from within its ranks: the individual justices of the Court decide for themselves whether to inhibit from a case, and whether to explain their decision or remain silent, Finally, because the Court itself abides by the Justice's judgment, and because there is no appeal a Justice's decision on the matter of his recusal is final

The Motion cites three charges that allegedly evidence my bias or prejudice against respondent namely that: (1) I have stated that she committed treason; (2) I described her actions during my nomination to the Court as "inhumane" and not those of a normal person; and (3) my negative characterization of her persists to this day.

In the interest of full transparency and to provide a more complete context, I shall also narrate the relevant events which preceded my testimony before the House Committee on Justice:

I. In public filings made in Jardeleza v Sereno, respondent accused me of committing "freason," being a "traitor," and being disloyal to the country through my alleged "deliberate refusal to promote the remedies available to the Philippines, and deliberately weakening the country's arguments."8 She also faulted me for allegedly demonstrating "weakness of character" when I was supposedly not willing to protect the interest" of the Republic even inferring that I may have been listening to extraneous factors or may have been promised something", thereby imputing that I may have

compromised national interests because of personal agenda

There, I recounted how the Philippine legal team, composed of lawyers from different offices within the Executive Department, and in coordination with our international legal team, unanimously and purposively embarked on a low-risk strategy involving the question of which features to include in the Philippine submission, Specifically, only features that (in our estimation

and based on evidence known or available to us) could, at worst, be declared only as rocks were included in our lanuary 2013 submission to the Arbitral Tribunal Relatedly, the team made a deliberate decision not to include itu Aba, the largest feature in the Spratty Islands, as it was reputed to have sources of potable water which, arguably, could qualify

it as an island to the detriment of the entire Philippine case.

In brief, the risk posed by including itu Aba was this, if declared by the arbitral tribunal to be an island. Itu Aba would generate a 200 Nautical Mile (NM) Exclusive Economic Zone (EEZ) that would cover large parts of the Philippine EEZ in the west, including keed Bank and extending almost up to Palawan. This was a risk none of the members of the Philippine legal team was willing to take.

Toward the end of the year, however, foreign counsel recommended the amendment of the Philippine statement of claim, with the addition of other features, among them, Itu Aba Considering the gravity and sensitivity of the proposal, we asked counsel to visit Manila to

personally discuss the matter with the test of the Philippine legal team. lu a meeting held in Malacanan in January 2014, the advantages and disadvantages of the proposal were discussed in the end, the team manimously affirmed the low-risk strategy initially agreed upon and decided against amending the Philippine submission to include hu Aba

to the Secretary of Foreign Atlants and myself, for purposes of elevating the matter to then President Aquino for his decision. After discussion, President Aguino decided to go with the foreign counsel's recommendation and the additional paragraphs mentioning lur Aba were included in the Memorial

Respondent would later on use this same confidential Memorandum to block my nomination and impugn my integrity before the JBC l emphasize that neither respondent nor her informant, Schior Associate Justice Antonio T. Carpio, were part of the Philippine legal team. They did not participate in the discussions that led to the initial adoption of the low-risk strategy, nor in the decision not to amend the Philippine submission. In fact, I did not furnish re-

spondent or Justice Carrio a copy of this confidential Memorandum in view of its highly sensitive content.

A sober understanding of the South China Sea conflict

WHEN the decision on the arbitral case that the Philippines filed against China was released in July 2016. I was catapulted into social media fame (or notoriety) by explaining the South China Sea conflict and why the decision will not resolve it.

At the time, I was still finishing my master's and working as a teaching assistant. During my free time, I was answering queries from different folks who wanted to deepen their understanding of the issues. Let me share one of them, the conversation I had with a friend, Marvin, who raised challenging points. Our conversation pivoted around the theme of rules-based order in the South China Sea, the role of the UN Convention on the Law of Sea (Unclos) in crafting it, and our role in escalating the conflict.

Marvin (M): Can you imagine how much trouble Europe with the Baltic and Mediterranean Seas would be without rules-based order?

Sass (S). The rules-based order that shaped these seas weren't wrought by a unilaterally sought arbitration but patient negotiations among the coastal States that have reconciled their interests. That is the crucial difference, and the difference that mattered— the reason why these seas have far more stability than the South China Sea.

M. Unclos, as foundation element of a rules-based order, was precisely designed to avoid wars by putting nation-states on even footing including small countries

S. I agree. However, Unclos

also mandates that the States bordering enclosed or semi-enclosed areas, such as the South China Sea, to cooperate. As stated in Article 123: "States bordering an enclosed or semi-enclosed sea should cooperate with each other in the exercise of their rights and in the performance of their duties under this Convention."

The arbitration proceedings and the animosity that it unleashed just made cooperation very difficult, making it hard for the coastal States to fulfill this duty to cooperate, which the Unclos obliges them to do.

If we are going to read the treaty according to the rules of treaty interpretation, i.e. that treaties should be read in light of their purpose, then we get the same emphasis on cooperation. In the Preamble, the Unclos, above all else, is "prompted by the desire to settle, in a spirit of mutual understanding and cooperation." If the interpretation and application of the Unclos doesn't produce mutual understanding and cooperation, then the Unclos isn't being faithfully enacted for its intended purpose.

The rules-based order in the South China Sea, just like the rules-based order in the Baltics and the Mediterranean, depends on

the negotiated cooperation of the coastal states, through which they reconcile their legitimate interests, achieve mutual understanding and cooperation. This cannot be done through a unilaterally sought arbitration proceedings overseen and helmed by men here in The Hague who wouldn't live the consequences of their 501-page decision.

M: Is it not obvious that the selection of the 9-dash line is a conscious territory grab based on an officious Kuomintang cartographer's practical 20th century wet dream — he actually dusted off old Western maps and just translated their names into Mandarin and as islands many sea features putting a lie to the current China claim in domestic campaigns of long-time "exploration and occupation"

S. When you said that by drawing the 9-dash line the Ruomintang was consciously doing a "territory grab," it was not quite clear from whom they are grabbing the territory.

Our country's first position on the status of the Spratlys was what the Marcos administration stressed in 1971.

*In 1957, we affirmed that the Spratly island group falls under the de facto trusteeship of the Allied powers by virtue of the Japanese Peace Treaty signed and concluded in San Francisco on September 8, 1951, whereby Japan renounced all her rights, title, and claim to these islands. By virtue of that trusteeship no

one may introduce troops on any of these islands without the permission and consent of the allied powers. Our position on this matter remains firm."

Based on this, the Spratlys are nobody's territory but as understood by the Marcos administration, falls under the de facto trusteeship of the Allied powers of which China was a member. Yet despite holding this position, we built the Rancudo airfield on Thitu island (Pagasa) in 1975, without the permission and consent of the Allied powers of which China was a member. 'A dog with a leash'

N 25 October 2016, President Rodrigo Roa Duterte aka Digong pronounced himself, rather emphatically, on the presence of US troops in the country with the following words:

"I really hate it. I don't want it. We don't need it."

"US shouldn't treat the Philippines like a 'dog with a leash'," he added.

Thenceforth, he ordered the annual PH-US military exercise Balikatan be reduced to training for humanitarian assistance and natural disaster operations, with a view to doing away with it altogether at the appropriate time.

The just-concluded Balikatan exercise, however, not only focused on humanitarian aid and natural disasters but also training for "man-made emergencies like, for example, a chemical attack", according to the spokesman of the Philippine side.

Consequently, the number of participants in the exercise substantially increased to some 3,000 members of the US Marines, Army, Air Force and Special Operations Force, along with 5,000 Filipino soldiers.

Moreover, some 60 Australian and 20 Japanese military personnel reportedly participated in the exercise.

Balikatan 2018 featured "civic action activities in pre-selected areas in Cagayan and Central Luzon; an Amphibious Landing at the Naval Education Training Command, San Antonio, Zambales; and a combined Arms Live Fire Exercise at Col. Ernesto Rabina Air Base, Tarlac (Crow Valley)".

The ouster of Corona accumplished Aquino's three objectives:

1) punish Corona for the Supreme Court ruling that the Hacienda Luisita owned by the Cojuang-co-Aquino family was subject to land reform and deciding that the amount to be paid by the farmer-beneficiaries must be based on the 1986 price; 2) Arroyo spent some six years in hospital deten-

tion, courtesy of Aquino's now detained ex-justice secretary Leila de Lima; and 3) he was able to appoint a Chief Justice in the person of Maria Lourdes Sereno who, again as generally perceived, would protect him from lawsuits after his term ends.

With Sereno gone, Aquino must be losing sleep nowadays, not only over the cases that have been filed against him so far, but also over the implementation of Corona's Supreme Court ruling on Hacienda Luisita whereby the Cojuangeo-Aquino family reportedly stands to lose some P3 billion.

AFP to poll bets: Refuse NPA extortion demands

MANILA -- The Armed Forces of the Philippines (AFP) on Monday reminded candidates for this year's Barangay and Sangguniang Kabataan Elections (BSKE) not to give in to extortion rackets of communist rebels.

"We advise the candidates and business owners not to give in to the group's demands and report their illegal activities immediately to the proper authorities like the Comelec (Commission on Elections), PNP (Philippine National Police), and the Armed Forces of the Philippines," AFP public affairs office chief Lt. Col. Emmanuel Garcia said in a statement.

He added that giving in to their extortion activities will only give the NPAs the means to conduct further atrocities against the government and its constituents.

"Legal ramifications are also waiting for those who will be proven to finance the CPP-NPA and its terror activities," Garcia said.

The AFP earlier said it is ready to secure the village polls, noting that it has yet to monitor any security threat on the polls.

Over 90,000 AFP personnel have been deployed in this year's village and youth polls. (PNA)
