

'Protect ombudsman, protect the people'

Iwo months before her retirement, Ombudsman Conchita Carpio-Morales has broken her silence over perceived attacks on her office and other constitutional bodies, saying the country needs strong, independent institutions more than strong leaders.

"In closing, let me underscore that great countries do not need strongmen They need strong institutions," Morales said in a speech at a forum organized by the Integrated Bar of the Philippines (IBP) on Thursday.

"Great men eventually perish, but great institutions outlast them all. By protecting great institutions like the Office of the Ombudsman, you are protecting the people," she alities," Morales said.

Without delving into details, Morales admitted that her office is facing challenges to its

independence.

"A check with reality evinces that the challenges hold true to this very day. Threats and intimidation always rear their ugly head along the way, sprouting from both imperfect systems and imperfect person-

The US-based TIME Magazine, in its May 14 international edition, listed President Duterte among the world's "strongmen" along with Russian President Vladimir Putin, Turkish President Recep Tayyip Erdogan and Hungarian Prime Minister Viktor Orban.

But Duterte refuted the "strongman" tag saying, "I Turn to Page 10

have never sent anybody to jail for criticizing me."

He had castigated the Office of the Ombudsman reportedly for having corrupt prosecutors who would accept bribe money from officials in exchange for dismissing graft charges.

Duterte had also slammed Morales and even dared her to resign for supposedly allowing her office to use illegally obtained documents in its probe on his alleged hidden wealth.

Overall deputy ombudsman Melchor Arthur Carandang, in an interview in September last

year, said that Morales had authorized him to investigate Duterte's bank transactions when the latter was mayor of Davao City.

He claimed that his office had obtained bank documents from the Anti-Money Laundering Council showing Duterte and his family had over P1 billion worth of transactions in several banks from 2006 to 2016. AMLC denied that it had provided documents to Carandang

Morales called the suspension order "patently unconstitutional" and refused to enforce it.

for 90 days for administrative sodes," Morales said in her offenses of grave misconduct speech Morales also lashed out at a proposal to abolish the Office of the Ombudsman.

"One guarantee of independence is that it cannot be abolished by the legislature since if is an office created by the Constitution," Morales said

"More importantly; the mode of removing an ombudsman as only by impeachment. Since the ombudsman is not subject to the disciplinary authority of the President, he or she is not, and should not be beholden to the appointing authority," she added

Leyte Rep. Vicente Veloso had floated the idea of abol-

ishing the ombudsman and transferring its powers to the Department of Justice, but colleagues in the committee on constitutional amendments rejected his proposal.

In her speech, Morales also called on the members of the IBP and the public to remain vigilant in protecting the independence not only of the ombudsman but of other constitutional institutions as well saying "no single branch tion had also accused Duterte can control the entire govern-

"The responsibility of addressing social maladies rests on the shoulders of government institutions. It is thus in-

cumbent for these institutions to be efficient, resilient and mostimportantly, independent in fulfilling its obligations to the people," Morales said. Morales will retire on July 26 when she turns 77

Aside from the Office of the Ombudsman, the Commission on Human Rights also gets frequent tongue-lashing from Duterte and his supporters.

The Department of Justice has removed the alleged pork barrel mastermind, Janet Lim Napoles, from its Witness Protection Program, saying she faces no more threats.

The alleged mastermind in the Pio-billion peso pork barrel scam has been removed from the government's Witness Protection Program (WPP), the Department of Justice (DOJ) said on Priday.

Justice Secretary Menardo Guevaria said he had sent a letter to lawyers of Janet Lim-Napoles "giving notice of the termination of her provisional coverage, under the Witness Protection Security and Benefit Program (WPSBP) effective May 25."

Guevarra said the "main purpose" for which Napoles had sought to be admitted into the WPP "has become moot and academic."

"As there has been no further claim of threats to her personal security inside Camp Bagong Diwa,"(we) found no reason to extend further Ms Napoles' provisional coverage under the WFP," Guevarra said.

He said Napoles had requested witness protection due to alleged threats to her life. She also sought her transfer from Camp Bagong Diwa in Taguig City, where she is currently detained on plunder charges, to a secure housing facility of the WPP

Sandiganbayan rejections

The First, Third and Pifth Divisions of the Sandiganbayan, where she is facing a string of plunder and graft charges linked to the pork barrel scam, had all denied her urgent motions to be transferred to the custody of the WPP of the DOJ.

Napoles was provisionally

admitted into the program on Feb. 27 under then Justice Secretary Vitaliano Aguirre II in exchange for her affidavit implicating more people in the multibillion-peso scam involving legislators' Priority Development Assistance Fund (PDAF)

NewPDAF cases

Under Republic Act No 6981, or the Witness Protection Act, a person to be admitted into the WPP must first execute a sworn statement describing in detail the manner in which a certain crime had been committed and his or her participation init.

Napoles' affidavit reportedly identified a former Cabinet secretary and more senators involved in the scam.

Invoking confidentiality, the DOI did not release her affidavit.

Napoles' lawyer Stephen David earlier said that his client was open to standing as a state witness in the new PDAF cases being investigated by the DOJ.

Ombudsman's objection

But Ombudsman Conchita Carpio Morales rejected such a tole for Napoles, saying she was "one of the principal alleged malefactors" in the scam and was therefore not qualified to become state witness

The decision of Guevarra, who earlier vowed not to let the DOJ be used to persecute administration critics, may have aborted Napoles' supposed plan to testify against politicians identified with former President Benigno Aquino III.

It was the latest of Napoles' legal setbacks in her attempt to win back her freedom following the Supreme Court's decision in April tossing out her bail petition due to "a great presumption of (her) guilt" in the pork barrel scam.

Napoles spent only two

years in the Correctional Institution for Women in Mandaluyong City after she was convicted by the Makati Regional Trial Gourt for the serious illegal detention of her cousin Benhur Luy, the primary whistle-blower in the scam.

She was taken back to a jail

in Camp Bagong Diwa in May last year after Solicitor General lose Calida's intervention prompted the Court of Appeals to reverse her conviction.

Napoles is accused of running a network of bogus foundao tions that received PDAF allocations from several lawmakers, who in turn allegedly earned kickbacks in exchange

In July 2013, the Inquirer broke the story on the scam.

In June 2014, the Ombudsmanindicted former Senators Juan Ponce Enrile, Jinggoy Estrada, Ramon Revilla Jr. and other goverment officials in the Sandiganbayan for plunder and graft in connection with the scam, with Napoles as their coaccused.

Revilla was accused of receiving P224.5 million in kickbacks, Estrada P183.8 million and Enrile P172.8 million. Allthree have denied any wrongdoing. INQ

Rody doubts US readiness to defend Phl vs extremists

President Duterte has raised doubts whether the United States would be ready to help defend the Philippines from Islamic militants amid concerns raised by some groups over the administration's

dealing with China

"Because of the threat here in Mindanac, you must have an option of where to go Is America ready to die for us? Are they ready to send their troops here? Or can I call China for more arms because we do not have it?" Duterte said during the inauguration of a bridge in Davao City on Thursday.

Duterte made the statement after some sectors questioned why the government did not contest Benjing's deployment of missiles and other military equipment in the South China Sea

The IJS was the first to provide missiles, guns, ammunition and other weaponry as well as surveillance equipment to the Armed Forces of the Philippines when Maute terrorists laid siege to Marawi in May lasy year. Australia followed, providing drones.

China and Russia later donated guns and bullets.

Duterte reiterated that the Philippines could not afford to wage war against China

He also maintained that he is not abandoning the Philippines' claims to the disputed areas in the South China Sea.

"We cannot afford a war. We cannot win a battle against China and I would only lose maybe thousands of my troops and policemen," he said.

Duterte had blamed the US for not lifting a finger when China started building military equipment in the South China Sea.

Meanwhile, Sen. Leila de Lima called on the President to convene the National Security Council (NSC) in a bid to take up China's militarization of Mendez, Marvin Sy

the South China Sea

De Lima said the country could not afford to remain silent while China continues to construct structures and install missiles in the disputed waters.

She filed Senate Resolution 744, asking the President to convene the NSC, the principal advisory body on the proper coordination and integration of plans and policies affecting national security.

"Diplomatic actions are no longer options as the military activities of China in the West Philippine Sea have placed the whole country under perpetual threat," De Lima said

presented all possible actions,
including forceful diplomacy,
close collaboration with allies
such as Australia, Japan and the
United States, renewed partnership with Indonesia, Vietnam
and other allies in the ASFAN,
and availment of other UN
mechanisms," she added.

China has reportedly deployed cruise ship and surfaceto-air missiles on three islands in the Spratlys, where the Philippines is one of six claimantcountries.

Beijing has also landed bombers on an outpost in the South China Sea.

Duterte admitted shedding a tear after he led the ceremonial valve opening of the Polyard-3 well, operated by the China International Mining Petroleum Co. Ltd. In Cebu City last weekend.

"Last week, I was in Alegria, Cebu. For the first time nakita ko 'yung apoy na (I saw the fire)... When I turned on the valve para lumabas 'yung (langis) pag-uwi ko sa chopper kunyari nag-wipe ako ng face ko but I cried. At least for the first time nakita ko oil (I saw oil)," the President said.—Christina Mendez, Marvin Sv.

WPS dispute with China 'can't be solved in this lifetime'

The country's territorial dispute with China in the West Philippine Sea (WPS) cannot be resolved in this lifetime, according to presidential spokesperson Harry Roque. Saying that the Duterte administration was "not pro-China" and would not give away territories to China, Roque said the government only wanted to set aside the contentious issues at this time and to pursue other matters in cooperation with the regional superpower. "We are not pro-China. We are not giving away our territories. Let's not touch the contentious issues first because I think the issue of the disputed islands has no resolution during our lifetimes," he said during a television interview on Thursday night on Light TV. He added that the Duterte administration was setting aside the issues with China that could not be immediately resolved. "The issues that can be agreed upon should be pursued. This is why issues of economic cooperation trade and investments, noncontentious issues, now proceed." Roque said.—Juhen Aureno My



DU30 GIVES WOUNDED TROOPS GUNS, CASH AND . . . A COW

DAVAO GITY—President Duterie's generosity toward soldiers is now well-known but it went a step further when he offered one soldier, wounded in battle, a gift that the soldier would surely not forget—a cow

Seven wounded soldiers recuperating at a hospital here were showered with gifts by the President, who promised them medals, pistols, money and the now famous trip to Hong Kong.

On top of all these, Mr. Duterre gave one soldier, Pfc. Daniel Fabular, a gift that he was likely to remember all his life.

The President offered Fabular a cow to be slaughtered for his wedding to his fiancee of nine years, Natasha Kresta dela Cerna

Overwhelmed

"I was elated and overwhelmed when the President stepped into my room, came to my bed and asked how I was doing," said Fabular, one of five soldiers wounded by an improvised explosive device planted by New People's Army (NPA) rebels at Cabuyoan village in Mabini town, Compostela Valley last week.

The 27-year-old Fabular suffered shrapnel wounds in the face, chest, arm and legs.

Dela Cerna, his fiancee, was at his bedside when the President, accompanied by Special Assistant to the President Christopher "Bong" Go and other officials, visited them at Metro Davao Medical and Research Center.

"I, too, was surprised. I'm very happy to see and meet him in person," the 26-year-old Dela Cerna said.

She and Fabular were set to tie the knot on June 16 in their hometown, Isulan, Sultan Kudarat province.

'Ninong'

They asked Mr. Duterte to stand as their wedding godfather, but it was not known if the President accepted the offer.

Dela Cerna said she believed the President could fit the wedding into his schedule. "After all, it's a Saturday," she said of the day the wedding falls.

Fabular said they intended to go on honeymoon in Hong Kong, still courtesy of Mr.

The President bestowed the

Wounded Personnel Medal and Order of Lapu-Lapu with the rank of Kampilan to Fabular and Cpl. Kith Domingo, Pfc. Jackson Macaraeg, Pfc. Roger Belas, Pfc. Nicasio Badana III, Pvt. Michael Liban and Pvt. Roy Inovejas.

Serving the country

According to Executive Order No. 35 signed by Mr. Duterte in 2017, the Kampilan medal is given to government workers and private citizens who were injured or had lost property in pursuit of the President's campaigns.

Macaraeg was wounded in a clash with the NPA in Lingig,

Surigao del Sur province, early this month. Domingo was shot in the leg in a clash with the rebels on April 19.

The soldiers said they would return to the battlefield to "continue serving the country."

"If it's already your time to go, your time will come," Fabular said.

"Death would come at its time whether you're a soldier or a civilian," he added.

The soldiers received a total of P110,000 in cash and checks from Mr. Duterte's special financial assistance budget and the military's cash aid to wounded troopers. —FRINSTON LIM INQ

Soldiers dig up illegal sewage pipes in Boracay

ILOILO CITY — Soldiers used shovels to dig up illegal sewage lines in Boracay Island in Aklan, which has been closed to tourists while undergoing a sixmonth rehabilitation program

Jim Sampulna, Western Visayas regional director of Department of Environment and Natural Resources (DENR), said 100 soldiers started digging up along the island's famous stretch of white beach

The use of soldiers from the Philippine Army's 3rd Infantry Division (3ID) was requested by DENR Secretary Roy Cimatu, a former military general.

Last week, government authorities found bacteria-tainted sewage pipes buried along the white beach.

Aghast at the discovery of the illegal pipes, Cimatu declared he will not recommend to President Duterte the reopening of the resort island if its waters do not meet safety standards

Testing conducted by the DENR's Environmental Management Bureau (EMB) found the level of coliform bacteria 74,000 probable number per 100 milliliters (MPN/100 ml), way beyond the safe level of 400 MPN/100 ml.

DENR continued to call on

DENR continued to call on islanders as well as business groups such as the Boracay Foundation Inc. (BFI) and the Philippine Chamber of Commerce and Industry Inc. (PCCI-Boracay) to continue supporting the rehabilitation program.

Families of 7 heroes of Marawi siege get P10-M gov't assista

THE families of seven brave policemen who were killed during the 5month Marawi Čity attacks staged by ISIS-in-spired Maute and Abu Sayyaf gunmen in May last year have received a total of P10460 million in assistance by the government, the Philippine National Police said yesterday.

Seven of the policemen. three of them from the Autonomous Region in Muslim Mindanao Police Regional Office and four from the elite PNP Special Action Force, were killed in operations to recover the city from the terrorists, said the PNP Directorate for Personnel and Records Management headed by ChiefSuperintendentLyndon G. Cubos

The three ARMM policemen were among the first casualties when Maute guinnen started sowingviolence in the city on May 23 2017 Accord-ing to Cubos, the families of Chief Inspector Freddie M. Solar, Inspector Edwin Placido and Police Officer Junaid Mama have each received Special Financial Assistance

amounting to P250,000 and other benefits amounting to almost P15 million

The same amount of money was received by the families of four brave PNP-SAF commandos who perished during the siege They were identified as Police Officers 3 Alexis Mangaldan and Daniel Tegwa, Police Officer 2 saidPNPspokesmanChier Alexis Laurente and Po-

dice Officer I Moises Ki mayong.

The families of the PNP heroes also received help from the Presidential Social Fund - Special Financial Assistance, the Office of the Chief, PNP, President Rodrigo Roa Duterte, One Philippines Foundation, Inc., and Regional Comptrollership Fund,



REVININGSTALLED PEACE TALKS

LUCENA : CITY—Communist Party of the Philippines founding chair Jose Maria Sison on Friday said that President Duterte's threat to kill him if peace talks failed was a way of expressing endearment.

"Duterte has repeated so many times the threat to kill me



"If nothing happens, I would tell him 'do not ever, ever return again to this country I will kill you. You've killed so much of my soldiers and policemen." Dapat lang (He deserves death)," Duterte said during the manguration of the Davao River bridge widening project the other day.

He stressed that the window is very small and that this invitation is a make-or-break deal.

If nothing significant will come out of the talks, Duterte said he would keep his word and personally escort Sison to the airport, allowing him to get out of the country instead of arresting and sending him to jail.

He added that he would make sure Sison will not be able to return to the Philippines again.

For Sison though, the re-

peated threats have become a "term of endearment."

"(Duterte) has repeated so many times the threat to kill me that sometimes I surmise that the expression kill has actually become a term of endeament, as in some American comedies," a statement posted on the National Democratic Front website reads.

The communist leader added that Duterte, by using strong words, would now appear to be eager to resume the peace negotiations rather than block them.

"It is best that Duterte and I allow and encourage the negotiating panels to continue preparing for the resumption of formal talks and make substantial progress as soon as possible," he said.

Sison, who fled to Europe after peace talks failed in 1987

and has stayed abroad since, said he is ready to go home as soon as there is "substantial progress" in the negotiations as he expressed optimism that the backchannel consultations on the resumption on peace talks are leading to better results

He earlier revealed that an interim peace agreement is expected to be signed when formal talks resume on June 28.

Both the government and the communists, he said, were expected to announce a standdown agreement two weeks before that.

"So, by June 14, plantsado na (it's all ironed out). Of course, I may be proven wrong because everything depends on that joint announcement... there may be some misunderstanding but they can be solved," Sison added.

The talks fell through in November last year following clashes between government troops and communist rebels. Duterte claimed the government is winning the war against the New People's Army (NPA), the communist party's armed unit, in apparent reference to the arrest of Elizalde "Ka Jinggoy" Cafiete who is considered to be the overall commander of the communist guerrillasun Mindanao and successor of Leonardo "Kumander Parago" Pitao, the NPA leader operating in Southern Mindanao.

Presidential adviser on the peace process Jesus Dureza, during a speech at the 22nd National Press Forum of the Philippine Press Institute at the Jen Hotel in Pasay City, challenged the media on Thursday to engage the entire country in the pursuit of peace.

He said the media have a unique role in peace building and that the public will not appreciate the milestones achieved in the peace process

if they are informed only after agreements are signed and not while the process is going on.

In Negros Oriental province, the military reported that three more heavy equipment units used to build farm-tomarket roads in Mabinay town were burned by the NPA.

Capt. Ruel Llanes, 303rd Infantry Brigade spokesman, said the nebels torched a roller, backhoe and bulldozer in sitios Butokon and Begonia of barangay Bagtic and in sitio Talingting in barangay Luyang.

Senior Supt. Raul Tacaca, Negros Oriental Police Provincial Office in charge, said at least two suspects were arrested for the incident, which cost at least P14 million in damage.

In his speech Thursday, (May 26) Duterie cited the military for rearresting Elizalde Canete, the successor of the late Leonicio Pitao, better known as Commander Parago.

"So the military is quite good in... we're winning the war actually," said Duterte.

Caneta, commander of the New People's Army's First Pulang Bagani Command, was at the Dom Carlos Doctors Hospital in Bukidnon seeking treatment at the time the military arrested him

The NPA leader is accused of being behind atrocities in Davao City, including the attack against Lapanday Foods Corpora-

tion, which killed fish vendor Larry Buenafe.

In the same speech, Duterte mentioned anew his planned talks with Communist Party of the Philippines (CPP) founding chair Jose Maria Sison, whom he invited to fly home.

Sison, according to Duterte, had agreed to visit the Philippines and had been given a window of two months for the talks.

But if there is no progress after two months. Duterte said he would tell his former professor to never return to the country again.

"If nothing happens, I will really tell him Do not ever, ever return to this country. I will kill you. You've killed so much of my soldiers and policemen," he said.

The Philippines has resumed negotiating with communists in "informal" backchannel talks in Europe earlier this month after Duterre ordered his men during the Cabinet meeting in April to support the resumption of the negotiation

Duterte described this as the "last chance" for peace with the communist rebels.

Earlier, Duterte apologized for showing up late to an event in his hometown Davao City as he complained of hyperhidrosis or excessive sweating.

Duterte arrived at the inauguration of the Davao River Bridge shortly before 6 p.m. The event was scheduled at 4 p.m.

T am sorry I'm late. Pero sinabi ko, next time do not be surprised. Hawakan ninyo likod ko, pati pantalon, basa na. That's hyperhidrosis, excessive

sweating," the President said in his speech.

"[It has] something to do with a procedure that I underwent many years ago. It's all because of smoking Kaya galit talaga ako sa sigarilyo."

According to the National Health Service of the United Kingdom excessive sweating can happen for no obvious reason," because of another condition a person may have or as a side effect of medication.

Last March, Duterte arrived more than an hour late to the oathtaking coremony for members of the Presidential Anti-Corruption Commission in Malacanang, citing spinal pain.

The President previously admitted to having a misaligned spine as the result of a motorcycle accident years ago.

Duterte's health has been the subject of much speculation, but the president has repeatedly downplayed such concerns.

During an extended stint away from the public eye last year, he asked the public not to worry about his health.

Duterte also previously revealed that he has Buerger's disease, a condition that causes constriction of the blood vessels due to nicotine, and Barrett's esophagus, a disease involving the tissue in the esophagus.

PNP wants control over Bangsamoro police under BBL

Philippine National Police Director General Oscar Albayalde has expressed opposition to a proposal under the Bangsamoro Basic Law (BBL) bill that would give the regional chief minister control over the Bangsamoro police force

Albayalde told reporters on Tuesday that a provision in House Bill No. 6475 giving the chief minister the power "to exercise operational control and supervision and disciplinary powers over the Bangsamoro Police" was unnecessary.

"What we want is for [the setup] to remain as is. Our stand is we will put up a different regional office there [in the Bangsamoro state], even just one ... "he said.

Private armed group

The PNP chief explained that the national uniformed forces should maintain control of their units in the area [which]

may otherwise become "politicized" by local powers.

"What we are [trying to avoid] is for them to be controlled, and become a large private armed group there," Albayalde said.

Under Section 8, Article XI of the proposed law, the chief minister will also be given powers to act as ex officio member of the National Police Commission and as ex officio chair of the Bangsamoro Police Board.

The chief minister is also tasked with, among others, selecting the head of the Bangsamoro police and his deputies, as well as employing

or deploying the elements of Bangsamoro police through the the state's police director.

Despite the provision in question, the bill expressly states that the Bangsamoro police shall remain "part of the Philippine National Police."

Marawi residents urged: Remain vigilant vs terror threat

By JAIME LAUDE

The government might have liberated Marawi City from Islamic State-inspired terrorists but the threat of militants still lingers in its ruins.

Defense Secretary Delfin Lorenzana issued the warning as he rallied displaced residents of the heavily devastated city to remain steadfast.

"We must remain vigilant because terrorists are just lurking in the shadows. Though we have accomplished much in our countenterrorism efforts for the past year, these endeavors still require continued perseverance, vigilance and sacrifice of everyone," Lorenzana told the gathered residents during a visit to Marawi on

Thursday.

The defense chief issued the call amid reports that remnants of the Maute group are actively recruiting members across Mindanao, particularly those living in the towns and villages located around Lake Lanao.

Lorenzana flew to Marawi a day after officials commemorated last year's attack and occupation of the city by the Maute group.

Nearly 1,000 terrorists, more than 160 soldiers and policemen and almost 100 civilians died during the five months of fighting to drive out the militants.

One of the highlights of Lorenzana's visit was the signing of a joint declaration of allout support by the displaced residents to government efforts in ensuring peace and order in Lanao del Sur and condemning local terrorist groups.

Lorenzana assured the people of Marawi that in no time the Islamic City will rise again and peace and development will rule the city.

"The city will be healed and the people will dance and laugh again. But to be safe we must stand firm for peace while being alert on what is happening around. Let us also continue to echo our call for peace and unity," he said.

Considered as the Philippines' longest urban warfare after World War II, the five months of fighting literally reduced Marawi City into rubble and forced thousands

of residents to abandon their homes.

Thousands of displaced residents remain in emergency shelters, unable to return to what remained of their homes under threat of unexploded bombs and booby traps.

"The concrete jungles of Marawi brought out many stories of gallantry, true courage, dedication of our troops and that of resilience of Marawi residents. He commended Task Force Bangon Marawi for doing a fine job in leading the rehabilitation of Marawi. Temporary shelters are already being constructed for the evacuees, while government is in the process of constructing their permanent houses, Lorenzana said.

"Foreign allies and international organizations have also been giving financial assistance for the rehabilitation and relief of this war-torn city." he added

Heroes of Marawi

A somber ceremony also highlighted the heroism of soldiers who gave their life to the cause of liberating Marawi from grip of terror

"The heart of a soldier is not measured in size but by the depth of commitment to make a difference in the lives of others. A tribute to the men and women who committed their hearts for the liberation of Marawi."

This was the epitaph on the memorial built inside the camp of the 103rd Infantry Brigade in Kampo Ranao here in memory of the 165 soldiers and policemen who laid down their lives to liberate Marawi

The name of each fallen officer was read in ceremonial rites during the Battle of Marawi Commemoration Program Thursday as a wreath was laid in their honor.

"I wish it could not have happened, but it happened because of the actions of some terrorists—wala tayong magagawa (there was nothing else we could do) but to deal with them in a way that we stopped them and we wipe them out," he noted

"The concrete jungle of Marawi brought out many stories of gallantry, true courage, dedication of our troops; and that of resilience of Marawi residents – these stories shed light during the city's darkest times," Lorenzana said. "The Marawi siege also strengthened us a nation—as diverse as we are, we were unified by our desire to stop the spread of extremists' gospel of hate and anger."

"One year may have passed but the pain and the ruins are still there. Rest assured that the government has been doing all it can to diminish the pain and put things back to normal," he added

Vigilance, lessons learned

But to ensure that the Marawi incident won't happen again, the defense official said the people should be vigilant to prevent the enemy from staging future attacks.

"We must still remain vigilant because terrorists are just lurking in the shadows. Though we have accomplished much mour counter-terrorism efforts for the past year, these endeavors still require continued perseverance, vigilance, and sacrifice of everyone for the years to come," he added.

"This is not to celebrate the fact that Marawi siege happened. But the heroism of soldiers in the Marawi frontlines as well as other individuals and groups who sacrificed their lives during the five-month long battle," Lorenzana said.

The siege reduced the Islamic City of Marawi into rubble only seen in Middle East countries.

But there are lessons learned

"First, the city officials were not vigilant enough to protect their territory," and agrees with President Duterte that Marawi residents were partly to blame for allowing the IS to gam a foothold in Marawi

Second, is lack of intelligence and the failure to appreciate the magnitude of things that could happen, Lorenzana said. This is because "we cannot accept the fact that they can do it here what they are doing in the Middle East."

Third, Lorenzana pointed out is that our troops are not trained for urban warfare and lacks the equipment.

He said this is the reason why govern-

ment is trying to procure equipments "so that if something like this happens, we are prepared." Urban warfare training is expected to begin next week.

"Kung sino man ang nagkamali doon (If whoever was at fault then) it's already water under the bridge. Hindi na tayo magtuturuan (We will not point fingers). All we can do now is to improve our processes, procedures and intelligence," Lorenzana said.

Order of Lapu-Lapu

Meanwhile, President Duterte vowed to provide the needs of wounded soldiers recuperating from their injury at the Metro Davao Medical Research Center (MD-MRC) in Davao City Thursday evening.

During the hospital visit, Duterte personally awarded the medals of the Order of Lapu-Lapu with the Rank of Kampilan to the soldiers in honor of their courage, bravery, and sacrifice in the service of the country.

The Order of Lapu-Lapu, Rank of Kampilan is conferred by the President to recognize exemplary service by workers of the government and private individuals who are wounded, injured, or suffered great loss of property for their participation in the advocacy of the President.

"The President had a brief chat with the wounded soldiers where he vowed to provide for their needs. He likewise assured them of their full recovery under government's care," the Palace statement read.

Duterte also gave financial assistance to the wounded soldiers.

The wounded soldiers were identified as Pfc. Nicasio Badana III, Pvt. Michael Liban, Pfc. Jackson Macaraig, Cpl. Kith Domingo, Pvt. Roy Inovejas, Pfc. Roger Belas, Pfc. Daniel Fabular

Badana, Liban, and Macaraig sustained injuries during separate encounters in Surigao del Sur last week

Gov't'bias' for Chinese firms in Marawi rehab hit

N OPPOSITION lawmaker on Friday assailed the government's bias in favor of Chinese companies in the projects involving the rehabilitation of Marawi City.

Magdalo Party-list Rep. Gary Alejano found out the alleged government bias in favor of Chinese companies during a briefing for congressmen conducted by the House committee on Muslim Affairs last May 23.

The TFBM selected the Bagong Marawi Consortium to lead the rehabilitation programs and efforts in Marawi City after it submitted an unsolicited proposal. The BMC is composed of five Chinese and three Filipino companies, Alejano said.

"Majority of the companies included in the BMC are Chinese. Two are even stateowned enterprises which mean that state funds of China would be used," Alejano said, referring to China State and China Geo Engineering Corp.

"Worries on the degree of control that China would have on these projects could not be dismissed especially since the Filipino companies included have no history of contracting big government projects. How can we make sure that the projects will remain Filipino-led and the interests of the Maranaos in particular, will be respected and given prime consideration in the rehabilitation projects given this configuration?" he asked.

Alejano also said that during the briefing, the TFBM could not provide the records and details of the preferred firms to join the BCM and it is not clear yet how the winning contractors will recover their billions of pesos investments.

Similarly, the party-list lawmaker questioned the business record of the Chinese companies.

"The two Chinese state firms were involved in corruption and fraud scandals. In fact, they were once blacklisted by the World Bank and DPWH itself. Though

already lifted from the list, China State Engineering continued to get involved in corruption scandals in other countries," Alejano said.

"Given this record, should it not have caused alarm for TFBM to select the BMC? How can we assure that the Marawi rehabilitation would not be marred by corruption cases in the future with such kind of participating firms?" he said.

Alejano also criticized the lack of detailed planning on the Marawi rehabilitation a year after the siege

"They have a timeline and grand proposals being presented to the public, but they have not even mapped out where these constructions will be built. Worse, they have not yet consolidated the number of displaced and affected Maranaos. How can we move forward if there is no starting point yet?," Alejano said.

He also questioned the procurement rules being observed in the Marawi rehabilitation.

The TFBM said that the National Housing Authority does not need to comply with the provisions of RA 9184 for the procurement related to the Marawi rehabilitation and would instead follow the Executive Order 49 issued by President Rodrigo Duterte A2

AFP chief cites Air Force's role in Marawi liberation

Armed Forces of the Philippines (AFP) chief of staff Gen. Carlito Galvez Jr. yesterday cited the key role played by Air Force, particularly the command's fighter jets, during the Marawi City siege.

Galvez admitted that the Air Force was the "game changer" during the five-month campaign against the Islamic State-inspired terrorists who laid siege on Marawi City.

"The roar of the FA50 is the roar to victory," said Galvez in his speech during the commemoration of the Marawi Air Campaign held at the Edwin Andrews Airbase (EAAB) in Zamboanga City.

"The Philippine Air Force is the 'Game Changer' during the Marawi campaign. I admire Air Warriors for flying day and night just to provide all the needed support for our troops on the ground during the entire campaign," he added.

The AFP said that without the Air Force, there could have been more casualties on the military side.

"Without our very skilled, focused, and hardworking pilots, air crew, and air controllers, our casualties could have been more," Galvez said.

A total of 165 government troops died during the siege while thousands others were wounded.

On the other, a total of 908 terrorists, led by Isnilon Hapilon — tagged as the emir or leader of the Islamic State of Iraq and Syria (ISIS) in Southeast Asia, were killed.

Around 1,000 Air Force personnel were part of the fivemonth campaign of the government against the terrorists.

Galvez noted that the airmen demonstrated power that was felt 24/7 wherever they were needed.

In the five month campaign, the Air Force flew more than 1,350 sorties, transported nearly 7,000 soldiers and police personnel, and transported around 700 wounded personnel.

Galvez also acknowledged the 205th Tactical Helicopter Wing that provided various types of missions day and night, while the 220th Airlift Wing transported military and civilians, supplies, ammunition, and relief goods during the siege

The 250th Presidential Airlift wing was also recognized for ensuring the safe flight of President Rodrigo Duterte during his numerous visits to the affected areas.

A disturbing proposal on martial law imposition

ay 23, 2017 marked the beginning of two catastrophes that befell the people of Mindanao; one year later, the harsh impact on their daily lives and the profound trauma in their individual and collective psyche seem far

from being assuaged.

First, there was the so-called siege of Marawi City, a nearly-five-month war between the state security forces and fighters of the Maute and Abu Sayyaf groups allegedly affiliated with the Islamic State of Iraq and Syria (ISIS). Due to almost daily aerial bombings and artillery firings by the government forces, guided by American and Australian spy planes and drones, the war caused the death of 1,000-plus fighters on both sides, with an undetermined number of civilians killed and missing; the displacement of a big number of the 400,000 residents of Marawi and adjacent municipalities; and the destruction of a wide swath of the main Islamic city (including mosques, cultural structures, and residential neighborhoods).

Today, the displaced residents who have not yet been allowed to return to Marawi are beleaguered by many problems. They feel uncertain how long their current condition will last and what future awaits them. The people of Marawi have been left out in the planning of the city's "rehabilitation"—but they want to do the rebuilding themselves, in their own way. The many questions they ask have not received satisfactory answers from government and

military authorities.

Three civil-society organizations – Tindeg Ranao, Ranao Multisectoral Movement, and Moro Consensus Group – are opposing the building of a P400-million new military camp for the Philippine Army in the old city hall complex which, in January, President Duterte announced would be completed by 2020. Building houses for the displaced families should be given priority, they declare. (Tindeg Ranao says 140,000 are still cramped in 67 evacuation centers and in the homes of relatives). The organizations also oppose a plan to set up a special economic zone in the city.

On the massive destruction caused by aerial and artillery bombardments, which has angered the people of Marawi, Duterte said he was assuming full responsibility as commander-in-chief of all the state's armed forces. It was right for him to say so, After the first few weeks of fighting wherein the AFP suffered many casualties in unfamiliar close-quarter fighting, it was he who ordered the city's "carpet bombing" so as to lessen the risks for the soldiers. "I will really destroy everything. and I will take full responsibility for it," he told reporters in

Cagayan de Oro City

Now the Duterte government is appealing to the people of Marawi to be patient. "The magnitude of destruction of this disaster is immense," said Gen. Eduardo del Rosario, chair of Task Force Bangon Marawi, "but we are doing our best to fast track the process [of reconstruction]. However, an analysis by the Philippine Center for Investigative Journalism (PCII) shows that the alleged master plan for rebuilding Marawi "remains a patchwork of disconnected promises mired in multiple problems."

The other and wider catastrophe, correlated with the Marawi siege, affected not only that city but the whole of Mindanao. This was when President Duterte imposed martial law and suspended the privilege of the writ of habeas corpus simultaneously. through Proclamation 216, covering the entire island. He did so upon the recommendation of his military and security advisers. Mind that the 1987 Constitution says that "in case of invasion or rebellion, when the public safety requires it, (the President) may...suspend the privilege of the writ of habeas corpus or [emphasis mine] place the Philippines or any part thereof under martial law."

Duterie opted to use both extraordinary powers in tandem, resulting in a double whammy against the people of Mindanao

Originally set to last for only 60 days (as delimited by the Constitution), the edict has been extended twice: first by five months until the end of 2017, then by another year ending December 2018. Duterte was able to easily do that – thanks to the servile majorities in the House and the Senate that he both controls; first separately then in joint session, they endorsed the proclamation and its extensions. Thanks, too, to the pliant majority of the Supreme Court who leniently reviewed and approved the presidential issuances.

The initial stated aim of Proclamation 216 was to suppress the "rebellion" of the Maute and Abu Sayyaf groups in Marawi. This was later expanded in order to "suppress all acts of rebellion and lawless violence" in the whole of Mindanao [specifically] to "dismantle the NPA, other terror-linked private armed groups, illegal drug syndicates, 'peace spoilers' and other lawless armed groups.' Except for the NPA, the other armed groups cited couldn't be deemed to be engaged in rebellion or invasion - the only specific acts for which imposing martial law and suspending the privilege of the writ can be authorized under the Constitution and only "when the public safety requires it" (Section 18, Article VII).

Yet the majority of the Supreme Court apparently let this erroneous listing pass when they reviewed, as the Constitution requires, the "sufficiency of the factual basis" for the proclamation and its extensions. Such leniency has opened the door to misinterpretations (for instance, AFP chief Gen. Carlito Galvez claims that martial law is still needed because "illegal firearms continue to proliferate" in Mindanao) and to abuses and human rights violations in the edict's implementation by the security forces, as borne out by human rights groups' reports published in the press and submitted to the relevant agencies of the United Nations.

Persistent opposition to martial rule cum writ supension has been raised in Mindanao and many areas of the country, particularly because of Duterte's repeated intimations that he might declare martial law nationwide if "enemies of the state" cause similar "trouble" outside Mindanao.

Now comes the news report that the consultative committee (con-com) which Duterte formed to recommend charter

changes towards shifting to a federal system of government has unanimously approved an amendment to the provision cited above adding "lawless violence" to invasion and rebellion as another reason for the imposition of martial law.

Retired Lt. Gen. Ferdinand Bocobo, a con-com member, said he suggested the amendment in view of present challenges to national security posed by "terrorism and violent extremism" to which, he

added, acts of lawless violence are related. Replying to a question, he claimed that "simultaneous or large-scale" attacks by the New People's Army would be enough reason for the President to impose martial law. "For NPA attacks to fall under 'terrorism' as ground to declare martial law, these attacks should cause widespread and extraordinary fear and panic among the populace," he explained. (He was referring to the provision of the Human Security Act of

But refired SC associate justice Eduardo Nachura, a con-com

subcommittee head, goes even farther "Lawless violence," he said, does not have to be widespread as a ground to declare martial law or suspend the privilege of the writ of habeas corpus."

As if it hadn't been easy enough for him to have his way in Mindanao, now the President's men seem to be thinking up more ways to make it even more of a breeze, next time around!

May 21, 2018, the Manila Bulletin headline reads: "Duterțe opens Alegria oilfields:"

The Times story raises alarm, no matter the scale, on an increasing sense of Chinese attack on the Philippines. In fact, it points out, "This means that nearly the entire Philippines falls within the radius' of the Chinese bombers that took off Woody Island."

But the Bulletin story highlights a successful oil exploration in Alegria, Cebu, undertaken by who else but a Chinese!

In fact, the Times story is an alarm actually raised by, according to the report, "the Asia Maritime Transparency Institute (AMTI) of the Washington-based Center for Strategic and International Studies (CSIS) in the wake of a video post by Chinese People's Daily showing the powerful "top-of-the-line" H-6 aircraft landing in one of the Chinese-controlled islands in the South China Sea.

Evidently, the war sirens are US-instigated. It is the US which has been goading the Philippine government to push the ruling of the Permanent Court of Arbitration (PCA) favoring the country's claims to areas in the South China Sea under the United Nations Convention on the Laws of the Sea (UNCLOS).

Our misunderstood position in the South China Sea

THERE are factors affecting our understanding of our claim in the South China Sea. This has deeply divided us such that the US has been using this to create a wedge between this country and China. This stems from our lack of understanding of our own history and of the subsequent conventions redefining international law. Unfortunately, the Liberal Party and the opposition have been exploiting this to ingratiate themselves with the US and instigate an anti-Chinese sentiment.

The first factor is on our understanding of the historical document known to us as the Treaty of Paris signed on Dec 10, 1898. The Philippine archipelago was sold by Spain to the US for \$20 million. Maybe Spain purposely did not include the Paracel and Spratly islands because they do not form part of the Philippine archipelago or that those islets have yet to be effectively occupied to assert sovereignty over the area.

This misunderstanding was reinforced when our historians purposely ignored the degrees indicating the lati-

tude and longitude that form the Philippine archipelago which would later constitute the formal boundaries of the first republic in Asia. The grant of Philippine independence by the US on July 4, 1946



constitutes the same boundaries demarcated by Spain that was handed to us when the US finally granted us our "independence." It is worth noting that the US did not alter the boundaries by adding, say, new islands or territories, subsequent to its US occupation of the Philippines.

Although not directly connected to our definition of national boundary, conflict among states somehow altered boundaries of which the defeated states were ordered to return by the Allied powers the territories they occupied and annexed during the war. The Treaty of San Francisco signed on September 8, 1951 mandated Japan to renounce all rights and claims to the Spratley and Paracel islands. Even if the San Francisco Treaty has no reference to our claim in the South China Sea, the treaty nonetheless acknowledged China as having the sovereign right over those islands. The only thing that is unclear is whether the Treaty has reference to the People's Republic of China or to Taiwan which today, both remain politically at odds.

The second factor is our misunderstanding of the role of the US. Most Filipinos do not understand whether the presence of the US military bases here is purely pursuant to its hegemonistic interest as a world power or pursuant to our existing alliance with that country. Even on that issue, there are questions whether their involvement is not due to our claim in the South China Sea, or that the Philippines is a victim of aggression to which US Congress would still have to approve the US involvement considering that our alliance is merely based on an executive agreement and not a treaty similar to Nato, where an attack would mean an automatic retaliation from other member-states.

Even if the US has manifested several times that its naval presence in the South China Sea is to assure compliance to the freedom of navigation, which is of general application for free passage. However, that gives no assurance that the US would come to our assistance in the event of conflict with China over

WEAKENING | MAUTE-IS crumbling, but still a threat

CAMP GEN EMILIO AGUINALDO, Quezon City (DWDD) – The Maute-IS group is weakening, with the surrender recently of forty-two (42) of their members.

This was confirmed by Armed Forces of the Philippines Chief of Staff General Carlito Galvez.

With the latest surrender of a big number of Maute-IS members, the AFP is confident that even the support that this group is receiving is also dwindling.

Gen Galvez said that initially, there just ten (10) surrenderees, but after President Rodrigo Duterte had a conversation with them, this number has doubled.

He added that the recent Maute-IS surrenderees belong to a group they termed as PSR-listed and are known with the organization. Galvez believes that the success of the surrender efforts is due to the support of Local Government officials and the continuous rehabilitation of Marawi.

Meanwhile, Galvez stated that they have to confirm if Abu Dar is the new leader of the Maute-IS group, because he was the only survivor among the ten (10) leaders of the terror group that planned the Marawi siege.

"Abu Dar is the only remaining significant figure, all of the nine have been killed and neutralized already during the battle of Marawi," said Galvez.

Galvez added that the AFP is strengthening its intelligence monitoring to neutralize Abu Dar and the remaining Maute-IS members. He is also not in favor in the lifting of Martial Law in Mindanao, since the ML has helped the AFP in the success of its various campaign against terrorism.

A year since the declaration of Martial Law (ML) in Mindanao, Eastern Mindanao Command (EMC) has been consistent to its dictum in the implementation of Martial Law which is Necessity, Proportionality, and Rule of Law.

As a proof, the Commission on Human Rights and their Regional Offices have not forwarded any complaint on abuses and violation of human rights perpetrated by our troops (both from the PNP and AFP) relative to the implementation of Martial Law.

In the same manner, the Help Desk of the Ateneo Law School of Davao, a quick response mechanism which was developed to ensure that Martial Law will be implemented in accordance with the rule of law, has not forwarded any complaint nor called the attention of Eastern Mindanao Command for any misdemeanor or abuse in the ML implementation.

While there may be allegations, particularly from the progressive groups, these have not been substantiated nor proven by any means. We have challenged them to file cases and prove them in court.

As reported by the Philippine National Police, there was a significant reduction of crime rate all over Mindanao. Relatedly, the movements of terrorist groups and other threats have been limited, thereby preventing the occurrence of possible sabotage and terror attacks. Further, it also led to the arrest of different terrorist personalities in Eastern Mindanao during the implementation.

This security impact, likewise, contributed to the successful conduct of the recently concluded Barangay and Sangguniang Kabataan Elections.

While Martial Law is in effect, business confidence in the region is continuously growing as manifested by the 6.8 GDP growth and the increase in tourist arrivals, especially in Davao and other areas within Eastern Mindanao as per record of different local tourism offices.

Eastern Mindanao Command owes these to the different sectors for their support by giving inputs, suggestions, and comments to our units and troops to ensure proper implementation of the ML declaration.

While the Government continuously pursues rehabilitation in Marawi, the Eastern Mindanao Command continues to aggressively implement security measures and activities to shield its area from terroristic attacks. ZAMBOANGA CITY—Four members of the Abu Sayyaf Group (ASG) have separately surrendered this week to military authorities as offensives continue against the group in Basilan province, an official disclosed Friday.

Brig. Gen. Juvymax Uy, Joint Task Force Basilan commander, identified those who surrendered as

Uy said Ajalan, who ranks number 21 on the ASG wanted list, surrendered on Friday to the Army's 18th Infantry Battalion in Ungkaya Pukan, Basilan.

Uy said Ajalan brought along with him an M-16 Armalite rifle with attached M-203 grenade launchers and ammunition when he surrendered. He has two brothers, who also joined the ASG: Mudzri Usuluddin, who was captured during a firefight in 2016; and Jabir Ajalan, who surrendered last year.

He said Haron, Arangli and Jalil have surrendered to the Army's 18th Infantry Battalion on Monday also in Ungkaya Pukan, Basilan. They turned over three M-16 Armalite rifles when they yielded.

Uy said Jalil confided to them that the ASG is using illegal drugs to lure more youths to join them. He added that the military will continue to partner with different local government units in Basilan to convince ASG members to surrender and live peaceful lives.

The Autonomous Region in Muslim Mindanao (ARMM) has recently launched livelihood programs for surrendering ASG members in Basilan province.

More than 1,600 Chinese structures in South China Sea

From Rappler (May 26): More than 1,600 Chinese structures in South China Sea

From basketball courts to buildings with radar equipment, nearly 800 of these Chinese structures can be found in the West Philippine Sea

China has constructed more than 1,600 structures in the disputed South China Sea, and nearly half of these can be found in waters belonging to the Philippines.

This is based on data exclusively reviewed and published by Reuters on Thursday, May 24.

The data came from the non-profit group Earthrise Media, which analyzed satellite images by DigitalGlobe. The building counts spanned the years 2014 to 2017.

Basd on these data, nearly 800 of these Chinese structures can be found in the West Philippine Sea, the part of the South China Sea that belongs to the Philippines. In particular, the Chinese structures can be found on the artificial islands constructed on the following reefs:

- Subi Reef, "now home to nearly 400 individual buildings," according to Reuters
- Mischief Reef and Fiery Cross Reef, that "each house almost 190 buildings and structures"
 China has constructed hundreds of other structures on the Paracel Islands, which the Philippines does not claim.

All in all, China has built 1,652 buildings in both the Spratly Islands, which the Philippines claims, and the Paracels.

"In total across both island chains, China has erected more structures than all other occupants combined," Reuters reported.

Here is Reuters' breakdown of the structures built by different claimants the South China Sea:

China - 1,652 buildings Vietnam - 338 buildings Philippines - 100 buildings Taiwan - 37 buildings Malaysia - 28 buildings

Reuters also noted the "shift of focus and massive expansion in the Sprattys" as of 2017.

Between 2014 and 2015, for example, there were 554 buildings in the Spratlys and 730 in the Paracels.

A few years later, there were already 1,350 buildings in the Spratlys and 805 in the Paracels.

"Most of this is due to China's island-building drive there," Reuters reported.

Capable of holding up to 2,400 troops

DigitalGlobe images "show neat rows of basketball courts, parade grounds, and a wide variety of buildings, some flanked by radar equipment," according to Reuters.

"Subi is the largest of China's seven man-made outposts in the Spratlys. The so-called 'Big Three' of Subi, Mischief and Fiery Cross reefs all share similar infrastructure – including emplacements for missiles, 3-km runways, extensive storage facilities, and a range of installations that can track satellites, foreign military activity and communications," the wire agency reported.

Analysts cited by Reuters, including Singapore-based Collin Koh, "said the facilities on Subi, Mischief, and Fiery Cross could each hold a regiment – between 1,500 to 2,400 troops."

Rappler is still trying to reach the Philippine Department of Foreign Affairs for comment as of posting time.

The Reuters report comes after Chinese state media said Chinese bombers <u>have landed</u> for the first time on an island in the South China Sea.

The DFA has chosen not to publicly condemn China over these bombers, saying it was not its policy to "publicize every action" it takes.

President Rodrigo Duterte earlier stressed the need to remain "meek and humble" to receive the "mercy" of the likes of Chinese President Xi Jinping.

Acting Chief Justice Antonio Carpio and former Philippine foreign secretary Albert del Rosario, however, <u>urged the Philippine government</u> to file a diplomatic protest over the Chinese bombers.

"Failure to formally protest means the Philippines is acquiescing or consenting to the militarization, and worse, to the claim of China that all the islands, waters, and resources within the 9-dash line form part of Chinese territory," Carpio said.
