'No amnesty application, admission of guilt'

Before departing for Israel, President Duterte ordered the arrest of his arch critic Sen. Antonio Trillanes IV, issuing a proclamation that voided the amnesty granted in 2010 to the former Navy officer for his involvement in coup attempts against the Arroyo administration.

Proclamation No. 572, declaring as "void ab initio." or void from the beginning, the amnesty for the senator, citing the latter's alleged failure to comply with the minimum requirements to qualify under an amnesty program.

Duterte signed Presidential the President's issuance of the issued by a Makati court before proclamation dated Aug. 31 before he left for Israel. The justice chief is the designated government caretaker while Duterte is abroad. Duterte is scheduled to leave Israel for Jordan today.

With the amnesty invali-Justice Secretary Menardo dated, Trillanes can be arrested Guevarrayesterday confirmed on the strength of a warrant

he was given amnesty by the Aquino administration, Guevarra pointed out.

"There must be formal filing of application and there must be an expressed admission of guilt on the crime charged for you to be eligible for anmesty. Based on the review taken,

he did not comply with these requirements," Guevarra said at a press conference.

"This means the amnesty never existed. It's not revoked or something that was given and being taken back," the DOI chief ex-

plained.

"The Armed Forces of the Philippines and the Philippine National Police are ordered to employ all lawful means to apprehend former LTSG Antonio Trillanes so that he can be recommitted to the detention facility where he had been incarcerated for him to stand trial for the crimes he is charged with," Duterte said in his procla-

"The grant of amnesty to former LTSG Antonio Trillanes IV under Proclamation No. 75 is declared void ab initio because he did not comply with the minimum requirements to qualify under the Amnesty Program," the President said in his

proclamation.

Duterte said Trillanes was granted amnesty pursuant to the decision of an ad hoc committee in the defense department and approved by then defense chief Voltaire Gazmin.

Trillanes was a junior Navy officer when he and several other fellow officers took over Oakwood Premier serviced residences in 2003 and the Manila Peninsula in 2007 - both in Makati City - to force the ouster of then president Gloria Macapagal-Arroyo, whom

they accused of corruption and poll fraud.

"The matter of taking a look on whether an amnesty granted is valid or not is something that can be done at any time because, as you may probably have seen from the proclamation, if it's declared to be void, that grant of amnesty is declared to be void, it can be attacked at any time because it's void," Guevarra added.

He also said the amnesty granted to Trillanes by then president Benigno Aquino III in 2010 does not have a

proscription period.

"The matter of timing is irrelevant, there is no time element or prescriptive period as we call it in legal parlance, for something to be attacked. if from the beginning it is void," he said.

"It's there in the proclamation," Guevarra said, referring to possible enforcement of any pending arrest order. "I guess if he has a pending case, at an RTC, and I think there was an ongoing military tribunal, at that time, then I guess all of this will have to proceed and if taking him into custody is an automatic effect of that, then so be it."

In revoking the grant of anmesty, Duterte said in his proclamation that Trillanes never expressed his guilt for the crimes that were committed" during the siege of Oakwood and the Peninsula

"CIDG (Criminal Investigation and Detection Group)

can already effect the (arrest) order," Guevarra said. referring to a Makati court's supposedly pending arrest warrant on Duterte.

The DOJ chief also recalled the Makati RTC Branch 148 was supposed to decide on the coup d'état case against Trillanes but held off action due to the amnesty grant.

#### No persecution

Guevarra also denied allegations that the proclamation was a form of persecution of Trillanes, a vocal critic of the Duterte administration.

"This has nothing to do with him being in the opposition. This is about compliance with the law," he

explained.

The DOJ chief said that Trillanes anyway has lawyers and would know the legal

remedies to pursue.

Guevarra added that while the proclamation applies only to the case against Trillanes, the Palace is reviewing the amnesty for other Magdalo soldiers who joined the Oakwood mutiny and the Manila Peninsula siege and are facing coup d'etat and rebellion cases before the Makati RTC.

In compliance with the proclamation, DOI prosecutors filed vesterday afternoon an urgent motion seeking issuance of alias warrant of arrest against Trillanes to "update" the arrest warrant previously issued against him.

They also sought the immediate issuance of a hold departure order against the senator.

Makati RTC Branch 148

said it will review Trillanes case. "We have to review the records again because this actually involves about 53 volumes and the case started from another judge," branch 148 presiding Judge Andres Soriano told reporters after receiving a motion from Senior Deputy State Prosecutor Richard Fadulon for the issuance of hold departure order and alias warrant against Trillanes.

"I will see what I can do, but I really don't think if I can. I'm still trying to retrieve the records. If it's not in the office, it's in the bodega," he

Asked if there was a standing arrest warrant against Trillanes, Soriano said there was a previous dismissal of the charges against the senator.


"I don't think there is a standing warrant of arrest right now," he said.

To his knowledge, Soriano said the DOJ motion is the only pending case in his sala involving Trillanes.

In a related development, Solicitor General Jose Calida refused to comment on his role in Duterte's issuance of Proclamation 572.

"I'm sorry, I cannot discuss that because we have what we call privileged communication between the lawyer and the clients, which is the Republic of the Philippines." Calida said in an interview.

For chief presidential legal adviser Salvador Panelo, there is no need for Congress' concurrence for Proclamation No. 572 to take effect.

"Aside from the grounds mentioned in Proclamation No. 572, the amnesty can be declared null even without the concurrence of a majority of all the members of Congress," Panelo said.

Duterte, as President, is the official authority considered by the 1987 Constitution as the only one empowered to grant executive clemencies, Panelo said.

"The State cannot be shackled by an act of clemency it has given to a political offender when the latter pursues subsequent acts inimical to its interest and violative of its fundamental charter," Panelo said.

He stressed it is inherent upon the state, acting through the President, to protect itself from assault coming from whatever source.

"As chief executive and head of government, he has the power to issue orders protective of the State and its people. This is in line with the prime duty of the government to serve and protect

the people under Article II, Section 4 of the 1987 Constitution," he emphasized.

While the Senate and the House of Representatives had concurred with Proclamation No. 75, Panelo noted that the two chambers had recommended that no application for amnesty shall be given due course without the applicant admitting his guilt or criminal culpability.

Consistent with such recommendation, the DND Ad Hoc Amnesty Committee crafted an implementing rule, which basically states that no application shall be approved without an express admission by the applicant of actual involvement or participation in activities detrimental to the state.

"As such, the amnesty granted to Senator Trillanes is void ab initio or one which is to be treated as invalid from the outset," he pointed out. – Marvin Sy, Robertzon Ramirez

President Duterte has ordered the arrest of his critic. Sen. Autonio Trillanes IV, after revoking his amnesty on the grounds that the former Navy officer who staged a mutiny 15 years ago had not applied for amnesty.

In Proclamation No. 572 dated Aug 31 but first made public through its publication in a broadsheet on Tuesday. Mr. Duterte also said Trillanes had not admitted his guilt.

The absence of an application and admission of guilt makes the amnesty granted to the senator in 2011 void from the start, the President said.

He directed the Department of Justice (DOI) and the Armed Forces of the Philippines to pursue all criminal and administrative cases against Trillanes in relation to the Oakwood mutiny in 2003 and the siege of The Peninsula Manila in 2007. Both took place in Makati City.

#### Arresting team

The President also tasked the Philippine National Police and the AFP with acresting Trillanes to stand trial for his al-

"The past finally caught up with Senator Trillanes," presidential spokesperson Harry Roque said on Tuesday in Israel. where Mr. Duterte is on an official visit

#### Military court, coup case

In the proclamation, the President said the former putsch leader did not file an Official Amnesty Application Form, as attested to by an Aug. 30 certification from Lt. Col. Thea Joan Andrade, chief of the discipline. law and order division of the Office of the Deputy Chief of Staff of Personnel.

Trillanes also never admitted his guilt for taking part in the Oakwood mutiny and Manila Feninsula siege during the administration of President Gloria Macapagal-Arroyo,

Mr. Duterte said:

When Proclamation No. 75 granting amnesty to Trillanes and several other mutineers was issued, he was facing trial before the military tribunal. He was also under trial for a coup d'etat case in the Makati Regional Trial Court (RTC).

Justice Secretary Menardo Guevarra on Tuesday said that reviewing the validity of an amnesty proclamation could be done at any time.

The President's order to arrest Trillanes, Guevarra explained, stemmed from the parture order against Trillanes. court-martial proceedings that were halted when the amnesty was supposedly granted.

He said the review of the amnesty granted to Trillanes was discussed as far back as 2013 by the Office of the Solicitor General and Malacanang lawyers,

In the wake of the President's order, the military willreconvene a general court-martial for Trillanes.

#### OSG query

AFP spokesperson Col. Edgard Arevalo said the revocation of the amnesty would bring Trillanes back to his former status as military officer with the rank of Navy lieutenant.

Being reverted to active military service also meant that the senator would have to be taken into military custody, Arevalo said.

Arevalo said it was the Of-

fice of the Solicitor General (OSG) that gueried about Trillanes' application for amnesty with the AFP office of the deputy chief of staff for personnel, the records custodian

There was no available record on file," he said.

Arevalo said the document was not missing but was just "not found at the time" of the Solicitor General's inquiry.

The DOI on Tuesday filed a motion at the Makari RTC asking for the issuance of an alias. warrant of arrest and hold de-

# No intention to destroy Phi's alliances - Russian envoy

Russia has no intention to inflict any damage on the Philippines' close relationship with the United States and its traditional allies and partners, Russian Ambassador Igor Khovaev said Monday night.

It is possible for the Philippines to have strong security cooperation with Russia while at the same time maintaining its strong alliance with the US and other traditional allies, according to the envoy.

"Yes, why not? That's why I would like to repeat... we have no intention to inflict any damage to a close relationship of the Philippines with your traditional allies and partners. And as ambassador, believe no need to explain me... I have never received any instructions from Moscow from my government in this respect. Our aim is absolutely different – to build a new partnership between our two countries," Khovaev told "The Chiefs" Monday night on Cignal Khovaev added.

liance in the Asia-Pacific region because the security must be for all, not for a select (few)," he said. Russia provided guns, trucks, helmets

"It's just a donation, of course, and it was our meral duty to support your country in your legitimate struggle against terrorism because for us Russians, there's no need to explain what terrorism means. My country, we suffered a lot from terrorism and all responsible members of the international community must put all contradictions aside and to combine efforts in the struggle against terrorism," Khovaev added. # BRP Del Pilar towed out of Hasa-Hasa Shoal

The grounded Navy vessel BRP Gregorio del Pilar was pulled out of Hasa-Hasa (Half Moon) Shoal late Monday, ofncials said.

"The operation to bull out the Philippine Navy ship that ran aground in Hasa-Hasa Shoal that started at around 2 p.m. Monday was a success." Col.

Edgard Arevalo, spokesman for the Armed Forces of the Philippines (AFP), said yesterday.

Arevalo cited the report of Commodore Rommel Jason Galang, commander of Joint lask Force Goyong, who said the ship was extricated from the shoal before midnight Monday.

Arevalo said preparation for the towing of the ship to Subicis now underway.

The ongoing preparations would include the thorough inspection of the vessel's current state after her successful removal from the shallow portion of Hasa-Hasa Shoal by combined military and civilian salvage teams.

The BRP Gregorio dei Pilar, a former US Coast Guard cutter, ran aground on Hasa-Hasa Shoal in the West Philippines

Batazara town in Palawan on Wednesday.

The warship was conducting a patrol mission when its starboard side hit a submerged feature in Hasa-Hasa Shoal. The accident is now under investigation.

Following the incident, the AFP activated Joint Task Force Goyong to coordinate military

# PH removes warship from disputed shoal

The Philippine Navy extricated one of its largest warships which ran aground in a shoal near a hotly disputed region in the South China Sea.

Two Philippine security officials said on Tuesday that tugboats were used to pull the BRP Gregorio del Pilar from the shallow fringes of Hasa-Hasa (Half Moon) Shoal before midnight.

The frigate, which was being towed back to a Philippine port, ran aground during a routine patrol last Wednesday night, damaging some of its propellers. Its more than 100 crewmen were unburt.

The barren shoal is on the eastern edge of the disputed Spratly archipelago, where tensions have run high in recent years, after China transformed seven disputed reefs into islands and reportedly installed missile defense systems.


Philippine defense officials notified their Chinese counterparts after the accidental grounding of the Philippine Navy frigate at the shoal, which Beijing claims, to avoid any misunderstanding.

Defense Secretary Delfin Lorenzana said last week that China offered to help but that the Philippines would handle it.

A Chinese frigate, which ran aground on the shoal in 2012, was pulled away by Chinese military ships.

#### Propellers damaged

A military report seen by AP said the propellers of the BRP

Gregorio del Pilar were damaged by the grounding. The crew checked the frigate after it ran aground and reported that it was not taking in water,

At least four Philippine Navy and Coast Guard ships were deployed to secure the BRP Gregorio del Pilar and provide food and other supplies to its sailors. Tugboats were hired to extricate the ship, according to Col. Noel Detoyato, a military spokesperson.

#### Former US ships

The frigate is one of three former US Coast Guard cutters, which were acquired by the Philippine military and are the Philippines' largest warships.

Hasa-Hasa Shoal lies about 110 kilometers from the south-

ern tip of Palawan and south of the disputed Ayungin (Second Thomas) Shoal, where a Philippine Navy transport ship was intentionally grounded-in-1999and has since served as a Philippine military outpost.

#### China militarization

China has repeatedly demanded the removal of the now rusty BRP Sierra Madre from Hasa-Hasa Shoal, which is claimed by the Philippines and China.

The United States and Asian governments, which have claims in the disputed sea, including the Philippines, have raised alarms over China's island building and militarization of the strategic territory. —AF

Arevalo earlier said Galang led a team of sailors, divers, airmen, marines, and civilian experts to determine how they can successfully extricate BRP Gregorio del Pilar with least collateral damage to herself and the environment. Arevalo said Galang has been aboard FF-15 since Saturday and has been rendering periodic report to the Western Command, Philippine Navy, and General Headquarters in Camp Aguinaldo, on the status of the ship.

Reports earlier reaching the General Headquarters at Camp Aguinaldo, Quezon City, said BRP Gregorio del Pilar ran aground in the vicinity of Hasa-hasa Shoal, West Philippine Sea late in the evening of August 29, 2018.

AFP Public Affairs chief Col. Noel Detoyato said all afloat vessels in the Western Command were mobilized to conduct assessment, retrieve the aground vessel and return her to safe harbor, and assist all personnel aboard BRP del Pilar.

"Other assets from nearby AFP installations were on standby for any contingency, reports also indicated that none of our personnel on board have been hurt due to the incident," Detoyato said. 4

### Former Army captain in Oakwood mutiny doubts rearrest

Customs official and former Army captain Alvin Ebreo doubts that his amnesty will be revoked because he has complied with all the requirements.

## 'Amnesty valid, final, irrevocable'

The amnesty granted to opposition Sen. Antonio Trillanes IV and other former military rebels was valid, former president Benigno Aquino III said

yesterday, as Albay Rep. Edcel Lagman argued that it could not be revoked by President Duterte because it was approved by Congress.

went through the process and was granted amnesty means that it was valid. It was not void," Aquino said in mixed English and Filipino in an interview with TV5.

He said no one opposed the amnesty application of Trillanes and military colleagues who rebelled against the administration of his predecessor, former president and incumbent Speaker Gloria Macapagal-Arroyo.

Lagman said Proclamation No. 75 dated Nov. 24, 2010 issued by Aquino and concurred with by Congress under Concurrent Resolution No. 4 dated Dec. 13 and 14, 2010 "does not provide for any revocation clause."

Consequently, he said Duterte's decision to scrap the amnesty grant to Trillanes "has no legal and factual basis."

"Amnesty, which obliterates past offenses, is final, absolute and irrevocable, unlike a presidential conditional pardon. Alleged present transgressions of a grantee are immaterial and do not militate against the grant of amnesty," he added.

Lagman explained that the President's power to grant amnesty with the concurrence of Congress is contained in Article VII, Section 19 of the Constitution.

"An amnesty is granted to a class of people, while a presidential pardon is given to a specific individual and does not need the approval of Congress. An amnesty obliterates the offense, while a pardon erases the penalty," he said.

Aquino said the amnesty grant allowed the former soldiers "to start anew."

He added that his grant had not been questioned "for the past seven to eight years." The former chief executive pointed out that Duterte's decision to withdraw the amnesty he granted to Trillanes has implications for any future amnesty program.

"They applied, complied with the process and suddenly, it is withdrawn. Perhaps, next time, they will think for how long amnesty would last? They would think twice in laying down their arms," he said.

If Trillanes were to be arrested, the basis should be an arrest warrant, according to Aguino.

In 2007, then president Arroyo pardoned former president Joseph Estrada after the Sandiganbayan convicted him of plunder.

Lagman said he could not remember any law providing for rules and procedures on applying for appears.

applying for annesty.
"Generally, the applicable rules are those issued by the Department of National Defense. One has to apply and comply with certain requirements," he said.

#### Diversionary tactic

The revocation of the amnesty-granted to Trillenes proves that the Duterte administration would do everything to silence its critics, Vice President Leni Robredo said yesterday.

Robredo also sees Duterte's Proclamation 572, which declared Trillanes' amnesty as "void," as a tactic to divert the public's attention from the government's failures to address the problems being faced by Filipinos.

"Politicking has no place in times when many of our countrymen are facing hunger, poverty and lack of employment opportunities," Robredo said.

"As elected officials of

the government, we have been entrusted with the power to find solutions and not to advance personal interest," she added.

Robredo said the Duterte administration's latest attack against its critics causes not only divisiveness but also hopelessness among Filipinos

"We urge this administration to honor the amnesty given to Senator Trillanes and to immediately stop wasting money on senseless quarrel and instead focus its attention on the needs of the

#### 'Abuse of presidential powers'

Filipino people," she said.

Trillanes' fellow Magdalo and Lagman's opposition colleague Rep. Gary Alejano said Duterte's amnesty revocation "is arbitrary, illegal and clearly an abuse of presidential powers."

"Senator Trillanes was already cleared from all charges. He has duly complied with all requirements set forth by the laws for his amnesty. The proclamation issued by Duterte, therefore, has no basis at all," Alejano said.

"The administration is panicking and trying to silence the opposition," he added.

Alejano was not discounting the possibility that Duterte might also scrap the amnesty granted to him by the Aquino government, but that he would fight it through the legal process.

"They could do that to me and other recipients of amnesty given by previous administrations. That amnesty was given to all. We have long heard that they wanted to do this. They studied it and this is clearly a case of political persecution," Alejano said.

He said Duterte's revoca-

tion of the amnesty granted to Irilianes, his fiercest critic at the Senate, is a "clear act of revenge."

"Fifteen years ago, we stood up against corruption in government. Today, we remain standing and fighting against abuse of power,"

Alejano said.

The congressman filed the first impeachment complaint against Duterte in the early part of last year. The President's allies at the House of Representatives later dismissed it for lack of merit.

#### 'Crazy' decision

Another opposition congressman, Edgar Erice of Caloocan City, described Duterte's decision as "crazy."

Erice said he does not believe Aquino amnestied Trillanes and other rebellious soldiers if they did not apply for it.

dismiss the official who recommended Trillanes' amnesty revocation.

Meanwhile, the Commission on Human Rights (CHR) said frillanes should be allowed to exhaust all legal remedies to challenge the revocation of his amnesty.

"As first and foremost a citizen or the Republic with rights protected by the Constitution, we hope that Senator Trillanes will be allowed to exhaust all legal means in seeking recourse in light of this order by Malacanang," CHR spokesperson Jacqueline de Guia said.

"We will let due process and the rule of law take its due course, guided by the principle of fairness and sound judgment," she added. -With Helen Flores, Janvic Mateo



# Authorities to arrest Trillanes amid missing amnesty application

#### By JAIME LAUDE

As the Department of National Defense (DND) is trying to locate the missing amnesty application of Sen. Antonio Trillanes iv, the Armed Forces of the Philippines (AFP) has declared its readiness to implement the directive to take the senator anto custody.

DND spokesman Arsenio Andolong vesterday said they are still looking for the amnesty application of Trillanes, which he said is not available at the moment.

President Duterte signed Proclamation 572 revolving Trillanes' amnesty grant and ordered the arrest of the opposition senator.

Andolong issued the statement at a press briefing yesterday in supporting Solicitor General Jose Calida in claiming Trillanes had failed to apply for amnesty. The AFP, on the other

hand, said Trillanes would be reverted to active duty as Navy Lieutenant Senior proceedings.

AFP spokesman Col. Edgard Arevalo said Trillanes was an active military officer when he was charged in his involvement in the 2003 Oakwood mutiny and Peninsula hotel siege in 2007...

Arevalo said Trillanes will be facing a reconvened orders of acting Armed Forces chief Lt. Gen. Salvador Melchor Mison.

Trillanes, a critic of the President, is facing charges for conduct unbecoming an officer and gentleman and conduct prejudicial to good order and military discipline, among others.

Trillanes, who won a seat Grade to face court-martial in the Senate while in detention in 2007, applied for amnesty in January 2011.

He took his oath of allegiance before then defense secretary Voltaire Gazmin after his amnesty application was approved by then president Benigno Aguino TIT

Calida said he requested general court martial on the AFP for Trillanes' amnesty records last Aug. 30.

# Palace voids Ifiliares amnesty

Senator not in amnesty list; Senate won't allow arrest within its premises – Sotto

resident Duterte has revoked the amnesty granted to Senator Antonio Trillanes IV by then President Benigno S. Aquino III in connection with two

attempts to overthrow the Arroyo administration.

In Proclamation No. 572, the President declared the amnesty given to Trillanes in 2010 as "void ab

initio" since he failed to apply for such amnesty and did not admit guilt for the crimes committed.

"The grant of amnesty to former LTSG Antonio Trilianes IV under Proclamation No. 75 is declared void ab initio because he did not comply with the minimum requirements to qualify under the Amnesty Program," the proclamation read.

Duterte also pointed out in the proclamation that Trillanes "never expressed his guilt for the crimes that were committed on the Oakwood Mutinty and Peninsula Manila Hotel Siege."

"Despite former LTSG Trillanes IV's failure to apply for amnesty and refusal to admit his guilt, his name was nonetheless included among those granted amnesty pursuant to DND (Department of National Defense) Ad Hoc Committee Resolution No. 2 approved by former Secretary of National Defense Voltaire T Gazmin," it said.

Justice Secretary Menardo Guevarra supported the proclamation, saying Trillanes failed to meet the requirements to qualify for the government's amnesty program.

"There are certain requirements for grant of amnesty, one of them is you need to apply for it. Number two, you have to admit what you have done and to be sorry for it. In other words, you have to make a confession and admit that you were wrong," he added.

But in a privilege speech during the Senate's session Tuesday afternoon, Trillanes presented proof that the amnesty granted to him was valid and that the charges were already dropped by the courts.

He showed before the Senate plenary a video clip of a radio report in January, 2010, when he submitted his application form before the Department of National Defense (DND) Ad Hoc Committee handling the amnesty program.

"That is the application form... That is the personal appearance." Trillanes said while presenting the video clip showing him filing his amnesty application form in Camp Aguinaldo.

As a consequence of Trillanes' alleged failure to comply with amnesty requirements, the President has authorized the arrest and prosecution of Trillanes for his involvement in the 2003 Oakwood mutiny and the 2007 Manila Peninsula Hotel siege against the administration of then President Gloria Macapagai-Arroyo.

#### No arrest in Senate - Sotto

But Senate President Vicente Sotto III said the Upper Chamber will not allow Trillanes or any other senator to be arrested within its premises.

Sotto, in an interview following a meeting with Trillanes, said senators agreed that authorities should not be allowed to arrest the opposition lawmaker inside the Senate building to preserve the institution's dignity.

"To preserve the dignity of the Sen-

ate, we have decided not to allow any senator to be arrested within Senate premises. Outside Senate premises, that's no longer our concern but within Senate premises that is the decision of the leadership," he said.

As of press time last night, Trillanes has decided to stay at the Senate

Aside from authorizing the arrest of Trillanes: Duterte ordered the Department of Justice (DOJ) and the Armed Forces of the Philippines (AFP) "to pursue all criminal and administrative cases" against the beleaguered senator in relation to the two mutinous incidents.

The Philippine National Police (PNP) and the AFP have also been directed "to employ all lawful means to apprehend" Trillanes"so he could be recommitted to the detention facility where he had been incarcerated for him to stand trial for the crimes he is charged with."

#### 'Amnesty can't be revoked'

But Trillanes explained that the granting of an amnesty is an act of Congress and cannot be superseded by an Executive Order.

"Hindi mo pwedeng bawiin ang amnesty. Ano ba yun? I was already subjected to that nung na-try ako tapos na dismiss. Ano ngayon, uulitin yun? Ano ba yan? Magpaturo nga sila sa mga law students (You can't revoke an amnesty. I was already tried and the case was dismissed. So now, it will be tried again? They should seek advice from law students)," the beleaguered senator said.

The Senate minority bloc, led by Senator Franklin Drilon, backed Trillanes and questioned the legality of Proclamation No. 572, saying that the amnesty granted by the Aquino administration was valid and already ruled upon by the courts.

"I'm sorry but we strongly believe that the amnesty is valid; number two, the validity of the application of Senator Trillanes was already ruled upon by the court when the court dismissed the rebellion and coup d'etat case against Sen. Trillanes on the basis of the amnesty," Drilon fold reporters in a hastily called press conference with the latter outside his office.

#### DOJ seeks arrest warrant

While Duterte authorized the arrest of Trillanes, the DOJ filed Tuesday afternoon before the Makati regional trial court (RTC) a motion asking for the issuance of an alias warrant and a holddeparture order (HDO) against the senator. However, there were reports that it will take the RTC around three to four days to issue the alias arrest warrant.

Guevarra also said the DOJ will reopen the charges against Trillanes over the Oakwood mutiny and the Manila Peninsula siege. 🥪

"After proper review of the records of this case, we have determined that it is

something that is ripe for reopening that there are grounds to reopen the case, then the first order of the day is simply to asl, the court for the issuance of an alias warrant so that the person of the accused will be brought in the custody of the court." Guevarra told reporters.

In 2010, then President Aguino issued Prociamation No. 75 granting amnesty to active and former military and policemen and their supporters involved in the Oakwood mutiny Marines stand-off in 2006, and the Manila Peninsula incident.

Trillanes-a-former-Navy-officer detained for seven years at the PNP custodial center pending his trial, was among the officers allowed to walk free by Aquino.

#### Not in amnesty list

But Acting Prosecutor General Richard Anthony Fadulion revealed Tuesday that Trillanes was not in the list submitted by the Amnesty Commission to the court trying the coup d'etat charges.

Fadulion recalled that in 2010, Makati City RTC Branch 148 Judge Oscar Pimentel was supposed to hand down a decision on the coup d'etat case concerning the Oakwood mutiny when defense lawyers filed manifestations that all 31 accused have sought amnesty. Pimentel eventually suspended the promulgation.

Pimentel later retired and Judge Andres Soriano took over.

In 2013, Fadulion said, the court approved the list submitted by the Amnesty Commission.

"But when I looked at the records, it did not include Sen. Trillanes," said Fadullon, referring to the list submitted by the Amnesty Commission.

#### Trilianes back as military

Meanwhile, Armed Forces of the Philippines (AFP) spokesman Colonel Edgard Arevalo said that President Duterte's revocation of the amnesty granted to Trillanes in connection with two attempts to overthrow the Arroyo administration effectively brings him back to his former status as a military personnel

"That being the case, he will again be subject of military regulation, including the Articles of War which every military personnel in the active service is supposed to be subjected," he added.

Arevalo said even though Trillanes is already retired from the military service, he can be again subjected to court

martial proceedings.

"Therefore, yung (the) court martial will have to be re-constituted kasi yungibang (because the other) members ng (of the) court martial has already retired. So in which case, the acting AFP Chief of Staff Lt. Gen. Salvador Mison Jr., has already instructed the convening of a general court martial that shall be hearing the case of Lt. Trillanes," he added.

The military spokesman told reporters that court martial proceedings against Trilianes was only stopped after amnesty was granted to him by then President Aguino in 2010. (With reports from Mario B. Casavuran, Jeffrey G. Damicog, Francis T. Wakefield)

EN. Antonio Trillanes 4th submitted himself to the custody of Senate President Vicente Sotto 3rd on Tuesday, with the former Magdalo mutineer fearing he would be arrested without a warrant after the surprise revocation of his 2011 amnesty by President Rodrigo Duterte.

Trillanes spent the night in the Senate building under the tight watch of the chamber's sergeant at arms, after delivering a privilege speech rejecting the basis of the revocation laid down by Duterte's Proclamation 572.

"My lawyers are exhausting all legal remedies to-void this stupid executive order." I will abide by the wisdom of the Senate leadership," Trillanes said in an interview.

### Trillanes under Senate custody

The senator refused to go with members of the Philippine National Police Criminal Investigation and Detection Group (CIDG) who went to the Senate supposedly to arrest him, saying they did not possess a warrant.

Trillanes, however, said he would not resist an arrest order, if implemented by authorities.

"I will pack my things. I will not hide definitely." he said.

Trillanes accused Solicitor General lose Calida of instigating the revocation of his amnesty and carrying it out on the day he was supposed to investigate contracts obtained by the Calida family's security agency from various government agencies.

"So, we're living basically in a 'defacto' martial law environment of the 1970s kind. The assurance given to me by the Senate president is that for as long as I'm in the Senate premises, he will not allow any arrest." Trillanes said.

Proclamation 572 revoked the Department of National Defense (DND) Ad Hoc Committee Resolution dated January 11, 2011 granting amnesty to Trillanes for leading the "Oakwood mutiny" in Makati City (July 2003), the Marines standoff in Taguig City (February 2006) and the Manila Peninsula hotel siege, also in Makati (November 2007).

Word on the surprise proclamation, signed on August 31 before the President left for Israel, spread after its publication on Tuesday in the classified ads section of *The* Manila Times.

#### 'No requirements'

In the proclamation, Duterte said Trillanes failed to comply with the minimum requirements to qualify for an amnesty proclamation, application for amnesty and admission of the crime.

"The admission of the crime is important. The amnesty is part of beneficence on the part of the state, what happened before will be erased and the crime will not exist anymore but the admission of the crime should be done. Senator Trillanes did not admit anything," Malacañang spokesman Harry Roque Jr. said in a news conference in Israel, where the President was on an official visit.

Duterte, in the directive, ordered the Department of lustice (Dol), the Armed Forces of the Philippines and the Philippine National Police to pursue all criminal and administrative cases against Trillanes, who was a lieutenant senior grade, equivalent to captain, in the Philippine Navy.

Col. Edgard Arevalo, the military spokesman, said the Armed Forces' leadership had instructed the convening of the general court martial or the military court to try Trillanes for mounting coup attempts during the term of former president and now House Speaker Gloria Macapagal-Arroyo.

Trillanes insisted he had complied with amnesty requirements.

"You will not be granted amnesty if you don't have any application. That's clear. That's why this is a clear case of political persecution because they cannot find any case against me. So, they need to invent," he said.

#### No warrant yet

The Dol immediately asked the Makati Regional Trial Court (RTC) to issue an arrest warrant and hold departure order against Trillanes.

The three-page "Very Urgent

Ex Parte Omnibus Motion" was signed by the officer in charge of the prosecutor general's office, Richard Anthony Fadullon, Senior Assistant State Prosecutor Juan Pedro Navera and Assistant State Prosecutor Mary Jane Sitat.

ludge Andres Soriano of the Makati RTC Branch 148 said an arrest warrant could not be issued immediately.

Soriano said he still had to review 53 documents on the Oakwood and Manila Peninsula incidents, some of which he was yet to obtain from the court warehouse.

"Based on this case, I don't think he would be arrested," he told reporters.

Any other arrest would be considered a warrantless arrest, which would need legal basis, the judge said.

#### Senators hit order

Senators from the majority and minority blocs said on Tuesday Proclamation 572 had no basis and that pursuing a criminal case against Trillanes would amount to double jeopardy, which is prohibited under the Constitution.

Senate Minority Leader Franklin Drilon pointed out that the Makati court had dismissed the criminal cases against Trillanes.

Drilon added that when amnesty was granted to Trillanes, it was as if no crime was committed.

"lurisprudence provides that the grant of amnesty abolishes and puts into oblivion the offense itself, it so overlooks and obliterates the offense with which he is charged that the person released by amnesty stands before the law precisely as though he had committed no offense," he said, citing jurisprudence in the Barrioquinto vs Enrique case. Drilon lauded Senate President Sotto for instructing the Senate sergeant at arms to bar arresting officers on Tuesday.

Senate President Pro Tempore Raiph Recto said charges should have been filed against Trillanes if he had violated the law, instead of revoking the 2011 ampesty.

Detained Sen. Leila de Lima condemned Duterte's proclamation, saying it was a political move to try to silence Trillanes.

Albay Rep. Edcel Lagman said any amnesty revocation needed the concurrence of Congress.

In a statement, the lawmaker said Proclamation 75 issued by then President Benigno Aquino 3rd in 2010, the original amnesty proclamation concurred in by Congress, did not provide for a revocation clause.

"Consequently, the reported revocation by President Rodrigo Duterte of the amnesty granted to Sen Antonio Trillanes has no legal and factual basis," Lagman noted.

In a separate statement, Akbayan party-list Rep. Tomas Villarinsaid Duterie's order was no more than "political vendetta against a very vocal critic."

Vice President Maria Leonor Robredo said: "The decision of the Palace to declare the amnesty granted to Trillanes as void is another proof that this administration is willing to do anything to silence its critics."

Jose Luis Martin Gascon, head of the Commission on Human Rights, said he would look into the implications of the revocation of the amnesty proclamation.

#### Magdalo, Aquino: Application valid

The Magdalo party-list composed of Trillanes' fellow ex-mutineers showed a video of the senator submitting an application form for amnesty at the Department of

National Defense, and publicly admitting guilt.

"We are man enough to admit that we committed mistakes...We faced the consequences...It waseasy for us to do that. Members of Magdalo who were also present at that time could attest to this," the party said.

Ex-president Aquino said Trillanes' application was in order, and that it was given to him on January 25, 2011

"We will assist him as far as we are able to, to be able to defend his rights and the rights of anybody else in this country," he told CNN Philippines.

Trillanes, 47, campaigned for and won a Senate seat from his prison cell in 2007. He got the 11th spot out of 12 vacant seats with 11.2 million votes. He was reelected in 2013, placing ninth with 14.1 million votes.

After spending seven years in prison on coup d'état charges. Trillanes was sworn into office by then-Senate President Juan Ponce Enrile and was finally able to attend his first Senate session on January 17, 2011, three years late.

He emerged as a strident Duterte critic and accused the former Dayao City mayor of hiding P2 billion in bank transactions shortly before the 2016 presidential election.

in a speech before new barangay (village) officials in Cebu City last June 7, the President said there will come a day that someone will shoot him (Trillanes) because he's arrogant.

Trillanes dared Duterte to "go ahead [and] order somebody to shoot me," but warned the President "it would lead to your end."

### Noy-granted amnesty void ab initio

Admission of guilt is very important. He did not admit to his wrongdoings. Just because someone became senator doesn't mean he can escape the charges

From Israel where he is on a state visit. President Duterte yesterday voided the amnesty earlier given by his predecessor to Sen. Antonio Trillanes, his chief critic who vowed to fight the proclamation order nullifying his liberty for his alleged failure to submit the most basic of

documents required for his pardon.

Trillanes was condoned of his crimes for leading a coup de 'etat against a sitting Chief Executive by former President Benigno Simeon "Noynoy" Aquino in 2011, a political ally against another former President Gloria Macapagal-Arroyo, subject of the two failed putsches which Trillanes led.

But Malacañang's legal minds said Trillanes failed to submit a written request for his amnesty, reason for Mr. Duterte to void the presidential pardon issued by Aguino.

While in Israel, President Duterte-signed Proclamation 572revoking Aquino's pardon of the former Magdalo coup plotter.

Also, an alias warrant against Trillanes is now being prepared by the Department of Justice, according to Justice Secretary Menardo Guevarra, who added that Trillanes cannot use his legislative immunity from suit in order to prevent his arrest and

incarceration.

The coup d' etat case that was filed against the senator is a non-ballable offence and has a penalty of life imprisonment if found guilty as charged, Guevarra said.

The senator will be detained at Camp Aguinaldo where he was formerly held prior to the granting of amnesty after his arrest.

The documents for the request are being prepared before the DoJ formally asks the Makati Regional Trial Court Branch 148 to issue the warrant.

Guevarra clarified that the order to arrest Trillanes was relayed to the Armed Forces of the Philippines and the Philippine National Police. They were ordered to bring him to where he was incarcerated in 2011.

He said the burden of proving that he met requirements for amnesty lies with Senator Antonio Trillanes.

Guevarra explained that while Mr. Duterte's proclamation is a "revocation" of the amnesty by title, the text clearly stated that it nullified the amnesty, rendering it void from the moment it was issued.

He said while the title indicates a revocation, the contents of the proclamation shows that it actually nullified the amnesty as if it never existed.

It was set aside and it's a declaration that it was void from the start, Guevarra said,

It is not political persecution. He (Trillanes) was the one responsible for the Oakwood mutiny, he was the one behind Manila Peninsula (siege). He is the one responsible for his current state.

The justice chief also explained the senator failed to comply with two requirements for an amnesty: a formal application under oath and an admission of guilt.

Guevarra also emphasized that the review of the amnesty given to Trillanes has been there for some time and that the decision to issue the proclamation did not happen overnight, though he has no information on what prompted the review.

#### Court Martial

The Armed Forces of the Philippines (AFP), meanwhile, said it is preparing the formation of a General Court Martial to hear the charges against Trillanes.

Lieutenant General Salvador Mison issued the order, this was revealed by AFP Spokesman Col. Edgard Arevalo.

"The acting APP Chief of Staff Lt. Gen. Salvador Mison, Jr. has instructed the reconvening of the General Court Martial that shall be hearing the case of Lt. Trillanes."

From Israel, Presidential Spokesperson Harry Roque maintained that President Duterte is merely enforcing the law when he rescinded the amnesty granted to Trillanes IV.

He said it is political persecution.

persecution. He (Trillanes) was the one responsible for the Oakwood mutiny, he was the one behind Manila Peninsula (siege). He is the one responsible for his current state," Roque Jr. told members of the Philippine media delegation during a news briefing.

The President issued Proclamation 572, published

in a newspaper on

Philippine Navy officer involved in coup attempts 15 years ago.

The pardon, it said, was ab initio or voided from the beginning because the former military man failed to meet the requisites for amnesty, among them his admission of guilt.

"Admission of guilt is very important. He did not admit to his wrongdoings. Just because someone became senator doesn't mean he can escape the charges," Roque stated.

"If a case is declared void ab initio, it is the President's duty to rescind the decision and enforce the law. Even the previous administration should have known that admission (of guilt) and concurrence are prerequisites to granting an amnesty. It is not undoing the amnesty granted by the former President (Noynoy Aquino) because it was never valid," he added.

Roque said the proclamation applies only to the senator and the revival and review of all charges filed against him - and his fellow Magdalo soldiers - will soon follow.

Roque also refuted allegations that Mr. Duterte's decision was due to Trillanes' role as an opposition critic of the country's leader.

'Enforcing the law'

"That is not true. Like I said, this is just the President

"As a former prosecutor, he (President Duterte) knows the full force of the law must be enforced. The government assures Sen. Trillanes that he will be given his day in court," Roque said.

Trillanes vowed to face Duterte and claimed he had no plans of leaving the country.

He did not surrender to authorities, however.

To avoid arrest and as a matter of policy to preserve the dignity of the Senate as an institution, the Upper Chamber took custody of Trillanes.

"Basically, I was placed under the custody of the Senate President until my lawyers are able to "F file the necessary petitions before the Supreme

Court," Trillanes said.

"The assurance of the Senate President is that for as long as I am here at the Senate premises, he will not allow any arrest," he added. Trillanes was still at the Senate premises at the time of this printing.

Trillanes made the announcement after a brief meeting with his fellow opposition senators, led by Senate Minority Leader Franklin Drilon and Senate President Vicente 'Tito' Sotto.

Sotto said he is not taking the president's revocation of Trillanes' annesty as an attack against the Senate.

"The President is exercising his prerogative," Sotto said. "But we have not allowed Sen. Trillanes' arrest within the Senate premises."

As a practical remedy, we have requested the Senate President that the Senate take custody of Senator Trillanes pending remedies in our regular courts.

Drilon, however, maintained that Trillanes is not under arrest.

\*Certainly, the Senate President did not arrest Senator Trillanes. The Senate President and the Senate will uphold the dignity of the Senate We have to protect the institution by resisting any unwarranted and

unlawful acts against a member of the Senate,\* Drilon said.

#### 'Warrantless arrest'

Drilon explained that the Senate custody of Trillanes does not depend on the session of Congress. "The custody is defined by the boundaries of the building. The custody is when you voluntarily submit to the custody of another person," he said.

Trillanes cried "warrantless arrest" over the attempt by joint elements of the Philippine National Police (PNP) and the Armed Forces of the Philippines (AFP) to take him. This despite his earlier claim that he will respect the arresting officers.

"This is a warrantless arrest that is clear. The arresting officers have no warrant because in the warrant, the specific case is stated and the (recommended) bail. In this case, there is none," Trillanes said.

Drilon cited a constitutional provision that states (Trillanes) cannot be arrested while Congress is in session and when the case is punishable with less than six years imprisonment.

"Under the Constitution he cannot be arrested while congress is in session, except for crimes which the penalty is beyond six years, in this particular case there is even no case. So with more reason that the constitutional protection will apply," Drilon explained.

"As a practical remedy, we have requested the Senate President that the Senate take custody of Senator Trillanes pending remedies in our regular courts," he added.

The minority

leader lauded Sotto for accommodating the opposition's request.

"In fairness to Senator Sotto, even before we came in, he had already directed the Sergeant at Arms not to allow the arresting officers to come into the premises," Drilon shared.

To avoid arrest, Trillanes should not leave the Senate premises.

The presidential proclamation, however, provoked opposition from other legal experts with constitutionalist and former

Solicitor General Florin Hilbay claiming President Duterte could not commit a unilateral act of voiding Trillanes' amnesty by his predecessor Aquino.

Aquino, elected president in 2010 after Macapagal-Arroyo's extended nine-year term, set Trillanes free after his reelection as senator following two campaigns launched from the military stockade where he was confined for leading two coups in 2003 and 2007.

## Trillanes vows to void 'stupid E0'

SENATOR Antonio Trillanes IV told reporters on Tuesday he has instructed his lawyers to study ways "to void this stupid executive order" of President Rodrigo Dutene revoking his amnesty for a failed coup attempt over a decade ago, adding it "has nobasis whatsoever." Next page

"This is a clear case of political persecution, but I will not cower. There's a time for reckoning for you and your minions," he added in a written statement.

The political opposition also chimed in, with Vice President Leni Robredo saying Duterie just wanted to silence his detractors and to hide the problems besetting the country.

"There must be no politics here at the time when our fellow countrymen are faced with so many problems, such as hunger, poverty and lack of employment. As elected public officials, we are given the trust and authority to look for solutions, instead of pushing for our personal interests," she said.

"We call on the [Duterte] administration to recognize the amnesty granted to Senator Trillanes and stop wasting the [people's] money and time on feuds," Robredo added.

Trillanes said Duterte and his allies were making themselves look stupid simply to get rid of him, and dismissed their claim that he had not complied with the requirements of his amnesty.

"This is a big stupidity. I would not be given amnesty if I did not comply with the requirements. I vowed before former [Defense] Secretary Voltaire Gazmin and defense officials can attest to this, so absolutely, these were all complied in the cases in civilian courts," Trillanes told reporters in an interview as he demanded the basis for his arrest.

During the session, Trillanes delivered a privilege speech blasting the cancellation of his amnesty.

Trillanes presented a video showing that he filed his amnesty application and media interviews wherein he admitted that he, along with other Magdalo soldiers, "broke the rules in pursuit of moral cause."

"It is clear from the video that I swore

under oath in this application, admitted being guilty based on the application form provided by the Department of National Defense [DND]," said Trillanes as he emphasized that his amnesty certification passed through a process.

He said a 15-day period was given for any oppositor to file a motion for reconsidcration. Since no objection was made, he said, the grant of amnesty is final.

He further showed a copy of court ruling from the regional trial court where his rebellion charge was dismissed. He said his criminal charge for coup d'etat was also thrown out by the court.

He reiterated his question involving the basis for his arrest. He also argued there can be no lawful arrest as indicated by the President to the PNP and Armed Forces of the Philippines due to the absence of an artest warrant.

"What crime? What court? This is the biggest stupidity he [President] did for this day," Trillanes said.

He also thanked the Senate leadership under Senate President Vicente Sono III and his colleagues for expressing their concern in his case. "We will be stronger if we unite." he said.

But Trillanes said he applied for amnesty and complied with all the requirements.

Trillanes blamed Solicitor General Jose Calida for the move to revoke his amnesty, saying he wanted to stop a Senate investigation into lucrative government deals that his security firm had bagged.

He branded Duterte a coward for letting

Calida do his dirty work.

Senate President Pro Tempore Ralph Recto also said Trillanes IV was granted amnesty, not by one person but by the 11.189,671 people who voted for him.

Recto said Trillanes should be granted every opportunity to challenge the revocation of the amnesty in complete freedom.

PRISIDENT Duterte has worked the grant of amnesty to Sen. Antonic Trillanes IV, a former Navy licutemant who was among leaders of a muriny 15 years ago, for alicgedly failing to comply with recuirements for the elemency, including admining guilt.

He also ordered Trillanes' arrest. The President signed on Au-Rust 31 Proclamation Order 572 which revoked Resolution No 2 (#1) that was issued by an ad hoc committee of the Department of National Defense on Jan. 31, 2011. The resolution granted amnesty to then liquienant senior grade Trillanes who was then facing several charges including coup d'érat

Justice Secretary Menardo Guerenta said based on the Proclama tion 572. Trillanes failed to comply with the requirements for amnesty grant, which are to apply for amnessy and admit one's guilt.

Proclamation No. 572 also instructed the Department of instice and the Armed Forces "to pursue all criminal and administrative cases" filed against Trillanes in connection with the July 2003 Oakwood Mutiny, the Tebruary 2006 Marines stand-off, and the Manila Peninsula "siege" in November 2007.

The incidents all happened under the administration of former President now Speaker Gloria Macapagal Arroyo, an ally of President Duterie.

Trillanes, Durerte's most vocal opnonent, has accused him of hiding wealth, and has supported petitions to the International Criminal Court seeking his indictment over the alleged murders of thousands of suspected criminals and drug dealers

Trillanes filed his annestr application on Jan. 5, 2011 and this was widely covered by the media. He took an eath before Desense Secretary Voltaire Gazmin after his application was approved by a DND-AFP amnesty committee.

In the application, I tillanes and the other applicants admitted drag their act constituted a violation of the 1987 Constitution, criminal laws and the Articles of War.

Proclamation 572 directed the Armed Forces and the PNP to "employ all lawful means to apprehend" Trillanes so he can be recommitted to the detention facility where he had been incarcorned for him to stand that for the crimes he is charged with.

"The grant of amnesty to former Lr (s.g.) Antonio Trillanes IV under Proclamation No. 75 is declared void ab inicio because he did not comply with the minimum requirements to qualify under the Armesty Proclamation," the proctamation said.

III in November 2010. Proclamation 75 grants amnesty to active and former police and military personnel and their supporters, who have committed crimes punishable under the Revised Penal Code, the Articles of War, and other laws in connection with the Oakwood Mutiny, Marines standoff, and Manila Peninsula incident.

Presidential spokesman Harry Roque, in a briefing in Israel where the President is on official visit, said politics had nothing to do with the issuance of the proclamation voiding the amnesty grant, and the President was just implementing the law.

He said the decision on Trillanes' case was reached after about two years since the Duterte government started a review of decisions and issuances issued by the previous Aquino administration.

He said in a mix of Filipino and English: "This has been two years in the offing, and they first had to find the records. They had to make sure that Trillanes does not really have an application and had not admitted his guilt. Second. there was also maximum tolerance being applied on Senator Trillanes. But in the end, it is the job of the President to implement the laws; and when a grant of amnesty is void ab initio, it's part of the role of the President to rescind it or declare it as void ab initio."

#### NOT MISSING'

Roque said based on AFP records certified by Lt. Col. Thea Joan Andrade of Discipline, Law and Order Division of the Office of the AFP's Deputy Chief of Staff for Personnel, "there is no available copy of the application" of Trillanes for amnesty.

Asked if this means that Trillanes' application was missing, Roque-said-it-is-not-missing-because there was none.

Asked about media footages showing Trillanes submitting his application for amnesty, Roque said government goes by official records.

He also said it was not only Trillanes' case that is being reviewed but also of others who received atmesty:

Roque expressed belief the amnesty grant was a political accommodation to Trillanes.

"Let's say that the amnesty granted to him was political. He was friendly with the previous administration that is why he was granted amnesty, without compliance with the requirements set by law," he said.

Defense department spokesman Arsenio Andolong said it is the first time an amnesty was withdrawn.

Told that Trillanes went to Camp Aguinaldo to fill up the amnesty application form and there was admission of guilt, Andolong said: "Per records of the DND and AFP, the application is not available at the moment. We're still looking for them."

"The certification issued on that day, on that hour, that they are not available. But it does not mean that we have ceased all our efforts to find them...We are still looking for the documents," said Andolong.

#### VOID AB INITIO

Guevarra; in a briefing, explained Proclamation 572.

"It's as if the amnesty never existed, never been valid. It is a declaration that it was void from the beginning, from the moment it was issued," he said.

"There is no time element here or a prescriptive period since from the very beginning, the amnesty is void ab initio," he also said.

Guevarra also said while the Constitution states that the Presi-

dent has the power to grant amnesty with the concurrence of all members of Congress, there is noneed for the concurrence of Congress in Duterte's proclamation because the amnesty was void abinitio.

Guevarra also said the review on the amnesty "might have been studied in the past by the Office of the Solicitor General and the review of the granting of the amnesty "probably came from OSG lawyers and Malacanang lawyers.

"This matter of review has been there for quite some time, it's not as if it happened for five days ago. I think this is being discussed a couple of years ago, as far back as 2013," he further said.

Asked if the amnesty granted to other members of the Magdalo group that staged the Oakwood mutiny would also be declared void, he said, "For now the proclamation only covers him but I believe that maybe others who might be similarly situated are, also their applications are also being reviewed. Not too sure about that but since there is a review ongoing it might include not only Senator Trillanes but also the others."

#### COURT MARTIAL

The Armed Forces has ordered the convening of a general court martial that will try Trillanes.

In a press briefing in Camp Aguinaldo, AFP spokesman Col. Edgard Arevalo said Trillanes will be tried by the military tribunal for violation of Article of War 96 or conduct unbecoming of an officer and a gentleman.

Arevalo said the voiding of Trillanes' amnosty reverted him to the status of a Navy lieutenant subject to military regulation.

Trillanes, a member of the Philippine Military Academy Class of 1995, and hundreds of military officers and enlisted men were de-

tained and tried by a military court in connection with the failed Oakwood mutiny.

He was also involved in the Manila Peninsula case in November 2007 and was charged with rebellion before a Makati City.

Trillanes and many others involved in the plots to oust Arroyo availed themselves of the amnesty proclamation issued by Aquino, erasing the crime against the coup plotters.

Arevalo said the court martial proceedings against Trillanes were stopped because of a "supervening event," referring to the amnesty grant.

"Now that the amnesty was revoked ab initio, meaning from the beginning, he will be reverted to his status as active military personnel subject to military law and discipline," Arevalo also said.

"The court martial will have to be reconstituted because some its members have already retired. In which case, the acting AFP chief of staff, Lt. Gen. Salvador Mison Jr., has already instructed the convening of a general court martial that shall be hearing the case of Lt. Trillanes," added Arevalo.

Arevalo said the Office of the Solicitor General inquired from the office of the AFP deputy chief of staff for the amnesty papers of Trillanes. "They do not have a copy of it (application) on file," he said.

Copies of Trillanes' amnesty application spread on the internet yesterday.

"If the senator decides to present that as part of his defense, we are more than welcome to see it," Arevalo said.

"He can use that to validate his claim that he submitted an application and we're perfectly willing to verify if the document is authentic... It will be subject to authentication and of course he can use that to validate his (defense)," said Andolong. — With Victor Reyes and Reuters



### Trillanes cries 'persecution'; placed under Senate custody

SEN. Antonio Trillanes IV was placed under the protective custody of Senate President Vicente Somo III yesterday, hours after Malacañang declared as void the amnesty granted to him by former President Benigno Aquino III in

"It was agreed by the Senate leadership that I remain under the custody of the Senate President until my lawyers have filed the necexeat) perition against the illegal and unconstitutional revocation of meanness," Trillages said after a meeting with Souto and Senate minorin leader Franklin Drilon.

"What Mr. Duterte wants to happen is to order a warrantless arrest which seems to declare a defacto martial law," he added.

Trilianes decried the Palace proclamation voiding his annestr as a "clear case of political persecution."

"Mr. Durerte, duwag ka Irantay

mo pang makaalis ka bago mo nilahas itong proclamation mo. (Mr. Duterte, you are a coward. You waited until you have left before you made your proclamation public.) The senator called Duteric's proclamation as a "big joke" and insisted he complied with

all requirements when he was granted amnesty in 2010.

He said that when he filed his application for amnesty, he even took his oath in front of then officials of the Department of National Defense led by former defense secretary Voltaire Gazmin.

He added all cases filed against him in connection with the Oakwood Hotel occupation in 2003 and the Manila Peninsula Hotel siege in 2007 have been dismissed by a Makati court on the basis of his amnesty.

"My amnesty was granted after all requirements have been complied with. I even took oath in front of then defense officials. All my cases covered by the amnesty have been dismissed," Trillanes said.

While under Senate custody, Trillanes said he will remain at the premises of the Senate.

He said his lawyers will file the necessary petition before the Supreme Court and question Duterte's Proclamation 572, which states that the amnesty extended to him was void from the start because he did not comply with the "minimum requirements to qualify under the amnesty-proclamation."

Members of the PNP Criminal Investigation and Detection Group arrived at the Senate grounds at around 10 a.m. but failed to enter the building on orders of Sotto.

Sotto said "the matter concerning one of our colleagues will have to be discussed by the Senare as a collegial body.

Sotto, in a text message to reporters, said all senators backed his decision not to allow the arrest of Trillanes within the Senate premises.

"(They) unanimously support my position," Sotto said when asked for an update on the allsenator caucus held on Tuesday afternoon.

Sotto said he has directed the Sergeant-at-Arms not to allow the arrest of any senator within its premises to preserve the dignity of the Senate.

Sotto also said Trillanes can stay in the Senate as long as he wants but probably with "some limitations," which he said senators will "take up later depending on how the courts will decide on his warrant of arrest."

The Department of Justice (DOJ) has already asked the Makati

City regional mal court to issue an alias warrant of arrest and a hold departure order (HDO) against Trillanes.

Senators denounced Duterte's proclamation was meant to stiffe dissent.

Drilon said the arrest of Trillanes has no basis and that the correctness of the amnesty granted to him has already been ruled by the court.

"All questions were ruled upon by the court when it dismissed the case. So there is no case today," he said. "If they want to file another case, first, they must go to court and file another case, and execute a warrant, if warranted."

He, however, said Trillaner can no longer be charged for the same offense because of the double jeopardy principle.

Sen. Francis Pangilinan said Proclamation 75, which granted amnesty to the Trillanes in 2010, was concurred in by Congress.

"It could not be easily set aside by the whims of one man. The Constitution provides that an amnesty proclamation requires the concurrence of both Houses of Congress and therefore, the said revocation requires our concurrence and is therefore not immediately executory." Pangilinan said.

"Absent\_our\_concurrence, any arrest is illegal. We urge the Armed Forces and the PNP not to enforce an illegal arrest," he also said.

Sen. Risa Hontiveros echoed Pangilinan's position

"While the Executive has the power to grant amnesty, it must have the concurrence of a majority of all the members of Congress. The same goes with revocation," she said in a statement.

Sen. Paolo Benigno Aquino IV said the opposition will not back down amid threats from the administration.

Senate Majority Leader Ralph Recto said Trillanes was granted amnesty by when 11,189,67 Filipinos voted for him when he sought a Senate seat in 2007 while in detention.

"When I lost my 2007 re-election bid, one of the first congratulatory calls I made was to the detained Sonny Trillanes. In my mind, here was a guy who, without setting one foot out of prison, was granted amnesty, not by one person but by 11,189,671 people." Recto said

"When he won the reelection in 2013, more people - 14,127,722 million this time - affirmed that the absolution earlier bestowed on him was right," he added.

"If he had committed offenses after Peninsula, if he had broken any law since, then the right course is to charge him, and not to nullify an amnesty that he applied for, recommended by the military, granted to him by the President, and concurred in by Congress," he added.

Trillanes' fellow mutineer, Rep. Gary Alejano (PL, Magdaio) said the development was a clear political persecution of members of the opposition and warned he might be the government's next target because of his vocal criticisms of the administration.

Alejano said no presidential proclamation can nullify an amnesty that has an effect of an existing law as concurred in by Congress.

"We expect that they (administration) will do everything (to silence the opposition)," he told reporters. "If we can no longer speak up, what more if you are just an ordinary citizen?"

Alejano said he is ready to face the threat of arrest if Duterte also revokes the amnesty granted to him in connection with his participation in the 2003 Oalrwood mutiny.

"They might do the same thing to me but I'm nor worried We will and stand up to it and find legal remedies," he said. "We will not turn our back from our responsibilities. It's clear that the government only wants to silence dissent."

· He said the administration is apparently going after its critics, citing the arrest of Sen. Leila De Lima and the ouster of formerchief justice Ma. Lourdes Sereno.

Alejano said that contrary to the lies that the administration is spreading about the reasons for the cancellation of the amnesty granted to Trillanes, there was an application form filed before the defense department, including an admission of guilt, and cited a video taken in 2011 at the DND premises showing a copy of Trillanes' application for amnesty.

With regard to the admission of guilt, he said the video also recorded Trillanes saying: "We are man enough to admit that we committed mistakes... We faced the consequences... It was easy for us to do that."

"Members of (the) Magdalo who were also present at that time could attest to this," Alejano said.

Rep. Edcel Lagman (LP, Al-

bay), a leader of the opposition bloc at the House, said Aguino's Proclamation No. 75 issued on November 24, 2010 and which was concurred in by Congress under Concurrent Resolution No. 4 on December 13 and 14, 2010 does not provide for any revocation clause.

"Consequently, the reported revocation by President Rodrigo Duterte of the amnesty granted to Sen. Antonio Trillanes has no legal and factual hasis," Lagman said.

He added that since a presidential declaration of amnesty needs the concurrence of the majority of all the members of both the House and the Senate pursuant to section 19 of Article VII of the Constitution, any revocation, if at all allowable, needs the same congressional concurrence.

"Amnesty, which obliterates past offenses, is final absolute, and irrevocable unlike a presidential conditional pardon. Alleged present transgressions of a grantee are immaterial and do not militate against the grant of amnesty," he said.

Vice President Leni Robredo slammed the Palace decision and said this was "another proof" that Duterte was bent on silencing his critics.

"Ang desisyon ng Palasyo na ideklarang void ang amnestiyang binigay kay Senato: Antonio Trillanes IV ay isa namang patunay na gagawin ng administrasyong ito ang lahat para patahimikin ang sinumang kumokontra rito (The decision of the Palace to declare void the amnesty granted to Senator-Antonio Trillanes: IV is another proof that this administration will do everything to silence all those who oppose it)." Robredo said.

Robredo questioned the timing of the Palace announcement, alleging the matter was made public to distract the public's attention from the country's problems such as continuing rise in prices of commodities, the ongoing rice crisis, corruption allegations being faced by several officials, and worsening traffic situation.

Meanwhile, Commission on Human Rights (CHR) chair Chito Gascon shared the position of other legal luminaries that once a presidential amnesty is granted, it could not be revoked.

He vowed to look study the revocation of the amnesty granted to the opposition senator. – With Wendell Vigilia and Angela de Leon

# DU30: 'War is insanity'

TEL AVIV, Israel — Following an apology for an earlier Hitler remark, President Rodrigo Duterte said "Never Again" to a repeat of the world's ugly history.

The Chief Executive likened himself to Adolf Hitler two years ago, a remark that resonated negatively to the Jewish community and has since apologized for before he visited Yad Vashem - a memorial dedicated to preserving the memory of those who bravely fought Hitler and perished in the Holocaust.

The President brought with him his daughter, Sara Duterte-Carpio, the Davao City mayor whose mother Elizabeth Zimmerman belonged to a family of Jewish settlers in the Philippines.

"I cannot speak for how my daughter feels now, but she is one of those generations that came after," Mr. Duterte said, referring to his children's Jewish roots. Zimmerman was Duterte's first wife by whom he had three children - two sons and Duterte-Carpio.

But his statement likening himself to Hitler dogged the President who received rebuke from some leaders and politicians halfway through his historic visit to Israel.

The Philippine leader atoned for his mistake by visiting the Yad Vashem and the Hall of Remembrance where he said everyone must learn from the terrors of the Holocaust, adding: "War is insanity."

"I could not imagine a country obeying an insane leader. And I could not ever fathom the spectacle of a human being going into a killing spree, murdering old men, women, children, mothers," the President stated.

He added visiting Yad Vashem had a deeper meaning for Sara, whose mother Zimmerman came from a Jewish family that fled Nazi Germany and found refuge in the Philippines.

The country opened its doors to more than a thousand refugeesfrom Germany and Austria during the Holocaust in World War II.

The Chief Executive toured the rest of the museum and wrapped the visit up by offering a wreath in the Children's Memorial.

Before leaving Yad Vashem, the President wrote a dedication in the guest book that read: "Never again. May the world learn the lesson of this horrific and benighted period of human history. May the hearts of the peoples around the world remain

ever open. And may the minds of all men and women learn to work together toward providing a safe haven for all who are being persecuted."

Earlier in the day Mr. Duterte had a monumental first meeting with Prime Minister Benjamin Netanyahu.

The Philippine leader atoned for his mistake by visiting the Yad Vashem and the Hall of Remembrance where he said everyone must learn from the terrors of the Holocaust.

During the face-to-face that lasted a few hours, the President expressed how israel and the Philippines "share the same passion of peace" and thanked Israel for giving "critical help" in freeing Marawi City from the hands of the ISIS-inspired Maute Group.

The President also said he is grateful to Israel for hosting some 28,000 Filiping workers.

President Duterte signed Presidential Proclamation 572, invalidating the grant of amnesty to Trillanes for failure to comply with its minimum requirements

The ghost of the failed Oakwood Mutiny continues to haunt Sen. Antonio Trillanes IV.

On 27 July 2003 the Magdalo rebel soldier's group occupied the Oakwood Premier hotel in Makati with explosives to protest the alleged corruption in the administration of then President Gloria Macapagal-Arroyo.

The soldiers disarmed the security guards and planted explosives around the

building and its vicinity.

Trillanes was designated as the spokesman for the rebel group.

While the rebel soldiers initially refused to heed the initial 5 p.m. deadline given by Malacañang to vacate the premises they later capitulated and agreed to return to their barracks around 10 p.m. the same day and the rebellion was declared over by 11 p.m.

The rebel soldiers were charged and tried in a general court marrial. During one of the hearings in August of the same year. Trillanes alleged that Arreyo kept on talking during a dialogue with the soldiers instead of listening to the grievances of the soldiers.

More than a year after the mutiny, Trillanes and the Magdalo leaders ate humble pie and apologized for the failed rebellion.

Trillanes was seen on national television being manhandled by a police official, dragging him into a bus by his belt buckle.

On 24 September 2004. Trillanes, along with five other alleged ringleaders of the 2003 uprising – Army Captains Gerardo Gambajari Mpalle

Gerardo Gambala and Milo Maestrecampo, Navy Lieutenant James Layug and Marine Captains Gary Alejano — gave a salute to President Arroyo during an event at Camp Aguinaldo.

The next month, Arroyo ordered 133 of the 321 soldiers freed, saying they were deceived by their officers into joining the mutiny.

In 2007, Trillanes capitalized on his media exposure during the failed mutiny and the court martial proceedings to run for the Senate and eventually won in the 14 May, 2007 elections after campaigning

# AMNESTY REVOKED

PRESIDENT Rodrigo Duterte has revoked the amnesty given to opposition Senator Antonio Trillanes IV in 2010 in connection with his involvement in unsuccessful attempts to overthrow the Arroyo administration.

Duterte's action was confirmed to the media yesterday by Justice SecretaryMenardoGuevarra.

The Department of Justice yesterday formally asked the Makati regional trial court to issue an alias warrant of arrest against the senator.

In a motion, the Doj also asked Makati RTC Branch48 to issue a hold departure order (HDO) preventing Trillanes from leaving the country.

Signed by Duterte on August 31, 2018, Proclamation No. 572 stated that the amnesty extended to Trillanes was void from the start because he did not comply with the "minimum requirements to qualify under the amnesty proclamation."

The President cited a certification from the Armed Forces of the Philippines Office of the Deputy Chief of Staff for Personnel that there is moavailable copy of Trillanes' application for amnesty.

Trillanes, a former Navy officer before entering politics in 2007, has also "never expressed his guilt" for the crimes committed in line with the Claswood Muttow in 2003 and Manula Peninsula Siege in 2007, the proclamation said

"Despite former LTSG (Lieutenant Senior Grade) Trillanes IV's failure to apply for amnesty and refusal to admit his guilt, his name was nonetheless included among those granted autresty pursuant to Department of National Defense Ad Hoc Committee Resolution No. 2 approved by former Secretary of National Defense Voltaire T. Gazmin," the proclamation stated.

With the revocation of Trillanes' anmesty, Duterte directed the Department of Justice and Court Martial of the AFP to pursue all criminal and administrative cases filed against the senator inconnection with the Oakwood and Manila Feninsula incidents.

The President also orderecide AFF and the Philippine National Police to arrest Trilianes "so that he can be recommitted to the deternion racility wherehe had been incarcerated for him, to stand trial for crimes he is charged with."

Malacañang denied politics was behind the decision of President Duterte to wold the amnesty given to Senator Trillanes, one of his staunchest critics.

"There is nothing political. These are all his acts," presidential spokesperson Harry Roque Jr. said at a news conference in Israel, where Duterte is on official visit.

"It's two years in the offing. There was maximum tolerance shown but when it was confirmed na walang compliance with the requirements set forth for the amnesty wala naman pong alternatibo ang Presidente but to execute the laws. Trabaho lang po."

Roque also said the government will check if other mutineers are similarly situated.

Trillanes has branded as a political persecution themove of Duterte to void his amnesty. He also insisted that he applied for amnesty and complied with all the requirements.

Roque said Trillanes may challenge the President sproclamation before the courts.

### Trillanes in Senate building

Trillanes is set to camp out in the Senate Building which was being guarded outside by agents of the Philippine National Police (PNP) who are tasked to arrest him

Trillanes bared that the Senate minority bloc and Senate President Vicente "Tito" Sotto III agreed that he will be under Senate custody while he is pursuing legal action against the revocation of his amnesty.

"It was agreed to by the Senate leadership that I remain under the custody of the Senate President until my lawyers have filed the necessary petition against the illegal and unconstitutional revocation of my amnesty. What Mr. Duterte wants to happen is to order a warrantless arrest which seems to declare a de facto martial law," Trillanes said to the media.

The ally of Trillanes, Magdalo Rep. Gary Alejano, is ready to face the revocation of his amnesty.

"I am not dismissing the possibility that the amnesty granted tome can also be revoked given the power-tripping that the Duterte administration is resorting to. Hindi akon satatakot at handa kami sa anumang mangyayari dahil alam naming kami ay nasa tama," Alejano said 3

# Palace revokes Trillanes' amnesty

It will be back to the police detention facility for Senator Antonio Trillanes IV after President Duterte has revoked the amnesty granted to him in connection with two attempts to overthrow the Arroyo administration.

In Proclamation No. 572, the President declared the amnesty given to Trillanes in 2010 as "void ab initio" since he falled to apply for such amnesty and did not admit guilt for the crimes committed.

"The grant of amnesty to former LTSG Antonio Trillanes IV under Proclamation No. 75 is declared void ab initio because he did not comply with the minimum requirements to qualify under the Amnesty Program," the proclamation read.

As a consequence, the President has authorized the arrest and prosecution of Trillanes for his involvement in the 2003 Oakwood mutiny and the 2007 Manila Peninsula Hotel siege against the administration of then President Gloria Arroyo.

Duterte ordered the Department of Justice (DoJ) and the Armed Forces of the Philippines (AFP) 'to pursue all criminal and administrative cases" against Trillanes in relation to the two incidents.

The Philippine National Police and the AFP have also been directed "to employ all lawful means to apprehend" Trillanes "so he could be recommitted to the detention facility where he had been incarcerated for him to stand trial for the crimes he is charged with."

In this connection, the Department of Justice filed before the Makati Regional Trial Court yesterday a motion to reopen the cases and issue an alias warrant and hold departure order against Trillanes.

"After proper review of the records of this case, we have determined that is something is ripe for reopening, that there are grounds to reopen the case," Justice Secretary Menardo Guevarra said.

Acting Prosecutor General Richard Anthony Fadullon disclosed that Makati RTC Branch 148 Judge Oscar Pimentel was set to promulgate a decision in 2010, but the promulgation was suspended after defense lawyers filed manifestations that all 31 accused have sought amnesty.

After Pimentel retired in 2010 and Judge Andres Soriano took over, Fadullon said that the court approved the list submitted by the Amnesty Commission in 2013.

The list did not include Trillanes, according to Fadullon.

In 2010, then President Aquino issued Proclamation No. 75 granting amnesty to active and former military and policemen and their supporters involved in the Oakwood mutiny, Marines stand-off in 2006, and the Manila Peninsula incident.

Trillanes, a former Navy officer detained for seven years at the PNP custodial center pending his trial, was among the officers allowed to walk

free by Aquino

In the latest proclamation. Duterte, however, pointed out that Trilianes did not file an official amnesty proclamation form required to avail of the program. "There is no available copy of his application for amnesty in the records," the proclamation read.

The same proclamation also noted that Irillanes "never expressed his guilt for the crimes that were committed on the Oakwood Mutinty and Peninsula Manila Hotel Slege.

"Despite former LTSG Trillanes TV's failure to apply for amnesty and refusal to admit-his guilt, his name was nonetheless included among those granted amnesty pursuant to DND (Department of National Defense) Ad Hoc Committee Resolution No. 2 approved by former Secretary of National Defense Voltaire T, Gazmin," it said.

The proclamation, issued last Aug. 31, took "effect immediately." The documented, published Tuesday, Sept. 4, on a newspaper, was later confirmed by Guevarra.

# 'Malaking kalokohan,' embattled senator cries

Senator Antonio Trillanes IV yesterday criticized Malacañang's move to revoke the amnesty granted to him by the Aquino government in January 2010, saying it was a clear case of political persecution.

The Senate leader, however, said that Trillanes' stay at the Senate would have limitations. He did not elaborate.

Facing the media, Trillanes said he would not be given amnesty if he was unable to comply with the requirements and filing an application form for amnesty.

The former navy lieutenant also said he also admitted his involvement in the unsuccessful attempts to overthrow the Arroyo administration in the July 2003 Oakwood Mutiny, the February 2006 Marines stand-off and the November 2007 Manila Peninsula standard.

Trillanes explained that the granting of an amnesty is an act of Congress and cannot be superseded by an Executive Order. D

Duterte, in his visit to YadVashem's Hall of Names with daughter Davao City Mayor Sara Duterte-Carpio, called Hitler insane and wondered how one country can follow such an insane leader.

"Me, I realized that war is insanity. And what happened here, in Europe especially under the Nazi. I could not imagine of a country obey an insane leader. And I could not ever fathom the spectacle of a human being going into a killing spree, murdering old men, women, men, children, mothers," he added.

Duterte said he is hoping that a tragedy like the Holocaust will not happen again and suggested that leaders who show signs of insanity should be disposed of immediately.

"I hope that this will not happen again. We have learned so much along the years during the two wars. There is always a lesson to be learned and that despots and leaders who show insanity should be—well they should be disposed of at the first instance," he said.

Duterte assured that the Philippines will be the first to speak loudly against a genocide that would stem from hatred.

"I would like to say that we are one in saying that it will not happen again and my country will be the first to voice (objection to) a massacre of a race just because of hate," he said.

The YadVashem's Hall of Names is Israel's memorial to Jews who perished at the Holocaust.

Aside from his daughter, Duterte was also joined in the tour by top Cabinet officials including Foreign Affairs Secretary Alan Peter Cayetano, Defense Secretary Delün Lorenzana, Labor Secretary Silvestre Bello III, Environment Secretary Hoy-Cimatu, and Executive Secretary Salvador Medialdea among others.

Duterte, joined by his daughter, laid a wreath at the Children's Memorial Hall. The venue is a tribute to the approximately 1.5 million Jewish children who were murdered during the Holocaust. The names of the children, their ages, and countries of origin can be heard in the background.

The Holocaust was a state-sponsored persecution and murder of around six million Jews by the Nazis who came to power in Germany in January 1933.

With Israel, the Philippines is celebrating the 81st anniversary of the Open Doors policy of the Philippines under then President Manuel L. Quezon who offered shelter to more than a thousand Jews escaping the holocaust in Europe.

According to Philippine Ambassador to Israel Nathaniel Imperial, the Philippine embassy and the Israeli government in 2009 dedicated the Open Doors monument in the city of RishonLezion to commemorate the humanitarian assistance extended to the around 1,300 Jewish refugees in the 1930s.



# AFP steps up patrol checkpoints in Kudarat

The Armed Forces of the Philippines (AFP) yesterday said that it has intensified the conduct of checipoints in Isulan, Sultan Kudarat following another blast that rocked the town Sunday night.

In a statement, APP Spokesman Coll Edgard Arevalo, said military units on the ground have further intensified the conduct of checkpoints in all of the town's entry and exil points to prevent terrorists from again placing IEDs (improvise explosive device)

"We have stepped up further patrols and intelligence efforts," Arevalo said

"We have (also) alerted our troops to augment PNP (Philippine National Police) efforts in the now ensuing police manhunt operations," he added

Arevaic said the AFP condemns in the strongest terms possible the cowardly attack that targeted innocent civilians.

He said the perpetrators' means of assaulting hapless victims through terror, death and destruction do not justify their ideals.

With this is mind, Arevalo assured that government security forces will address these vile aggressions with vehement counteractions and with the support of the community, they will get these criminals.

"(Also) with the help of the local residents, we can potentially prevent any repeat (of the incident)," he Said

Arevaio said the local govern nent of Isulan led by Mayor Marites Palasigue and the PNP are leading the efforts to hunt down the perpetrators behind the incident.

He added that the AFP extend its sincerest condolences to the victims of the bombing and assure their families that the AFP is one with them in their quest for justice.

Two persons perished while 14 others were wounded – three of them critically – as a result of the explosion.

Arevalo said the AFP is urging communities to unite in these attacks by terrorists targeting the lives of people, their freedom of movement, and the peace in the towns and cities.

"We urge every individual – every man or woman, young or old—to be vigilant and actively involved in reporting their observation of any suspicious activities or persons in their localities," Arevalo said.

The Army's 6th Infantry Division (6th ID) said they are looking at the possibility that the Daesh-inspired group under Esmael Abdulmalik alias Abu Toraife/Toraype, was behind the blast.

In an interview, AFP 6th ID spokesman Capt. Arvin Encinas said Sunday night's bombing in Isulantown, Sultan Kudarat was perpetrated by the faction under Abdulmalik, an influential cleric and skilled bomb expert, said to be involved in previous bombings in Maguindanao.

He said their main purpose is to sow terror and create fear in the community. The group's areas of operations are in Maguindanao and Sultan Kudarat.

"Itong pagpapasabog eh part ng retaliation nila as they suffered significant losses during our FMO (focus military operations)," Encinas said

With regard to criticism by some that another bombing incident happened in Sultan Kudarat despite the implementation of martial law in Mindanao. Encinas said terrorism is a global issue that even the most advance countries are having a hard time dealing with:



# Isulan mayor rejects BIFF claims state forces behind blasts

IDAPAWAN CITY – Isulan municipal mayor Marites Kapunan-Pallasigue dismissed as baseless allegations that state forces were behind the twin deadly blasts that hit her town.

Pallasigue, in a radio interview, said it would be absurd to believe such a thing.

Pallasigue hinted the Bangsamoro Islamic Freedom Fighters (BIFF) was more likely the group behind the series of bombings in Isulan.

"I was told by [Brig. Gen. Cirilito] Sobejana that this is just a retaliation [of the BIFF] because they're already overpowered and could not fight the Army," said the mayor, adding, "the military won't allow killing children and innocent civilians."

Pallasigue made the statement after BIFF spokesman Abu Misry accused the state forces of allegedly "masterminding" the so-called terror attacks in Mindanao.
"The BIFF has nothing to do with the bombings, instead, it's the Army and other state forces," said Misry.

The blasts that occurred on August 28 and September 2 killed five people and wounded 49 people, data from the police said.

As of this posting, no one among the terror groups operating in the country has claimed responsibility for the attacks.

# Cotabato Archbishop condemns Isulan bombings

COTABATO CITY: Orlando Cardinal Quevedo, OMI, DD, archbishop of Cotabato condemned the two bombings in the town of Isulan, Sultan Kudarat.

In a statement issued on Tuesday. Quevedo said the true believers in God have to cry out in outrage at the terrorist bombings in the Isulan adding that all religions are religions of peace.

He said the two bombings in a span five days, August 28 and September 2, have mercilessly snuffed out the lives of at least five innocent people, including two young men who were active in their Catholic youth ministry. Scores of others, equally innocent, have been wounded, he added.

The Islamic State (IS) reportedly claimed responsibility for the first bombing.

Some sectors suspect the Bangsamoro Islamic Freedom Fighters (BIFF) that had also pledged allegiance to IS. However, all the three BIFF factions have vehemently denied the accusations saying how could any member of their group bring an improvised explosive device and penetrate the heavily guarded town of Isulan without being detected.

"In either case, religion is distorted in order to commit brazen crimes that cry out to heaven," Quevedo said.

"As the religious leader of all Catholics in the Archdiocese of Cotabato, I absolutely condemn these terroristic acts. I enjoin every true believer in the one true God, by whatever name the almighty and merciful God is called, to pray for the victims and for their families," the cardinal's statement said.

Quevedo said, he is strongly urging the military, security and peace officers with the collaboration of the Moro National Liberation Front and the Moro Islamic Liberation Front, now forces for peace, to flush out the perpetrators and bring them to justice.



### Probers reviewing videos from blast site in Isulan

INVESTIGATORS from the Central Visavas Police Regional Office are reviewing CCTV footage to determine who were behind the explosion inside an internet shop Sunday night.

The blast, the second in the town in less than a week, killed two

persons and injured about a dozen others.

Supt. Aidrin Gonzales, regional police spokesman, said sceneof-the-crime operatives and local policemen have gathered CCTV footage from cameras mounted inside the Renz Internet Café in Barangay Kalawag 2, Isulan and areas near it.

The explosion killed Mark John Luda, 18, and his cousin Marialvn Luda, 15.

Gonzales said eight other victims remained confined in hospitals in Sultan Kudarat, while four others have been discharged.

Gonzales also said bomb experts are comparing the improvised explosive device used in the Sunday blast with that used in Barangay Kalawag 2-10n-August 28:

The PNP leadership and military officials are suspecting the Bangsamore Islamic Freedom Fighters, or a faction of the terrorist group, to be behind the bomb explosion, to prevent peace in Mindanao despite the passage of the Bangsamoro Organic Law.

The two explosions in Isulan in less than a week prompted the relief of Senior Supt. Noel Kinazo, Sultan Kudarat police chief, and Supr. Celestino Daniel, chief of police of Isulan town.

They were relieved to pave the way for an impartial investigation, the PNP said Monday. - Raymond Africa 132

### Duterte thanks Israel for Marawi battle help

PRESIDENT Rodrigo Duterte on Monday thanked Israel for its "critical" help in defeating Islamic Stateinspired rebels that laid siege to Marawi City last year.

Duterte extended the country's gratitude during his remarks prior to the signing of agreements he and Israeli Prime Minister Benjamin Netanyahuwimessed aithe premier's office in Jerusaiem.

"Mr Prime Minister, I can only thank you so much especially the critical help that you have extended my country intime when we needed it most," the President said:

Duterte declined to name the "very substan-

tial and crucial" equipment in his remarks but the President revealed during his meeting with the Filipino community on Sunday evening (early Monday morning in Maniia) that Israel provided "most of the intelligence gadgets that we used to win the Marawi siege."

"It was a help to preserve the Republic of the Philippines and I thank you for that," Duterte told Netanyahu.

Duterte was originally scheduled to visit in May last year but it was put on hold so he could supervise government efforts to crush militants led by the Maute group, whom he said were trying to establish a caliphate for the Islamic State.

In June 2017, the same group also claimed responsibility for an attack at the Resorts World Casine that left 37 people dead, most of them due to suffocation from the smoke. However, the National Capital Region Police then headed by now PNP chief, Director General ()scar D Albayalde denied that what happened was terror-related.

"They can always claim whatever they want to claim. They have this reputation of claiming all atrocities all over the world to perpetuate themselves to gain global notoriety. There is no truth that the incident is a terror act," Gen. Albayalde said then.

It turned out that the

lone gunman who entered the Resorts World Manila firing shots from an assault rifle and setting fire to gambling tables was a casine addiet who incurred huge debts and attacked the casine in an attempt to rob it.

"It should not surprise us that ISIS is now claiming responsibility for this incident in Basilan.

Initial investigation revealed that the Lamitan explosion was the handiwork of the Basilan-based faction of Abu Sayyaf led by Furuji Indama resulting from a botched extortion attempt, said Durana.

The official said the PNP is closely coordinating with military security forces and other government agencies to dig desper into the incidents in Basilan and Sultan Kudarat. "We have mobilized all available resources and personnel to strengthen defenses in other vulnerable targets." he said.

In the aftermath of the Sultan Kudarat bombing, Gen. Albayalde placed all police forces in Mindanao under full alert status while the NCRPO headed by Director Guillermo Lorenzo T. Eleazar was put on heightened alert.

Officers are also doubling up their intelligencegathering. However, Eleazar maintained that police have yet to receive information regarding direct terrorism threats in Metro Manila.

he passion and commitment to serve probably come second nature to them.

On September that year, the Moro National Liberation Front (MNLF) faction led by Nur Misuari stormed into Zamboanga City and held civilians hostage, a move that paralyzed the city, razed some 10,000 homes and reduced some 40 hectares of once-thriving communities to rubble, an inquirer report stated.

The following month, in October, saw Bohol being struck by a 72-magnitude earthquake, which destroyed structures, killed at least 200 people, and displaced more than 300,000 survivors. And in November, that year's strongest typhoon ravaged through Eastern Visayas, leaving a trail of destruction: more than 900,000 families displaced, more than 1 million houses damaged, left about 6,300 people dead, 1,000 missing and 28,000 injured.

### ZAMBOANGA SIEGE

September, 2013

"It was a Monday morning when we heard the gunfire. It was really a war and we didn't know if we would survive it. Add to that the mental torture of being invaded any time by the MNLF. But by September 13 (four days after the siege). I insisted that we open a branch because the clamor was there. Metrobank was one of the first banks to open then," Vice President Rita Ongrecalled of the Zamboanga City siege in September 2013.

Despite the fear, Ong related that almost all the Metrobankers in the area, from day one of the war, were calling her, asking when they would need to report for work.

"There is a willingness to help and serve our clients. I think I've got one of the best sets of Metrobank employees They're all brave and I can

see their passion to do their jobs. I have a very young group, with most of them being in service for three years or less but I'm grateful to them because they showed how it is to be a real Metrobanker, ready to (heed) the call to serve the clients and humanity," she further said.

### SUPERTYPHOON YOLANDA

November, 2013

It was no different for First Vice President Federico Mariano. His own house in Tacloban was destroyed by the neck-high floods triggered by torrential rains of Yolanda.

"I was with my family and we were inside the house. We cannot go out then and the following morning, there was a total blackout. But I braved the floods walked from my subdivision to the city, which was about 15 kilometers. After a three-hour walk, I reached the (Metrobank) office," Mariano recalled.

According to Mariano, the ground floor of the Metrobank office was totally destroyed.

His first instruction then was to

### Smiling Russia

or a Russian, Igor Khovaev smiles a lot. Russia's top diplomat in the Philippines himself says smiling does not come easily to many of his compatriots. He says his posting of two years in the Philippines has infected him with the ready Pinov smile.

ready Pinov smile.

But this is not the only reason the envoy is smiling these days and

even cracking jokes on national TV. Russians and Filipinos know so little about each other. Now bilateral ties have warmed significantly, thanks to President Duterte's foreign policy shift and open admiration for his Russian counterpart Vladimir Putin.

Ambassador Igor, as he prefers to be called, is now preparing for what he describes as his "dream" of contributing to the two countries' rapprochement, by laying the groundwork for a likely visit in Manile by Putin. It will be the first ever visit to the Philippines by a Russian leader.

Even if Putin changes his mind, however, and again sends in his stead Prime Minister Dmitry Medvedey, bilateral files have so warmed that the Philippines is considering buying big-ticket military equipment from Russia.

Ambassador Igor even proposed last year a joint production in the Philippines of Russia's world-renowned export, the AK-47 and other Kalashnikov weapons and ammunition.

Over 100 countries use Kalashnikovs, Ambassador Igor points out, and many of them also use weapons from other top defense equipment producers such as the United States. Russia, he stresses, knows how to deal with any technical compatibility problems.

We all know what could douse cold water on these warming bilateral ties: the Philippines' treaty ally the United States.

Randall Schriver, US assistant defense secretary for Asian and Pacific security affairs, recently cautioned the Philippines that the purchase of Russian military equipment such as submarines could harm the decades-old Philippine-US alliance.

The comment expectedly drew an acerbic rebuke from Duterte. Ambassador Igor, facing us on "The Chiefs" on Cignal TV's One News, described Schriver's comment as "outrageous," adding that Manila's traditional allies "have no right to interfere" in such matters.

Russia has no alliance with any state outside the former Soviet Union, Ambassador Igor emphasizes, because alliances shut out others. The Kremlin prefers partnerships, and it's time for the Philippines to "diversity" cooperation arrangements, he said. In the process, he said Russia has "no intention to inflict any damage" on the Philippines' traditional alliances.

Is the Philippines open to such diversification? Under Duterte, it seems likely.

As far back as 2007, Dmitry Medvedev had said in an interview, "It's an argument which dates back to Soviet times—is it better for the world to have a weaker or a stronger Russia?" Medvedev stressed that Russia is different from the Soviet Union and its "totalitarian tendencies."

"A strong, democratic Russia is good for the world. But I'm afraid that old concepts still hold sway among

many in the West," Medvedey said.

Russia is still under US-led sanctions for its annexation of Crimea and its support for the regime of Syria's Bashar al-Assad as well as accusations of interference in US elections. The British are also accusing the Kremlin of poisoning a Russian double agent and his daughter in England with the Soviet-era nerve agent Novichok in March this year, with two more Britons becoming critically ill from the same poison in a nearby town in July.

Moscow has vehemently denied the accusations, with suspicion raised that the Brits were trying to sabotage the goodwill generated by Russia's hosting of this year's

FIFA World Cup.

Several months ago, the US blacklisted Rosoboronexport, the state-owned Russian arms maker with which the Philippine government was working out the purchase last year of 750 rocket-propelled grenade launchers. The US has warned of sanctions on governments and private sector entities dealing with Russia's defense industry, including disruption of the delivery of the goods.

Duterie has brushed aside these developments and is forging ahead with strengthening ties with Russia and Putin:

Last year during the Marawi siege, Russia donated AK-47s with ammo and military trucks to Philippine troops battling Maute militants. Off-camera, Ambassador Igor told us with pride, "Russian trucks don't need a road, they just need a destination."

Beyond weapons, Russian businessmen are exploring other areas of partnership, including participation in Duterte's Build Build Build infrastructure expansion. Also renowned for their subways and extensive train network (the Trans-Siberian railway from Moscow to Vladivostok is the longest in the world), Russians will be constructing the Clark to La Union railway. In its rapprochement with Russia, is the Philippines turning its back on democratic ideals? If the world, including democratic Western Europe and the US, can be heavily

engaged with China, why not with Russia?

Ambassador Igor prefers to dwell on shared values, pointing to many things in common between Russians and Filipinos. One in particular has not been emphasized: Christianity. The envoy points out that while his country was a communist state for decades, many Russians are Orthodox Christians, and his country, like the Philippines, also has Muslims. Religion, he stresses, is much more binding "than any ideological principles."

He admitted that making people forget Russian stereotypes won't happen overnight and will take some effort.

"Look at me, I'm a typical Russian guy," he told us.
"Not those aggressive, stupid Russian guys" as portrayed by Hollywood, which he said has produced "not a single good movie" about his country.

He said the World Cup showed that "the absolute majority of Russian people are friendly and hospitable. They are normal people. We have the same values."

Referring to his country and the Philippines, he acknowledges, "We have never been close friends, but we have never had conflicts... there is nothing that can cast a shadow on the improvement of our relations."

He said defense cooperation is not only technical but

also "mental, psychological, even emotional."

"We have to overcome all possible prejudices. I believe it's possible. It's not easy but it's possible," he told us "My country has only one wish: to become a reliable partner and a close friend of the Philippines. And I believe this is mutual."

A ready smile, which Ambassador Igor says he flashes in Manila more often than in Moscow, is a good start.

### DND fuel supply bidding anomaly?

here are many ways of winning an open bidding process. Some methods are straightforward, while some involve the use of creative methods. Here's one that looks more like the latter.

Biz Buzz learned that there's a brewing controversy at the Department of National Defense over a P4.5-billion contract to supply the armed forces with fuel for an entire year. And at the root of the controversy, it seems, is some kind of preferential treatment that one bidder is getting over the other.

The controversy began in late May when one contender for the fuel supply contract, Petron Corp., received incomplete requirements from the agency's bids and awards committee. Specifically, what was missing was the wholesale posted price reference for . Visayas and Mindanao that serve as the basis for local refiners to set fuel prices. The bidding committee only provided Petron with reference prices for Metro Manila and Luzon.

This early. Petron officials were already sensing that something was afoot, so they immediately asked the committee to supply them with the missing reference prices. The committee replied the following day, however, that it could no longer entertain any queries.

Left with no choice, Petron used for its bid the reference prices for Visayas and Mindanao that it had been using anyway as the incumbent government supplier.

Well, Petron was promptly disqualified because it failed to use the prescribed reference rates for Visayas and Mindanao, which the committee failed to provide the bidder in the first place. Petron, of course, filed an appeal.

But wait. This is where it gets interesting Its rival-bidder—Phoenix Petroleum of Davao-based businessman Dennis Uy—apparently didn't have the same problem as it was able to submit a bid using the defense department's reference prices for Visayas and Mindanao.

Phoenix also submitted a lower bid of F3.791 billion, compared to Petron's P4.416 billion. To the surprise of observers, however. Phoenix reportedly retracted its winning bid, claiming it made a mistake in its computations.

Word in the petroleum community is that Phoenix's recomputed bid was now more expensive than Petron's. Uhoh.

But after further review, the defense department's technical working group decided to disqualify both bidders. Phoenix did not appeal or challenge the disqualification, but Petron elevated its appeal to Defense Secretary Delfin Lorenzana.

The defense chief reviewed the matter and sided with Petron. He noted that Petron had, in fact, followed the correct formula for computing the reference prices and also did not exceed the limit ser by the government.

In fact, the reference prices
Petron used in lieu of the missing ones that the bids and
awards committee failed to
provide turned out to be even
lower, meaning the government could have bought
cheaper fuel for the armed
forces

Lorenzana also pointed out that the bidding committee could have addressed Petron's query by issuing a supplemental bid bulletin that would enhance the competitiveness of the process.

He used the words "illogical" and "preposterous" to describe Petron's disqualification since it would result in cheaper fuel costs for the government. Lorenzana's final verdict was to award the contract to Petron. But wait? Is that the final word? Maybe not. Word on the street is that some parties are moving heaven and earth to have the whole bidding process voided. The end goal, we're told, is to have the entire bidding process redone from square one. It should be worth watching to see if this scheme triumphs. Abangan! —DAXIM L. LUCAS

#### 'Fugitive' broker

Local stockbrokerage Salisbury BKT Securities Corp., widely believed to be affiliated with Lucio Tan Jr. a.k.a Bong Khao Tan (hence, BKT), was recently compelled to name a new president and nominee as its British chief executive, Simon Boulstridge Bailey, was recently nabbed by the fugitive search unit of the Bureau of Immigration (BI).

According to the BI, the 54year-old British national was the subject of an Interpol "red" notice in connection with a case for forgery that was filed against him in the United Kingdom.

Bailey allegedly conspired

with another suspect in forging documents in order to misappropriate—for—themselves the stock investments of a deceased business partner, based on an official BI report.

Bl agents recently arrested Bailey—who is now facing deportation charges and blacklisting—at the PSE Tower in Makati.

But other sources alleged that Balley was himself just a victim of forgery and that his signature in this case was faked without his knowledge. Bailey is reportedly now asking for voluntary deportation.

Industry sources said that Salisbury, which caters to institutional accounts, had originally petitioned the PSE to simply allow it to declare Balley on leave of absence. Bailey, formerly affiliated with a big global investment house, is apparently valuable for Salisbury as he gets business volume out of Hong Kong from his old peers.

But whether or not Bailey has been framed up, and given that there's no telling how long it will take for this case to be resolved, the brokerage house has been directed to appoint a new nominee.

On Aug. 31, Salisbury filed an application to name Jimmy Yaokasin Jr. as its new nominee.—DORISDUMLAO-ABADILLA

#### Pro tax incentives

Biz Buzz has highlighted the arguments for removing tax incentives a few weeks ago. Now it's time to hear the other side of the argument.

As is to be expected, overseas businessmen are opposing the government's move to remove tax perks on foreign companies in special economic zones, citing the detrimental effect such a move would have on investment inflows to the Philippines.

One such group is the American Chamber of Commerce of the Philippines, which recently released a position paper on the second phase of the Comprehensive Tax Reform Program, formerly known as "TRAIN 2," and now called the "Trabaho Bill."

In that paper, AmCham pointed out that "the Board of Investments and Philippine Economic Zone Authority approval data for new projects reflect a declining level of new foreign investor interest:"

"There are troubling indicators that significant potential foreign investment, especially in IT and manufacturing at Peza zones, is being postponed and even going to competing countries," the group said.

According to some members of the group, the Philippines has recently lost electronics manufacturing giant Samsung as a potential locator to Vietnam and, indeed, Amcham details that the biggest foreign investor in Vietnam now is Samsung. It assembles half of its global supply of mobile phones there and exported \$50 billion in 2017.


Samsung operations in Vietnam began in 2007 with a \$650 million plant and has now grown to total \$17 billion invested in three mobile phone plants and a consumer electronics factory, employing up to 150,000 Vietnamese directly and an additional 250,000 indirectly through local suppliers.

What incentives do the Vietnamese government provide? Rent-free land near the main airport and long-term fiscal incentives such as a corporate income tax holiday for the first four years of operation and a preferential tax rate of 5 percent over the next nine years. After that, the tax rate rises to 10 percent.

By comparison, another global brand, Nike, is Vietnam's biggest foreign-owned job creator, employing 397,000 workers. It buys apparel and footwear from 89 contracted local factories. On its website of global locations where its goods are manufactured, Nike shows no factories in the Philippines—compared to eight in Cambodia, 10 in India, 29 in Indonesia, nine in Malaysia and 30 in Thailand.

According to AmCham, the impending loss of incentives due to the new tax package will make the Philippines lose competitiveness further against its Asean neighbors.

The question now is:
Which side of the tax argument will prevail? We'll know soon enough -- DANIMILLUCAS



## A taste of CDO

agayan de Oro—On our second dav of the "Yes for Peace" workshop, meant to help selected members of civil society organizations in Mindanao to develop a media plan for the coming referendum on the Bangsamoro Organic Law (BOL), the body got down to brass tacks on what a media plan consists

of and why it is necessary.

Beverly Orozco of Gaston Z. Ortigas (GZO) Peace Institute outlined the reasons for the need to develop a communications plan to promote and advocate a social issue. First, she said, nongovernment organizations have limited resources and must rely on creative and innovative ways of reaching mass audiences to deliver their messages. Second, sticking to a plan "imposes discipline and clear thinking," helping a cause-oriented organization in "clarifying objectives and target audiences, while sharpening messages.'

Beverly's walk-through on the steps to formulating a plan and a message was reinforced by Karlon-Rama, who helps NGOs plan their communications programs. With the participants, he conducted an exercise in which they explored a campaign plan and strategy for the BOL referendum. This included identifying the target audience, developing the key messages, planning for resources and implementation for delivering the messages, and refining the message as needed.

One thing that emerged from the discussions was the existence of parties bent on derailing passage of the BOL and returning Muslim Mindanao to the feudal status of old. Among the identified opposition were local, provincial and even regional political leaders who feel their positions of privilege threatened. Another were business interests who may wish to secure their



operations (and continued exploitation of Mindanao's resources) from an unknown autonomous government.

Would there be enough time to carry out the information/education project even in the face of powerful opposition? That is a question still up in the air.

While in this city, I also had the chance to try restaurants I hadn't had the chance to visit previously. On our first night, we went out for dinner at the seaside restaurant Panagatan, which Cagayan de Oro native Beth Yang told us had started off as a mere hut in her childhood. Today, it has graduated into a sprawling restaurant that spills over into several pavilions, with whitewashed walls and nipa roofs. We ordered a "seafood basket" with tinola of lapu-lapu and a side salad of tomatoes, onions, green mangoes and red eggs.

The next day, with GZO Peace Institute's Karen Tanada and Julie Alipala, a Zamboanga-based Inquirer correspondent, we dropped by Cucina Higala, which Inquirer desk person and lifetime friend Pennie dela Cruz had discovered while googling for places to see in this circ.

Cucina Higala is a charming former residence in a busy district where many of CDO's heritage houses can be found. lust to give you an idea of how quaint the interiors are, Pennie and I made a point to visit the restroom armed with our smartphone cameras, the better to take photos of the facilities which were done up in an eclectic mix of postcolonial decor and modern fixtures. "There's no other bathroom in the city like this," explained our server with pride.

The food was no less memorable. starting with the tinola of blue marlin. The tinola is supposed to be the Visavan version of the Tagalog sinigang or sour soup. But it is far less aggressive in its sourness, with only baby tomatoes as the souring agent.

Then we tried the beef rendang that came with a fiery condiment of crushed green peppers, humba of soft, "liggly" pork belly, and callos which we deemed a disappointment.

But Pennie was most intrigued by the binaki, a dessert item that Beth explained was akin to a suman made from corn. What came to our table, though, were two slices of corn bread topped with vanilla ice cream and drenched with caramel sauce. Sure, it was a more "civilized" way of presenting a native dessert. and quite tasty, too. But we were looking forward to enjoying a taste of a childhood treat that Beth said had been a hallmark of her childhood. Maybe we'll go for a taste of the authentic binaki on our next visit.



### The bloody point

High hopes are still on the Bangsamoro Organic Law (BOL) to establish the path to lasting peace in Mindanao.

After President Rodrigo Duterte's historic signing of the BOL creating the Bangsamoro Autonomous Region in Muslim Mindanao, many hoped this would mean the fight of minority Muslims for self-determination would cease and the whole country would finally work as one for the progress, development and security.

Yet recent bombing incidents have put a blight on such optimism. It seems the BOL will not stop the terrorism just yet, if anything ever will.

History shows how rebel forces keep subdividing when ideals clash - the side that decides to pursue a compromise and the side that refuses to give an inch.

Right now, the explosions in Sultan Kudarat and Masbate that killed civilians and led to the sacking of police officials in said regions have brought up a rising new threat. It is not really new, however - this defiant lot whose lovalty had been declared for the global terror network Islamic State.

In reports, the Armed Forces of the Philippines (AFP) said it believes members of the terrorist group Bangsamoro Islamic Freedom Fighters (BIFF) are behind the fatal blast in Sultan Kudarat that killed two persons in the town of Isulan and wounded at least 30 more.

"We believe that the terrorist group BIFF is the primary suspect behind this atrocity. They are the ones who have the strongest evil desire to initiate this kind of attacks that victimize innocent civilians and disrupt peace," the AFP said in a statement.

The splinter group of the Moro Islamic Liberation Front (MILF) had claimed responsibility for the blast, specifically the Abu showsTuraife group of the BIFF.

Two bombings hit Isulan how rebel within a week. In Mashate, two forces keep similar incidents happened in subdividing a span of a month. Casualties when ideals and injuries were reported clash. in Sultan Kudarat while the results were destruction of property, including military equipment in the Masbate blasts.

If the bombings are indeed the work of BIFF, it shows that there are still loopholes in the government peace efforts. Something is not being addressed or targeted, or else these rebel saplings are just plain evil.

Is it all just about disputes on ancestral land and decades of neglect that they want to emphasize by their bombing spree?

What else is at the root of this decades-old conflict that has kept setting the beautiful region at a slower pace of development?

Peace negotiations with rebel groups such as the Moro National Liberation Front and MILF have finally borne fruit after a number of presidents. We now have the the BOL, officially called the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao or OLBARMM.

The question is, does this law abolishing the Autonomous Region in Muslim Mindanao have everything it takes to ensure no repeat of corruption and mismanagement happens? Will it have the system to ensure peace among the clans and tribes that have always made the culture of Muslim Mindanao distinct? Even if someone can answer these questions and help clear the path to real peace, the ones who really need to speak up only seem too happy blasting away at innocent civilians to make a bloody point. What's the point in that?



### New threats, old claims

Various thoughts have been put forward on the latest spurts of bombing in Mindanao, most of them rehash of the old but which are also worth looking at and delving into.

But Sen. Panfilo Lacson expressing hope the latest blasts are detached from talks of peace and the Bangsamoro Organic Law (BOL) is more like a desperation on what has become a victous cycle of history in the Mindanao region which until now is under martial law and with questions on whether peace will remain clusive to its people.

Lacson raised the spectre of yet another young group set to take over the militancy being left by the Moro Islamic Liberation Front (MILF), which many years ago when change it was young and drawn to the extremism comes then being dropped by the Moro National overnight Liberation Front (MNLF), had superseded and it will its founder Nur Misuari and threaded the path of war it is now renouncing.

process to But there is always a chance for peace. achieve. The BOL is it for the MILF, whose leaders saw fit to set firm grasp of government

hand. But it will not, as it looks now, guarantee full peace in the face of what could be an imminent rise of the Bangsamore Islamic Freedom Fighters (BIFF).

Lacson, a former police general, sees the voungest of these groups as a threat like the MILF was then when MNLF talked peace in exchange for autonomous rule which Misuari had wasted in large parts of Mindanao.

The MILF leadership should be able to relate to the BIFF now as they were once there, employing the same tactics like the relatively small bombings now sending the region to a scare.

Lacson is seeing BIFF hands in the recent bombings in Isulan and in Masbate. He claimed hopes that no new organization was or is being formed to thwart the peace process and what the BOL offers to Mindanao.

The Armed Forces of the Philippines and the Philippine National Police ordered a lock up in Isulan. Sultan Kudarat is not at ease now, especially after the possibility of BIFF presence in the province.

At least one teenager died and 15 others were wounded in the 2 September bombings. Many were wounded in a previous incident.

The Masbate City seaport was also rocked by another blast These incidents gave rise to talks of extending martial law in Mindanao, which Lacson called premature.



Newly installed House Speaker Gloria Macapagal-Arroyo, however, assured her support should President Rodrigo Duterte decide to extend what is already an extended martial rule in the region since it was first declared at the height of the Abu Sayvaf/Maute Group invasion of Marawi City.

"It's not just too early. I don't think martial law extension is the better solution," Lacson said, offering a "better solution\* by suggesting the military and ground forces "keep their ears on the ground and intensify their intel operations."

Some persons in authority, however, seem to be offering quick and patch up solutions. Martial law, they seem to be saying, is the panacea to what could be another looming crisis in Mindanao.

Another school also wants to tag the Maoist communist rebels as complicit to the recent bombings, further raising speculations of government laying the martial law predicate not only in Mindanae but also in the rest of the nation.

Such a suggestion does not help in keeping a fit image of Mr. Duterte. It only reinforces claims by Duterte's critics of the President setting himself up for a strongman's rule.

There seems to be an image switch attempt by the President, in case we have not noticed it.

He now sticks to prepared speeches when he can help it. That means less controversial statements when he can. But no image change comes overnight and it will take a long process to achieve.

Rocking the plan through claims no valid information could back up, especially with new threats rising in the Mindanao region, only myddles up the issues stakeholders to peace must uplift.

### Duterte's desperation

F President Duterte thought that Seo. Antonio Trillanes -IV would cower in fear and hide when he ordered the revocation of the amnesty granted to him and other officials who took a stand against the presidency of Gloria Arroyo on July 27, 2003 at then Oakwood Hote! (now Ascott) at the Makati Commercial Center and on November 29, 2007 at The Peninsula Manila hotel in Makati, he is wrong.

No, the 47-year-old senator, who was imprisoned for more than seven years (he won his senatorial sear in 2007 while he was in detention) called Duterte a coward:

"Mr. Duterte, duwag ka. Inantay mo pang makaalis ka bago mo nilabas itong proclamation mo. (Mr. Duterte, you are a coward. You waited until you have left before your released this proclamation.)"

Trillanes said he will not be intimidated. "This is a clear case of political persecution, but I will not cower. There's a rime for reckoning for you and your minions."

In a statement, Trillanes said: "It was agreed to by the Senate leadership that I remain under the custody of the Senate President until my lawyers have filed the necessary petition against the illegal and unconstitutional revocation of my amnesty. What Mr. Duterte wants to happen is to order a warrantless arrest which seems to declare

a de facto martial law?"

He underscored that all requirements for the grant of the amnesty "have been complied with."

"I even took oath in front of then defense officials. All my cases covered by the amnesty have been dismissed," said the senator who has exposed Duterte's bank deposits amounting to not less than P200 million, contrary to Duterte's claim that he is not a millionaire

A paid legal notice for Proclamation No. 572 was published in the Manila Times Tuesday (Sept.

Proclamation No. 572 is titled "Revocation of the Department of Nazional Defense AD HOC

Committee Resolution No. 2 (31) dated January 31, 2011 insofar as it granted amnesty to former LTSG Antonio Trillanes IV.

The reason cited in the proclamation signed by Duterte and Executive Secretary Salvador Medialdea (who are both in Israel and Jordan on an official visit) was that Trillanes did not file an Official Amnesty Application Form and "there is no available copy of this application for amnesty in the file records."

The proclamation also said Trillanes never expressed his guilt for the crimes that were committed on occasion of the Oakwood mutiny and the Manila Peninsula Hotel siege.

Social media is now flooded with video of Trillanes filing the application form for amnesty at the Department of National De-

Tindig Pilipinas, a civil society group critical of Duterte said, "Kung nag-Google lang sana si Duterte, makikim niya ang public admission na ito. (If only Duterte searched in Google, he should have seen Trillanes' public admission.) It attached a Jan. 5, 2011 GMÁ-7 news item with the headline, "Trillanes avails of amnesty, admits 'breaking rules'."

Detained senator Leila de Lima, who was secretary of justice when Trillanes was granted amnesty by President Benigno Aquino III, issued a statement from her detention cell in Camp Crame condemning Duterte's revocation of Trillanes' amnesty: "Kinokondena ko at mariing kinasusuklaman ang pagbawi ni Duterte ng amnestiya kay Sen. Sonny Trillanes. Ito ay mali, hindi makatwiran at walang basehan. Tunay na karimarimarim!"

De Lima raised a question: "If there is ZERO basis in fact and in law to revoke Sen. Sonny's amnesty, then, why did Duterte issue his Proclamation? Walang legal, legal dito. It was simply a political move to try to silence Senator Trillanes. Another palpable case

of political persecution."

De Lima said Duterte must now be in a state of panie: "Nagpapanie na si Duterte. Nasusukol na sya sa kanyang mga kawalanghiyaan, kabuktutan, kasinungalingan at asal-diktador. Nakikita na tin ng marami ang kapalpakan at kawalang liderato ni Duterte sa maraming isyu gaya ng papataas pang presyo ng mga bilihin at krisis-sa bigas at isda. Lumalaki na ang oposisyong umaalma sa kanya. Kaya binabalingan ni Duterte ang mga lider na gaya ni Sen. Sonny."

Duterte's revocation of Trillanes' amnesty shows the depth of his desperation.

We recall what our source in Malacañang related that early in his presidency, Duterte ordered that "dirt" be gathered about his critics who include De Lima and Trillanes. After a few months, his "researchers" came back with some stuff about De Lima which was used against the senator. But they got nothing on Trillanes.

"Wala talaga?" an exasperated Duterte asked, our source said. The "researchers" replied: "Wala talaga, Mr. President."

The source said Duterte gave a chilling order: "Itumba na lang 'van."

Some of those in the room were military officers, graduates of the Philippine Military Academy. There's a brotherhood among PMAers. Immediately, Duterte's order reached Trillanes.

Duterte even fell for a scam about Trillanes' bogus foreign bank accounts. Now, this amnesty revocation.
