<u>Heavier rains, stronger storm surge expected</u>

By HELEN FLORES

Super typhoon Ompong barreled toward Eastern Luzon yesterday, with the state weather bureau warning residents to brace for possible devastating storm surges of up to six meters high or about 19.6 feet and rains heavier than that brought by Ondoy.

The predicted storm surge from Ompong (international name Mangkhut), described by meteorologists as the strongest cyclone to hit the country this year, is worse than that spawned by Super Typhoon Yolanda (Haiyan) in November 2013 that killed thousands in Eastern Visayas.

Vicente Malano, administrator of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), said Ompong may generate storm

surges of at least six meters high along Cagayan and the eastern and northern coastal areas, including Aparri.

In November 2013, Yolanda brought fivemeter high storm surges in the eastern coastline of Leyte and Samar, such as Tacloban, leaving widespread destruction and loss of lives.

Malano said they would provide the public "more precise" storm surge advisory every six hours once the typhoon is already close to landmass.

Ompong, which has been categorized as a super typhoon by the US Joint Typhoon Warning Center as early as Tuesday, entered the Philippine area of responsibility at around 3 p.m. yesterday.

It is forecast to make landfall over Cagayan

on Saturday.

PAGASA advised residents in many parts of Luzon to seek safer grounds as Ompong is expected to lash the region with heavy rains and powerful winds beginning tomorrow.

PAGASA, however, maintained its typhoon category for Ompong, which packed maximum sustained winds of 205 kilometers per hour

(kph) as of 5 p.m. yesterday.

PAGASA classifies a cyclone with 220 kph and above maximum sustained winds as a super typhoon.

Malano said there is still a possibility that Ompong will reach the super typhoon category:

Ompong was forecast to bring damaging winds and torrential rains in many areas in Northern and Central Luzon.

"Ompong's winds could uproot many trees and topple electric posts. We urge the public to evacuate to safer grounds and to coordinate with their local government officials," Rene Paciente, assistant weather services chief of the PAGASA's weather division, said.

As of 4 p.m. yesterday, the eye of Ompong was spotted at 1,145 kilometers east of Virac, Catanduanes.

Ompong packed maximum sustained winds of 205 kilometers near the center and gusts of up to 255 kph.

The typhoon slowed down from 30 kph on

Tuesday to 20 kph yesterday.

Ompong was expected to slightly change its track from west to west northwest in the next hours as the high-pressure area north of it moves, according to PAGASA weather forecaster Gener Quitlong.

Lead time

PAGASA raised tropical cyclone warning signal no. 1 over Catanduanes as of 5 p.m. yesterday.

The province will experience occasional rains and gusty winds from Ompong's outer periphery.

Areas under signal no. 1 can expect winds

of up to 60 kph within 36 hours.

"When we raise signal number 1, it doesn't mean that they could already feel the effect of the typhoon. The warning gives (residents) a 36-hour lead time. They have to evacuate by (tomorrow)," Quitlong said.

Signal no. 1 is also expected to raise over the provinces of Cagayan, Isabela, Aurora, Camarines Norte and Camarines Sur this morning.

The trough or extension of Ompong and the southwest monsoon was already dumping rains over Palawan, Bicol region, the Visayas and Mindanao yesterday.

Heavy rains and strong winds, however, are expected over Northern Luzon and parts of Central Luzon by tomorrow due to the cyclone's outer periphery.

The typhoon is also expected to enhance the southwest monsoon, which will bring rains over Palawan, Mindoro provinces and Western Visayas by tomorrow and Saturday.

Quitlong said moderate to heavy to at times torrential rains are expected over Southern Luzon, including Metro Manila, by tomorrow due to the combined effect of the southwest monsoon and the outer cloud band of Ompong.

Paciente said signal 1 may be raised over Metro Manila as it is also expected to experience gusty winds from Ompong.

Ondoy-like rains

Malano said the rains to be dumped by Ompong and the southwest monsoon could surpass the rains brought by Tropical Storm Ondoy in 2009.

"If there's southwest monsoon plus the rains

from the typhoon, we could experience the volume of rain brought by Ondoy or even surpass it," Malano said.

Malano said Ompong is expected to weaken once it slams into the Sierra Madre, the longest mountain range in the country.

Palace monitoring

President Duterte will be monitoring the developments and the impact of Ompong.

As part of precautionary measures, Malacañang has postponed

Duterte's trip for the test firing of Spoke Extended Range of BRP Davao del Sur (LD602) in Lamao Point in Limay, Bataan this afternoon.

"Due to (Ompong), we were advised that the Bataan event is cancelled," Malacañang said in its media advisory.

Special Assistant to the President Christopher Go said the President will be in Manila in the next days to monitor the impact of the weather disturbance.

"He might go to the National Disaster Risk Reduction and Management Council (NDRRMC)," Go said on the sidelines of the awarding of certificates and incentives to the medalists in the 18th Asian Games, presided over by Duterte at Malacañang yesterday.

Go said the President's schedule is "fluid" in the next lew days, depending on the weather and the advice of his security team.

Earlier in the day, presidential spokesman Harry Roque Jr. advised the public to be updated on the weather and alert issuances of PAGASA and NDRRMC.

The NDRRMC is ready to release funds, food packs and relief assistance to affected families through the Department of Social Welfare and Development (DSWD).

"As I speak, there is an ongoing pre-disaster risk assess-

ment meeting now to ensure the orchestrated response of the government to (Ompong)," Roque said.

NDRRMC executive director and Office of Givil Defense administrator Ricard Jalad said the Operations Center is currently on red alert and the Response Cluster has been activated.

The NDRRMC is closely monitoring Ompong with the regional councils to ensure orchestrated response by the government.

On the other hand, DSWD has ensured the prepositioning of food and non-food items on the ground and is preparing for possible augmentation of relief supplies for affected communities.

LGU response

As Ompong is barreling down on the north, the Department of the Interior and Local Government (DILG) ordered governors, mayors and other local executives to ensure immediate government response or face sanctions.

DILG officer-in-charge Eduardo Año said local chief executives should be physically present in their respective local government units (LGUs) during the onslaught of Ompong.

"Those who fail to show up and remain absent when Ompong rakes through the country will be sanctioned by the department," he warned.

As this developed, the Batanes Provincial Disaster Risk Reduction Management Council is in the thick of preparations to avert any disaster that the super typhoon may bring, while the National Food Authority has prepositioned emergency stocks in the island-municipalities of Sabtang and Itbayat.

Several LGUs have suspended work and classes this week in anticipation of the impact of Ompong, including the Ilocos region; Albay; Masantol, Pampanga; Dolores, Abra; Apayao; Apalit, Pampanga; Dagupan City and Isabela, Cagayan.

In Bulacan, at least 300 cubic meters per second of water was released at Bustos Dam yesterday afternoon.

Full alert

The PNP today placed all its forces in Luzon on full alert as part of its preparations for the effects of Ompong.

The highest alert status will take effect at 6 a.m., PNP chief Director General Oscar Albayalde said at a news briefing yesterday.

It means vacation leaves of police officers are cancelled to ensure the availability of all personnel and resources for disaster response operations.

"Resources and personnel from these operational support and maneuver units with disaster response capability are directed to preposition within closest and safest proximity to threatened and high-risk areas along coastlines, riverbanks and geo-hazard zones for rapid deployment in the event of contingency," he said.

The Ninoy Aquino International Airport terminals/aerodrome will be closed if Ompong packs 35 knot-crosswinds, Manila International Airport Authority (MIAA) general manager Ed Monreal said yesterday afternoon after meeting with the Airline Operators Council at the MIAA board room. — With Christina Mendez, Jaime Laude, Cecille Suerte-Felipe, Janvic Mateo, Jack Castaño, Eva Visperas, Cesar Ramirez, Raymund Catindig, Emmanuel Tupas, Edu Punay, Rudy Santos, Ramon Efren Lazaro

Typhoon "Ompong" further intensified as it entered the Philippine area of responsibility on Wednesday afternoon, growing in diameter from 600 kilometers on Tuesday to 900 km and prompting more areas to take precautionary measures

"There is still a possibility that it will reach the superty-phoon (category)," said Vicente Molano, administrator of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (Pagasa).

Packing sustained winds of 205 kilometers per hour and gusts of 255 kph on Wednesday, "Ompong" (international name: Mangkhut) is forecast to strengthen to 220 kph on Thursday, enabling the Philippine Atmospheric, Geophysical and Astronomical Services Administration to categorize it as a supertyphoon.

At 4 p.m. on Wednesday, the typhoon was tracked at 1,145 km east of Virac, Catanduanes province, moving westward at 20 kph.

Landfall

Ompong is expected to make landfall in northern Cagayan province or the Batanes group of islands on Saturday, but it will bring stormy weather to most of Luzon as early as Priday, according to weather specialist Gener Quitlong.

Pagasa raised Storm Signal No. 1 in Caranduanes on Wednesday afternoon and in southern Luzon on Thursday.

Forecasters warned residents in the coastal villages along the eastern seaboard of Luzon to brace for storm surges of up to 6 meters.

The dangers posed by Ompong have prompted the authorities, schools and residents to take a number of measures.

 Early harvest of rice in Cagayan Valley

- Preemptive evacuation by Thursday of those in areas prone to floods and landslides, and those near rivers and coasts
- Postponement of the University of the Philippines Col-

lege Admission Test scheduled for Saturday and Sunday

 Suspension of classes in flocos towns and cities, including Dagupan City, for Thursday and Friday. Also suspended are

classes in all elementary and high schools in Lapu-Lapu City on Wednesday and in preschool, elementary and high school in Albay province on Thursday.



• Cancellation of the trip of 301 Davao City delegates to the Batang Pinoy (Philippine Youth Games) in Baguio City. The opening of the games was moved from Sept. 16 to Sept. 17.

Strong winds, heavy rain

The outer bands of Ompong could extend to Metro Manila and the rest of Luzon, bringing strong winds and heavy rain, according to Pagasa.

Other parts of Luzon and portions of the Visayas and Mindanao will experience rain brought by the induced monsoon.

Among regions where preparations have begun are Ilocos, Cagayan Valley, Cordillera Administrative Region, Central Luzon, Calabarzon, Mimaropa, Bicol and Caraga.

Renato Solidum, undersecretary for disaster risk reduction and climate, urged residents in areas lying along the projected path of Ompong to take safety precautions.

"We reiterate that we expect strong winds, heavy rains, severe flooding and landslides with this typhoon," Solidum said.

"We ask our people in vulnerable areas to check out possible evacuation sites, and get set to flee from their homes whenever necessary," he added.

He also warned residents living on mountain slopes of the risks of landslides.

Three waves of response

At a press briefing on Wednesday, Executive Director Ricardo Jalad of the National Disaster Risk Reduction and Management Council (NDR-RMC) said the council had crafted three waves of response.

Damage to crops

The first wave of responders will come from local governments and the second wave from the Regional Disaster Risk Reduction and Management Office (DRRMO).

The third wave involves the DRRMO in areas outside the affected areas and the national agency.

Agriculture Secretary Emmanuel Piñol said Cordillera, Ilocos and Cagayan Valley could suffer up to P7 billion in agricultural damage.

Piñol said on his Facebook page that his office was expecting about 1.2 million hectares of rice and corn farms to be devastated

Rice and corn losses may amount to P3.3 billion and P4.2billion, respectively, since these crops were mostly ready for harvest, he said.

Early harvest

In Isabela province, Romulo Caspe said he quickly harvested his palay produce in Barangay San Antonio as a precaution.

At the farming village of Bungcag in Dingras town, Ilocos Norte, Jude Valencia and his nephew, Lyndon Madrid, plucked green papayas so they could sell these in the market for P15 a kilogram.

Valencia said he feared that his 500 papaya trees may not withstand Ompong. His solution was to peel off the leaves to help the trees recover once Ompong barreled out of the country.

Sierra Madre

"One optimistic thing about this typhoon is that it may be weakened once it hits the Sierra Madre mountain range (in Isabela), which usually serves as a natural barrier," Pagasa's Molano said in a press briefing.

"Also, the seabed along the coastal areas in Cagayan and Isabela is relatively deep, which could help minimize the occurrence of storm surges," he added.

In Ilocos Norte, Gov. Imee Marcos asked volunteers to prepare more food packs, medicines and other supplies sufficient.

In Bicol region, the Office of Civil Defense advised local disaster councils to prepare and activate their operation centers.

Chinese envoy visits PH to discuss WPS joint exploration

CHINESE Foreign Minister Wang Yi will visit the Philippines next week to discuss infrastructure projects, as well as joint oil and gas exploration in the West Philippine Sea, the Department of Foreign Affairs said Wednesday

Wang, who is also a Chinese state councilor, will visit the country on the invitation of Foreign Secretary Alan Peter Cayetano.

The two officials will discuss the framework on the possible projects which is expected to conform to domestic rules and regulations and international laws as both sides had stated in the past.

In a statement, the DFA said Wang will visit the country on Sept. 16 to 18 which is aimed at further building on the increasingly strong foundation of friendship between the Philippines and China.

"With continued dialogue and consultation anchored on mutual trust and respect, and the resolute pursuit of mutually beneficial practical cooperation, Philippines and China will continue to work together in managing differences and addressing issues pertaining to the West Philippine Sea or South China Sea," the DFA statement said.

Wang visited the Philippines in July 2017, where both the Chinese official and Cayetano signed a memorandum of understanding on strengthening cooperation.

In that meeting, Wang said that the China-Philippines continuing relations have "dispelled the dark clouds and embraced splendid and bright prospects again under the joint efforts of both sides" since President Rodrigo Duterte has assumed office, with bilateral political mutual trust being constantly enhanced and cooperation in various fields being advanced in an orderly manner.

The Philippines is a close neighbor of China separated by only a narrow strip of water and a regional major country with significant influence.

Wang said that China is willing to see the Philippines achieve national stability and economic development and play a more important role in regional affairs.

"It is hoped that both sides will earnestly implement the important consensus reached by the leaders of the two countries, continue to properly handle sensitive issues, and create a favorable environment for the sustained and stable development of bilateral relations," Wang said.

Beijing's foreign minister visiting Manila

Foreign Affairs Secretary Alan Peter Cayetano will host this week his Chinese counterpart, Foreign Minister Wang YI, for a three-day official visit to Manila where they are expected to follow up on the initial discussion on possible joint oil and gas exploration in the disputed West Philippine Sea (WPS).

Philippines and China will continue to work together in managing differences.

In a statement, the Department of Foreign Affairs (DFA) yesterday announced that Wang will be in Manila 16 to 18 September upon the invitation of Cayetano

Wang's visit comes after last month's top-level meeting between Chinese officials and the Philippine economic managers in Beijing.

Cayetano said the upcoming visit affirms the closer bilateral relations between Manila and Beijing since President Duterte assumed office.

"State Councilor Wang's visit is a demonstration that our bilateral ties are becoming solid and steady as never before," said Cayetano.

"The Philippines and China are both committed to continue on the path of cooperation, all the while ensuring that the Filipino and the Chinese peoples will reap the dividends of our mutual efforts," he added.

Expected to be part of the agenda in the Cayetano-Wang meeting is the continuation of discussions on oil and gas cooperation between Manila and Beijing to come up with a framework of cooperation that conforms to respective laws of both countries and international laws as well.

Cayetano said the visit will likewise provide both sides an opportunity to take stock of infrastructure projects under the Philippine government's flagship "Build, Build, Build" program.

He said that with continued dialogue and consultation anchored on mutual trust and respect as well as the resolute pursuit of mutually beneficial practical cooperation. Philippines and China will continue to work together in managing differences and addressing issues pertaining to the WPS, 3

Duterte: No regrets being president

DAVAO CITY - Facing alleged threats of ouster and destabilization plots, President Duterte said he has no regrets being the country's Chief Executive.

In fact, according to Duterte, his remaining three years in office is too short to fulfill his campaign promise to eradicate illegal drugs and corruption.

"Three years left is too short. I like to start again where I left off to finish this job," Duterte said during his televised one-on-one with his chief legal counsel Salvador Panelo on Tuesday.

"And of course, the scourge of drugs — I promised the people that I would finish this. Believe me, I will really put an end to this," he said.

candidate in the May 2016 presidential elections. Even without campaign machinery, he won the presidency on his campaign promises of strong leadership to bring peace and order and security for Filipinos.

Duterte stressed he could not renege on his campaign promises.

As much as possible, Duterte said he would do his best for Filipinos for the next three years before stepping down in 2022.

If there were certain things

that the presidency deprived him, Duterte said it is the time that he would have wanted to do things freely on his own.

Duterte said the Presidential Security Group (PSG) has been strict in the security arrangements wherever he is.

He said he could not even do the things he usually did before, like strolling in malls without throngs of people milling around him If there is one thing the President also delights in while in office, it's the chance to meet the thousands of Filipino migrant workers on his trips abroad.

Duterte said after more than two years in office he had some misgivings.

He cited in particular the refusal of lawmakers to grant him emergency powers to solve the traffic problem in Metro Manila and other urban areas. – With Jaime Laude, Roel Pareño, Michael Punongbayan, Artemio Dumlao, AP

Trillanes calls Rody 'obsessed and insecure'

Sen. Antonio Trillanes IV described President Duterte yesterday as "obsessed" with him and "insecure" for devoting much of his time hitting him rather than focusing on problems of the country during a one-on-one with Chief Presidential Legal Counsel Salvador Panelo on Tuesday.

Trillanes also warned Duterte against dragging the senator's ailing mother into their fight.

Vice President Leni Robredo and some senators also said the televised interview was a "lost opportunity" for Duterte and that they were disappointed because it should have been used to address the urgent concerns of the people, including high prices.

Magdalo party-list Rep. Gary Alejano, who was also part of the group of soldiers who staged uprisings against the Arroyo government like Trillanes, urged Duterte to put his quarrel with the opposition senator behind him and attend to the nation's problems.

Trillanes called Duterte names after the President called him corrupt and that his mother was a supplier for the Navy, where he used to serve as lieutenant.

The senator noted that during the 90-minute-long interview, Duterte mentioned his name "more than a hundred times."

"Maybe he's obsessed with

me. Maybe he has dreams of me when he sleeps – that's good, I hope you have nightmares because of me because I will not go away." Trillanes told reporters.

He said Duterte always talks like someone who just came from a drinking spree.

Trillanes also thinks Duterte was insecure with him as he appears to be "competing against me" for the loyalty of the Armed Forces (of the Phillipines or AFP) and the police when he keeps enumerating his initiatives to modernize the military and help soldiers.

"There should be no competition. He is the commander-inchief of the AFP, I'm a senator. I help whenever I can – not only soldiers and the police – to everyone. He should be like that too," Trillanes said.

He said he believes members of the AFP and the police remain loyal to the chain of command and the Constitution "so I don't know where this insecurity is coming from."

The senator also denied Duterte's allegations that he and the Magdalo group were plotting with communist rebels to oust him.

He said he and members of the Magdalo became law abiding citizens and upheld the Constitution when he and some of his colleagues were elected to Congress.

Low blow

Trillanes warned Dulerte not to drag again his 84-year-old mother, who he said is afflicted with advanced Parkinson's disease into their fight.

"I think everyone saw how low that blow was. If you have a problem with me, stick with me. I can face that. But dragging my mother, that's personal already. Don't go there. That's not the work of a real man," he said in mixed Filipino and English.

He did not deny that his mother was a private supplier to the Navy while his father and namesake – who retired in 1988 – was naval captain. He was in high school at the time

"There was no case (against my mother) and there was no impropriety. That's what's important," the senator said.

Waste of time

For her part, Robredo said, "We expect (Duterte) would face the people to say that we really have a problem, and here are the solutions of the government."

"This is not the time to focus on politics. This is the time to fix the country's economic problem," Robredo said.

Some senators were also not impressed with the tete-a-tete.

Sen. Grace Poe said while it "is also important that we know his (Duterte's) sentiments... we also want to know more about his concrete plans for the problems we are facing – not just the abolition of the NFA (National Food Authority) Council or importing rice—but something more detailed."

"But maybe that will come in the future," Poe said.

Sen. Risa Hontiveros described the event as "a complete disappointment" and a "total waste of time and precious government resources."

She said the measures that Duterte offered to address the country's twin rice and inflation crises "were vague and lost in his stories of destabiliza-

tion plots."

"President Duterte should snap out of his fantasy with destabilization plots, roll up his sleeves and start working. Strong economic policies, not wild conspiracy theories, will address the country's rice crisis and untamed inflation," she said.

Sereno visits Trillanes

Former chief justice Maria Lourdes Sereno warned that Duterte's move to revoke the annesty granted to Trillanes without-consulting the AFP was "divisive and dangerous."

She said Duterte's televised interview also did not at all help in reducing tensions nor in providing the AFP the opportunity to study the questioned Proclamation No. 572 first before being ordered to arrest Trillanes.

The proclamation revoked Trillanes' amnesty for allegedly being void. Trillanes denied this and went to the Supreme Court, which said the issue should be heard before the lower courts that tried the senator's cases.

"What the President did (issuing proclamation) by not consulting the military is very dangerous, in other words, he put the AFP in jeopardy,"

Sereno told reporters after visiting Trillanes in his office.

She said the proclamation raised the idea that all amnesties granted in the past to all soldiers can be revoked anytime.

She cited the case of Armed

Forces chief Gen. Carlito Galvez, who was granted amnesty after taking part in the 1989 coup attempt against then president Corazon Aquino, and Sen. Gregorio Honasan.

Dut military Mapredicament

President Duterte created a dangerous precedent and put the military in a predicament when he voided the amnesty given to Sen. Antonio Trillanes IV as a military rebel years ago, as his move opened to invalidation the amnesty grants to many active soldiers, former Chief Justice Maria Lourdes Sereno said on Wednesday.

One of those amnestied soldiers is Gen. Carlito Galvez Jr., chief of staff of the Armed Forces of the Philippines, Sereno said.

Sen. Gregorio Honasan, chair of the Senate committee on national defense and security, could also lose his amnesty, she said.

Both Galvez and Honasan were granted amnesty for their roles in past military mutinies, and Sereno said their pardon could be voided by a new administration.

Potential risk

Presidential spokesperson Harry Roque said it was possible Mr. Duterte's Proclamation No. 572 would affect the other soldiers given amnesty by former President Benigno Aquino III but he did not know if the government had plans to question their pardon.

"They could be potentially affected, but I do not know if the government will question the others similarly situated," Roque told reporters.

Sereno spoke to journalists after visiting Trillanes in his Senate office, where he has dug in for more than a week.

Mr. Duterte, lashing back at Trillanes for his relentless criticism of his administration, last Tuesday ordered his arrest and trial for coup attempts against President Gloria Macapagal-Arroyo in 2003, 2006 and 2007.

Mr. Duterte voided Trillanes' amnesty, saying he did not apply for it and did not admit guilt in the uprisings against Arroyo.

Fighting back, Trillanes, 47, took Mr. Duterte's order to the Supreme Court, which on Tues-

day found the senator's plea to block the arrest order moot and ruled that two branches of the Makati Regional Trial Court (RTC) that dismissed the coup d'état and rebellion charges against the former Navy lieutenant should handle the question of the order's legality.

The Makati RTC Branch 148 opens hearings on the controversy on Thursday, and Branch 150 on Friday.

No consultation with military

Sereno did not disclose what she and Trillanes talked about.

She said Mr. Duterte did not consult the military before voiding Trillanes' amnesty.

"I think they have come to the realization now that what President Duterte did by not consulting the military is very dangerous. In other words, President Duterte put the AFP in danger," she said.

How? Imagine, he opened the idea that the amnesty granted to thousands of soldiers who had a problem with the law, not only during the time of Cory (President Corazon Aquino), but even during the time of our forebears when there was a revolution, all of these could be opened," she added.

The uncertainty could cause divisions in the military, she said. "Its implication goes

very deep and is alarming. It means that instead of the Armed Forces being united, it would be divided and there would always be the concern that what has been closed could still be opened."

Loyalty to Constitution

Sereno also said Mr. Duterte's statements during his televised interview on Tuesday reinforced the sense that the military must do some soul-searching.

"In other words, the Armed Forces of the Philippines must remember to look beyond the term of this President, remember that the Constitution is its north star, that they are, by the terms

of the Constitution, the protector of the people and that they will do nothing that is violative of that Constitution," she said.

Mr. Duterte uses the possessive pronoun "mine" when describing the military and the police, she noted.

"I hope he does not come to the point where he says the taxpayers' money is his as well," she said.

The military, she said, should remember that the financial benefits that Malacañang claims the soldiers have received come from taxpayers.

Getting these benefits does not mean they have to obey a questionable order, she added.

AFP, PNP statements

Galvez reaffirmed the military's loyalty to the Constitution

"I recommit to the nation the unity and firm resolve of the AFP for an unflinching loyalty to the Constitution and the duly constituted—authorities," the AFP chief of staff said in a statement issued on Wednesday.

For its part, the Philippine National Police denied claims that there were officers' groups that backed Trillanes.

PNP Director General Oscar Albayalde, however, said the police were looking into the President's claim that the Magdalo group of pardoned military mutineers was plotting with communist rebels to oust him by October.

Magdalo had already denied Mr. Duterte's claim, but the President repeated it in a televised interview with his chief legal counsel, Salvador Panelo, on Tuesday.

Mr. Duterte also told the soldiers that they were free to stage a mutiny if they believed in Trillanes, a comment that the senator interpreted as inciting to sedition.

"That is inciting to sedition, an impeachable offense," Trillanes told reporters on Wednesday.

'Go home, Trillanes'

In Malacanang, Roque advised Trillanes to go home, reminding the senator that Mr. Duterte had said he would not be arrested without a warrant.

"Go home, because it's not right that the people [are] paying for your board and lodging there," Roque said.

there." Roque said. Magdalo Rep. Gary Alejano said Mr. Duterte was "insecure" and appeared to be goading the military to take over.

"[He's] upset and reproaching the [military]. In fact, he's challenging them to stage a coup d'état. [That's not good], because he's inciting them to resort to extraconstitutional action," Alejano said. —with reports from christine o. Avendand, Jeannette 1. Andrade, Jaymee T. EX-MUTINEER FAELDON BACKS DUTERTE ARGUMENT, READY TO GO BACK TO JAIL

Former mutineer Nicanor Faeldon is willing to go back to jail if his amnesty will also be revoked for failing to go through the proper process.

Faeldon said he agreed with President Duterte that there was a problem with the amnesty that former President Benigno Aquino III granted to soldiers who took part in the 2003 Oakwood mutiny, 2006 Marines standoff, and 2007

Manila Peninsula hotel siege.

Proclamation No. 572

Mr. Duterte issued Proclamation No. 572 on Tuesday last week that voided the amnesty granted to Faeldon's fellow mutineer Sen. Antonio Trillanes IV on the ground that he did not file an application and admit his guilt.

Mr. Duterte later raised a new argument—not mentioned in his proclamation—saying the pardon granted to Trillanes was not valid because his amnesty certificate was signed by Defense Secretary Voltaire Gazmin and not by Aquino, who should not have delegated the power.

The issuance of the certificate was pursuant to Aquino's Proclamation No. 75 granting amnesty to all mutineers.

Also a beneficiary

Faeldon, who is now a deputy administrator at the Office of Civil Defense, also benefited from this proclamation.

"If we all agree that an act of pardon and amnesty is an act of the State and can't be delegated to another official, there's really a problem," he told reporters at the Senate.

Trillanes has said he is willing to go back to jail and submit himself to the courts if there is a warrant for his arrest.

Faeldon said he was willing to be detained if the court said so and possibly go through an amnesty process again.

"If it will be revoked, I am very willing to go back to jail so that it will pass through the process," he said. INQ

No order to arrest, silence critics — Duterte

No order to arrest or silence government critics has been issued by President Duterte.

The President said critics of the government have the "time of their lives" to talk, disputing allegations that he was using his authority to silence dissent.

"I have yet to sign anything ordering the arrest or the silencing of anybody in this government especially the

critics." Duterte said over government television last Tuesday.

"The fact that they are doing it everyday only goes to show that I am giving them the time of their lives to just talk and talk and talk Wala naman. It's an invented phrase kasi 'yang 'silencing." he said.

The President recently voided the amnesty given to Senator Antonio Trilanes IV for two past military uprisings due to his failure to meet its requirements, including admission of guilt.

Vice President Leni Robredo and other opposition groups have slammed the President's amnesty recall as an attempt to silence the critics of the government.

Duterte, however, explained that the amnesty of Trillanes was flawed since it was signed by former Defense Secretary Voltaire Gazmin, not then President Benigno Aquino III.

He maintained that only the President has the power to grant amnesty and could not delegate such power to his alter ego. He said his predecessor made a "glaring mistake" when he let Gazmin approve such amnesty to Trillanes.

"I would rise and fall on the proposition that only the President himself physically doing the pardoning and granting the amnesty." Duterte said

"An act of pardon, an act of amnesty is always an act of state which cannot be done by a mere Cabinet member, especially if that Cabinet member was the one or was one of those who investigated and made the recommendation and approved the recommendation

himself," he added

The President said the amnesty procedure was "totally wrong" since former President Benigno Aquino III issued a "motherhood" amnesty proclamation. The proclamation did not contain the names of the grantees, he added.

He said the problem arose when Gazmin recommended and approved the amnesty papers himself. He noted that Gazmin was "actually protecting Aquino" when he signed the document.

"He recommended to the President in a cover letter and then he signed," he said.

"He was actually protecting Aquino. And there are – all the time sa lahat ng ano, they were protecting Aquino," he added.

PNP will not support Trillanes – Albayalde

Philippine National Police (PNP) chief, Director General Oscar Albayalde announced on Wednesday that the 190,000-strong police force is united and will not express support for embattled Senator Antonio Trillanes IV amid the revocation of his annesty.

The bold statement was issued by Albayalde in a press briefing at Camp Crame after President Duterte's statement during a television interview that there is a faction in the military expressing support for Trillanes, a former Navy officer.

"Wala. I have repeatedly said that zero sa amin' yan sa PNP Wala tayong namo-monitor kahit na little support, in any way, dito kay Senator Trillanes (None. I have repeatedly said that he gets zero [support] from the PNP We have not monitored even little support, in any way, for Senator Trillanes)," Albayalde said.

In a televised meeting with Chief Legal Counsel Salvador Panelo Tuesday afternoon, Duterte turned to the Armed Forces of the Philippines (AFP) and 'encouraged' them to unseat him if they see him no longer fit to be the President of the Philippines.

If the AFP thinks I am not competent, that I am not qualified to be sitting here, I discussed this with them in a command conference—bahala kayo (do whateveryou want)," he said

The President claimed that Trillanes "did not do anything" for the military but if they still want to take Trillanes side, he said

they should go to him and stage a mutiny or revolution.

As for the PNP Albayalde assured that there is no need to conduct a loyalty check within their ranks as they remain loyal to three things: the Constitution, the Filipino people, and the Duterte administration.

"Hindi na namin sila kailangan i-remind (We don't need to remind them). We don't evenneed to have a loyalty check in our ranks," he said.

While the PNP, in nature, are mandated by its Ethical Doctrine to remain apolitical, non-partisan and professional, Albayalde has repeatedly said in the past that he sees nothing wrong in expressing support for the Duterte administration since they also are being backed by the President.

"We pledge support to the present administration. Wala naman tayong nakikitang masamang ginagawa, na labag sa konstitusyon. So bakit tayo kokontra? (We have not seen the administration doing something bad, they don't violate the Constitution. So why should we oppose them?)," Albayalde said.

The AFP, for its part, earlier belied speculations that there are factions within the organization, adding that they remain united and loyal to the Constitution and to the Filipino people. Meanwhile, Defense Secretary Delfin Lorenzana Wednesday reiterated that no arrest will be conducted on Senator Antonio Trillanes IV in the absence of a warrant of arrest to be issued by the court.

This despite the Supreme Court decision which turned down the preliminary injunction and temporary restraining order (TRO) sought by Senator Trillanes against the presidential proclamation that voided his amnesty.

"No warrant, no arrest," Lorenzana reiterated

On Tuesday, Armed Forces

of the Philippines (AFP) Spokesman Col. Edgard Arevalo said that they will refrain from making any comment whether or not the military will already arrest Trillianes following the SC's

decision.

Arevalo said they will immediately issue an appropriate statement once they get a copy of the SC decision. (With a report from Francis Wakefield)

Defense chief: No warrant, no arrest for Trillanes

WITH the Supreme Count (SC) denying his petition for a temporary restraining order (TRO), Sen. Antonio Trillanes 4th will remain free until a warrant of arrest is issued against him, Defense Secretary Delfin Lorenzana said on Wednesday.

"No warrant, no arrest," Lorenzana told reporters in a text message, when asked for actions from the military against Trillanes after the rejection of the senator's petition by the high court.

The cinbattled senator failed to secure relief from the tribunal in his petition seeking to avoid arrest and prosecution after President Rodrigo Duterte issued Proclamation 572, voiding an amnesty granted to him by the Aquino administration.

Former Defense secretary Voltaire Gazmin approved the amnesty application of Trillanes and the Magdalo group in January 2011.

Malacanang had said Gazmin may be jailed for usurpation of authority for issuing an amnesty to Trillanes and his Magdalo comrades without consent from Aquino.

Also on Wednesday, Philippine National Police (PNP) Chief Oscar Albayalde said members of the police force have not thrown their support behind Trillanes.

"We have not monitored anyone in the PNP giving support in any way to Sen. Trillanes," Albayalde said.

"We need not conduct loyalty checks in our ranks. We will remain loyal to the Constitution, to the administration, and to the Filipino people.

He allayed speculations that some PNP personnel are supporting the ouster plot against President Rodrigo Duterte.

"We [have] not receive[d] any information

whatsoever because it will easily leak. Maybe, there are some but it is their personal opinion," he said.

Albayalde expressed doubts that the Philippine Military Academy (PMA) Class of 1995. Trillanes' batch, will explicitly show support to their mistah.

"They are not even solid, you could just imagine. I don't know but they are our underclass and not all of them support him because they have their own conviction and beliefs." he said.

If any member of the PNP wants to show his support to Trillanes or any politician. Albayalde added, they would have to resign from the police force.

"If you want to take sides, you resign from the service. You can resign anytime," he said.

The PNP, he added, would verify Duterte's claims that there are certain groups conniving to oust him from office.

Duterte said in his Tuesday tete-a-tete with his top legal counsel and Secretary Salvador Panelo that communists, opposition politicians and the Magdalo group are planning his ouster.

Trillanes is part of the Magdalo group.

"These |pieces of information we get from the Commander-in-Chief are very serious allegations that need to be seriously verified... |They have to be validated and taken seriously." Albayalde said.

Duterte said he would soon disclose pieces of evidence in proving his claims.

Magdalo party-list Rep. Gary Alejano already denied that their group is involved in any ouster plot

on Wednesday reaffirmed the military's loyalty to the Constitution and elected authorities.

"I recommit to the nation the unity and firm resolve of the Armed Forces of the Philippines [AFP] for unflinching loyalty to the Constitution and the duly-constituted authorities." Galvez said in a statement.

Galvezsaid the 145,000-strong soldiers, airmen, sailors and Marines of the Philippine military would be solidly behind the Commander in Chief.

"I am confident that the men and women of the AFP will decline firmly any and all attempts to create a wedge in the AFP," he added.

Meanwhile exiled Communist Party of the Philippines (CPP) founder lose Maria "Joma" Sison denied the claims of Duierte that he was in connivance with the Magdalo group and the President's political rivals.

"There has never been any discussion between me or the CPP with Trillanes or the Liberal Party about ousting Duterte from power," Sison said in a statement late Tuesday.

But the communist leader, who is on self-exile in The Netherlands, admitted it was no secret for the CPP to "promote a broad united front of patriotic forces and encourage the broad masses" to rise up and remove Duterte from power.

"The moment of ouster will occur when Duterte's own military and police forces withdraw support from Duterte upon the sight and inspiration of the rising people in their millions throughout the archipelago," Sison pointed out

Trillanes' surprise visitor: Ousted chief justice

Then-President Fidel Ramos granted Honasan amnesty in 1992.

Not even an assurance from Defense Secretary Delfin Lorenzana that there will be no warrantless arrest against him can persuade Sen. Antonio Trillanes IV to halt his Senate campout and end the media attention he and his allies have been getting.

Yesterday, Lorenzana said the military would not act against Trillanes unless the courts issued an arrest warrant.

"No warrant, no arrest," Lorenzana said.

Contrary to his initial pronouncement on Tuesday that he intended to go home. Trillanes yesterday said he will keep himself holed up inside the Senate building "for fear of being arrested."

Trillanes is demanding an official order to be issued to units of the Armed Forces of the Philippines (AFP) which are tasked to arrest him.

Until yesterday, Trillanes claimed that no such order had been issued to the military

"We tried to validate that (Lorenzana's) pronouncement on the ground but the concerned AFP units are still maintaining that they will still arrest me because that is the order," Trillanes said.

"Without_such_an_order revoking the arrest order, I was advised by my lawyers not to go out just yet," he added.

For more than a week now, Trillanes has taken refuge inside the Senate building where Senate President Vicente Sotto III has declared that as a matter of policy and to preserve the dignity of the chamber there will be no arrest to be made without proper warrant.

On Tuesday, Trillanes publicly announced he intended to go home after the SC released a decision denying his petition for a temporary restraining order (TRO) against Proclamation 572.

"We are not hiding any information about Trillanes as everyone knows all the crimes he committed even during the Oakwood mutiny," Roque said.

While Duterte said the conversations were provided by a foreign government, Roque said he had no information about the President's source.

"I don't know if it's a regular thing. But what I do know is that it's the nature of an intel. Intel, precisely, is intended to provide you information to avoid eventualities," Roque said.

"The gathering of Intel has always been recognized as a function of diplomatic missions... We also get intel information, that's the nature of diplomatic relations nowadays," Roque said when asked if the intel provided counted as foreign interference.

Roque also said that the President's incitement to the military to oust him was just an expression of confidence.

The President is confident there will be no support to oust him. His excitement is an expression of confidence that no one will follow Senator Trillanes or his companions," Roque said.

On Tuesday, Duterte said he has evidence, provided by a foreign country, to prove there is a plot to oust him. He also warned the Armed Forces of the Philippines against siding with his enemies.

"I asked that it be declassified, and we will show it [to the public]," Duterte said as he addressed the nation with his live dialogue with Chief Presidential Legal Counsel Salvador Panelo Tuesday afternoon.

"This is my message to the Armed Forces: Just be careful. Just be careful of your connivance with the Magdalo [group of Trillanes]. Because Magdalo is not all in agreement to destabilize or overthrow

Ex-rebel ready to return to jail

More importantly, there are certain executive powers that by their very nature cannot be delegated

Office of Civil Defense (OCD) deputy administrator Nicanor Faeldon, a former rebel officer and co-leader of the Magdalo mutineers, admitted yesterday the amnesty certificates given

him and Sen. Antonio Trillanes IV by former President Benigno Aquino were flawed.

At a chance interview after taking his oath as member of the ruling Partido Demokratiko Pilipino (PDP) at the Senate, Faeldon said he is willing to

go back to jail if that is the consequence of the defective amnesty.

"I believe so," Faeldon replied when asked by reporters if there is something wrong with the amnesty granted to them during the Aquino administration, adding "after seeing the cards of both parties, it became clear to me that I think there is really a problem."

Faeldon said he is willing to go back to jail anytime if the amnesty granted to them is really flawed. "If the process we have gone through is not in accordance with the Constitution...I am very much willing to go back to jail so that I can go through the process," Faeldon said.

of pardon and amnesty is the act of the state, it cannot be delegated to another position other than the President," he added.

No less than President Rodrigo Duterte questioned the authority of former Defense Secretary Voltaire Gazmin for recommending and approving the amnesty to Magdalo members that included Trillanes.

The President issued Proclamation 572 specifically ordering the revocation of the amnesty granted to Trillanes.

Apart from the delegation of authority by Aquino, Faeldon also said that an affidavit of admission of guilt was required of them when they applied for amnesty.

Affidavit needed

"One of the requirements there is that you have to attach an affidavit admitting specifically identified offenses. So the affidavit of admission of guilt is an attachment," Faeldon said.

Trillanes, who is still taking refuge at the Senate to prevent arrest, has repeatedly stated that the application form already stated his guilt and has not presented any affidavit of admission of guilt which was among the issues raised in the proclamation.

"We all came up with our application forms but I do not know how many submitted that affidavit of admission of guilt and how many did not submit, I can only speak for myself," Faeldon stressed.

I am very much willing to go back to jail so that I can go through the process.

Paeldon and Trillanes are among the core leaders of the botched coup on 27 July 2008 at the posh Oakwood Apartments in Makati City.

Gazmin error as evidence

Gazmin having usurped the authority to grant amnesty, even if this was not included in the proclamation, can be used as evidence on the factual issues, according to a ranking justice department official.

On 31 August, President Rodrigo Duterte issued the proclamation that voided the

amnesty of Trillanes which was given by former President Benigno Aquino.

Faeldon and Trillanes are among the core leaders of the botched Oakwood Mutiny.

The proclamation stated that Trillanes did not comply with the minimum requirement for the granting of the amnesty and it was not signed by Aquino but by former Defense Secretary Voltaire Gazmin.

"Cabinet secretaries are alter egos of the President and their acts are deemed legal and valid, unless countermanded by the President," the official said.

"More importantly, there are certain executive powers that by their very nature cannot be delegated and because the Constitution mandates that the President himself act in person, such as the grant of executive clemency" he added.

"In pardons, the President himself signs the grant of pardon. In other jurisdictions, it's the king or the emperor. More so in the case of amnesty, which is so important that the concurrence of Congress is required. You cannot trivialize this process by delegating its approval to a mere alter ego," the official said.

Bato on board PDP

Bureau of Corrections (BuCor) Chief Ronald "Bato" de la Rosa, meanwhile, formally took his oath along with Faeldon as PDP member and confirmed he will seek a Senate seat in the next year's mid-term polls.

PDP president Sen. Aquilino Pimentel III administered the oath to De la Rosa, Office of Civil Defense (OCD) deputy administrator Nicanor Faeldon and actor Philip Salvador.

Also present was PDP vice chairman Energy Secretary Alfonso Cusi.

De la Rosa confirmed he will seek a Senate seat during next year's national and local elections.

On the other hand, Salvador did not specifically say what elective post he would seek while Faeldon said he wanted to join PDP to help promote Federalism.

If elected, De la Rosa said he would focus on legislating measures concerning law enforcement, particularly in connection with illegal drugs and security.

He also vowed not to "embarrass" resource persons invited to the Senate similar to what he experienced when he was subjected to grilling at the Senate.

Prior to his stint as BuCor

chief, De la Rosa also served as chief of the Philippine National Police and led the government's all-out war against illegal drings.

The Senate conducted several hearings on the government's war against illegal drugs which is being blamed for thousands of extra judicial killings.

Trillanes hogged media attention, Duterte laments

Sereno: Voiding of amnesty 'very dangerous'

OUSTED Chief Justice Maria Lourdes Sereno vesterday said President Duterte has pur the Armed Forces in danger when he issued Proclamation 572 without consulting the military.

The proclamation, signed by Duterte on August 31, nullified the amnesty granted in 2011 to Sen. Antonio Trillanes IV, a former Navy lieutenant, by then President Benigno Aquino III.

Aquino's amnesty proclamation covered at least a hundred soldiers involved in the 2003 Oakwood mutiny staged by the Magdalo group, of which Trillanes was one of the leaders.

"I think they (military) have come to the realization now that what President Duterte did by not consulting even the military is very dangerous. In other words, kung baga pinahamak ni Presidente Duterte ang AFP (In other words, Duterte put the AFP in danger)," Sereno told reporters at the Senate after a visit to Trillanes.

Trillanes has been holed up at the Senate since September 4 when the proclamation, which also ordered the senator's arrest, was made public by Malacañang.

Sereno said Duterte opened the "idea" that thousands of soldiers who have been given amnesty might face the same situation as Trillanes, including those involved in coups during the time of President Corazon Aguino in the 80s.

Even the amnesties granted to now AFP chief Gen, Carlito Galvez Jr. and Sen. Gregorio Honasan for their role in the 1989 coup attempt against the Corazon Aquino government could be nullified, she said.

Galvez, of the Philippine

Trillanes has no support from PNP - Albayalde

Philippine National Police (PNP) chief Director General Oscar Albayalde announced yesterday that the 190,000-strong police force is united in its stand not to support embattled Senator Antonio Trilianes IV amid the revocation of his amnesty.

The statement was issued by Albayalde in a press briefing at Camp Crame amid President Duterte's outbursts regarding the supposed faction in the military, where some soldiers are allegedly expressing support to Trillanes, a former Navy officer.

"Wala. I have repeatedly said that zero sa amin 'yan sa PNP. Wala tayong name-monitor kahit na little support, in any way, dito kay Senator Trillanes from the PNP," Albayalde said.

In a televised meeting with Chief Legal Counsel Salvador Panelo Tuesday afternoon, Duterte surprisingly turned to the Armed Forces of the Philippines (AFP) and "encouraged" them to unseat him if they see him no longer fit to be the President of the Philippines.

"If the AFP thinks I am not competent, that I am not qualified to be sitting here, I discussed this with them in a command conference – bahala kayo," he said.

The President claimed that Trillanes "did not do anything" for the military but if they still want to take Trillanes' side, he said they should go to him and stage a mutiny or revolution.

"You are free to do that. As a matter of fact, I am encouraging you to do that para tapos na" Duterte added.

As for the PNP, Albayalde assured that there is no need to conduct a loyalty check within their ranks as they remain loyal to three things: the Constitution, the Filipino people, and

the Duterte administration.

"Hindi na namin sila kallangan i-remind. We don't even need to have a loyalty check in our ranks," he said.

While the PNP, in nature, are mandated by its Ethical Doctrine to remain apolitical, non-partisan and professional, Albayalde has repeatedly said in the past that he sees nothing wrong in expressing support to the Duterte administration since they also are being backed by the President.

14 dead as overloaded jeep plunges into Kalinga ravine

LA TRINIDAD. Benguet - Fourteen passengers, including 13 senior citizens, perished when their hired overloaded jeepney plunged into a ravine in Balbalan, Kalinga, Tuesday afternoon.

Twenty five other passengers were injured

The senior citizens, who were among the estimated 50 passengers of the ill-fated jeepney, were returning home to Barangay Dao-angan after claiming their pension at the Balbalan municipal hall when tragedy struck.

Chief Inspector Richard Gadingan, information officer, of the Kalinga Provincial Police Office, said that the passenger jeepney (WRR-535) owned and driven by Francisco Gumaad Jr. was negotiating a curved, a descending portion of the road.

Gumaad asked the passengers on the roof of the jeep to disembark to make it easier for him to maneuver.

After making it past the curved

portion, however, survivors said the driver lost control of the jeepney after its engine conked out.

The vehicle then hurtled down a raying around 100 meters deep.

Luzon bracing for Ompong'; classes suspended in Gagayan, Hocos Norte

UGUEGARAO CITY – Provincial, city and municipal officials and residents in many parts of Luzon, particulary in the Ilocos region, Cagayan Valley and Bicol region, are bracing for the impact of potential super typhoon Ompong (international name: Mangkhut) which was expected to breach the Philippine area of repsonsibility (PAR) yesterday afternoon.

Classes in all levels and work today and tomorrow have been suspended in Cagayan province and Ilocosd Norte yesterday.

Cagayan classes suspended Classes on Thursday and Friday in all levels in Cagayan have been suspended in anticipation of the onslaught of typhoon Ompong, which is expected to bring heavy rains in most parts of the country.

Cagayan Governor Manuel Mamba has ordered the suspension of classes, which include graduate school studies, after a meeting with disaster riskreduction officials at the provincial capitol on Tuesday afternoon.

"The governor's action is necessary to ensure safety to villagers especially those staying near flood-prone and landslide-prone areas," Provincial Information Officer Rogelio Sending Jr. said.

Sending said Mamba also ordered the suspension of government and private work, except those at the frontline services like hospitals, law enforcement agencies and emergency response teams who will be on standby at the sub-capitol command post in Lal-lo and other designated areas.

No classes, work in Hocos Norte

Ilocos Norte Governor Imee Marcos has suspended classes in all levels in public and private schools in the province on September 13 and 14 as typhoon Ompong lurks.

Marcos also suspended worksin both public and private sectors in
the province, except those involved
in vital frontline services, including
personnel from the Provincial Disaster Risk Reduction and Management
Council (PDRRMC) and city/municipal
DRRMCs

Marcos appealed to the public to take appropriate safety measures to minimize loss of life and limb and damage to properties She asked barangay chairpersons, barangay health workers (BHWs) and other local officials to be alert and vigilant.

Farmers were likewsie advised to harvest crops before the typhoon hits.

'Ompong's" power

In its 11 a.m. tropical cyclone advisory, the weather bureau said the eye of "Ompong" (international name: Mangkhut) was spotted 1,190 kilometers east northeast of Guiuan, Eastern Samar.

It packs maximum sustained winds of 205 kms per hour and gustiness of 255 kph.

Liquor ban

A liquor ban will also be imposed on Friday and Saturday.

Cagayan Valley

The Department of Tourism in Cagayan Valley recommended the postponement of trips to the northern parts of Cagayan province, and the northern parts of Batanes, island municipalities of Calayan, including Palaui Island of Sta. Ana, and Fuga Island starting September 14

In its social media account, DOT -Cagayan Valley cited that Typhoon Mangkhut, (local name Typhoon Ompong), is expected to cut across northeastern Luzon by Saturday

Adverse weather conditions, however, are expected to prevail by September 14

The regional DOT office likewise advised the public to be cautions when travelling to other parts of the region and elsewhere in Luzon.

Bicol region

Albay Public Safety and Emergency Management Office (APSEMO) chief Dr. Cedric Daep told the Manila Bulletin that he is now drafting an advisory suspending classes from pre-school to highschool in anticipation of the raising iof public storm warning signals.

"Inabisuhan na ako ni Governor Ai (Francis) Bichara na pag-aralan yung sitwasyon. So baka itaas ng PAGASA ang signal number 1 mamayang gabi, bukas suspended na yung klase sa preschool hanggang high school." he said.

The draft advisory has been sent to the office of the governor as the head of Albay Provincial Disaster Risk Reduction and Management Council (PDRRMC) and expected to be released on Wednesday afternoon.

Lahar alert

Daep also said that they (APSEMO) will also issue a separate advisory for possible lahar / mud flows.

namin yan ng Phivoles at saka PAGASA, kasi depende pa rin yan sa lakas ng ulan." he said.

According to Philippine Institute of Volcanology and Seismology (Phivolcs) resident volcanologist Dr. Ed Laguerta, about 23 million cubic meters of new volcanic debris may threatensvillages around Mayon Volcano.

'Yung 23 million cubic meters na loose materials ay yung bago yun ng mag-erupt si Mayon noong Pebrero saka Marso. Meron pang luma, mas madami ito kaysa sa bago na hindi pa natin alam yung eksaktong dami nito, dagdag pa dito yung pinag-quarry. Rough seas

Along with the suspension of classes, operators and crewmen of small vessels are advised not to set sail due rough sea conditions.

He added that the APSEMO is studying all the scenarios of the possible impact of the typhoon.

"Meron tayong tinitingnan na apat na scenarios. Una yung posibleng direktang pagtama ng bagyo sa Albay, pangalawa ay sa gilid lang, pangallo ay sa pinaka-gilid ng bagyo at pangapat ay hindi tatamaan pero huhugutin ang habagat na posibleng magdala ng pag-uulan sa Albay at maging kawsang pagbabaha at landslide. Sa apat na yan, yung pang-apat ang pinakamataas na probability na mangyari," he explained.

Ilocos region

The Regional Disaster Risk Reduction and Management Council - Region 1 (RDRRMCI) started mobilizing assets in prepatration for potential super typhoon Ompong.

Director Melchito M. Castro, RDRRMC1 chairperson, on Wednesday said the Northern Luzon Command (Nolcom) of the Armed Forces of the Philippines (AFP) started the deployment of trucks, boats and choppers complete radio communications equipment.

The Ilocos region police, headed by Chief Superintendent Romulo E. Sapitula, formed an emergency operations center in all provincial police headquarters to house all their assets and radio communications equipment.

Castro convened on Wednesday an emergency response preparedness meeting of the RDRRMC1 memberagencies, the Regional Incident Management Team (RITM) and the Rapid Emergency Telecommunications Team (RETT) to finalize the contingency plans for 'Ompong'.

As of Wednesday afternoon, Castro said that Ilocos region is under "red alert" status

Flood, landslide threats

Based on risk assessments on the effect of southwest monsoon to be enhanced by the typhoon in the Ilocos region, Castro said the weather disturbance may cause flooding in low lying areas, landslide in the mountainous areas and storm surge near the coastlines of the initially identified areas to be affected.

"I am appealing all the local DRRMCs to closely monitor the situations in their respective local government units (LGUs) to anticipate the effect of the typhoon," he said.

Pagasa warns of Ompong's fury, extensive damage to rice, corn crops

YPHOON "Ompong"
(international name:
Mangkhut) barreled
into the Philippine Area of
Responsibility Wednesday,
bringing with it the threat of
torrential rain that could exceed
the levels experienced during
Tropical Storm "Ondoy," which
inundated Metro Manila in 2009,
the weather bureau said.

Forecast to be the strongest typhoon to hit the country this year, "Ompong" is expected to make landfall in the northern tip of Cagayan on Saturday, bringing very strong winds and six-meter-high storm surges in coastal areas along the path of the typhoon, weather forecaster Chris Perez said.

Agriculture officials said the typhoon could damage more than P11 billion worth of rice and corn crops if it his northern Luzon, further aggravating food supply problems. Next page

"The typhoon may reach a peak intensity of 220 to 270 kilometers per hour," the weather bureau said.

Tropical cyclone warning signal no. 1 could be raised in Cagayan, Isabela, Aurora, Camarines Norte and Camarines Sur-

"Ompong" intensified, packing maximum sustained winds of 205 kph near the center, and gustiness of up to 255 kph. It was moving west at 20 kph.

Heavy rains due to the enhanced monsoon are expected in Zamboanga Peninsula, Northern Mindanao, Siquijor, Surigao del Norte, Agusan del Norte, Dinagat Island and Lanao del Sur.

Agriculture Secretary Emmanuel Piñol on Tuesday warned that "Ompong" may damage more than P11 billion worth of rice and corn crops if it hits northern Luzon.

"In the worst-case scenario... if it hits northern Luzon, rice alone will lose about P7 billion, and corn around P4 billion," Piñol told lawmakers during budget hearings.

He said this is because some rice and corn crops in the region are still in the vegetative state, even while the harvest season has already begun.

"So I am praying that it won't hit extreme northern Luzon because it could be devastating and could change the figures altogether," Piñol said.

Weather forecasters said the typhoon threatens northern Luzon and may traverse the Cagayan-Batanes area on Saturday.

A report from ING Bank warned that "Ompong" could drive food prices higher if it does widespread damage to crops in northern Luzon.

"This could exacerbate price pressures in the Philippines as the harvest season is just about to begin," the bank said.

Reports early this week said farmers in Cagayan and Isabela, two of the country's top rice and corn-producing provinces, were rushing to reap their harvests as the typhoon approached.

Cagayan has harvested less than 10 percent of its produce from 130,000 hectares of rice fields, Gov. Manuel Mamba said in a statement.

High food prices drove the inflation rate to 6.4 percent in August, a nine-year high.

The Palace on Wednesday reminded the public to be alert and ready as "Ompong" approached the country's area of responsibility.

"We remind the public to be alert and safe because of the approaching storm," said Presidential Spokesman Harry Roque in a Palace press briefing.

Roque said the National Disaster Risk Reduction and Management Council and the Department of Social Welfare and Development have already prepared standby funds, food packs, and other relief assistance.

Roque said several government agencies involved in disaster preparedness are now in contact with each other to facilitate quick emergency response to those who will be gravely affected by the coming storm.

He urged the public to take precautionary measures by knowing the evacuation plan, and preparing flashlights, radio, battery, sufficient amount of food, water supply, and first-aid kits.

"Please stay inside your houses and refrain from going outside if not necessary for your safety," said Roque. "Let us pray for the safety of all."

The Manila International Airport Authority on Wednesday announced it will close airport terminals and aerodromes if "Ompong" hits the country with maximum sustained winds of 35 knots crosswind.

MIAA officials led by its general manager Eddie Monreal met with members of Airline Operators Council to discuss contingency plans and possible measures in anticipation of the bad weather.

"We need your advance advisories regarding your planned cancellation or delay flight so we can disseminate the information to all passengers and employees who will be affected by the typhoon," Monreal told AOC officials during the meeting.

"The Passengers Bill of Rights will be strictly implemented during the closure of the airport," Monreal said.

On Wednesday, Senator Grace Poe urged MIAA and airlines officials to prioritize passenger welfare with the looming cancellation of flights as a result of "Ompone."

"A typhoon is approaching the country. Please call up passengers if their flights are canceled or prepare food at the airport," said Poe over radio dzMM.

She also noted that the Ninoy Aquino International Airport has standby funds of some P200 million that can be used for emergency response:

Trade and Industry Undersecretary for Consumer Protection Ruth Castelo assured the public that there is an ample supply of rice in case the typhoon damages crops.

"Yes, we have 5 million bags coming in October. And then, the DTI has already initiated importing rice also as assistance to the NFA [National Food Authority]," Castelo said. "We are on standby because we also need to seek the approval of the NFA Council before we can do this."

Public Works Secretary Mark Villar said his department's Regional and District Disaster Response Teams nationwide will deploy heavy equipment to high-risk areas to ensure structural integrity of vital roads, bridges, and high-rise public buildings.

The department, he added, is coordinating with the weather bureau, the Office of Civil Defense, the Army, the police, and local government units to monitor and submit timely situational reports of national roads and bridges every six hours and provide

prompt assistance during the onset of ty-

Villar said all teams are likewise responsible for the initial assessment of damage as well as the submission of detailed information on damaged structures with cost estimates for the restoration of calamity-hit structures.

Motorists are advised that a section of the Basco-Mahatao-Ivana-Uyugan-Imnajbu Road is temporary closed to traffic due to a landslide. Clearing operations are ongoing, and motorists may take Uyugan-Mahatao Interior Road as an alternative route.

The Metro Manila Development Authority announced it was preparing for "Ompong."

MMDA chairman Danilo Lim tapped heads of the agency's quick response units to ensure readiness of all assets and personnel to respond during emergencies.

The agency's assets and emergency equipment on standby include seven ambulances, two tow trucks, two military trucks, two fire trucks, a boom truck, seven chainsaws, man-lift, rubber boats and extrication equipment.

Personnel of the agency's emergency stations in the area of Epifanio de los Santos Avenue in Roxas Boulevard, Orense Street, Ortigas Avenue, and Timog Avenue; Circumferential Road-5 in Libis, Commonwealth Avenue, Tandang Sora Avenue and Nagtahan were also placed on blue alert.

With about 20 tropical cyclones entering the country every year, the MMDA reminded the public to heed warnings and take all precautions to protect health and ensure experts.

The NDRRMC has also called on people living in flood and landslide-prone areas to undertake necessary preparations as early as possible and heed calls by authorities for pre-emptive evacuation.

The initial effects of "Ompong" will befelt in Catanduanes during its approach and Signal No. 1 has been hoisted over the province.

The NDRRMC said heavy rains and strong winds may be experienced over northern Luzon and parts of Central and Southern Luzon and surrounding seas are expected to be rough to very rough.

Metro Manila is likely to be placed on Signal No. 1.

The Philippine National Police and the military have alerted their personnel in the provinces along Ompong's path to mobilize all search and rescue units to respond to emergencies.

The NDRRMC Operations Center is currently on red alert and the Response Cluster has been activated.

Preemptive evac set for 'Ompong'

TYPHOON Ompong entered the Philippine area of responsibility (PAR) yesterday, and disaster ofncials are preparing to: preemptive evacuation starting today as Ompong gains strength while heading for Cagayan province.

The weather bureau expects landfall in the northern up of Cagayan on Saturday and exit on Sunday.

Ricardo Jalad, executive director of the National Disaster Risk Reduction and Management Council (NDRRMC), said in a press conferènce in Camp Aguinaldo that gov-

ernment is preparing for a storm surge scenario, with high possibilities of floods and landslides.

lalad, concurrent administrator of the Office of Civil Defense the NDRRMC's operating arm, said the possibility of Ompong becoming a super typhoon seems high, based on the weather bureau's data.

"As of now, its (wind strength is) 205 kph. The upper limit of a typhoon is 220 kph. Above that is super typhoon. It is still 1,190 kms from our land mass...It's that far so it's possible that it will be-

come stronger, so the scenario of a storm surge is possible," he said. Jalad said government is aiming for zero casualty.

Jalad said the interior department has alerted local government units for preemptive evacuation in areas that are likely to be hit by the typhoon.

"I think we should start by Friday or even later part of Thursday because as it approaches, we are going to experience rains already." he said.

PNP chief Oscar Albayalde placed all Luzon-based police units on full alert status effective 6 a.m. Thursday to ensure the availability of resources and men for disaster response in anticipation of the destructive effects of Ompong,

Albayalde said he has activated the national headquarters "1st level battle staff" to make sure that command and control of all

police disaster response operations are effective.

He said relief goods are on standby in Camp Crame, ready for distribution to areas to be affected by the weather disturbance.

The NDRRMC earlier said it is making Yolanda-level preparations with a budget of P1.7 billion.

As of 4 p.m. yesterday, the eye of typhoon Ompong was estimared to be some 1,145 kilometers east of Virac, Catanduanes.

It packed maximum sustained winds of 205 kilometers per hour (kph) near the center and gusts of up to 225 kph. It was moving west at 20 kph.

Based on its track, Ompong's 850-kilometer diameter eats up Luzon's northern half plus the Babuyan Group of Islands.

Weather forecaster Meno Mendoza said Ompong is expected to

traverse the Cagavan-Batanes area on Saturday with winds around 205 kph and gusts of up to 255 kph.

Mendoza said there could be heavy to intense rain, very strong winds, and storm surges in coastal areas-in-Cagayon and Isabela on Friday and in northern Luzon on Saturday

He said the storm surges could be up to six meters high, which is dangerous and potentially damaging.

Due to Ompong's size, Mendoza said its outer cloud bands will also affect parts of Central Luzon when its eye passes through the northern up of Cagayan.

He said the typhoon's trough will bring cloudy skies with light to moderate rains over the Bicol region, Eastern Visayas, and eastern portion of Mindanao today.

He said Ompong has started enhancing the southwest monsoon yesterday.

Because of this, he said parts of Palawan, Western Visayas and

the western side of Mindanao will experience cloudy skies with light to moderate rains today.

Provinces in northern and Central Luzon and some cities in Metro Manila have suspended classes in all levels, both public and private, from Thursday to Friday as a preemprive public safety measure.

The Metropolitan Manila Development Authority (MMDA) said it is ready to deploy at least 60 emergency personnel to provide assistance to the public "at any given time."

It said at least seven ambulances, two trucks, two fire trucks, two military trucks, and one boom truck are also on standby

Cops soldiers snum destablinoves

Top police and military officials yesterday reiterated their loyalty to the Constitution and the administration of President Rodrigo Duterte.

Earlier, Duterte had bared that Sen. Antonic Trillanes IV, along with members of the Liberal Party and the communists, is plotting to topple him. Duterte dared soldiers to side with Trillanes if they are dissatisfied with his leadership.

Yesterday, Philippine National Police (PNP) chief Director General Oscar Albayalde categorically said the PNP will not take part in any bid to ous; Duterte.

"Over and over and over, (I will say) that's zero for us in PNP. In our monitoring, we have no indication whatsoever of (PNP officials) giving support to Sen. Trillanes," Albayalde said.

We will always be loyal to the Constitution, to his (Duterte) administration and to the Filipino people.

Albayalde and Trillanes are both graduates of the Philippine Military Academy (PMA). However, Albayalde is a member of the PMA Class of 1986 while Trillanes belongs to PMA Class of 1995.

The PNP chief said he was in Zamboanga the other day, particularly with the Special Action Force and from what he observed there is no need to conduct loyalty check within the ranks of the police.

"We will always be loyal to the Constitution, to his (Duterte) administration and to the Filipino people. The President has our trust and confidence and we have his

trust and confidence," Albayaide added.

In a radio interview, Presidential Communications Operations Office Secretary Martin Andanar expressed confidence in the professionalism of the military and the police.

"Our AFP (Armed Forces of the Philippines) and the PNP are very professional. Their loyalty is with the people and the flag. And that is exactly what President Duterte meant when he said: I don't need your loyalty; you need to be loyal to the people," Andanar said.

Talks of destabilization plot came after Duterte issued Proclamation 572 last week. It voided the grant of amnesty to Trillanes on the ground he failed to comply with the requirements to apply for the amnesty and express remorse for his crimes against the people.

Trillanes led the mutiny against former President Gloria Macapagal Arroyo twice, in the 2003 Oakwood Mutiny and in the 2007 Manila Peninsula siege.

AFP chief: No reason to doubt military's loyalty

ARMED Forces chief Gen. Carlito Galvez vesterday affirmed the military's lovalty to the Constitution and to the chain of command, amid talks of a plot to oust President Duterte, the military's commander-in-chief.

"I recommit to the nation the unity and firm resolve of the Armed Forces of the Philippines for an unflinching loyalty to the Constitution and the duly-constirured authorities," he said.

Galvez issued the statement a day after President Duterte told soldiers sympathetic to his predecessor, Benigno Aquino III, and to opposition Sen. Antonio Trillanes IN that they are free to stage a mutiny, a destabilization move, or any

plot to remove him from office.

Over the weekend, Duterte accused Teillanes and the political opposition, particularly the Aquino's Liberal Party, of conniving with the communist movement to oust him. He said the plot would be carried out next month. He made the disclosure after Trillanes, who was involved in plots to oust former President now Speaker Gloria Arroyo, criticized him for issuing Proclamation 572 which voided the amnesty granted to the senator by Aquino in 2011.

Defense Secretary Delfin Lorenzana later said the only ones plotting to remove Duterte are the communists

sailors and marines of the ATP are scholy behind the chain of command," said Galvez.

Galvez also said he is confident that military personnel "will decline firmly any and all attempts to create a wedge in the AFP.

"We will not allow them to pursue their plans against us... So, I urge everybody to focus only on their job." he added.

CLARIFICATION

Presidential spokesman Harry Roque said President Duterte was not goading anyone from the military to revolt against him or ioin any ouster plot.

He said the President made the statement because he believes that the military is loyal to the flag and the country, and no soldier will join Trillanes and his group.

Chief Presidential Legal Counsel Salvador Panelo said the President does not believe that any soidier would join Trillanes despite the senator's claimed of support from soldiers.

PNP chief Oscar Albavalde said information on any movement in the PNP to destabilize the government will easily leak, out no matter how discreet, because it will involve recruitment of policemen.

"I have repeatedly said that over and over, actually it is zero here in the PNP. We have not monitored any group whatsoever

or any group which is giving support to Trillanes... We need not conduct loyalty checks... we will always remain loyal to the Constitution, to the administration, and to the Filipino people," Albayalde said.

He said there may be a few disgruntled policemen but "that is probably their own personal opinion but that does not include anybody else or influence anybody inside the PNP."

"If you want to take sides you resign from the service. You can always resign anytime and go there if you want. Maybe that's the message the President wants to convey because if not all and you will do that (take sides) for sure you will face sanctions," he said. - With Jocelyn Montemayor and Raymond Africa

"We are leval to the Constitution, the institution and the Filipino people," the PNP chief said as he rejected anew suggestions to conduct a loyalty check on the police. "I have said it again and again, zero, nil. We have not monitored anybody in the police force who is reportedly undermining the government, thus there is really no need to conduct a loyalty check," he said.

Gen. Albayalde stressed that they have no information about any rumblings in the 190,000-strong police force. If there is discontentment against the government among police officers, for sure it would leak,"

He said however that there could be some policemen who may have their 'personal opinions' on the present situation but are keeping it to themselves and some of their colleagues. "But personal discussions does not involve everybody in the PNP," he added

As a general rule, members of the uniformed service are mandated to always respect.

He stressed that soldiers will do so more for the reason of their oath than it is for fear of severe consequences of relief from post, investigation, and steep penalties under the Military Justice system.

On the issue regarding Senator Antonio Trillanes IV, Galvez said he will defer comments on the matter.

The PNP chief also said

they will just wait for the Makati City court decision on the case of Senator Antonio Trillanes IV before making their move in accordance with the law.

He explained the President had made it clear when he said that the rule of law will prevail' on Trillanes' case. "That's following the law clearly. We will respect what the court will say, klarong-klaro ang sinabi ng Presidente," he said.

Gen. Albayalde also called on other officials and the media not to speculate on the matter so as not to confuse the people. As of yesterday, he said the PNP Legal Service is preparing its reply on the High Tribunal's resolution regarding the presidential declaration that voided the amnesty given to Trillanes by former President Benigno Aquino III.

He also called on classmates of Trillanes from Philippine Military Academy Class 1995 to respect the law and remember what they have been taught in Fort del Pilar.

Albayalde said he is of the belief that even PMA Class 1995 is not ell solid behind Trillanes. Since we all came from the same institution. I hope they (PMA Class 1995) will never forget the ideals they learned from the four portals of the Academy kasi kung hindiparang binents me na din

pati yong institution mo, he said.

Gen. Albayalde said they are checking all information regarding plots to undermine the Duterte government including one that involves a conspiracy between the communist movement and the Magdalo Group of Trillanes.

"It's very possible when they are desperate," he said Albayalde said the pieces of information spilled by President Duterte are also 'serious information' which they need to fully verify because the President. has so many sources.

He said they are even verifying information regarding supposed terrorist plans to bomb some targets in the country this coming September 21. But I would tell you na hindi na bago ang mga information na yan. Some are even rehashed, raw and unvalidated information but we have to react, we have to verify those pieces of information and possibly preempt them." the PNP chief said.

Gen. Albayaide earlier maintained that police will always follow the rule of law in the case of embattled Senator Trillanes even as he assured that there are no rumblings in the 190,000-strong police force in the aftermath of President Duterie's decision to revoke the amnesty granted to his staunch critic.



COA: P10B AFP-PNP housing project went to questionable contractors

THE Commission on Audit has found anomalous circumstances in the award of 28 housing projects worth P10.62 billion under the AFP/PNP Housing Program.

In its 2017 audie, the COA said the NHA did not observe the

required evaluation process and the contracts were awarded to construction companies with doubtful capacity to handle multi-billion government projects.

"Verification of the documents ...showed that the developers are not technically and financially capable to undertake the housing

projects. These are manifested by the deficiencies in the documents submitted and non-compliance to some requirements by the developers on the evaluation of financial capacity" the COA said.

The report did not disclose the

identity of the questioned contractors, merchy designating them as Developers A. B. and C. However, it said some of the projects are located in the municipalities of Bocuae and Pandi, Bulacan.

The audit ream said Developer-A did not disclose the contract cost as well as the clients/owners of on-going projects.

In the case of Developer B. technical and financial documents concerning all five AFP/PNP housing projects awarded to it were not submitted for evaluation.

Auditors said Developer C's license under the Philippine Contractors Accreditation Board (PCAB) gave it a limit of only P100 million bur it still landed a P726.4 million project in Bocuse, contrary to the provisions of PCAB Circular No. 001 (S. 2009).

Three shelter projects for infor-

mal settler families (ISFs) with a combined value of P2.141 billion also went to Developer C. These were Pandi Residence 1 consisting of four contracts with a total cont of P864 million; Pandi Residence 2 with two contracts worth P561.6 million combined; and Pandi Residence 3 with four contracts totaling P716 million.

"The contractor's license was not required in the provisions of the MC (Memorandum Circular) No. 2518-A for ISFs living in danger areas," the audit warn found.

Additional deficiencies found included failure to conduct a complete evaluation-of-the developers' financial capacity, non-submission of the lists of manpower and equipment, and the Net Financial Contracting Capacity (NPCC) was not included in the terms of reference (TOR) for the contracts.

Withour these, the audit team noted that there was no way to

tell if the chosen contractors had the means to complete the multi-million pesos projects in the specifications and in the timetable required.

It recommended that the NHA review and strengthen the Terms of Reference as well as the Memorandum Circulars governing the AFP/PNP Housing Program along with other existing shelter programs of the agency.

The COA said there should be guidelines for a comprehensive evaluation of project proposals and better controls over the implementation.

It also insisted that the submission of the List of Manpower, the List of Equipment for each individual contract be made mandatory in the technical evaluation process.

In its comment on the audit observations, the NHA claimed the PCAB licenses of the developers were not considered for the

Bocuae Housing projects as well as the Pandi Residences 1, 2, and 3.

It said the primary consideration in the selection process if that the developer should be the real owner of the site offered for the projects:

It said the Net Financial Contracting Capacity is "no longer necessary," the list of equipment is not considered a mandatory requirement and the PCAB license is only a "secondary reference" since not all developers are registered with the accreditation board.

The COA said as of December 31, 2017, the total loan receivables of NHA have reached P4.612 billion.

The amount represents payments to developers for 20 housing projects under the AFP/PNP Housing Program and another one for Informal Settler Families Living in Danger Areas.

However, upon review of the

supporting documents, the audit team discovered that 51 percent or P2.358 billion of the payments were not supported by individual loan agreements (ILAs).

This means the developers constructed housing units and charged the cost against the NHA programs even if the supposed beneficiaries were not known.

It also meant the NHA does not have any idea who is holding the loan and who will pay it back.

"The ILA serves as the commitment of the identified beneficiaries to pay NHA in return for financing the acquisition of the house and lot packages," the COA pointed out.

So who is responsible?

The audit team said the process requires the Finance Unit of the concerned NHA Project Office (PO) or NHA Area Management Office (AMO) to conduct an initial checking of the documentary requirements which include the ILA.

This is done to verify if the payment due a developer is in order.

The completeness and authenticity of relevant documents were further verified by the Pre-Audit Unit now under the Accounting Department before paying the developer. However, verification of the payments revealed that the PAU did not require the complete submission of the ILA from the concerned AMO," the auditors said

The NHA did not contest the finding. Instead, it informed the COA that the AFP/PNP Housing Board was given until June 30, 2017 to submit the "revised/santized list of the names of beneficiaries/awardee" for all AFP/PNP project sites.

Eight months after the deadline, the said job has not been completed.

Another twist is likely to make the records murkier.

alacanang said that foreign governments listening to conversations of Filipinos in the Philippines is not necessarily a bad thing, claiming that the country has benefitted from such sharing of information.

Presidential Spokesperson Harry Roque made the statement after President Duterte said that he has been receiving information from "sympathetic" foreign countries about plots to oust him.

In a press briefing, Roque said that while he has no idea on how often it is being done, "spying" on the government's perceived enemies is part of the nature of the intelligence community.

"I do not know if it is a regular thing. What I do know is that's the nature of intel. Intel, precisely, is intended to provide you information to avoid eventualities," he said Wednesday.

"You know even as early as the time we developed inter-state relations, the gathering of intel has always been recognized as a function of diplomatic missions, he added.

"We have regular reports from our own embassies, we also get intel information, that's the nature of diplomatic relations nowadays," he continued.

The Palace official also said that there's nothing wrong with foreign governments listening in on local conversations, especially if the general population will benefit from it.

"Well we have been beneficiaries of shared information from the United States about terrorist groups, nothing wrong with that," he added.

In his tête-à-tête with Chief Presidential Legal Counsel Salvador Panelo Tuesday, Duterte claimed that an intel report from foreign countries said that the Magdalo soldiers are working with the Communist Party of the Philippines (CPP) on his ouster.

"We have the evidence and we have the conversation provided by a foreign country sympathetic to us." he said.

"The connection will be shown maybe any day now. I asked that it be declassified at ipaldta nila sa lahat (and show it to everybody)," he added.

Meanwhile, Roque said that only the Congress can determine if President Duterte allowing foreign interception is a culpable violation of the Constitution and is an impeachable offense.

Reque made the comment after constitutional law professor Tony La Viña said that the act is a violation of public trust and compromises the country's security.

"That's his personal opinion. Ultimately, Whether or not it is impeachable is it will be a decision of the House of Representatives," he said.

"That's just an expression of a personal opinion which should not carry much weight." he added

Roque, meanwhile, advised the public to take extra measure to protect their security, even advising everyone to not use their cellphones if they fear of other countries listening in on their conversations.

"I'm sure everyone is listening to everyone else. And that is why the rule now is don't use your telephone," he said.

"Well, at this time and age, you need to know that oftentimes, privacy of communication is seriously challenged not just by intel individuals, but because of the nature of the technology," he added.

"So take extraordinary precautions in protecting the privacy of your communication," he continued.

Two NPAs killed in CamSur clash

Two New People's Army (NPA) terrorists were killed in an encounter with government troops in Brgy Malabog Caramoan, Camarines Sur, Tuesday afternoon.

Troops of the Army's 83rd Infantry Battalion and 97 Military Intelligence Company (MICO) under the 902nd Infantry Brigade, 9th Infantry Division, encountered at about 12:40 p.m. Tuesday 10 NPAs resulting in a firefight that led to the death of the two unidentified communist rebels.

Troops recovered from the encounter site one carbine, one improvised explosive device (IED), personal belongings, and subversive documents.

Lieutenant General Danilo Pamonag, the Commander of the Armed Forces of the Philippines-Southern Luzon Command (AFP-SolCom), expressed his condolences to the families of the deceased and encouraged other rebels to allow the government to help them rebuild their lives.

He further commended the troops for their bravery and diligence in the performance of their duties.

He said operations in the area are ongoing, in coordination with the local Philippine National Police, communities and local government unit.

Indonesian fishermen snatched off Sabah

ZAMBOANGA CITY _ The military has alerted government troopers in Tawi-Tawi and Sulu over the reported kidnapping of two Indonesian fishermen in the waters off Sabah on Tuesday.

"We have alerted our forces at the border," Lt. Col. Gerry Besana, spokesman for the Western Mindanao Command, said yesterday.

Besana said they received reports on the kidnapping irom their Malaysian counterparts.

Malaysian authorities said the kidnappers, who were on a speedboat, took the Indonesians from a fishing boat off Sempornah near the border of the Philippines. Two other fishermen managed to escape.

Besana said the Malaysian

police could not confirm if the Abu Savyaf was behind the kidnapping.

Besana said reports that the ladnappers were speaking in a Philippine dialect have yet to be verified, adding that it was unclear where the gunmen brought their captives.

The Abu Sayyaf has carried out kidnappings in the waters between Sabah and Mindanao.

Besana gave assurance that there is no letup in military operations to rescue the remaining hostages of the Abu Savvaf.

The bandits are still holding a Dutch man, a Vietnamese, three Indonesians and five Filipinos. The Indonesians were taken in the waters off Merabong near Kunak district in Sabah in November 2016.

2 Indonesian fishers abducted off Sabah

ZAMBOANGA CITY: Two masked gunmen abducted two Indonesian fishermen off Semporna town in Sabah despite a strict security and sea curfew imposed by Malaysian authorities over persistent threats posed by Abu Sayyaf Group terrorists.

Malaysia's Star Online reported on Wednesday that two other fishermen managed to hide in a compartment of their boat.

It said police were investigating whether the gunmen have links with the Abu Sayyaf or criminal groups from Tawi-Tawi province in southern Philippines that have carried out ransom kidnappings in the past in Sabah.

The attackers, armed with automatic rifles, were speaking in Tausug. a dialect commonly used in Tawi-Tawi and Sulu, according to the two fishermen, who identified their abducted companions as Usman-Yunus, 35, and Samsul Sagunim, 40.

"Based on the account of the two fishermen who managed to flee, Omar said they heard the sound of a pump boat approaching their vessel as at was docking at the jetty. The two men went to hide themselves. And from a hole in the compartment, they saw two armed men in dark clothing boarding their boat."

"When they got out of their hiding place, they discovered that their crew mates and the boat's radio were missing. The armed men were said to have spoken in the Suluk dialect," the report said.

Police said all four Indonesians had gone fishing with 11 other fishermen near Pulau Gaya in the past three days.

... The 11 fishermen then headed to shore to deliver their catch.

The abduction occurred just a day before an extended sea curfew is to end September 13 after four years.

Sabah extended its curfew covering three nautical miles off Tawau, Sempoma, Kunak, Lahad Datu, Kinabatangan, Sandakan and Beluran—all near the border of Tawi-Tawi's chain of islands.

Sabah Police Commissioner Datuk Ramli Din said the decision to extend the curfew was made based on continuous threats from cross-border criminals, including from kidnap-for-ransom groups and the Abu Sayyaf.

Ramli said police intelligence indicated that kidnap-for-ransom groups and Abu Sayyaf bandits were still trying to commit cross-border crimes.

The curfew was implemented on July 19, 2014 after a series of kidnappings, which saw the beheading of Sarawakian Bernard Then Ted Fed and the killing of several others, including a policeman and tourists.

In August, a group of gunmen also attempted to abduct the crew of a tugboat in Sabah.

At least 10 armed men were involved in the failed abduction near Lahad Datu's Tambisan area after the crew locked themselves in a room.

The armed men managed to sneak into Sabah and boarded a tug boat on the evening of August 9.

The crew quickly radioed for help and patrolling members of the Eastern Sabah Security Command (Esscom) responded immediately, forcing the gunmen to escape.

Esscom commander Datuk Hazani Ghazali said the crew were ferrying palm oil from Felda Sabahat in Tengku and on their way to Kuantan when the gunmen on a motorboat came along-side their boat in Tambisan waters near the Tawi-Tawi chain of islands.

Malaysia and Indonesia have a border patrol agreement with the Philippines and share regular intelligence and conduct trilateral maritime patrols to prevent piracy and terrorism, including ransom kidnappings of sailors in the maritime borders.

The military previously said security is tight in the border to prevent Abu Sayyaf kidnappings inside Sabah or in the waters of Tawi-Tawi, which is frequented by cargo boats.

The Abu Sayyaf is still holding several foreign hostages in the restive southern region of Mindanao.



MILF lauds Duterte for commitment to campaign for BOL ratification

COTABATO CITY - The Moro Islamic Liberation Front (MILF) lauded, Wednesday, President Rodrigo Roa Duterte for the assurance he gave that he would personally campaign for the ratification of Republic Act 11054 or the Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao (OLBARMM), describing the process as its "last battle" for self-determination in the south

"This inspires us more to reciprocate his administration's commitment for a peaceful end in the so-called Mindanao conflict," MILF Vice Chairman Ghazali Jaafar told The Manila Bulletin.

The plebiscite has been set on January 2019.

In his meeting with the Filipino community in Jordan on Sept. 7, the President was quoted as assuring: "I will campaign for 'yes' vote (in the referendum)."

It was the first time since his signing of RA 11054 into law on July 27 that the Chief Executive categorically declared he would lead campaign for "yes" vote. In previous pronouncements, he merely cited the essence of the new law in the charting of lasting peace in Mindanao.

The MILF leadership was elated by Duterte's assurance because some elected officials in the proposed BARMM territory had earlier aired concernithat the President might adopt a "hands off" stance in the campaign for BOL ratification.

Jaafar, who is also chair of the Bangsamoro Transition Commission (BTC) that crafted the original draft of the new law, likewise cited the Commission on Election (Comelector providing some leeway in the massive registration of new voters, who are eager to participate in the referendum and in subsequent elections in BARMM areas.

"We earlier asked Comelec to accommodate new registrants as much as possible. We are glad that Comelec heeded our appeal," Jasfar said citing the turnout of thousands of mostly MILF members and sympathizers at the opening of three-day special list-up on September 11.

Special registrations start for Bangsamoro plebiscite

COTABATO CITY: The Commission on Elections (Comelec) has conducted its three-day satellite voter registrations in the Autonomous Region in Muslim Mindanao (ARMM) on September 11, 12 and 13 as part of its preparations for the plebiscite on the Bangsamoro Organic Law (BOL) on January 21, 2019.

Director lames Jimenez, Comelec spokesman, said the special satellite registrations were held simultaneously in the provinces of Lanao del Sur, Maguindanao, Basilan, Sulu, Tawi-Tawi, Lanao del Norte and North Cotabato and in the cities of Cotabato and Isabela.

The first day of registration on Tuesday inside the Shariff Kabunsuan Cultural Complex at the Office of the Regional Governor (ORG) Compound at the ARMM in this city coincided

with the Muslims' celebration of Amun Jadid or New Year.

Jimenez said at least nine teams from the Comelec main office in Intramuros, Manila, were deployed to augment workforces in local election offices in the plebiscite areas.

The special registration covered applications for voter's registration, transfer of registration, reactivation, change/correction of entries and inclusion/reinstatement of records, he added.

Jimenez said those who already registered for the barangay (village) and Sangguniang Kabataan elections did not need to register again during the special registrations.

The satellite registrations started at 8 a.m. and ended at 5 p.m. on the dates mentioned.

Who warned Du30 of plot against him?

IKE the New York Times being forced by President Trump to Jreveal who wrote its hot oped item on White House intrigues, President Duterte may find himself pressed to disclose which foreign power gave information on a destabilization plot against him in October.



And just as NYT refuses to identify the author, described as a While House official, Duterte is not expected to name the "ally" that shared intelligence about the plot that was hatched, he said, by the Liberal Party, Sen. Antonio Trillanes (Magdalo Party-list) and the Communist Party.

This is a serious accusation against the opposition. With no less than the President faming speculation by withholding the source and other details, a free-wheeling discussion has ensued.

The usual suspected source is the United States, which knows everything that happens or will happen in its former colony. This may be a slippery assumption, especially with Duterte saying that the US Central Intelligence Agency is out to assassinate him.

(But then, the CIA is known to move at times without explicit instructions from official Washington. If the CIA wanted to kill Duterte, as he claims, why would it expose a plot to get rid of him? To shunt blame if anything untoward happens?)

Or did Duterte pick up the destabilization rumor during his sometimes awkward meetings last week with officials of Israel and Jordan? But note that both countries look too distant to bother eavesdropping on Manila.

Closer to home, another possible source of reports of a conspiracy – assuming it is true – is China, which like the US knows everything about Filipinos who matter. Having forged mutually beneficial ties with Duterte, Beijing is interested in helping him consolidate power.

There is also Malaysia. Although neighbors and cofounders of ASEAN (Association of Southeast Asian Nations), Manila and Kuala Lumpur have had uneasy relations on account of the unresolved Philippine claim on the Malaysian state of Sabah.

Even as it played as third-party facilitator in talks between Philippine government panels and Moro rebel groups, Malaysia has not been able to put to rest suspicion that it was stirring up secessionist sentiments in Muslim Mindanao and sowing intrigue.

On Tuesday, Duterte again mentioned the three-party plot in a two-hour TV dialogue with his legal adviser Salvador Panelo. He first disclosed the plan to topple him upon arriving Saturday from Israel and Jordan

Duterte's Q&A-like exchange with his lawyer, billed

as a tête-è-tête, replaced the "President's Address" that was announced but scuttled later for still unknown reasons. The duo did not take media questions after the show, an unusual conclusion for the event.

We were expecting these items to be the likely subjects of the aborted "address": more details of the LP-Magdalo-CPP conspiracy set to explode in October, the declaration of nationwide martial law, a multi-pronged attack on rising prices, and escalated action against Trillanes.

· Duterte 'nakoryente' on October plot?

DESTABILIZATION could be among the weapons of a political opposition. But we think it most unlikely that the three parties tagged by Duterte – the LP, Magdalo, and the CPP – could quickly lay aside their differences and act together to oust him next month.

If some foreign power told this supposed plot to Duterte and he believed it, we think he was fed a bum steer. In local press parlance, nakoryente siya!

Starting to explain our skepticism last Tuesday, we noted that Duterie's conspiracy theory merely improved on the tale told by then President Marcos in 1972 to justify his declaring martial law so he could stay beyond the two-term limit and segue on to autocratic rule.

While Marcos talked of only two forces – the elitist Right and the radical Left – conspiring to grab state powers. Duterte lumped together the three parties, and left out the CIA that he had accused of planning to assassinate him.

We find it improbable that the three disparate parties named by Duterte could mount a serious destabilization as early as next month. They could, probably if they exploited the deterioration of the economy, over time – but not next month.

The remnants of the Liberal Party are in disarray and in bad need of leadership and funds. Trillanes' camp has some firepower but not enough to scare Duterte. The Communist seniors lolling in Holland have been reduced to a maudlin "Maalaala Mo Kaya?" club.

With these anti-administration forces not primed for an October strike, what plot is Duterte warning against? Could a crisis develop from extreme economic woes and trigger widespread violence and lawlessness to justify martial law or a revolutionary government?

Would the armed forces, assigned by the Constitution as the "protector of the people and the State," be able to handle a fake crisis if one were to be mounted? Would the Supreme Court hear the people's cries and defend their rights when threatened?

As a crisis – real or contrived – builds up, we expect an escalation in the communications cyberwar. The objective is to gain the upper hand in manipulating the public mind in relation to situations that may arise in October and on to the May 2019 midterm election.

With some 90 percent of the thinking population having access to cellphones and such devices, social media – not the traditional mainstream news and entertainment platforms – will be the crucial fronts in that war.

Duterte has had the communications advantage since the 2016 election, but that has not saved him from fumbling planners and operators – as has happened a number of times recently.

Such gut issues as rising prices of essential goods are distracting the target public. The economic stress makes people vulnerable to propaganda for or against the administration. The distraction is reinforced when such calamities as typhoons and floods hit populated areas.

Steady on ... honoring a Filipino hero of the Korean War

According to Filipino war correspondent Juan Villasanta, these were the dying words uttered by one of the heroes of the Korean War, words that echoed his team's motto. His name was Captain Conrado Yap, of the 10th Battalion Combat Team's Tank (later, Heavy Weap-



ons) Company

After surviving the Bataan Death March and serving as operations chief in the Filipino guerilla army, the young Conrado Yap married Aurora de la Llana in 1944. When the Korean War broke out on June 25, 1950, the Philippines was the first Asian country to join a United Nations coalition to support South Korea's efforts to repel the northern invaders, and Capt. Yap was one of the first officers deployed to Korea. As a soldier dedicated to duty, he did not hesitate to fight another nation's war for freedom and democracy, even it meant leaving Aurora and their three young daughters.

On April 23, 1951, at the famous Battle of Yuldong, Capt. Yap was shot by enemy fire while attempting to recover and rescue his fallen comrades, after he and his men had secured a strategic location that restored the Filipino front line and saved the lives of hundreds of UN Command soldiers. For his heroism, Capt. Yap has been honored by at least two countries, and recently, by another most grateful nation.

Shortly after his death, Capt. Yap was accorded the highest military honors by the Philippines (the Armed Forces of the Philippines Medal for Valor) and by the United States (the Distinguished Service

Cross)

On July 27, 2018, the 65th anniversary of the signing of the Korean Armistice Agreement, the Republic of Korea fittingly honored Capt. Yap by awarding him the First Class Taegeuk Cordon of the Order of Military Merit. This is the highest recognition given by the Korean government for military bravery and valor.

The award was presented to his daughter Isabelita Yap-Aganon by no less than Korean Prime Minister Lee Nak-yeon in Seoul as part of the annual Visit Korea Program, where Korea shows its gratitude to the veterans of the

Korean War,

On August 22, I received a heartfelt letter of appreciation from Isabelita, who said she was grateful for the warm welcome in Korea, and more importantly, for having been able to go to Korea as part of Revisit Korea 2018 and receive the rare honor for her father. She also expressed gratitude for the lunch I hosted

for her family last month.

I am humbled by her kindness, which only shows how well she was raised by her parents, even if her father had to leave his family when she was still a

small girl.

Last Friday, I joined the veterans of PEFTOK (Philippine Expeditionary Forces to Korea) and their descendants for the celebration of the 19th Korean War Veterans of the Philippine Memorial Day. Capt. Yap was one of those fallen heroes whom we honored

that day.

Moreover, since Koreans, just like Filipinos, place enormous value or education, our government also regularly awards educational scholarship to descendants of PEFTOK veterans. It is one of the means by which the Korea people recognize the noble sacrifice of the veterans. Without a doubt, Kore would not be the nation that it is toda progressive, motivated, with a stron economy and stable democracy—without the blood sacrifice of valiant soldier like the PEFTOK veterans, heroes like Capt. Conrado Yap.

We hope that we bring honor to Cap Yap and his comrades by continuing t remember their bravery and selfless ness during one of the darkest hours.

Now the judiciary can return to normalcy

ast Aug. 28 we entitled our column "An impeachIment impossible" because I personally believed that newly appointed Chief Justice Teresita de Castro and Justices Diosdado Peralta, Lucas Bersamin, Andres Reyes Jr., Francis Jardeleza, Noel Tijam and Alexander Gesmundo



would never be impeached for allowing the Quo Warranto decision that removed Ma. Lourdes Sereno. We columnists have already been warned not to make prophesies in our columns. However I felt that in this particular case, I never entertained any thoughts that Congress would be so stupid to allow this thing to happen to the Judiciary. True enough my prophesies came through!

I was watching ANC TV when Mindoro Oriental Rep. Salvador Leachon, committee chairman, announced "The complaints are hereby declared by this committee to be insufficient in substance and dismissed."

Opposition Reps. Edcel Lagman of Albay, Teodoro Baguilat Ir. of Ifugao and Gary Alejano of Magdalo who filed the impeachment complaints meekly requested for a case of reconsideration.

But Rep. Leachon was just being polite to them when he asked them to file that case for reconsideration, but my bets are ... this case is over, finished or done! The committee declared the evidence presented to them as insufficient in substance and therefore considered dismissed! At this point, we can finally say that the Judiciary can now return to some kind of normalcy after the ugly removal of the late SC Chief Justice Renato Corona and the removal by Quo Warranto of Ma. Lourdes Sereno. Let's hope and pray that this will be the end of top political leaders using the Legislative branch to remove Supreme Court Justices that they dislike.

This week was quite unnerving in the sense that certain legal issues remain unanswered with regards to Proclamation No. 572 signed by Pres. Rodrigo Duterte because the yellow fanged opposition went out of its way to use this issue at a time when prices of basic goods were rising and the political situation was supposed to be collapsing. Worse was when Pres. Duterte wanted to talk to the nation, which we later found out was a one-on-one interview with Chief Presidential Legal Counsel Salvador Panelo Tuesday afternoon.

One solution we've always looked at is for the Philippines to support our rice farmers through some kind of subsidy. Come now, we taught the Thais how to plant rice, but now we import rice from them. There is something wrong with this equation and various groups have offered solutions, but proper solutions are needed here.

On the issue of the amnesty given to Sen. Antonio Trillanes the President stated that his predecessor former Pres. Benigne "P-Noy" Aquino, apparently did not sign the amnesty for Trillanes because he believed that then Defense Secretary Voltaire Gazmin's

giving this Amnesty to Trillanes was sufficient. But apparently, the grant of amnesty is a presidential power that cannot be delegated to presidential appointees. Pres. Duterte also claimed that former Defense chief Voltaire Gazmin committed "usurpation of authority" when he signed the certificate of amnesty issued to Trillanes. This is a serious accusation done by the President.

Opposition stalwart. Sen. Risa Hontiveros called the tête-à-tête a "complete disappointment" and "a total waste of time and precious government resources." I have no doubt that Sen. Hontiveros expected much more from Pres. Duterte or for him to do even worse like declaring Martial Law. But her disappointment is not shared by many people who believed that the President did the right thing in having what I would call a "fireside" chat with Chief Presidential Legal Counsel

Salvador Panelo. On the contrary the President talked a lot with Panelo, which gives us an idea that Pres. Duterte is truly in control of the situation. Let me suggest to Sec. Panelo (I first met him during Mother Lily's birthday bash a few weeks ago) that they should have a fireside chat at least once a month. It's good for the nation.

Bangsamoro substate, not federalism

s envisioned, the proposed shift to "federalism" will divide the country into several "states" comprising more of less the existing geographical regions. Some political pundits have pompously claimed that federalism will arise from a proposed "federal" constitution.

But that is not federalism in its truest sense. Federalism did not arise that way in the United States or Germany, which represent the political model for federalism. In the American and German models of federalism, there were previously long-standing existing states with their own separate state "constitutions," and these states eventually grouped together in a federated union that was then characterized as federalism.

In fact, in the US, the Constitution never mentions anything about federalism, even if it is of common political knowledge that the US is a federal state. The US Constitution does not create "states," but merely allocates governmental power between the federal government and the already long extant state governments.

In the case of Germany, the German Basic Law expressly states that it is a federal republic. But it is merely descriptive, because, the fact is, there have long been existing states, called "Länder" in German, with their own state constitutions. These Länder grouped together after World War II to form the Federal Republic of Germany.

In political science, the true characteristic of federalism is the existence of independent states—with their own state constitutions—that form together into what

is known as federalism. In other words, federalism is not formed by carving up regions to constitute the states. The lack of a separate constitution for each state in such an artificial setup even detracts from the true nature of federalism.

In modern times, what comes to mind as another model of federalism is the European Union, with different full-blooded European nation-states coming together in a union along federal lines:

It is the function of the federal constitution to allocate governmental powers between the states, on one hand, and the federal government, on the other. It is in this context that a federal constitution can truly be considered as such. A constitution, like the one being foisted by the Duterte administration, is not federal in nature when it purports to carve out regions into states. It is more in the nature, rather, of a glorified local government code masquerading as a federal constitution. The only difference is in its name and its object, because it is called a constitution meant to create states out of groups of provinces and cities.

In our history and political culture, it is ineluctable that there have been no independent, existing states at all. There is no public desire for regional states, as evidenced by the low public awareness and support for federalism. Even the Cordillera Administrative Region rejected the concept of autonomy in a plebiscite.

Only our Muslim brothers in Mindanao have consistently demanded self-government, from the time of the Moro National Liberation Front to the Bangsamoro Liberation Front. It is only this distinct minority that has consistently evinced, through decades of wars of liberation, a long-standing desire for a "substate," as expressed in the recently passed Bangsamoro law.

If federalism is meant to provide a substate not only to the Bangsamoro but also to the other regional states for the sake of political equality, why create other regional states just to create a substate for the Bangsamoro?

As a matter of practical politics, the most viable solution to the problem of the Bangsamoro is to push through with its clamor for a substate. This solution should be threshed out in the Supreme Court, where the government and the Bangsamoro should be able to ardently defend the constitutionality of the project.

And if there is a need to amend the 1987 Constitution to forestall any constitutional challenge, then the proper constitutional amendment should be done to accommodate a Bangsamoro substate. This political nonsense about federalism should be stopped as an exercise in political witchcraft.

Farce in progress

uried in the Sept. 4 issue of the Manila Times is a copy of Proclamation No. 572 that ordered the unprecedented revocation of the amnesty granted to Sen. Antonio Trillanes IV, and his apprehension by the Armed Forces of the Philippines and the Philippine National Police.

The proclamation, signed by

President Duterte on Aug. 31 before he left on an official trip to Israel and Jordan, cited as its basis the supposed failure of the failed mutineer to "file an official amnesty application form." There is no available copy of his application for amnesty, the Palace said, and Trillanes also "never expressed his guilt for the crimes that were committed on occasion of the Oakwood mutiny and Peninsula Manila hotel siege."

For those reasons, declared Mr. Duterte, the grant of amnesty to Trillanes was "void ab initio," or void from the beginning, because he did not comply with the minimum requirements to qualify for amnesty under Proclamation No. 75 signed on Nov. 24, 2010, by President Benigno S. Aquino III; and later concurred in by both Houses of Congress.

That original reasoning barely lasted a day. Legal experts and other observers immediately weighed in to declare that the proclamation had no basis in fact and law. Relevant audio, video and photo evidence soon came up showing that Trillanes indeed applied for amnesty and admitted guilt in 2011. Moreover, it was pointed out, the President cannot order anyone's arrest, no matter his pique; only the courts can. The rush by government forces to arrest Trillanes in the Senate premises on Tuesday was checked forthwith when the chamber provided sanctuary to one of its own, and declared that Trillanes could not be arrested without a valid warrant.

The Integrated Bar of the Philippines, expressing alarm at the development, said that amnesty, once granted, "cannot be simply dissolved by the invocation of the words 'void ab initio' as though it were some magical incantation that can nullify vested rights."

The courts themselves seemed in no mood to include the Palace. The Department of Justice filed "very urgent" petitions to arrest Trillanes in not just one but two Makati City Regional Trial Courts, triggering charges of forum shopping. Both, however, refused to issue any warrant and preferred to give Trillanes time to comment on the cases. The Supreme Court itself, while declining to issue a temporary restraining order on the President's proclamation as requested by Trillanes, remanded the matter to the lower courts, effectively further staying any move to arrest the senator.

Bested on all fronts, its immediate plans to have a fierce critic of the President triumphantly locked up in jail upon Mr. Duterte's return now in shambles, the Palace was forced to retreat. It would respect the rule of law, it announced, and let the courts decide on the arrest.

But it was not about to back down so easily. Next came a new justification: Former defense secretary Voltaire Gazmin had supposedly "usurped" the authority of the President to declare amnesty, because only the President can grant amnesty, and Gazmin's signature on Trillanes et al.'s applications was not enough to make the amnesty official. But Gazmin's actions, everyone else pointed out, were in fact all in accordance with Aquino's Proclamation No. 75. Moreover, this belated resort to blaming Gazmin was obviously meant to shore up the battered—Palace—position;—nowhere—was—any "usurpation" mentioned in the original reasons cited for the amnesty revocation.

Perhaps the more authentic reason was let out in Mr. Duterre's unusual televised "tête-â-tête" with presidential legal counsel Salvador Panelo on Tuesday. "Ang problema kay Trillanes ay (the problem with Trillanes is) he's crucifying Bong Go for entering into business with the government," said the President, referring to his long-time special assistant. The implication seemed to be, if only Trillanes had played nice with the administration, he wouldn't be hounded this way.

Certainly, that all-too-revealing pretext wouldn't make it to the official Palace arguments once its case against Trillanes is heard in court. But in this farce in progress with Malacañang moving its arguments and goalposts every time, the bet is high that yet another, more cockeyed rationale would soon roll out from the Palace story factory—any excuse, really, to cut down the prickliest thorn in the President's side.

Still 'very good' but drop in rating must be stopped

HILIPPINE presidents have all historically begun their administrations with high expectations and support from the people, then gradually tapering down as problems arose. Days before his inauguration in June, 2016, President Duterte received a personal record high of plus-79 as his trust rating in the Social Weather Stations survey for the second quarter of that year. The SWS deemed this score "excellent."

The President continued to score "excellent" in the next four quarterly surveys. Then in the sixth survey in the quarter ending December, 2017, his trust rating fell to plus-75. It dropped to plus-65 in March, 2018. Last Sunday, in the latest survey of June, 2018, the trust rating fall further to plus-57.

Despite these three successive quarterly drops, the President's rating is "very good," in the assessment of SWS. This is so much better than the ratings of some previous presidents, which fell to as low as plus-6 at one time during the Arroyo administration and plus-5 during the Estrada administration.

Nevertheless, administration leaders should make an effort to determine what may have caused this steady drop in the President's trust rating for three quarters now – nine months since December, 2017. Before the drop, the administration engaged in an all-out campaign against the drug menace, with thousands reported killed in the course of the drive led by the Philippine National Police, until it was replaced by the Philippine Drug Enforcement Administration. But during all that time, the presidential trust rating remained "excellent," so the

drug campaign was apparently was not a factor in the survey.

Very likely, the critical factor was rising prices – inflation to economists – which started around January this year. There were many other issues in the following months, among them the smuggling of drugs worth billions of pesos, efforts to cancel the 2019 midterm elections in the effort to draft a new constitution for federalism, killing of several priests at one time, a police campaign that rounded up thousands of "tambays." But the rise in prices dominated the public's attention. In one survey, the people listed as their foremost concerns the prices of goods, low salaries, and unemployment – all economic issues.

The administration has a host of concerns that it needs to attend to – our claims in the South China Sea, our need to strengthen our military forces, our relations with the United States, Russia, China, and other nations, the break in peace talks with the New People's Army, new reports of violence in Mindanao, etc. We have also been hit by a series of floods from the "habagat" monsoon rains intensified by one Pacific storm after another.

On all these issues, the President and his menhave done very well. But the latest SWS survey shows a continuing drop in the President's trust rating. We can only surmise that people are feeling — more than the effects of these many other issues — the economic problems that have been worsened by the record inflation, the market prices that continue to rise, affecting—the daily lives of their families.

Bangsamoro Organic Law

NE question that maintains currency in the scheduled January 21, 2019, plebiscite for the Bangsamoro Organic Law (BOL) under Republic Act 11054, was an answer made by former Assemblyman Homobono Adaza in my TV interview with him. The threat or spiraling of Mindanao declaring independence or a portion separating from the Republic in the future, is a serious concern which must be prevented and addressed not by

Mindanaoans alone, but the entire country," he said.

'Destabilization' is a CIA euphemism for 'overthrow'

First word

THE situation has suddenly gotten more complex and menacing, not because President Duterte says so, but Makabenta A4

because our political vocabulary has suddenly morphed from "amnesty" to "destabilization."

In a wink, we have been transported to the world of the spooks, the intelligence community. The language or lingo here is "CIA-ese," says William Safire, the language maven (See list of CIA-ese below.)

If you know a fraction of what I have learned (from books, reports, DVDS, etc.) about the world of intelligence and the games that spooks play, you will sit up straight when you hear President Duterte declare that there is a destabilization plot against his government that is targeted to unfold on September 21, 2018, the anniversary of Martial Law.

You will listen and you will study the mountain of information before you. Then you will watch the calendar and become enraged.

Destabilization a CIA coinage

Consider first this discovery that I found during my research:

The US Central Intelligence Agency (CIA) coined the term "destabilization" or "destabilize," as a euphemism for "overthrow." A euphemism, as my Collins English dictionary defines it, is "an inoffensive word or phrase substituted for one considered offensive or hurtful."

My authority on this is William Safire, lexicographer, author, presidential adviser and erstwhile New York Times columnist, and his indispensable lexicon, Political Dictionary (Random House, New York, 1978).

Safire shares plenty of information and inside knowledge — much of which is hair-raising but which nobody bothers to dispute.

Safire reports that the Director of Central Intelligence William Colby disclosed to a congressional committee in April 1974 that the CIA had spent \$8 million in Chile between 1970 and 1973 in an effort to make it difficult for Marxist Salvador Allende Gossens to govern.

"The goal of the clandestine CIA activities," wrote Seymour Hersh in the New York Times on September 8, 1974, "was to destabilize the Marxist government...."

Since the word was a freshly coined euphemism, and since it appeared to conflict with sworn testimony by Secretary of State Henry Kissinger that "the CIA had nothing to do with the coup" that overthrew Allende, the term was used with savagery and glee by critics of covert US activities.

Thereafter, the word was

used in a positive sense early in the Carter administration. US ambassador to the UN Andrew Young discussed Cuban intervention in Africa as possibly proving to be a "stabilizing force." As Cuban troop strength grew in Africa in 1978, critics of the Carter foreign policy used "stabilizing force" against Carter's men, much as critics of Kissinger had used "destabilization" against him.

Over the years, the CIA coinage has found acceptance in the language.

Oxford now includes "destabilization, destabilize" (British, "destabilisation, destabilise") in its dictionaries.

It considers "destabilization" a mass noun, and defines it as "the process of upsetting the stability of a region or system, especially of government."

The American Heritage Dictionary of the English Language, the foremost American English dictionary, lists and defines "destabilize" as

 To upset the stability or smooth functioning of a policy;

2. To undermine the power of a government or leader by subversive or terrorist acts.

"Destabilization" has become an obsessive part of Philippine political culture. Leaders and plotters, citizens and soldiery, even religious, talk freely of destabilization here.

From media meeting to dialogue

This brings us to the question then: Is there really a destabilization plot against the government of President Duterte?

I was not disappointed to see President Duterte's meeting with the media shift to a dialogue between DU30 and his legal counsel, Salvador Panelo. They conversed about the reality of the threats of destabilization against the Duterte government.

Serendipitously, presidential communication could take place without the usual questioning by Palace journalists, who ask DU30 endlessly to comment on something Trillanes said or so-and-so has said. I was more interested in getting to the truth or falsity of the alleged destabilization plot against the government.

Duterte claimed that he had received validated information from a foreign intelligence group that confirms threats to destabilize the government or launch a coup.

Malacañang has named the Magdalo group led by Sen. Antonio Trillanes 4th as among those that have connived to

oust the President from power.

Duterte accused Trillanes and his Magdalo party of coalescing with the "yellows" and the Liberal Party and the communist rebels (CPP-NPA) to remove him from the presidency by October,

He attested to the veracity of the intelligence information. He said he has asked the military to declassify the information given by the unnamed foreign power on the plot and the principal plotters, so that the Filipino people can become fully aware of the threat to their government.

Presidential spokesman Harry Roque Jr. said that the president had basis for the claim because he has access to privileged information, which may have led him to conclude that his enemies were out to overthrow him.

Roque took a shot at members of the LP who cannot "move on" and accept Duterte as president.

Duterte rounded it up by saying that the public should be wary that Trillanes, the LP and the communist rebels have combined in planning to remove him from office.

Proof from foreign intelligence

He suggested that there is incontrovertible proof on the plot from the intelligence report given him by "a foreign power.

Was the foreign power China, the US or Russia? Was it Israel, from where he had just rushed home to explode the news about destabilization. Anyone of these four countries, with their intelligence agencies, have the capability to secure the information. If they disclose what they know. it will be incontrovertible and actionable

There may be no hole for the plotters to hide in.

The named groups now see what they are up against. They are scampering for cover and denials.

All have denied complicity in a destabilization plot. But all have persisted in their declared desire to remove Duterte from office.

Do they want to overthrow Duterte as president? They look ready to shut up on this.

Trillanes has finally left the Senate, resigned to the certainty that he must face trial in civil court, and face renewed court martial proceedings against him.

The LP senators talked at first about conducting a Senate inquiry into the revocation of the Trillanes amnesty. But now that the specter of a coup plot

is leveled at them, they will quickly forget about it. The LP must choose whether to declare support for Trillanes. or declare support for the duly elected government.

The CPP-NPA has not made known it's response. The front groups in Congress are especially apprehensive, because a misguided statement could cut them off from their lifeline to the public treasury.

The media will also be reassessing the situation, and review how they have reported this political crisis. They will see that the situation is more serious and complex than they at first believed. They themselves will wonder why Trillanes and the opposition and even Leila de Lima have such easy access to their front pages and channels with selfserving statements.

A member of the Catholic clergy has resorted to prayer, supplicating Providence that Duterte will get sick and die. Even the CBCP will cringe from this

CIA glossary

This makes "CIA-ese" sound noble.

"CIA-ese," says Safire, is spook speak, the language of the intelligence community. în 1976, a Senate select committee to study governmntal operations with respect to intelligent activities compiled a glossary of CIA-ese.

Surprisingly, the committee did not include the word "destabilization" or "destabilize" in the glossary, probably because they are too close to home. They look like 'a skeleton in the CIA closer.*

included in the glossary are:

1. Executive action - a cuphemism for assassination, used by the CIA to describe a program aimed at overthrowing foreign leaders.

2. Plausible denial - a cover story to disclaim knowledge of an intelligence activity.

3. Plumbing – clandestine sting operations of CIA field stations, such as safehouses, unaccountable funds, investigative persons, surveillance teams.

4. Covert action - a clandestine activity to influence foreign governments.

5. Blowback - lies circulated by the CIA that are picked up by US correspondents abroad and sent back to the US as the truth.

There is more on the list.

I think the local Catholic Church should submit "assassination by prayer" for inclusion in the CIA glossary. Maybe by this, the CIA could be induced to take local priests seriously.

Out of the EDSA hamster wheel

T's an all too familiar story. Seek the impeachment of the president you want to remove (and replace). If it doesn't work, prod people to flock to EDSA. Then wait for the military to defect. Thus, EDSA is a people-supported coup d'etat. It's a formula used and abused over and over again in our politics. A formula the opposition wanted to use again to overthrow and grab power from President Rodrigo Duterte.

A trigger activates the formula. In EDSA 1986, it was the assassination of Ninoy Aquino three years before. In EDSA 2001 (A), it was the refusal of 11 senators to open a second envelope during the impeachment trial of deposed president Joseph Estrada. And in EDSA 2001 (B), it was the arrest of Estrada.

Among three presidents who faced an EDSA uprising, it was only Gloria Macapagal-Arroyo who survived one. Well, two, if we count the planned-EDSA in February 2006, which fizzled out after Arroyo nipped it in the bud by declaring a state of national emergency.


In Proclamation 1017, Arroyo identified the strange bedfellows conspiring to bring down the presidency — 'elements in the political opposition have conspired with authoritarians of the extreme Left represented by the NDF-CPP-NPA and the extreme Right, represented by military adventurists." The media was also implicated. "The claims of these elements have been recklessly magnified by certain segments of the national media."

Arroyo put a stop to the EDSA madness. And what was then called "people power fatigue" staled the magic of EDSA.

In Democracy and its Discontents, investigative journalist Sheila Coronel limns that phenomenon as the "weariness and disillusionment about the prospects of democracy." A malaise precipitated by "skepticism about the desirability — and long-term viability — of the elite democracy established after [Ferdinand Marcos'] fall,"

I don't think people are disillusioned with democracy. What people are tired of and disgusted with is the EDSA wolf in sheep's clothing. People have realized that those who sell another EDSA to them are akin to the con men who wove the emperor a robe of the finest fabric. EDSA lost its magic the moment they realized that the fabric of revolt is made not of threads of yearning for deeper transformation but of skillfully crafted PR of power-hungry political swindlers who speak decently, dress dandily, and act godly.

The opposition to Duterte is trying to sell another EDSA to us. Their first major attempt was in February 2017, after Sen. Leila de Lima was arrested for her alleged involvement in the illegal drug trade. No EDSA. Now, the opposition might be thinking that the impending arrest of Sen. Antonio Trillanes 4th after his amnesty was voided could be the trigger. That lacks historical perspective.



Trillanes is not Emp Estrada who commands a cult-like following. During EDSA 2001 (B), Estrada's supporters massed and rioted outside Malacañang.

At the time, we were living near Malacañang. We could smell the scent of the car burnt by the noters for Erap. And we couldn't go out of our house without feeling the sting of tear gas. The rioters were willing to die for Erap. It almost overthrew GMA's months-old government. The poor folks chanting "Dugo ng Masa" while pointing at the fresh blood on concrete was very haunting.

None of that happened for any of the cause celebré of the Liberal Party of the Philippines. For the masses, Erap was worth dying for. Will the so-called "woke" and "hashtag" generation die for Trillanes or any of the celebrated cases the Liberal Party might be able to supply them?

I don't think so.

After Marcos was buried in the Libingan ng mga Bayani in November 2016, the Liberal Party drummed up another EDSA in February 2017. The moment came, we saw it, nothing was conquered. EDSA is done. It has outlived its purpose. The more wester out of the EDSA hamster wheel, the more we will be able to muster the political maturity needed so we can really improve on the shortcomings of our political community.

Former Supreme Court Associate Justice Jose Vitug eloquently expressed the essence of that political maturity in the last paragraph of his concurring opinion on Estrada v. Desierto (2001):

"A reminder of an elder to the youth. After two non-violent civilian uprisings within just a short span of years between them, it might be said that popular mass action is fast becoming an institutionalized enterprise. Should the streets now be the venue for the exercise of popular democracy? Where does one draw the line between the rule of law and the rule of the mob, or between "People Power" and "Anarchy?" If. as the sole justification for its being the basis of the Arroyo presidency lies alone on those who were at EDSA, then it does rest on loose and shifting sands and might tragically open a Pandora's box more potent than the malaise it seeks to address. Conventional wisdom dictates the indispensable need for great sobriety and extreme circumspection on our part. In this kind of arena, let us be assured that we are not overcome portunism. The country must not grow oblivious to the innate perils of people power for no bond can be stretched far too much to its breaking point. To abuse is to destroy that which we may hold dear." At

The ouster plot



IS THERE really a plot to oust President Duterte? If there is, where is it coming from and who are behind it?

Basing from the two models wherein the country ousted two of its presidents, the report, to be credible, could
only come from two fronts. The tactical alliance of our uniformed services
and the political opposition is materially supported in part by vested interest groups from the business community. But there is no credible and
verifiable intelligence coming from
these groups.

In the ouster of former President Joseph Estrada, left-leaning organizations participated by providing warm bodies to help the demonstrations going for days. The civilian plotters worked on the military and police to turn them around. They eventually succeeded in removing President Estrada.

In the current situation, it is hard to see where the threat is coming from. Other than the communists who are bent on ousting the President, the report of a plot is only a rumor according to Defense Secretary Delfin Lorenzana, a staunch but level-headed supporter of President Duterte. It is possible that it is just a product of the insecurities of the President.

If it is, he should not be alarmed. His trust and approval ratings remain high, midway through his term. He among many Presidents have shown partiality to our uniformed services showering them with better pay and appointment to positions in government. In fact, one criticism of the President is that there are too many retired uniformed people occupying senior positions in government. He has indeed pampered the Police and Military to the envy of other government employees. In his recent trip to Israel and Jordan, he brought with him retiring military and police personnel as a parting gift which

swelled the number of the delegation. I realize of course, that these are not iron-clad guarantees that some disgruntled elements from the police and military will not join other factions for a plot to oust the President but right now, there are no indications at all.

As they say, where there is smoke, there is fire and those of us even in the retired list are not hearing anything. If there is, we would have heard it in the grapevine because it is something that cannot be hidden for long. If it is the

Liberal Party that is leading the plot, it is hard to see how it will succeed considering that its ranks have been decimated and whose members are now mostly with the majority party. Vice President Leni Robredo, the head of the party, is not exactly the type that can spearhead a plot to oust a President. The President himself already questioned the competence of his Vice President. If it is a project of the Liberal Party and the reds, this would automatically exclude the uniformed personnel because they could never go to bed with the Reds. Perhaps what is in the mind of the President that he cannot say in public is the unseen hand of a puppeteer directing or encouraging disgruntled elements in the country to oust him. If so, he is probably referring to the CIA which has occupied This mind ever since he took office. He seems to believe that the United States. represented by the CIA, has a plan to get him. During his trip to Israel, he alluded to some unseen forces who are spying on him and monitoring all his

activities.

Since he is the repository of all intelligence reports, we do not know if he has some basis in believing so. Senator Antonio Trillanes has also been mentioned as one of the leaders of the ouster plot. But if we ask anybody in the police or military, it is doubtful if the good Senator can recruit a platoon much less a company of soldiers to follow him. Besides, his record of leading coups has not been very good. He was of course able to parlay his involvement in coup plots to become a senator of the realm but most of his comrades were not as successful as him. We have seen this in the two coup attempts that the good Senator has participated. The Oakwood and Peninsula Hotel capers ended in total failures and destroyed many careers.

It is true that Senator Trillanes is a big thorn on the side of the President but to make a martyr out of him will just be igniting a fire that has the potential of developing into a bigger problem. If indeed we have a democratic system of government, it is better to leave Senator Trillanes alone so that we can say to the world that there is dissent in this country. If dissent is stifled then our reputation as a country ruled by a strongman will cause our democratic credentials to deteriorate further.

The midterm elections is just around the corner and politicians from all parties are already lining up for the coming political battle which is one good reason why the story of an ouster plot is not credible. What the administration should perhaps be doing instead of being so fixated on the ouster plot is to try to do something about the economy which is floundering. The peso is depreciating, the inflation is at record levels, our international reserves have gone down not to mention the scarcity of rice which the government continue to describe as artificial. If all these are left unattended, these will be the spark that will ignite bigger problems for this government in the long run and not the report of an ouster plot.

Hiding in Senate's plain sight

Isa't it as clear as day that the order to employ "all legal means" translates to a court order?

Both parties welcomed the decision of the Supreme Court (SC) not to issue a temporary restraining order (TRO) which was sought by Sen, Antonio Trillanes through his lawyer.

The SC turned down the plea of Trillanes for a TRO as it said the court found "no extreme and urgent

necessity" to grant the opposition senator's request for injunctive relief as it took judicial notice of President Duterte's "categorical pronouncement" that Trillanes "will not be apprehended, detained or taken into custody" without a court-issued arrest warrant.

The High Court's non-issuance of a TRO on the Trillanes plea is a big legal loss to Trillanes but he and his lawyer are trying so hard to make it appear that they had won and that it is Duterte who lost.

As Solicitor General Jose Calida stated, "Clearly, the baseless and inflammatory statements of Mr. Trillanes are mere delusions of a grandiose man."

But if the senator believes that the SC ruling favored him, why then has he refused to leave the

Senate grounds, which he has been using as his safehouse, hiding in plain sight, evidently in fear of an arrest, despite Duterte already having given the order to both the police and the military not to arrest Trillanes without a court order?

His continued hiding in his Senate office merely generates

the perception that while he portrays himself as a courageous man taking on the President of the Republic, he instead shows himself to be a coward.

Calida welcomed the SC's ruling, saying: "The OSG (Office of the Solicitor General) welcomes the development that no temporary restraining order was issued and we minure the hope that Mr. Trillanes, no matter how remote the possibility, will finally man up and face the charges against him for the unlawful actions—he—committed—against—the-Filipino people."

The way it looks, given Trillanes history of evading arrests, should the Makati court issue a warrant of arrest for Trillanes, one can bet his bottom peso that Trillanes will immediately go into hiding, just as he made sure that the two paid witnesses he presented before the Senate against Duterte in the senator's bid to portray the President as having ordered the murders of extra judicial victims.

Still, not to worry since the arm of the law will get to Trillanes,

sooner or later.

Trillanes' lawyer, Rex Robles, tried to make it look as if they won, saying "we were hoping for an issuance of TRO but despite the fact, that the Supreme Court did not issue a TRO, we are gratified that SC has taken official judicial notice of the, commitment of the President not to order his arrest and commitment of the Armed Forces of the Philippines, (AFP) not to arrest Senator Trillanes without a valid warrant."

Instead, they were clear in their message - a fight was in the offing, lines have been drawn and they choose to stand defiantly opposite the people.

Their timing is suspect however. One was being confronted by the growing diminution of her gossamer-thin lead versus a more experienced pedigreed candidate in the 2016 polls who might have won had not massive cheating denied him the vice presidency.

Not ordy would she stand to lose her seat but also, charges of electoral fraud would be validated and fall upon her and her political party - the ruling

party in 2016.

We make no pretense, what we did in Oakwood or the Manila Pen are natural acts of a soldier...we were detained (for it)...We have no regrets for what we did. It happened and that is whatever fate had written...so we accept it."

The difference is critical More so had his deadly betrayal succeeded in overthrowing the government and installing a junta in its stead. 4

President Rody Duterte had his opponents taken for a ride in their anticipation on Tuesday of a major announcement such as the declaration of a revolutionary government but instead got to watch on television a legal discourse between him and Chief Presidential Legal Counsel Sal Panelo.

When his political enemies were entertaining the thought that Rody had finally caved in and had fallen for their trap of baring his most ruthless side, the President gave the nation a clarification of the legally complex issues on the invalidation of the amnesty of Sen. Antonio Trillanes IV.

Between lawyers, Rody and Sal effectively explained the problems confronting the nation and how these tie up with the intensified destabilization efforts.

Rody was a prosecutor in Davao City before becoming its mayor.

The key agenda of the tete-a-tete was the invalid amnesty given to Trillanes and other Magdalo mutineers by yellow President Noynoy Aquino.

Explaining the legal requirements for the grant of the privilege to rebels, Rody said he will not back down from enforcing what was mandated under the law.

Through the dialogue, Rody and Sal showed how the amnesty process for Trillanes was apparently rushed and went through shortcuts that ultimately made it illegal.

He insisted that since former Defense Secretary Voltaire Gazmin signed the original amnesty documents for Trillanes and not Noynoy, they are invalid as only the President can sign such an order.

Rody compared the presidential prerogative to grant amnesty to that of declaring martial law. Such matters were not for Congress, the courts or the Cabinet but for the President alone to decide on, he said.

Aside from the legal explanations, the dignified dialogue between two lawyers was also an assurance to Filipinos that Rody is in full control of the situation which is underlined by his dare to his opponents to face the people and offer a solution to the nation's problems and if these are accepted, he would gladly step down.

He addressed soldiers and said if they think Trillanes cares about them "go ahead and kill me."

For Rody, he remains on track in his commitments to policies

based on promises to voters who elected him.

The foes of Rody have clearly tried to bait him to fight fire with fire and thus heighten the conflict that would have been exploited to further increase the international pressure on him.

The clarity of the contrast between the lust for power of his critics and his unwavering commitment and sense of duty to protect the government and the nation became more striking after Rody's explanations.

The dialogue also touched on the high inflation rate and the weak peso which are both reactions to external forces rather than policy reforms that his administration had taken. 4

Economists point to many developing economies, including China, as experiencing a currency depreciation that also causes consumer prices to rise. India, Pakistan, Turkey, Russia, Iran, Indonesia and Argentina are also reeling from weak currencies.

Global markets are feeling the effects of US tariffs and sanctions on developing economies, a strong US dollar amid recovery of the American economy, high US interest rates that siphon funds from emerging markets, high oil prices as a backlash of new US sanctions on Iran and the generally unstable political situation in parts of the Middle East.

Also, economists indicated that the fast developing economy increases consumer demand that leads to inflation pressures.

In criticizing oligarchs who he said hoard rice and other commodities resulting in higher prices, he indicated that more actions will be taken to lower prices of essential commodities.

He indicated plans to seek Congress' move to abolish the National Food Authority (NFA) Council and to replace NFA head Jason Aquino since the agency failed in its duty to control the prices of the staple grain.

The main message of the Rody and Sal show was that the government is in control and a new power grab will not prosper.

Nananatiling 'very good', ngunit kailangang mahinto ang pagbagsak ng rating

MAKASAYSAYANG nagsisimula ang administrasyon ng lahat ng naging pangulo ng Pilipinas kasama ng mataas na ekspektasyon at suporta mula sa mga mamamayan, hanggang untiunting bumababa sa pag-usbong ng mga problema. Ilang araw bago ang kanyang inagurasyon noong Hunyo 2016, nakapagtala si Pangulong Duterte ng personal record high na plus-79 bilang trust rating sa survey ng Social Weather Stations (SWS) para sa ikalawang bahagi ng nasabing taon. Ang puntos na ito ay "excellent" sa pagtataya ng SWS.

Nagpatuloy ang pagtanggap ng Pangulo ng "excellent" sa sumunod na apat na survey. Sa pagpatak ng ikaanim na survey sa huling bahagi ng Disyembre, 2017, bumaba sa +75 ang kanyang trust rating. Muli itong nabawasan sa +65 nitong Marso 2018. At nitong Linggo, sa pinakabagong

tala ng survey para sa Hunyo 2018, lalo pa itong bumagsak sa +57,

Duterte's oust dare to military an 'expression of confidence'

MANILA -- President Rodrigo Duterte's challenge to the military to oust him was an expression of confidence that Senator Antonio Trillanes IV and other groups will not get support from the soldiers, Malacañang said Wednesday.

"Ang konteksto talaga ng President is kung gusto nyo talagang mag-alsa, mag-alsa na kayo para matapos na. Ibig sabihin kampante ang Presidente na wala naman suporta sa hanay ng military para patalsikin sya (The proper context of the President is if you want to oust me, then oust me so that it will be over. It means the President is confident that there would be no support from the military to unseat him)," Presidential Spokesperson Harry Roque said in a Palace press briefing.

Roque, however, said Duterte has clarified that he is not clinging to the position he won overwhelmingly in the 2016 elections.

"Chinallenge niya dahil sigurado naman siya na walang suporta. Pero sinasabi niya na ako'y hindi kapit tuko. Kung gusto nyo, gawin nyo (He challenged them because he's sure there would be no support. But he's also saying he is not clinging to his post. If they want to, then do it)," he said.

During last Tuesday's televised one-on-one interview with Chief Presidential Legal Counsel Salvador Panelo, Duterte said Trillanes' Magdalo group, Communist Party of the Philippines founding chairman Jose Maria Sison, and other opposition groups are in a "loose conspiracy" to overthrow his government.

"They have combined and we have the evidence and we have the conversation provided by a foreign country sympathetic to us," Duterte said.

The President then dared the soldiers to join Trillanes if they think the senator, a former Navy officer known for his failed coup attempts against former president Gloria Macapagal-Arroyo, can do better in running the country.

"I urge you to go to Trillanes. If you want another president, fine," Duterte said.

The salaries of the soldiers and policemen have been doubled under the Duterte administration.

When asked to expound on Duterte's intelligence report from a "sympathetic" foreign country, Roque said he has no idea if sharing information is a regular thing.

"What I do know is sharing intel is precisely intended to provide you information to avoid eventualities," said the international law expert.

Roque clarified that the sharing of intelligence reports is "recognized as the function of diplomatic nations."

By 2028, a world-class Army that is a source of national pride.

"That's the nature of diplomatic relations nowadays," he said.

He said the Philippines has actually benefited from sharing information from the United States about terrorists.

Duterte has said the "sympathetic" nation, which he did not identify, has granted his request to declassify the conversation for it to be shown to everyone "maybe any day now." (PNA)
