Evidently, he failed to present the original hard copy, a duplicate copy or even a photocopy showing that he personally accomplished and filed with the (defense departofficial amnesty application form duly acknowledged and stamp marked received by said office," Alameda said.

"A cursory examination of the omnibus motion filed by the prosecution to issue warrant of arrest and hold departure order against Senator Trillanes reveals that it raised valid grounds that require factual determination of the issues in order to arrive at a just resolution, so that none of the parties would be deprived of due process," he said.

The court said the state would be deprived of due process if the case of rebellion against Trillanes is not revived.

"The order of dismissal was issued in contravention of the 'Rules and Procedures in the processing of amnesty application pursuant to Proclamation No. 75 series of 2010'," Alameda said.

Alameda was the same judge who dismissed the rebellion case against Trillanes following the amnesty granted to him under Proclamation No. 75.

He said the dismissal order, being a void order, it has no legal and binding effect, force or efficacy\_for any\_purpose."\_

He added the Sept. 7, 2011 dismissal order is already nonexistent, which means it cannot attain finality "and the (Trillanes) was not my busi-

Eleazar read Trillanes his rights after the sheriff served the warrant.

Trillanes was not cuffed when he boarded the police van on the way to the Makati Police for booking procedures before going to the court for filing of bail.

When asked if he had anything to say to Duterte, the former Navy officer remarked: "I hope he's watching this now because he will go through the same procedure soon."

He said he could still be locked up by authorities for other reasons, considering Duterte's zeal to have him and other critics jailed.

Some lawmakers went with Trillanes to oversee the arrest procedure. He was accompanied by Sens. Francis Pangilinan, Paolo Benigno Aquino IV and Risa Hontiveros.

After undergoing court procedures, Trillanes was released late in the afternoon and returned to the Senate.

Earlier in the day, Senate President Vicente Sotto III said he will not allow any forcible arrest of any member of the chamber, even as he disclosed that Trillanes assured him that he will yield peacefully.

Senate President Pro Tempore Ralph Recto said the authorities must ensure Trillanes'

"Dissent is very important in a healthy democracy. There should be a place for dissenting views. This can only help in governance. Just because there is dissent doesn't mean that there is an intention to cause any harm," Robredo

Pangilinan said that while they respect the order of the court, "we disagree with it."

"It is as clear as day that "Since the charge, by order the revocation of the grant Suerte Felipe, AP

abuse of presidential powers must be vigorously opposed," Pangilinan said.

Aquino, for his part, called for an end to the threats and intimidation against members of the opposition.

He said the administration has neglected the needs of the people with its insistence on going after Trillanes and other critics of the administration.

Hontiveros condemned the issuance of the warrant against Trillanes, saying that this is "a black eye for democracy and rule of law as our courts caved in to the whims of President Duterte."

Rights defenders said the arrest of Trillanes is part of the persecution of critics of the Duterte administration.

Carlos Conde, Human Rights Watch Researcher-Asia Division, said the arrest is the latest in the relentless campaign to silence those who dare to challenge Duterte's murderous drug war.

"He (Trillanes) has likewise supported the International Criminal Court's preliminary examination of the complaints against President Duterte related to the drug war," he said.

Trillanes' arrest sends a chilling effect among other critics of the Duterte administration, the group said. - With Marvin Sy, Rhodina Villanueva, Cecille

The latest Pulse Asia survey shows President Duterte's approval and trust scores have declined to their lowest levels. Presidential spokesperson Harry Roque says rising inflation caused the drastic drop.

Gut issues are pulling down the approval and trust ratings of President Duterte.

His approval and trust ratings saw double-digit declines early this month, plunging to their lowest levels, as soaring prices of basic commodities hurt consumers, especially the poor, who spend a big part of their income on food.

Results of a Pulse Asia survey released on Tuesday showed Mr. Duterte's approval and trust scores declining 13 points and 15 points, respectively, although a majority of Filipinos still approve of his work and expressed trust in him.

The President's approval rating stood at 75 percent and trust rating at 72 percent, both his lowest since September 2016.

Mr. Duterte's ratings fell among all socioeconomic classes and across geographic areas. The biggest declines were in Class D, the poor, who gave him an approval rating of 74 percent, down 13 points and trust rating of 71 percent, down 16 points.

Approval ratings of Mr. Duterte in Class ABC—the rich and middle class—as well as in Class E, the poorest of the poor, also recorded double-digit declines.

#### Unperturbed

Presidential spokesperson Harry Roque said Mr. Duterte was unperturbed by ratings and was focused on doing his job.

"We are not affected by it because the President will do his best to discharge his duties," he said at a news briefing.

Roque said rising inflation could have caused the drop in the ratings because higher rice prices negated the administration's gains in other areas.

The survey was conducted from Sept. 1 to 7, when the



President Duterte

Philippine Statistics Authority reported nationwide inflation in August hit 6.4 percent yearon-year, a nine-year high.

Inflation was higher in Metro Manila at 7 percent and highest in the Bicol region at 9 percent.

Prices of food and nonalcoholic beverages rose further to 8.4 percent. Souring rice prices

Rice prices, especially those of commercial varieties, skyrocketed last month amid the depleted stocks of the National Pood Authority, which sells cheap rice consumed by the poor.

In areas like Zamboanga City and Tawi-Tawi province, prices of commercial rice rose to P70 to P80 per kilogram, prompting their local governments to declare a state of calamity.

Rising fuel prices, weakening of peso, low supply of certain commodities and the Tax Reform for Acceleration and Inclusion (TRAIN) Act were also blamed for the rising cost of living.

The TRAIN law raised the excise on goods such as oil cigarettes, sugary drinks and vehicles to compensate for a higher tax-exempt personal income.

'Withering appeal'

"The (President's) populist appeal has withered as people suffer from inflation and economic uncertainty," Akbayan Rep. Tom Villarin said in a statement.

Bayan Muna Rep. Carlos Isagani Zarate said people were "feeling the worsening difficulties, which can no longer be covered up by empty promises."

"It's the economy, it's the food prices; it's the jobs," Zarate added.

Highest among officials

Even so, Roque noted that the President's trust and approval ratings were the highest among top officials.

The approval and trust ratings of Vice President Leni Robredo were essentially unchanged between June and September.

Robredo got an approval rating of 61 percent in September from 62 percent in June and a trust rating of 56 percent, unchanged from June.

Senate President Vicente Sotto III obtained an approval rating of 73 percent and a trust rating of 66 percent.

Distrust in Arroyo

Forty-three percent expressed distrust of Speaker Gloria Macapagal-Arroyo Only 19 percent trusted her.

Villarin said the installation of Arroyo as Speaker in July may have also contributed to the decline in the President's trust ratings.

"[Arroyo] became the lightning rod that absorbed people's distrust in Duterte's administration," he said.

The approval rating of the House of Representatives declined 10 points to 56 percent, while that of the Senate dropped 6 points to 63 percent.

The Supreme Court's approval rating declined 11 points to 52 percent.

#### Palparan remains in AFP custody

Retired Army general Jovito Palparan Jr. remains in the custody of the Armed Forces of the Philippines (AFP) at Fort Bonifacio in Taguig despite a court order for his transfer to the national penitentiary following his conviction in the kidnapping of two University of Philippines students in 2006, an official said yesterday.

Justice Secretary Menardo Guevarra said Palparan, dubbed by human rights groups as "The Butcher," has yet to be transferred to the New Bilibid Prison (NBP) in Muntinlupa.

"He is still with the Army Custodial Center despite a commitment order issued by the Malolos Regional Trial Court in Bulacan," Guevarra told reporters.

Guevarra said they would ask the AFP why Palparan's transfer to the NBP has been delayed.

Palparan and his two coaccused – Lt. Col. Felipe Anotado and 5/Sgt. Edgardo Osorio – were sentenced to life in prison for the kidnapping of UP students Sherlyn Cadapan and Karen Empeño in Hagonoy, Bulacan in June 2006. Cadapan and Empeño remain missing.

## Palparan moved to Bilibid

Retired General Jovito Palparan and his fellow convicts in the kidnapping of University of the Philippines (UP) students Karen Empeño and Sherlyn Cadapan in 2006 are now detained at New Bilibid Prison (NBP) in Muntinlupa City.

The two students were never seen again after their abduction in Hagonoy, Bulacan.

"Gen. Palparan has already been committed from the AFP detention center to the NBP," Justice Secretary Menardo Guevarra yesterday told the Daily Tribune via text message.

The commitment order was signed by Bulacan Regional Trial Court Branch 15 Judge Alexander Tamayo. "I hereby commit to you the person of accused M/Gen. Jovito S. Palparan Jr., Lt. Col. Felipe G. Anotado Jr. and SSgt. Edgardo Osorio having been convicted as per the decision promulgated by this Court 17 September 2018," the commitment order read.

Finding Palparan and his two co-accused guilty of kidnapping and serious illegal detention, the court sentenced them to reclusion perpetua or life imprisonment.

In the Philippines, life imprisonment actually translates to up to 40 years in prison.

Judge Tamayo also ordered Palparan and his fellow convicts to pay the amount of P300,000 each in civil indemnity and moral damages to the families of the two UP students.

Ex-general convicted for kidnapping 2 UP students.

Palparan was arrested by authorities on 12 August 2014 in a house in Sta. Mesa, Manila after three years in hiding.

Prior to the promulgation of the case, Palparan was detained in Camp Aguinaldo in Quezon City.

Bureau of Corrections chief Ronald "Bato" dela Rosa said Palparan will not be given special treatment at the maximum security compound of NBP. Alvin Murcia

## Makatijudge Fevives Febellon case Vs Trillanes

"Democracy lost today," Sen. Antonio Trillanes IV declared as he left his Senate office to go with police officers and postbail after the Makati Regional Trial Court (RTC) ordered his arrest on revived rebellion charges on Tuesday.

"Officially, we have no democracy. This case goes beyond me," Trillanes told reporters.

Judge Elmo Alameda of Makati RTC Branch 150 issued a warrant for the arrest of Trillanes a day after the senator submitted an affidavit of a military officer attesting to the former military rebel's filing an application for amnesty in 2011 and admission of guilt in taking part in attempts to overthrow the government in 2003, 2006 and 2007.

Proof of application

The affidavit of Gol. Josefa Berbigal, head of the secretariat of the temporary amnesty committee of the Department of National Defense (DND) that processed the applications of military rebels for amnesty in 2011, belied the claim of President Duterte that his fiercest critic in Congress did not apply for amnesty nor admit guilt.

For those reasons rebutted by Berbigal, Mr. Duterte on Aug. 31 voided the amnesty granted to Trillanes and ordered the revival of the coup d'état and rebellion charges against the senator.

His order set off a controversy that, together with rising inflation and a shortage of low-priced rice, pulled down his approval and trust ratings.

But Judge Alameda, in his order to arrest Trillanes, said the senator "failed to present the original hard copy, a duplicate copy or even a photocopy showing that he personally accomplished and filed" an application for amnesty.

Earlier, Trillanes showed

pictures of himself holding the accomplished application form for news photographers as he applied for amnesty at the DND on Jan. 5, 2011.

Former Defense Undersecretary Honorio Azcueta, the then head of the DND aimnesty committee, said on Sept. 9 that Trillanes applied for amnesty, "[t]hat's why on record he was granted amnesty."

Trillanes' application and those of 94 other military mutineers were approved after three weeks.

Eight months later, Makati RTC Branches 150 and 148 dismissed the rebellion and coup d'état charges against Trillanes.

#### Application form missing

What happened to his application form is unknown. But after the Office of the Solicitor General had been inquiring about it, the military issued a certification saying there was no copy of the form available.

That certification became the basis for Mr. Duterte's Proclamation No. 572 voiding Trillanes'

amnesty, which the senator had asked the Supreme Court to declare unconstitutional.

#### 'Barren of probative weight'

Trillanes had asked Alameda to dismiss the bid of the Department of Justice (DOJ) to revive the rebellion charges against him, but the judge said that because an admission of guilt would have been included on the application form, the lack of a form meant it could "be safely stated here that Senator Trillanes failed to comply with the minimum requirement of expressly admitting his guilt."

He dismissed the documents submitted by Trillanes as "barren of probative weight to prove [the former military rebel's] compliance."

The court, he said, was "morally convinced of the sufficiency and legality of the issuance of Proclamation 572."

Alameda said the proclamation would remain legal and valid unless the Supreme Court were to decide otherwise.

The judge ordered Trillanes'

arrest and set the bail at

Trillanes posted bail in court, accompanied by Senators Francis Pangilinan, Bam Aquino and Risa Hontiveros, after he was booked at the Makati City Police Station.

#### Darkness and evil

Trillanes said his arrest was a clear example of Mr. Duterte harassing his critics, "the ones telling the truth who he could not face."

"For all intents and purposes, darkness and evil prevailed in our country. So whatever happens next is in the hands of the Pilipinos," he said.

"The court has spoken," countered presidential spokes-person Harry Roque. "Let's stop the drama by [press conference] and allow the legal process to take its course."

Trillanes said he decided to go with the arresting team to fulfill his promise that he would honor a warrant of arrest issued by a civilian court, "no matter how unjust that warrant may be."

He said his arrest had noth-

ing to do with anything except Mr. Duterre's anger and vindictiveness.

Mr. Duterte has vowed to imprison Trillanes after the senator, during the 2016 presidential election campaign, disclosed what he called secret bank accounts of the then mayor of Davao City that the latter claimed contained hundreds of millions of pesos in unexplained wealth.

Last year, Trillanes linked one of Mr. Duterte's sons and his son-in-law to drug smuggling from China and extortion.

#### Failed democracy

Trillanes said he had debunked all the arguments that the Duterte administration had raised to justify the scrapping of his amnesty.

"They forced and twisted the law, which is why democracy and our institutions falled," he said.

Vice President Leni Robredo, who was in the Senate for a budget hearing when police officers arrived with the arrest warrant, said the arrest of Tril-

lanes was a sad development.

"We feel that dissent is important in a healthy democracy. We should give space for dissenting views," Robredo said.

Hontiveros described Trillanes' arrest as a "blackeye for democracy."

Aquino called on the Duterte administration to stop intimidating and attempting to scare its critics.

Sen. Grace Poe said that if Trillanes' amnesty could be questioned, all other amnesty grants would be in peril as well.

"So how can there be trust?" Poe said

#### House reactions

Magdalo Rep. Gary Alejano called Trillanes' arrest "an assault to the whole Philippine Justice system."

"With the issuance of the warrant of arrest against Senator Trillanes, the pretensions of the Duterte administration that we are still in a democracy has been removed. We are in a dictatorship now," Alejano said.

Albay Rep. Edcel Lagman said that instead of issuing a warrant of arrest, the lower court should have reported the results of its "fact-finding" to the Supreme Court, which is hearing Trillanes' challenge to the legality of Proclamation 572

For Justice Secretary Menardo Guevarra, however, the order to arrest Trillanes was significant, as it showed "the court's recognition that the rebellion case is still alive,"

The DOJ has also asked Makati RTC Branch 148 to reopen the coup d'état case and order the arrest of Trillanes.

"As it is, we are waiting for a miracle from Branch 148. We're slightly more hopeful, but we have to expect the worst," Trillanes said.

"You have to expect the worst because the enemy is the devil," he added. —with reports from Christine O. Avendano, Jerome ANING AND VINCEF. NONATO INQ

## Trillanes should honor court order — Palace

There is no more legal impediment for the implementation of Presidential Order No. 572 that voids the amnesty granted to Sen. Antonio Trillanes IV during the previous administration, presidential spokesman Harry

Roque Jr. said yesterday.

In a statement, Roque said this goes to show that President Duterte respects the decision of the judiciary.

"The court has spoken... Whatever Sen. Antonio Trillanes IV has to say can be addressed to the court," he said. "Let us stop the drama by (conducting) press conferences and allow the legal process to take its course," he said.

In another interview, Roque said the Makati regional trial court (RTC) can now proceed with the trial and find out whether Trillanes should be held liable for the rebellion charges filed against him.

"At this point, the military tribunal would be superfluous because the law provides that where you have concurrent jurisdiction over the civilian courts

and the military courts... here you have a determination by the solicitor general, and actually, by the President, that he would defer to the court," he said.

"That means the matter now

"That means the matter now is entirely on the regional trial court," Roque said.

It is up to the senator to appeal the decision of the local court, according to Roque.

"He can still appeal the decision of the RTC on the issue. He can bring this up to the appellate court. Meanwhile, he has to honor the decision of the court

unless he gets a restraining order of the Supreme Court (SC) or the Court of Appeals," he said, before the senator surrendered.

"Right now, the warrant of arrest is immediately executory and he should respect our court and voluntarily surrender and face the charges against him," he added.

Since Duterte has deferred to the Makati RTC, Roque said Malacañang is hoping that Trillanes will equally respect the court and voluntarily surrender so that he may prove his innocence of the charges leveled

against him.

Will Trillanes suffer the same fate as that of detained Sen. Leila de Lima in seeking relief from the SC against Duterte's Proclamation No. 572 that voided the amnesty he obtained during the previous administration?

A document submitted to the SC yesterday showed that Trillanes falsified the notarization of his petition earlier this month seeking to strike down the proclamation for alleged violations of the 1987 Constitution.

## Tribanes arrested, posts bail

#### Within three hours, senator goes through process, returns to Senate

FTER being holed up in the Senate for almost three weeks, Senator Antonio Trillanes IV took less than three hours to surrender to the police, have his mugshots and fingerprints taken at the Makati Central Police station, post P200,000 bail and return to the Senate Tuesday.

After a Makati court issued a warrant for his arrest, Trillanes left the Senate past 3 pm-with a police team led by Metro Manila police chief Guillermo Eleazar.

warrant 21 days after President Rodrigo Duterte signed Proclamation No. 572, nullifying the amnesty granted to Trillanes by President Benigno Aquino III.

The court set a P200,000 bail for his temporary liberty.

State prosecutors earlier asked Alameda to order Trillanes' arrest and prevent him from leaving the country, saying the nullification of his amnesty meant that the case against the senator related to the 2007 Marilla Peninsula Hotel siege must be pursued.

The military man-turned politician is also facing a separate coup d'etat case at the Makati RTC Branch 148 for leading the 2003 mutiny at the Oakwood Premier hotel, also in Makati City.

Last month, President Duterte voided the amnesty granted by former President Benigno Aquino III to Trillanes for his alleged failure to file an application form and admit guilt for his crime.

Prosecutors said the rebellion charges filed against Trillanes have yet to be terminated by the court despite the issuance of Proclamation No. 75 issued by Aquino, which granted him amnesty.

Trillanes, a former Navy lieutenant, was among those who led mutiny in Oakwood Premiere Hotel in Makati City on July 27, 2003 and the Manila Peninsula siege on November 29, 2007. Both were aimed at ousting President Gloria Macapagal Arroyo.

Almeda on Tuesday also granted the Justice Department motion for the issuance of a hold-departure order against Trillanes.

The Makati City Regional Trial Court Branch 150 on Tuesday revived the rebellion case against opposition Senator Antonio Trillanes IV as it granted the Department of Justice's motion for the issuance of warrant of arrest and a hold departure order against him.

Alameda said that after the hearing it conducted on Sept. 14, the prosecution managed to prove that Trillanes actually did not apply for amnesty.

The DoJ prosecutors led by Acting Prosecutor General Richard Anthony Fadulion presented a certification dated Aug. 30, 2018 issued and signed by one Lt. Gen. Thea Joan Andrade of the Armed Forces of the Philippines-Discipline, Law and Order Division to prove that the senator failed to apply for an amnesty.

"The court's evaluation of the...certification is that it confirms the claim of the prosecution that Senator Trillanes did not apply for amnesty," the court said.

Alameda said the burden of proving compliance with the minimum requirements to be entitled to amnesty under Proclamation No. 75 issued by the previous administration lies with Trillanes.

"However, Senator Trillanes through his counsel failed to convince this Court that he indeed complied with the minimum requirement to personally fill up and file the official amnesty application form as required in Section 5,6, and 11 of DND [Department of National Defense] Amnesty Committee Circular Dated December 21, 2010," Alameda said.

The court also noted that Trillanes failed to present the original hard copy, a duplicate copy, or even a photocopy to substantiate his claim that he personally accomplished and filed his amnesty application form.

The court also gave weight to the online news report published on January 5, 2011, which was presented by the prosecution to prove that Trillanes failed to expressly admit his guilt for the crimes committed during the Oakwood mutiny and manila Peninsula inciNow that the amnesty has been voided, the court said, it would regain jurisdiction over his case, despite its dismissal on Sept. 7, 2011.

That dismissal, Almeda said, can also be considered void and has on legal and binding effect, given the issuance of Proclamation No.

"With the revocation of the amnesty granted to Senator Trillanes the resulting consequence is that the order issued on Sept. 7, 2011 dismissing the case of rebellion becomes void ab initio. Proclamation No. 572 was precisely

issued to rectify the erroneous grant of amnesty to accused to Trillanes due to his failure to comply with the basis minimum requirements of filing his application and the admission stated in the said application of his guilt of the acts/crimes covered by the amnesty," the judge said.

Justice Secretary Menardo Guevarra welcomed the order of the court, saying the DoJ was confident from the very start that its bid to bring Trillanes back to jail would be granted.

Makati RTC Branch 148 Presiding Judge Andres Bartolome Soriano has yet to issue an order with regard to the coup d'etal case against Trillanes.

Prior to the grant of amnesty, Trillanes and several members of the so-called Magdalo soldiers were charged with a case for coup d'etat before Makati Regional Trial Court (RTC) Branch 148 for the Oakwood mutiny in 2003 and a case for rebellion before Makati RTC Branch 150 for the 2007 Manila Peninsula siege.

After posting bail, Trillanes returned to his Senate office, where he has been holed up since Sept 4.

In an interview, Trillanes told reporters that it's really to fight a demon, referring to the President.

He said it was obvious that the decision of the lower court was swayed and influenced by the President's hell-bent wish to send him to jail.

He bewailed what he called the railroading of the justice system just to accommodate the whims of the President. His lawyers would exhaust all possible legal remedies, believing that the truth would prevail, he added.

Senate President Pro Tempore Ralph Recto said the government must ensure first the safety of Trillanes.

"Since the charge, by order of the court, is bailable, his security must be ensured by the state," he said.

Senator Juan Edgardo Angara said he hopes Trillanes will be afforded justice by the court.

Senator Grace Poe said she was confident that Trillanes would be able to defend himself.

She said she was baffled when Trillanes' amnesty was questioned, despite its approval by both chambers of Congress.

"So how can we have trust [in the grant of amnesty]?" she said.

Opposition Senator Risa Hontiveros branded Trillanes' arrest as "a black eye for democracy and the rule of law."

She considered the issuance of the warrant a part of the government's attempt to intimidate political critics and said it foreshadowed a crackdown on the opposition.

"It reeks of panic and desperation over the growing opposition to the President's authoritarian rule. Beyond the President's intolerance of opposition politics, it exposes the depths of his paranoia and fear of dissent," she said.

"It also effectively shows President Duterte's incompetence and lack of strong leadership," she added.

Instead of being tough on inflation and the rice crisis, instead of mustering the needed political will to address the country's economic slowdown, she said, Duterte has been wasting his time and energy, as well as precious government resources, on trying to obliterate the democratic opposition.

"He intimidates and terrorizes people, particularly his critics, to compensate for his incapacity to govern," she said.

Senator Paolo Benigno Aquino IV said the real enemy of the administration government was poverty and high prices, of the opposition.

In a news briefing in the Senate, Trillanes said "democracy lost" when the Makati court sustained Duterre's cancellation of his amnesty in connection with the rebellion case that was dismissed seven years ago due to the amnesty.

"Democracy was defeated here. Like what I said last week, our petitions in court are a test case of the strength of our judicial system," Trillanes said.

"Officially, we no longer have democracy...
I did not commit any crime, I was given amnesty seven years ago," said Duterte.

Before posting bail. Trillanes briefly attended the Senate session. The senator then went to the Senate lounge wherein he was met by National Capital Region Police Office (NCRPO) chief Guillermo Eleazar, who read to him his rights.

The Senate sergeant at arms, retired general Jose Balajadia, said Eleazar then served the arrest order on Trillanes. Balajadia then led Trillanes to the sergeant at arms' office, where the senator was turned over to Eleazar.

Fellow opposition senators Francis Pangilinan, Paolo Benigno "Bam" Aquino 4th, and Risa Hontiveros accompanied Trillanes to the Makati Police headquarters and to the Makati RTC to postbail.

#### 'The court has spoken'

Reacting to the arrest order, Palace spokesman Harry Roque Jr. said: "The court has spoken. As the President has said, we will respect the decision of the judiciary. Whatever Senator Antonio Trillanes 4th has to say can be addressed to the court. Let us stop the drama by [press conference] and allow the legal process to take its course."

Chief Presidential Legal Adviser Salvador Panelo said the order was anchored on solid legal ground.

"Trillanes should face the music and dance as Frank Sinatra's would croon in his song with the same title. He has stop milking the issue and act pathetically as if he is a a victim of injustice. The law of Karma as well as of the law has finally caught up with his shenanigans. He has been using his position as senator in planting the seeds of hate and sedition against [President Duterte] and the government," Panelo said in a statement.

Justice Secretary Menardo Guevarra said that from a purely legal standpoint, "the court's order is significant because it considers the case as still very much alive."

#### **Opposition surprised**

Vice President Maria Leonor 'Leni' Robredo, who happened to be at the Senate to defend the budget of her office, lamented the arrest order against Trillanes.

"We were a bit surprised because I know that the rebellion case against him has already been dismissed with the granting of the amnesty. The crime, anyway is bailable," Robredo said in an interview.

"It's sad. We feel that dissent is every important in a healthy democracy. I hope dissenting views would be given some space. The absence of dissent breeds abuse. Public officials like us should always be on our toes," Robredo said.

Senate President Pro-Tempore

Ralph Recto said the government must ensure Trillanes' safety. "Since the charge, by order of the court is bailable, his security must be ensured by the State."

Pangilinan said: "While we respect the court order we disagree with it. It is as clear as day that the revocation of grant of amnesty is illegal and an abuse of presidential powers and must be vigorously opposed."

Hontiveros said the issuance of the warrant of arrest against Trillanes was "part of the government's attempt to intimidate political critics and a looming crackdown on the opposition."

Sen. Grace Poe said she was confused. "The amnesty went through the Senate and the House of Representatives. It's not only him that was granted amnesty. Several others were given amnesty too on the same period. So, it the amnesty granted to him will be questioned, what would happen to the amnesty granted to the other individuals?" she asked

#### Failure to present papers

Makati Judge Elmo Alameda, through Clerk of Gourt Diosfa Valencia, said the decision to issue the arrest warrant and travel ban against Trillanes came after the senator's camp failed to produce his application form for amnesty.

"Upon the voiding ab initio of his amnesty, which is the basis of the case, the court had to issue the warrant because the application form was proof for application," Valencia said.

Trillanes' lawyer Reynaldo Robles, however, was able to produce a certificate of the senator's amnesty, affidavits of military officials saying he filed for amnesty, and official Department of National Defense amnesty secretariat documents.

Alameda sustained his decision to allow only the actual application form to be the primary evidence as it was "the best proof that the senator applied for amnesty."

Branch 150 said that the court's jurisdiction over the senator's rebellion case was merely a "reiteration of its previous authority to hear and decide the case" despite its dismissal in 2011, because of the supposed "discovery" that Senator Trillanes had failed to file his application for amnesty, which should contain his admission of guilt.

The court dismissed in September 2011 the rebellion charges against Trillanes in connection with the 2003 Oakwood mutiny and the 2007 Manila Peninsula siege after he was granted amnesty by the Aquino administration.

Alameda set a hearing for an initial presentation of evidence from prosecutors on November 21 at 2:00 p.m.

A MAKATI City court yesterday issued an arrest warrant against Sen. Antonio Trillanes IV and barred him from leaving the country pending the resolution of the rebellion case filed against him in relation to the 2007 Manila Peninsula siege.

Trillanes voluntarily surrendered to police authorities and posted a P200,000 bail hours after the arrest warrant was issued.

He was taken into custody by NCRPO chief Guillermo Eleazar, who served the arrest warrant at the Senate accompanied by Makati police chief Supt. Rogelio Simon.

Trillanes went through the standard booking procedures at the Makati City police station, then proceeded to the Makati City Regional Trial Court Branch 150 to post the P200,000 bail set by Judge Elmo Alameda for his temporary liberty.

After his release order was issued by the court, Trillanes returned to the Senate and arrived at the premises around 5:20 p.m.

Trillanes said he will continue to stay at the Senate until he has consulted with his lawyers on their next step. He also said he will talk with the Senate leadership on the issue of his continued stay in his fifth floor office, where he has been holed up since early September after Proclamation 572 voiding the amnesty granted to him in 2011 was issued by Malacanang.

Trillanes became the second lawmaker in less than-two years, after Sen. Leila de Lima, to be arrested in what human rights groups say is a "relentless campaign" to silence the critics of President Duterte.

Alameda issued the warrant of arrest as he upheld the validity of Proclamation 572, which said the amnesty given to Trillanes was void because the senator allegedly did not apply for the amnesty.

In his 22 page ruling, Alarneda said he found legal basis for the issuance of the proclamation, noting there was no copy of the senator's application for amnesty in the records.

Alameda also said Trillanes failed to convince the court that he complied with the requirements for the amnesty, such as the admission of guilt and the application for amnesty.

Since the amnesty was void, Alameda said there was no legal basis for the dismissal of the rebellion case against Trillanes in 2011.

The rebellion case was dismissed by the Makati City RTC Branch 150 in 2011 on the basis of the amnesty granted to Trillanes by former President Benigno Aquino III in 2010.

Alameda also barred Trillanes from leaving the country while the case remains pending with the count, Prosecutors sought the HDO, arguing the senator has the means and resources to flee to another country and escape prosecution.

Trillanes' lawyers on Monday submitted supporting documents to the court to prove the senator indeed applied for amnesty, including the sworn affidavits of two former members

of the DND Ad Hoc Amnesty Committee which received, processed and approved the application.

Trillanes is also facing coup charges before the Makari City RTC Branch 148 for the Oakwood hotel takeover in 2003:

#### 'DEMOCRACY LOST'

Trillanes was holding a committee hearing when informed that a warrant has been issued for his arrest. After the hearing, he briefly met with his lawyers and held a press conference before he surrendered to police authorities.

"Democracy lost today. As I said last week, the petitions we are filing in court are a test on the independence of the judicial system." Trillanes said.

He lamented that while his lawyers have presented supporting documents to belie the basis used by Malacanang in voiding his amnesty, "the court still issued the warrant of arrest.

"Officially, there is no democracy anymore. This case goes beyond me. I did not commit any crime, I was granted amnesty seven years ago. All that is happening now is Mr. Duterte's tactics to silence his political critics," Trillanes added.

In another press conference after he posted bail, Trillanes said he will continue to stay in the Senate since he expects the government to continue to harass him.

"Definitely not (free to go home). You have witnessed that we cannot be complacent because if we do that, they will find other ways to attack me. We expect other forms of harassments in the day = to tone and unless and until this issue has been formally settled then (will stay in the Senate)," Trillane said,

Asked what hind of harassments he expects, Trilanes said his camp foresees more cases to be filed against him. "lexpect legal harassments, court cases," he said.

Trillanes saidhe was disappointed that the Makati court gave in to the pressure tacics of the Duterte administration.

He said that while he is expecting a "miracle" from the Makati RTC Branch 148, he was only "slightly more hopeful but we have to expect for the worse."

Makari RTC Branch 148 is handling the coup d'etat case against the senator. Coup is a non-bailable offense.

Trillanes said he and his lawyers will sit down and discuss legal remedies they can avail, even as he expressed doubt that he can get any relief from the courts.

#### POLITICAL CRACKDOWN

Several lawmakers condemned the arrest order against Trillanes, saying the administration was putting more focus on its crack-down against the position.

Rep. Gary Alejano (PL, Magdalo) assailed the latest development in Trillanes' case, saying it has come to a point that even the judiciary is being used to go after the opposition.

"We've reached a point where our courts are becoming tools of the administration to clamp down on its political opponents," Alejano said in a statement.

Alejano said "there is someone who backed down from the pressures of the Duterte administration."

The lawmaker, however, said that even the opposition views the issuance of an arrest warrant as "an unjust action, we will abide by the legal orders – we will continue to have faith on our institutions and legal processes."

"The people have been forgotten while the government is busy silencing Senator Trillanes and other critics. The enemy is poverty and high prices of commodities, not the opposition," Sen. Bam Aquino said.

"Instead of being tough on inflation and the rice crisis, instead of mustering the needed political will to address the country's economic slowdown, he (Duterte) wastes his time and energy, as well as precious government resources, on trying to obliterate the democratic opposition," Sen. Risa Hontiveros said.

Hontiveros called on the public to "amplify the voice of dissent and reason" amid the government's "looming crackdown on the opposition."

Senate President Vicente Sotto III said the Senate will "remain efficient" despite the latest legal development.

"Life goes on. We just have to move on," Sotto told reporters, adding: "Whatever it is, haharapin namin and then do our work. Tuloy trabaho."

#### 'FACE THE MUSIC'

Chief Presidential Legal Counsel Salvador Panelo said Trillanes should just face the music.

"The order is anchored on solid legal ground. Trillanes should face the music and dance as Frank Sinatra would croon in his song with the same title. He has to stop milking the issue and act patheticalivas if he is a victim of injustice. The law of karma as well as of the law has finally caught up with his shenanigans." Panelo said. Panelo said Trillanes has been

Panelo said Trillanes has been using his position as senator to plant the seeds of hate and sedition against Duterte and the government

Presidential Spokesman Harry Roque said Malacanang respects and abides by the court's decision on Trillanes' case.

"The court has spoken...Whatever Senator Antonio Trillanes IV has to say can be addressed to the court. Let us stop the drama by presscon and allow the legal process to take its course," Roque said.

#### STANDARD PROCEDURES

The Makati City Police, Southern Police District, and the National Capital Region served the warrant of arrest against Trillanes at the Senate building in Pasay City after the session started at 3 p.m.

Senators Francis Pangilinan, Hontiveros and Aquino accompanied Trillanes at the Makati police office when he underwent booking procedures, and again at the Makati court when he posted bail.

Senate Sergeant-At-Arms Army Major General (ret). Jose Balajadia said Eleazar arrived at the Senate compound past 2 p.m. and presented him the arrest warrant.

Shortly after undergoing booking procedures at the Makati police station, Trillanes arrived at the Makati RTC past 4 p.m. where he was subjected to a medical examination at the court's clinic.—With Jocelyn Montemayor and Stella Sarmiento

## Irillanes arrested, nosts hail

Sen. Antonio F. Trillanes IV was arrested yesterday after the Makati City Regional Trial Court Branch 150 Issued an alias warrant of arrest and hold-departure order against him in connection with his rebellion case.

In a 22-page order, Makati RTC Branch 150 Judge Elmo Alameda granted the motion filed by the Department of Justice in connection with the rebellion case against Trillanes and other Magdalo soldiers over the Manila Peninsula siege in 2007.

"In a view of the above disquisition, the prosecution's omnibus motion dated Sept. 7, 2018 for issuance of warrant of arrest and hold-departure order against Sen. Antonio Trillanes IV is granted. Bail for temporary liberty of the accused is fixed at 11200,000 per order dated Feb. 16, 2010," Alameda said.

Alameda said the burden of proving compliance with the minimum requirements to be entitled to amnesty under Proclamation No. 75 issued by the previous administration rests on Trillanes. "However, Sen. Trillanes, thru his counsel, failed to convince this Court that he indeed complied with the minimum requirement to personally fill-up and file the official amnesty application form as required in Section 5,6, and 11 of Department of National Defense Amnesty Committee Circular dated Dec. 21, 2010," Alameda pointed out.

The trial court noted that Trillanes failed to present the original hard copy, a duplicate copy, or even a photocopy to substantiate his claim that he personally accomplished and filed his official amnesty application form.

The court also gave weight to the

online news report published on Jan. 5, 2011 which was presented by the prosecution to prove that Trillanes failed to expressly admit his guilt for the crimes committed during the Oakwood multiny and Manila Peninsula incident.

"Since Sen. Trillanes cannot produce the copy of the official application form for amnesty which he purportedly filed with DND Amnesty Committee containing the admission of guilt expressly made, it can be safely stated here that Sen. Trillanes falled to comply with the minimum requirement of expressly admitting his guilt for the offenses committed during the Oakwood Mutiny and the Manila Peninsula incident," Alameda explained.

The trial court said with Trillanes' amnesty being declared void ab initio, it has regained jurisdiction to hear and resolve the case despite its dismissal on Sept. 7, 2011.

Justice Secretary Menardo Guevarra welcomed the order of the court, saying that the DoJ was confident from the very start that its bid to bring Trillanes back to jall will be granted by the court

"That is how I construe the deeper meaning of the order granting the Issuance of a warrant of arrest," Guevarra said, when asked whether or not the order is tantamount to the reopening of the rebellion case and a ruling based on its merit.

Yesterday afternoon, a police team from the National Capital Region Police Office, headed by the chief of police of Makati Senior Supt. Rogelio Simon, was sent to Senate to serve the arrest warrant against Trillanes.

NCRPO chief Director Guillermo

Eleazar, who served the warrant, fetched Trillanes at the parking lot of the Senate, where he had been holed up since President Duterte nullified his amnesty.

Trillanes, from the Senate, went to the Makati police headquarters to turn himself in. Police took his mugshot and blometrics.

The opposition senator was accompanied by Senators Bam Aguino, Kiko Pangilinan, and Risa Hontiveros.

Afterwards, they went to the Makati RTC Branch 150 and paid bail at 4:50 p.m. or 10 minutes before the court closed.

Based on the release order of Alameda, the initial presentation of prosecution evidence is set on Nov. 21 at 2 p.m.

Trillanes, in a press conference before proceeding to the court to post bail, said he would go with erresting officers despite the fact that the warrant has not been served to him personally.

He said the issuance of the issuance of the arrest order shows that democracy has been compromised.

Arrest order finally issued, senator gives up self

THE Makati regional trial court yesterday issued an arrest warrant and hold departure order against embattled opposition Sen. Antonio Trillanes IV whose amnesty was voided by President Duterte's Proclamation No. 572.

Judge Elmo Almeda of Branch 50, who was handling Trillanes' rebellion case from the 2007 Manila Peninsula siege, set a P200,000 bail bond for the opposition leader's temporary liberty.

The senator immediately posted bail after his arrest

and undergoing booking procedures. Duterie recently voided Trillanes' amnesty due to the lawmaker's supposed failure to meet minimal require-

Apart from Branch 150, Makati RTC Branch 148 was also handling the coup d'etat case against Trillanes over

the 2003 Oakwood mutiny.

The amnesty was granted in 2010 under Proclamation No. 75 of then president Benigno "Noynoy" Aquino

Trillanes challenged the legality of the President's proclamation before the Supreme Court arguing that if violated his constitutional rights.

#### No resistance

Trillanes yesterday voluntarily turned himself over to National Capital Region Police Office chief Director Guillermo Lorenzo T. Eleazar moments after a Makati court ordered his arrest for rebellion in relation to the infamous 2007 Manila Peninsula siege

The staunch critic of President Duterted id not put up any resistance to NCRPO officials led by Eleazar who came to serve the warrant of arrest against him.

However, before he yielded to the NCRFO chief at the Senate lounge, Trillanes, who had been holed up at his Senate office since last September 4, met with his colleagues in the minority bloc and even attended their regular session.







The Philippine Navy (PN) gave a warm welcome at South Harbor, Manila, for the 200 Navymen and Philippine Marines aboard the BRP Ramon Alcaraz who fook part in the 14th Multilateral Regional Maritime Exercise codenamed "Kakadu 2018" in Darwin. Australia

Navy Chief Vice Admiral Robert A. Empedrad ioined the families and friends in welcoming the sailors, marines and reservists comprising the Naval Task Force (NTF+91 headed by its commander, Navy Captain Junjie B. Tabuada.

Tabuada said every member of NTF 91 must be excited to arrive home, "after one month and four days, of which 23 days were actually spent at sea, logging in more than 500 hours steaming time, while traversing more than 5,763 nautical miles."

Empedrad lauded the participating troops and underscored the significance of the Navy's conduct of International Defense and Security Engagement as "the means by which we enhance partnership and build closer ties with our regional partners."

He added that Alcaraz "was able to show to the whole world that we can stand equally and at par with the first world countries even with our older ships."

Exercise Kakadu was considered as Australia's largest maritime exercise which aims to promote greater levels of military cooperation and understanding amongst regional nations.

This year's participants were 24 naval vessels and 21 aircraft from 26 countries. This is the third time that the PN participated in this exercise

#### NOLCOM, MERALCO INK DEAL ON SOLAR PANELS FOR FISHERFOLK

CAMP AQUINO, Tarlac City: The Northern Luzon Command (Nolcom) partnered with One Meralco Foundation with the signing of a deal in putting up two units of solar panels at the structures of Mavulis Island in Batanes for the fisherfolk. #### Itogon operations shift to retrieval mode

RESCUE workers at a landslide site in Itogon, Benguet shifted to search and retrieval operations Monday night as hopes for finding any survivor dimmed.

Fifty-four bodies have been recovered since the landslide hit a former mining site in Barangay Ucab on September 16.

"There are still 20 missing... They're now presumed dead," said Itogon Mayor Victorio Palangdan.

In the landslide in Naga City in Cebu, which occurred four days

later, search and rescue operations continued yesterday.

"We are still on search and rescue (operations). We are still hopeful of recovering more survivors," said Capt. Joe Patrick Martinez, deputy commander of the military's 3rd Civil Relations Group based in Cebu.

The death toll in the landslide near a quarry site rose to 62 yesterday, up by eight from Monday. Thirty-five persons remained missing. Ten survivors have been found.

Martinez said workers will con-

tinue with the search and rescue mission "as long as it takes."

The Naga police reported 56 bodies recovered and 10 rescued as of 4:30 a.m. vesterday.

Chief Insp. Roderick Gonzales, city police chief, said combined government and volunteer organizations are still in ground zero in Sitio Sindulan, Barangay Tina-an and Barangay Naalad where at least 24 houses were buried.

He said about 500 government workers and volunteers are

buried a bunk house of smallscale miners, life-finder equipment failed to detect life, said Palangdan.

The landslide was triggered by heavy rains brought by typhoon "Ompong." Authorities said the typhoon left about 60 to 70 fatalities in other areas in Benguet and in other parts of the country. – With Raymond Africa



the AFP and the Philippine National Police (PNP) believe that he is no longer fit to lead the country, there is no problem.

All they have to do is tell him and he will step down, Duterte said. Meanwhile, the President assured the soldiers that he would fulfill his mandate and work according to his campaign promise.

"Ì will work according to my promise. Corruption, drugs, Î will not benefit from them," Duterte said in Filipino.

Duterte said he has made sure that he would not get involved in any government purchase or contract.

"No purchase of ships or airplanes reach my desk. These munist Party of the Philipstop in the departments concerned. I curse a lot because I am angry at corruption and illegal drugs," Duterte added.

Duterte told the opposition to wait for the elections if they are not satisfied with his performance.

"If you do not like me as president – Duterte is inept, dueless, it's OK. Fine. Just wait for the elections three years away," he said.

to oust Duterte or destabilize the government seriously, considering that such plot was uncovered as early as February 2017 in an encounter between government troops and the New People's Army in Bukidnon.

"It was hatched by the CPP-NPA in October 2016 even before the President cancelled the peace talks. After (the cancellation), the implementation (of the ouster moves) became an urgent program by the CPP-NFA, Lorenzana explained.

"Their plan was to get as many civil organizations as possible to join their mass actions led by their progressive fronts. It is supposed to culminate this October," he said.

Lorenzana, however, noted that based on CPP founding chairman Jose Maria Sison's latest pronouncement that Duterte will not last until the middle of 2019, there may have been a change in plans.

"Maybe they have moved their goals, considering the lackluster performance of their socalled massed rallies last martial law anniversary. We are closely monitoring them, including other groups," he said.

## Duterte: Some soldiers conniving with LP, Reds

RESIDENT Rodrigo Duterte said he was displeased that some members of the military were conniving with the opposition and communists to oust him from office.

Duterte told reporters in Jolo. Sulu on Monday evening that some of his troops were supporting Sen. Antonio Trillanes 4th, one of his ardent critics, and were involved in moves to remove him from power.

"What hurts is, you Liberal [party] and some military, you are connecting with rebel soldiers then that is it. You three - the Yellow, soldiers that I do not understand where their loyalty is, and the Liberal. This is where I have resentment," Duterte said.

"I have no problem with them being angry with me, but to do it in cahoots with the enemy... Me, I am just one. I can fall now, but the problem of the country... if you are true to your country, do not bed

with the enemy," he added.

Duterte also said that if the opposition was bent on ousting him, it should wait for the elections in 2022

But he said he would readily step down if the military and police told him to.

"You know, this plot, plot, plot, I have one thing to say: Nothing will succeed without the help of the Armed Forces of the Philippines. If the military, the Armed Forces, and the police think that I cannot be a President, tell me There will be no fights. If they said I will be replaced, I will go," Duterte said.

Duterte earlier said the opposition was moving to oust him from his post after he issued Proclamation 572 revoking the amnesty given to Trillanes in 2011

He said he had obtained intelligence information on the supposed ouster moves from a foreign, sympathetic country.

The military has said that members of Trillanes' Magdalo group. the Liberal Party and the Communist Party of the Philippines (CPP) were moving to collude and oust the President.

The supposed movement was dubbed "Red October,"

Burgos said troops and NBI agents served at 7:30 a.m. the warrant in a farm that is believed to be a safe house of top NPA leaders in Southern Tagalog.

"The presence of top NPA leaders and the proximity of Teresa town to Manila are indicators that the threat of "Red October" cannot be downplayed and that the plotters are just awaiting for an opportunity to execute their plans," Burgos said.

Burgos added that they will remain proactive in addressing any form of threats within our jurisdiction since our primary mandate is to be the vanguards of the national government's southern frontier.

Lt .Col. Melencio Ragudo, commander of the 80IB, said the joint operations with the NBI at Coral Farm, located at Sitio Dalig of the said municipality, resulted to the recovery of four M653 (baby armalite) rifles, one M203 Grenade Launcher, five US made 12-gauge shotguns, one caliber .45 pistol, one caliber .38 revolver, one 9mm KG3 machine pistol, six units of two-way radios, two grenades, eight cellphones, enemy documents and numerous war materials as well as weapon system

accessories.

He added that the owner of the sixhectare farm, Ki Be E, alias "Lily Ong," was among the eight personalities apprehended by the government forces.

One of the apprehended personalities revealed to authorities that two of the M653s belong to alias Bart while the other two, including the grenades, were owned by alias Pat Romano. The person also confirmed that the two NPA leaders were regular visitors of Coral Farm.

Major General Rhoderick M. Parayno, army 2nd Infantry Division commander, congratulated the troops and agents for the successful operations which preempted the destabilization plot.

# NDF consultant eludes arrest in Rizal town

A National Democratic Front (NDF) consultant on peace negotiations with the government eluded arrest in Teresa, Rizal, on Tuesday.

Brig. Gen. Arnulfo Burgos Jr., commander of the Philippine Army's 202nd Infantry Brigade, said they were about to serve an arrest warrant against Tirso Alcantara alias "Ka Bart," but the NDF consultant slipped away.

"He is too slippery and that is why we were not able to arrest him again," Burgos told reporters.

He said Alcantara was first spotted at a village in Umiray, Quezon, in May this year.

Government troops and agents from the National Bureau of Investigation, according to Burgos, were about to serve the warrant; only to find firearms in a farm in Teresa.

Recovered were four M653 or baby Armalite rifles, one M203 grenade launcher, five U5-made 12-gauge shotgums, one cal. .45 pistol, one cal. .38 revolver, one 9mm KG3 machine pistol, six two; way radios, two grenades, eight mobile phones, documents and war materiel.

Alcantara was among those ordered released by President Rodrigo Duterte in 2016 when he announced that he was ready to hold peace talks with the Communist Party of the Philippines.

Alcantara and 20 others, however, were ordered rearrested by the government after Duterte decided again to scrap the talks last year.

Duterte, with one saying it is still on while another is claiming it is not.

This as the Chief Executive himself also alleged some of his soldiers "are sleeping with (his) enemies" amid conflicting claims of destabilization against the government.

But Col. Edgard Arevalo, the AFP spokesman, said the members of the "legitimate opposition," like the Magdalo and Tindig Pilipinas, have removed themselves from the reported oust-Duterte move, highlighted by the AFP announcement of the alleged "Red October" plot and the "Operation/Plan: Talsik" which the military said were being planned by the Communist Party of the Philippines and several anti-Duterte groups.

Arevalo said the political opposition's detachment from the reported destabilization plots was evident during the 2I September rally that commemorated the proclamation of martial law by the late President Ferdinand Marcos in 1972.

According to Arevalo, even the Magdalo (which is part of the Tindig Pilipinas coalition) had expressed support to a democratic government and had allegedly vowed never to join groups aiming to overthrow a democratically elected government and replace it with a communist system.

'Oplan Aklasan' and 'Kampanyang Talsik' are rolling plans until the GPP is able to generate enough support in December in time for the 50th CPP anniversary.

The Magdalo used to be a fraternal organization of soldiers which launched a series of coups against former President Gloria Macapagal Arroyo in protest of massive corruption in the AFP during her term.

One of its leaders who also saved as the face and voice of the group is Sen. Antonio Trillanes, who was ordered arrested by a Makati City Court for a case of rebellion in connection with the anti-Arroyo coups. Several opposition groups, Arevalo said, also expressed that they will not support destabilization.

"They (opposition groups) told our chief of staff Gen. Carlito Galvez Jr. that they support our democratic government," Arevalo said.

The President, however, on Monday let out his sentiment during his visit to wounded soldiers in Jolo, saying he is hurting over reports some military leaders are conniving with forces out to oust him from power.

"What hurts me here (is that) you Liberal (Party) and some of those from the military have been in talks with the rebels (CPP-New People's Army)," Mr. Duterte said. "The soldiers, I cannot understand where their loyalty lies."

"That's my resentment with them, those soldiers. I don't care if they get mad at me, that's nothing. But to go into cahoots with the enemies. Me, I am just one. I can even fall now," he added.

Duterte said he will voluntarily step down from the presidency if the soldiers and the police will tell him so.

Duterte called on the military to remain loyal to the flag as he vowed to focus on fulfilling his duty as Chief Executive, particularly his continuing fight against illegal drugs and corruption.

"If you are true to your country, do not [bed] with the enemy. Just say you don't want me anymore as your President - Duterte is stupid, Duterte is no good. It's okay. That's fine. They can wait for the elections, it's only three years away," the President said.

"If they say I have to be replaced, I will leave," Duterte added. "But for now, I will fulfill my promise of fighting corruption, drugs."

Prior to this, the Palace expressed support to the AFP's proposal of creating a national anti-insurgency task force to quell the Maoist rebellion.

The President, the Palace reiterated, also prioritized additional salaries and benefits of uniformed personnel.

"Under my administration, I went on a buying spree. There was no request I did not grant (the soldiers)," Duterte said.

The AFP over the weekend bared an alleged conspiracy tagged as "Red October" as a connivance among the Liberal Party, Trillanes and the Magdalo group, along with armed leftist groups allegedly plotting to overthrow the President from power.

Despite Arevalo's statement, however, Brig, Gen. Antonio Parlade Jr., Armed Forces of the Philippines (AFP) assistant deputy chief of staff for operations, gave a more detailed "Red October" plot.

According to Parlade, the CPP is planning to recreate a "First Quarter Storm" scenario similar to those in the early 1970s when the youth and poor sectors organized anti-government protests.

Parlade also reiterated Tindig Pilipinas, an umbrella organization of groups and personalities identified with the opposition LP, of forging an alliance with the CPP-NPA to oust Duterte.

They (opposition groups) told our chief of staff Gen. Carlito Galvez, Jr. that they support our democratic government.

"The Red October Project is mainly designed as intensified mass campaign by the CPP and its urban based organizations using legal covers," Parlade told the Daily Tribune.

"The CPP-Central Committee, through its national political commission, aims to foment continuing labor unrest, agitation among the urban poor communities and peasants and the revival of First Quarter Storm among universities, schools and colleges to mobilize the youth and students," he added.

After mustering enough forces, Parlade said the CPP will sabotage large gatherings then blame the government, like it did following the 1971 bombing at Plaza Miranda.

"Oplan Aklasan' and 'Kampanyang Talsik' are rolling plans until the CPP is able to generate enough support in December in time for the 50th CPP anniversary." Parlade told Daily Tribuse.

# 'Oust-Duterte plot doomed to fail'

DEFENSE Secretary Delfin Lorenzana yesterday said the communist movement is eveing protest actions like those in 1986 to cause the ouster of President Duterte.

However, he said, the "Red October" plot hatched by communist party leaders in October 2016 is doomed to fail because it lacks "popular support"

"What they planned to do is initiate mass actions which they

hope to snowball into a 'people power,' such as what they intended last September 21 or ML (martial law) anniversary," Lorenzana said.

The 1986 "people power" protest ousted the late dictator Ferdinand Marcos. The protests had the support of the military which withdrew support from Marcos, their commander-in-chief.

"Their plan was to get as many civil organizations as possible to

join their mass actions led by their progressive fronts. It is supposed to culminate this October," Lorenzana said of the supposed ouster plan.

The September 21 rally at the Luneta Park in Manila marked the 46th anniversary of the martial law declared by Marcos.

"The turnout was pinfully small," Lorenzana said referring to the anti-Duterte crowd at the Lunera.

"Despite this setback, they (CPP/NPA) will keep trying," he also said.

### ROBREDO PROTESTS

Vice President Leni Robredo said the military's claim linking her and other members of the political opposition to the ouster plor poses a threat to democracy.

"Baseless allegations that link my involvement in legitimate opposition activities with illegal actions, particularly when they come from high ranking military officials, undermine not just the opposition but also our democracy," she said in a statement.

She was reacting to statements made Sunday by Brig. Gen. Antonio Parlade, assistant AFP deputy chief of staff for operations, who said the military has documents proving that the communists forged an alliance with the political opposition, particularly with the camps of Robredo and opposition Sen. Antonio Trillanes IV, and the Magdalo group that staged a mutiny against the Arroyo administration. Trillanes was among core leaders of the Magdalo.

Parlade also said the political opposition cut ties with the communist Movement Against Tyranny just before the martial law commemoration.

Duterte earlier this month said members of the opposition belonging to the Liberal Party or the "Yellows," the Magdalo together with soldiers in the active service, and the rebels Communist Party of the Philippines-New People's Army have formed an alliance aimed at ousting him.

Robredo said government's attempt to "de-legitimize various opposition groups and personalities by linking them to an alleged extraconstitutional plot is alarming."

She said a similar tactic of "branding critics as criminals" was used during martial law to silence the opposition.

The Vice President maintained that the opposition plays 2 critical role in guarding democracy.

Presidential spokesman Harry Roque said Robredo has not been in the supposed plot.

"She was not amongst those specifically named to be part of the conspiracy. She is, after all, the second highest elected official. She took an oath to support the Constitution and she should not and she's expected not to support any unconstitutional means to remove the President. Pero ang ating AFP naman po, hindi ko po sila narinigna pinangalanan si VP Leni (I never heard the AFP identify her as among conspirators)." Roque said.

Parlade vesterday said the military is helping expose the ouster plan to prevent the youth and students from taking part in it.

"It's okay to stage rally as long as the goal is clear, as long as they are not up for violence... Ever since, that is part of their plan, the exploitation of the youth and student sector," said Parlade.

President Duterte on Monday night said those plotting to oust him should just wait for the next national elections instead of "bedding the enemy."

The President, during a visit to soldiers confined at the Camp Teodulfo Bautista Station Hospital in Jolo in Sulu, lamented that some soldiers are conniving with the "Liberals" or "yellows" and the rebels.

He said what hurts him is the fact that he has done everything to promote their welfare, including increasing their salaries and benefits and providing them more equipment. — With Angela Lopez de Leon and Jocelyn Montemayor

# Military monitors groups plotting to unseat Duterte

Defense Secretary Delfin Lorenzana said yesterday that they are closely monitoring the New People's Army (NPA) and other groups who are plotting to unseat President Duterte from power.

In a statement, Lorenzana said threats coming from the communist and "grand coalition and broad united front" are also being taken seriously.

"We take it seriously. Remember that this was uncovered last Feb 2017 in an encounter in Bukidnon. It was hatched by the CPP/NPA in Oct of 2016 even before the President cancelled the peace talks," Lorenzana

said

"After it was cancelled, the implementation became an urgent program by the CPP-NPA," he added.

Lorenzana said the CPP-NPA's plan was to get as many civil organizations as possible to join their mass actions led by their progressive fronts. Their plan is supposed to culminate this October but may have moved it for another date," Lorenzana said.

"However, if you have been listening to Joma Sison he came out recently to say that PRRD will not last till middle of 2019. Maybe they have moved their goalpost considering

the lackluster performance of their so-called massed rallies last martial law anniversary," the DND secretary said.

"We are closely monitoring them including other groups," he added.

On Monday, the Armed Forces of the Philippines (AFP) said that their revelation of the communist plot to topple the Duterte administration through their October revolution or popularly known as "Red October" is not meant to protect President Duterte but the government itself.

AFP spokesman Colonel Edgard Arevalo made the statement even as he reiterated that its request for

the creation of a national task force intended to end insurgency does not seek to obtain additional budget for the military or to cause burden on the people.

In press briefing at Camp Aguinaldo in Quezon City, Arevalo said that they are very much aware of the plot to topple the Duterte administration and taking the matter seriously.

He, however, stressed that they are not protecting the Chief Executive but the government per se.

Arevalo, at the same time, stressed that they are not against freedom of speech for as long is within the bounds of the law.

"Let us not be mistaken or let us not be misled, or let us not be misconstrued. We are not against any legitimate exercise of the poeple's freedom of speech, freedom of the press, and freedom of assembly only that in so doing, that must be within the bounds of law," Arevalo said.

Arevalo said they are exposing the plans of these "grand coalition and broad united front" so that the public will be made aware of this plans.

Earlier, AFP assistant deputy chief for operations Brig. Gen. Antonio Parlade revealed that they were able to recover documents indicating that various anti-Duterte groups are plotting to unseat President Duterte from power.

Parlade said their main objective is to oust President Duterte using issues like extrajudicial killings, martial law, inflation, the increase in the prices of basic commodities, and tyranny of the media, (Francis T. Wakefield)

Amid the alleged "Red October" ouster plot against him, President Duterte has called on the military to shun any alliance with government enemies if they were "true to your country."

The President issued the statement after expressing resentment towards some members of the military who were allegedly in co-hoots with some opposition forces to overthrow-him from power.

Duterte asserted that the military and police need only tell him that he was unfit to lead the country, and he would leave his post to avoid bloodshed.

"Ang sakit ko dito, kayong mga Liberal, pati 'yung ibang sa military, nakipag-ugnayan sila kay, 'yung mga sundalo na rebelde. Tapos 'yun na 'yun, iyong tatlo. Duterte, who previously claimed that communist rebels and his political rivals were plotting to remove him by next month, maintained that the country's soldiers must loyal to the country at all times.

He said they should tell him straight if they were no longer satisfied with his performance. "If, you are true to your country, do not bed with the enemy, Sabihin mo, ayaw mo akong Presidente, si Duterte kasi bugok, walang alam, eh okay lang, fine. Maghintay lang slla ng election, three years away," he added.

The military recently bared that the communist rebel group was behind the alleged Red October conspiracy to oust Duterte. The group was allegedly conniving with the Liberal Party and Sen. Antonio F. Trillanes IV and his Magdalo Group in the alleged ouster plot.

The President, in his remarks last Monday, renewed his offer to

step down if the military was not satisfied with his governance. He acknowledged that no ouster plot would prevail without the support of the military.

"Nothing will succeed without the help of the Armed Forces of the Philippines. If the military, the Armed Forces, and the police think na hindi ako bagay na maging Presidente, sabihan nila ako. # PROBE SHOWS 7 TAUSUG MEN CIVILANS, NOT SAWAF

DAVAO CITY—Seven Tausug men killed in what the military said was a clash between soldiers and terrorists were civilians, according to results of an investigation by two human rights commissions.

The investigation results came as President Duterte gave medals to 17 Scout Rangers who were part of the group of soldiers being blamed for the Tausug men's killing.

On Monday, Mr. Dutertevisited the 17 wounded Scout Rangers at a hospital in Jolo, Sulu province, to pin medals and hand over .45-caliber pistols.

jerome Succor Aba, spokesperson for the Moro group Suara Bangsamoro, said the visit only added to the pain of the men's relatives.

### Not terrorists

Mr. Duterte's visit to the soldiers became more controversial after findings made by the Commission on Human Rights and Human Rights Commission of the Autonomous Region in Muslim Mindanao showed that the slain men—aged 16 to 30 years old—were all civilians and not Abu Sayyaf members, as claimed by the military.

The two commissions had launched a joint probe of the killings.

Aba said Mr. Duterte's visit was an attempt to "wash the blood off the hands of the offending soldiers."

The families of the men said the seven had sought permission from soldiers to harvest fruits from their trees on the day they were arrested.

### Hunt for Sahiron

The military said the men were among some 70 members of Abu Sayyaf who clashed with a group of Scout Rangers belonging to Class 205-18 in the village of Bakong in Patikul town, Sulu.

Seventeen Scout Rangers suffered minor shrapnel wounds during the clash and brought to the Camp General Bautista Hospital in Jolo, Sulu, where the President visited them.

The military said the Scout Rangers, still students, were on a mission to get Radullan Sahiron and two other Abu Sayyaf leaders—Hajan Sawadjaan and Idang Susukan—in an area of Patikul with grid coordinates 51NTG8929270577. INQ

# Teachersnatched In Sulufieed for P2 M2

ZAMBOANGA CITY – A public school teacher kidnapped by Abu Sayyaf bandits in Patikul, Sulu over the weekend was released on Monday.

Shariff Benjamin Asamli Ubaid, a resident of Jolo, was reunited with his family after reportedly paying P200,000 to his captors.

The Sulu police said Ubaid, a teacher at the Camp Andres Central Elementary School, was released at around 6:30 p.m. in Barangay Danag also in Patikul.

Ubaid reportedly had just attended a prayer marking the 100-day death anniversary of his brother when he was taken along Godinez street in Barangay Latih near Jolo.

The victim managed to

call one of his co-teachers, saying they were heading out of Jolo.

The kidnappers reportedly demanded P1 million in exchange for Ubaid's release, but later reduced it to P200,000.

Chief Superintendent Graciano Mijares, Autonomous Region in Muslim Mindanao (ARMM) police director, said they are still validating the reported payment of ransom.

"The government does not

allow that; we still have to verify that," Mijares said.

There were also reports that officials of the Department of Education in the ARMM helped in the negotiations for Ubaid's release.

The Abu Sayyaf is still holding two foreigners and nine Filipinos.

Lt. Col. Gerry Besana of the Western Mindanao Command said there is no letup in military operations to rescue the remaining hostages.

# ASGkidnaps Sulu teacher

AMBOANGA CITY: Suspected Abu Sayyaf Group (ASG) bandits have reportedly abducted a public school teacher in Sulu, sources said on Tuesday.

The victim, Shariff Benjamin Asamli his safe release. Ubaid, was seized in the capital town of Jolo on Saturday morning, said one of his friends who appealed to the terrorists to free their hostage.

According to this friend, the teacher was a hardworking one.

The abduction was reported only on Monday after the ASG bandits allegedly used Ubaid's mobile phone to demand P1.5 million in ransom for

No other details of the kidnapping were made available, but on the eve of his abduction, Ubaid wrote this on his Facebook account: "Have faith in Allah, everything will be in good hands!"

Police and military authorities did not release any information or reports about the latest abduction, as well as the Department of Education (DepEd)

in the Autonomous Regions in Muslim Mindanao.

The motive of the abduction is still unknown, but the Abu Sayyaf has been largely blamed for many ransom kidnappings in the troubled region of Mindanao

The kidnapping happened while the entire southern Philippines is under an extended period of martial rule over threats of terrorism and insurgency.

It was unclear how the abductors managed to enter Jolo and escaped with their hostage considering the huge presence of soldiers and policemen in the town.

them." They were returning to Marawi from their evacuation center for the first time since the siege.

In Barangay Bacolod Chico, a boy wrapped his arm around his beloved grandmother. Despite the destruction of their home during the Marawi battle, the family smiled warmly as the grandmother exclaimed, "Allah is great! We lost our home, but the children are all safe, None of them joined ISIS. We are all alive."

These were among the many realizations of displaced Marawi City residents as they began to survey the damage wrought by last year's prolonged battle, as well as the process of rebuilding their lives.

Given the continued recruitment efforts by Islamic State sympathizers despite their loss in Marawi and the destruction of their informal networks, destroying the local narcotics trade and other "shadow economies" will

not be enough as there is also the question of the thousands of indoctrinated children left behind.

A group called "Can Mothers Challenge Extremism" has examined the potential of mothers in counter-terrorism.

The group's independent study was carried out in regions affected by violent extremism such as Nigeria, Northern Ireland, Pakistan, Palestine and Israel.

The results of the study showed that mothers trusted themselves and other mothers first in protecting their children against extremism. The current security approach, including in the Philippines, tends to focus on the role of national and local authorities.

Globally, almost every known terrorist organization in recent history has recruited women into their causes.

In the Philippine context, however, women, mothers and grandmothers can serve as effective front-liners in de-radicalizing young people drawn to extremism.

In the case of Ishmael Omar, one of the "bakwits" or internally displaced persons from Marawi, parental influence reinforced his already strong resolve not to become an IS fighter.

"Ngayon, karamihan ng mga kaibigan at kakilala-ko-na mga kabataang nag-ISIS, patay na. (Now, most of my peers and acquaintances who joined ISIS are dead.) Pati ang ibang mga kamaganak namin na nag-ISIS, patay na rin (Even our other relatives who joined ISIS are already dead)," he said in an interview.

"Ako, dahil sa mama and papa ko, hindi talaga ako na-recruit. Pero talagang hindi tumitigil dati ang ISIS sa pag-recruit sa akin (Because of my own mother and father, I was not recruited. But ISIS was relentless in trying to recruit me)," he added.

# Terrorist leader arrested

# ARMM may realign budget for BOL plebiscite in 2019

COTABATO CITY: Autonomous Region in Muslim Mindanao (ARMM) Gov. Mujiv Hataman has suggested that a fraction of the regional government's budget for 2019 be realigned for the Bangsamoro Organic Law (BOL) plebiscite scheduled on January 21, 2019 in case funding for the referendum will not come on time

"We support the BOL all the way and budget should not be a problem, we are recommending to allow part of the ARMM proposed budget to be used for the plebiscite," Hataman said on Tuesday.

He pointed this out in the wake of reports that there is no allocation in the P3.757-trillion 2019 national budget for the BOL plebiscite which requires P857 million.

Lawmakers have said the P10-billion budget submitted by the Commission on Elections for 2019 does not include expenditures for the plebiscite

Hut Senator Loren Legarda said it is understandable since the law was certified urgent and passed in the middle of the year therefore not funded in the 2018 General Appropriations Act which was signed in December 2017.

Hataman said Congress may realign over P800 million for the plebiscite from the P10.1 billion infrastructure fund for the region proposed by the ARMM next year.

In a media report on Saturday, lawmakers said if the funding problem is not seitled in Congress within the succeeding days, one option would be for the Comelec to use its savings from the barangay elections held last May.

Another option would be to seek funding from the Office of the President.

The criminal cases against Sen. Antonio Trillanes IV were revived after the amnesty

granted to him by then president Benigno Aquino III was declared void by President Duterte. While the amnesty was granted to a group of rebel soldiers following the same procedures.

only Trillanes lost the privilege.

'Malacanang argues that the amnesty granted to Trillanes was invalid because he did not apply for it, and only Aquino's defense chief Voltaire Gazmin approved it. Aquino has said his amnesty proclamation covered all the rebel soldiers.

Yesterday, Judge Elmo Alameda of the Makati Regional Trial Court's Branch 150 set aside materials presented by Trillanes to prove that his amnesty grant is valid. Alameda went along with the petition of the Department of Justice and ordered Trillanes' arrest for rebellion. But the judge allowed Trillanes to post P200,000 bail.

Trillanes might yet end up back in detention for the crime of coup d'etat in connection with the Oakwood mutiny. This was filed before another Makati trial court, Branch 148. The offense normally does not allow bail.

Malacaiang voided the amnesty on the same day that Trillanes' committee began its probe into possible conflict of interest and graft against Solicitor General Jose Calida, whose familyowned security company has bagged several contracts with various government agencies. The President said the voiding

of Trillanes' amnesty was the idea of Calida, who was also the one who initiated a quo warranto petition to kick out Maria Lourdes Sereno as chief justice.

Still to be resolved is whether Malacafiang can void an amnesty without Senate approval for individual recipients. The Supreme Court under Teresita de Castro, however, has refused to touch the amnesty issue.

Some quarters argue that what applies to one should apply to all. With Alameda's order, all the other rebel soldiers who were given amnesty together with Trillanes, some of them now working for the government, are in limbo.

The amnesty given by Fidel Ramos during his presidency to those who launched coup attempts against Corazon Aquino may also be affected. Among the recipients are Sen. Gregorio Honasan, Armed Forces chief Carlito Galvez and Chairman Danilo Lim of the Metropolitan Manila Development Authority.

If the government is challenging the validity of Trillanes' armesty, it should also go after the other recipients. Failing to do this bolsters accusations that the government, supported by a compliant judiciary, is engaged not in prosecution but persecution of its critics.

### Red October

Masbate native who is now a blue-collar worker in Manila says communist rebels have a strong presence in his home province.

The worker understands that the insurgency feeds on poverty, bad governance and social injustice. He says that criminality is



high in his province, with even the impoverished being robbed of their earnings from the sale of backyard crops and livestock. Or else they are forced to sell their crops to middlemen at unreasonably low prices. When thievery happens, the worker says, the victim has three options.

One is to just grin and bear it, praying for divine

justice to catch up with the crooks.

A second option is to report the case to local authorities – the barangay and police. There is no certainty that the culprit will be caught. If the suspect is arrested, he may be allowed to post hail or manage to escape. Or the case may be dismissed because the poor litigant does not have the time or resources to pursue a court case that can drag on for a decade, even with assistance from the Public Attorney's Office.

Such litigants just want the stolen goods back, plus a bit of jail time for the thief, in hopes that the punishment will teach the culprit a lesson so he won't steal again and the victim will feel safe. Such crime victims, however, often fail to get redress in the country's dysfunctional criminal justice system.

So they take the third option, if presented to them. The blue-collar worker says that when people in his village turn to the New People's Army with complaints not just of thievery but also of abuse by the wealthy or state forces, the culprit is shot dead. In return for the swift justice, the NPA occasionally gets free meals from the grateful household.

The gratitude can be abused. A "donation" of chickens and an occasional pig to the NPA can weigh heavily on an impoverished household. The worker says the household is also typically compelled to pay "revolutionary taxes" about twice a month.

Serious trouble can erupt when the military gets wind of the assistance, even if forced, given to the NPA. A terrible fate can await NPA sympathizers, whether genuine or simply those who are left with no choice but to give in to rebel extortion.

Reprisals by government forces, however, can backfire and drive more people to turn to the NPA

for swift justice.

This is the situation in just one province. You can see why we now have the world's longest running) communist insurgency.

And you can see why government forces are insisting that there is a genuine communist plot, code-named "Red October," to oust President Duterte next month.

Incidentally, Russian Ambassador Igor Khovaev asked me why we call our homegrown rebels communists.

"Look at me, I am a communist," Khovaev told me when he was our guest some weeks ago on "The Chiefs" on Cignal TV's One News. Neither the Leninists nor Maoists would recognize the rebellion being waged by the Communist Party of the Philippines, said Khovaev, who grew up in Russia when the Soviet Union was still in existence.

The envoy of course understands that for many members and sympathizers of the Philippine communist movement, the driving force is not ideology or the attainment of some vague communist utopia.

Poverty, social injustice, state abuses, glaring inequities, weak governance – these roots of public discontent made the Communist Party of the Philippines (CPP) attain utmost strength during the dictatorship of Ferdinand Marcos.

Today, thanks to the persistence of the problems, aggravated by the dirty war on drugs, the insurgency is enjoying such a resurgence that an administration led by an immensely popular president feels threatened by a supposed plot to oust him.

From exile in the Netherlands, one of the world's most liberal societies, CPP founding chairman Jose Maria Sison pointed out to The Chiefs that the communists are waging a rebellion, so obviously, their ideal goal is to overthrow the government.

But Sison has denied that there is any "Red Oc-

tober" plot spearheaded by his group.

President Duterte has claimed that Joma Sison is dying of cancer and that the communist rebellion would be crushed by mid-2019. Still, even with the CPP leader's allegedly poor health, the Armed Forces of the Philippines (AFP) maintains it is taking seriously the supposed ouster plot.

The opposition Liberal Party as well as the Magdalo group of Sen. Antonio Trillanes IV have also denied conspiring with the communists to topple Duterte. The Magdalo in particular has stressed that it cannot possibly work together with rebels who continue to kill government forces, which the group is representing in Congress.

Still, President Duterte has insisted that certain elements in the AFP are part of Red October, and

the plot is still on.

Since the Marcos dictatorship, the AFP has evolved in terms of professionalism and now enjoys a much-rehabilitated image in the eyes of the public. Let's hope it is not staking that hard-earned respect on a fabricated conspiracy.

If Red October turns out to be a case of smoke and mirrors to justify a crackdown on political dissent, it could work in favor of the communist

movement.

Like Sison's purported looming demise from cancer, the death of the communist rebellion by next year could turn out to be greatly exaggerated.

# Moving on is not forgetting

HOSE who cannot remember the past are condemned to repeat it. This cautionary observation from the philosopher George Santayana seems rather appropriate today in view of the revisionist retelling our shared national experience with martial law in the 1970s, coming from one of its architects, Juan Ponce Enrile.

These names were not the result of any propaganda—they were based on claims received, evaluated, processed and investi-This week, Enrile went a gated by the HRVCB—and represented only 14 percent of the total 75,749 applicants.

Angered by Enrile's claims. prominent politicians who suffered under martial law have also made their voices heard.

Against this backdrop, we welcome the Palace statement that Enrile cannot twist history and claim there were no arrests of political activists under martial law.

"As far as the Palace is concerned, there are decisions affirming that there were grave human rights violations committed during the Marcos regime. There's even a law in Congress which provides for compensation for victims of martial law," Presidential Spokesman Harry Roque said. "I don't think they can twist history when there's a law and there are court decisions attesting to what happened during martial law."

At 95, perhaps Enrile's memory may no longer be what it was. But those of us who lived through the martial law years and know people who were detained for their beliefs, remember.

It is often suggested these days that we need to move on from that period in our history. On this we agree. But moving on does not mean forgetting the excesses of the past, pretending they did not exist, or falsely believing that they could not happen again. 🛝

eno did not want to be included in the opposition slate.



DESPITE irritants triggered by President Rodrigo Duterte's anti-US statements, Manila and Washington reaffirmed their commitment to the 1951 Mutual Defense Treaty. In a meeting in Washington on Sept. 19, Philippine Defense Secretary Delfin Lorenzana and US Secretary of State Michael Pompeo discussed addressing regional challenges including Beijing's militarization of the South China Sea. Unimpeded passage along international navi-

gational lanes for commercial cargo ships is the main concern of the US State Department spokesperson Heather Nauert said the two secretaries also took up the threats of terrorism and the denuclearization of the Korean Peninsula.

Secretary Pompeo, according to Nauert, reiterated the US readiness to assist the Armed Forces of the Philippines to modernize by granting weapons including warships for its territorial defense. A rising China and its agenda of hegemony in the Southeast Asian region is a great concern to the US.

In another good development, two Philippine senators—Edgardo "Sonny" Angara and Sherwin Gatchalian—said they would restore cuts in the budget of the Department of Education. Angara, who was elected president of the Laban ng Demokratikong Pilipino, said

scholarships for deserving students must not be sacrificed in the altar of the P3.57-trillion national appropriations act. He was also concerned that slashing the DepEd budget would hamper the building and repair of schools and classrooms destroyed by a series of typhoons.

Mamba on mayors

Cagayan Gov. Manuel Mamba took exception to our column last Friday about the vice governor and 10 mayors who were in Manila when Typhoon "Ompong" swept the province. In the interest of fair play, we are running his letter that took issue with some of our comments. Here it is in full:

I write relative to your Sept, 21 column titled "Why Cagayan mayors were in Manila."

At the outset, let me make clear I was never informed of the travel or invitation from Malacañang of the 10 mayors and provincial officials your column referred to I did not know that these officials left their area of re-

sponsibility because none of them requested travel authority from my office, Hence, I could not have fed "false reports" to Palace reporters.

It was days after Ompong devastated Cagayan that I learned of the Palace invitation. I read news reports that SAP Bong Go extended the invitation long before Typhoon Ompong threatened and cancelled the meeting precisely because of the oncoming typhoon. To my mind, the concerned mayors and provincial officials should have exercised the same acumen.

## Affirming...

As early as Sept. 10, 2018, I announced during the flag-raising ceremony at the provincial capitol that Super Typhoon Ompong was likely to hit the province and directed everyone to prepare for the same. In fact, the provincial government was incessant with the announcements, preparations and preemptive evacuations. Had I known of the impending travel of the concerned officials, I would have stopped them from leaving their areas of responsibility. Given that they did not request for travel authority, they should have nonetheless exercise better judgement by not leaving

their people, considering the people's traumatic experience and devastation from Super Typhoon "Lawin."

I am not privy to the purpose of the mayors' and other provincial officials' travel to the Palace on Sept. 14, 2018 and as to why former Senator Juan Ponce Enrile was with them. But it is not for them to

judge whether or not I am serving my people well. I bring the funds and services of the provincial government to everyone of the 820 barangays in the province under the No Barangays Left Behind Program or rendering 24/7 quick response services through the Task Force Lingkod Cagayan with six stations strategically located province-wide or opening communications with the Governor 24/7 under

the I Text Mo Kay Gov services. I bring frontline services of the provincial government closer to the people or improving the hospitals and making the provincial health services responsive to the needs of the people by fighting illegal drugs, insurgency, terrorism, corruption and impunity by local officials. [If this is not service], then I don't know what "serving the people well" is.

Cagayan was once the premier province in northern Luzon. Compared to Isabela, Kalinga, Apayao and Ilocos Norte, Cagayan was resplendent. Look at us now.

## Martial law: The historical narrative



IT WAS AFP Chief of Staff Carlito Galvez who noted that then President Marcos was justified in declaring martial law in 1972. Citing the historical record, Galvez said that the country was on the verge of disintegration and chaos in the run up to that fateful September. There was the growing Communist insurgency supported by China and other like regimes. The secessionist movement in the South fueled by Malaysian interests. An economic downturn magnified no end by the profligacy of the privileged class. Deepening divisions among members of the political elite giving rise to warlords and private militias and the worsening crime situation across the archipelago.

The State decided to cut off those who stood in the way of stabilizing the situation and preventing the country's Balkanization. In a very real sense, the country was at war.

To Galvez, this historical confluence of events in the midst of the Cold War prompted Marcos to make use of the extraordinary constitutional option of putting the entire Philippines under martial law to save the Republic. Of course, this narrative runs counter to that promoted by those who were against such an imposition in the first place: the old oligarchy who had to part with their privileged status, the political elite who had to surrender their standing and private armies to the martial law government, members and fighters of the CPP/NPA/ NDF and their supporters; the secessionists and a subset of the intelligentsia and their foreign partners.

But a majority of our people at that time, whether out of fear or belief, as well as the US and its Western allies, welcomed martial law and saw it as a necessary initiative to arrest the chaos and decline enveloping the country. Unfortunately, abuses committed by the security forces and even by those waging armed struggle against the state soon became the centerpiece of the martial law narrative and took wings after 1986. That is now being revisited especially by those like Galvez and the military establishment who fought hard to bring the peace and ensure the country's territorial integrity.

And so, 46 years after the declaration of martial law, there is growing public interest in revisiting the past and hear out the entire story, so to speak, not get confined to the narrative of those who detested its implementation in the first place. As Brigadier General Antonio Parlade Jr., AFP Deputy Chief of Staff for Operations emphasized a "complete historical narrative will show that the declaration was justified."

In a very real sense, the country was at war

in 1972.

Said Parlade: "The narrative of martial law always starts in 1972 during the declaration itself. But no one is talking about the circumstances, the events before martial law...Instead of pointing all accusing fingers at the former President, the public should pin the blame on the 'monsters' New Peoples'Army [NPA] and the Moro National Liberation Front [MNLF] both of which waged war on the duly elected authority."

The two monsters escalated their destabilization efforts, combining their armed uprising and bombings across the archipelago with protest marches, strikes and other legal maneuvers, culminating in the bombing of the Liberal Party's "Miting de Avance" in 1971, which was blamed on Marcos but was found out later on as a CPP/NPA operation in league with opposition leaders. By the time, the daily spectacle of killings and violence and protest actions became so widespread and brought the

country to its knees. It had to be stopped before the situation got out of control.

"I am just stating facts," Parlade continued, "which should have been part of history prior to martial law which the media never wanted to talk about. It's time people should know. That's necessary for the nation to heal itself and move on."

Again, there will be a strong rebuttal to Parlade's views. It is inconceivable to bring the anti-martial law/anti-Marcos groups to even consider inquiring into the issues which have surfaced questioning their version of martial rule. In fact, Parlade has been called all sort of things including being a revisionist. But Parlade has stood his ground and he deserves our accolades. But to go back.

"It's not revisionism," Parlade said. It is completing the historical narrative—the stories which came out after 1986. That is the Edsa story. That is incomplete and in many instances unavailing. He even claims that then Senator Ninoy Aquino in one public engagement admitted that given the circumstances in 1972, he himself would have declared martial law.

But even as he justified the imposition of martial law in 1972, Parlade acknowledged the abuses committed by the security forces and the backsliding at all levels which occurred after. But it is the notion of the AFP and the security forces being themselves the monster in the eyes of the public second only to then President Marcos as perpetrated by those who entered the scene as conquering "heroes" in 1986 which grates. It is a continuing black eye which the military establishment wishes cleared and put in proper perspective.

"The AFP was very much a victim of martial law also," Parlade said. "We don't deny the abuses. Those who were part of that dark history have all retired. Some have died. Others have suffered for their misdeeds, So let's stop blaming the AFP."



## What Red October plot?

HAVE a real problem with this so-called "Red October" plot to bring down the Duterte administration: I don't think the Armed Forces actually has enough



intelligence to go after the shadowy people behind this alleged plot, assuming that it does exist.

## What Red October plot?

Forget about the cheap cinematic allusion of the plot's name. My concern has to do with the Armed Forces of the Philippines conducting the business of thwarting such plots through the media using the unfamiliar weapons (to them, anyway) of press releases and media briefings.

The military should not, in my view, be doing its work like politicians, warning of phantom forces being assembled to bring down established and legal authority. What I'd like to see the AFP doing is rounding up actual persons involved in the alleged plot — before they even announce that they've uncovered it.

In the first place, President Rodrigo Duterte himself has already repeatedly talked about groups—including the Communist Party of the Philippines and its armed component, the New People's Army — planning to unseat him next month. That probably inspired the military publicists and gave them the idea for the reference to the debut Tom Clancy novel that became a hit Cold War submarine movie thriller.

Understand, as well, that Duterte said the basis for his revealing the plot is not even the AFP's intelligence-gathering efforts. The President explained that a friendly foreign country that he did not identify was the source of his information.

Also, even exiled Communist Party leader Jose Maria Sison had long ago declared, upon the collapse of the peace talks between the government and the communists, that he and his

comrades were joining the effort to oust Duterte. That is an admission from Sison himself that the communists are already working to remove the President that a quick Google check will uncover.

All the military had to do was to dream up a name for the plot. The "Red October" name was their only contribution, as far as I know.

Of course, I've heard the old joke about military intelligence being an oxymoron. But that's really just an ignorant putdown, for the most part.

With its huge intelligence resources, the military has done fine work in the past of uncovering threats to the Republic. And even its previous spokesmen have done an excellent job of getting the AFP's message out without resorting to the cheap propaganda that has been coming out from Camp Aguinaldo recently.

I remember the time, not so long ago, when the AFP had the most capable spokesman in all of government in Brig. Gen. Restituto Padilla. Alas, Padilla was so good at his job that he was promoted to deputy chief of plans — and the AFP lost the best mouthpiece it ever had, in my view.

But now we are treated to the spectacle of the AFP chief of staff himself, General Carlito Galvez, and his deputy chief of operations, Brig. Gen. Antonio Parlade, talking about a "broadbased" coalition to which the communist old guard and even ousted Supreme Court chief justice Maria Lourdes Sereno belong, working to bring down Duterte. And this without mak-

ing even one arrest first or revealing one actual document to back up their claim.

Perhaps it is relevant to mention here that Parlade was sacked in 2011 as Army spokesman for calling on the government to suspend its truce with the secessionist Moro Islamic Liberation Front. And soon, if Parlade and his boss insist on talking about a Duterte ouster plot that they cannot prove, maybe the general will reprise the defense he made back then, that "I just did my job and said what I think was right."

To be fair to Parlade, I actually sympathized with his call back then to suspend peace talks with the MILF rebels, which he made in the aftermath of the killing of 19 Army men in an encounterwith the Moro secessionists in Al Barka, Basilan. Parlade said his sentiments were shared by nearly all the soldiers on the ground at the time, who were aghast that the administration of Noynoy Aquino continued to talk peace with the MILF after the brutal killings.

But perhaps Parlade should also be reminded of what he said after Al Barka, which was this: "We are not politicians, we are soldiers, professional soldiers."

Well, sir, that may still hold true for your men on the ground. But the AFP's leadership, of which you are now an important part, seems to be acting a lot like the politicians you once detested.

Then again, I've not really been impressed with the entire leadership of the military under Duterte from the very beginning, or since he named the US-loving

Delfin Lorenzana as defense secretary. And I'm not the only one who thinks so, but perhaps even Duterte himself, who frequently ribs his defense secretary about staying so long in Washington that he's practically a member of the bureaucratic "deep state" that has never cottoned to the former mayor of Davao City.

For the life of me, I still wonder why Duterte keeps Lorenzana around, when his defense secretary has not only kept his excellent ties with the Americans under an anti-American president, but has also shown no compunction about cozying up to the opposition to Duterte. I'm talking about the two times that Lorenzana has given security briefings to Vice President Maria Leonor Robredo while the President was away on official visits abroad, when everyone knows that Robredo is as in demand in this administration as a bad case of herpes.

Of course, the reason why Lorenzana is defense secretary is because Duterte's first choice for the job, the much-admired Gilberto "Gibo" Teodoro (who held the position in the Gloria Arroyo years), turned him down. several dozen Filipinos whom he condemned as counter-revolutionaries, ordered the 1971 Plaza Miranda bombing of a Liberal Party rally, and for nearly 50 years now exhorted the party's New People's Army to wipe out soldiers and policemen of the Republic.

He was captured in 1977 and faced charges of rebellion, subversion, and murder in two military courts, a process deemed constitutional by the Supreme Court in 1981, since the crimes were committed during Martial Law.

Corazon Aquino ordered him freed eight days after she assumed power on Feb. 25, 1986. A few months later, after a speaking tour at the University of the Philippines, he abandoned his comrades in the country and went abroad, finally settling in the Netherlands in 1987. There he continued his incessant exhortations for the NPA to intensify their killing of the Republic's soldiers — one soldier a day, he even boasted a few months ago.

Yet last May, he and his wife Juliet got P2.4 million, remitted to his bank in Utrecht. For his arrest in 1977 and incarceration, and because his wife's psychological travails due to his detention, they were declared "human rights violations victims" during the Marcos regime, deserving to be, as Sison himself quipped, "instant millionaires."

It was the Human Rights Victims' Claims Board (HRVCB) attached to the Commission on Human Rights that declared the Sison couple as "human rights violations victims," and gave them P2.4 million. Among the members of the board (who are appointed by the President) who decided on this was now CHR chair Chito Gascon, and former National Democratic Front spokesman Byron Bocar.

#### Trail of blood

How on earth could the top communist whose party's insurgency has left a trail of blood all over the Philippines merit that?

It was authorized under Republic Act 10368, or the Human Rights Victims Reparations Law, passed in February 2013. It was former President Benigno Aquino's huge gift to the Communist Party that lobbied for it through its representatives in Congress, which consequently supported him almost entirely during his regime.

The money for compensating the alleged victims of martial law came from the \$670 million (\$350 million in 1986) which the Swiss Federal Court ordered remitted to the Philippine government, after concluding they were illegally acquired by Marcos and his wife imelda.

About 10,000 have been beneficiaries of the law. The joke that had been going around among leftist activists and former NPAs, after the first releases were made: "I didn't know we won. We are now receiving our back pay."

It is this law which Presidential Spokesman Harry Roque Jr. the other day invoked as having already determined martial law's "history," which is really the Yellow and communist narrative that there was widespread violation of human rights under the Marcos regime.

Referring to former senator Juan

Ponce Enrile's recent claims questioning that Yellow narrative, Roque said. "I don't think they can twist history when there's a law and when there are court decisions attesting to what happened during Martial Law."

Roque exaggerates; there are no other "court decisions" confirming the Yellow and Reds' narrative of martial law. Only this R.A. 10386 does that. It was passed at the height of Aquino's power, during which he had Congress under his thumb, bribed by billions of pesos from his now notorious Disbursement Acceleration Program that was initially intended to get the legislative body to remove Chief Justice Renato Corona in a few months' time.

It was authored by Aquino's loyal legislators like Lorenzo Tanada 3rd and Edcel Lagman and communist party-list congressmen such as Neri Colmenares and Teodoro Casiño. The bill was cleverly introduced in March 2012, at the height of Corona's impeachment trial, most probably in a quid pro quo for the Left's support for Aquino's project to assault the Supreme Court

#### Hereby declared

The law's Section 1 legislated a history of Martial Law.

"It is hereby declared the policy of the State to recognize the heroism and sacrifices of all Filipinos who were victims of summary execution, torture, enforced or involuntary disappearance and other gross human rights violations committed during the regime of former President Ferdinand E. Marcos covering the period from September 21, 1972 to February 25, 1986."

Thus, Sison simply submitted while he was in the Netherlands newspaper articles that he was arrested and detained, and claimed that his wife suffered psychologically, and the board awarded them P2.4 million.

I am astonished at how Roque, formerly a legal academic, could subscribe to this blatantly inane view that a bunch of opportunistic politicians could legislate history. That is what the Aquino-controlled Congress did when the law they passed defined as anybody incarcerated under Marcos' martial-law powers, as automatically a human rights victim, each one or his heirs entitled to as much as P1.8 million in "compensation."

What if another Congress were to enact a law declaring that all arrests, disappearances, and extrajudicial killings from the day Cory captured power in February 1986 to 1991 - which numbered 10,882\* up to 1988 alone - are human rights violations, with the victims also entitled to P1 million compensation? Such a law might even declare that the more than 200 killed and wounded in the 1987 Mendiola massacre and in the fight against Hacienda Luisita will be given an additional P2 million in compensation. It could even declare that Cory had the worst human rights violations among Philippine presidents. So what if there are no reports by historians to verify that. RA 10386 wasn't based on any historical studies, yet it was enacted into law?

History cannot be legislated. It is stupid for Roque to claim that Enrile is "revising the history of Martial

Law," simply because there are as yet no objective history narratives of that period written by scholars and peer-reviewed. There were no reports on that era by historians, nor even by the National Historical Commission, to Congress when the bill was rushed. There is totally no mention at all in the law of the one thing that caused the arrests and even killings: the war waged by the communists to violently overthrow the democratically elected government.

What we have are the books written by American parachute journalists right after Marcos fell wishing to cash in on the best-seller possibilities of hate-Marcos books, and hacks of the Yellow cult, and recently by a crackpot blogger who thought that she could make tons of money if another Yellow president won, who would make her book required reading in our schools.

There is only one case about which several mainly European states indirectly legislated a history. That of the Holocaust in which 6 million Jews were killed by the Nazis. This was by making it illegal for anybody in their nations to deny that the Holocaust occurred.

I hope Roque realizes that the law he claims has determined what the martial law era was leads to such an absurdity as the top communist — himself guilty of human rights abuses (as I wrote Monday) and who had waged a bloody war against the Republic — being declared as a human rights victim, and with his wife awarded P2.4 million as compensation.

He should also realize that the mob that claims widespread human rights violations during Martial Law is the very same gang that alleges that his boss in his war against illegal drugs is following in Marcos' footsteps. Or is Roque just being clever, calculating that he would be the "DDS" whom the Yellows and the Reds would vote as Senator next year?

It probably says a lot about Sison that nobody knew that he and his wife had applied for compensation as human rights victims, until he admitted it when interviewed by a Europe-based TV network reporter.

Most top communist leaders, retired or current, like Bernabe ("Commander Dante") Buscayno, army defector Victor Corpus, former party chairman Rodolfo Salas, and Satur Ocampo did not apply for compensation. They had proudly claimed that they joined the revolution to serve the people, and for money. I guess, to use a sentence allegedly made by Imelda Marcos: "Some are smarter than others," whether you're a capitalist or a communist.

### RevGov - the end game

AST week, a letter addressed to the President purportedly signed by the AFP Chief of Staff and the major service commanders edited by an eminent newspaper columnist, Carmen (Chit) Pedrosa, was circulated in social media. I must presume by now, this has reached the President's ear.

It is supposed to be a letter that the President has been waiting for presumably to give him the raison d'etre to act. This letter did not mince words "... there is enough ground already to dissolve Congress and declare RevGov...".

In the parlance of the revolutionary movement, a catalyst is needed to speed up the attainment of its goal of social upheaval.

Juan Ponce Enrile appeared In a one-on-one discussion with ex-Sen. Ferdinand "Bongbong" Marcos. Jr. The discussion was disseminated on the social media.

Enrile was the Secretary (later, Minister) of National Defense during most of the Marcos administration and is Now that the chief architect and administrator of martial law. He began his stint as the defense chief in 1970. In November 1971, Enrile made an unsuccessful run for senator. Despite his defeat. Marcos saved him from oblivion by reappointing him to the defense portfolio in January 1972, a post he kept until the end of the Marcos' presidency in February 1986. Enrile wielded tremendous power under Marcos,

In February 1986, Enrile and then Armed Forces Vice Chief of Staff chose to be disloyal to President Marcos and holed themselves pup at Camp Crame. Upon the instigation of Manila Archbishop Jaime Cardinal Sin, civilians assembled outside the military camp to protect the mutineers from certain arrest by troops loyal to the commander in chief. That massive assembly which lasted for four days eventually became the so-called EDSA People Power Revolt.

After Corazon Cojuangco Aquino seized the presidency in February 1986, she kept Enrile as defense minister for a year. Mrs. Aquino eventually fired Enrile on suspicion that the latter was sympathetic to a segment of the military establishment that wanted to overthrow her administration.

Bongbong Marcos is the namesake and only son of the late president.

As senator, Marcos, Jr. was instrumental in stopping the controversial Bangsamoro Basic Law (BBL) which then President Benigno Aquino III tried to railroad into legislation through his Liberal Party (LP). The BBL would have created a Moro sub state in Mindanao.

Marcos, Jr. ran for vice president in May 2016 and was the leading bet in the whole week after election day. In the end, Leni Robredo of the LP was proclaimed winner. Marcos, Jr. has a pending election protest before the Supreme Court sitting as the presidential electoral bibunal.

In his conversation with Marcos, Jr., Enrile said President Marcos resorted to martial law to neutralize the conspiracy between the LP led by then Sen. Benigno Aquino. Jr., and the Communist Party of the Philippines led by Jose Ma. Sison, to overthrow the duly-constituted government of the Republic.

Enrile also suggested that the yellow army and the local communists are distorting the historical record.

As expected, Enrile's statements elicited criticism from many known anti-Marcos personalities. They accused Enrile of historical revisionism and of demeaning the significance of the 1986 EDSA People Power Revolt.

President Aquino III and ex-Sen. Aquilino Pimentel, Jr. added that the

94-year-old Enrile must be experiencing memory lapses because of his age. How senior citizen groups in the country will react to that ageist remark should be interesting.

Noticeable was the common mantra of the noisy oppositionists - "Never again to martial law."

Despite her claim to restoring press freedom in the Philippines, Mrs. Aguino filed libel charges against two leading journalists of the period - Maximo Soliven and Luis Beltran. No President before her ever sued journalists for libel.

> The media detested the brazen involvement of Mrs. Aquino's relatives in many government transactions so much so that Beltran branded them as "Kamag-Anak, Inc."

Innocent farmers attending a rally in Mendiola to protest Mrs. Aquino's version of agrarian reform were killed or beaten by law enforcers. Farmers

in the Cojuangco-Aquino-owned Hacienda Luisita in Tarlac demanding reforms suffered the same fate.

Regarding Enrile, his remarks were no longer surprising for many.

As the chief architect and administrator of martial law, Enrile is expected to defend the martial law regime he was part of. On the other hand, those who were put to a disadvantage when martial law was in force are likewise expected to disagree with Enrile's statements.

The same can be said of Marcos, Jr., being the son of the father.

Both the pro-Marcos and anti-Marcos sides embody the extremes in the assessment of martial law in the Philippines as a historic fact and neither side is expected to yield. It is no wonder that both sides accuse each other of historical revisionism.

What does all that mean? It means there will always be different perspectives of what martial law in the Philippines was all about and those

different perspectives will always be topics for heated debate during anniversaries associated with martial law in the country.

So, until the next anniversary ...

As it was then, so will it always be. But the Communists, the political opposition and elements in uniform working in harmony to achieve one end?

I have heard and do believe in the saying "The enemy of my enemy is my friend"; but this to me is just a little too much of a stretch.

I was therefore left unmoved by newspaper reports of a September 21 plot, and now of a Red October plot

#### AFP: Palparan still under military custody

Former Army Major Gen. Jovito Palparan is still in the custody of the military despite the order of the Malolos Regional Trial Court (RTC) that he be committed to the New Bilibid Prison (NBP).

Palparan was found guilty on two counts of kidnapping and serious illegal detention over the disappearance of University of the Philippines (UP) students Sherlyn Cadapan and Karen Empeño

After handing down the sentence, Malolos RTC Judge Alexander Tamayo also issued a commitment order for Palparan's transfer to NBP.

Aside from Palparan, the court also sentenced Lieutenant Colonel (LTC) Felipe Anotado Jr. and S/Sgt. Edgardo Osorio for Cadapan and Empeño's disappearance, and similarly directed for their transfer to the national penitentiary in Muntinlupa City.

Army Spokesperson LTC Louie Villanueva confirmed that Palparan is still in their custody.

"Gen Palparan is still under the custody of Army Custodial Center since the army is still waiting for the decision of the court (regarding) his disposition," he said in a message to reporters on Tuesday.

Villanueva said Palparan has a pending case with another court, which issued a separate commitment order stating that the former Army official should remain in the custody of the military.

"The Philippine Army for its part has already filed a motion clarifying to the Honorable Court on the appropriate disposition of Gen. Palparan," he said.

Atty. Edre Olalia, president of the National Union of Peoples' Lawyers (NUPL), earlier said they intend to inform the Malolos RTC about the non-compliance of the Armed Forces of the Philippines on its commitment order regarding Palparan's detention.

"The military and his coddlers are liable for contempt of court for open defiance or disobedience to an explicit judicial order to immediately commit the convict to the National Penitentiary as all convicted felons are," Olalia said.

Meanwhile, Justice Secretary Menardo Guevarra said he will verify why Palparan remains in the custody of the military. /kga 80

#### Army recovers high-powered guns in Rizal farm raid

SAN PEDRO CITY – Soldiers and government agents on Tuesday recovered high-powered firearms supposedly owned by communist guerrillas that targeted to overthrow President Duterte.

Armed with a search warrant, a joint team from the Philippine Army and the National Bureau of Investigation raided the private Coral Farm in Sitio Dalig in Teresa town, Rizal around 7:30 a.m.

Recovered were four M653 baby armalite rifles, an M203 grenade launcher, five U.S. made 12-gauge shotguns, and three pistols of calibers .45, .38, and 9mm.

They also found six units of two-way radios, two grenades, eight cellphones, and documents that contained "war materials."

Brigadier General Arnulfo Marcelo Burgos Jr., commander of the Army's 202nd Infantry Brigade, said the search warrant was issued against Armando Lazarte alias "Pat" or "Romano," allegedly the secretary of the New People's Army (NPA) in Calabarzon, and Tirso Alcantara, a former commander of the NPA's regional guerrilla unit.

Alcantara was a National Democratic Front consultant to the peace negotiations who was granted temporary liberty in 2016.

Alcantara had reportedly fled from the farm before the troops arrived this morning, according to Army's division spokesperson Captain Patrick Jay Retumban in a text message.

Eight people, among them Lily Ong, the owner of the six-hectare farm, were arrested during the raid.

Burgos, in a statement, said the presence of NPA leaders in Rizal, a province adjacent to Metro Manila, were "indicators" of the supposed "Red October" destabilization plot against Duterte.

The Armed Forces earlier said a coalition led by the Communist Party of the Philippines with supporters of ousted Chief Justice Maria Lourdes Sereno, members of the group Tindig Pilipinas, and Liberal Party leaders, were planning to unseat the president next month.

Major General Rhoderick Parayno, Commander of the Army's 2nd Infantry Division, said the operation had "preempted" the supposed destabilization./lb

# Joma denies LP-Reds-gov't soldiers conspiracy to oust Duterte

LUCENA CITY – Exiled Communist Party of the Philippines (CPP) founder Jose Maria "Joma" Sison mocked President Duterte for claiming there was now a conspiracy between the political oppositions, communist rebels, and disgruntled government soldiers to topple down the Duterte administration.

"He (Duterte) is becoming desperate and afraid of his own shadow," Sison said in an online interview from his base in Utrecht, The Netherlands.

Sison said the so-called Red Revolution plot was "a figment of Duterte's imagination."

But Sison maintained that the broad united front of Filipino people that opposed the Duterte government "is open to the support and participation of the military opposed to Duterte."

"But there is no conspiracy among them, the LP (Liberal Party) and the CPP-NPA," Sison stressed.

He claimed that there were military officers and foot soldiers who opposed President Duterte for various reasons like "encouraging unlawful acts against civilians, giving corruptive rewards for fake surrenderers and fake encounters, trying to trick the military by issuing the proclamation to revoke the amnesty of Trillanes, favoritism in promotions, corruption of highest civil and military officers who are Duterte favorites and sympathy for the people who suffer from the deteriorating economic and social conditions like poverty, unemployment, low income and soaring prices of prime commodities."

In a statement, the CPP strongly denied that the revolutionary movement was in cahoots with the political oppositions to bring down President Duterte from power.

"This so-called Red October plot is nothing but an AFP invention. Like the rest of the AFP's fakery, it is a poorly concocted story," the CPP said in a statement issued Tuesday.

It added: "Neither Duterte nor the AFP could show the public proof of their claims."

Though the CPP admitted that a broad united front of democratic forces – progressive and patriotic forces, as well as various strands of politicians, religious and business groups – has emerged in both formal and informal alliances to oppose Duterte.//b

#### Lorenzana: 'Red October' plot will fail due to lack of popular support

While the defense establishment is taking the supposed "Red October" ouster plot against President Rodrigo Duterte seriously, Defense Secretary Delfin Lorenzana is confident that the plan supposedly directed by communist rebels will be unsuccessful.

"Like the other plots of the CPP-NPA (Communist Party of the Philippines-New People's Army), this too will fail for lack of popular support," he told reporters Tuesday.

The purported plot, which is an alleged coalition of communist rebels and members of political opposition, aims to remove the President from office by next month.

AFP deputy chief of staff for operations Maj. Gen. Isidro Purisima on Monday explained that the groups are also targeting to discredit the Philippine government by internationalizing various issues to destroy the country's image abroad and to scare away potential investors.

The plan is said to culminate in October, which the military says coincides with the international celebrations for Marxism, indigenous peoples, and communism.

Lorenzana stressed that they would not need emergency powers to deal with the alleged plot to unseat the President.

"We are not yet facing an emergency situation. These are just irritants that somehow distracts us from properly governing," he said.

The military continues to insist on the said ouster plot, even if the previously reported Sept. 21 ouster plan, which they also claimed, failed to materialize.

"What they planned to do is initiate mass action which they hope to snowball into a people power such as what they intended last Sept. 21 or the anniversary of Martial Law. The turn out was pitifully small," Lorenzana said.

"Their plan was to get as may as civil organizations as possible to their mass actions led by their progressive fronts," he added.

Lorenzana said that they exposed the plot to the public to preempt it.

"Exposure is the first step. Second is to monitor their activities and affiliates. Third is to pre-empt if there are indications that they will conduct destabilization or any violent mass movement," he said.

But the defense chief said that the plan may not be executed next month, as what CPP founding chairman Jose Ma. Sison had hinted.

"If you are listening to Joma Sison, he came out recently to say that PRRD will not last until the middle of 2019. Maybe they have moved their goalpost, considering the lackluster performance of their so-called mass rallies last Martial Law anniversary," Lorenzana said, adding that they are closely monitoring them and the other groups.

Reacting to Duterte's statement that the decades-long communist insurgency would end by mid-2019, Sison said last week that it was more likely that the President would be ousted by that time. /je
