The Armed Forces of the Philippines through the PABAC now calls for the submission of eligibility documents for **Procurement of Consultancy Services for the Adoption of Enterprise Architecture**. Interested consultants must submit their eligibility documents not later than November 19, 2019, 1:30 P.M at Office of the Philippine Army Bids and Awards Committee, Fort Bonifacio, Taguig City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

In accordance with the provisions of Republic Act 9184, otherwise known as the "Government Procurement Reform Act", and its 2016 Revised Implementing Rules and Regulations (RIRR), the PABAC shall come up with a shortlist of local Consultancy Firms (CF) that have submitted Eligibility documents/Expression of Interest. Only those CFs that will be declared eligible and included in the short list will be entitled to submit bids.

The PABAC will evaluate the Technical Proposals using the Quality Cost Based Evaluation (QCBE) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instruction to Bidders.

The contract shall be completed within 90 calendar days from receipt of Notice to Proceed.

The PABAC reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
